(57) **CLAIM**

The ornamental design for a catamaran, as shown and described herein.

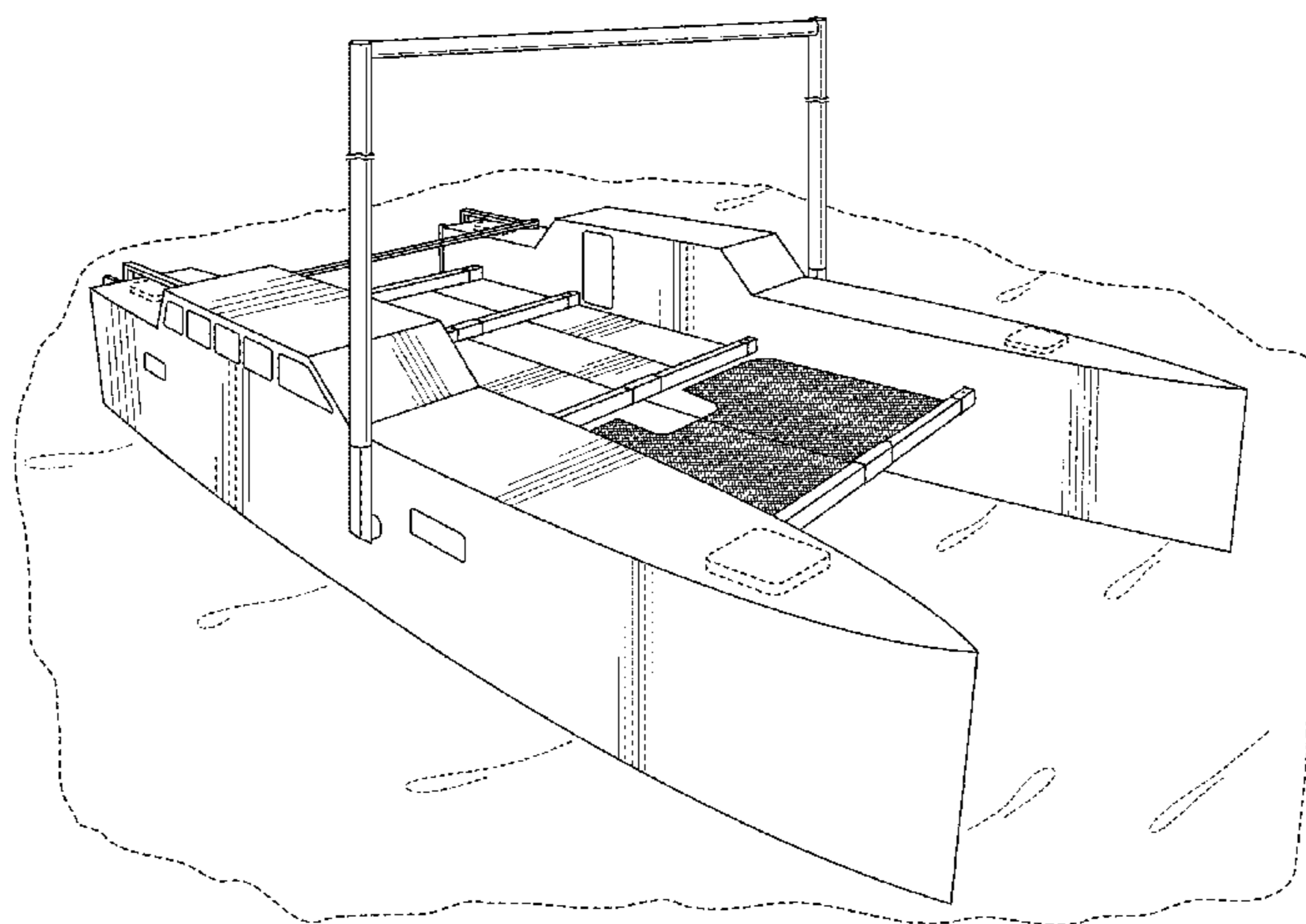
DESCRIPTION

FIG. 1 is a front perspective view of a catamaran showing the new design;
 FIG. 2 is a left side view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a front elevation view thereof;
 FIG. 5 is a front elevation view thereof, in a partially folded position, with the masts and the tiller off;
 FIG. 6 is a rear elevation view of FIG. 4;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is a bottom plan view thereof;
 FIG. 9 is a top plan view thereof, with the deck shown in a partially folded position, of FIG. 5;
 FIG. 10 is a top plan view thereof, with the deck shown in a folded position;
 FIG. 11 is a right side view thereof, rotated 180 degrees, with the masts in a first rotated position;
 FIG. 12 is a right side view thereof, rotated 180 degrees, with the masts shown in a second rotated position; and,
 FIG. 13 is a front elevation view thereof, with the masts shown in canted position.

The broken line showing of the water in FIG. 1 depicts environment and forms no part of the claimed design. All other broken lines depict portions of the catamaran that form no part of the claimed design.

The catamaran masts are shown with a symbolic break in their lengths. The appearance of any portion of the article between the break lines forms no part of the claimed design.

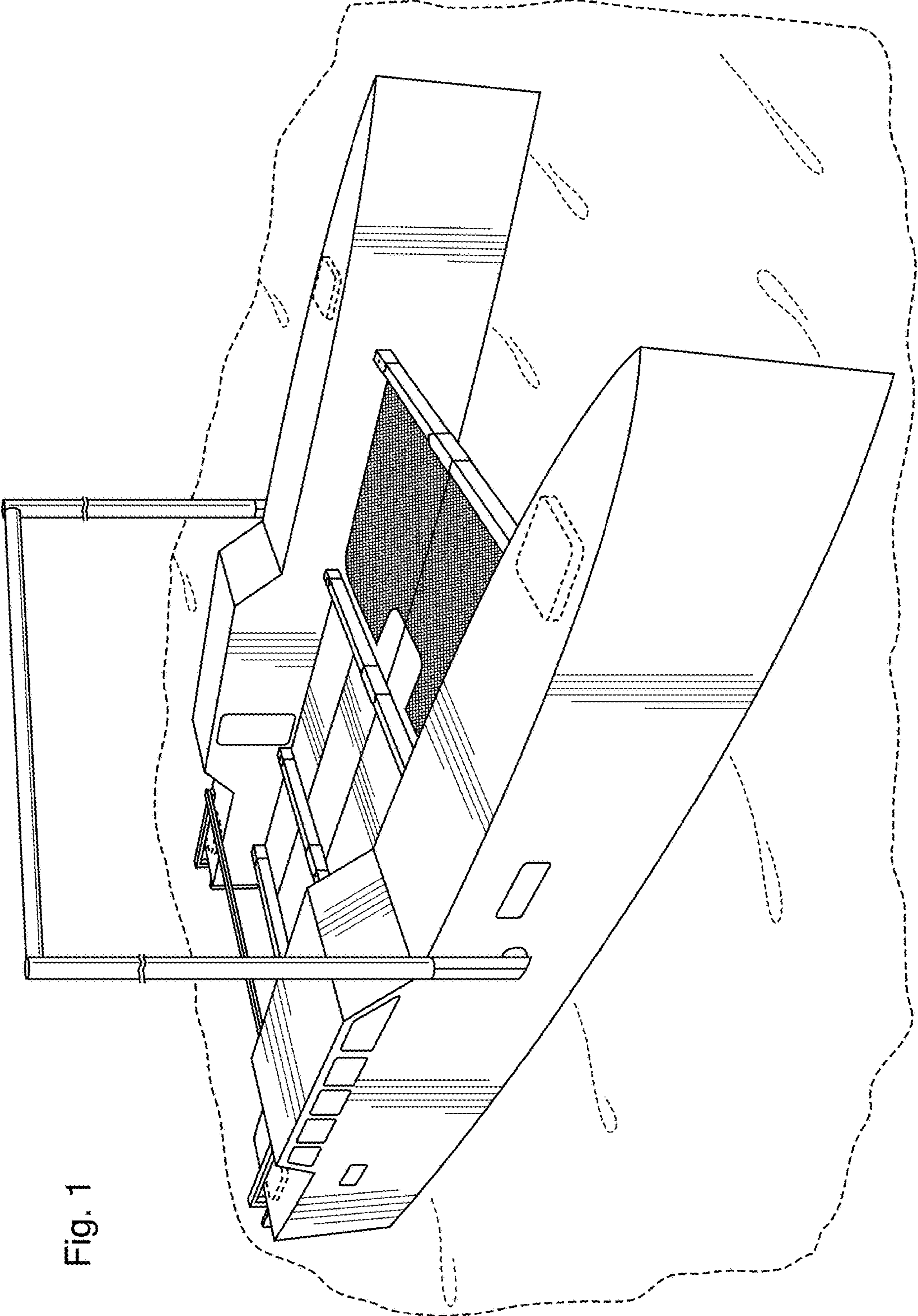

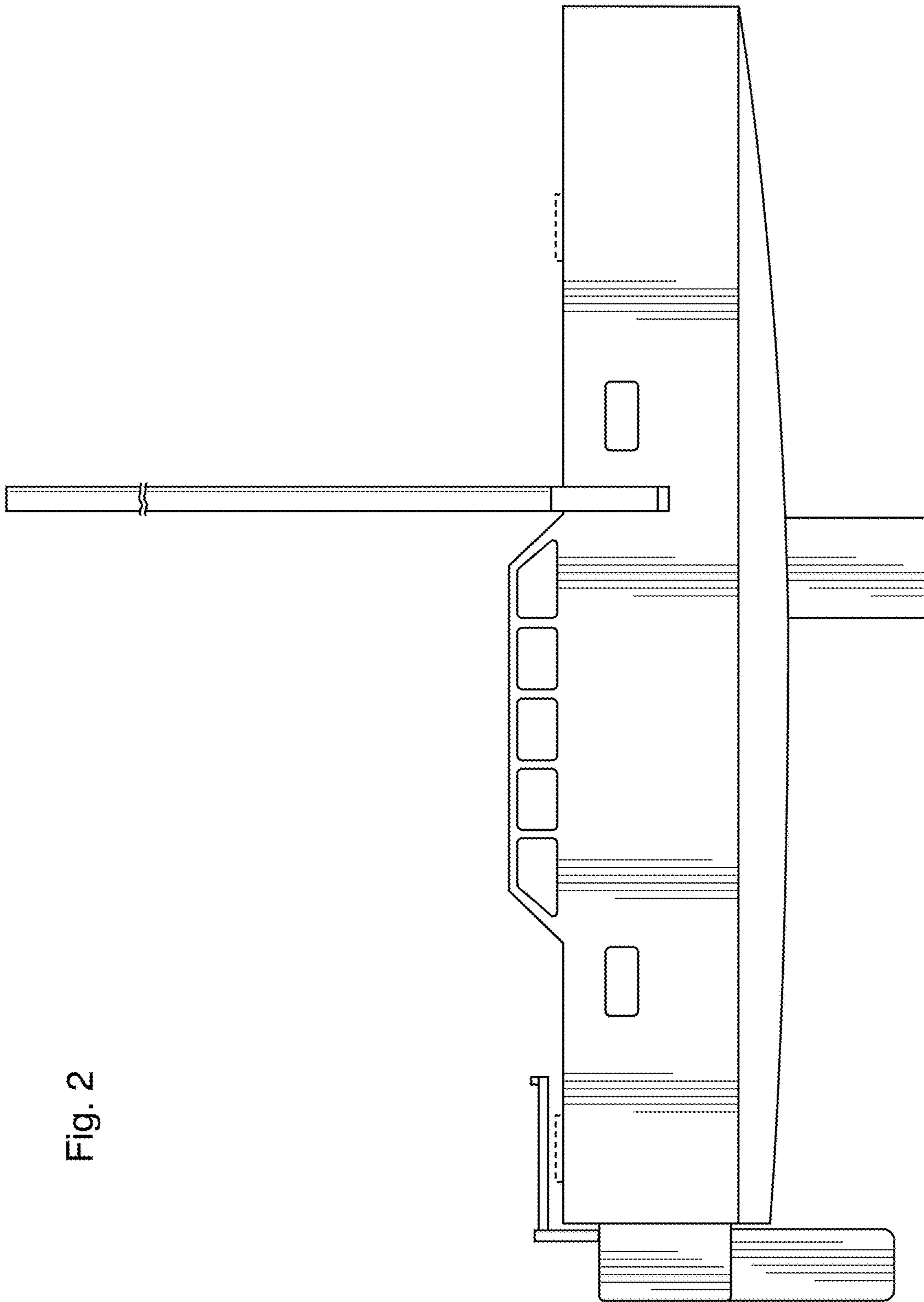

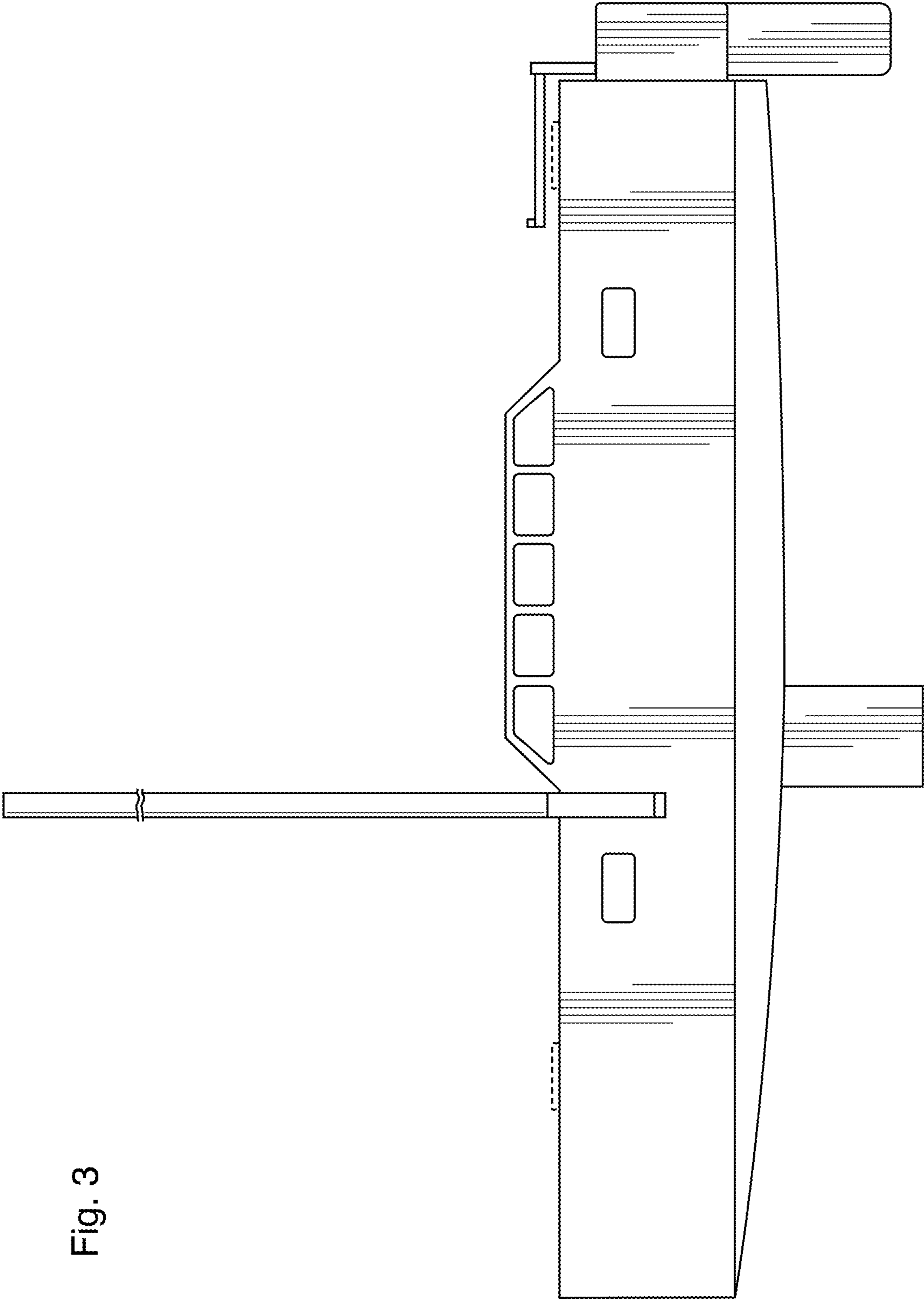

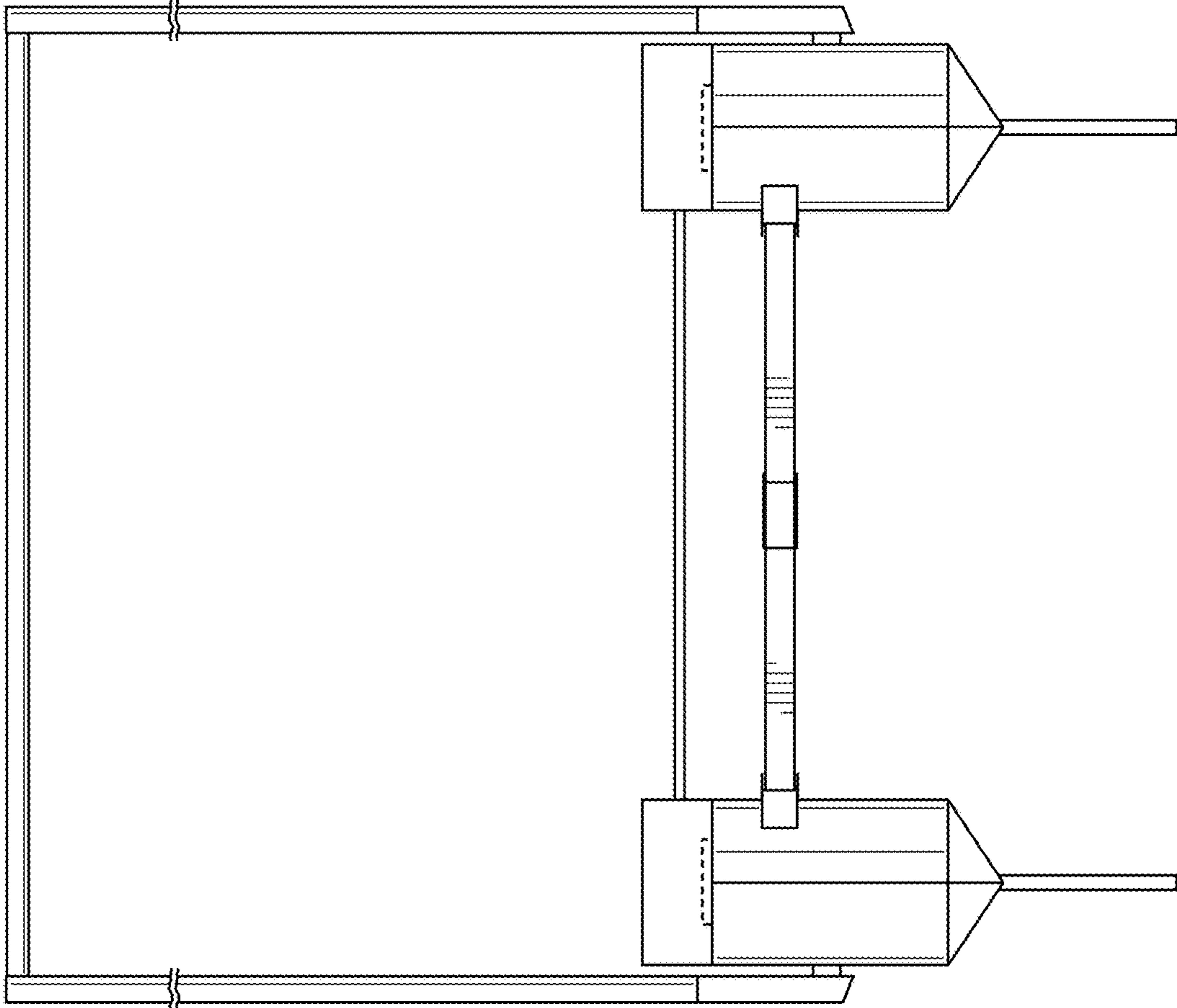

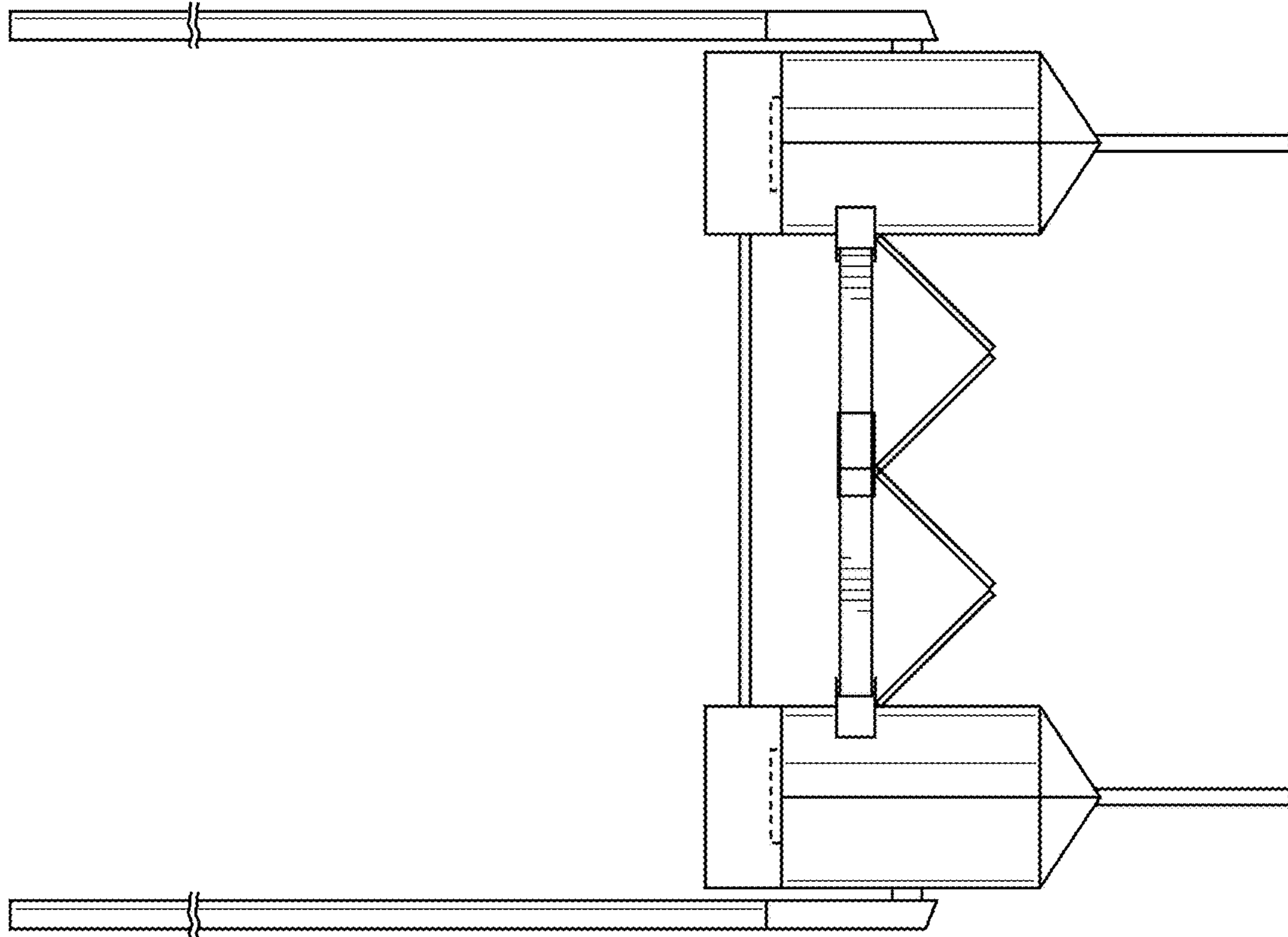

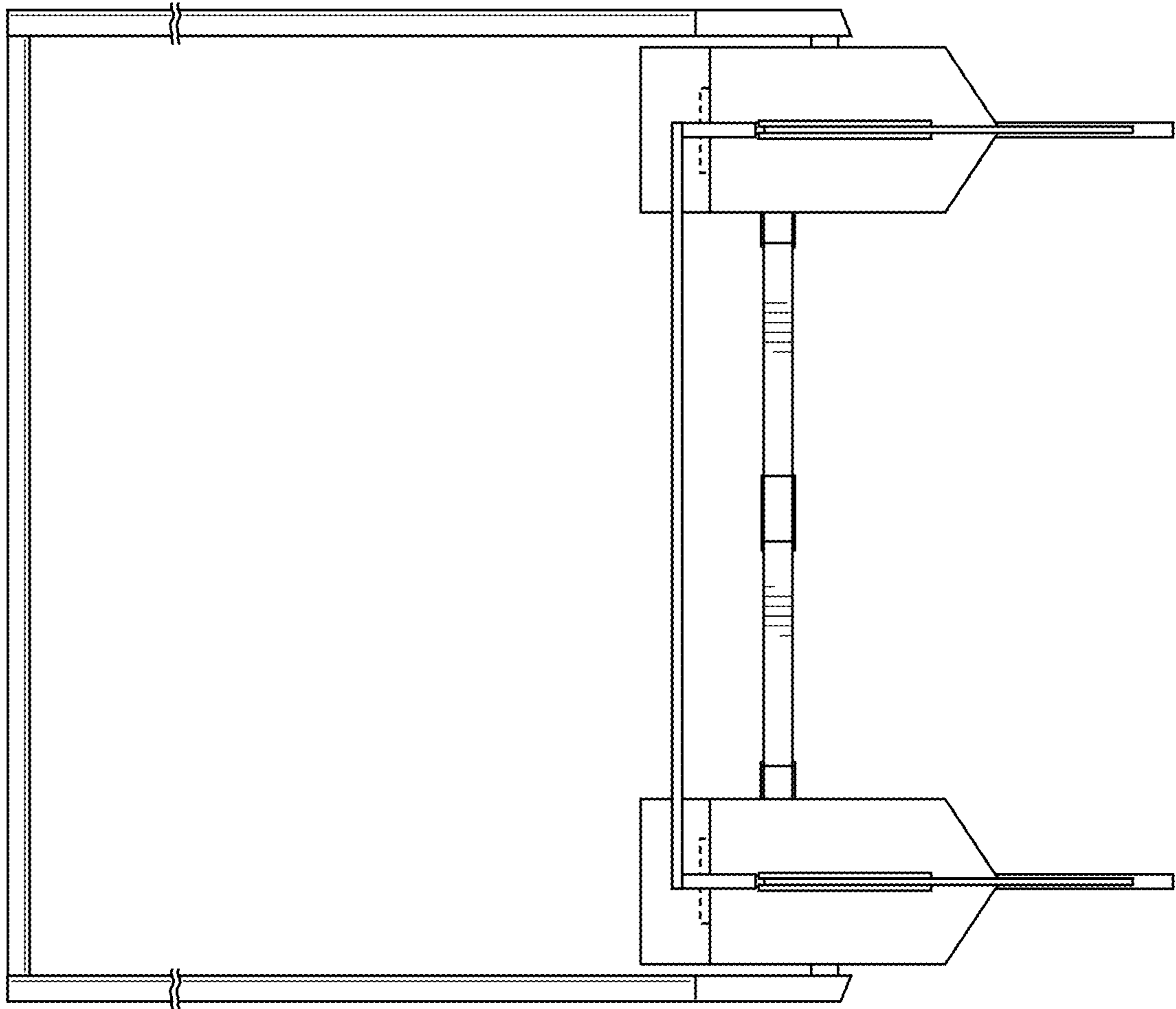

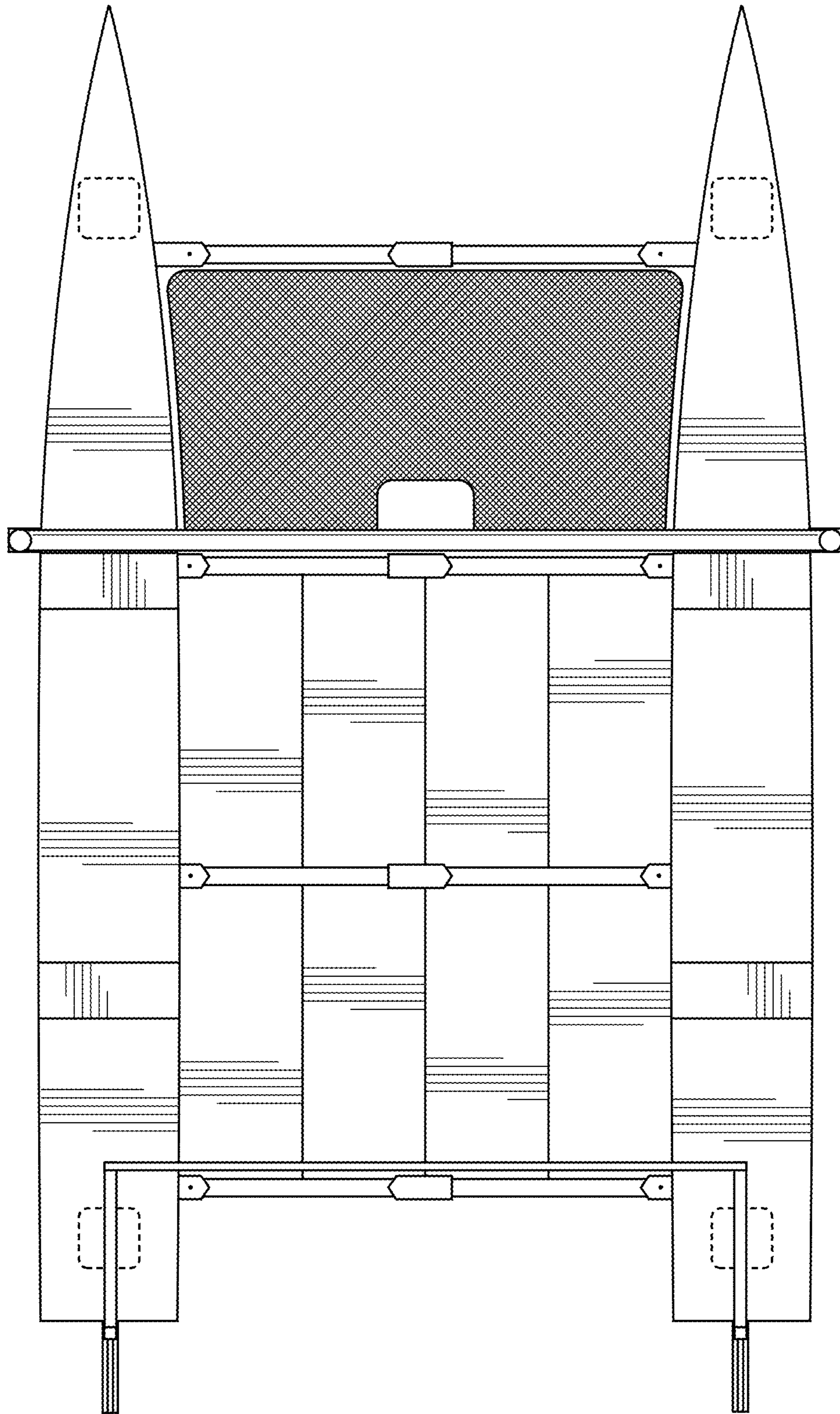

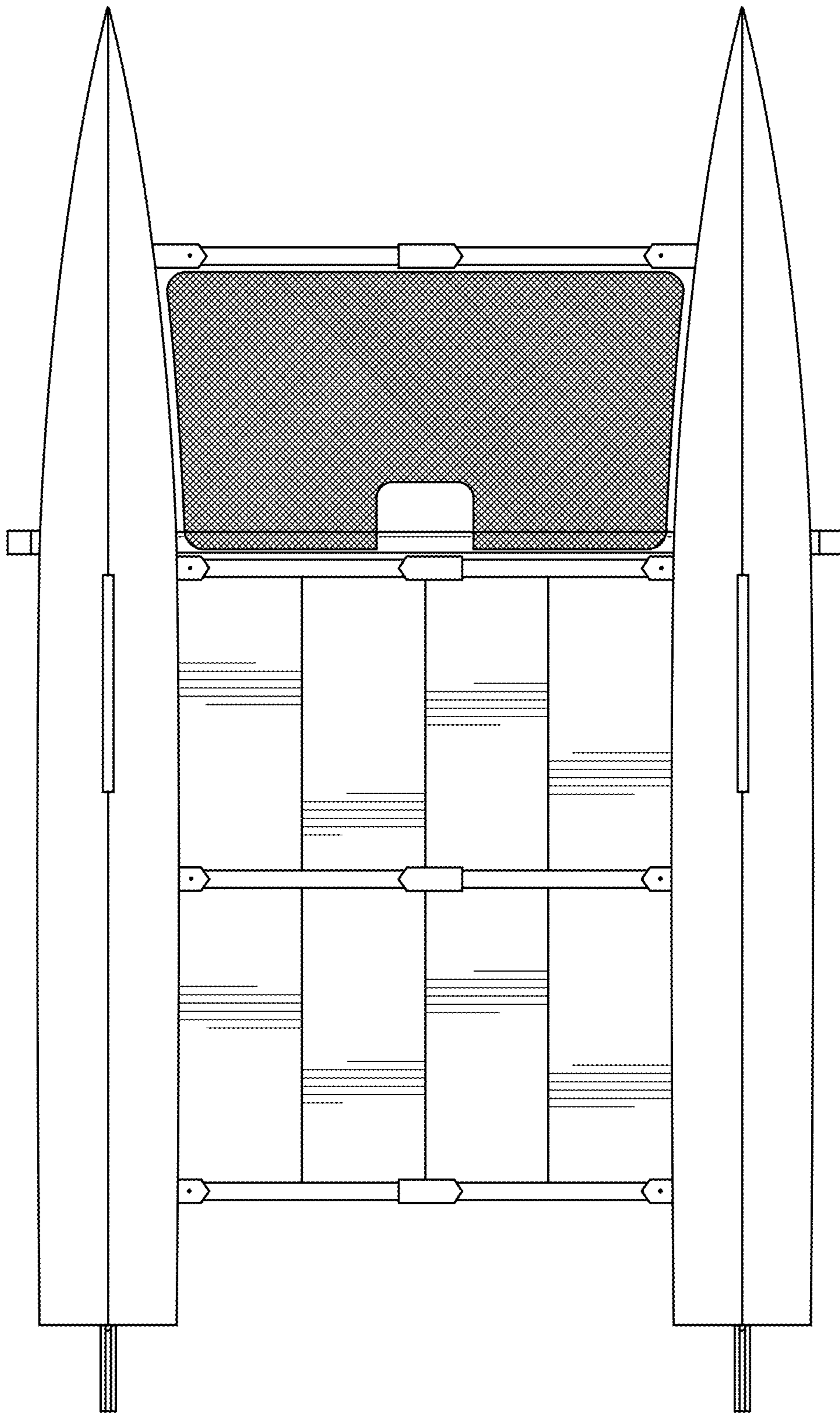

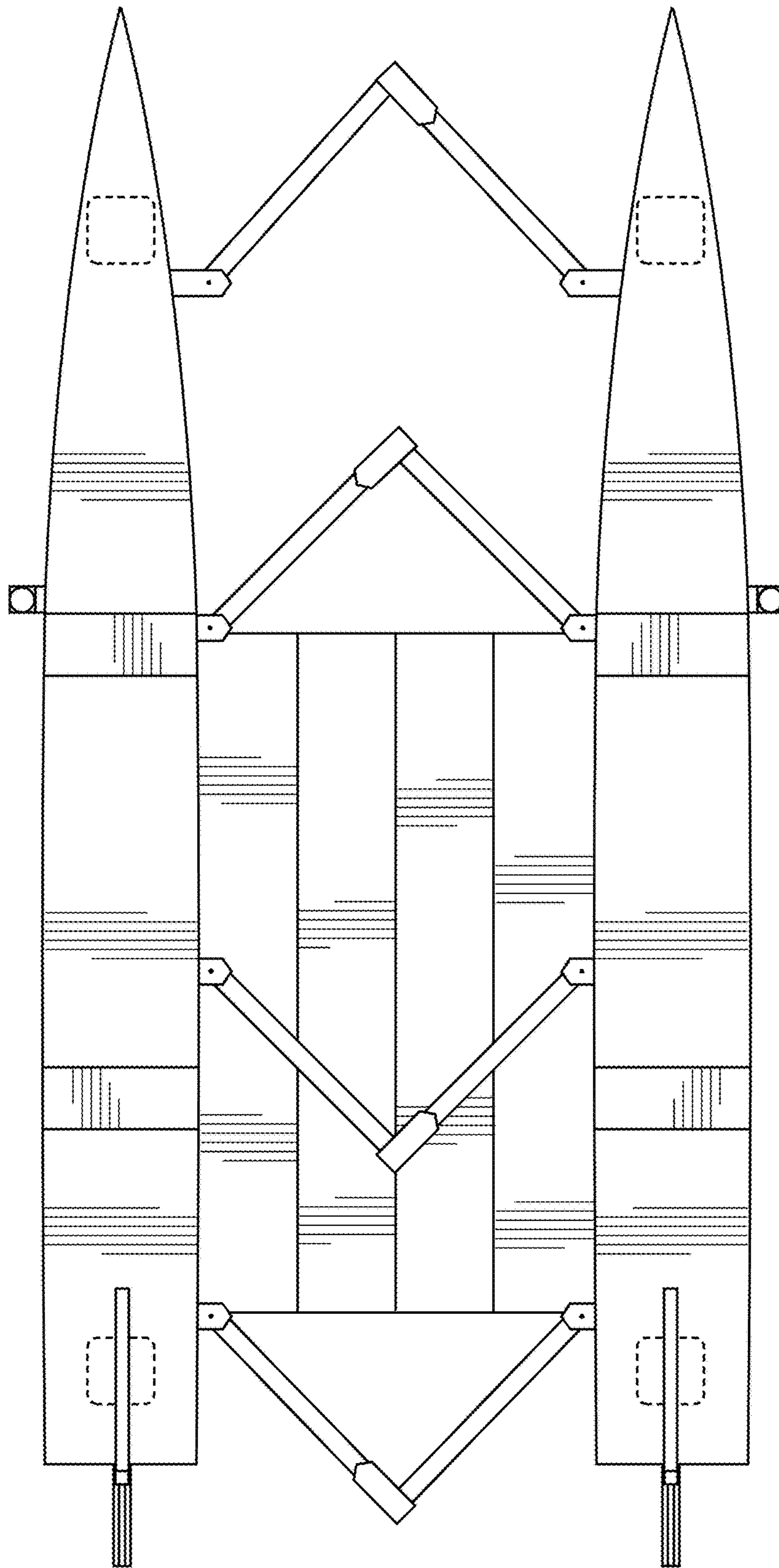

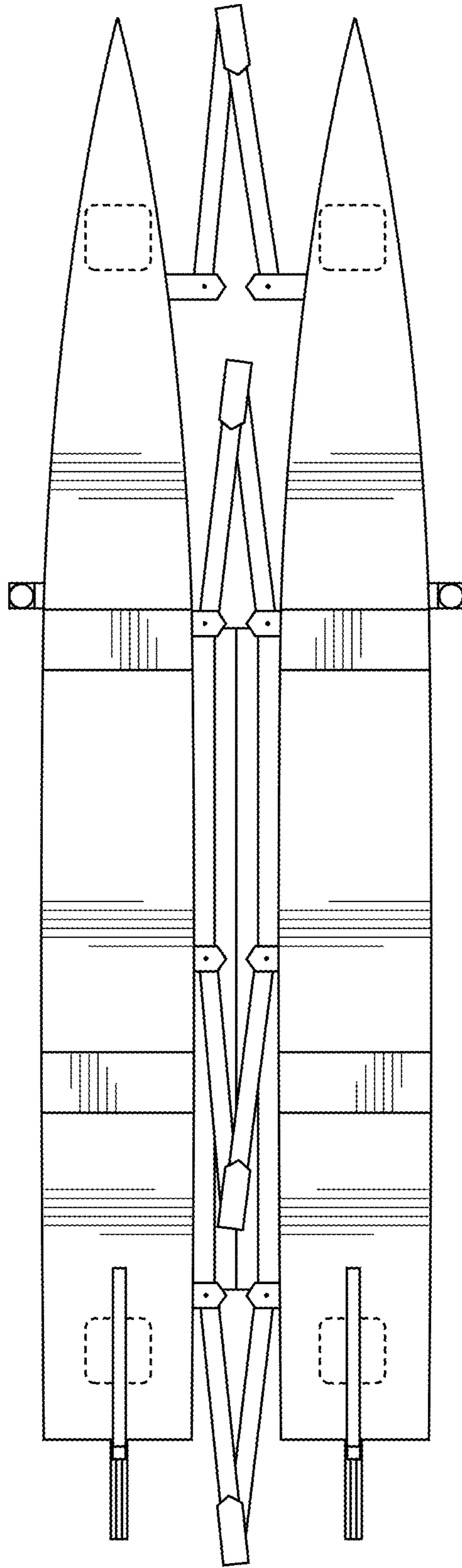

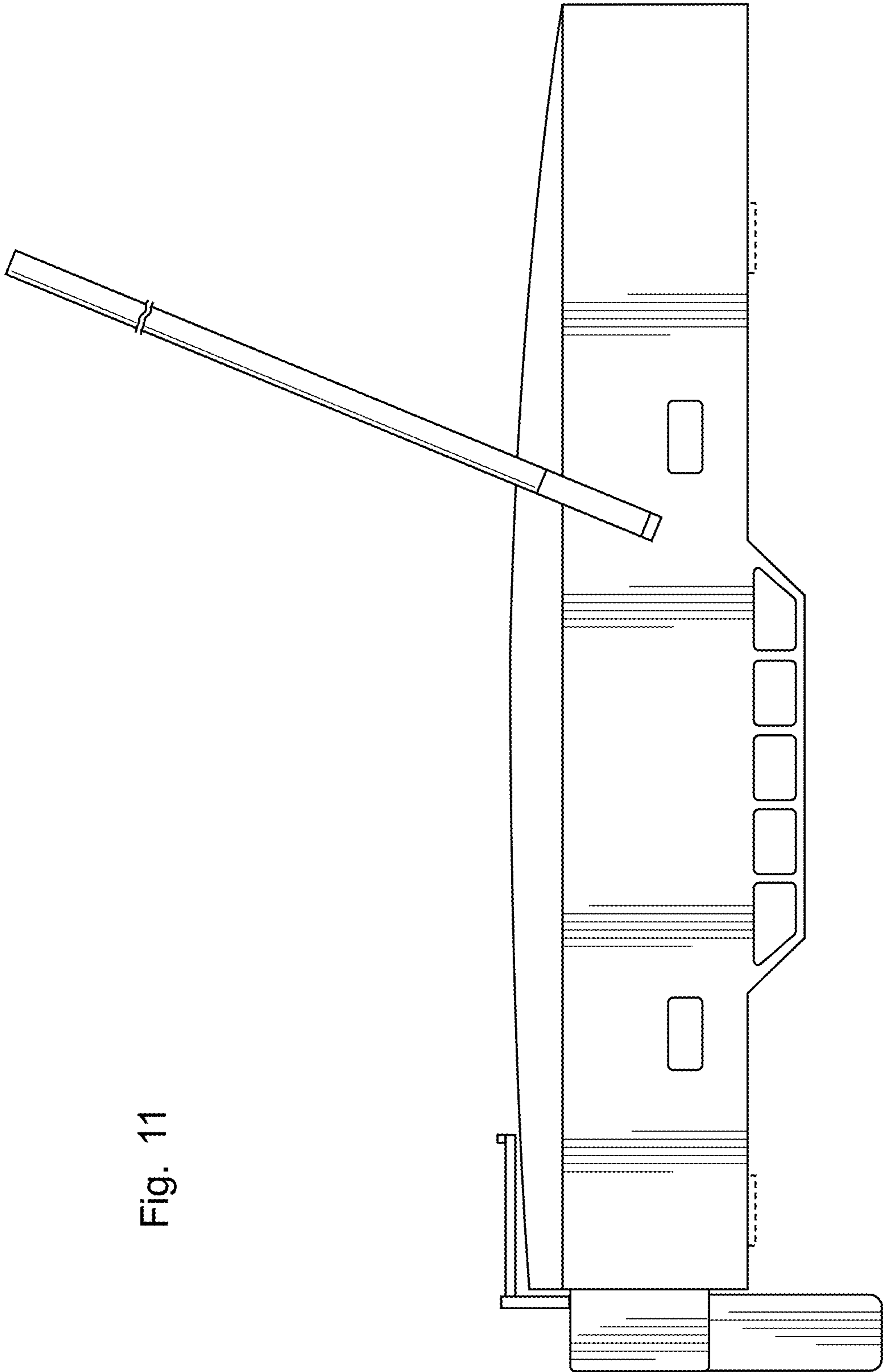

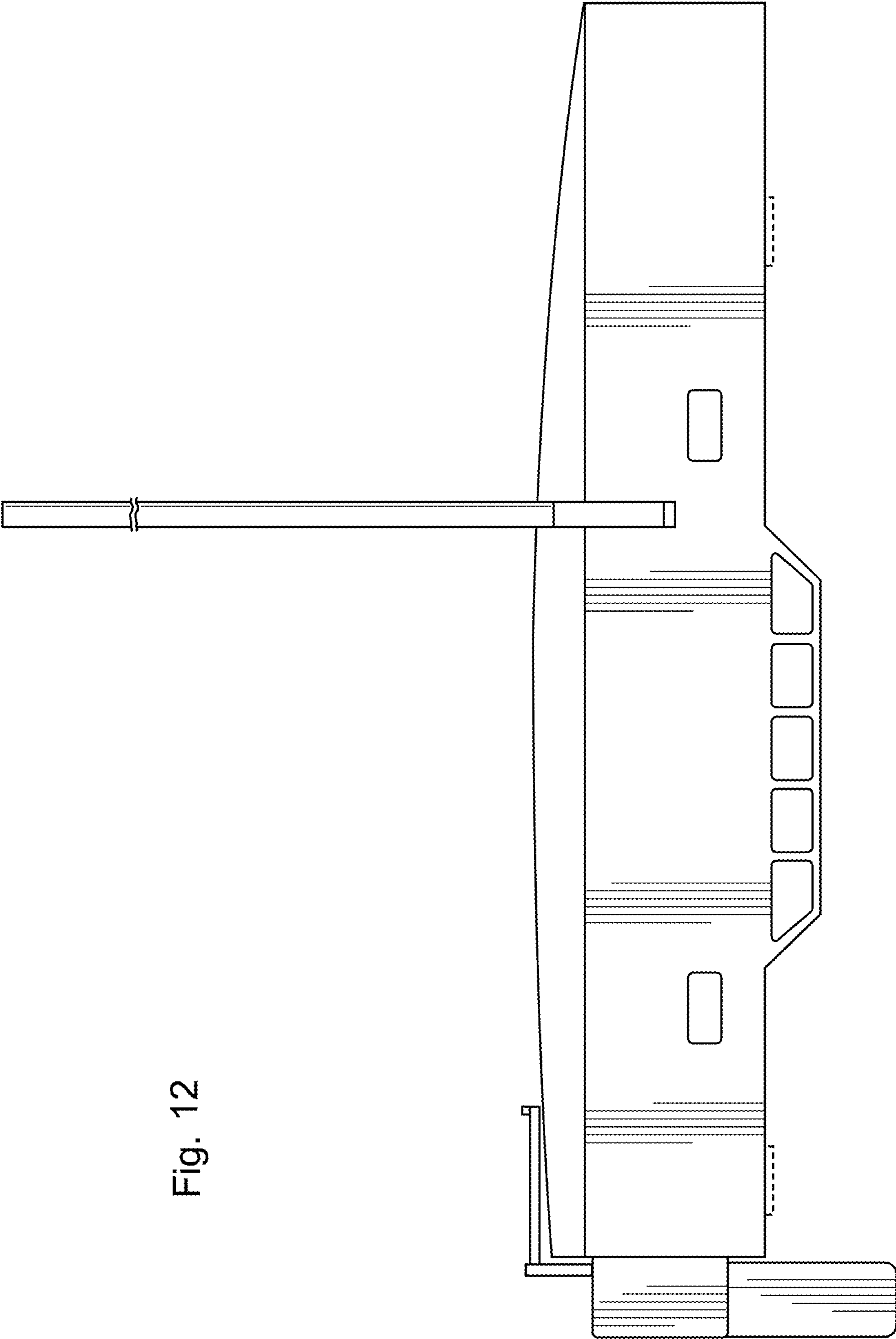

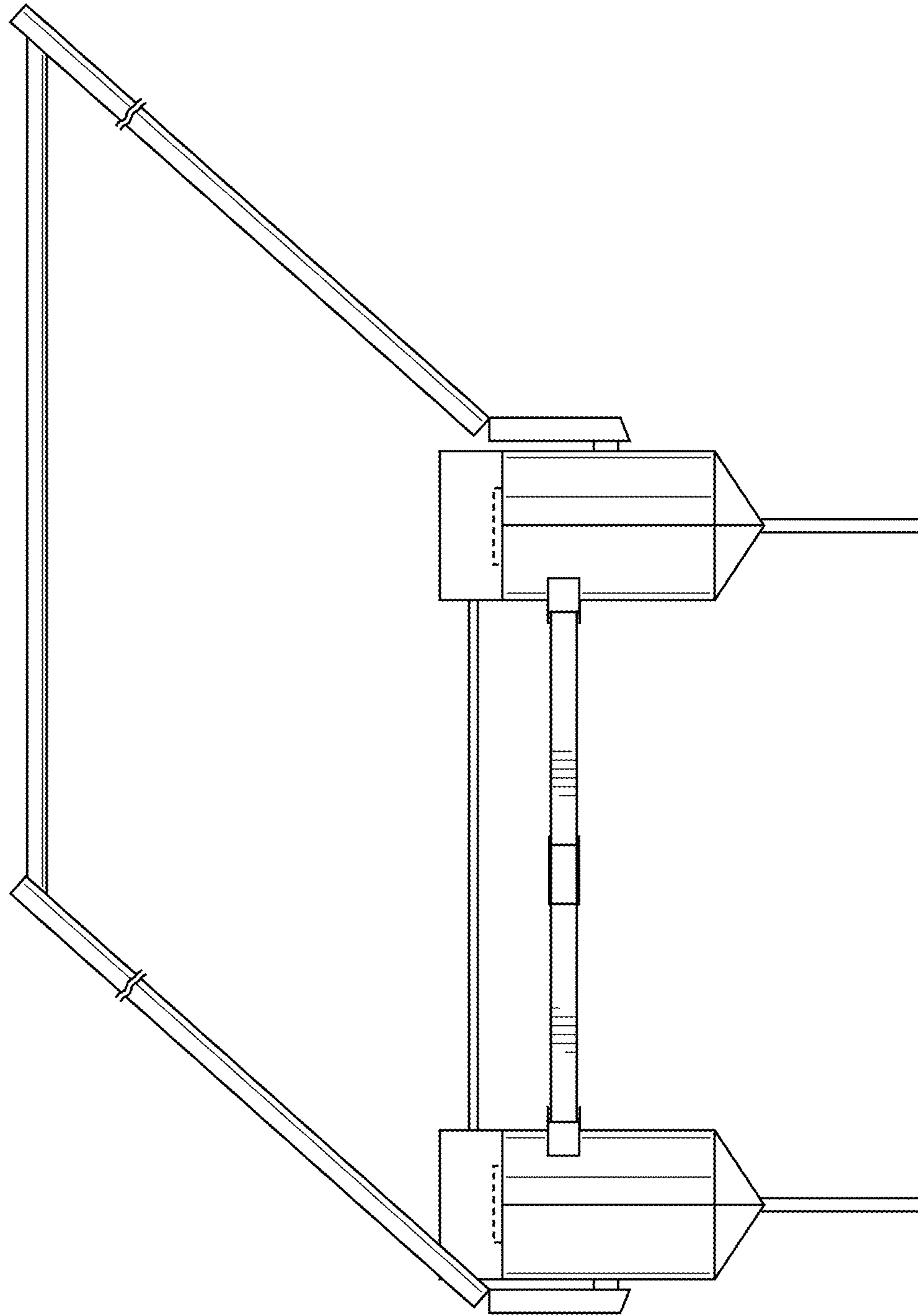
