(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tire showing the claimed design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top plan view thereof, to which the bottom plan view is symmetrical;

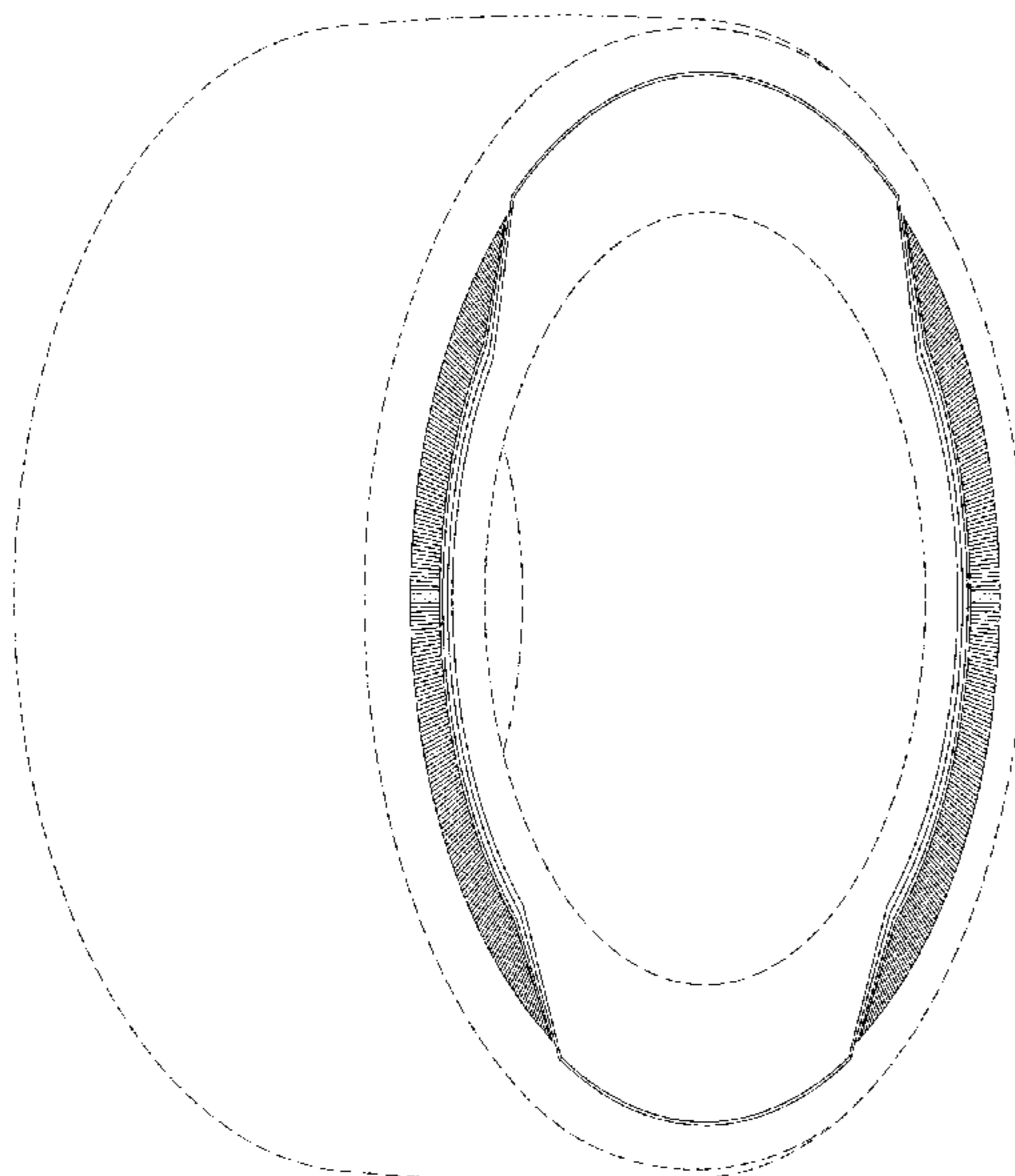
FIG. 5 is a left side view thereof, the right side view being a mirror image thereof;

FIG. 6 is an enlarged view of the portion between 6-6 and 6'-6' in FIG. 2; and,

FIG. 7 is an enlarged cross-sectional view taken along line 7-7 in FIG. 6.

In the drawings, the broken lines showing portions of the tire tread, sidewall, and inner bead depict portions of the tire that form no part of the claimed design.

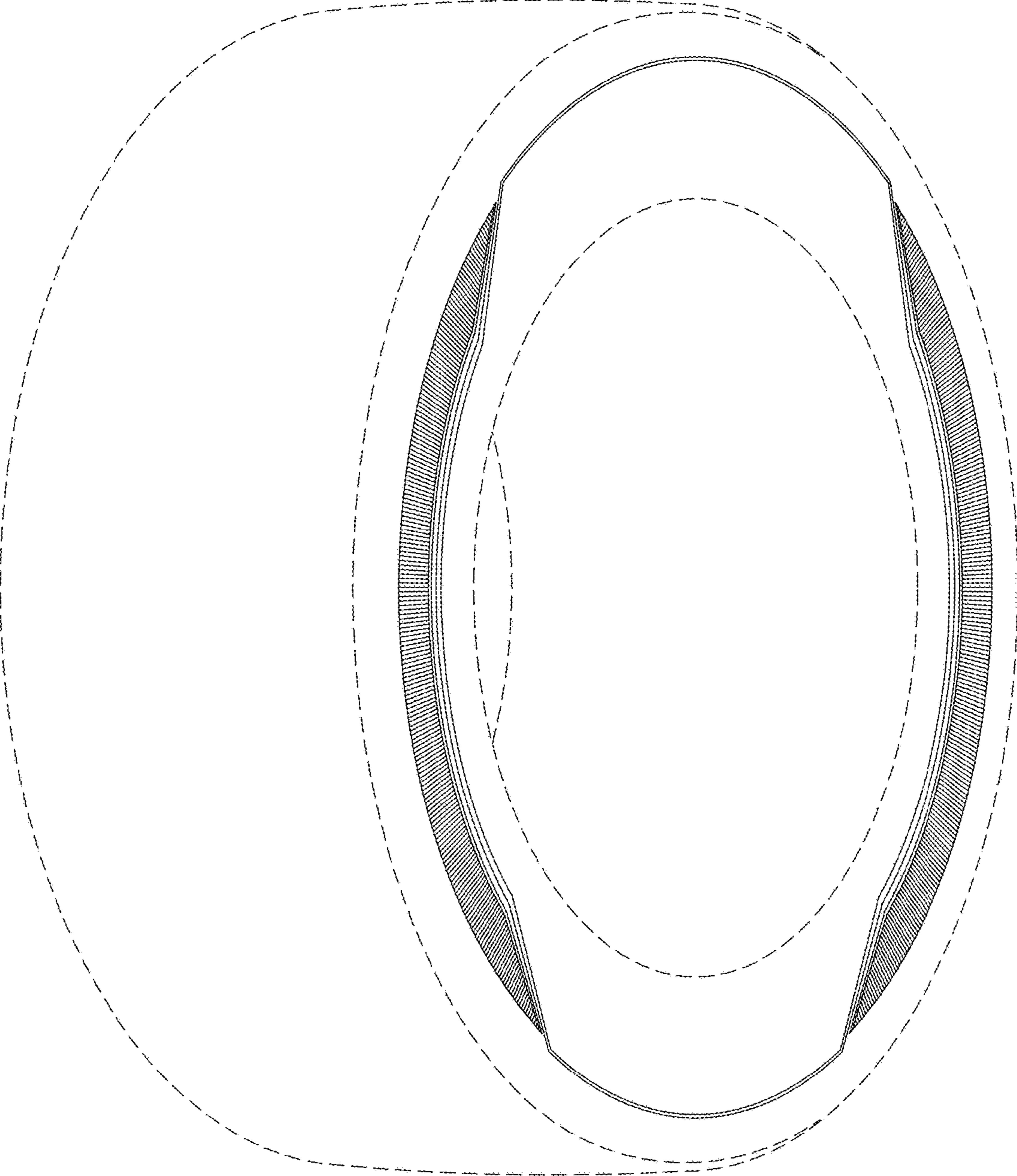

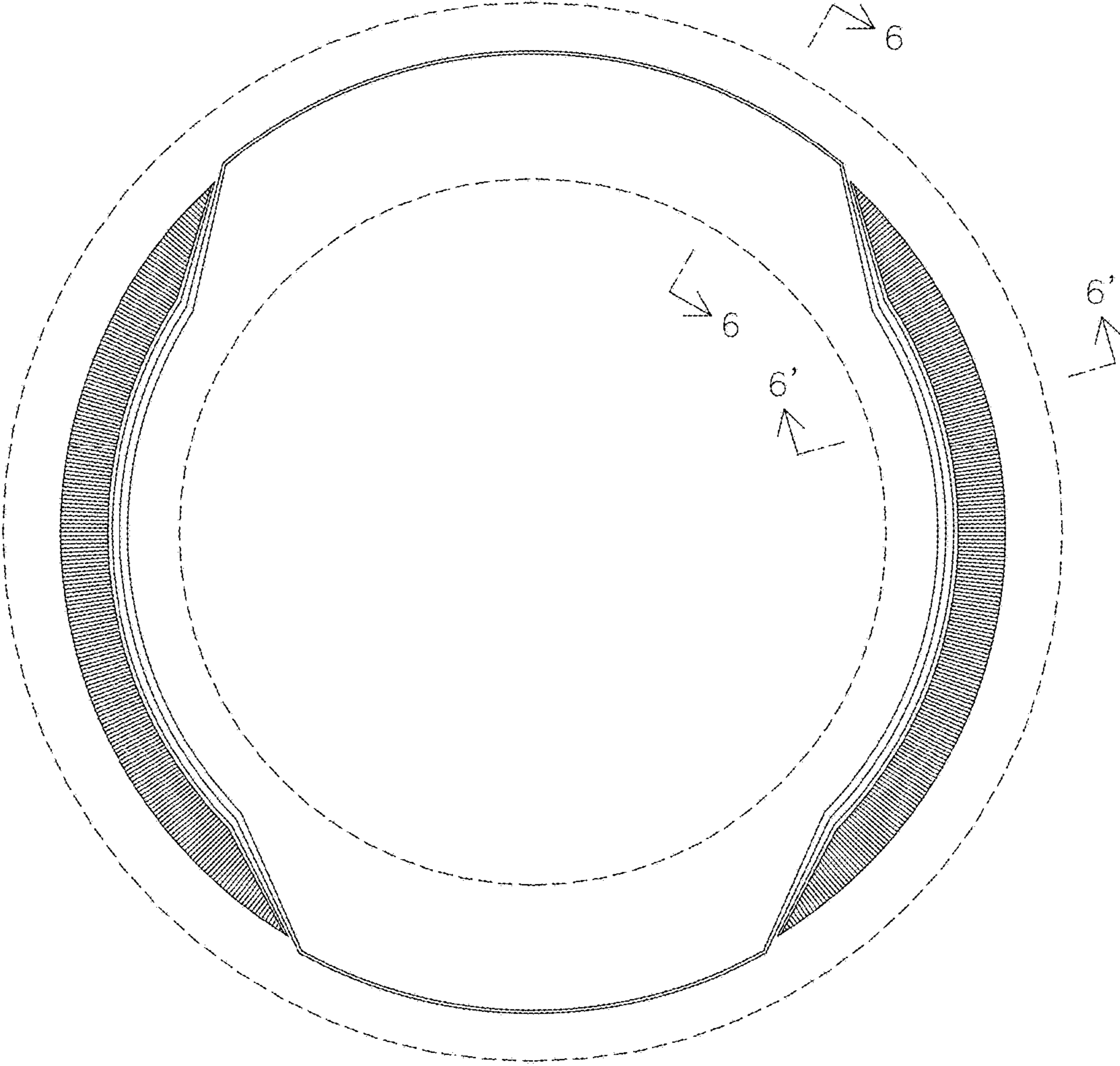

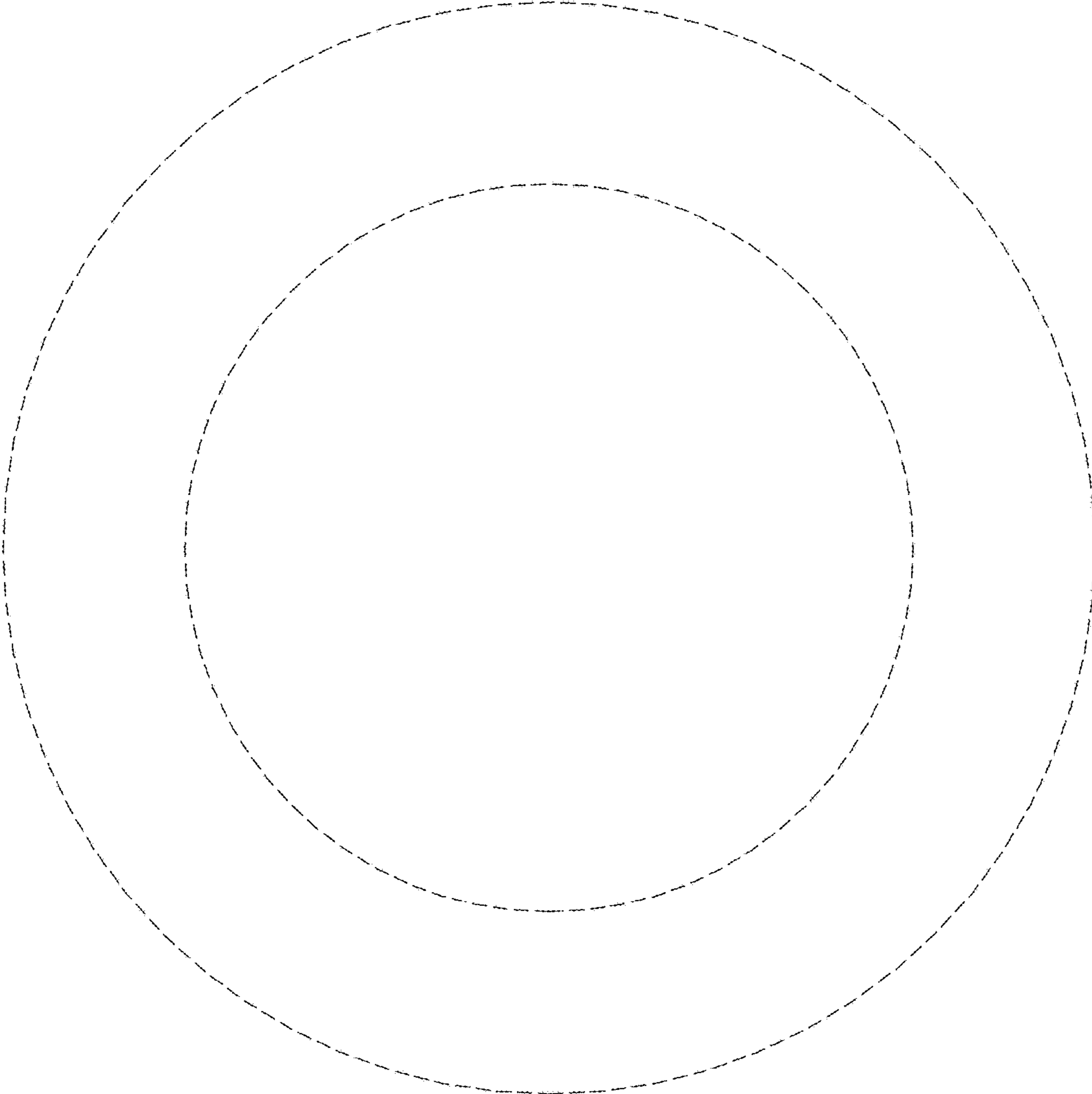

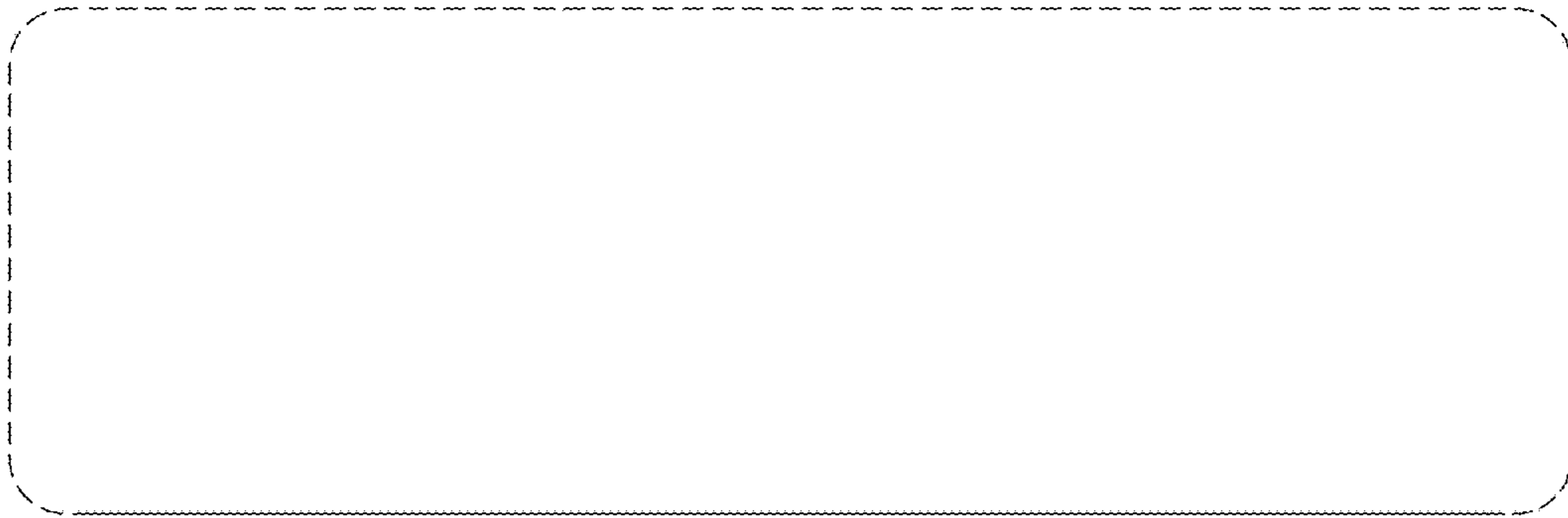

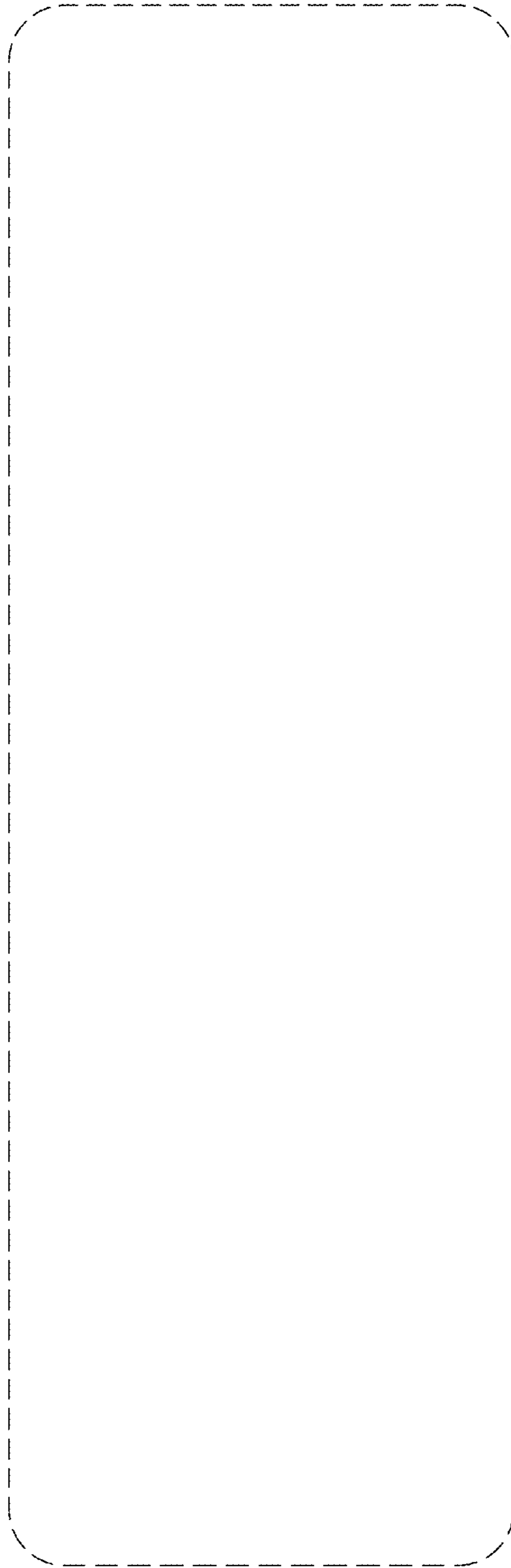

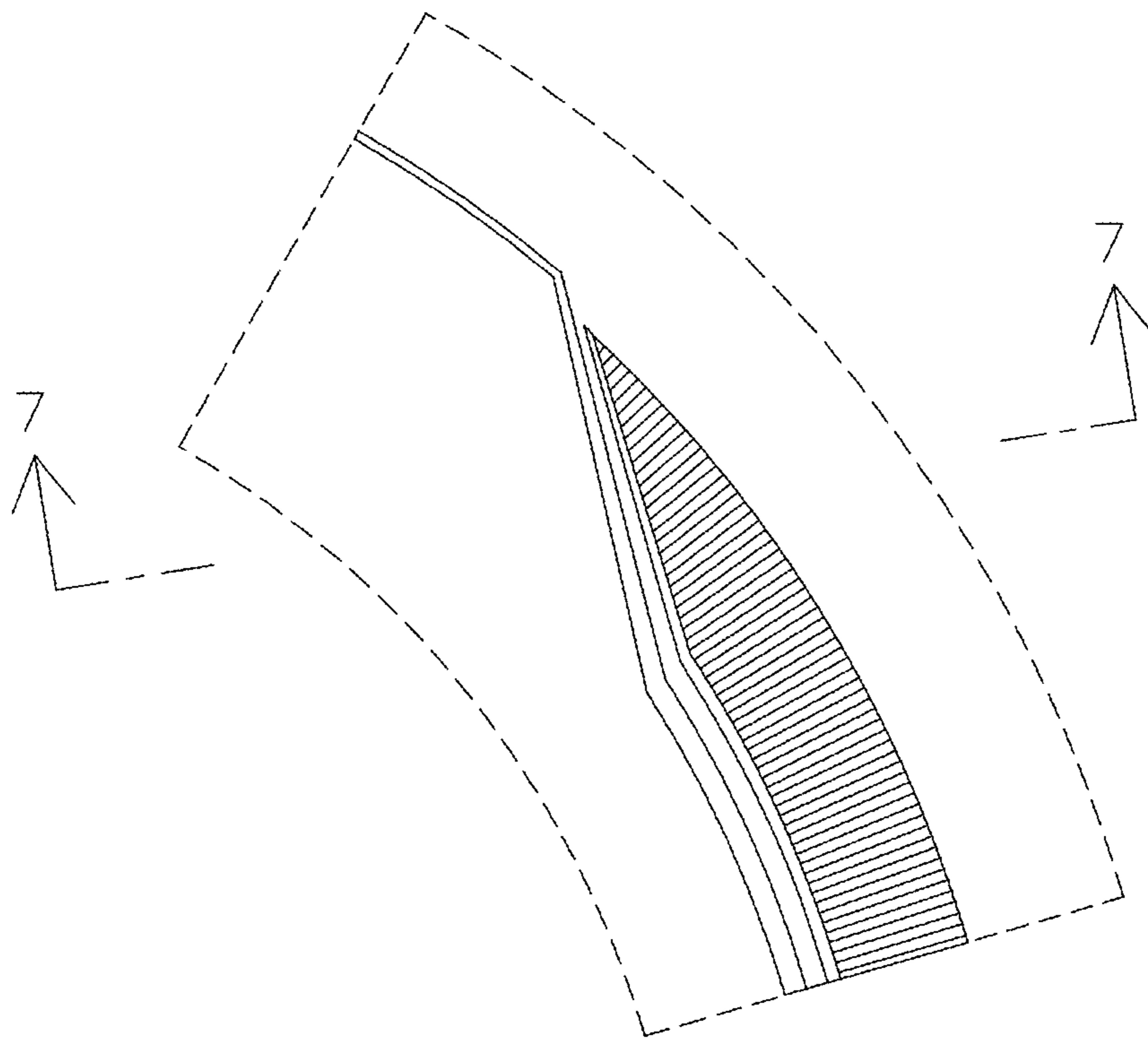

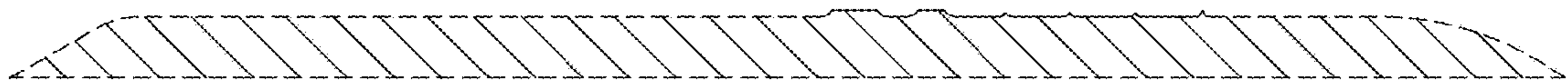
