(57) **CLAIM**

The ornamental design for a monitor, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a monitor showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left-side elevation view thereof;
FIG. 5 is a right-side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a front perspective view thereof; and,
FIG. 9 is an enlarged view of the portion encircled in FIG. 1.

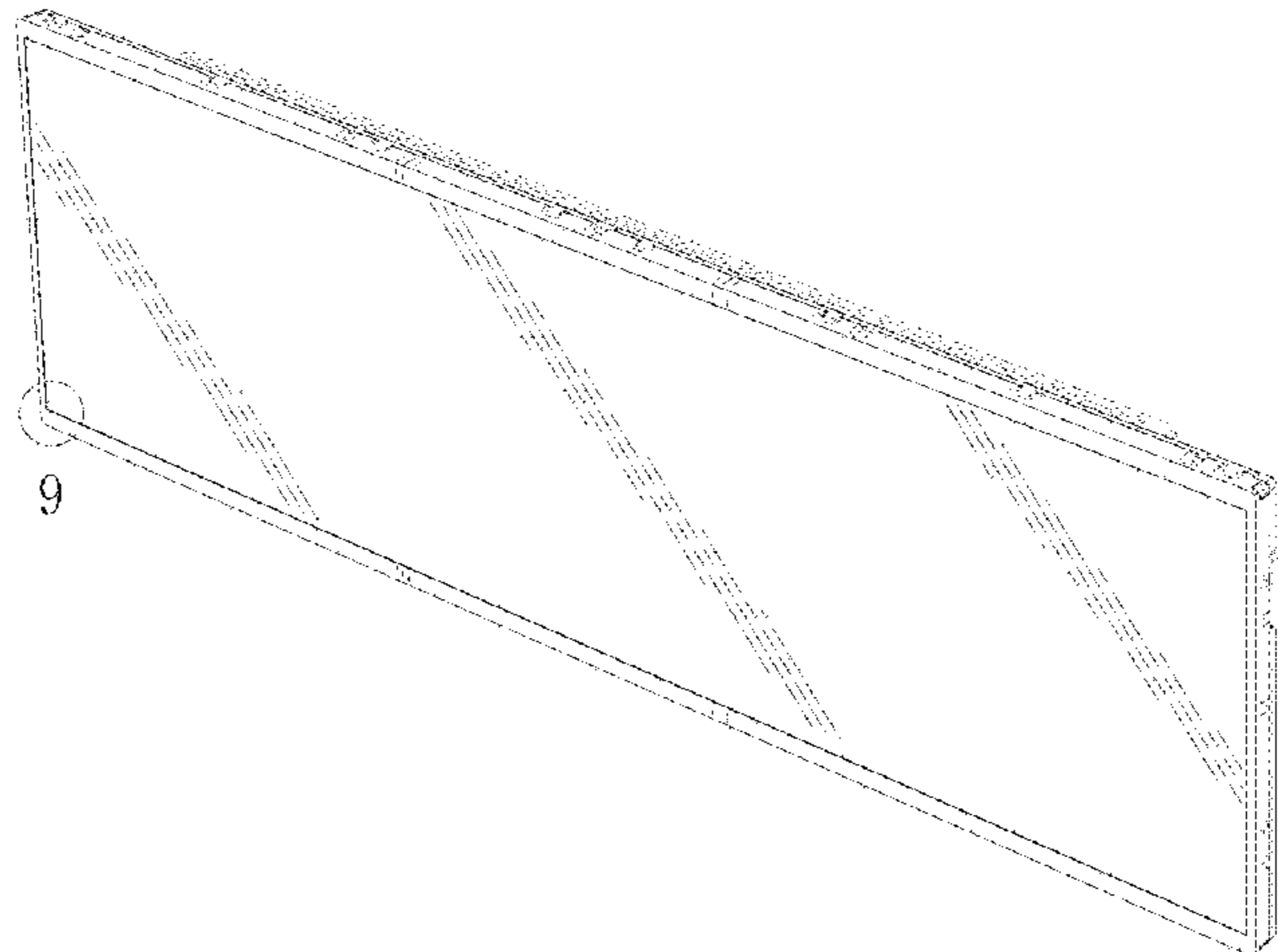

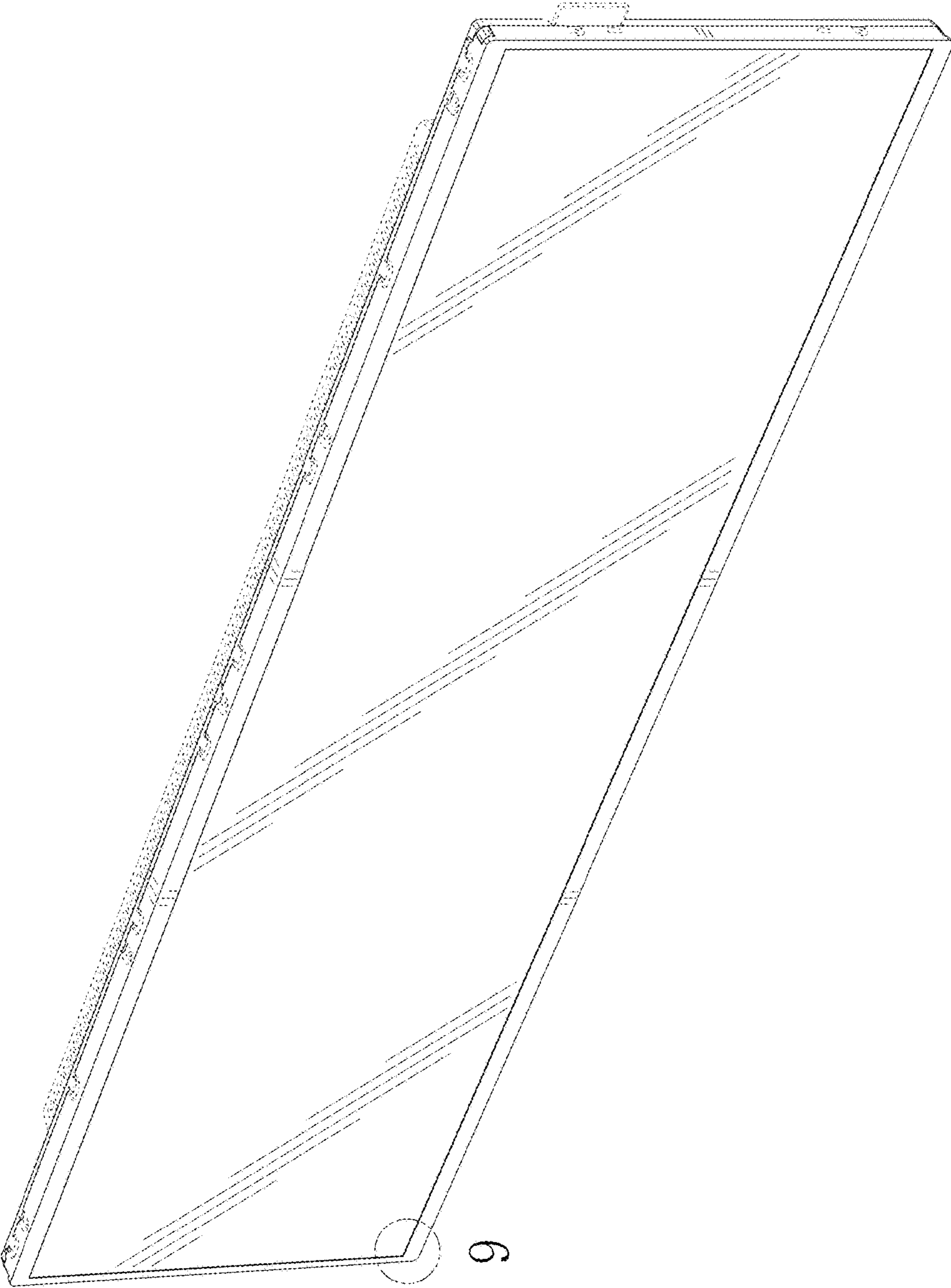

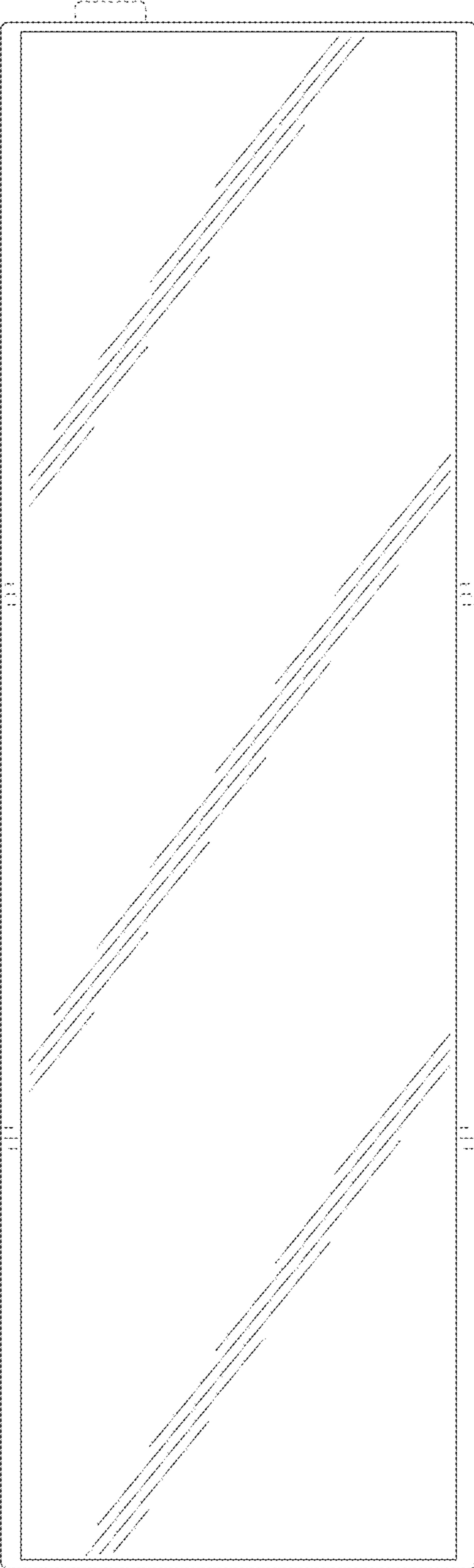

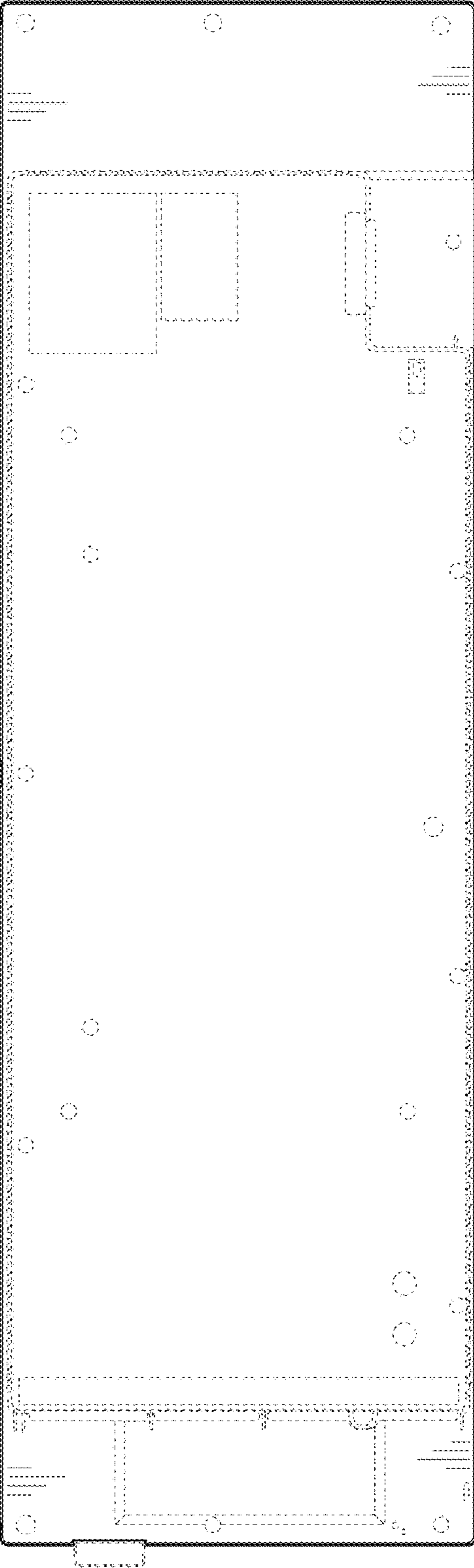

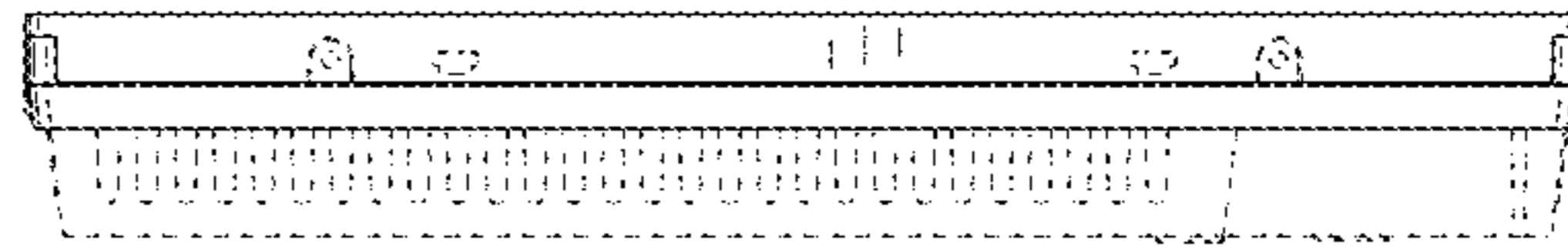

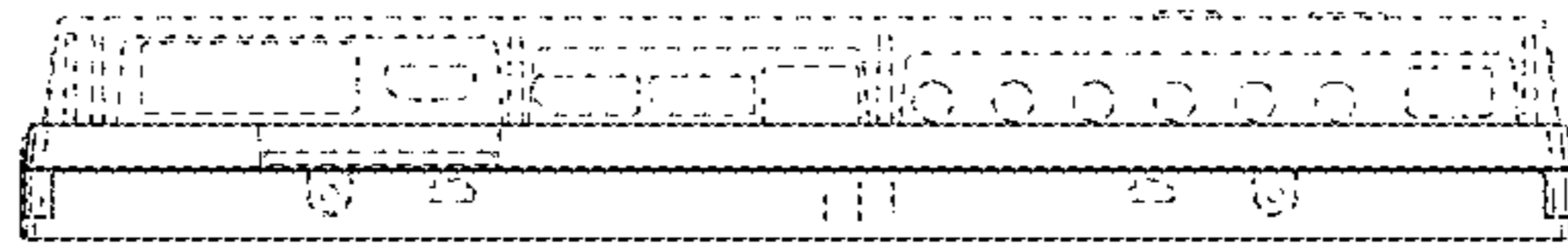

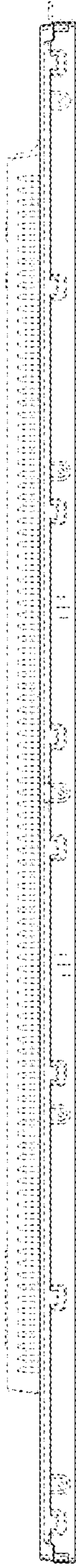

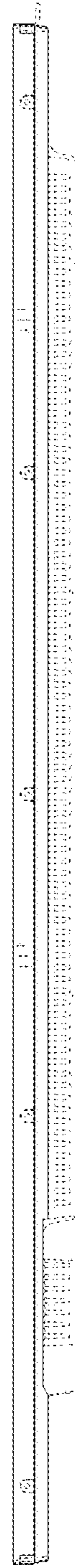

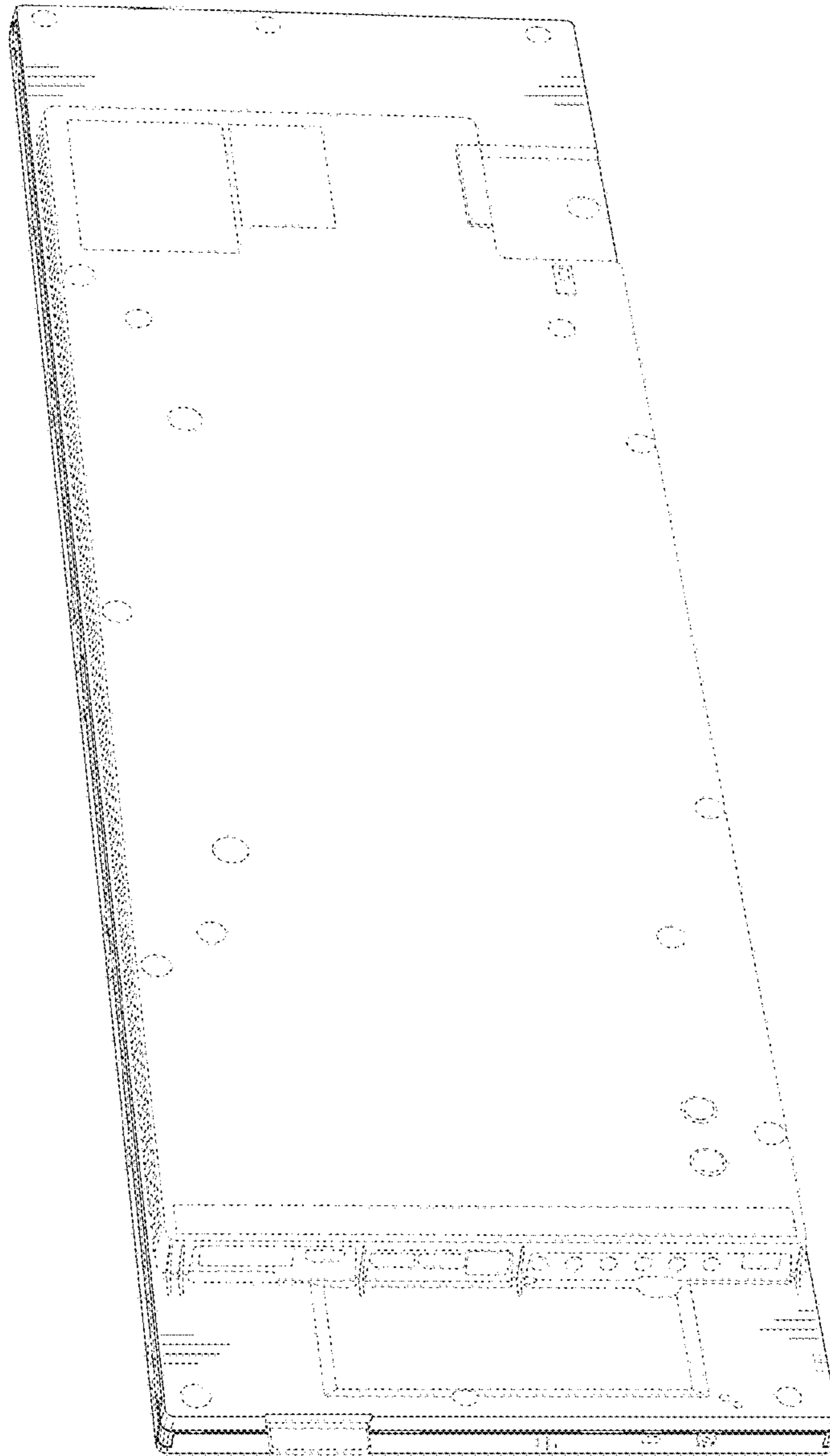
