(57) **CLAIM**

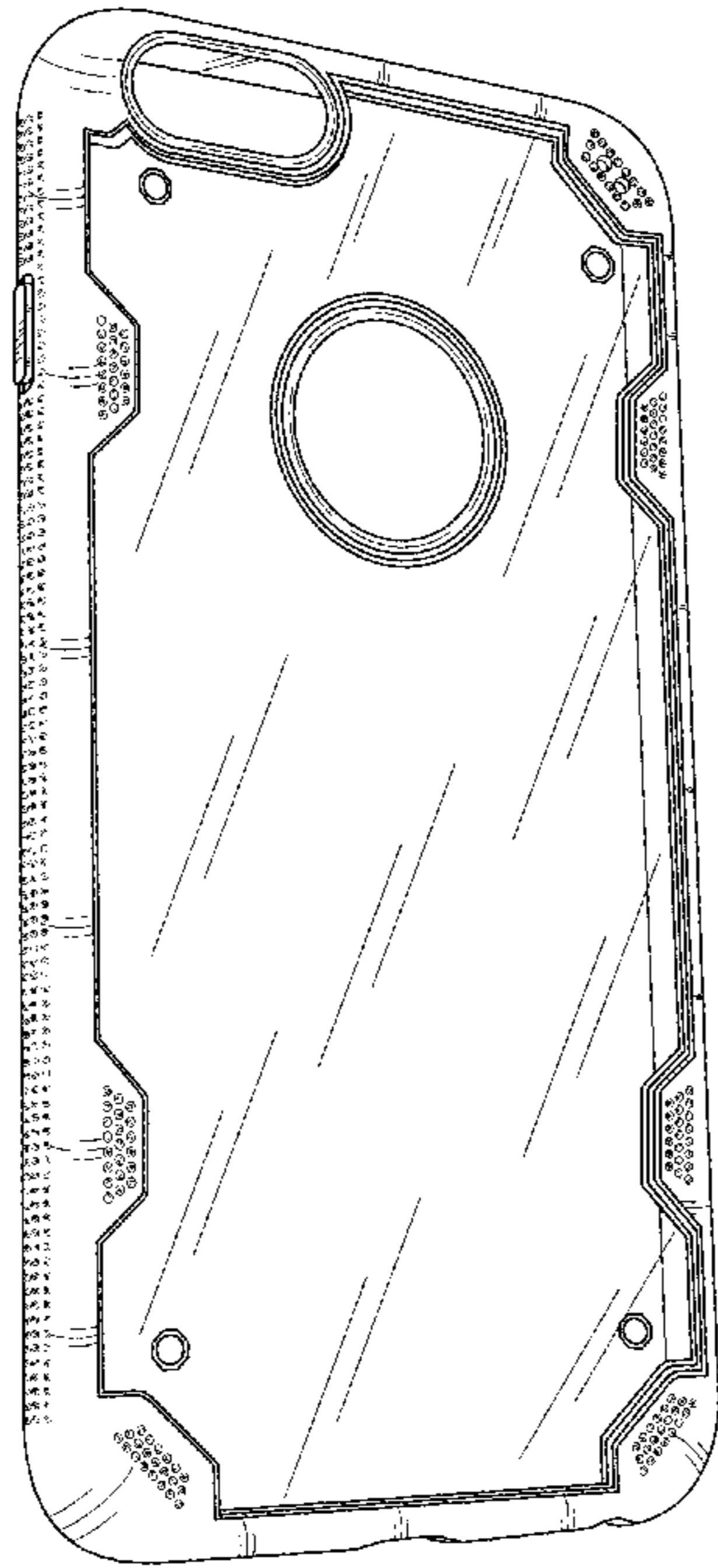
The ornamental design for a hybrid cell phone protector case, as shown and described.

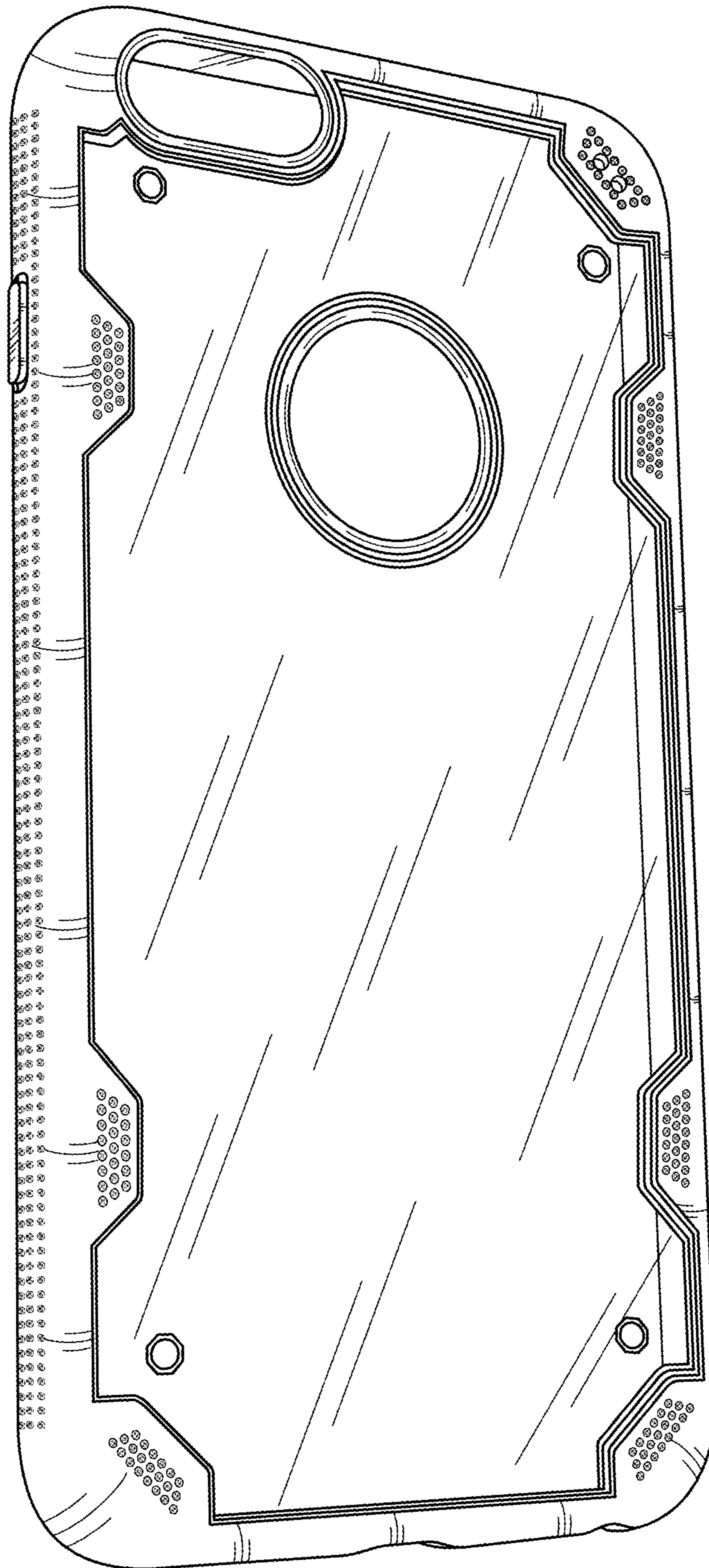

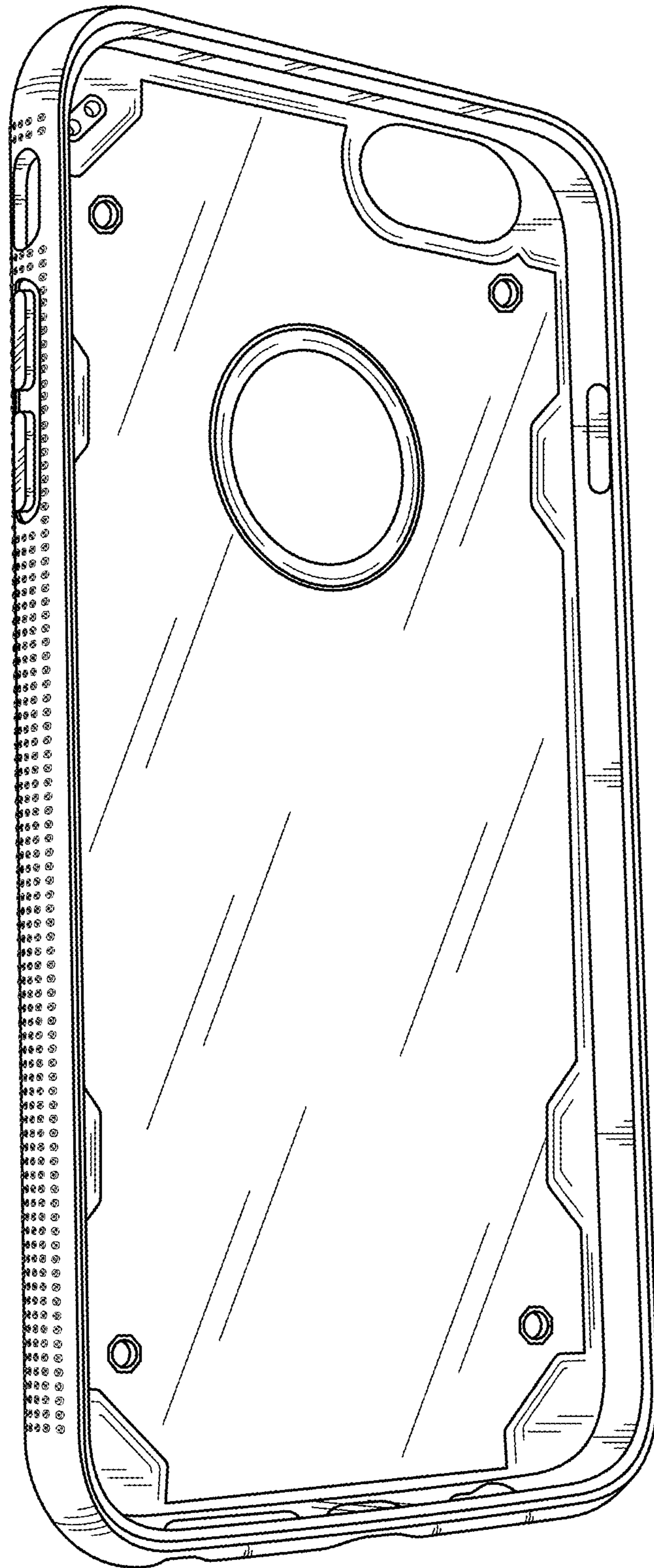

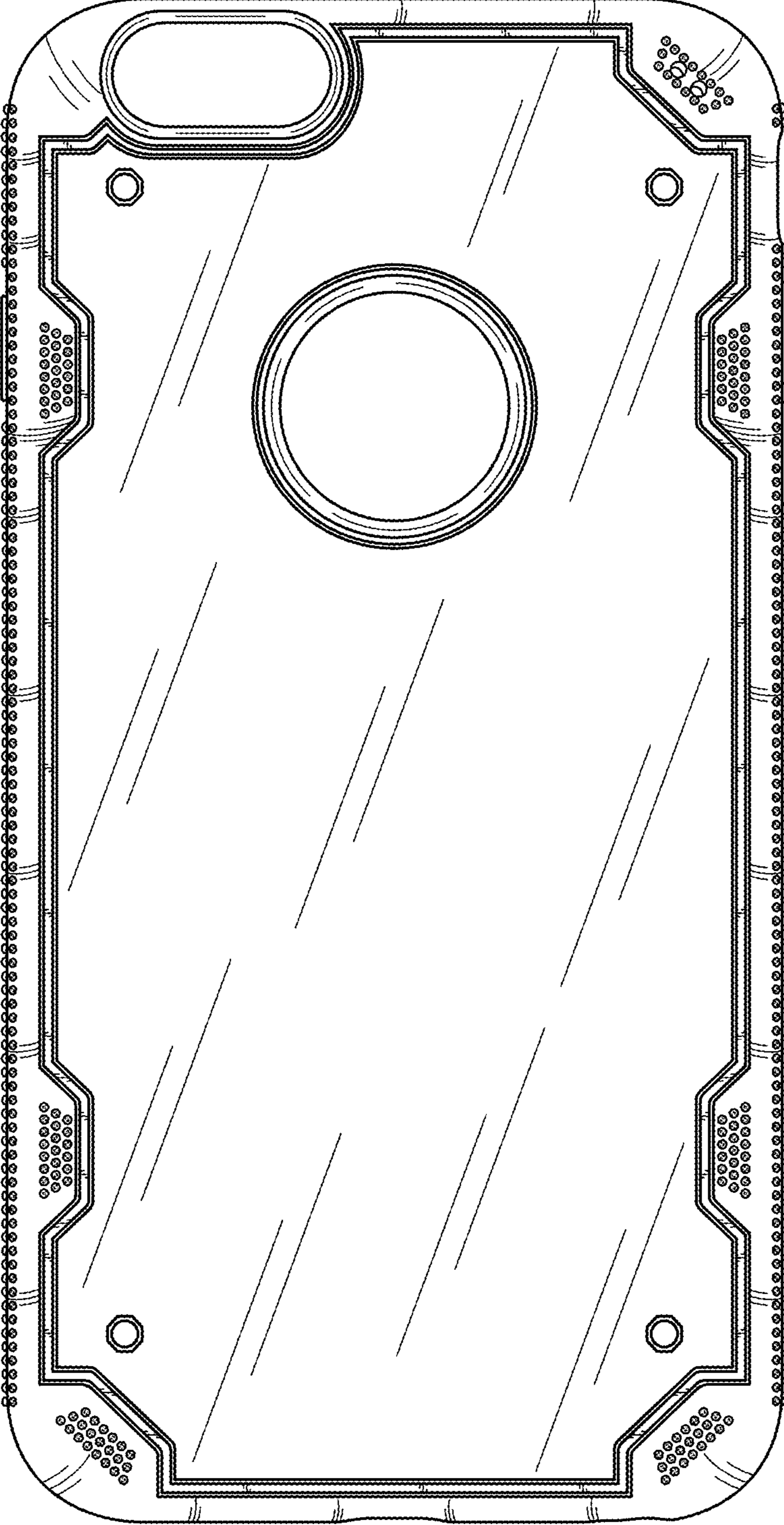

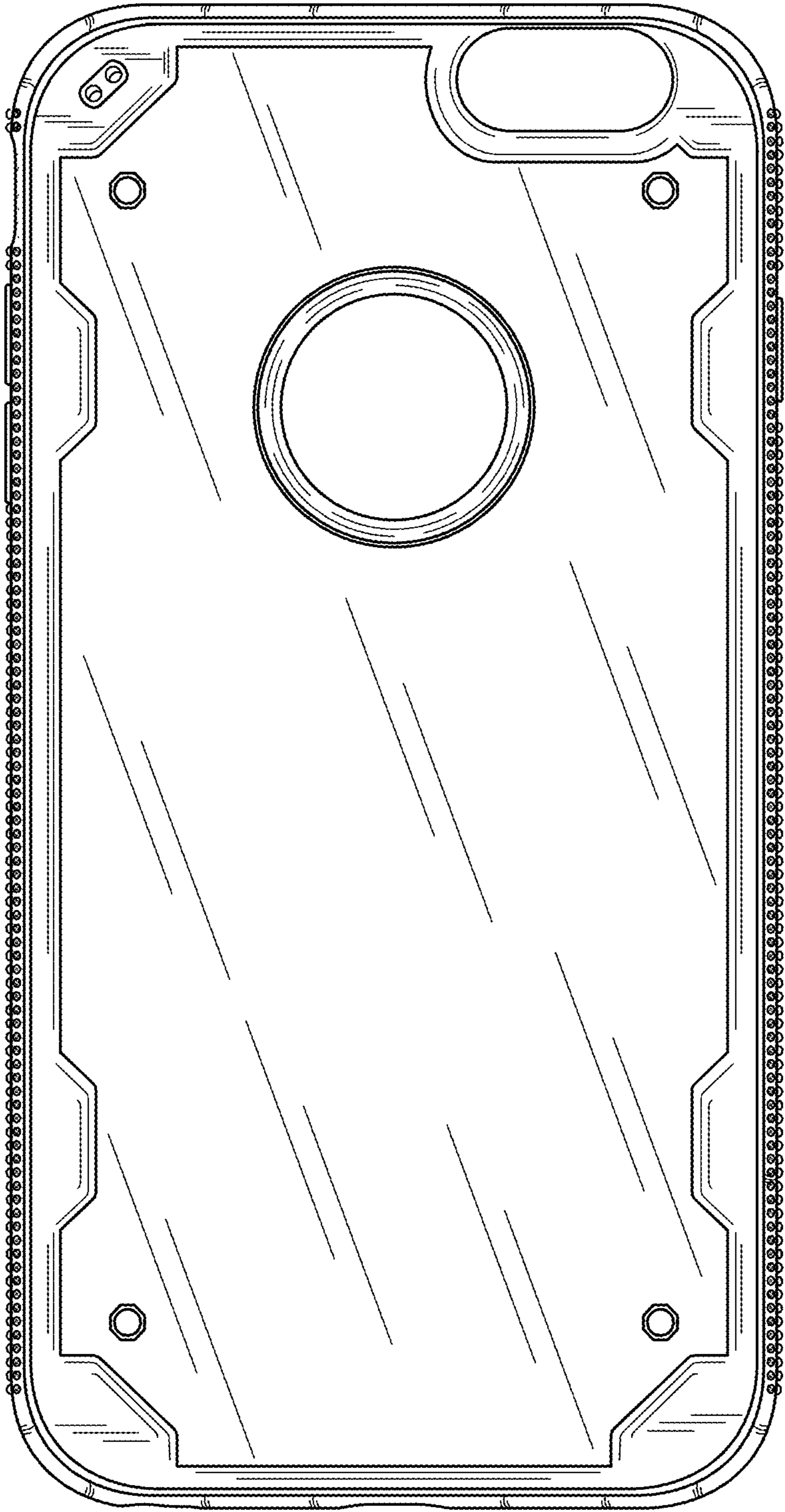

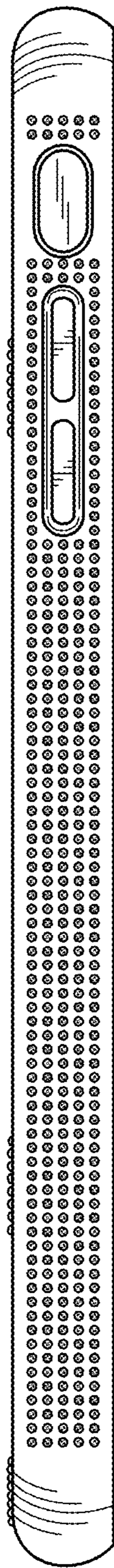

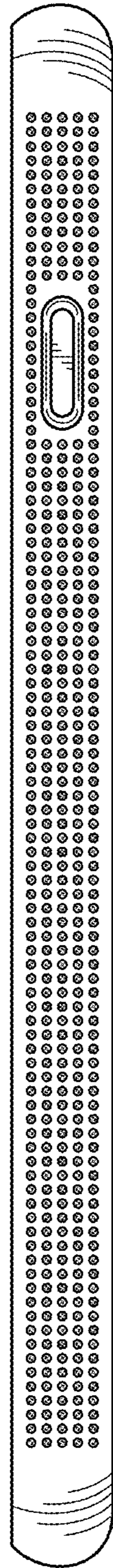

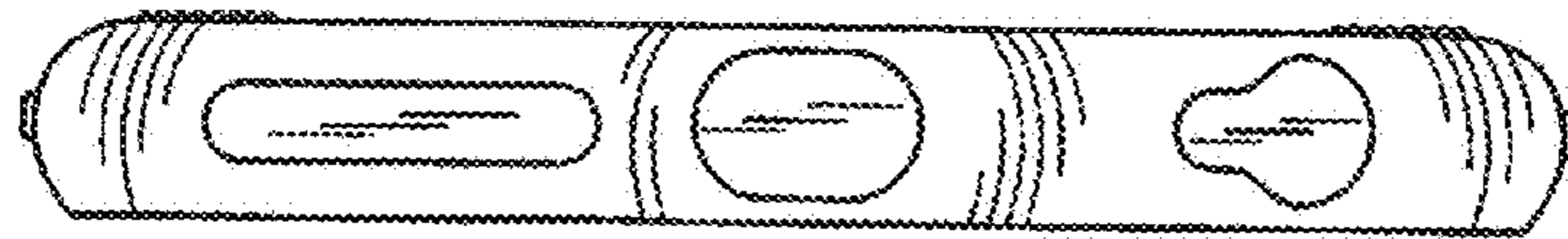

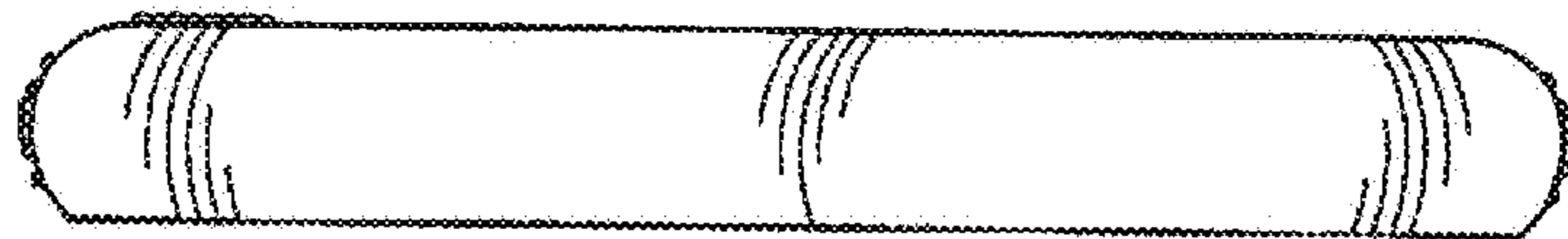
