FIG. 2 is a front view of an embodiment of a display screen or portion thereof with graphical user interface;

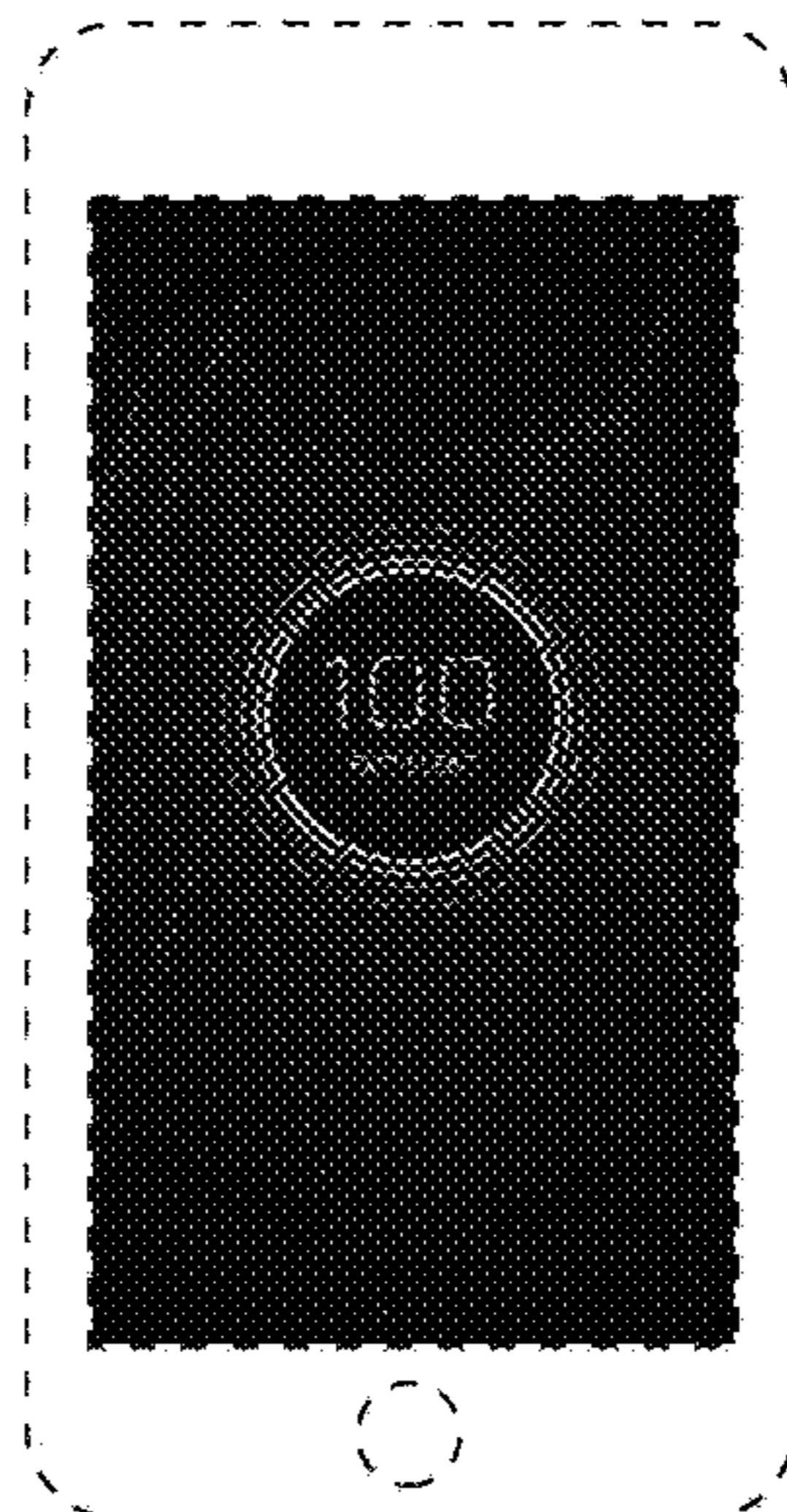
FIG. 3 is a front view of an embodiment of a display screen or portion thereof with graphical user interface;

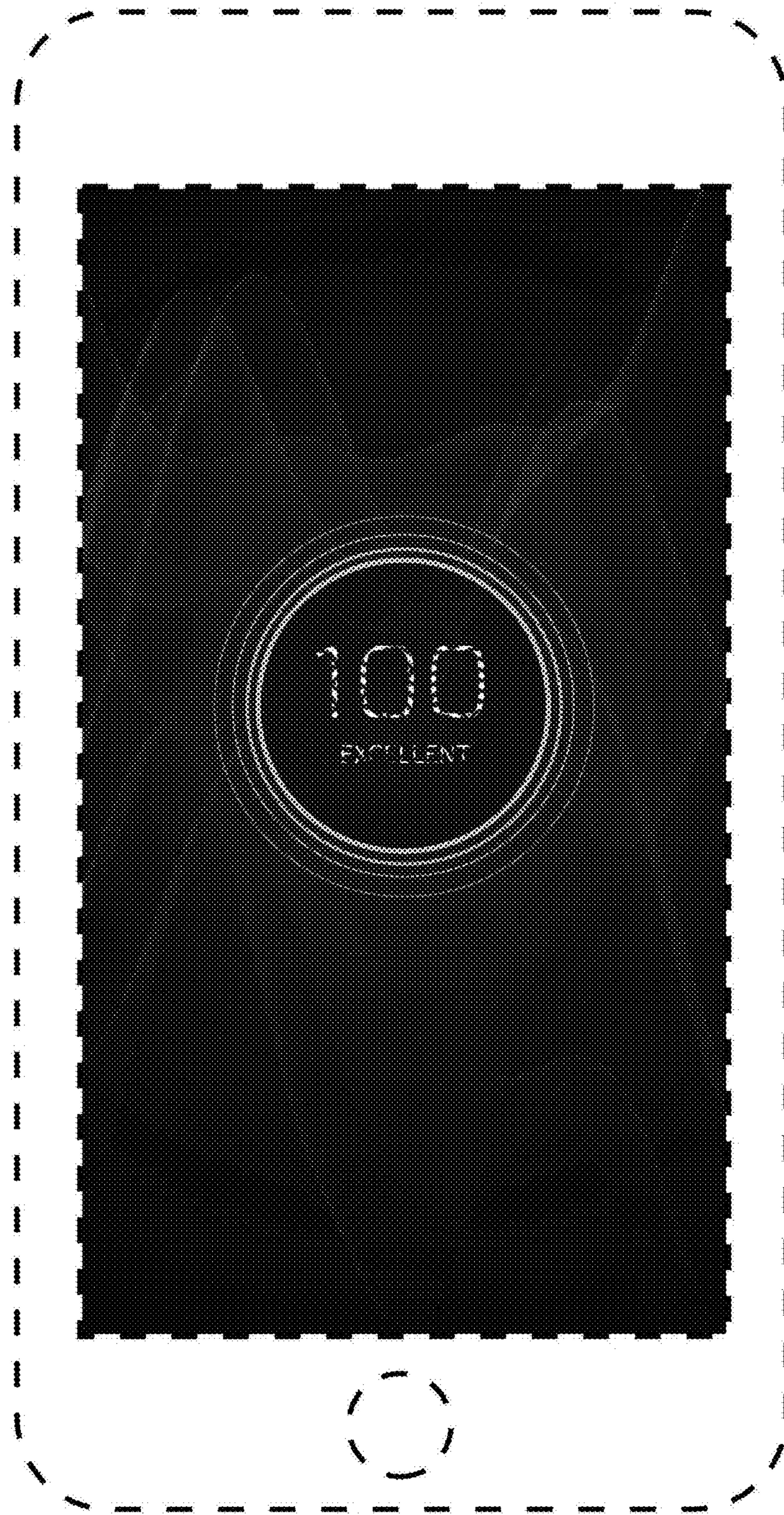

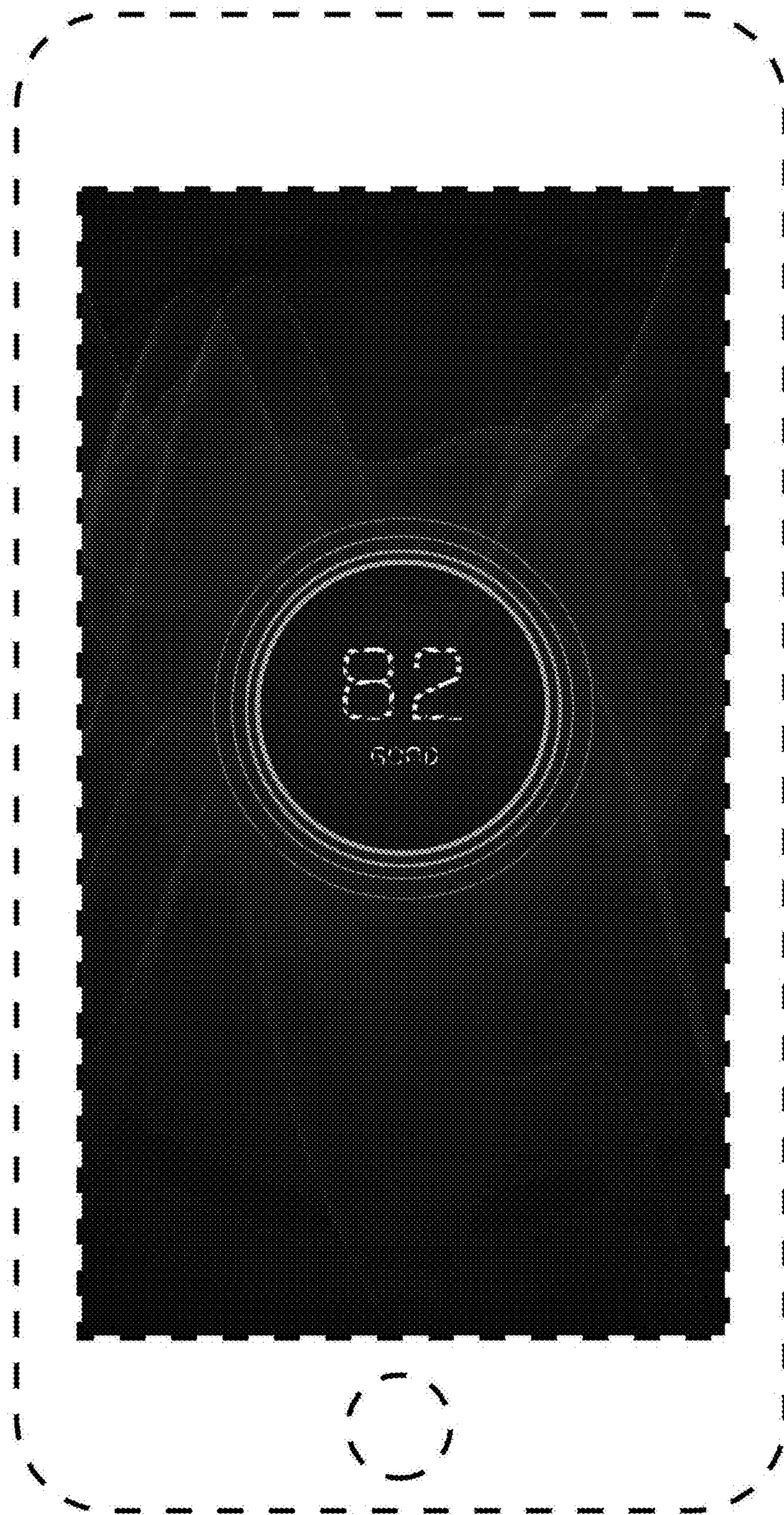

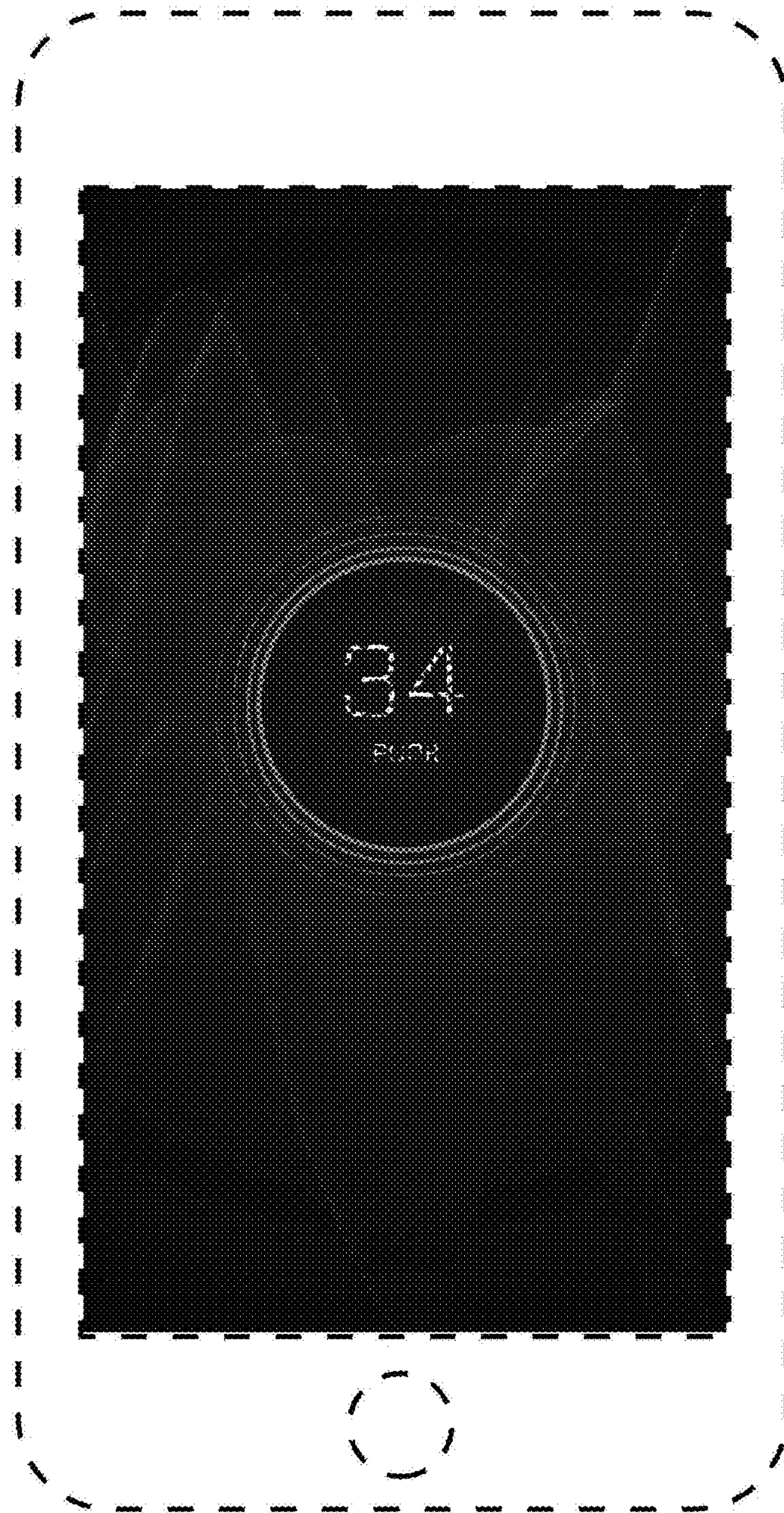
