DESCRIPTION

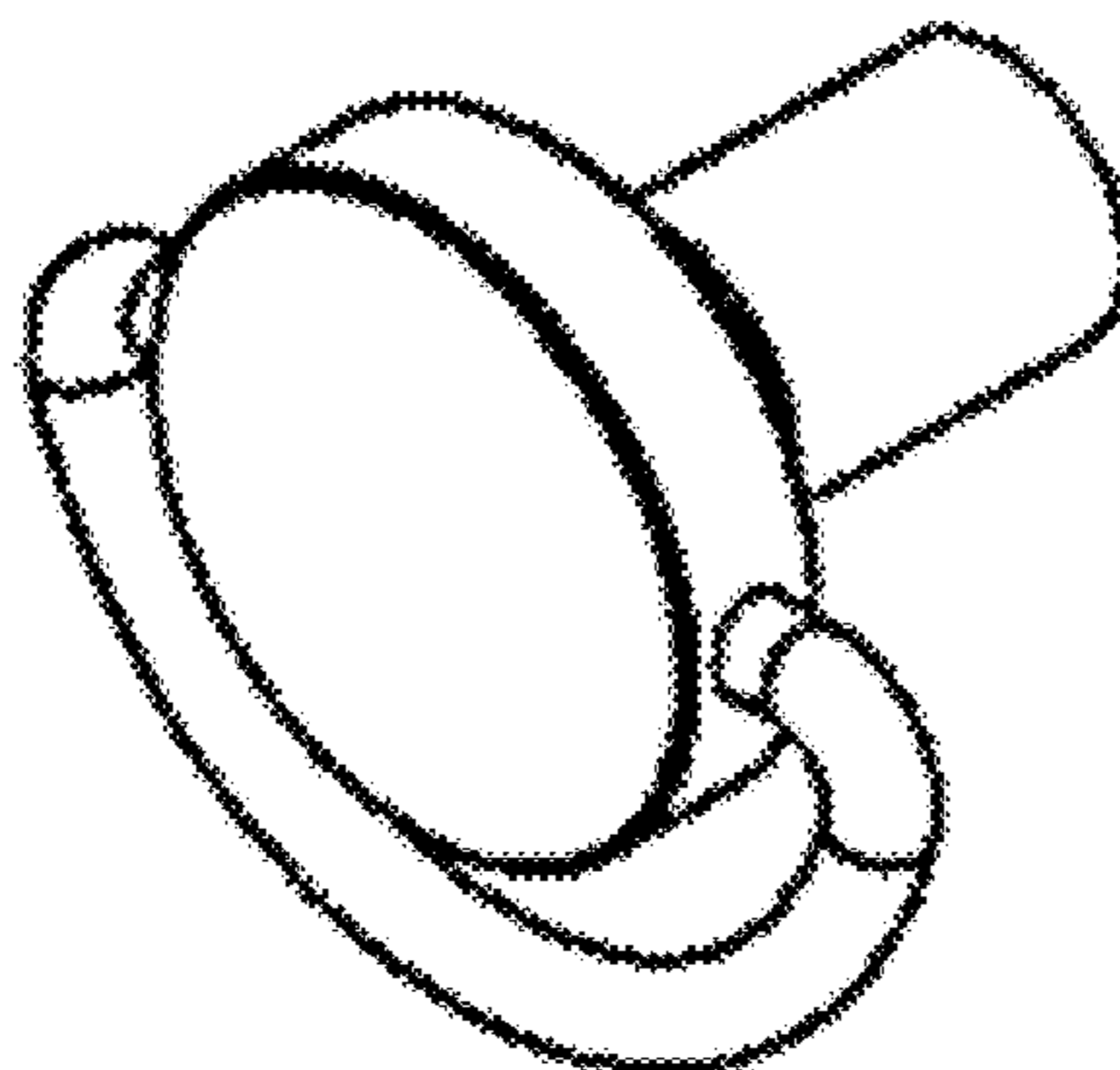
FIG. 1 is a front, right, and top perspective view of a coupling screw for portable camera showing our new design;

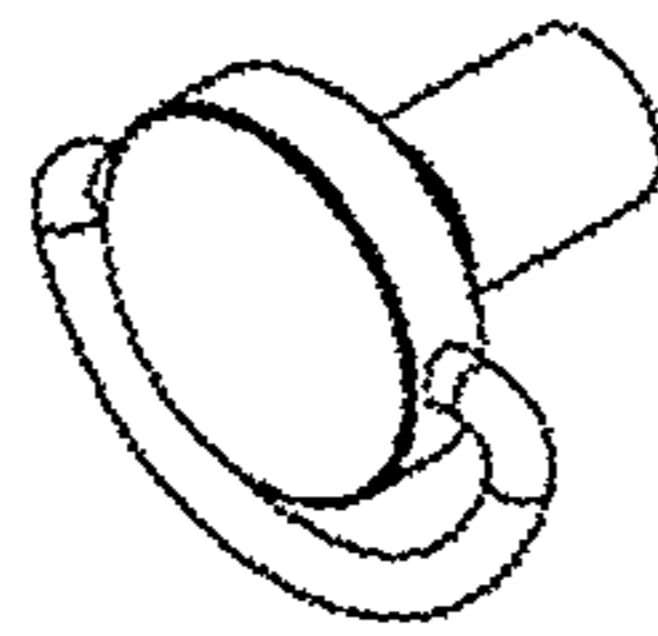

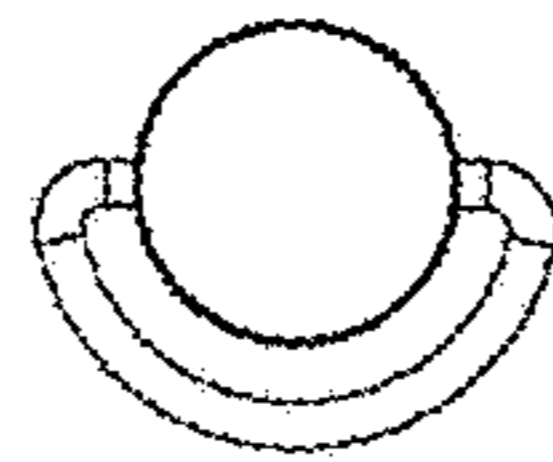

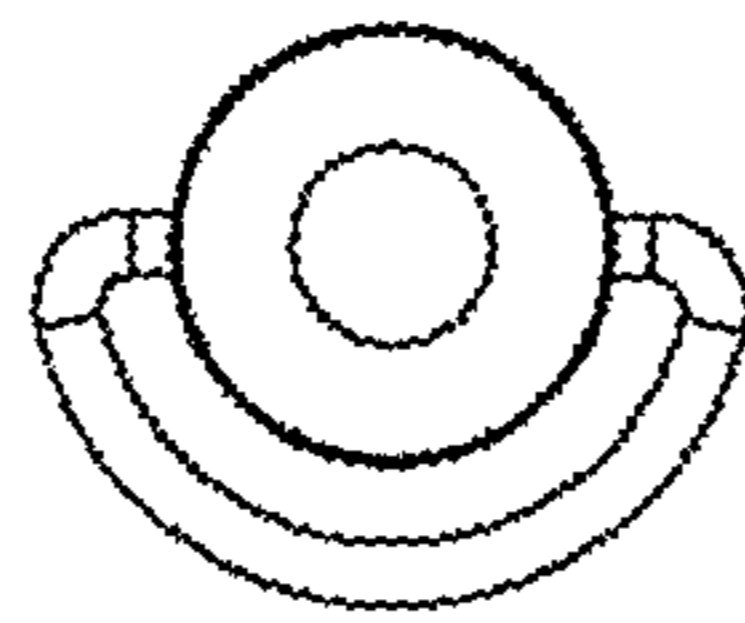

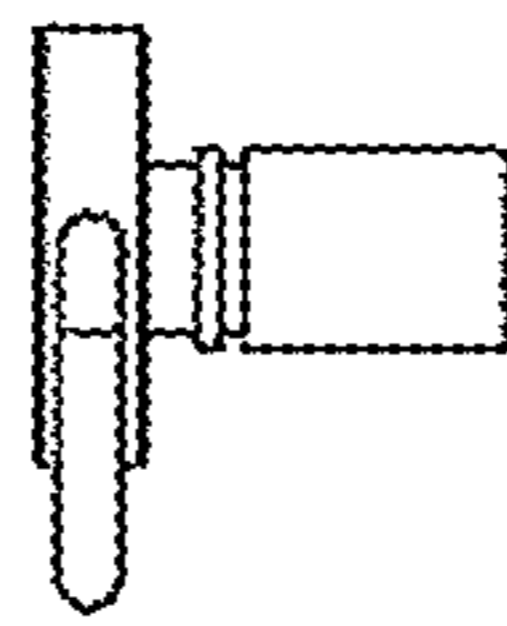

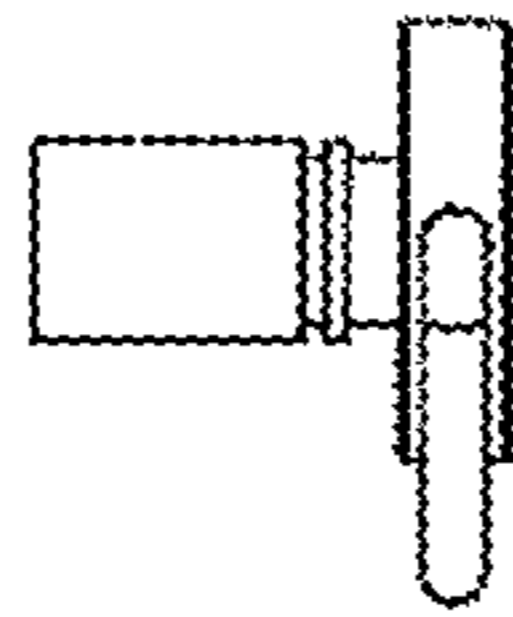

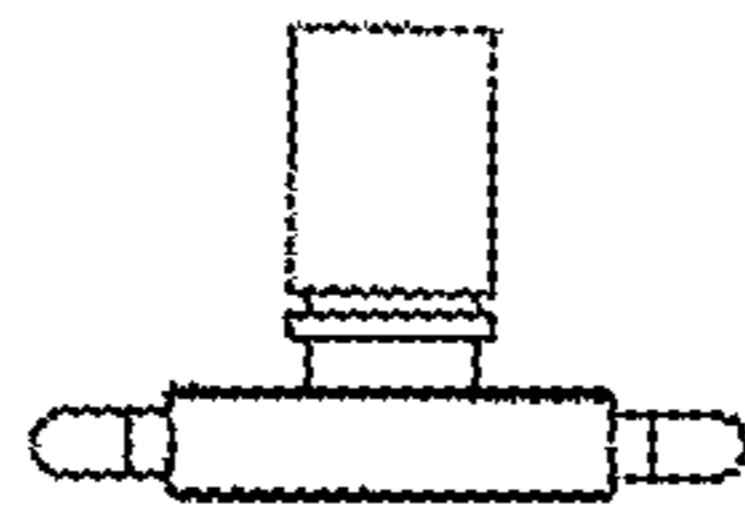

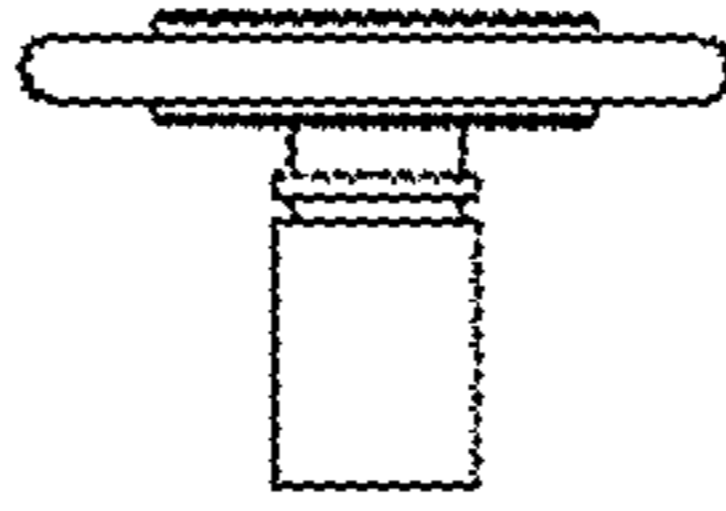
