FIG. 4 is a front view of the razor seal in FIG. 3, shown in color thereof.

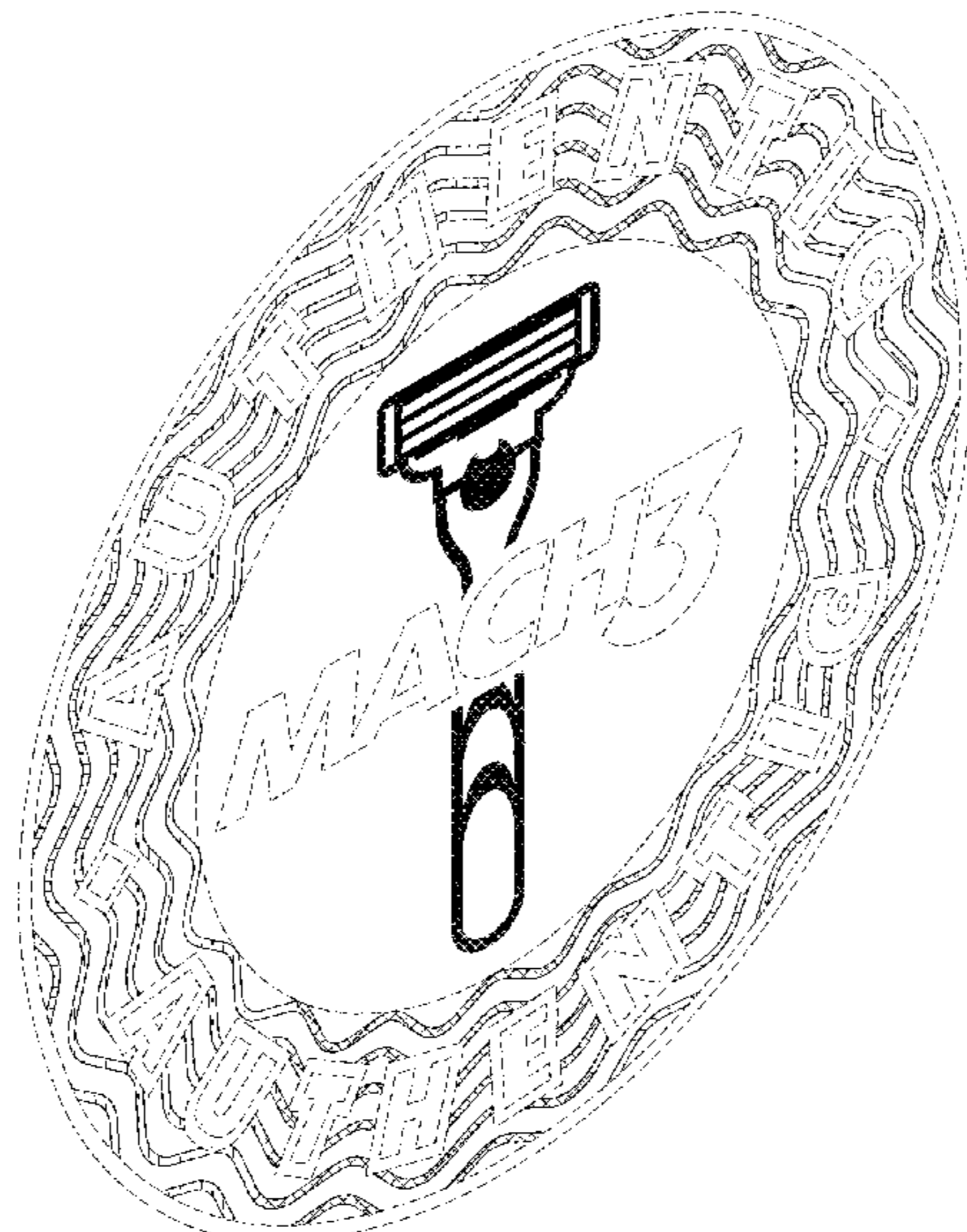
The broken line showing of elements on the razor seal illustrate portions of the article and form no part of the claimed design.

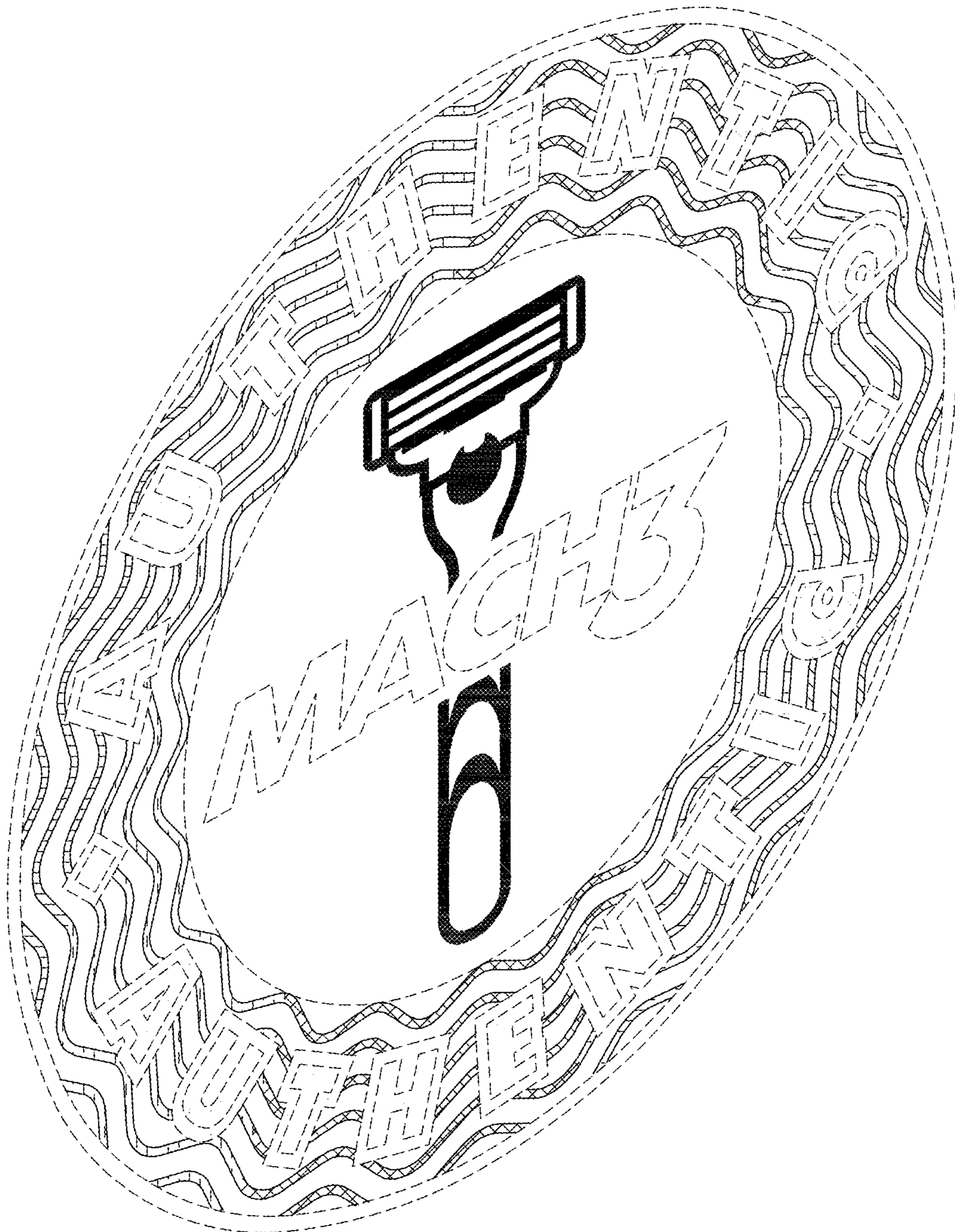

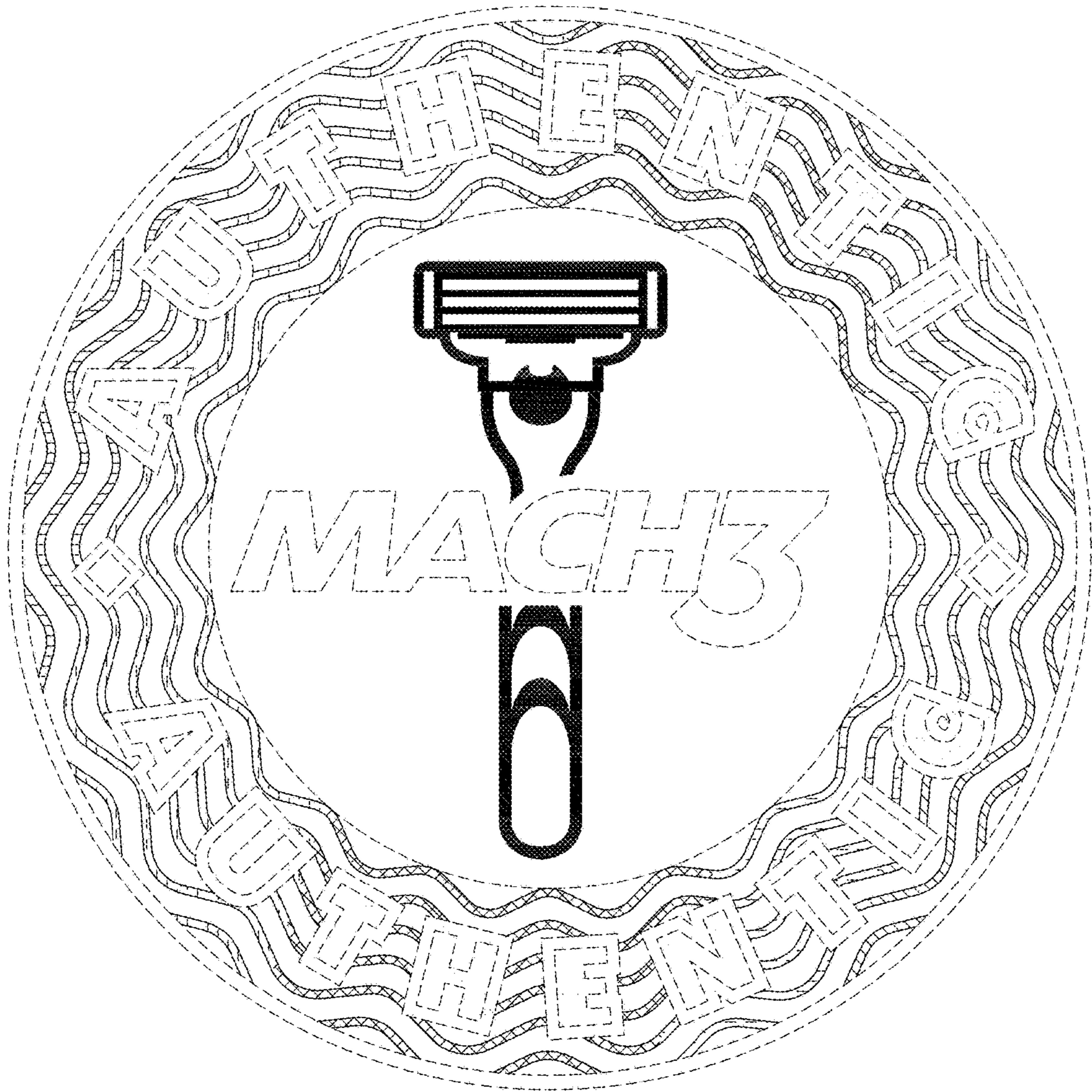

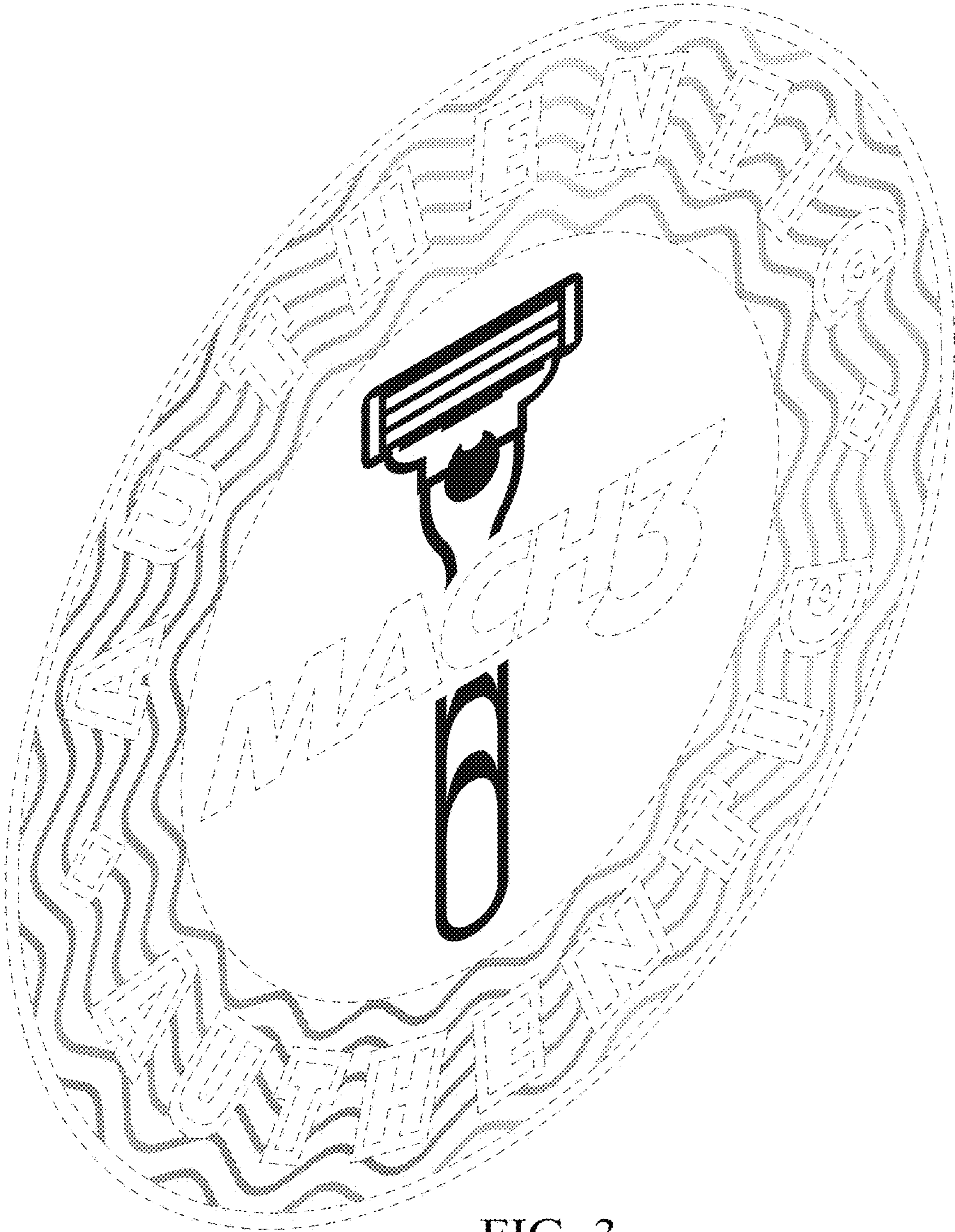
