DESCRIPTION

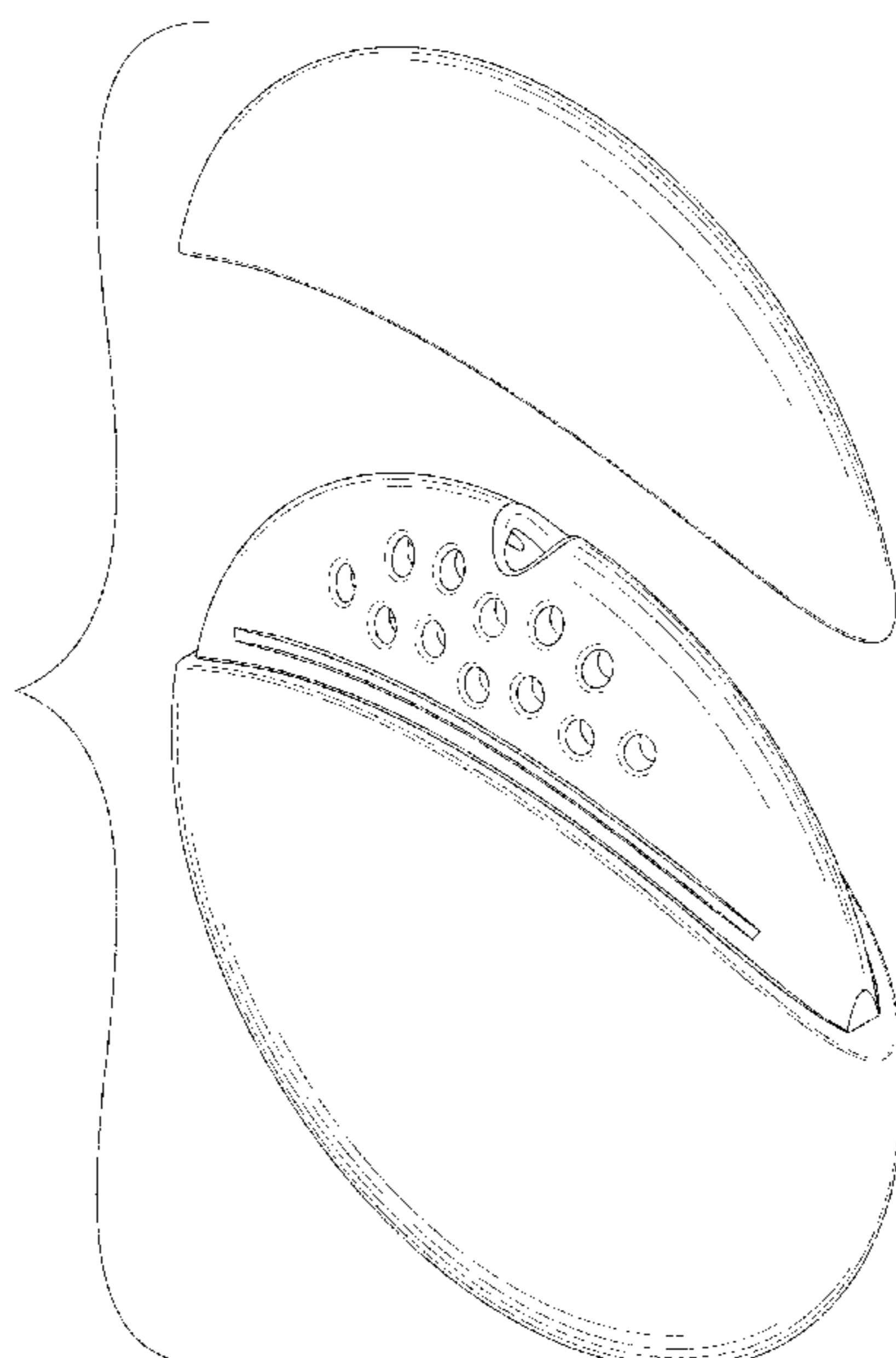
FIG. 1 is an exploded isometric view of an inhaler showing my new design;

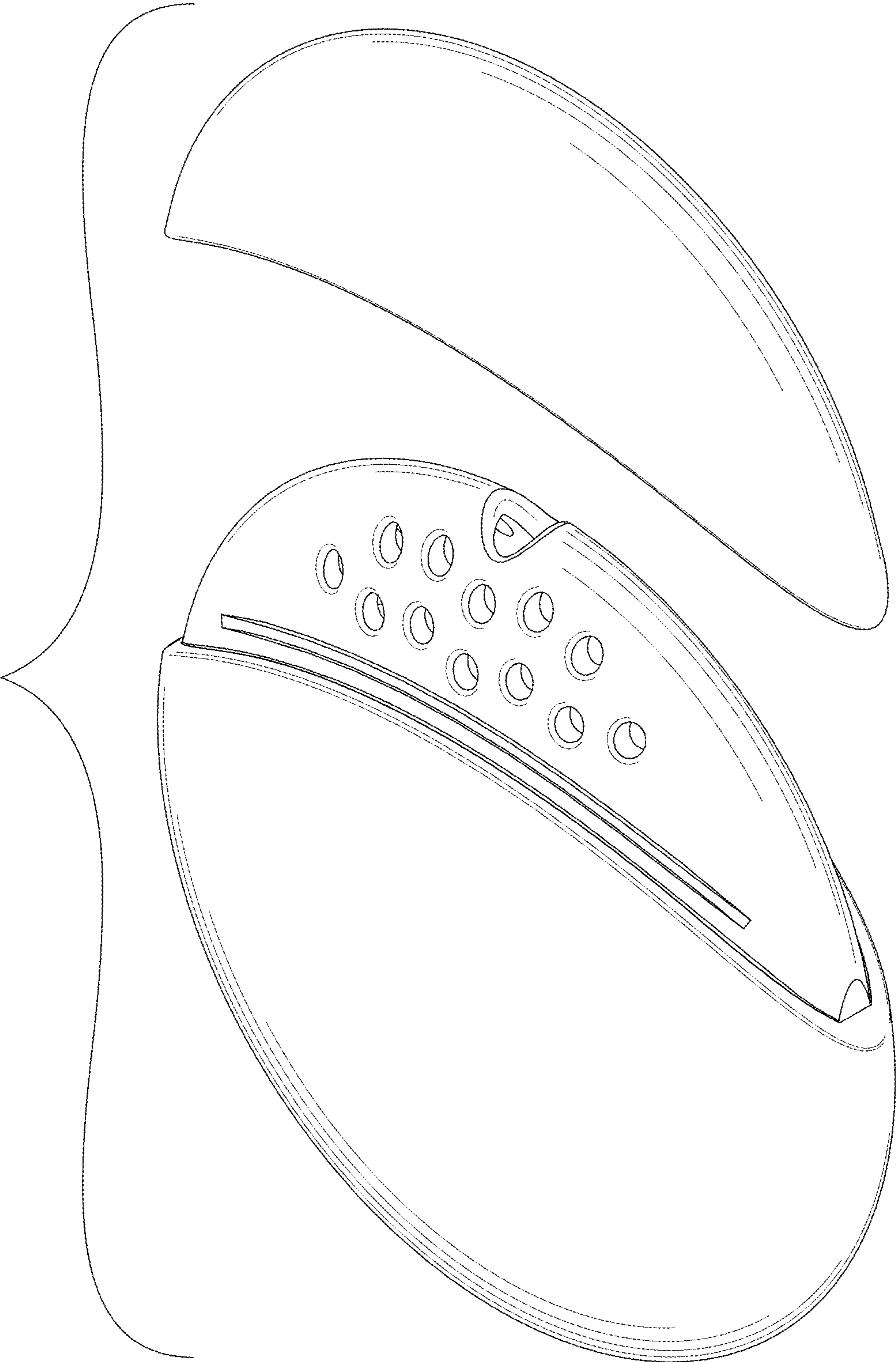

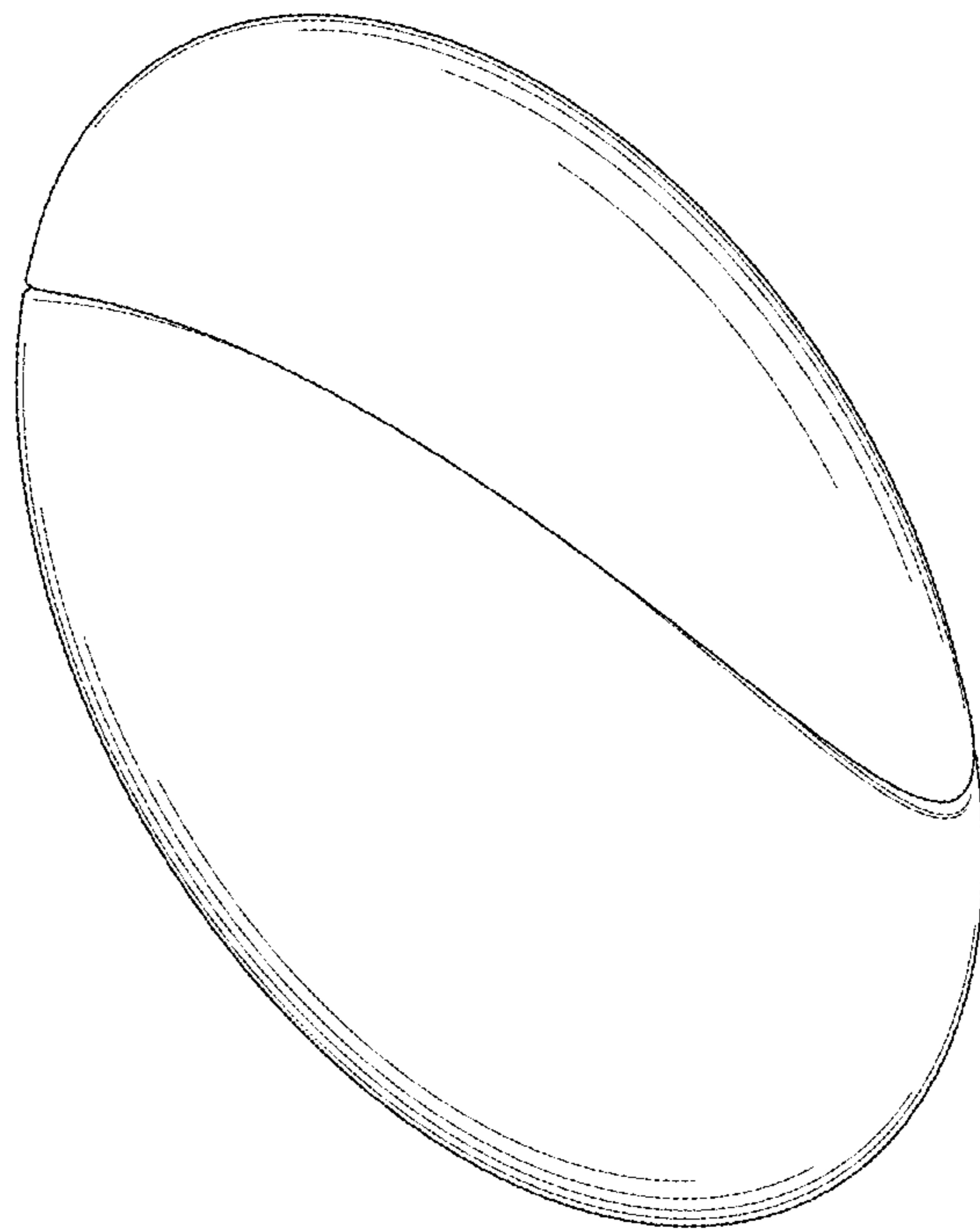

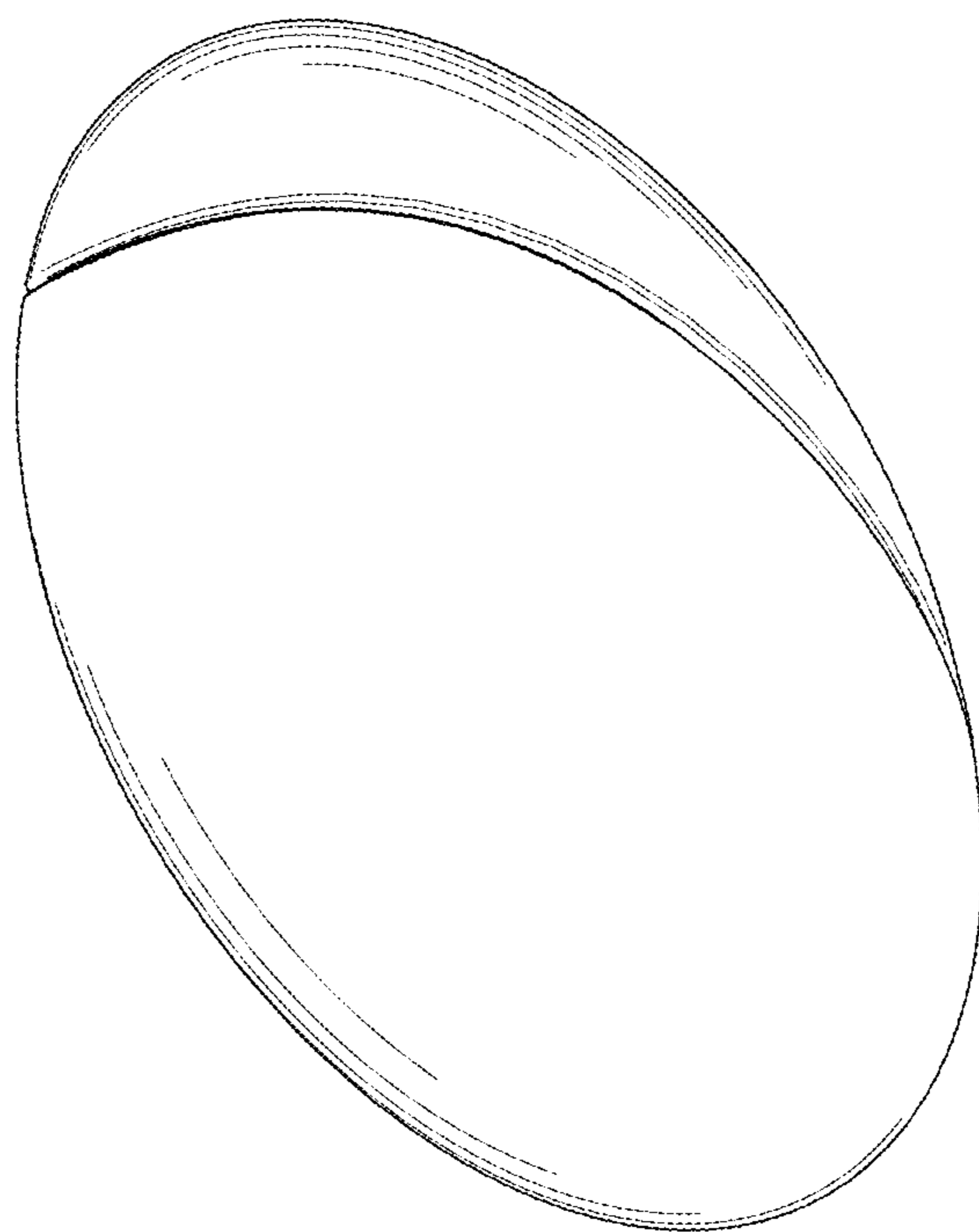

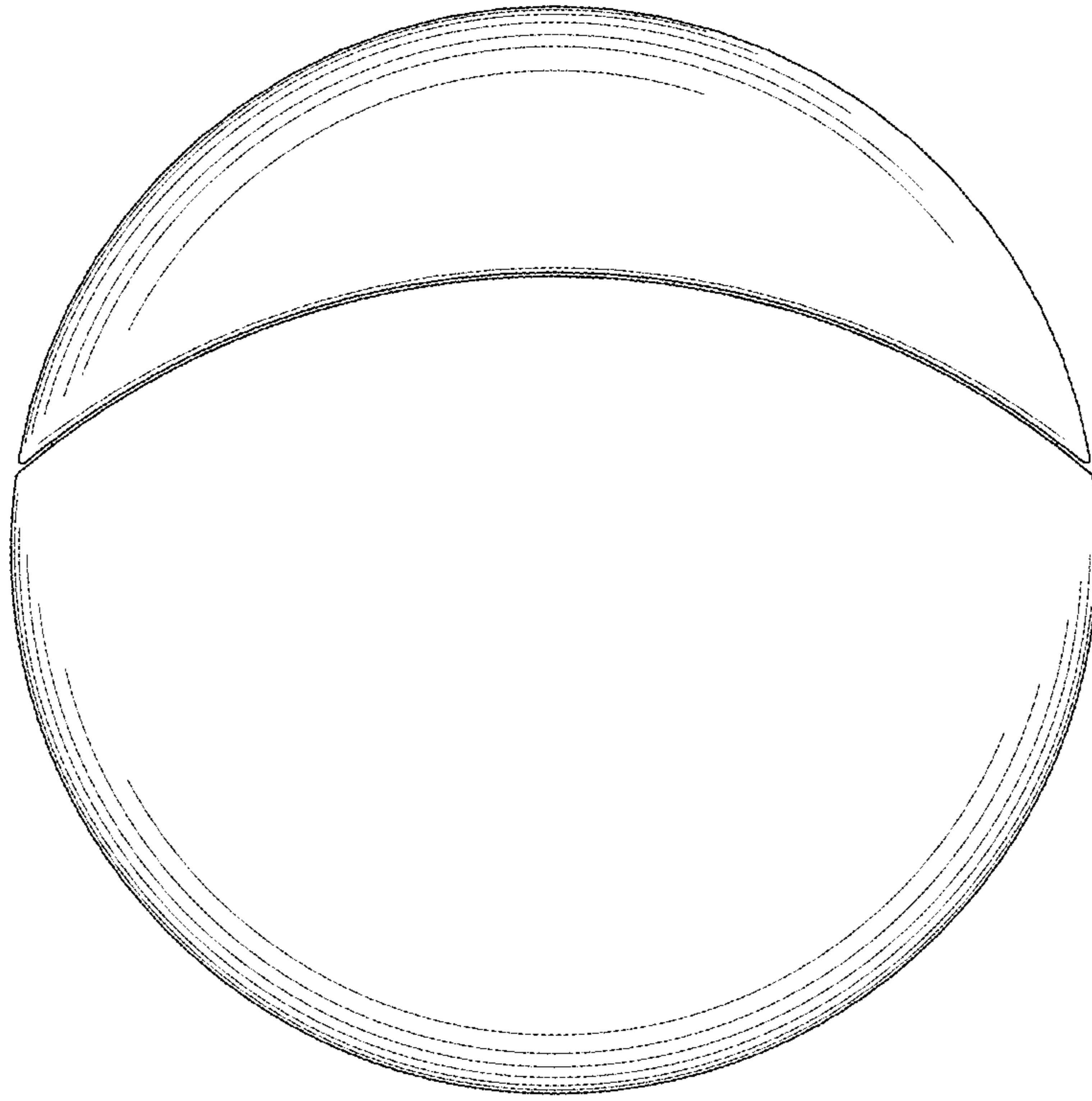

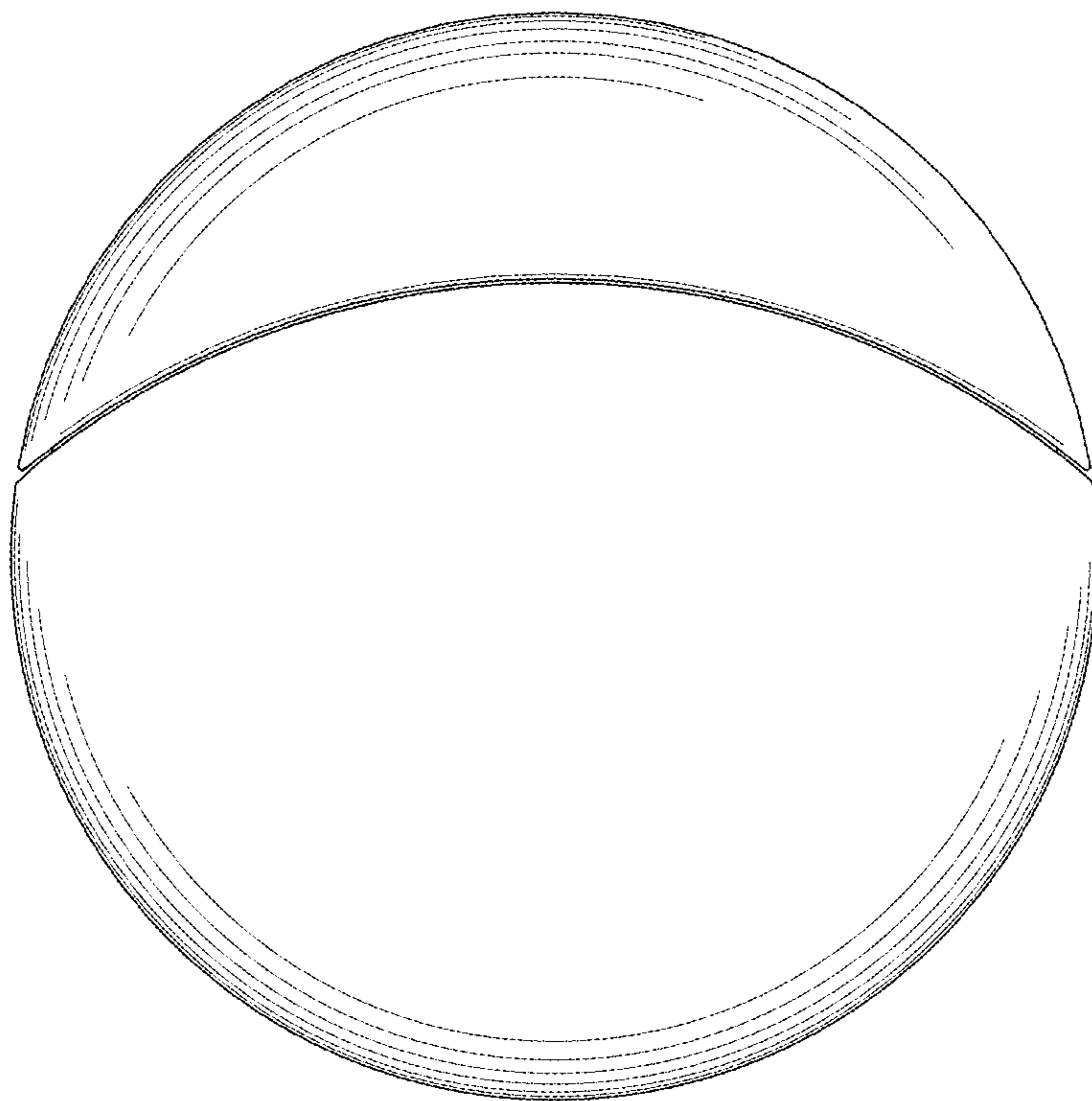

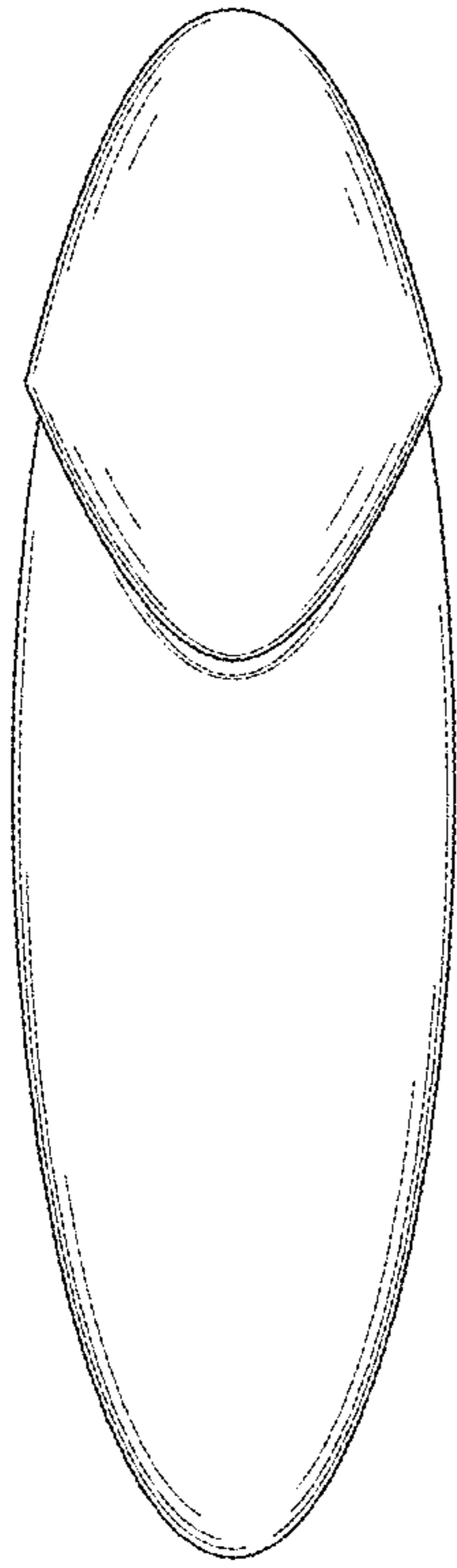

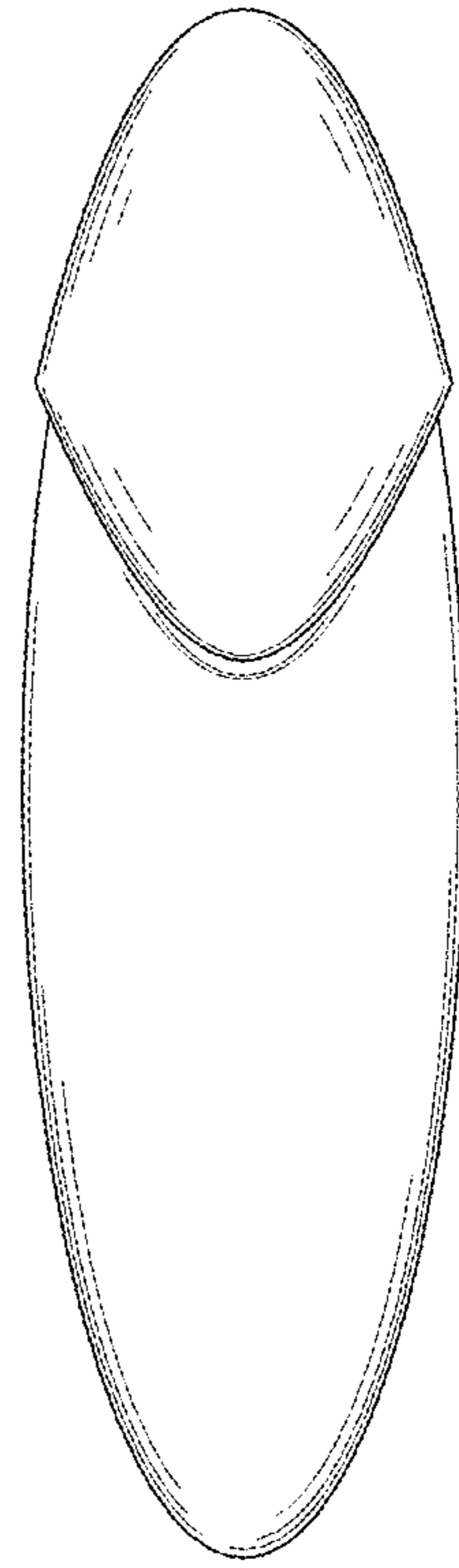

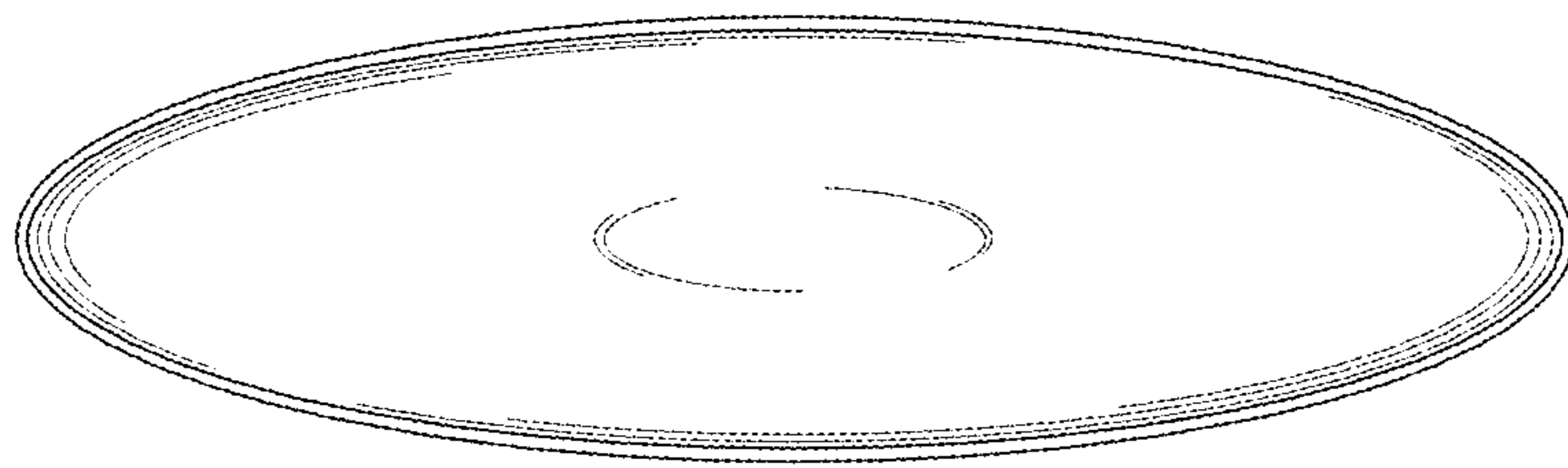

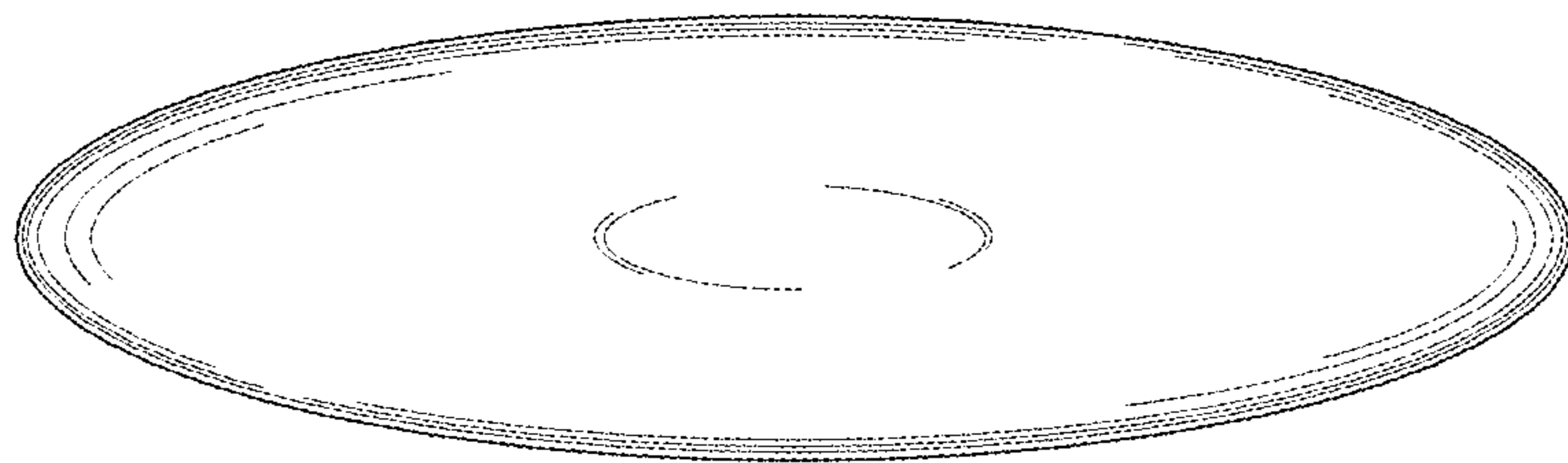

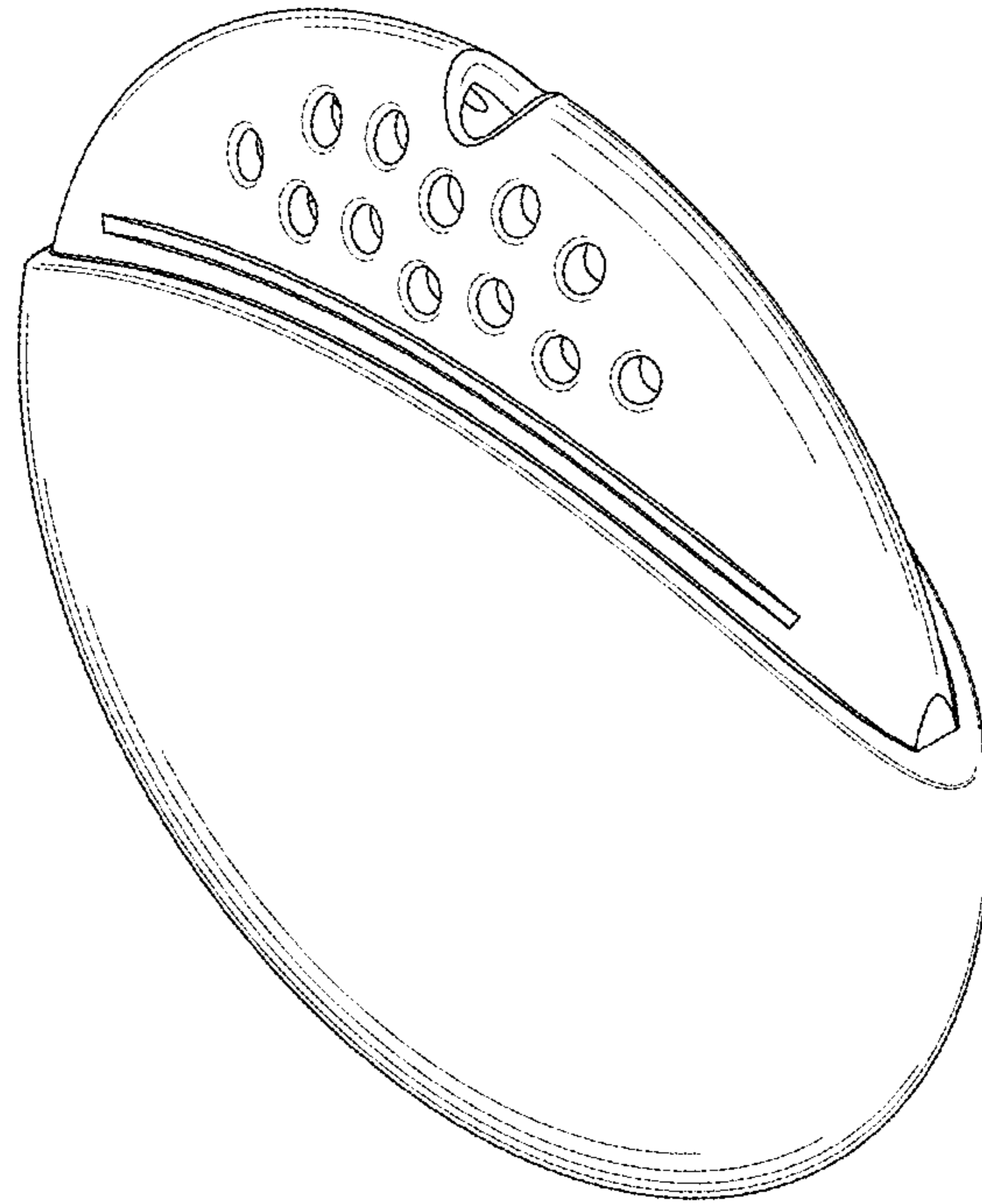

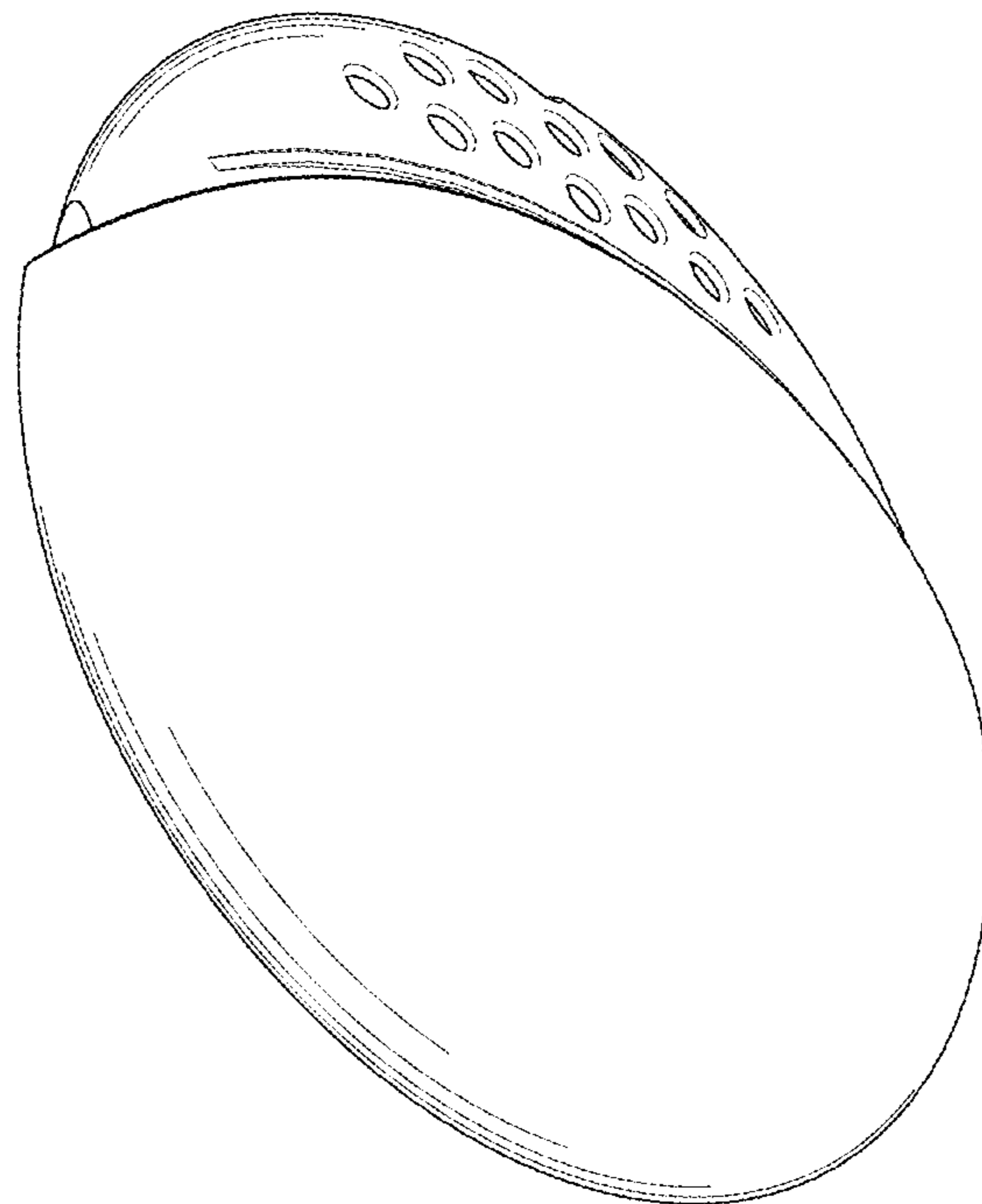

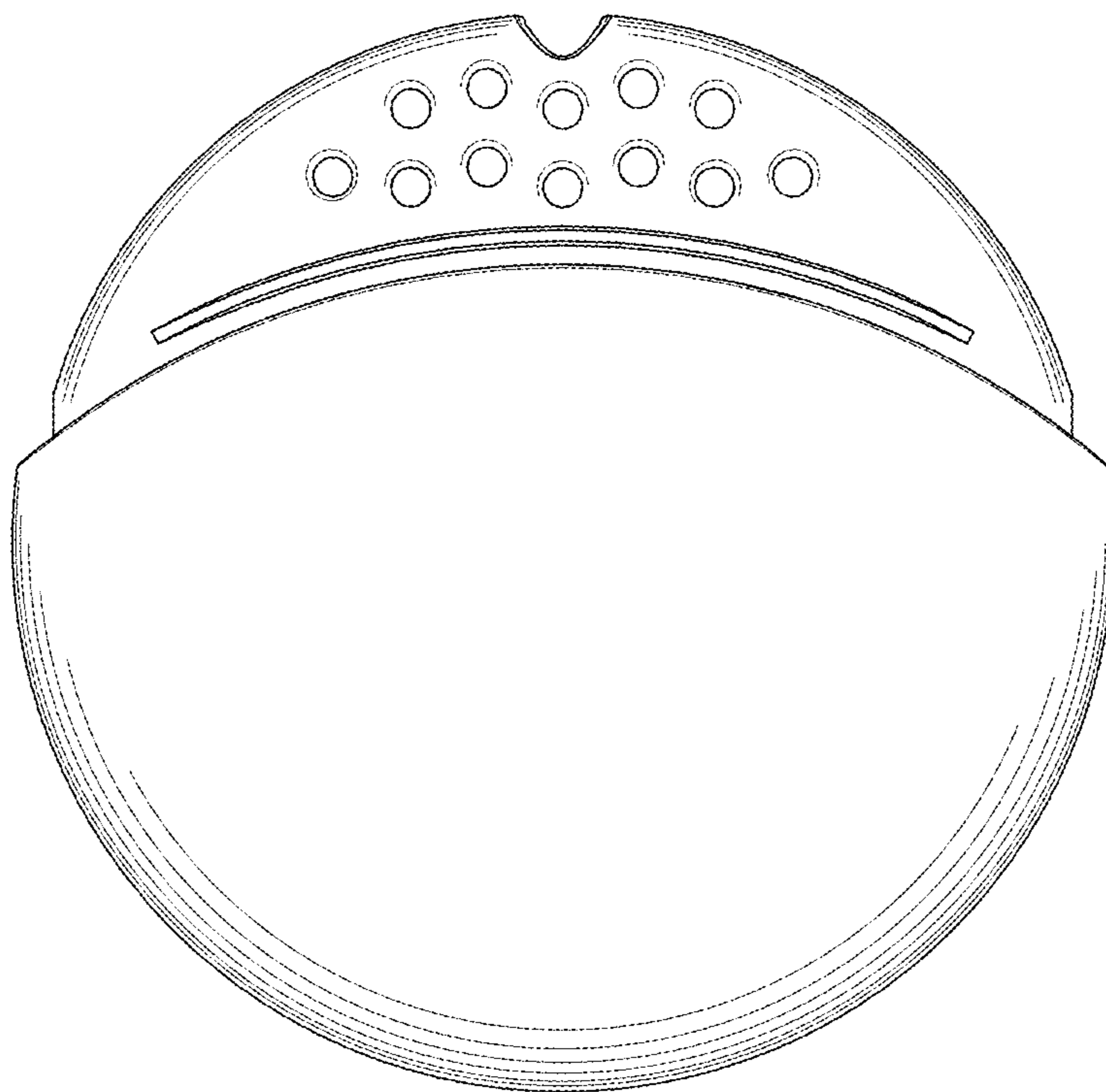

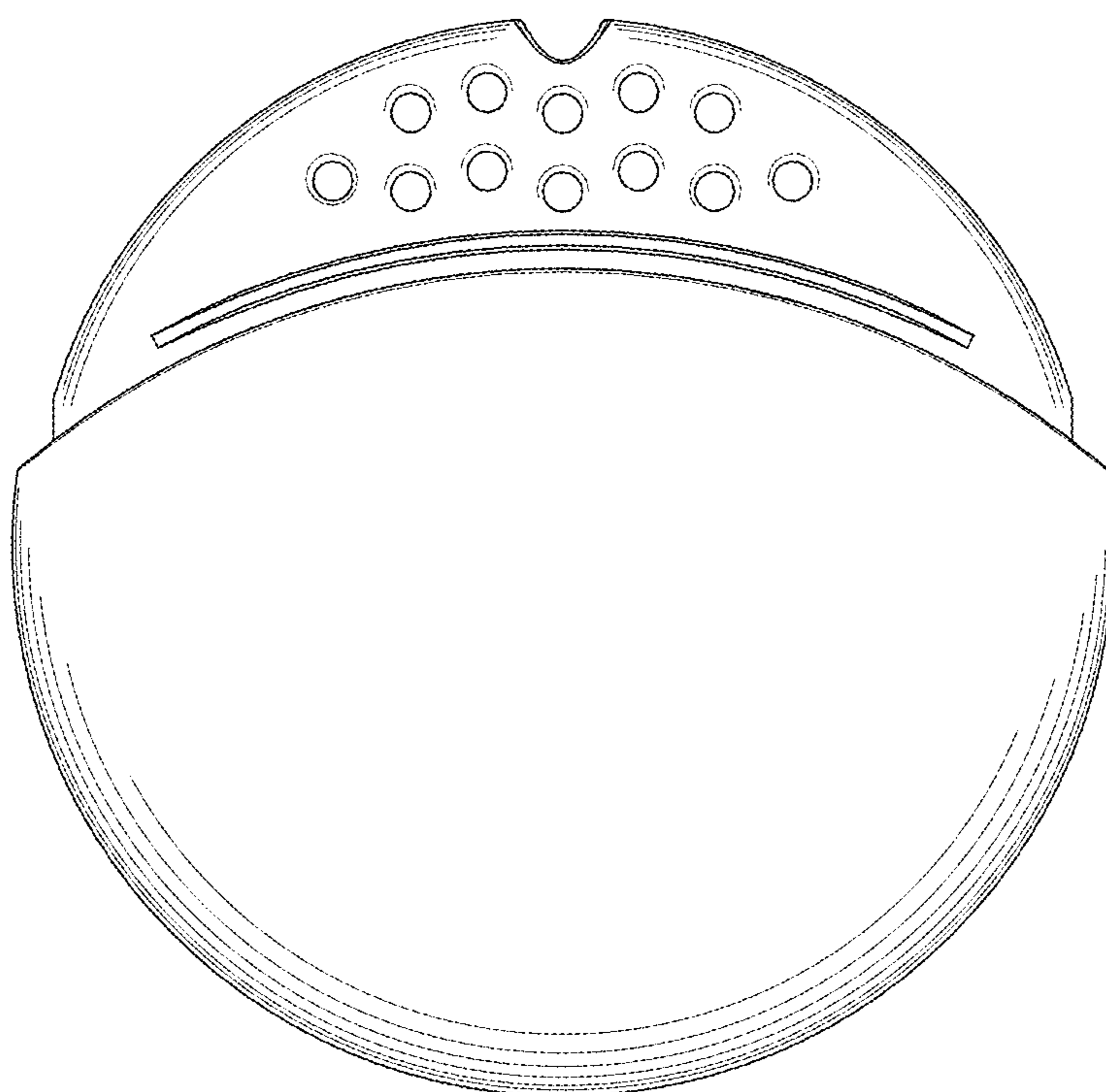

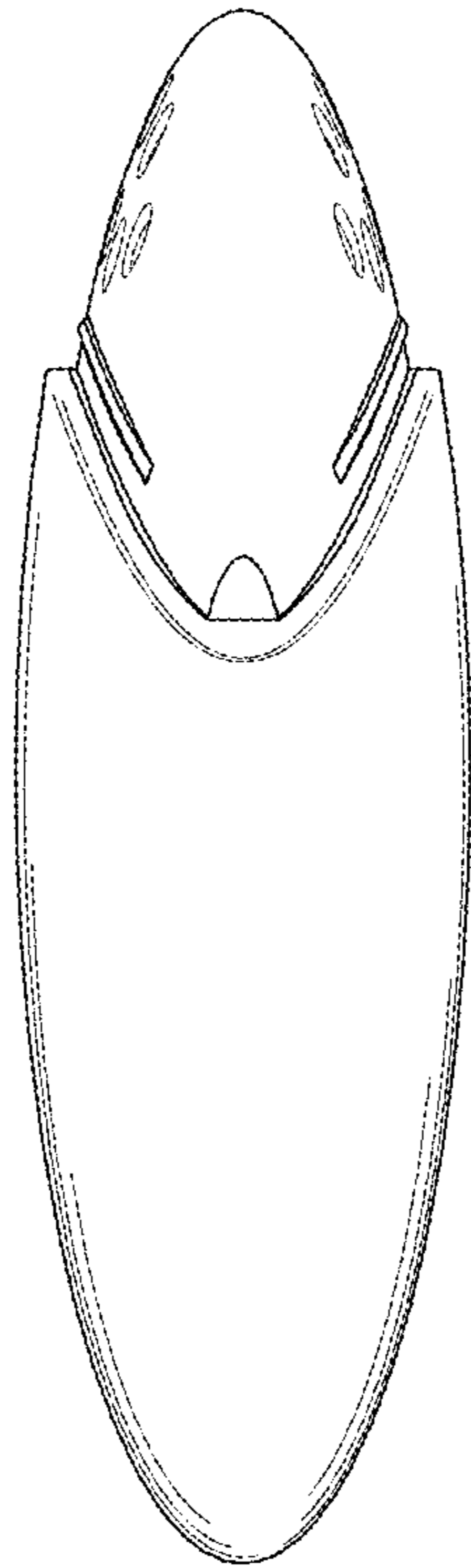

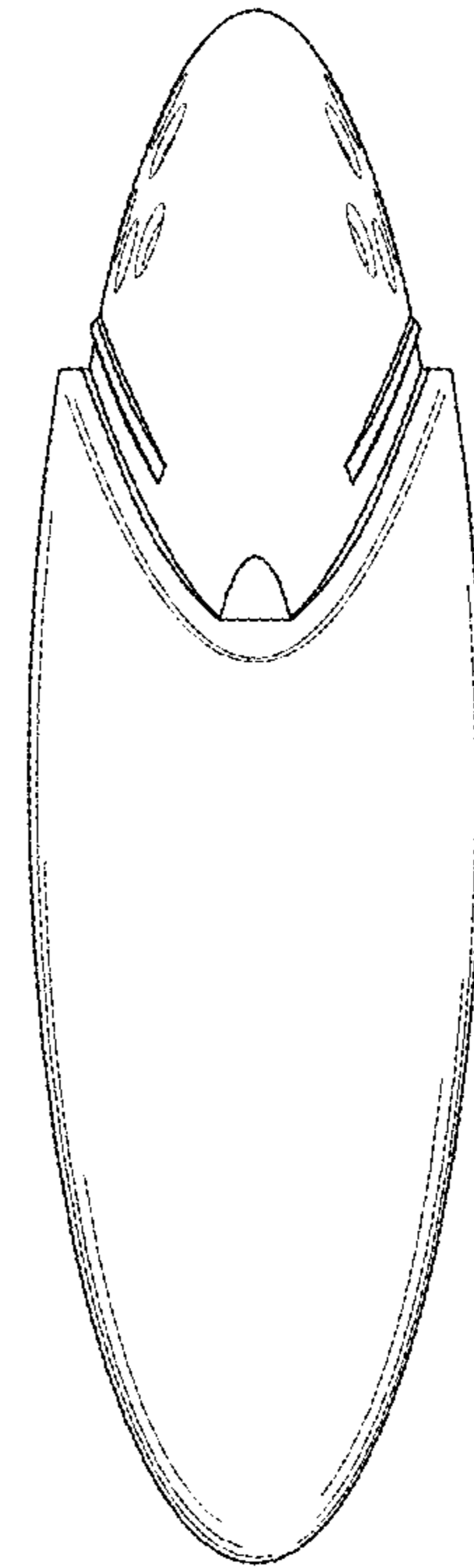

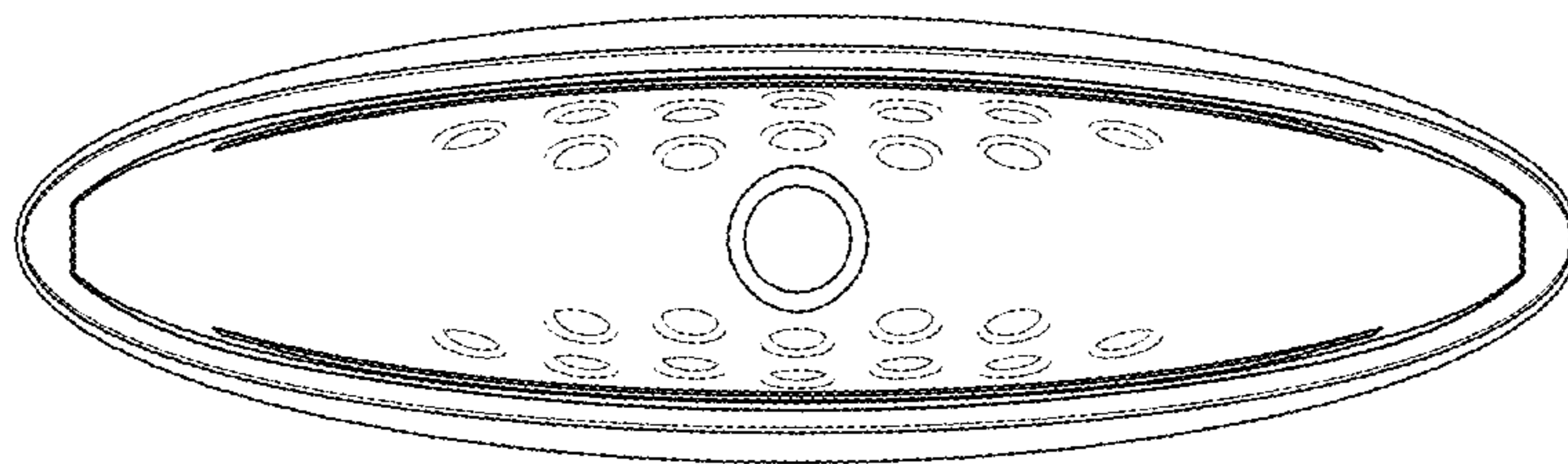

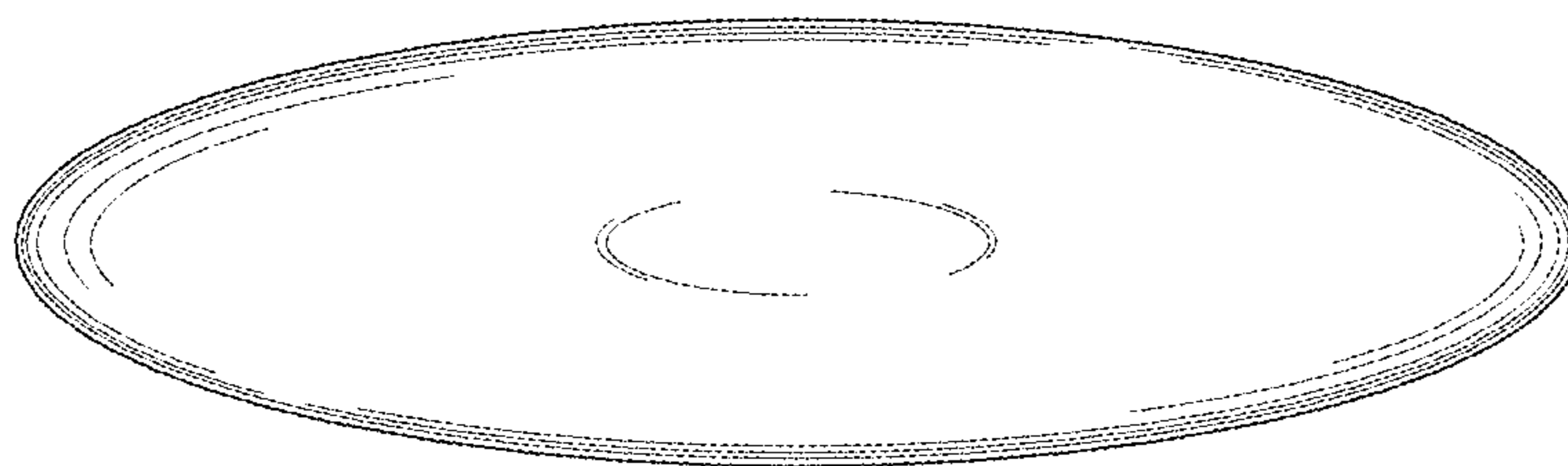
