FIG. 4 is a left side view thereof, the right side view being a mirror image; and,

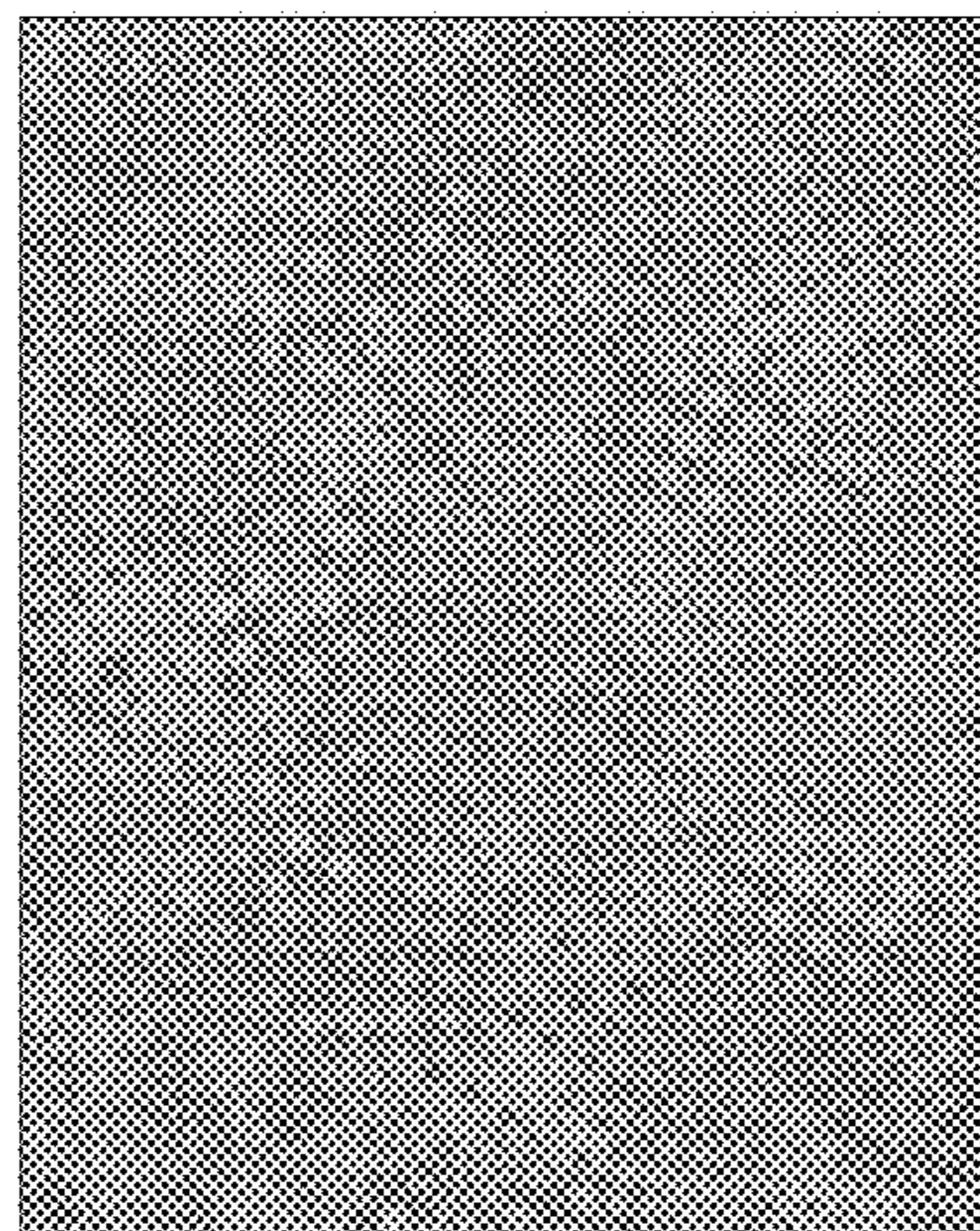
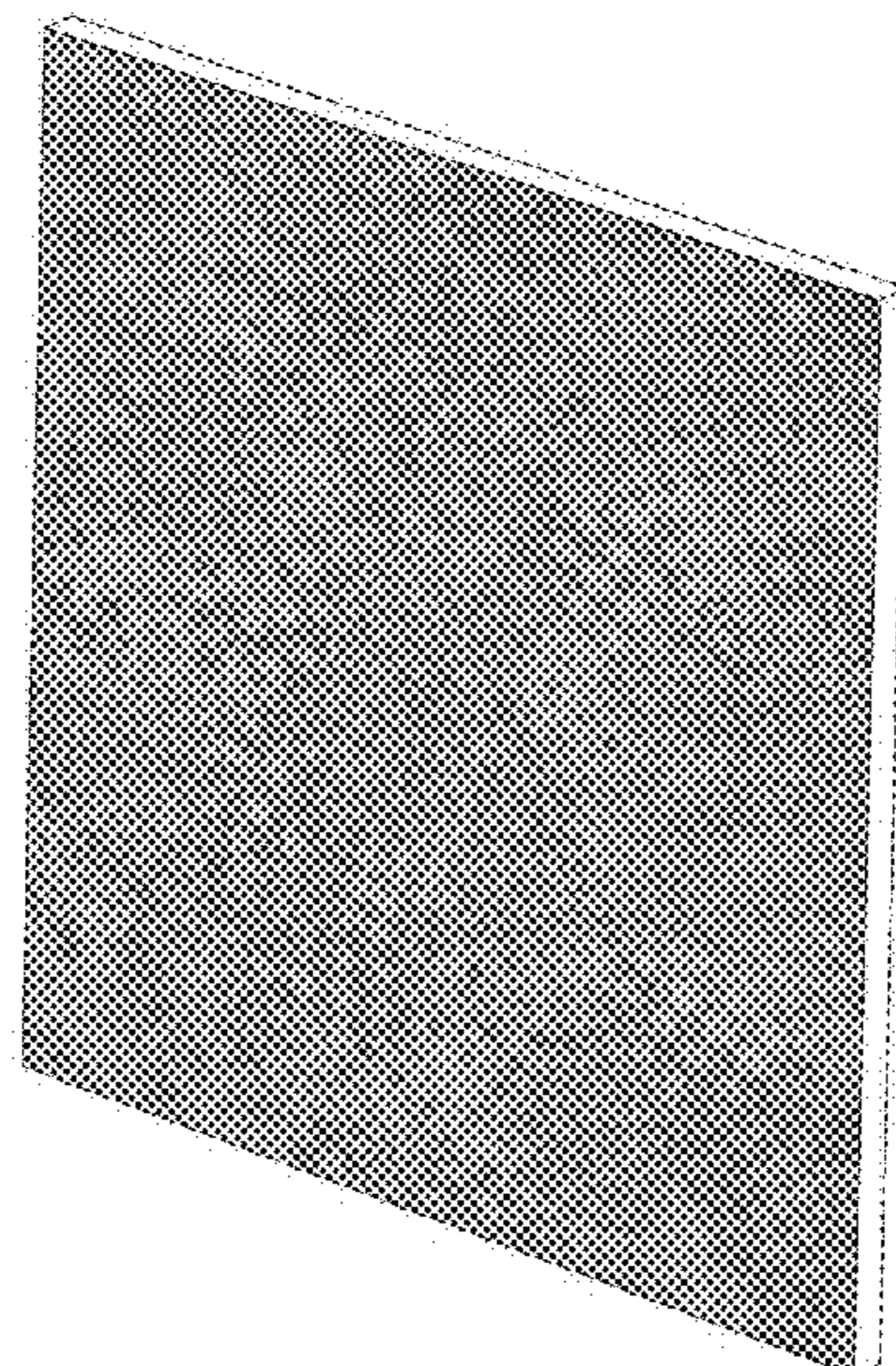
FIG. 5 is a top view thereof, the bottom view being a mirror image.

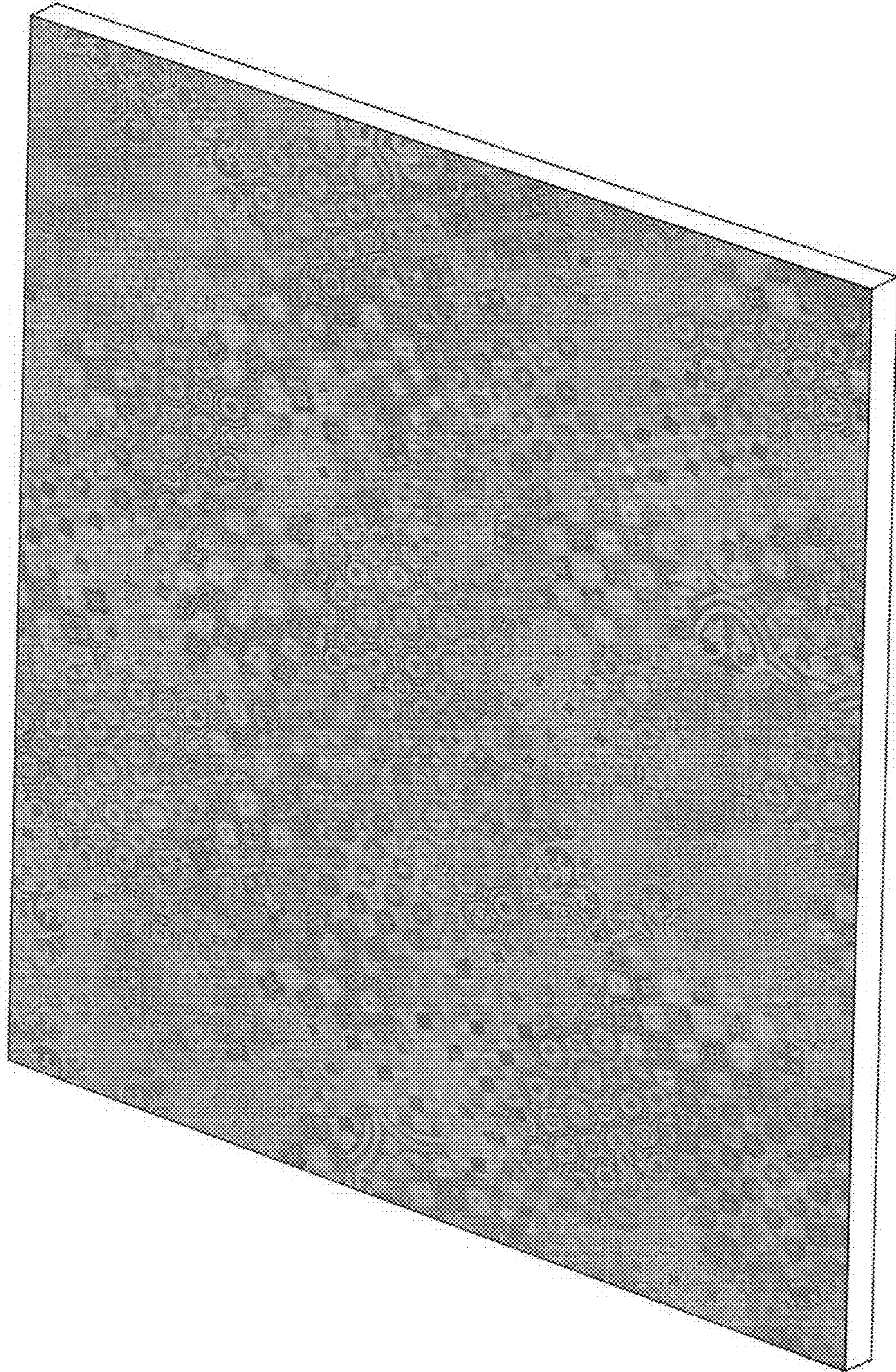

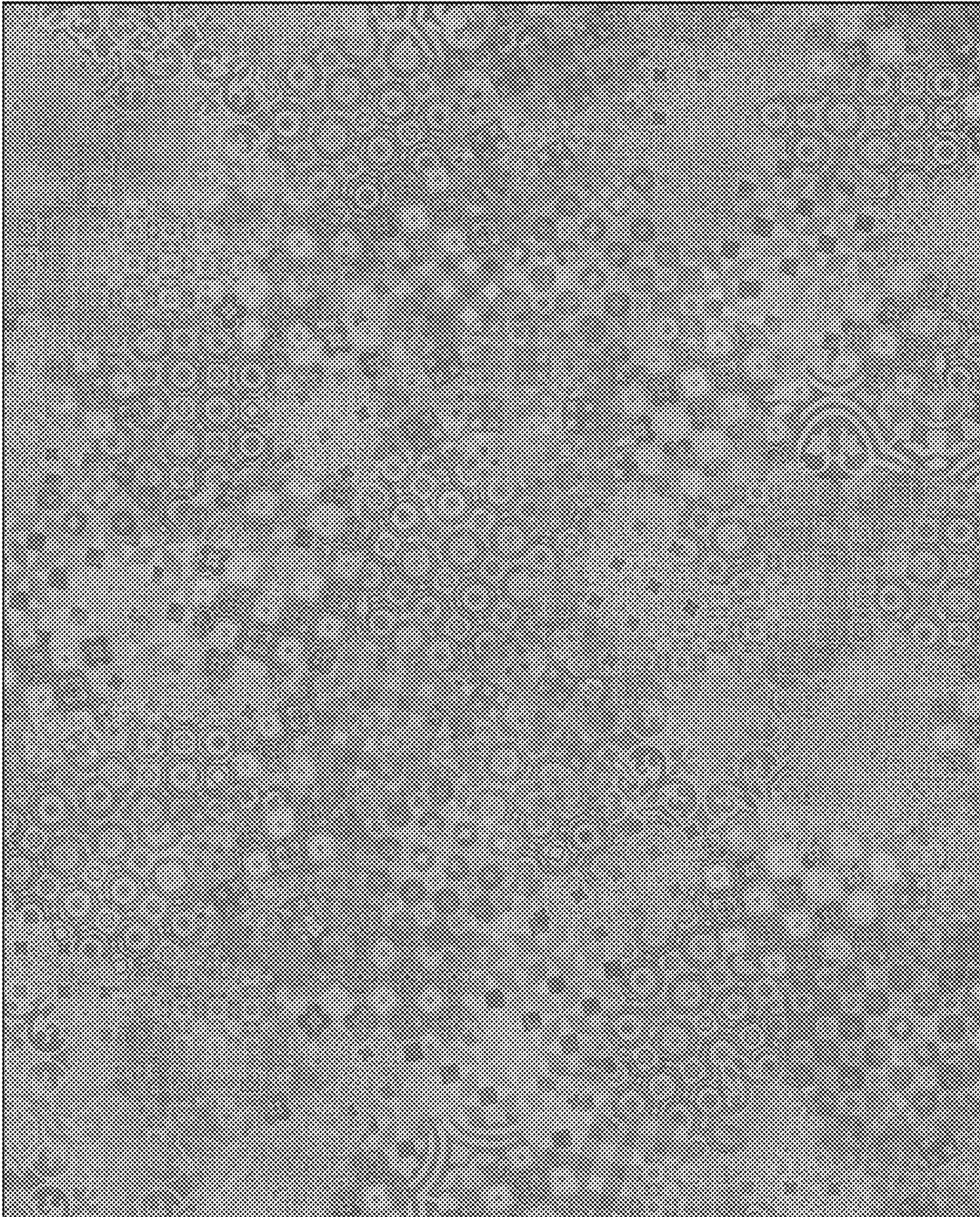
