The broken lines are included for the purpose of illustrating a portion of the capsule containing washing products that forms no part of the claimed design.

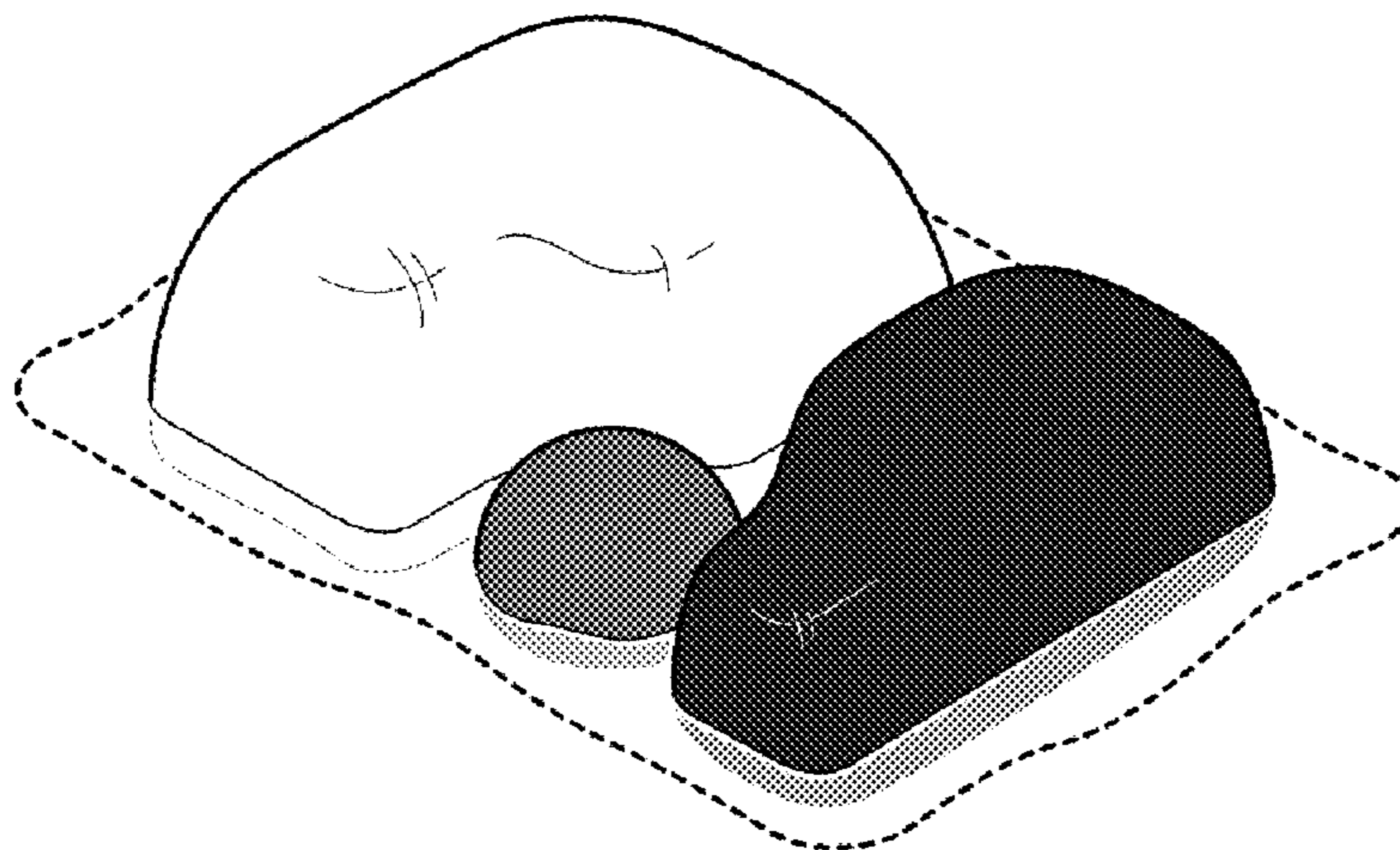

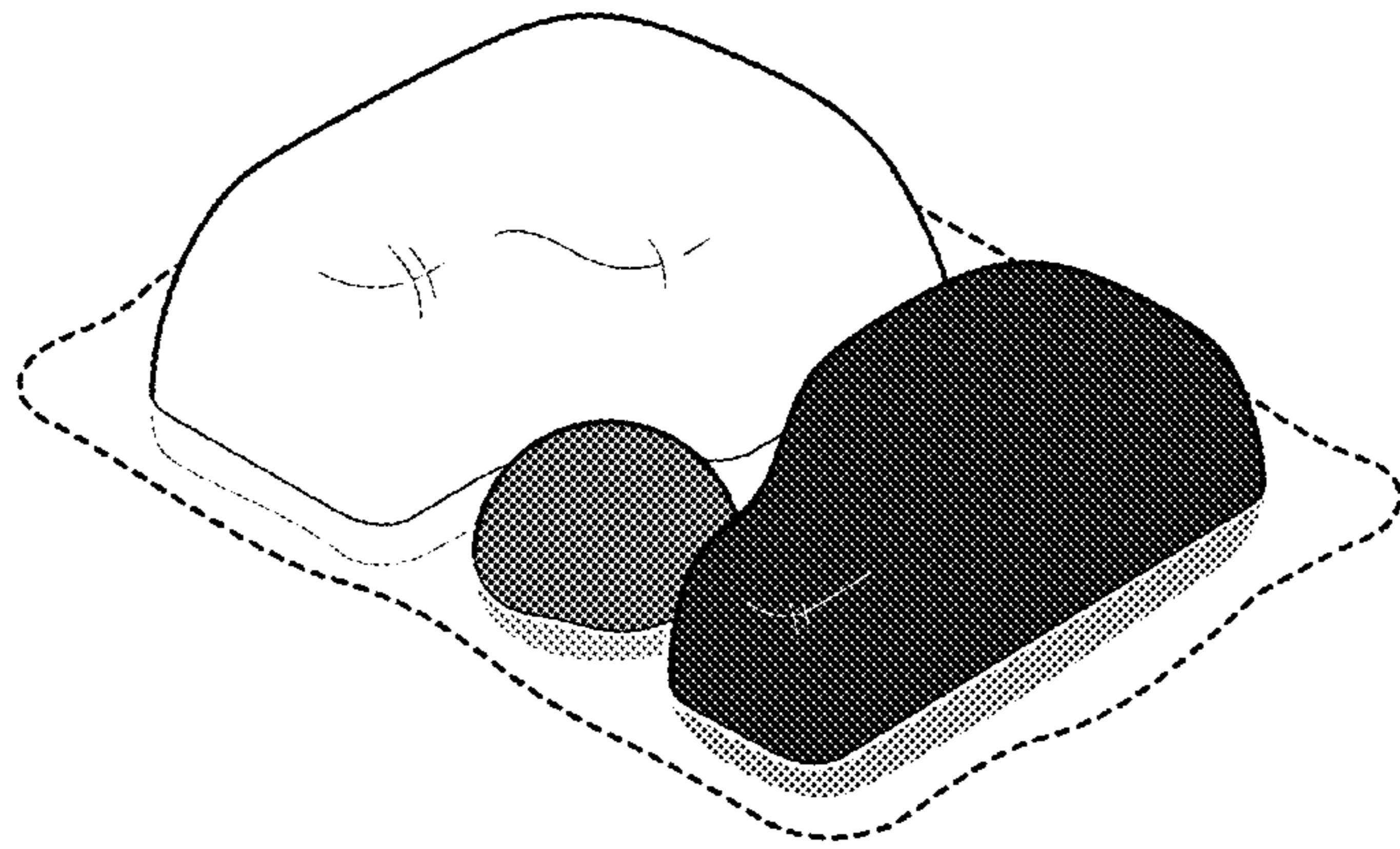

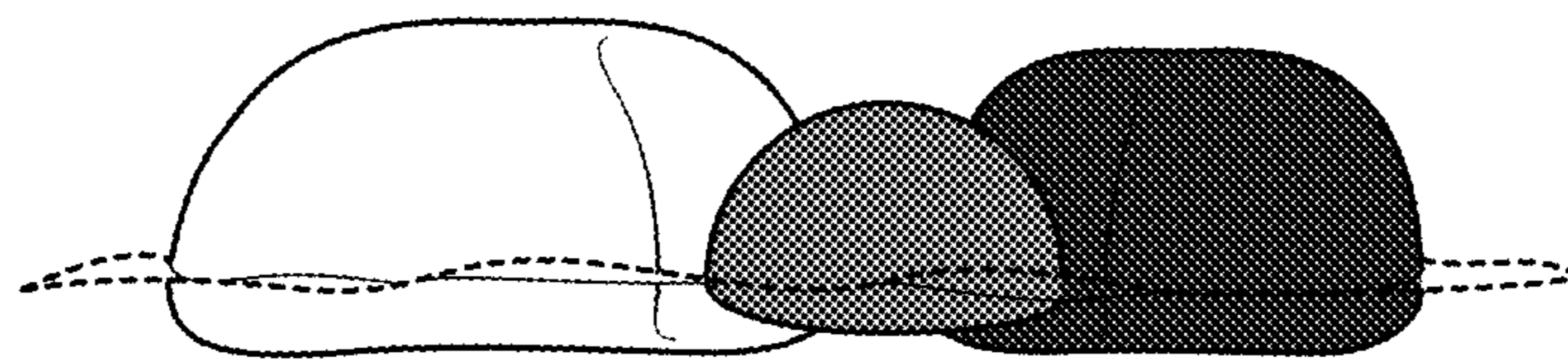

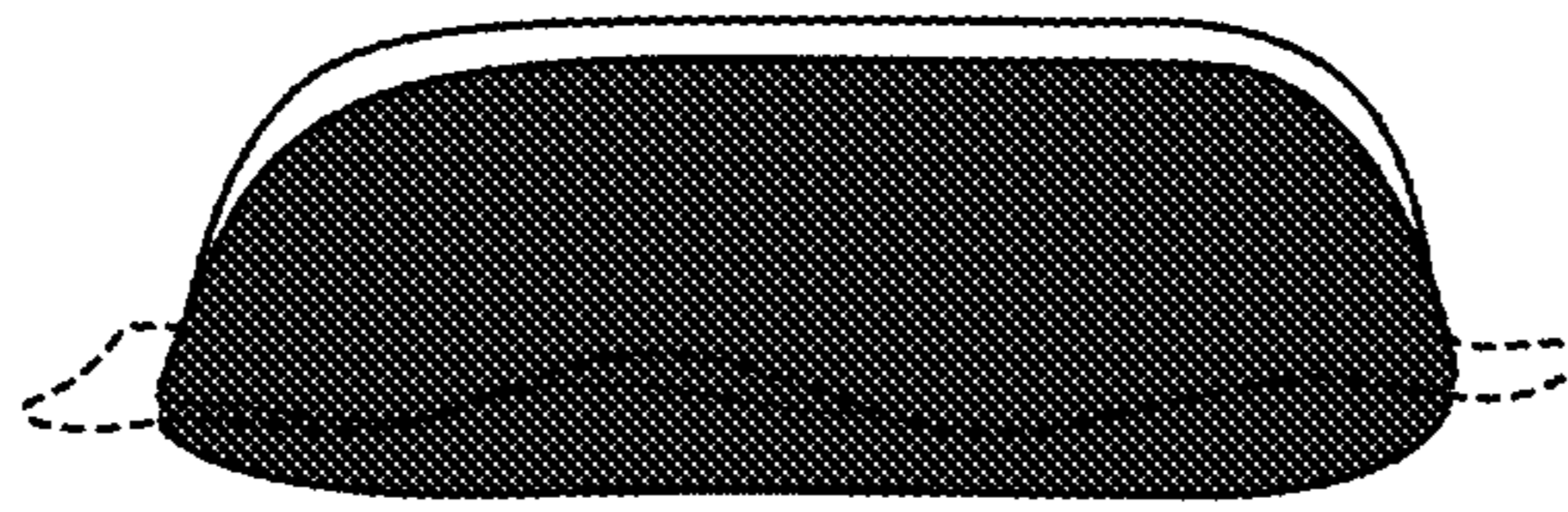

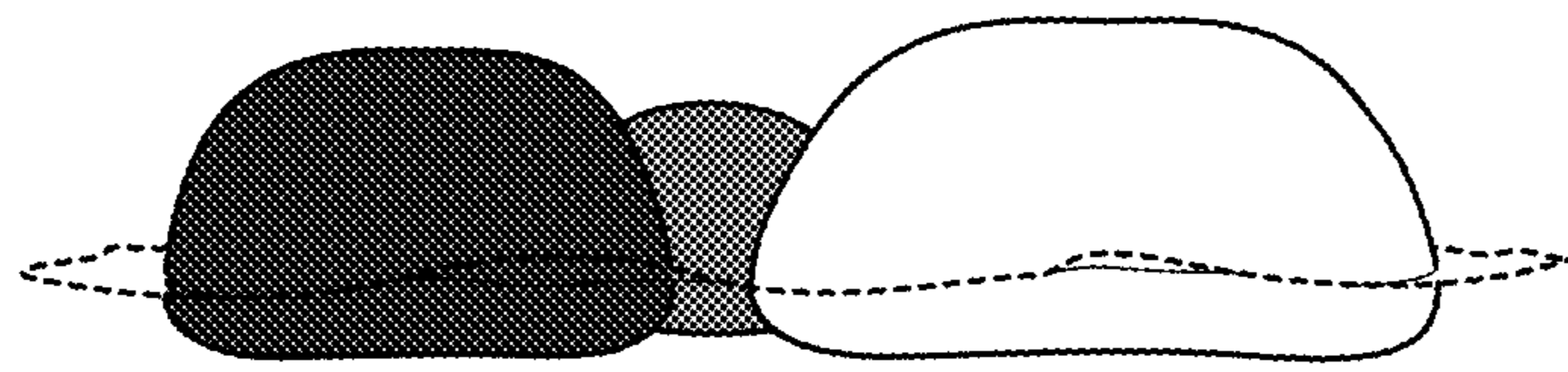

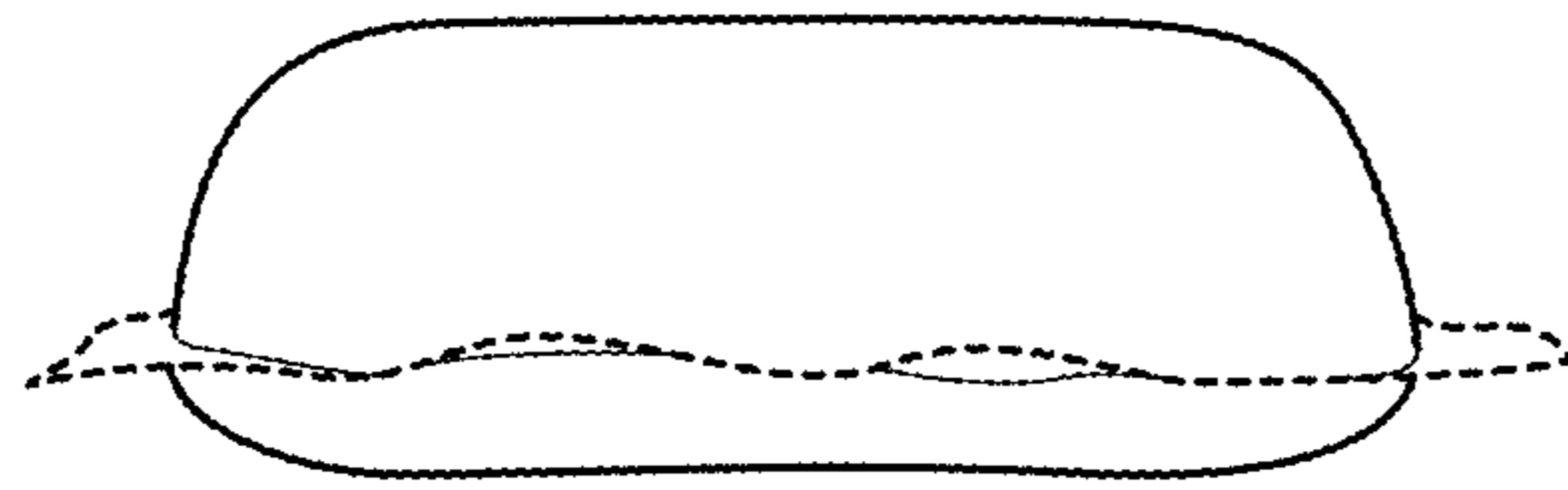

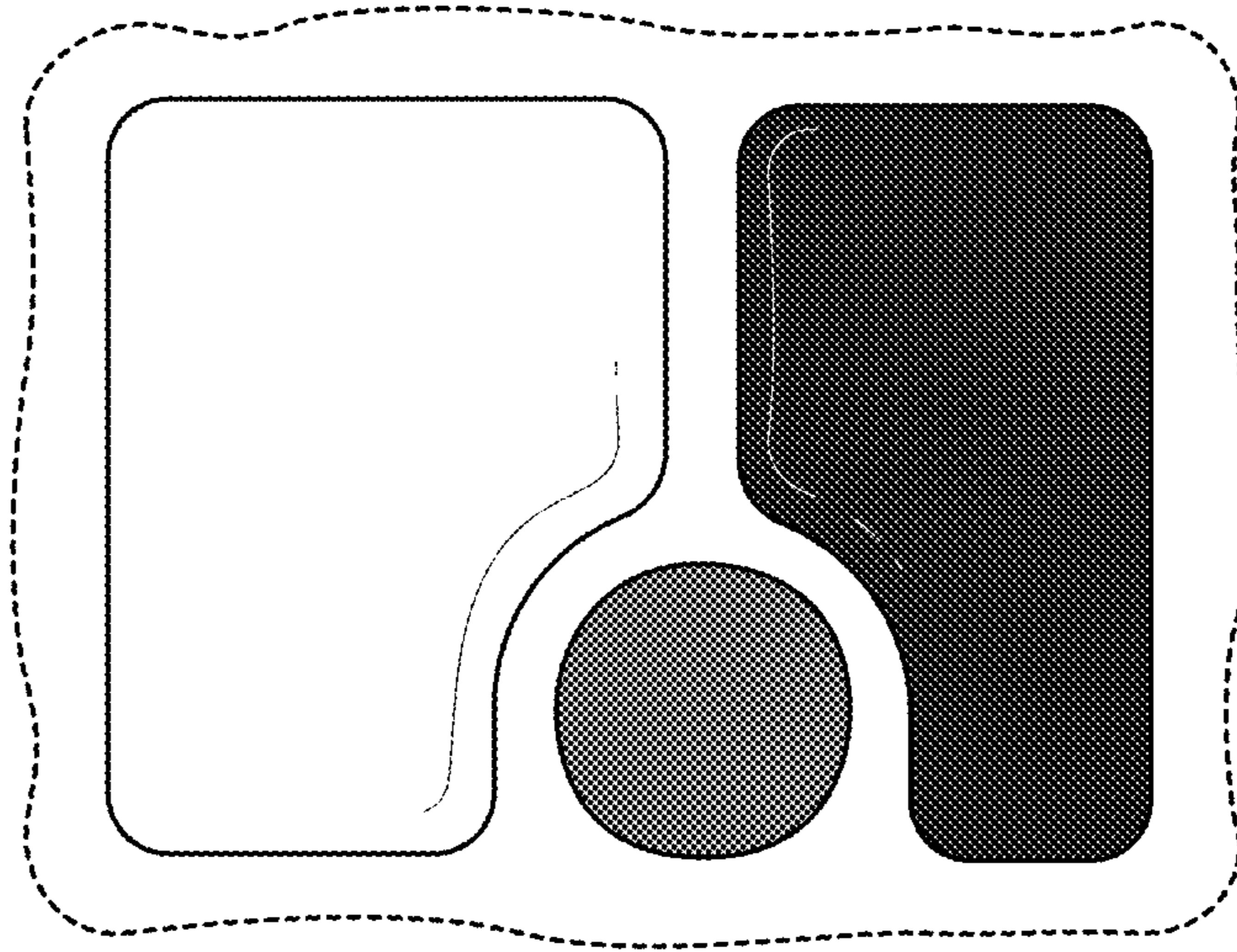

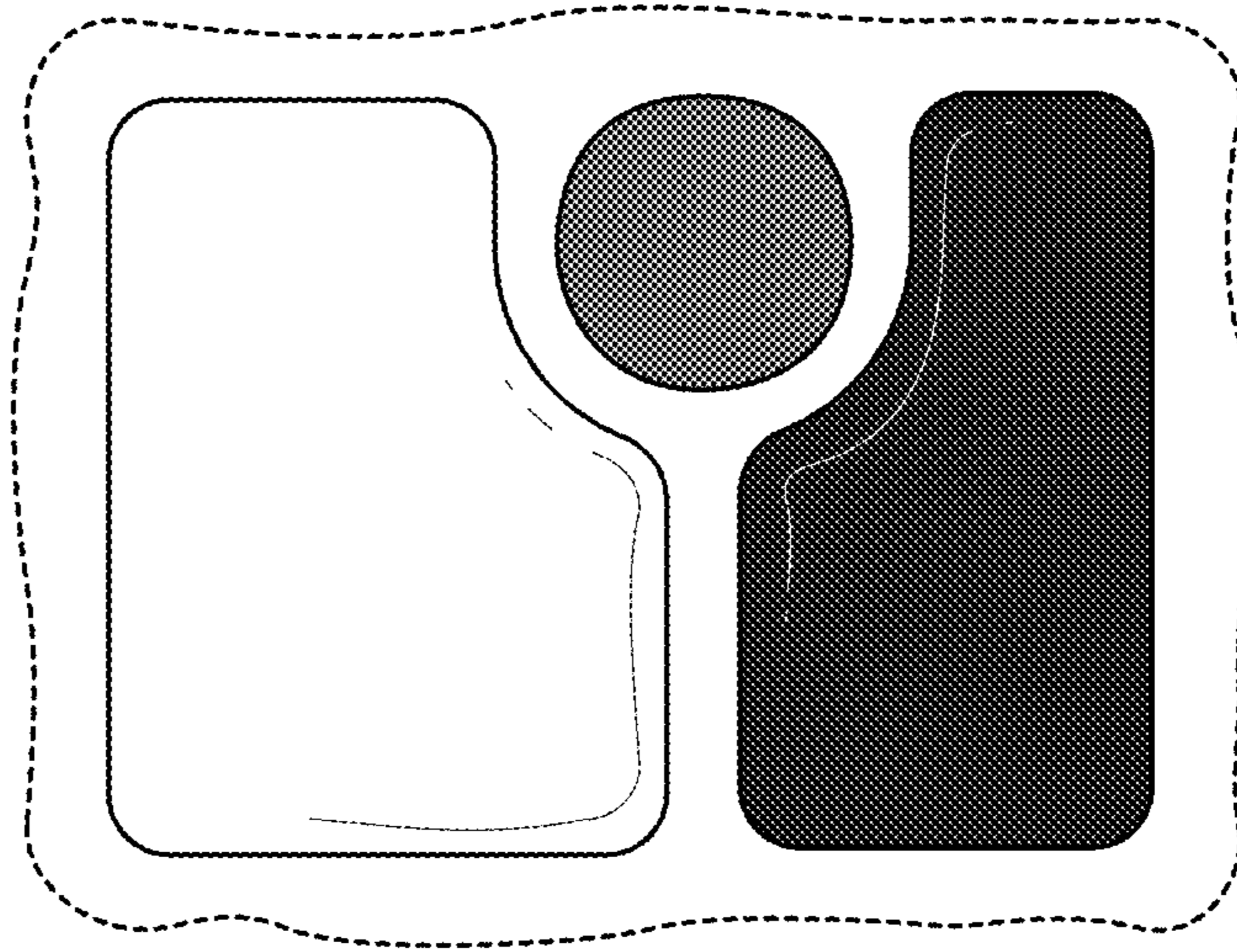
