I claim the ornamental design for an oriole feeder, as shown and described.

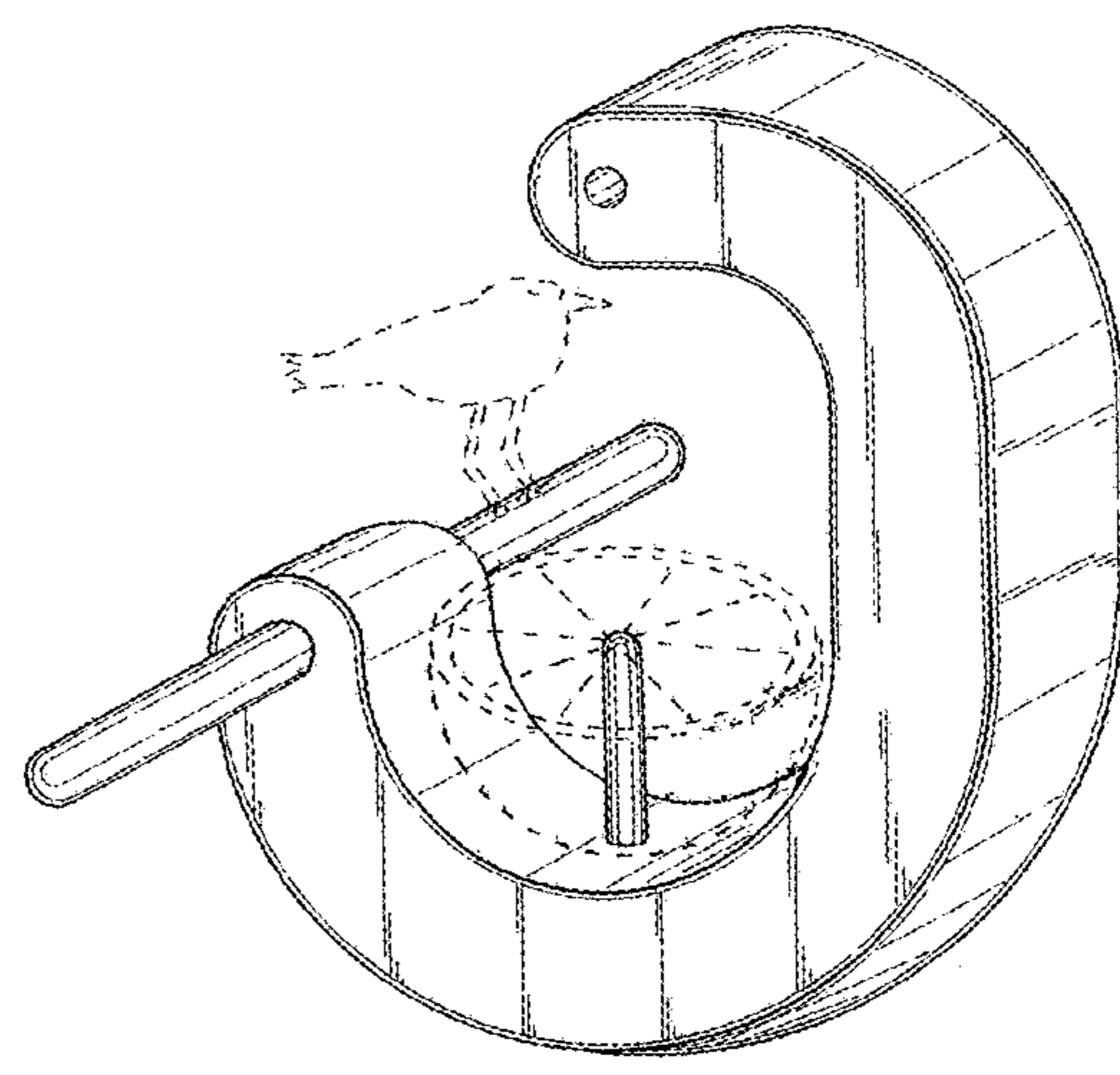
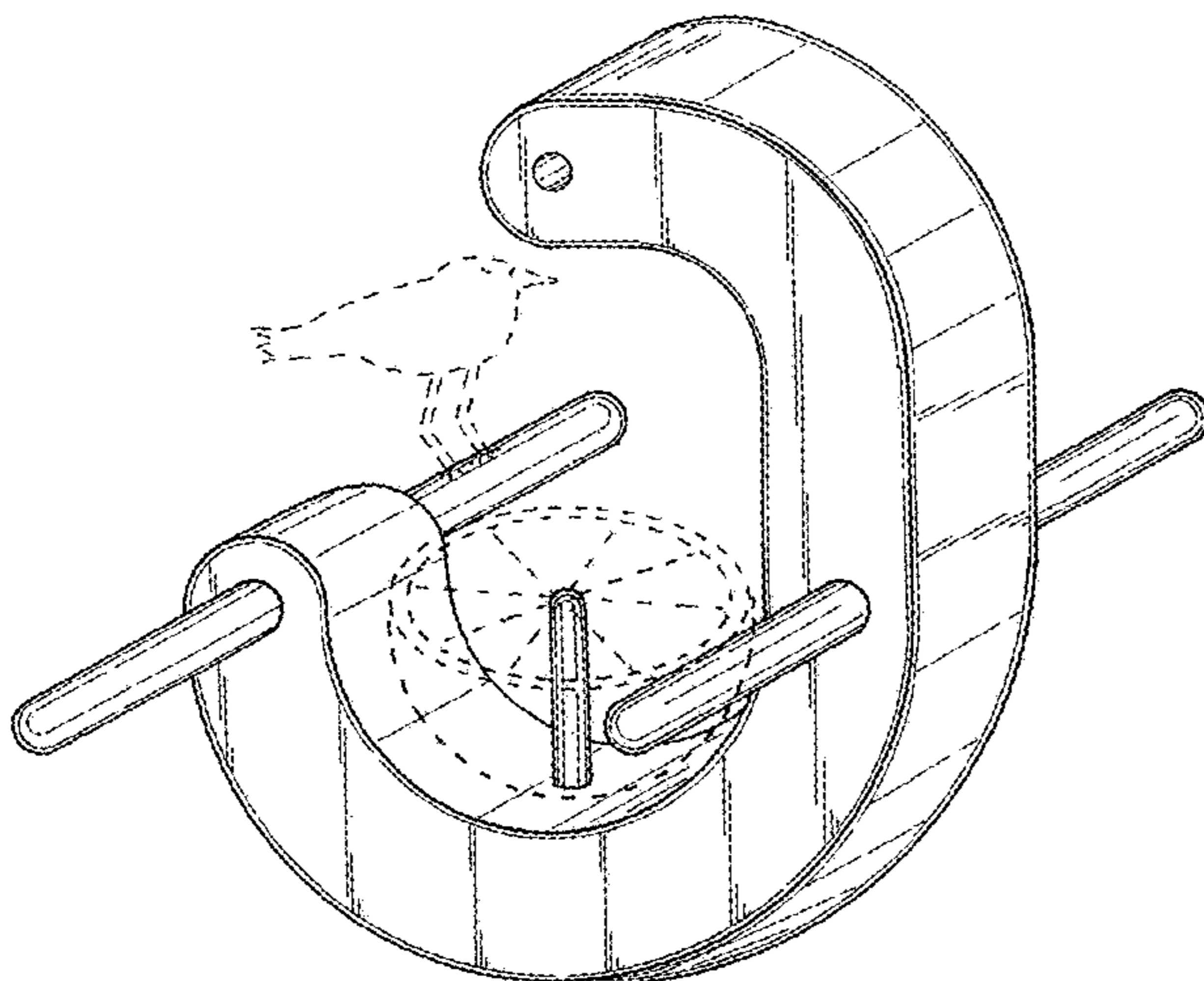
**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the oriole feeder of my design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a side elevational view of the left side thereof;  
 FIG. 5 is a side elevational view of the right side thereof;  
 FIG. 6 is a rear elevational view thereof;  
 FIG. 7 is a front elevational view thereof;  
 FIG. 8 is a perspective view of a second embodiment of the oriole feeder of my design;  
 FIG. 9 is a bottom plan view thereof;  
 FIG. 10 is a top plan view thereof;  
 FIG. 11 is a side elevational view of the left side thereof;  
 FIG. 12 is a side elevational view of the right side thereof;  
 FIG. 13 is a rear elevational view thereof;  
 FIG. 14 is a front elevational view thereof;  
 FIG. 15 is a perspective view of a third embodiment of the oriole feeder of my design;  
 FIG. 16 is a bottom plan view thereof;  
 FIG. 17 is a top plan view thereof;  
 FIG. 18 is a side elevational view of the left side thereof;  
 FIG. 19 is a side elevational view of the right side thereof;  
 FIG. 20 is a rear elevational view thereof; and,  
 FIG. 21 is a front elevational view thereof.

The broken line showing of a bird and an orange half in FIGS. 1, 8 and 15 illustratively depicts environment and exemplary in-use elements, and forms no part of the design claim.

FIGS. 15, 20, and 21 are lined for the color red.

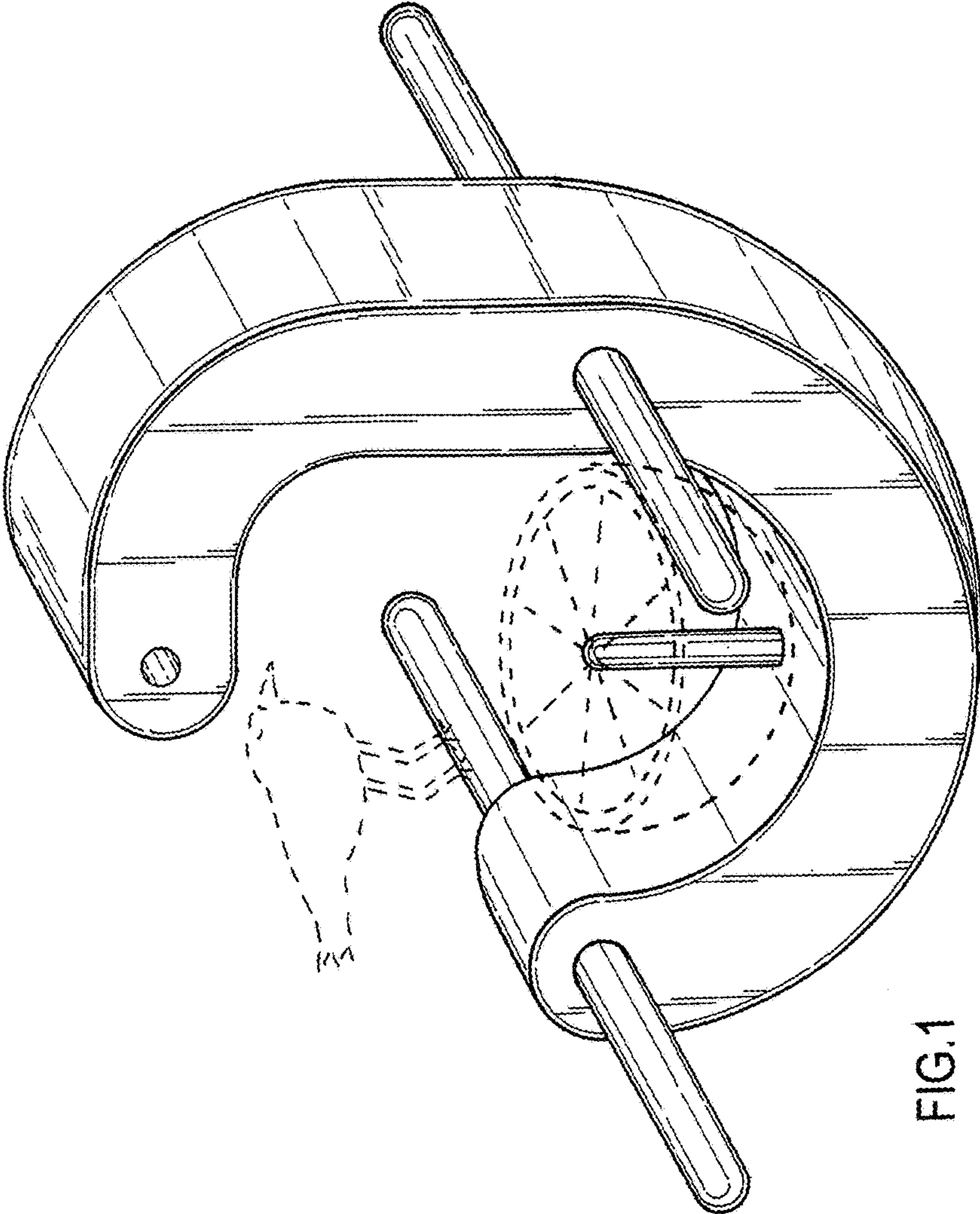

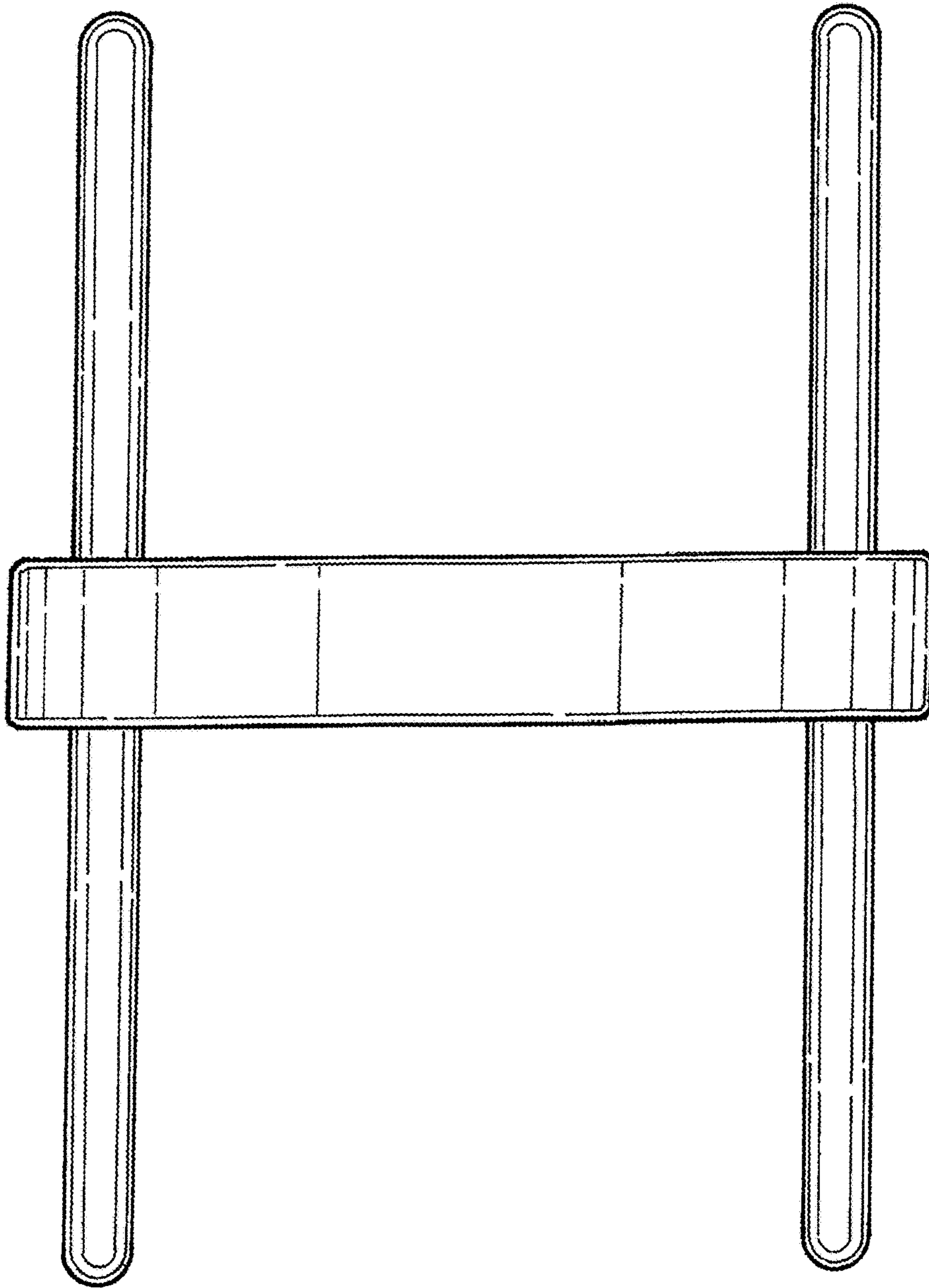

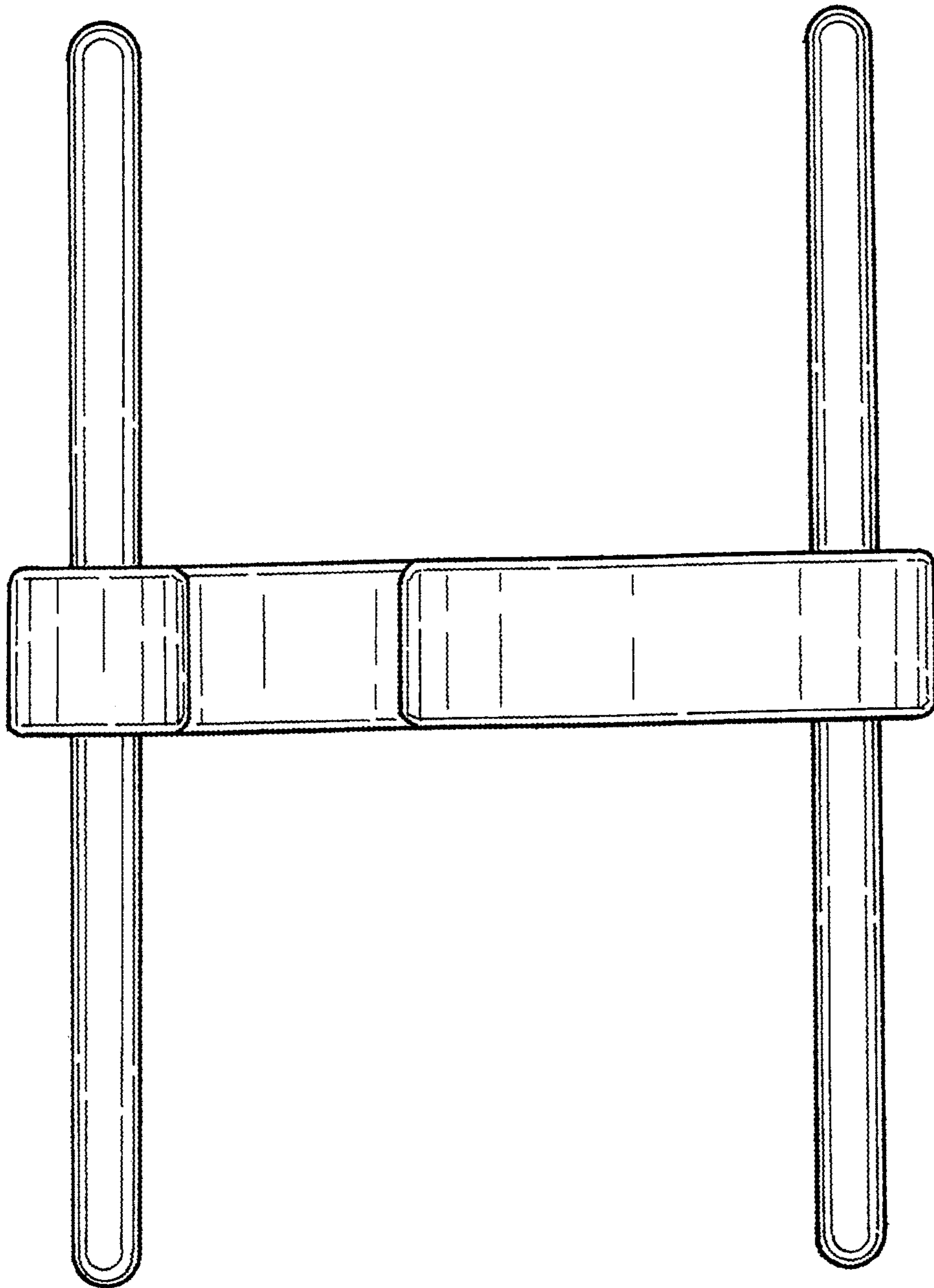

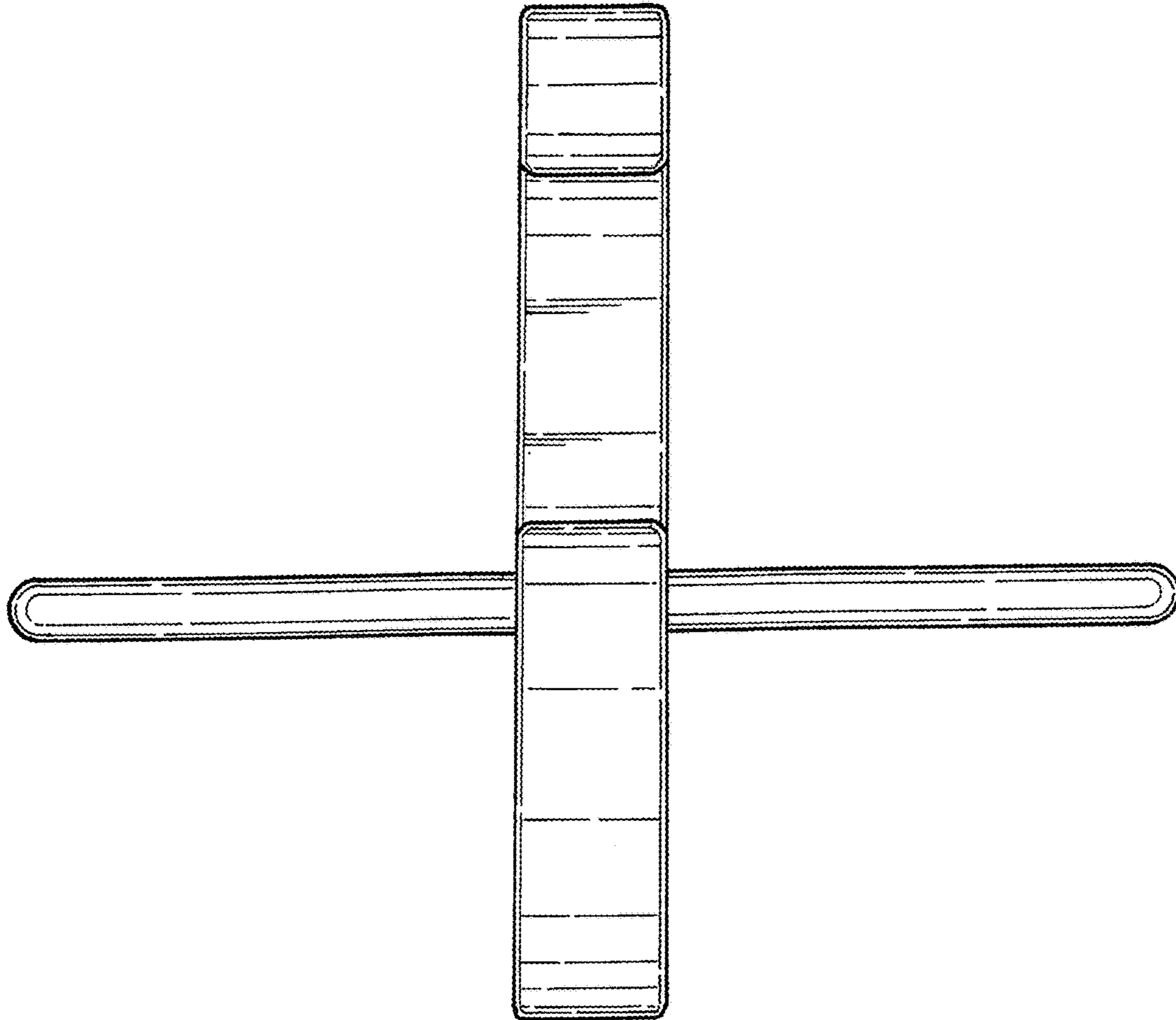

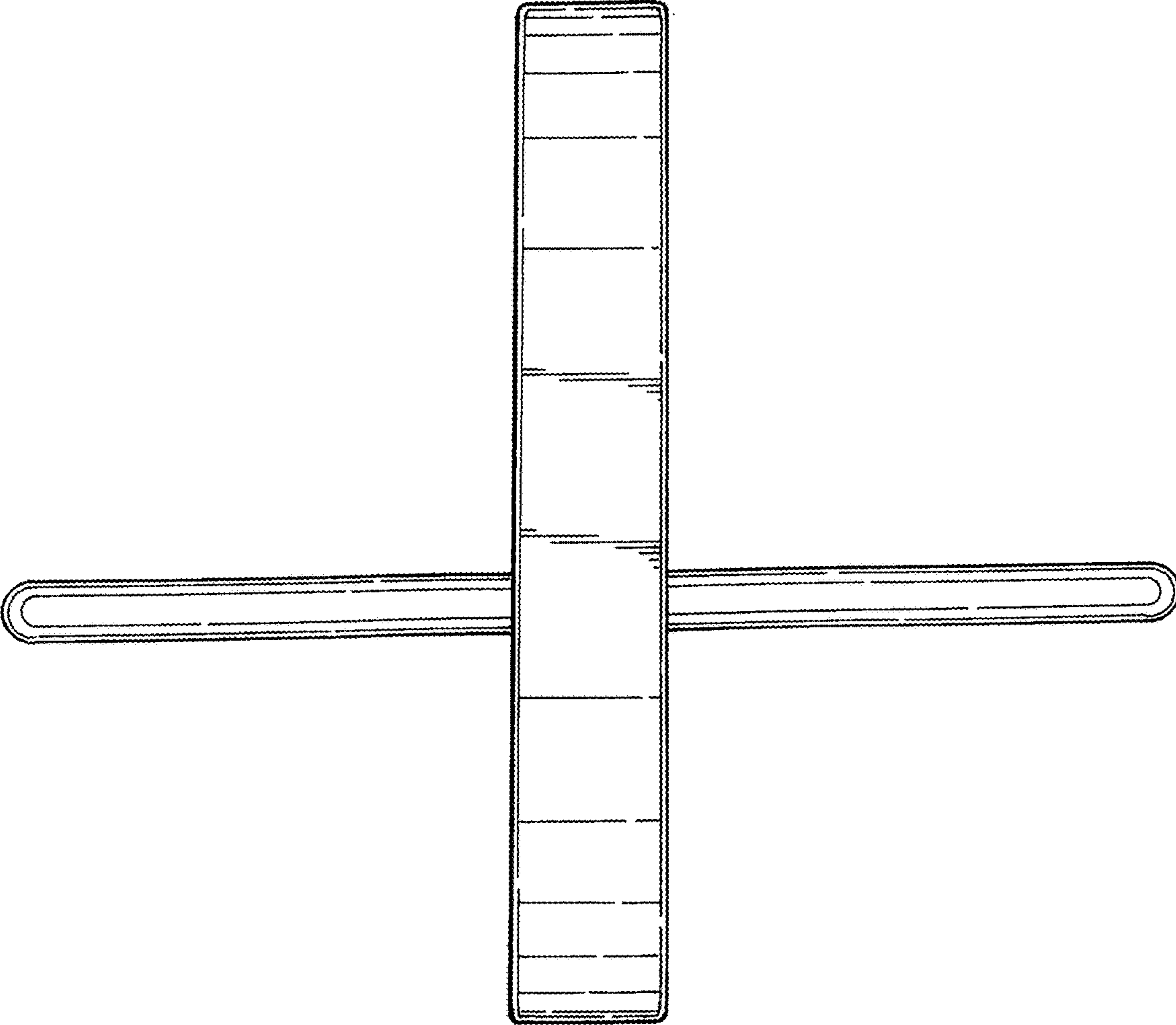

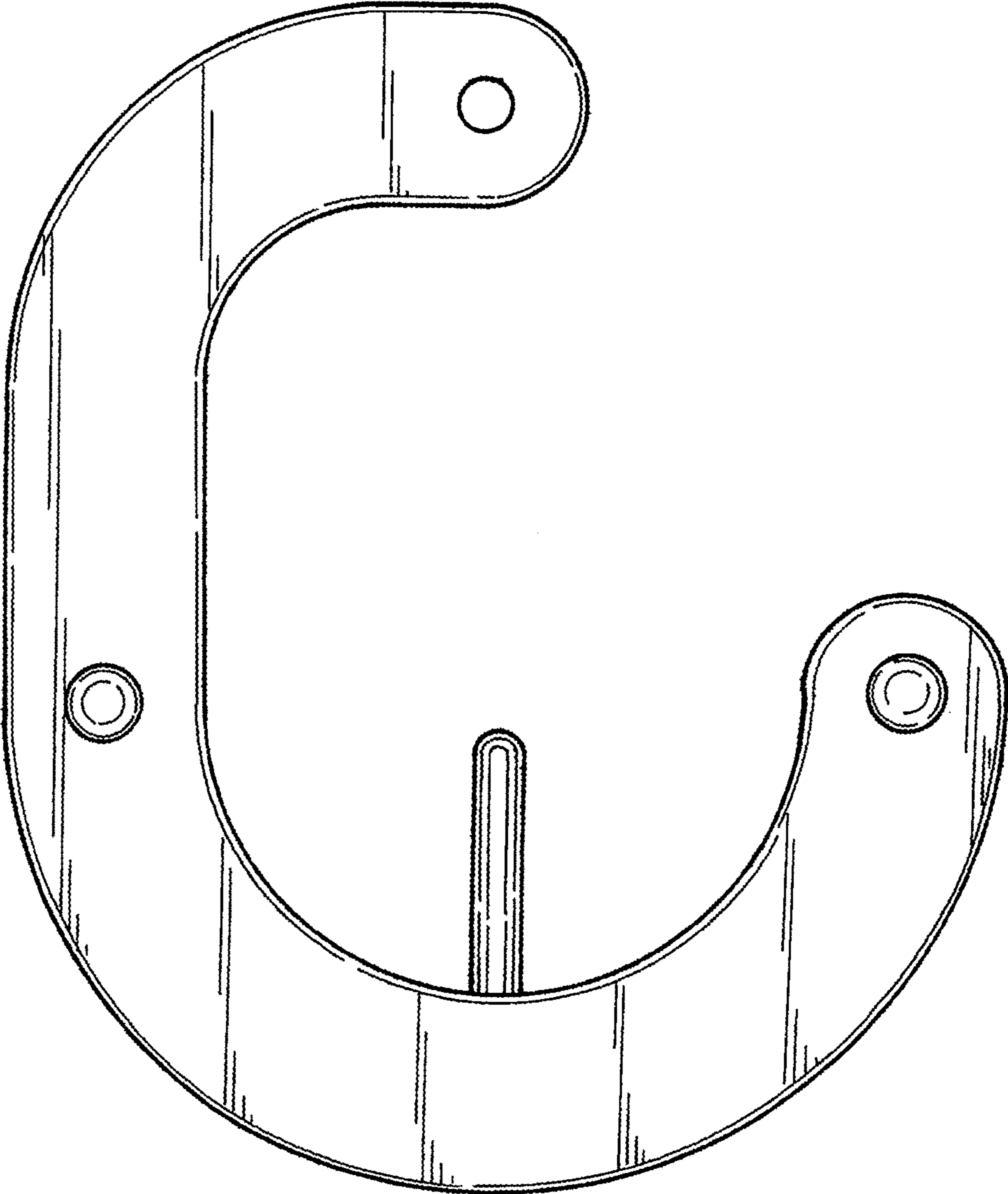

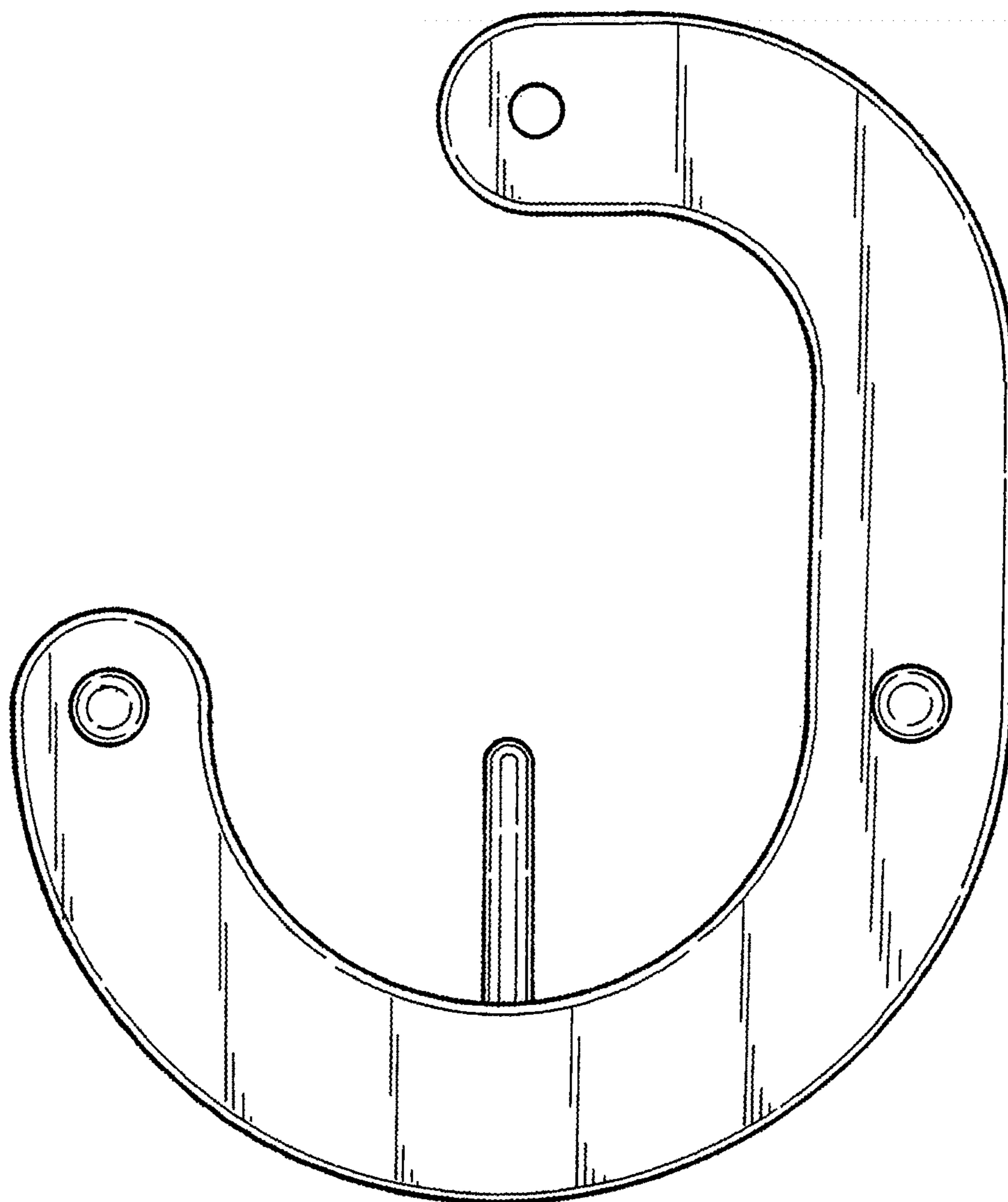

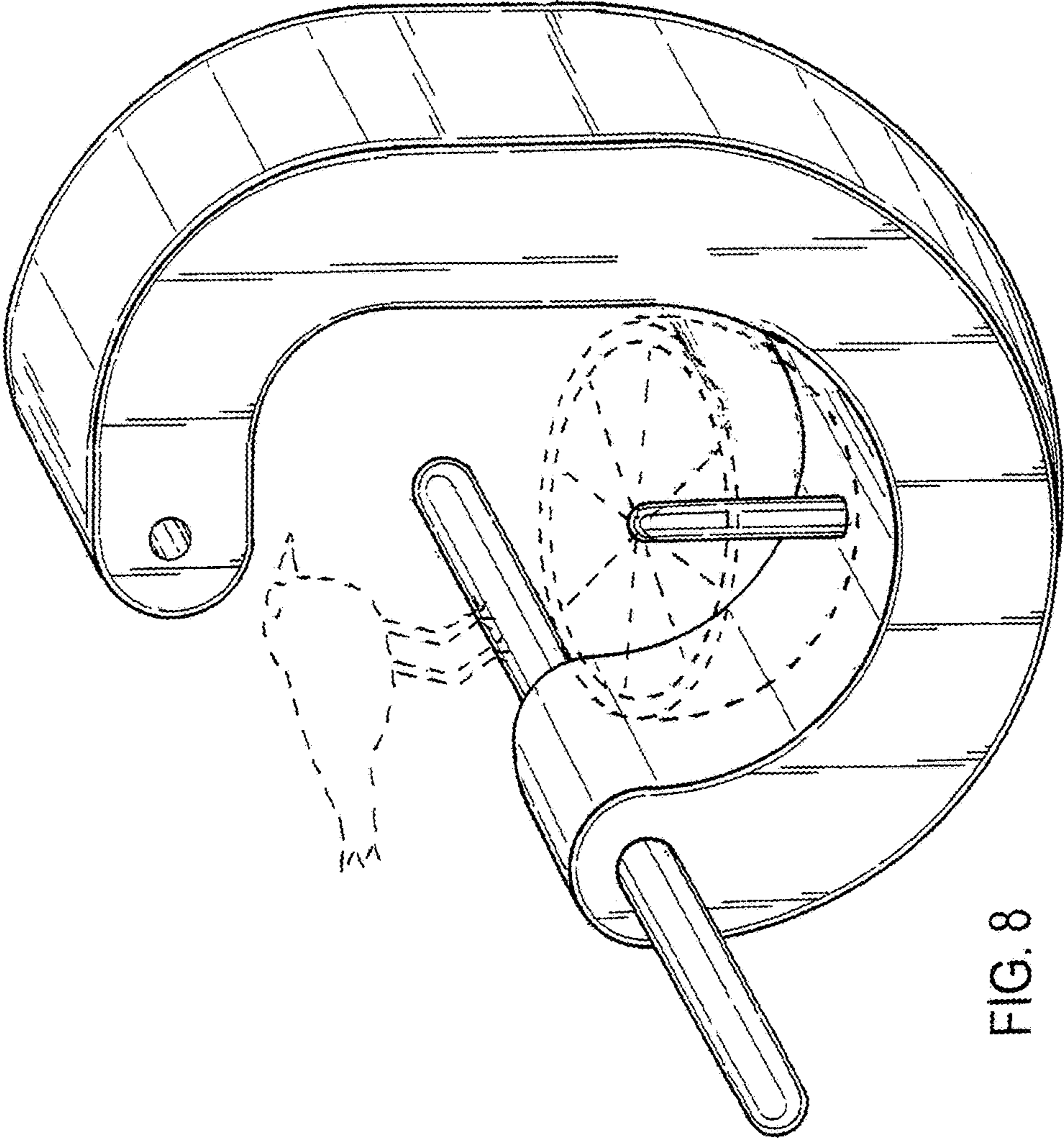

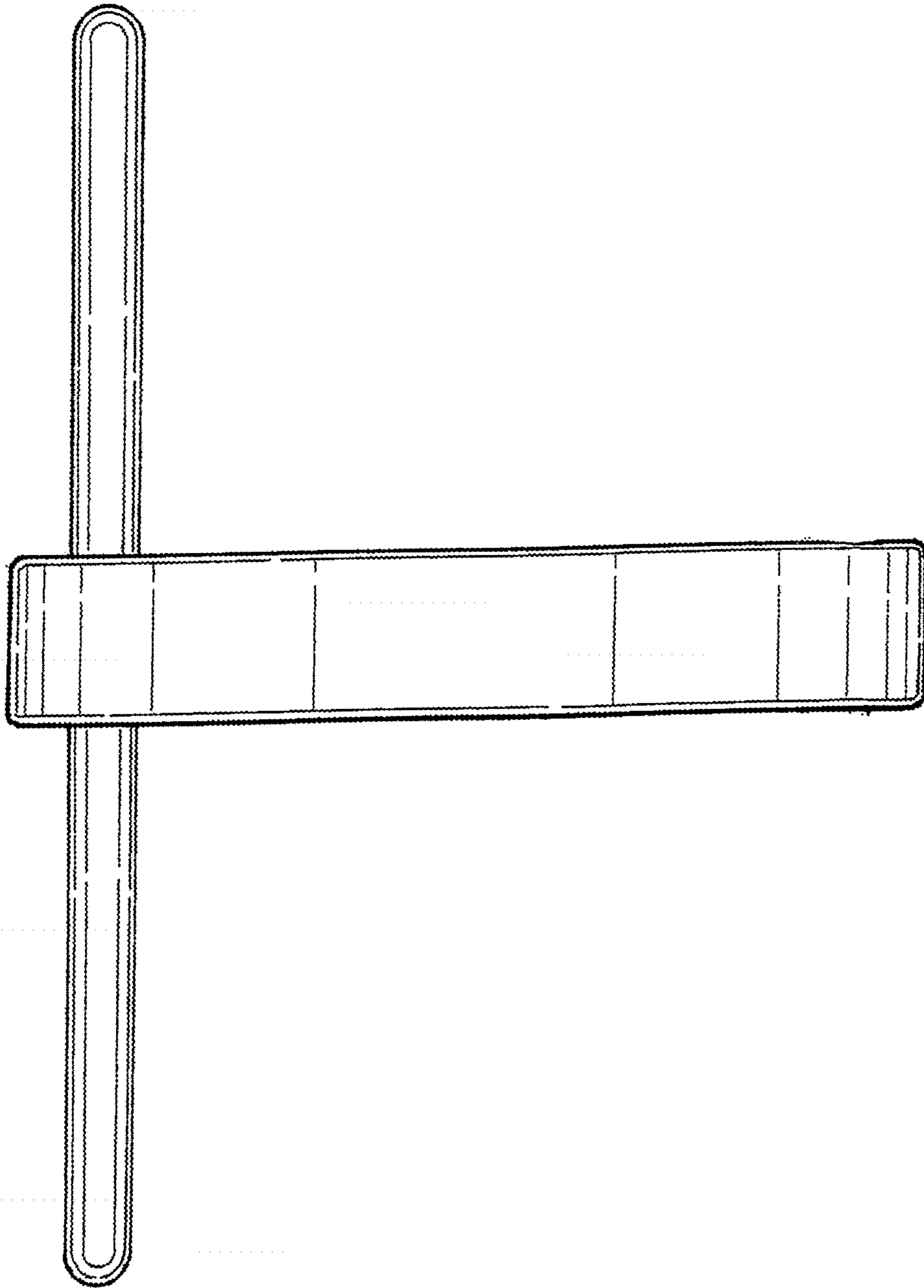

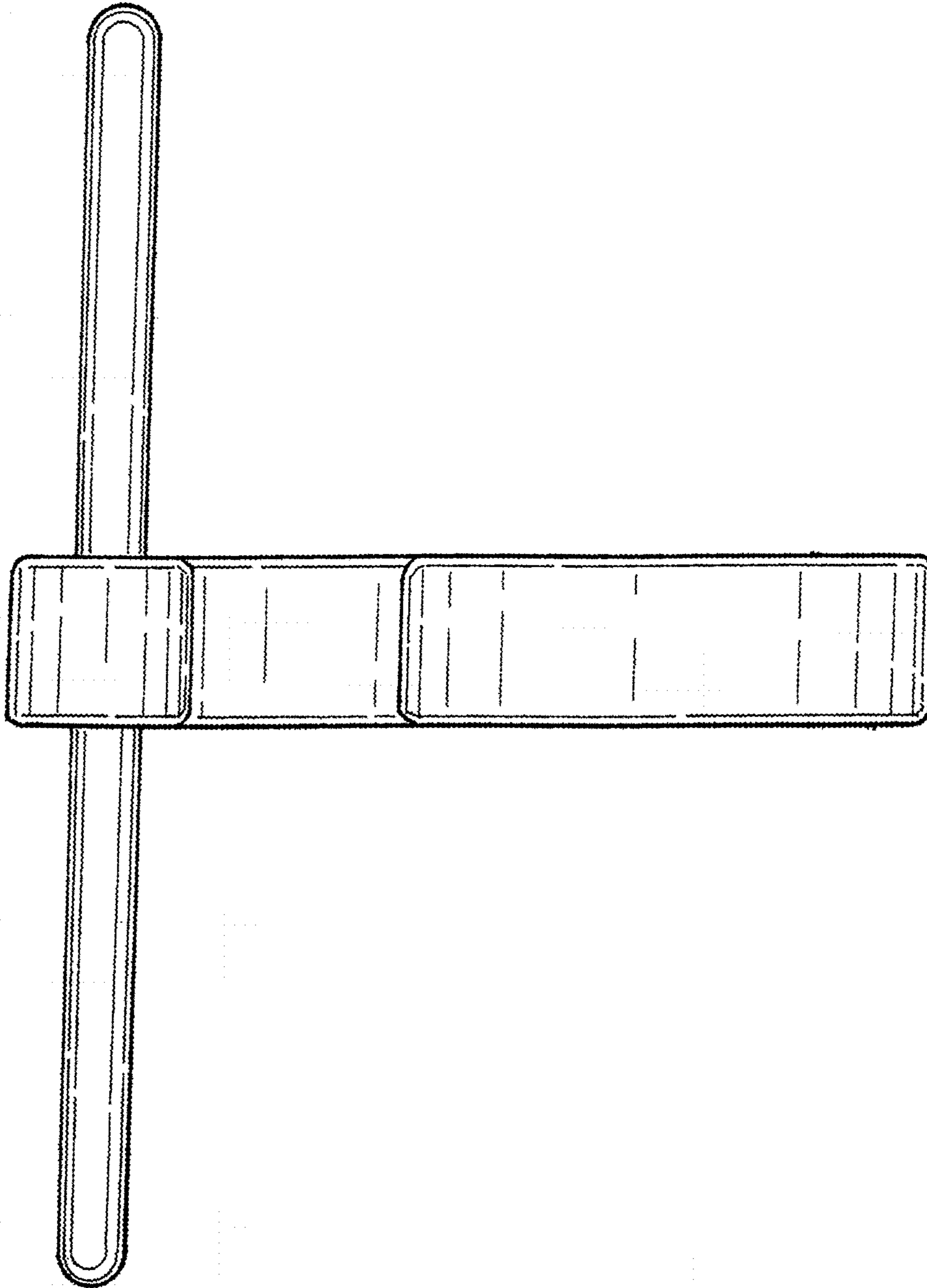

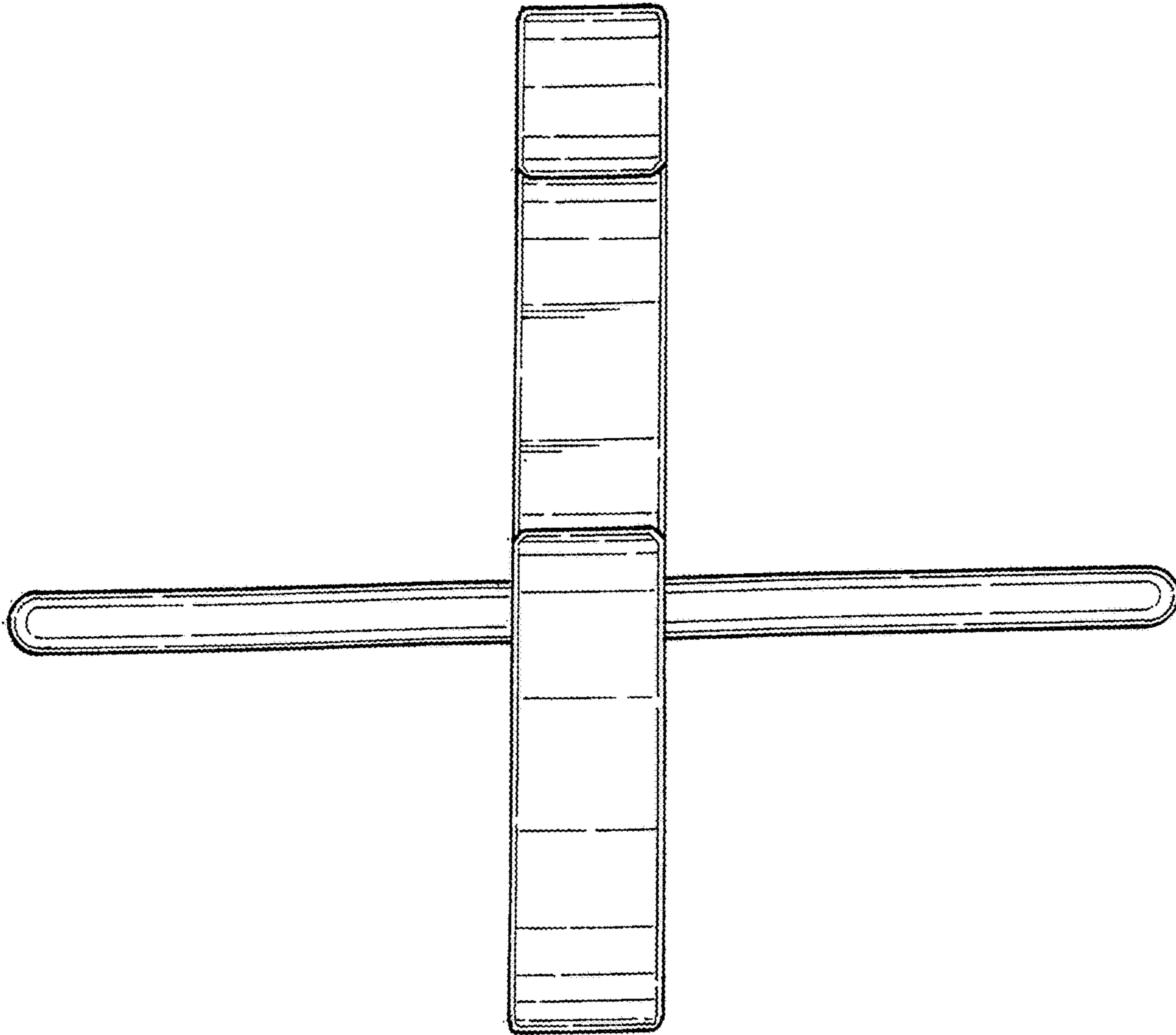

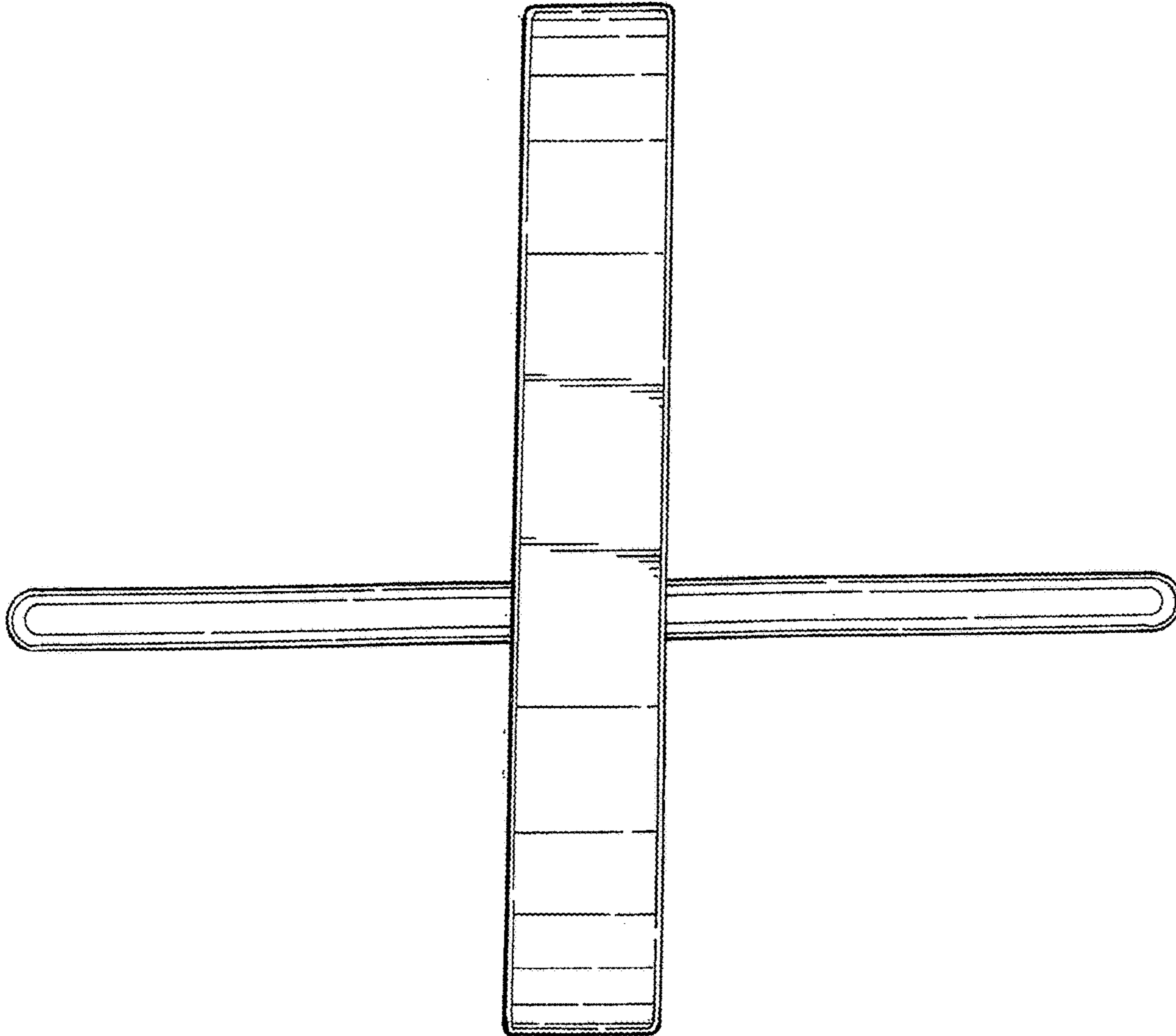

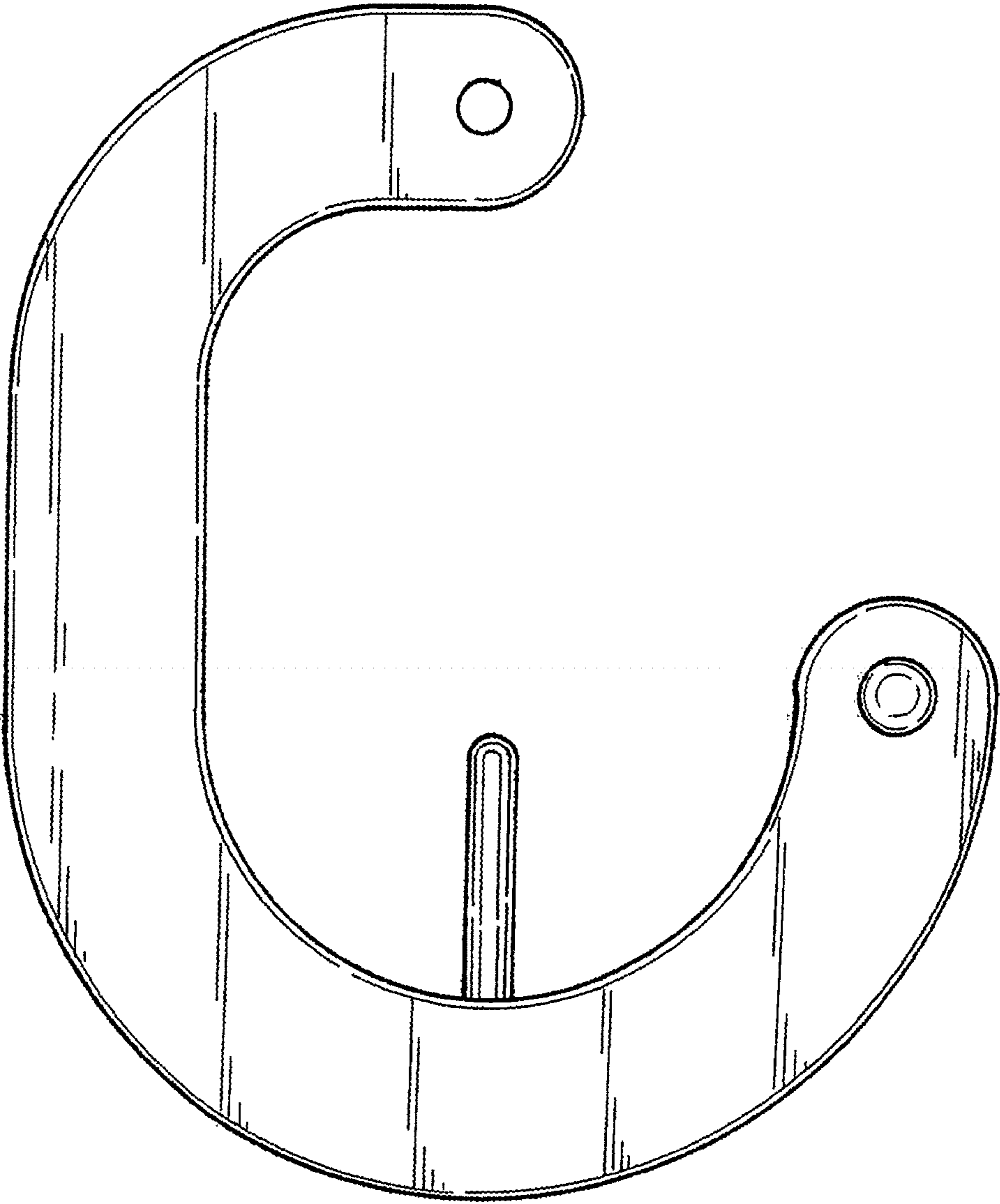

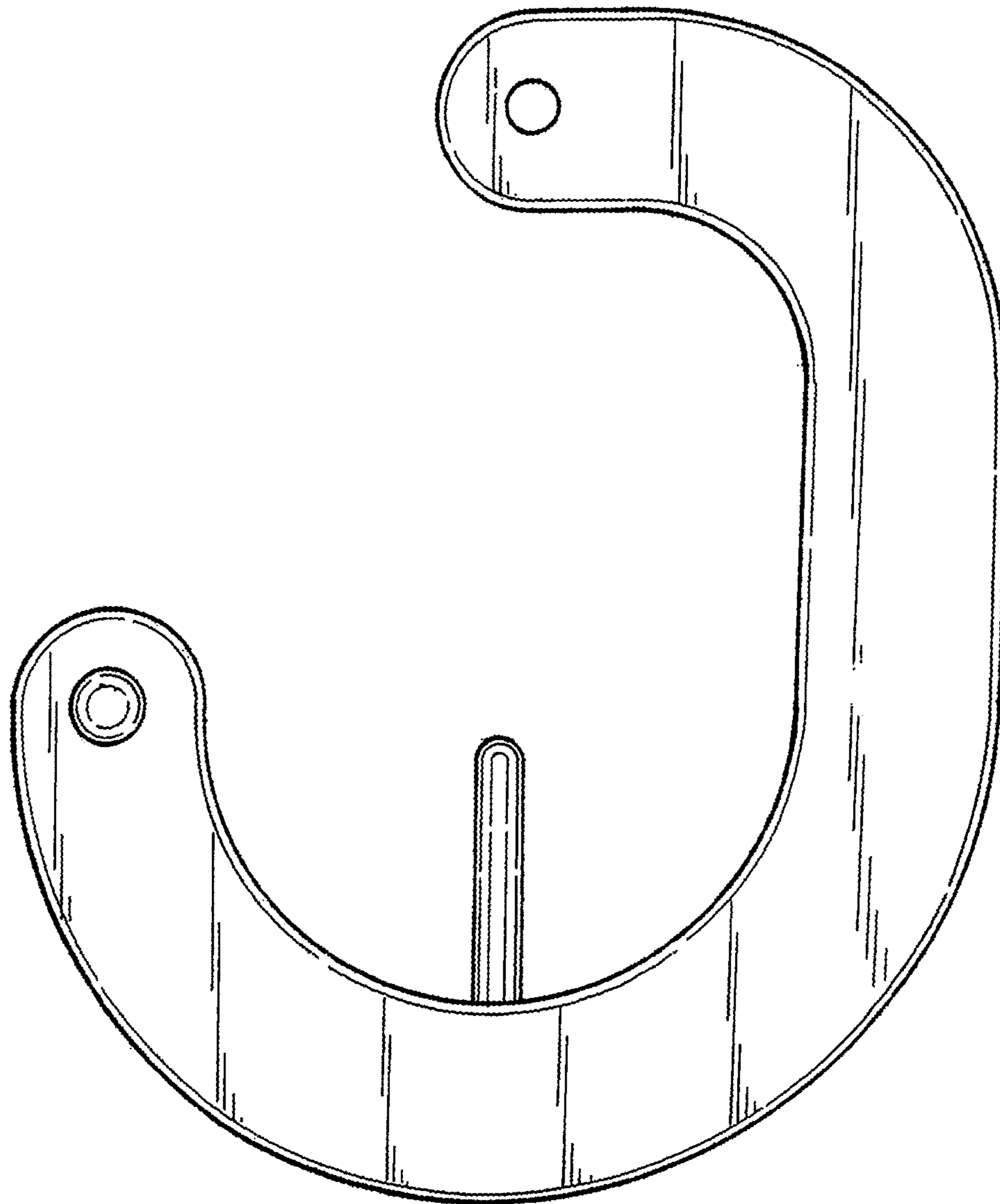

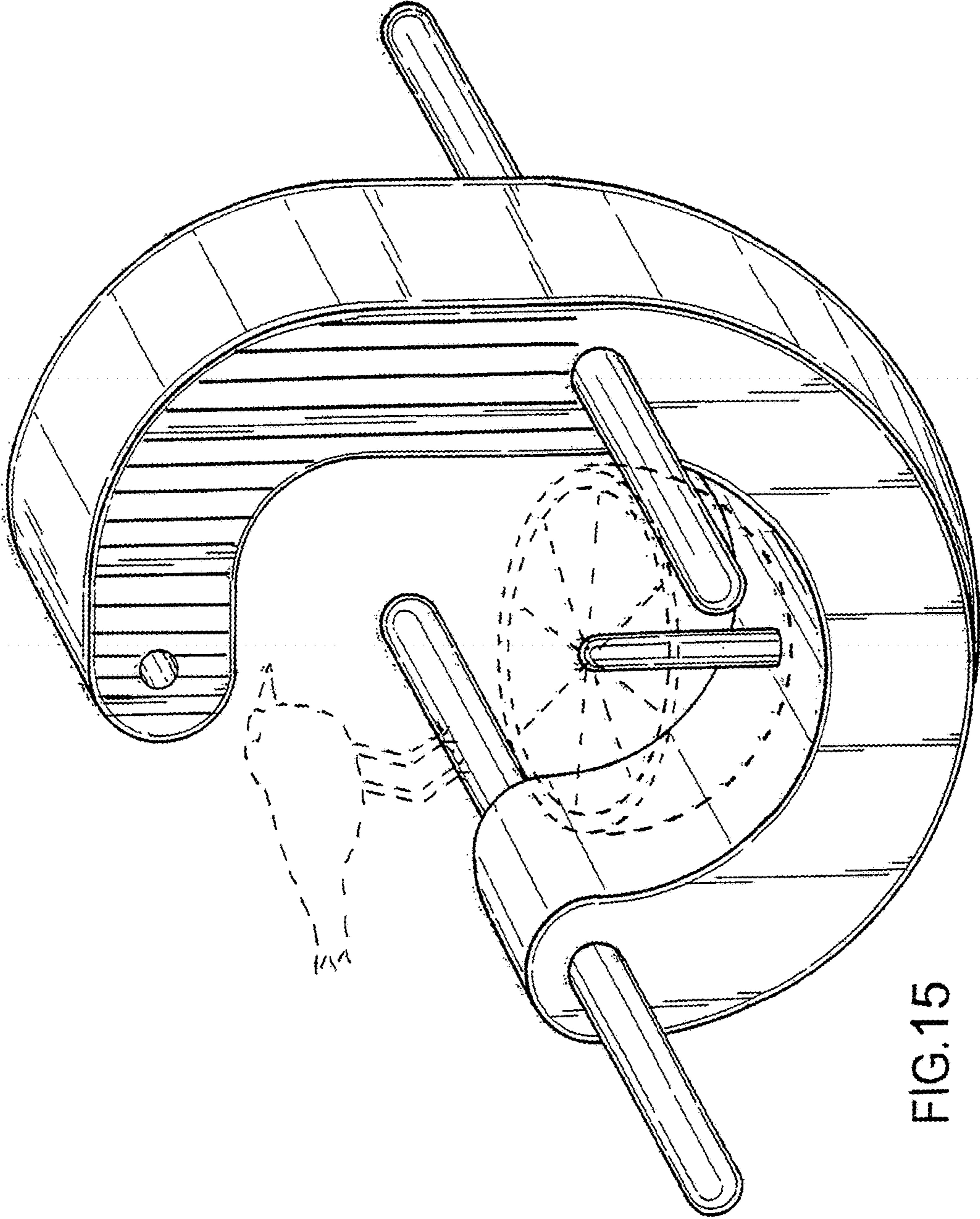

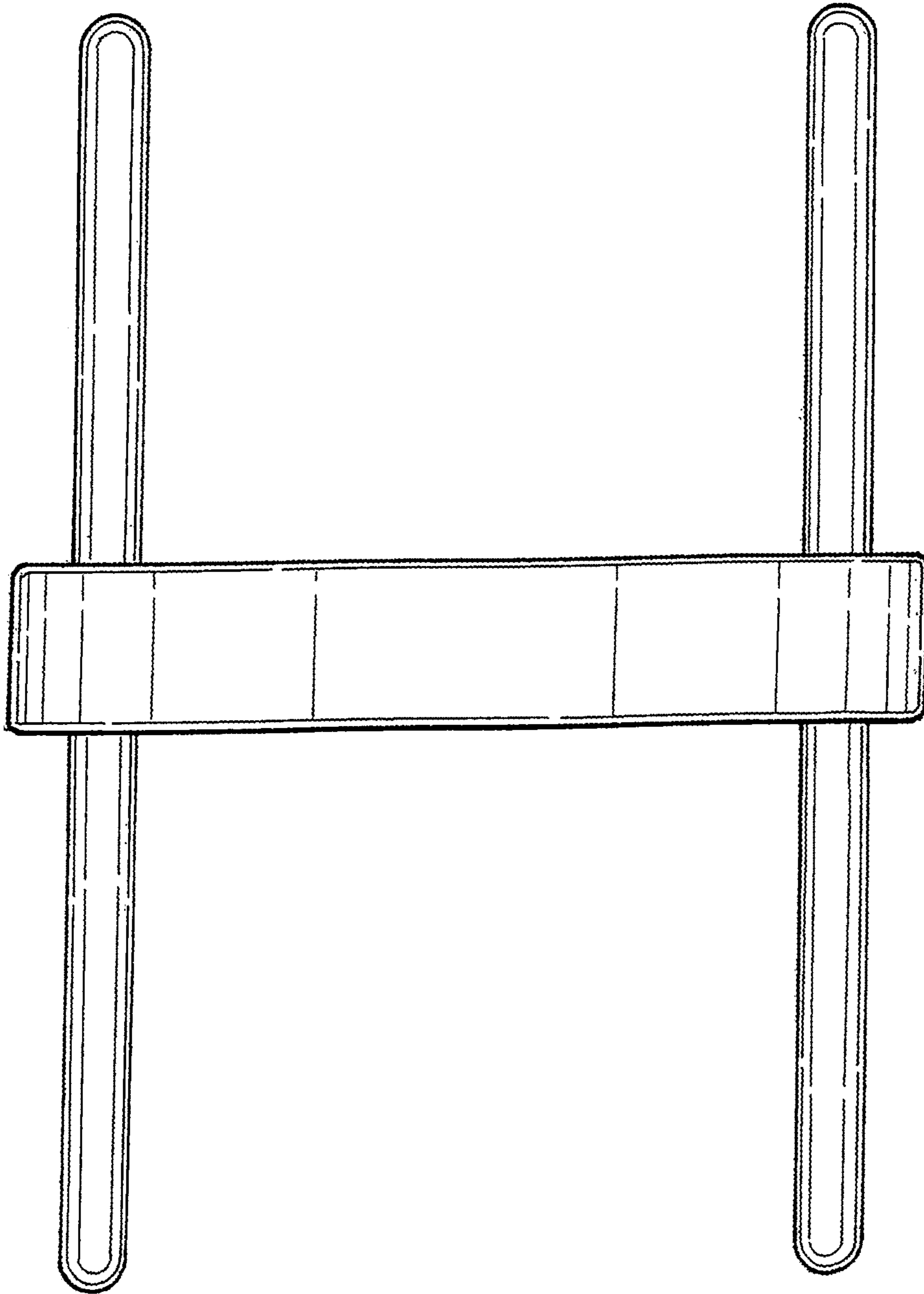

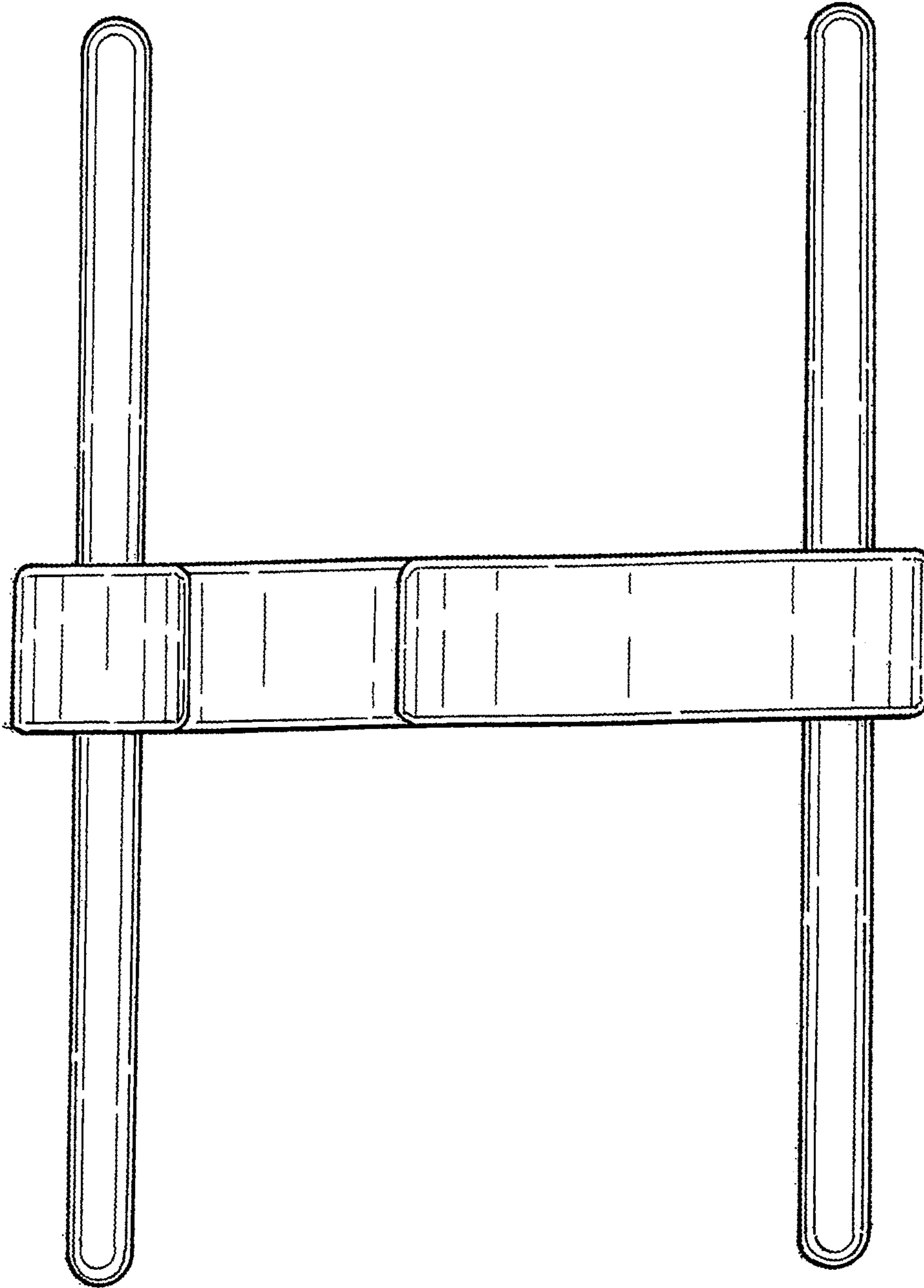

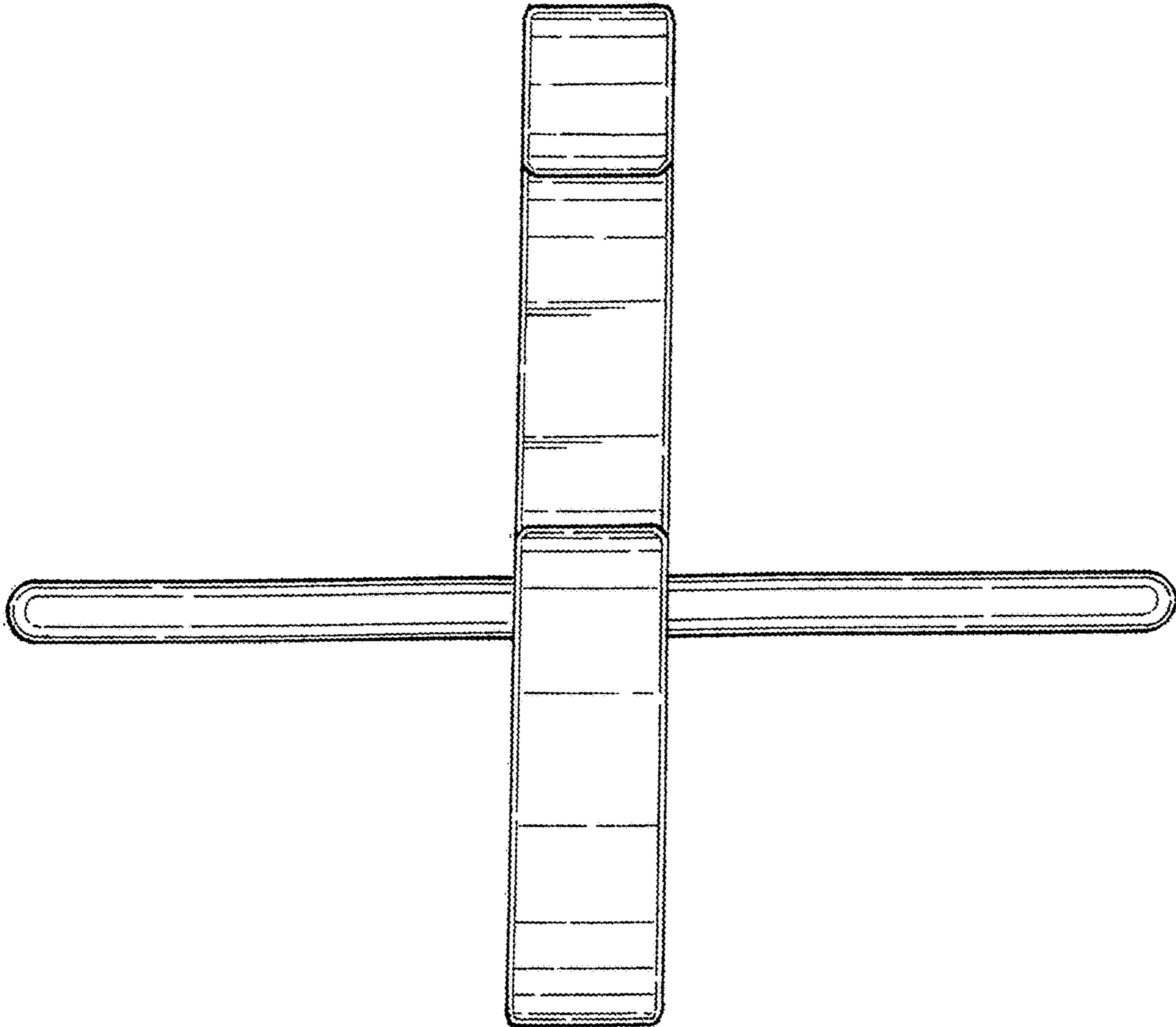

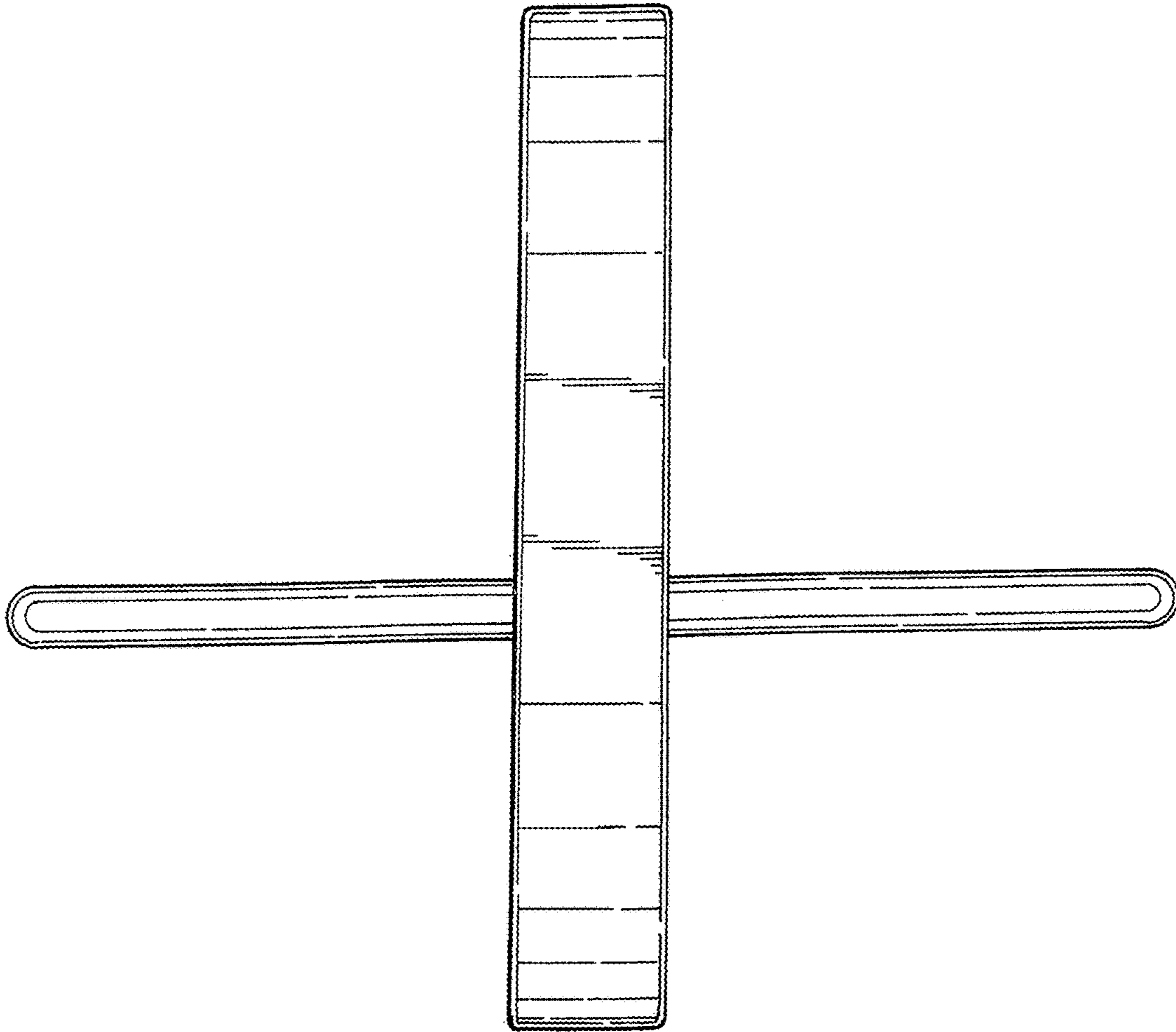

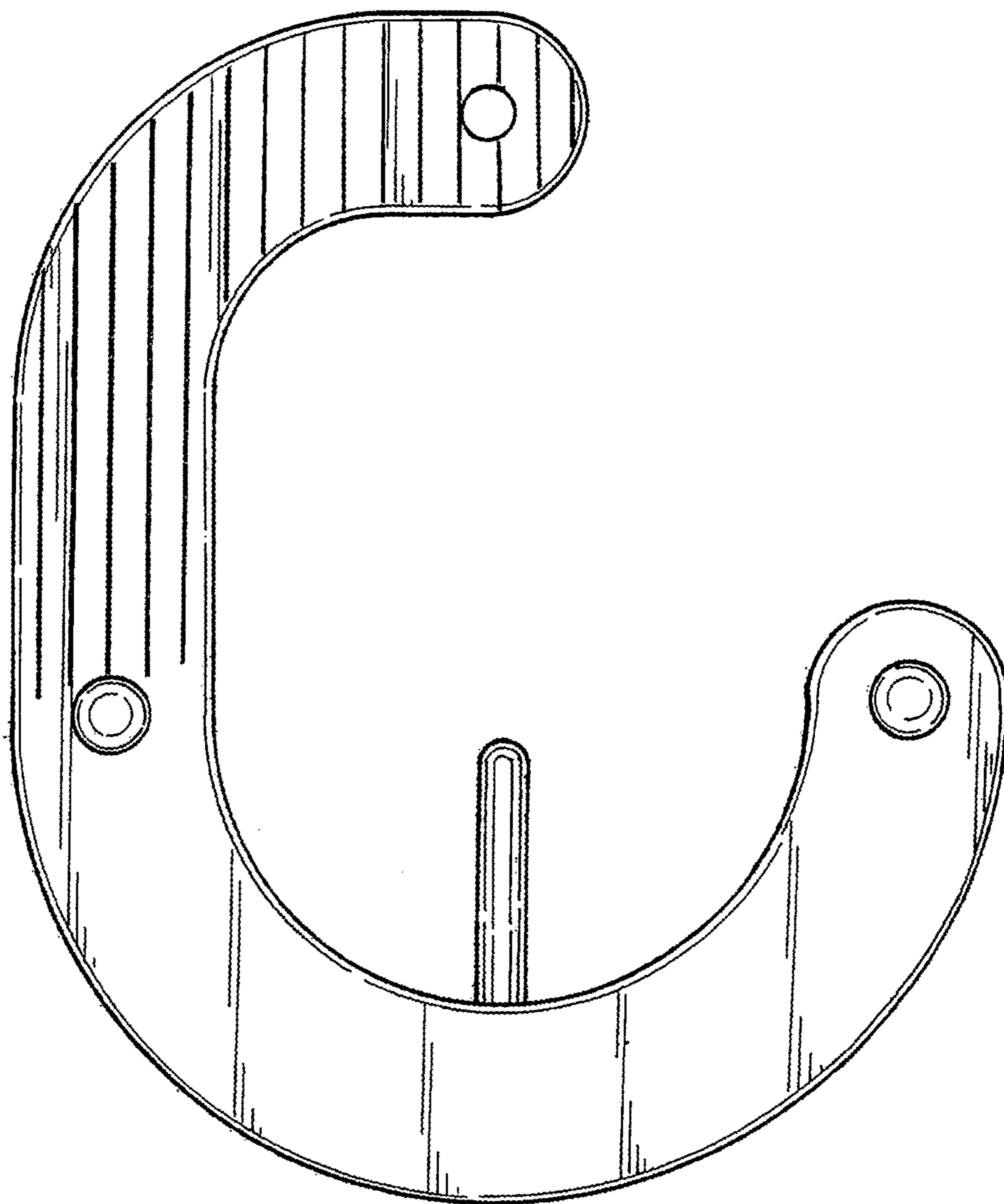

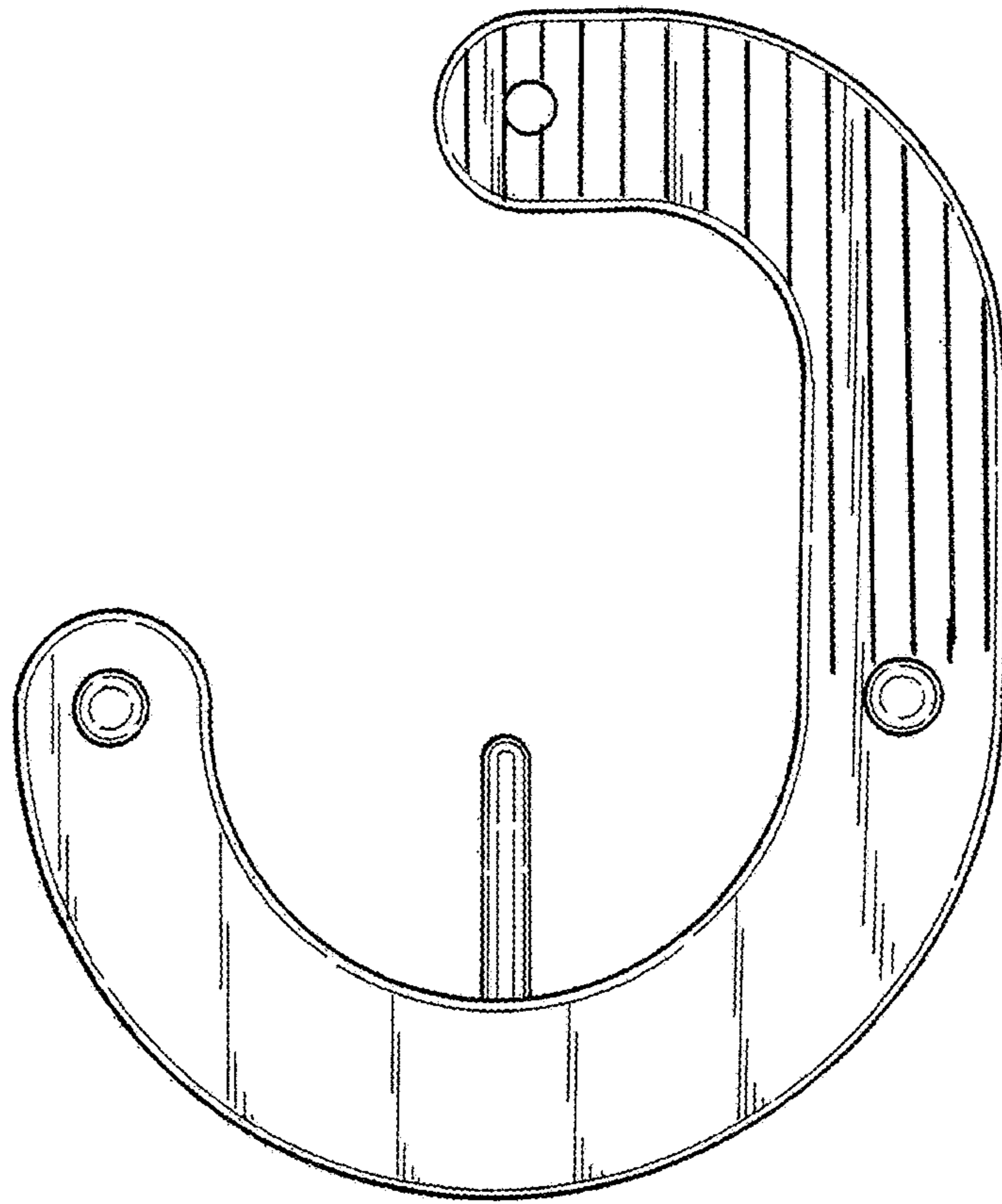
