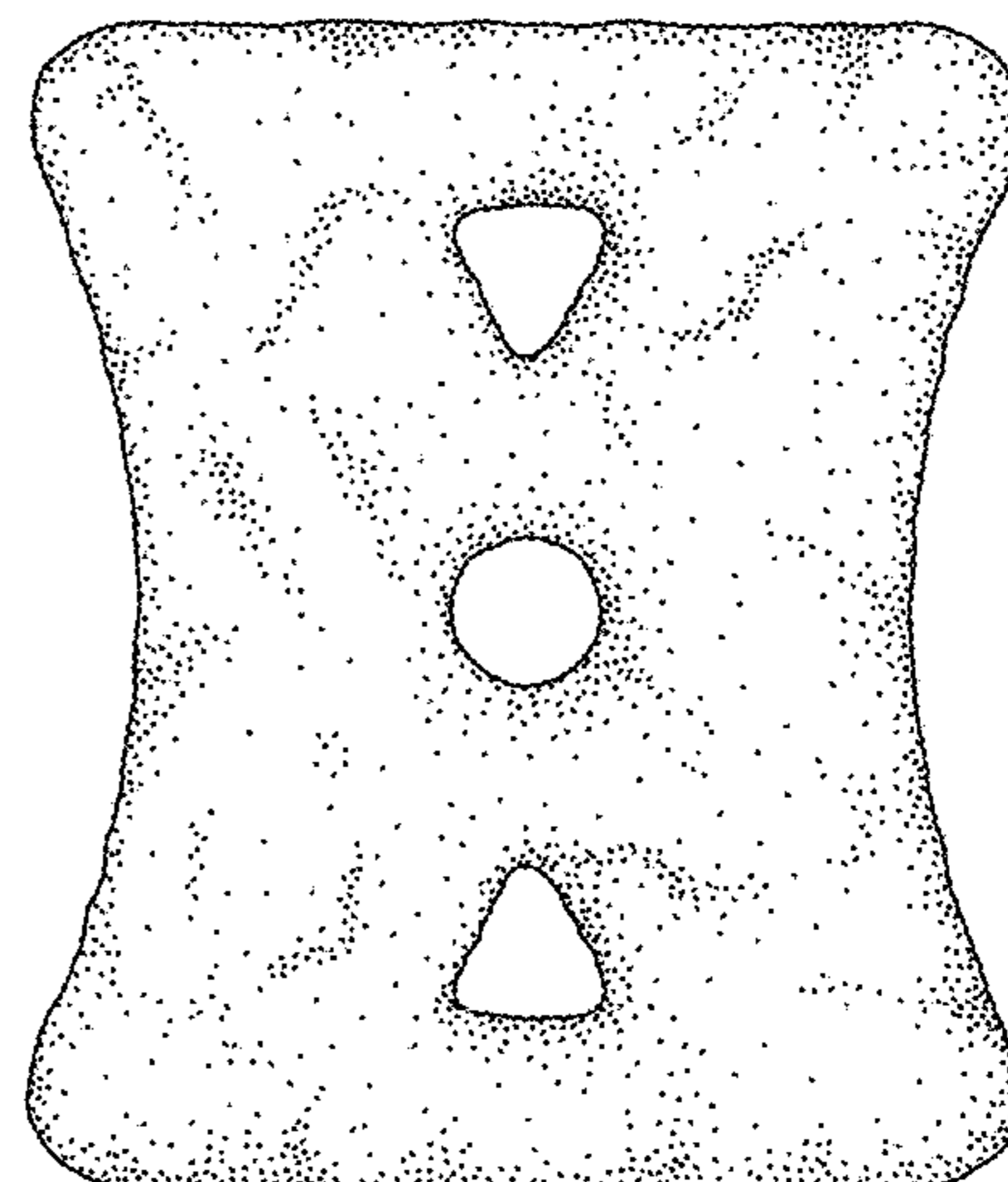
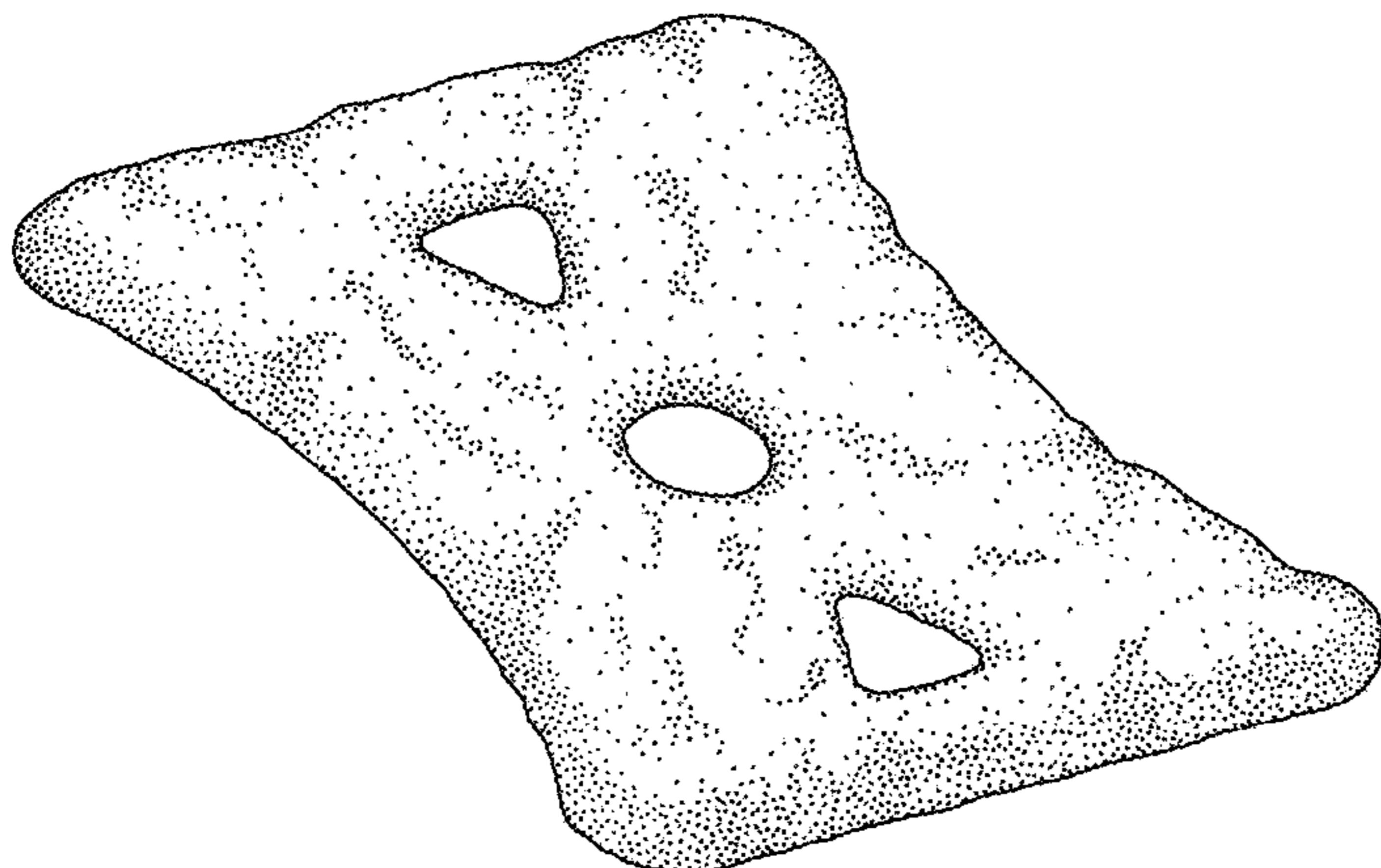
We claim the ornamental design for a food product, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left perspective view of a food product; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a left elevation view thereof; and, FIG. 7 is a right elevation view thereof.

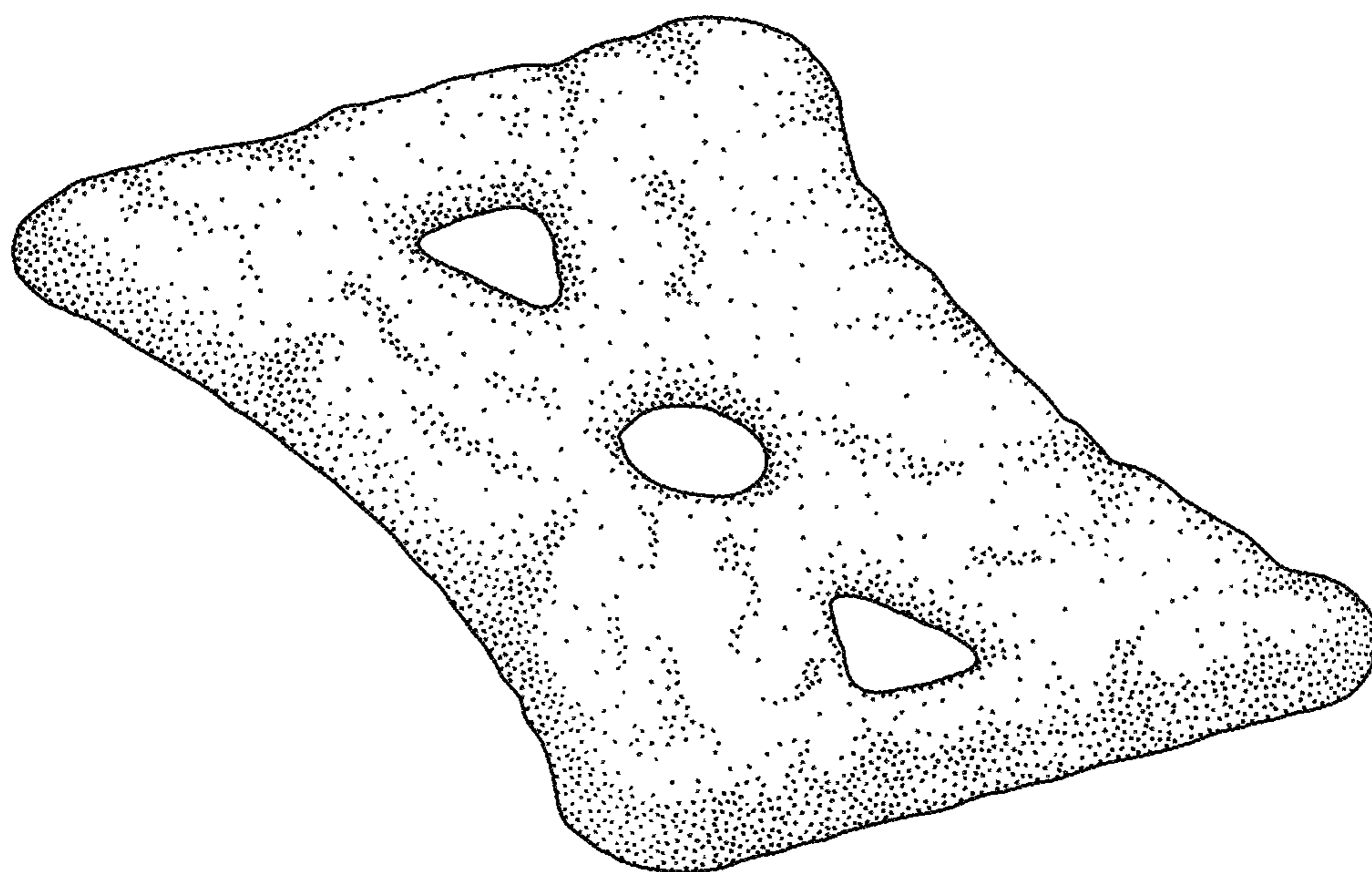

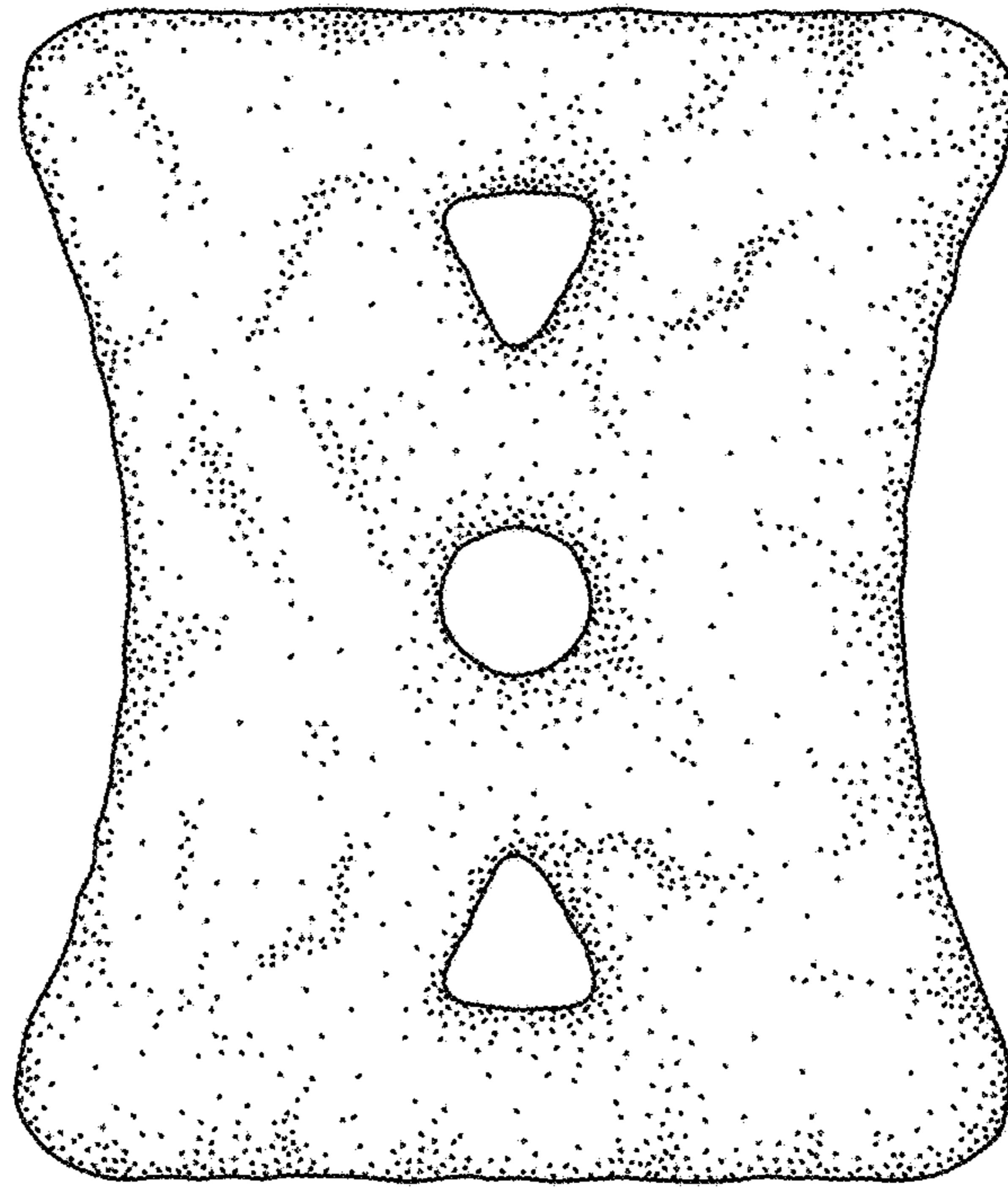

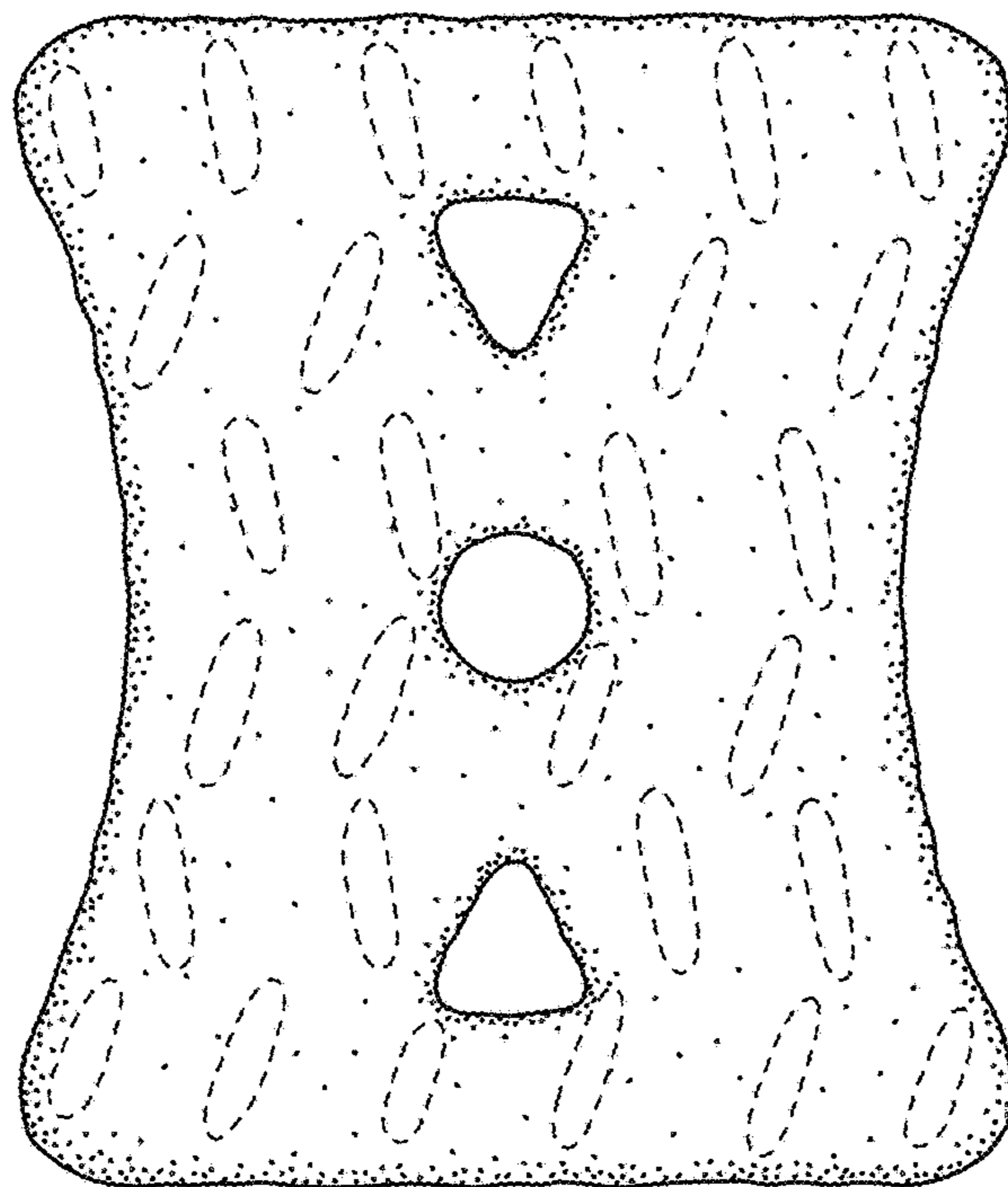
