The ornamental design for a jacket, as shown and described.

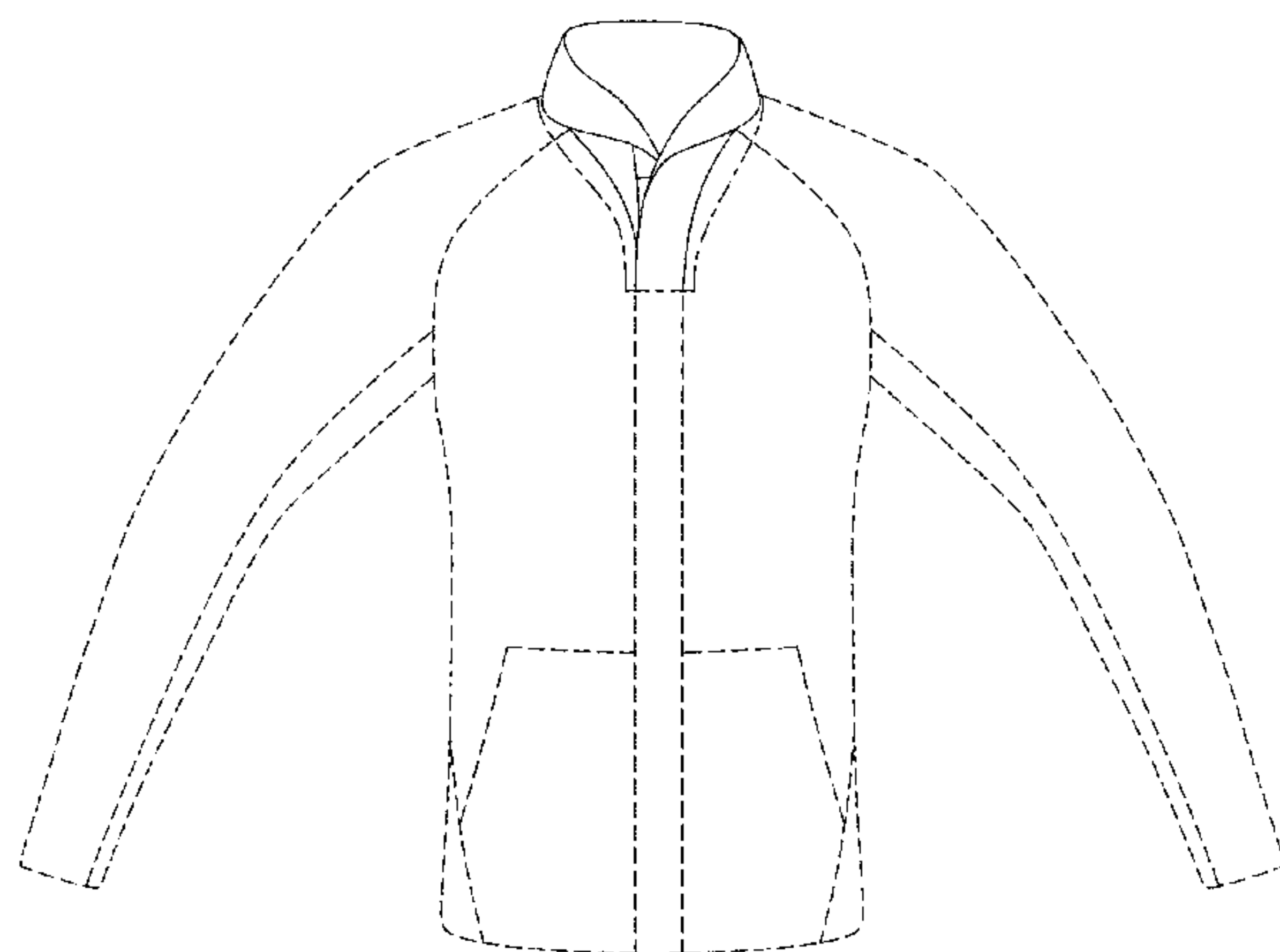
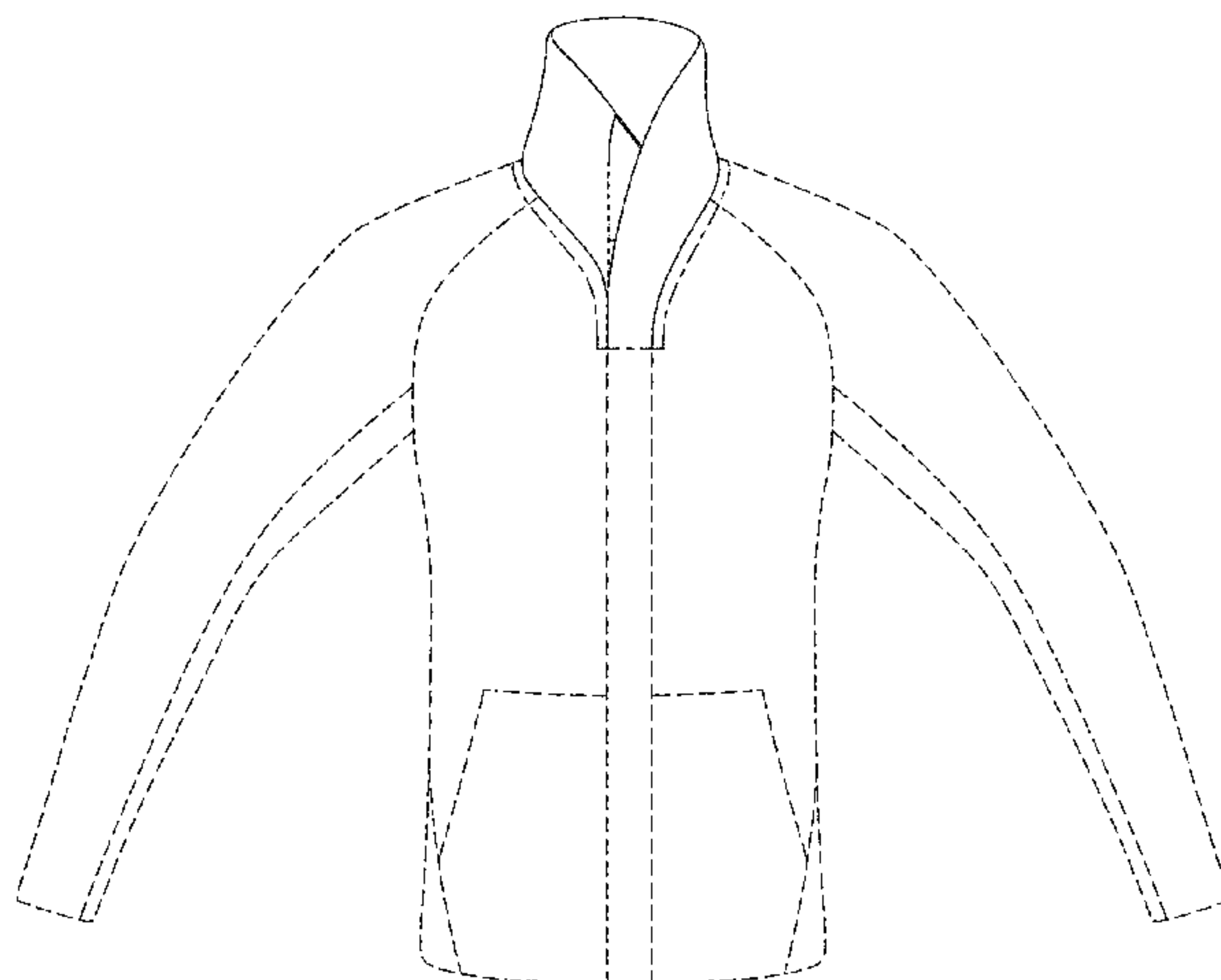
DESCRIPTION

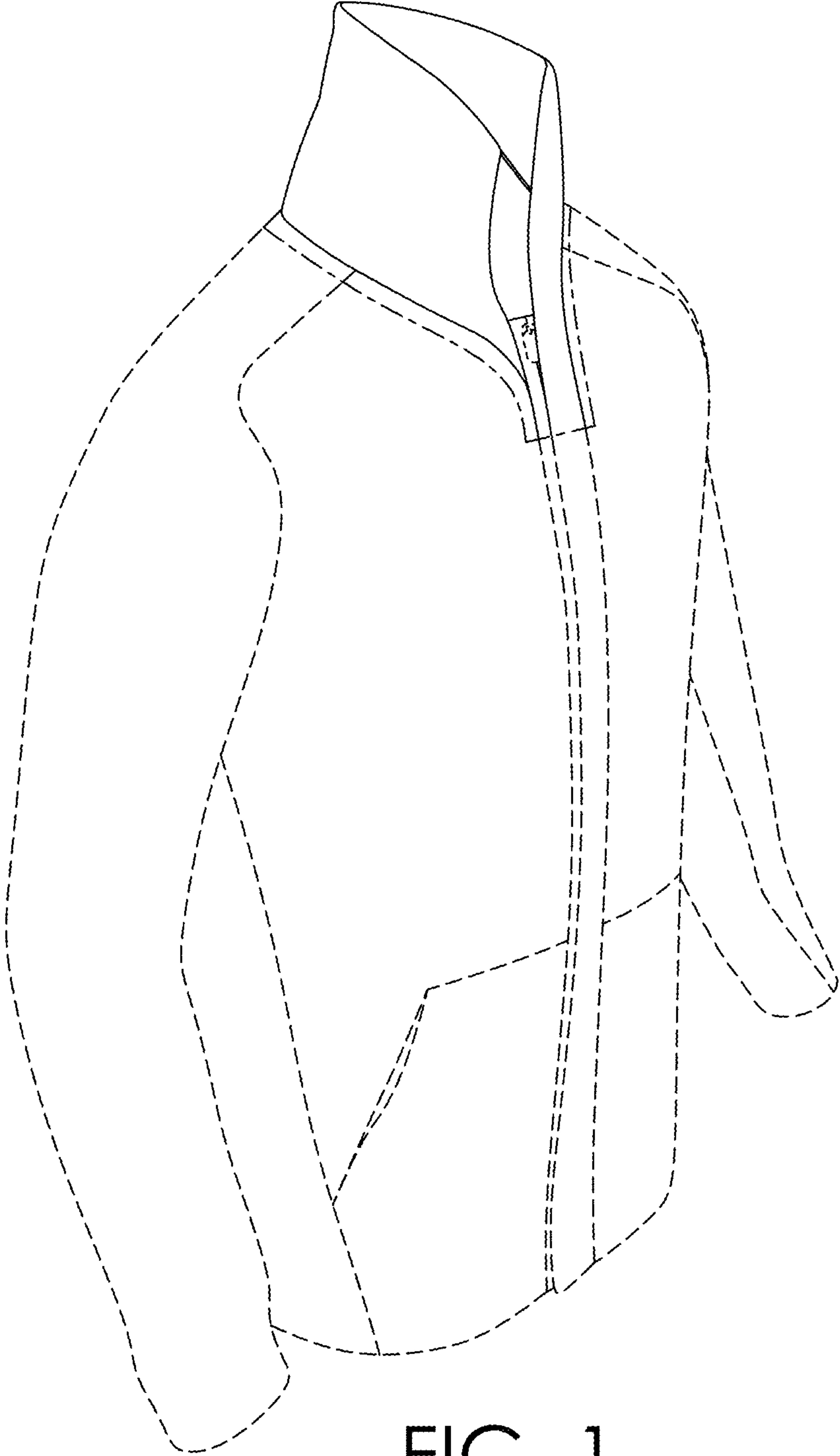

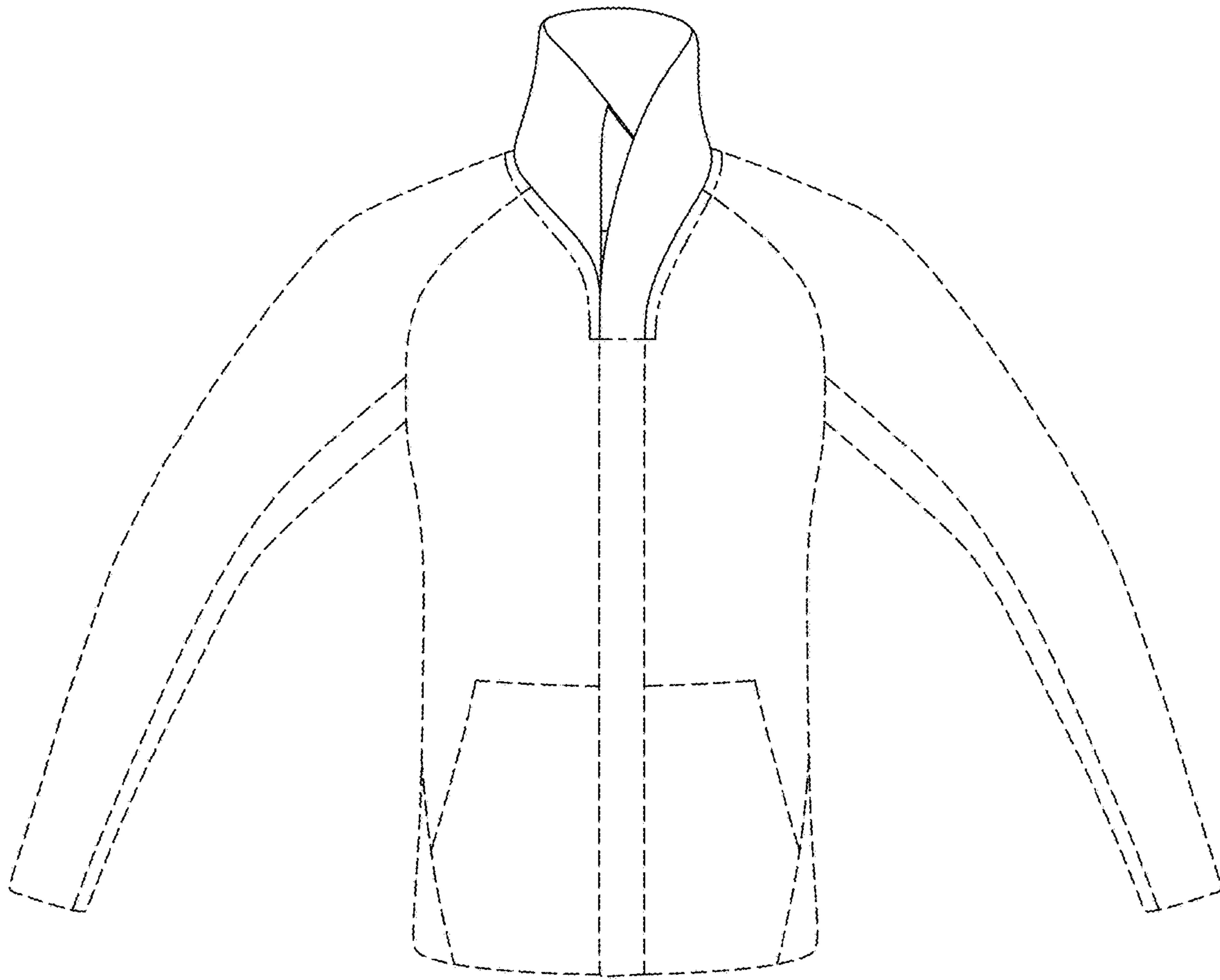

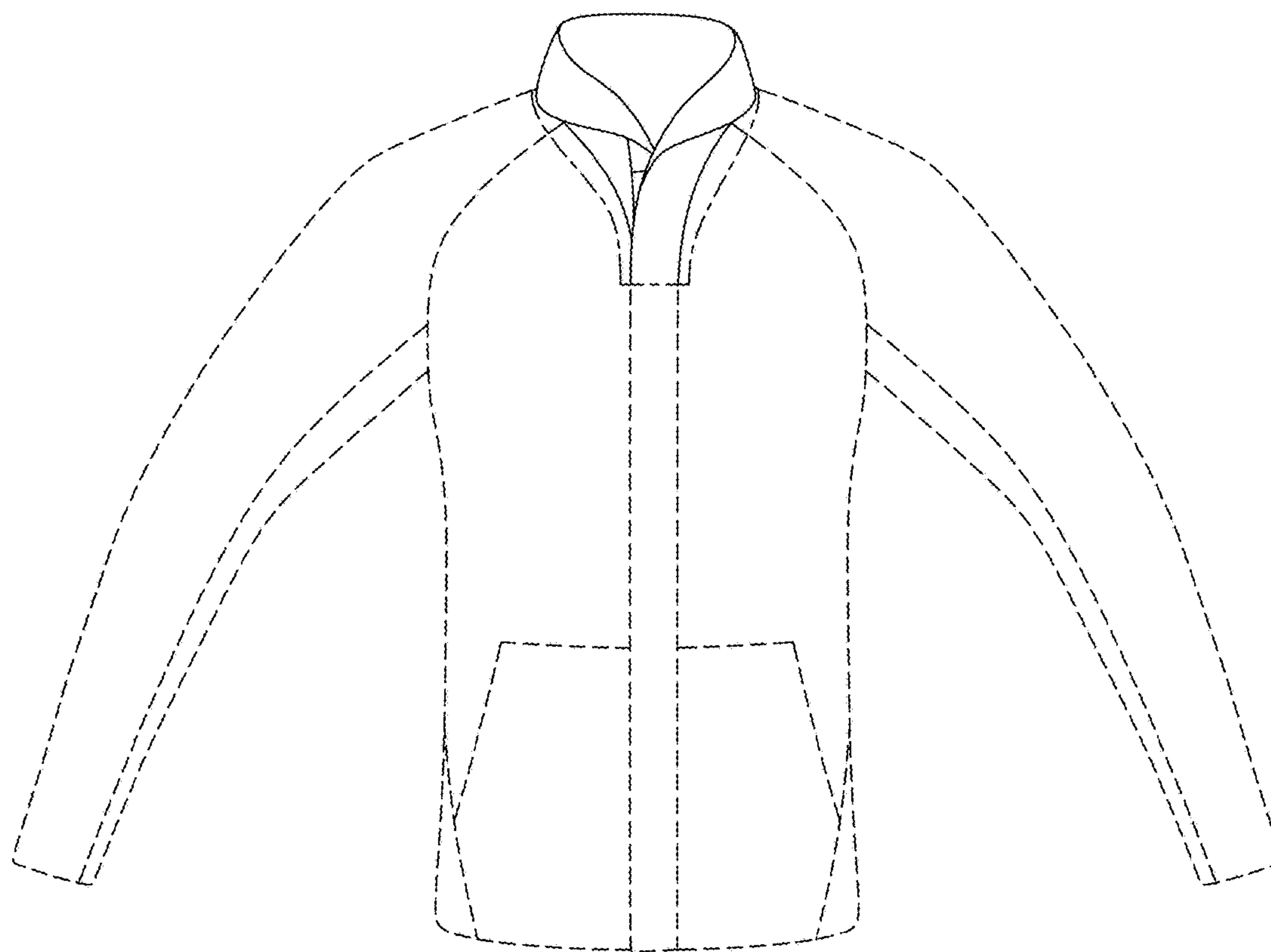

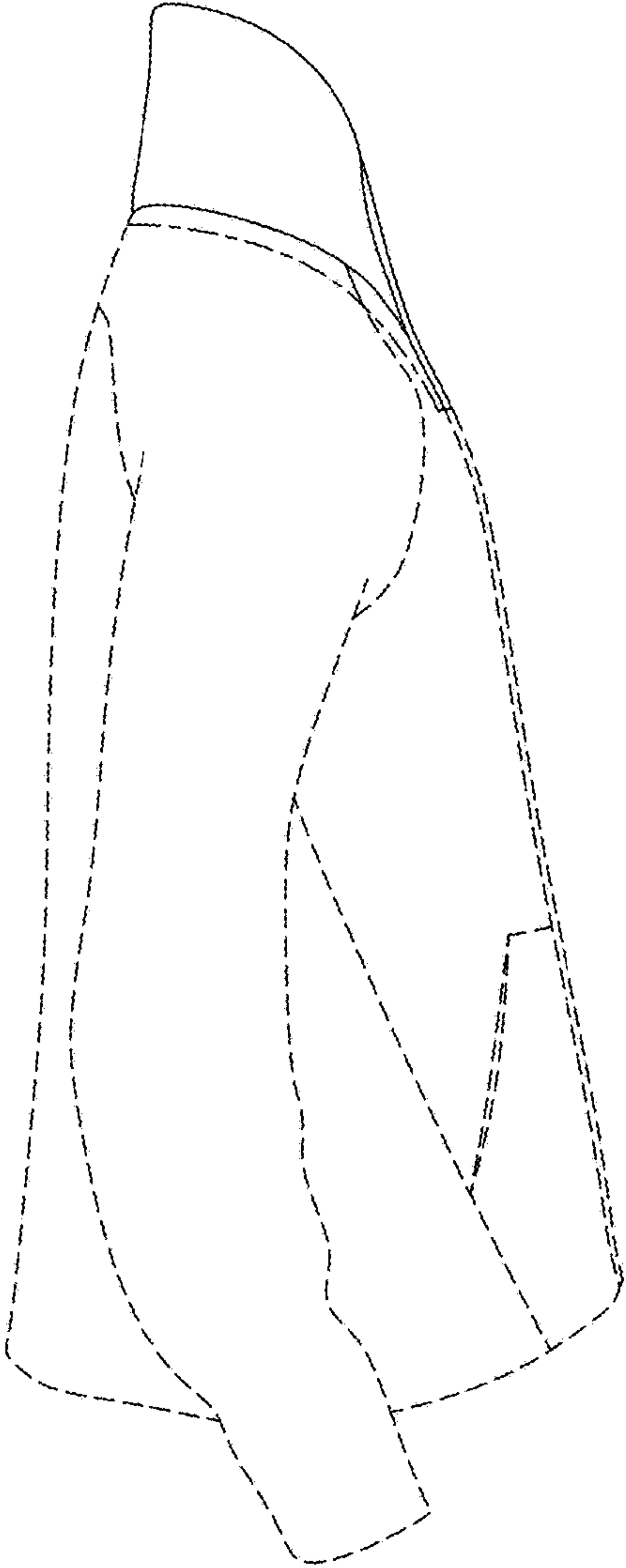

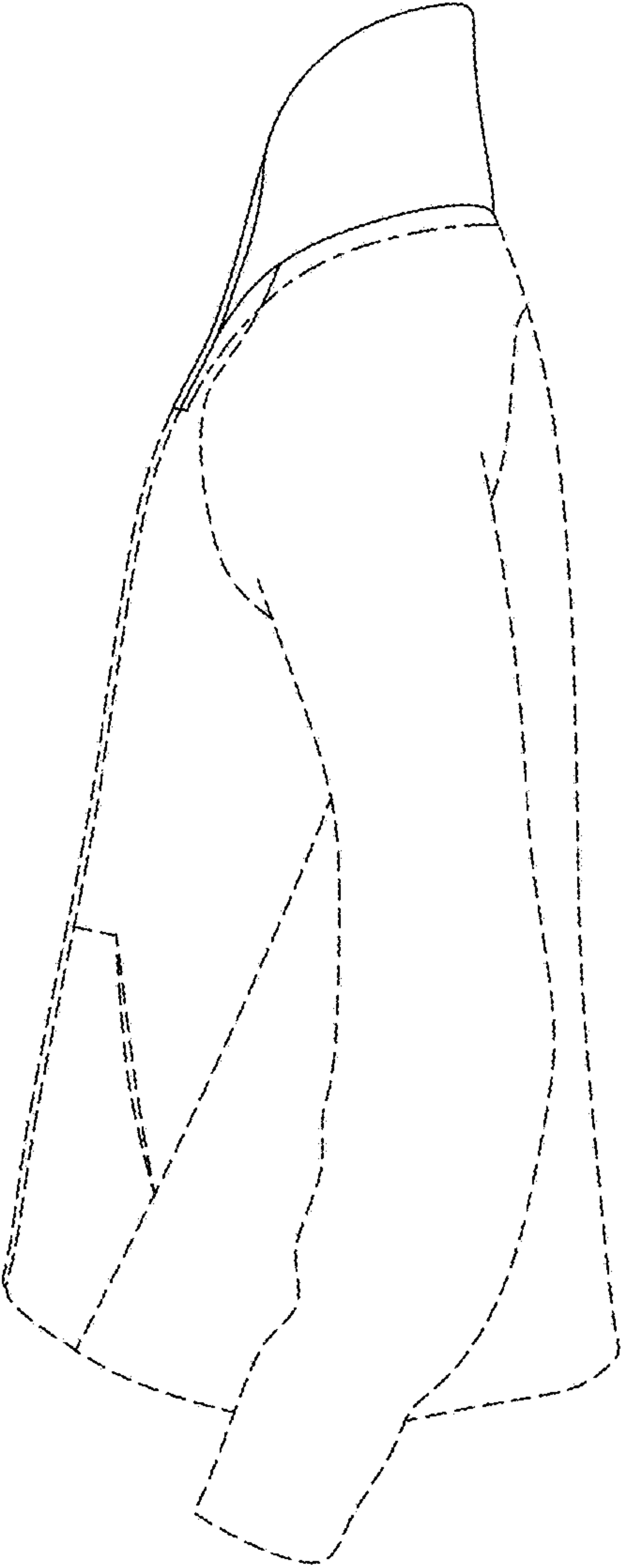

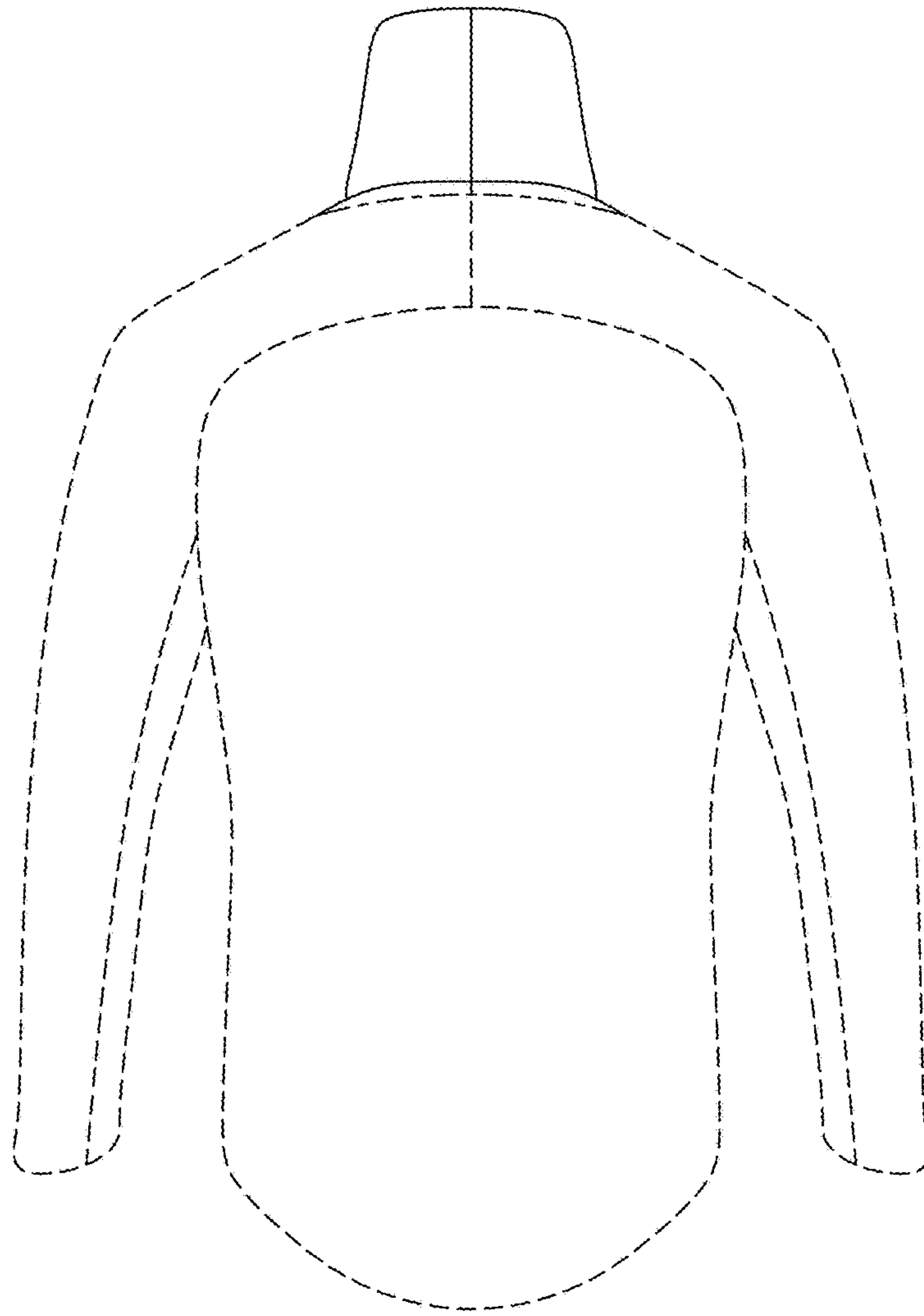

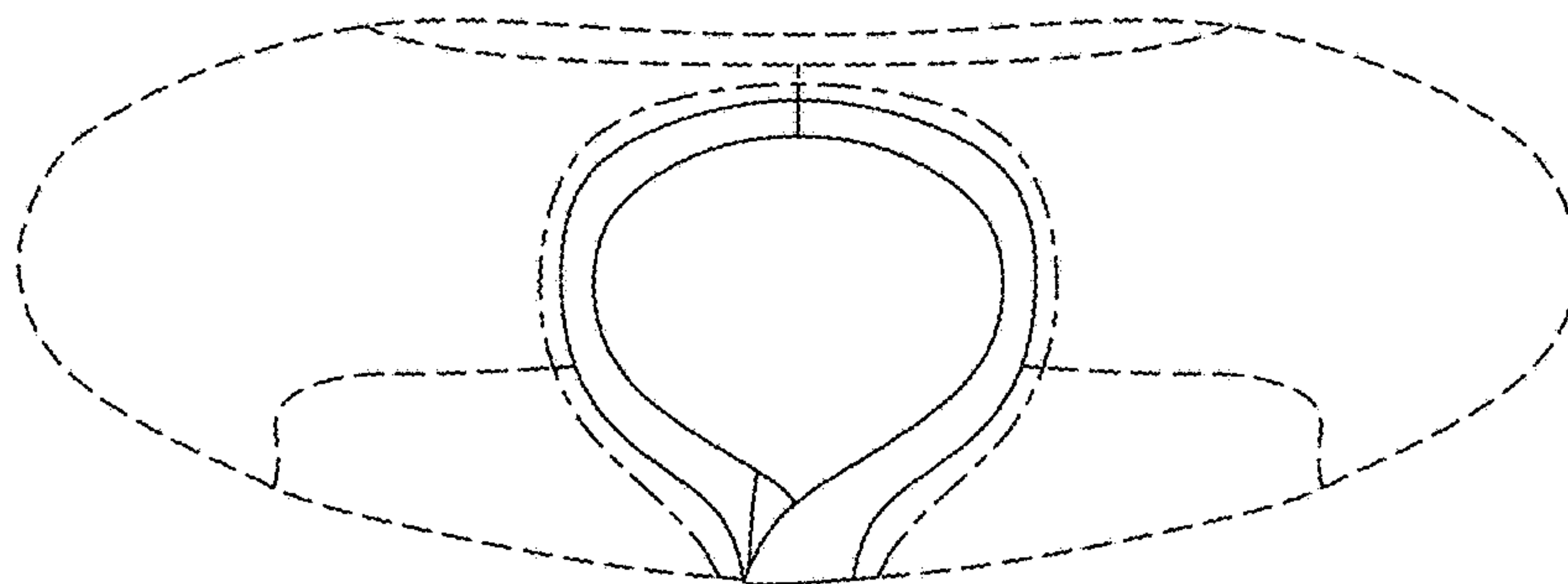
