(57) **CLAIM**

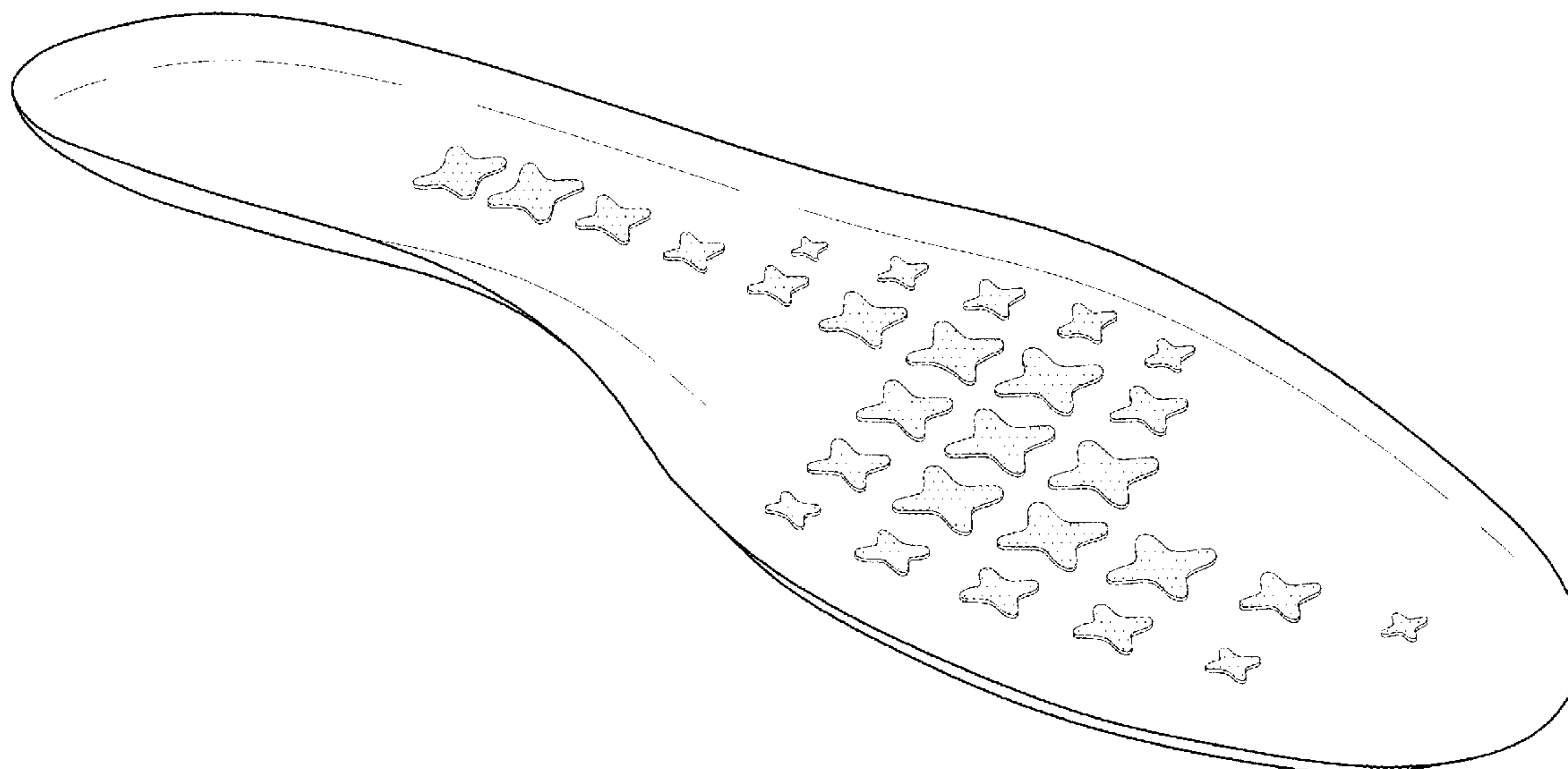
The ornamental design for a shoe insole, as shown and described.

DESCRIPTION

FIG. 1 is a top, perspective view of a shoe insole showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a lateral side elevation view thereof;
 FIG. 5 is a medial side elevation view thereof;
 FIG. 6 is a front elevation view thereof; and,
 FIG. 7 is a rear elevation view thereof.

The shoe insole shown in FIGS. 1-7 is for a left foot, the shoe insole for a right foot is a mirror image of the left foot. The stippling in FIGS. 1 and 2, representing a contrast in appearance, is not part of the claimed design.

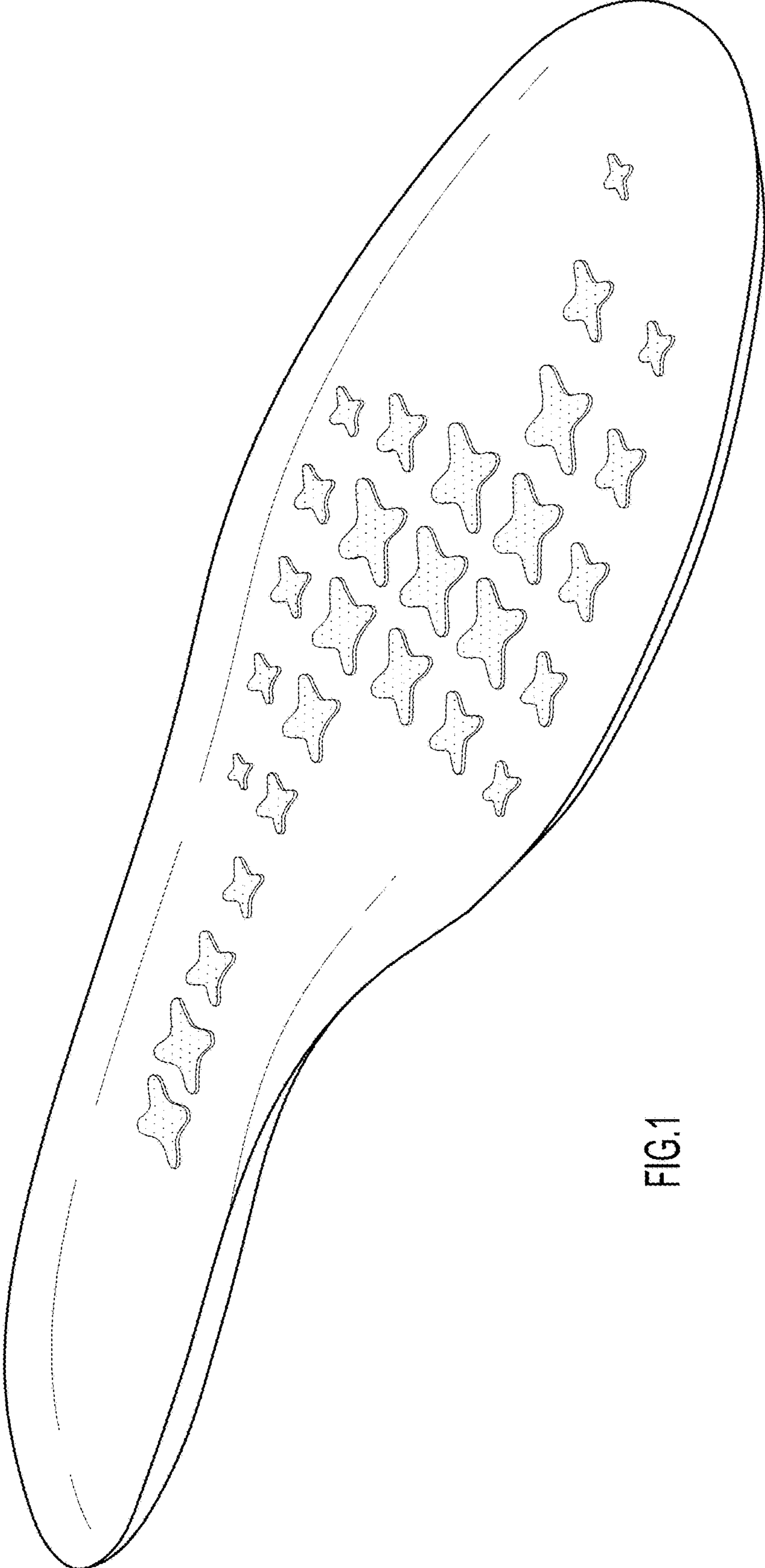

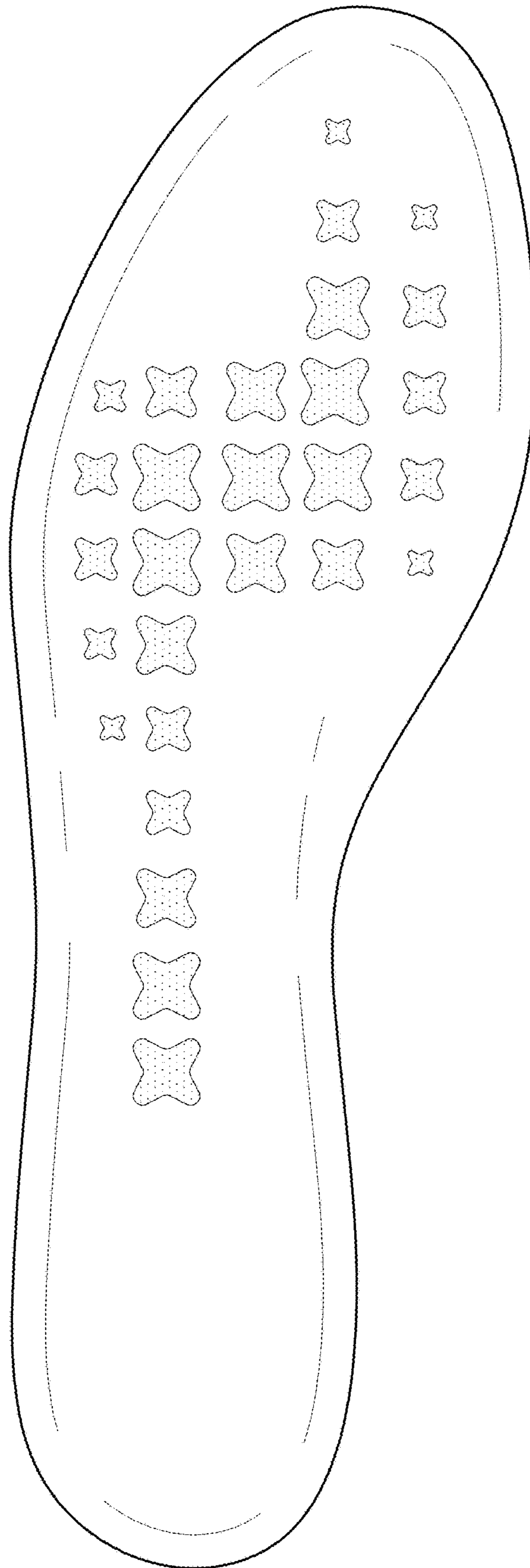

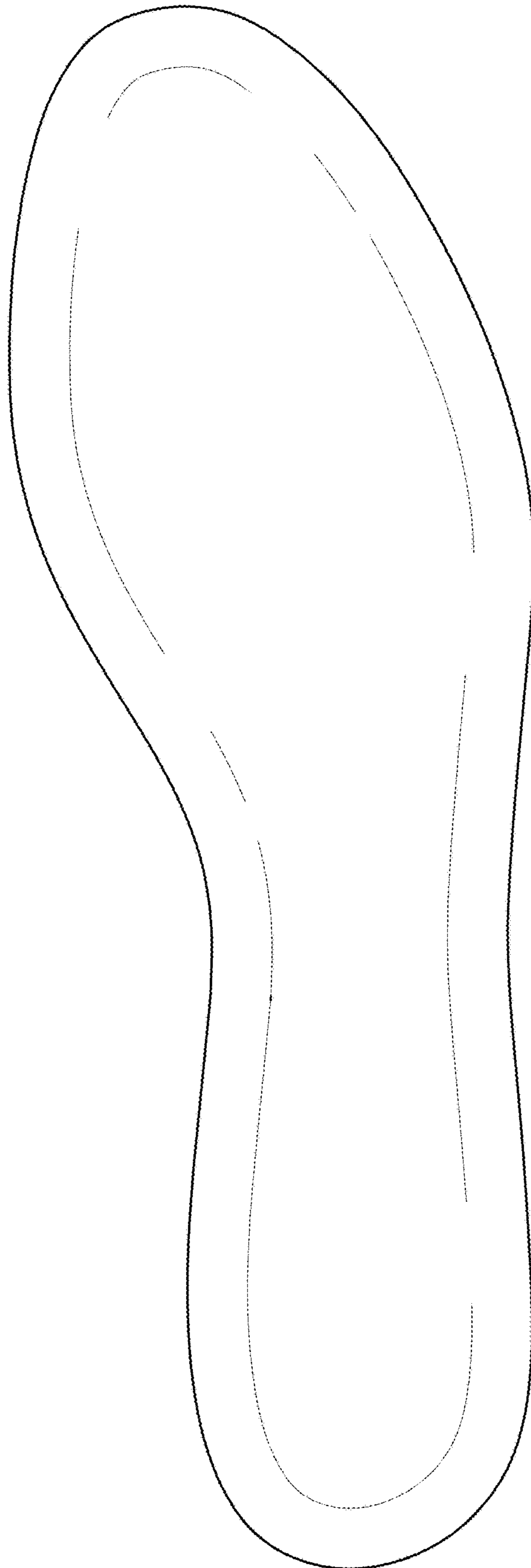

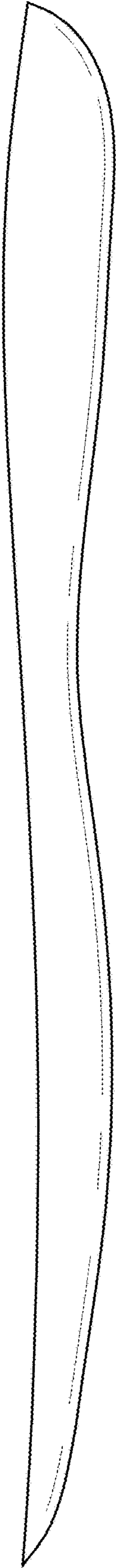

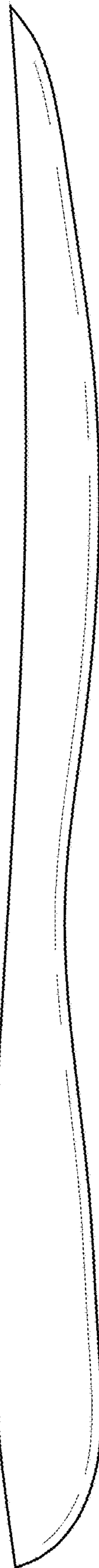

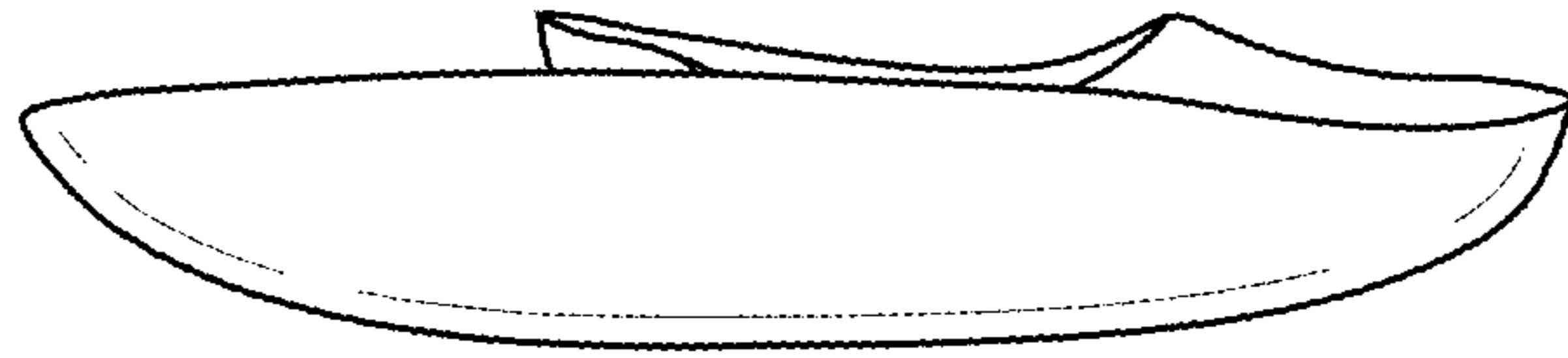

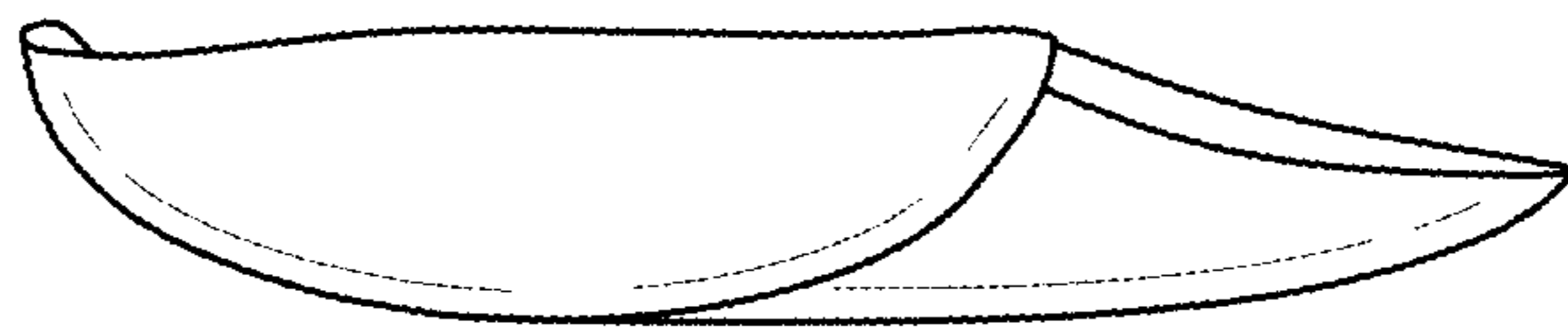
