(57) **CLAIM**

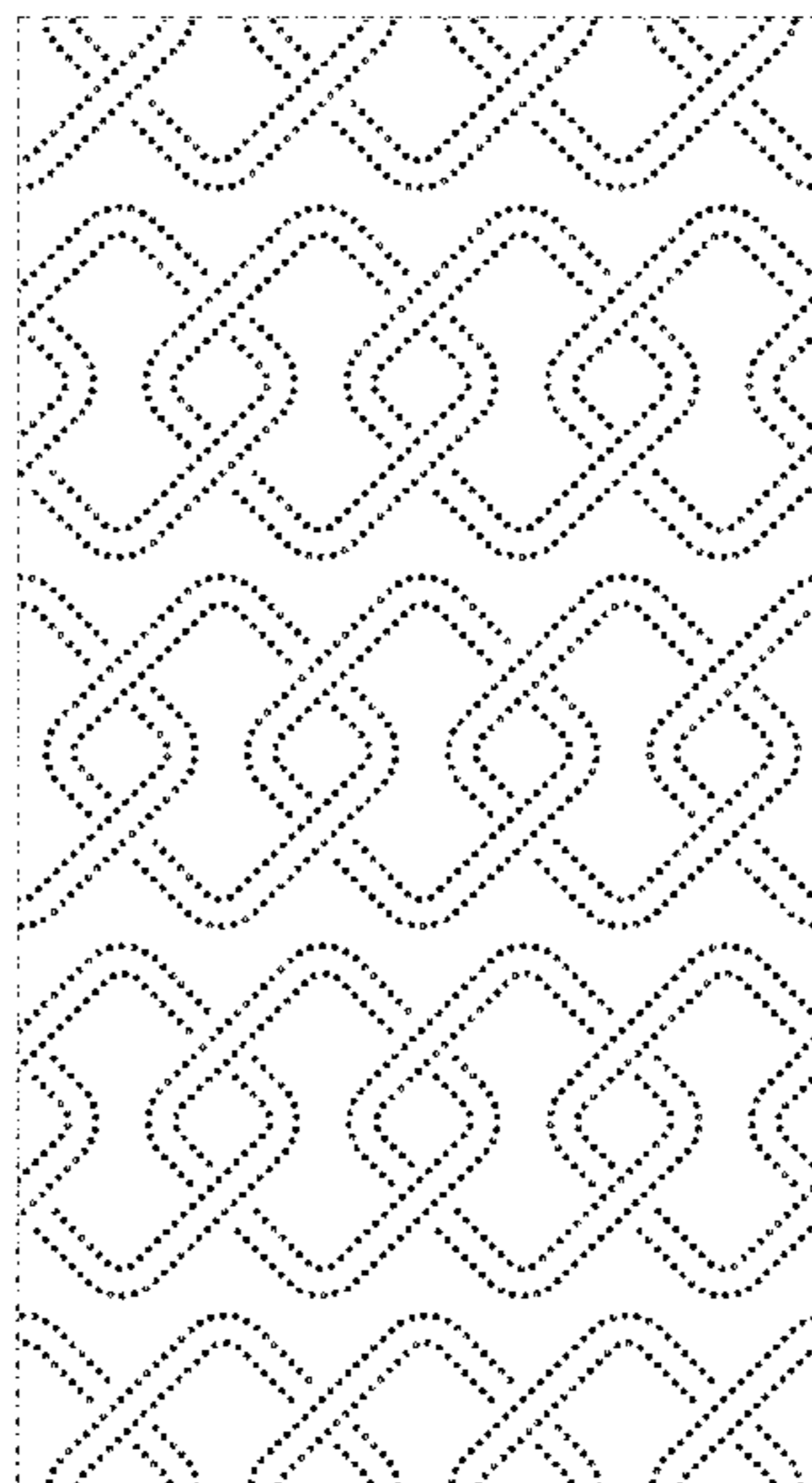
We claim the ornamental design for a paper product with surface pattern, as shown and described.
