(57) **CLAIM**

The ornamental design for a cover for bowl, as shown and described.

DESCRIPTION

This application is related to co-pending Ser. Nos. 29/583, 624 and 29/583,629, which are incorporated herein by reference.

FIG. 1 is a top, front and left side perspective view of a cover for bowl showing my new design;

FIG. 2 is a bottom, front and right side perspective view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a right side elevation view, the left side being a mirror image thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a cross-sectional view taken along line 8-8 of FIG. 6; and,

FIG. 9 is a cross-sectional view taken along line 9-9 of FIG. 6.

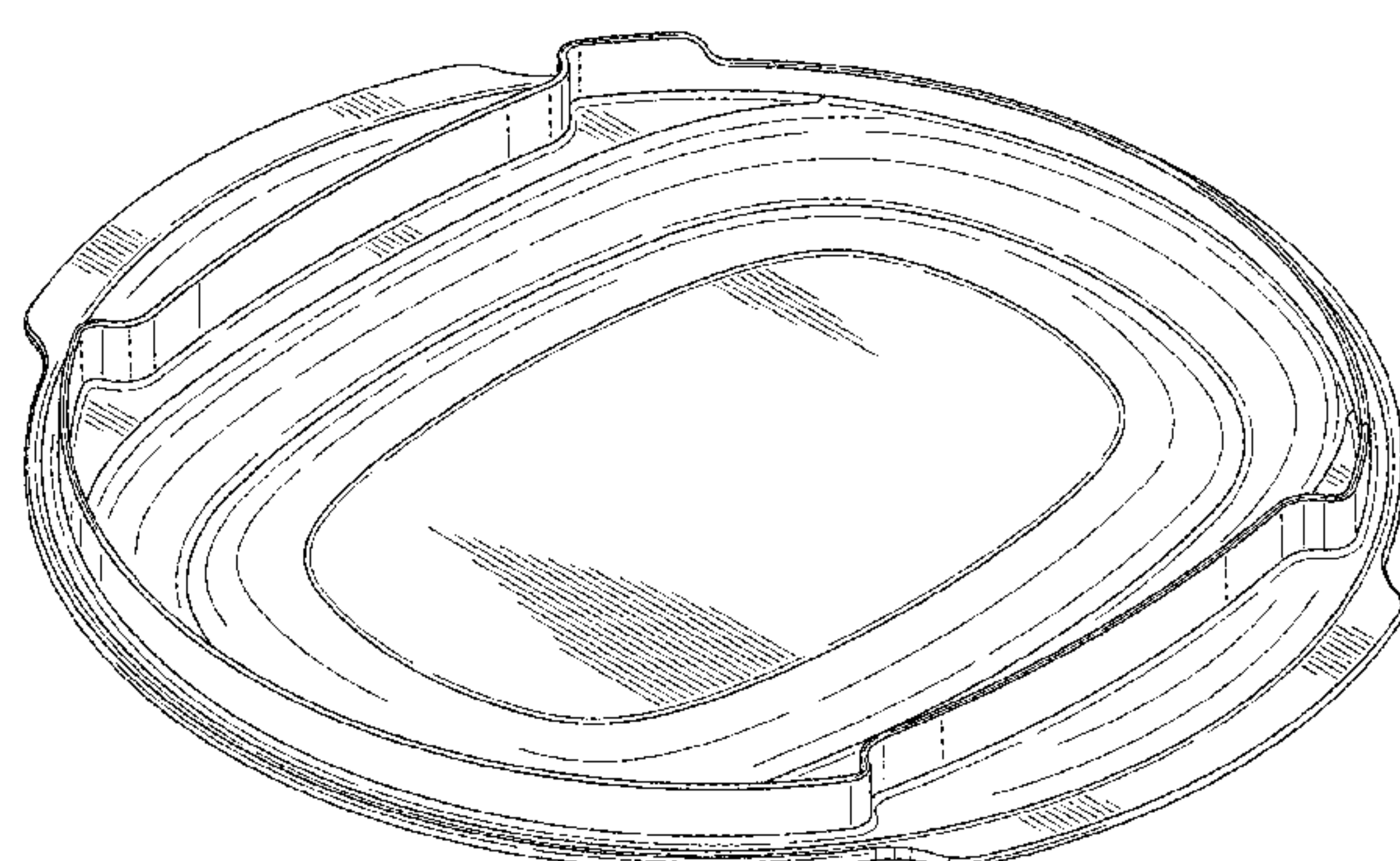
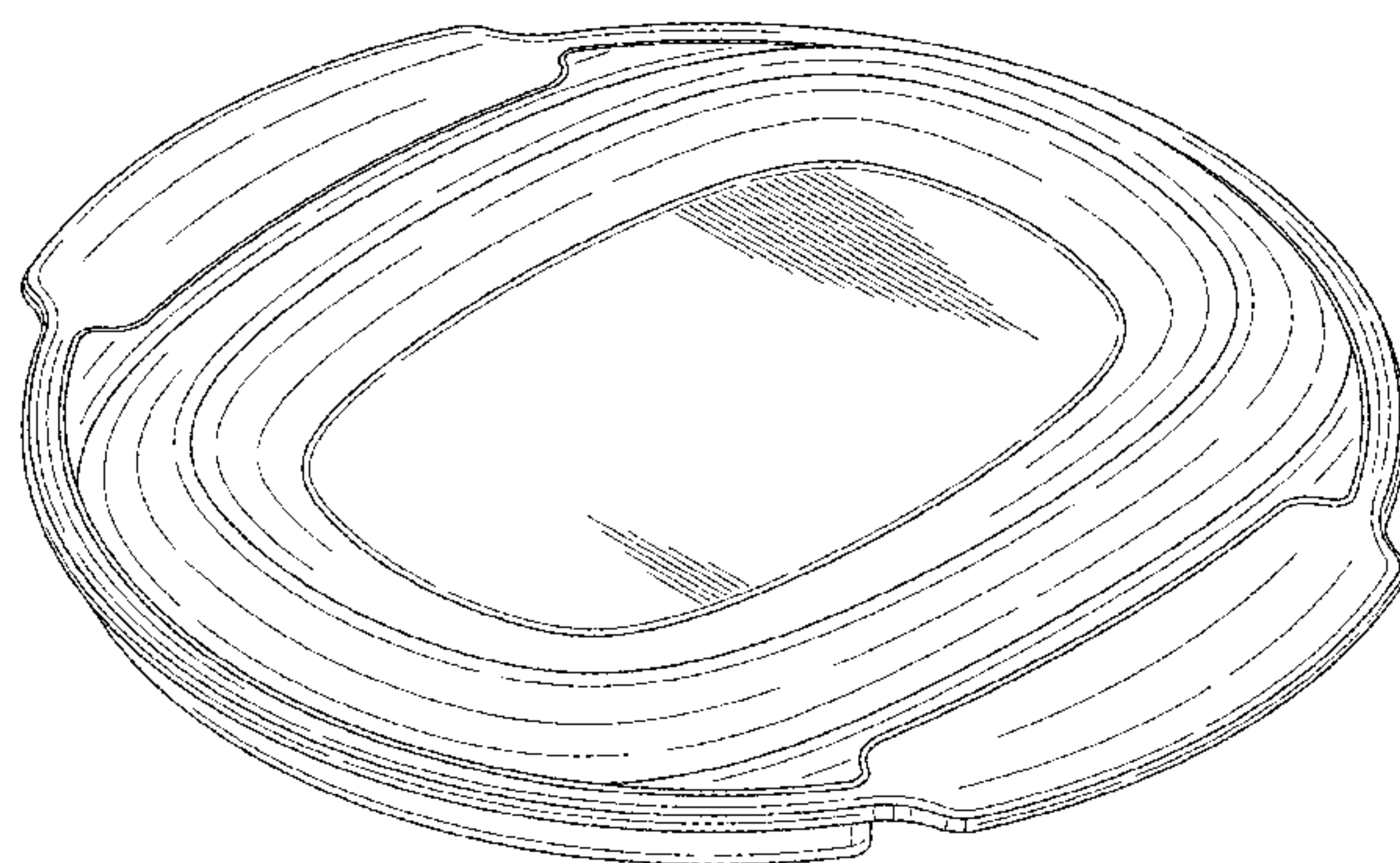

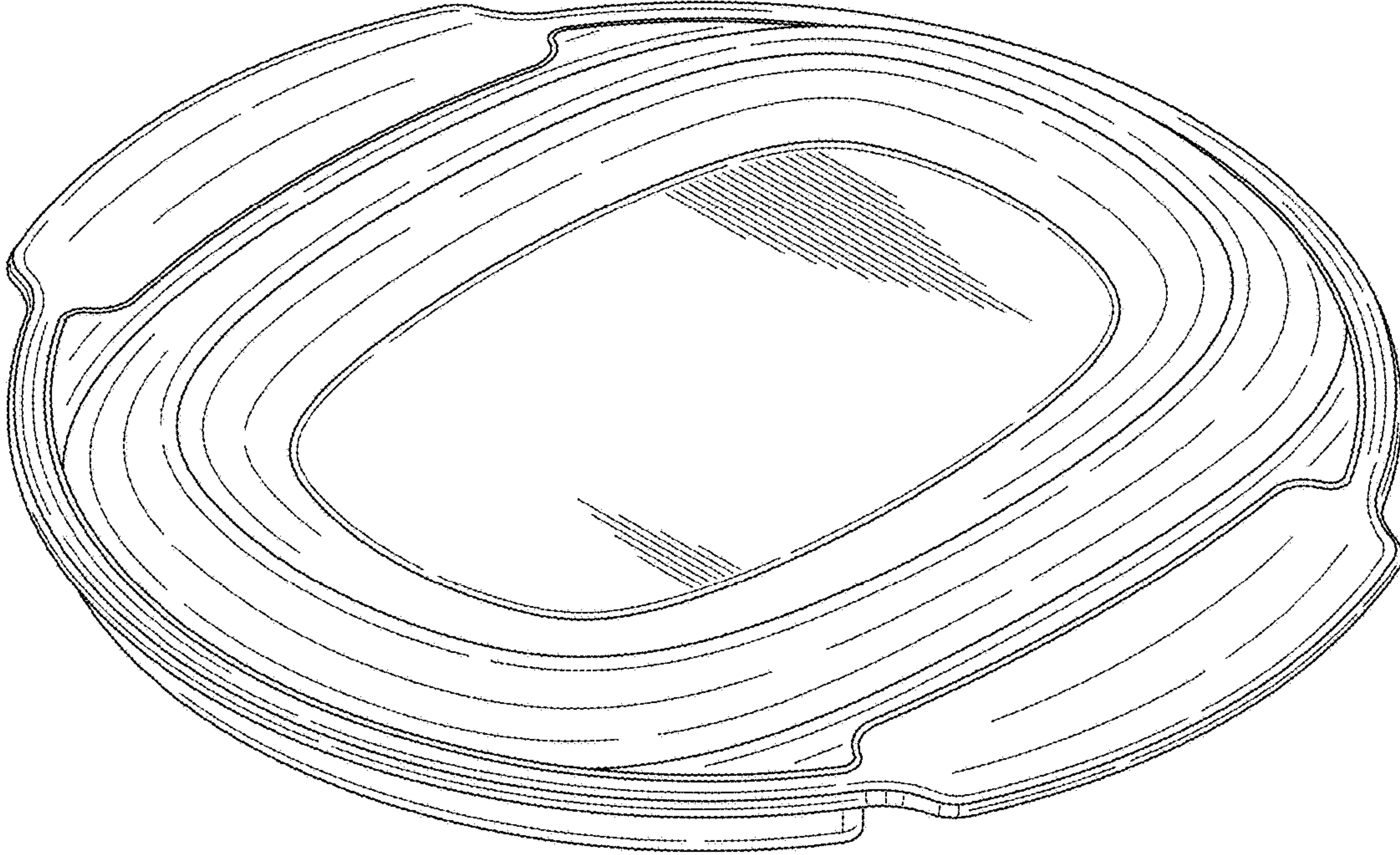

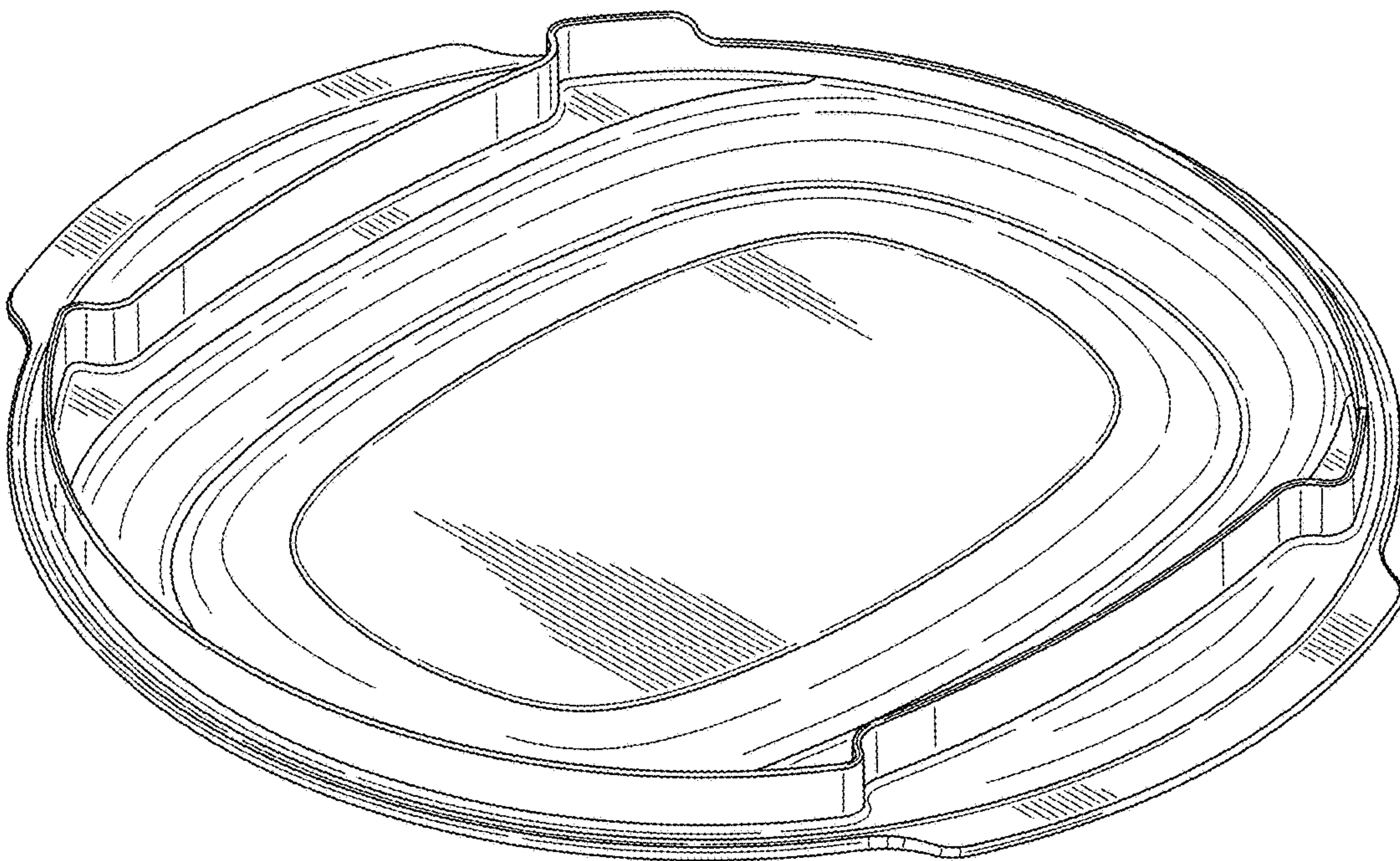

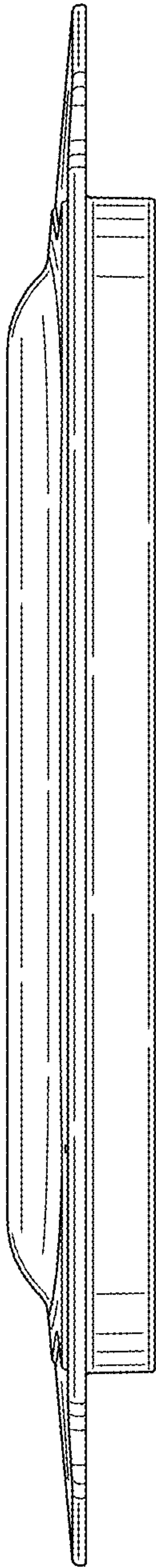

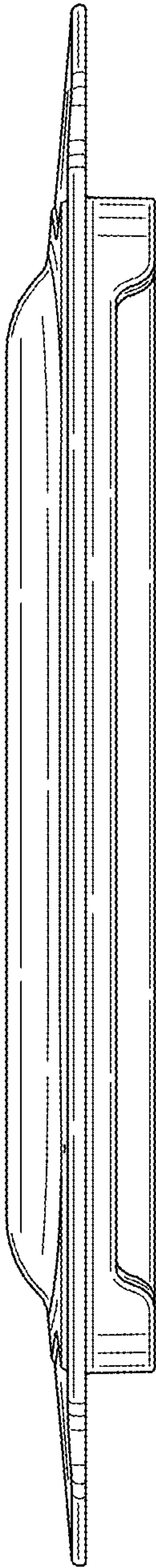
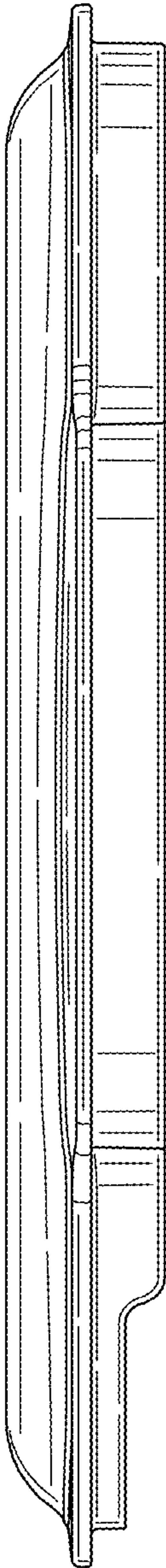
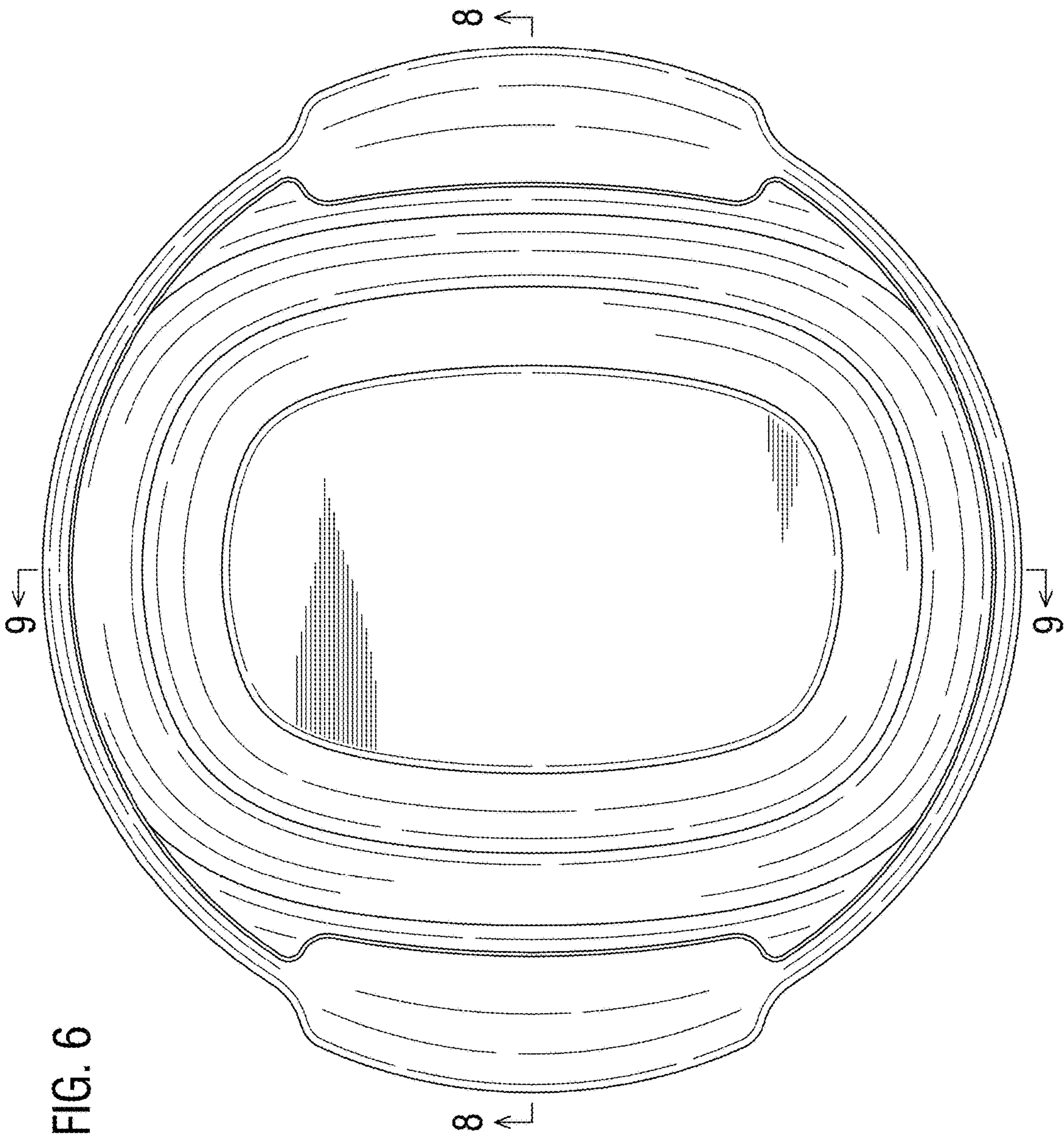

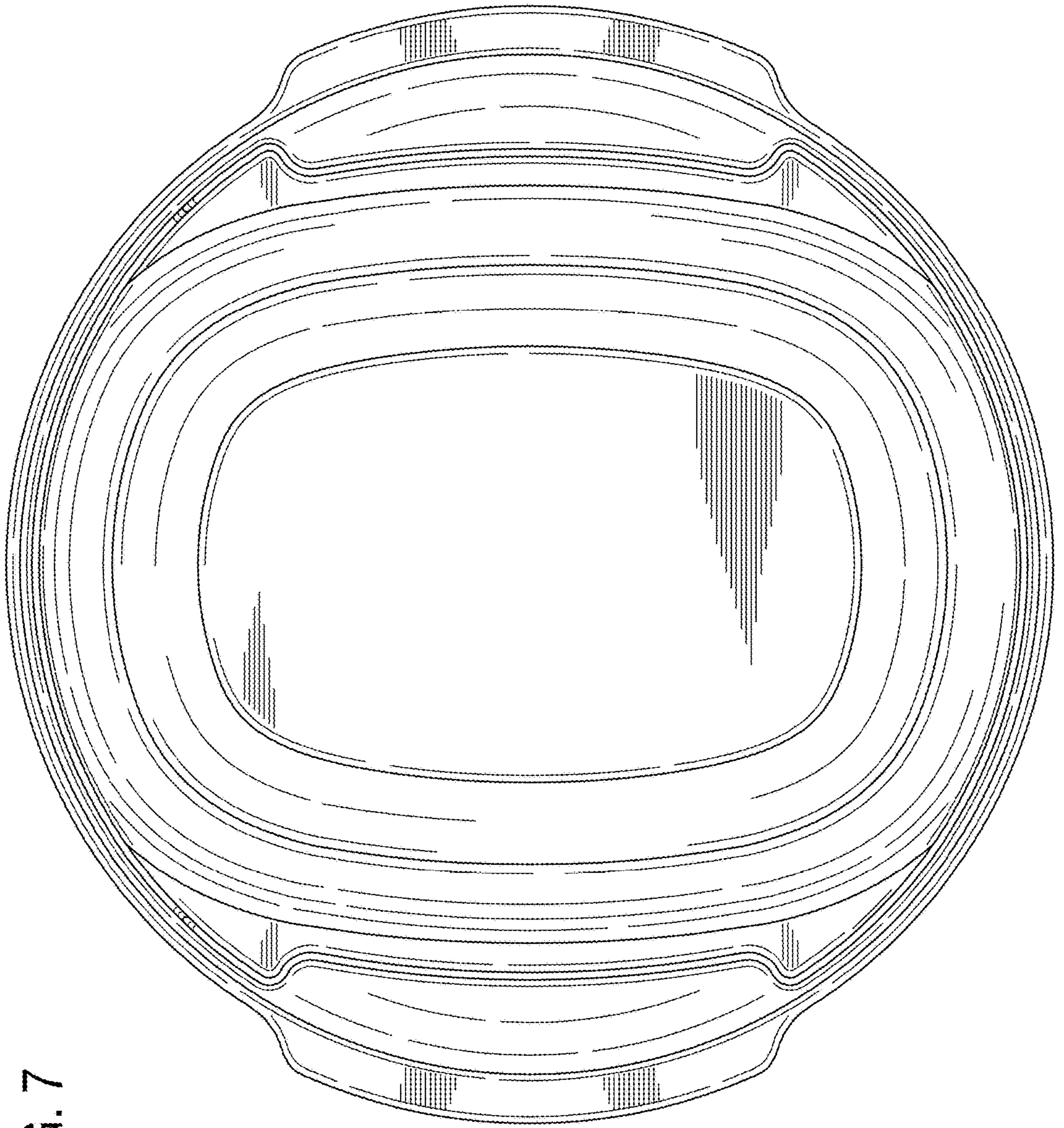

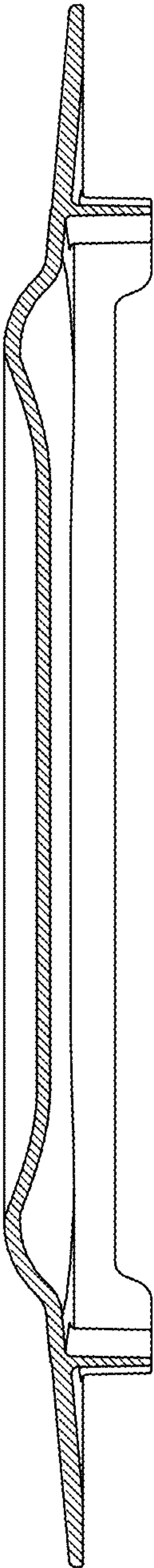
