The ornamental design for a handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the handle showing surface shading of the contours;

FIG. 2 is a top plan view thereof, the bottom plan view being identical thereto contours;

FIG. 3 is a front elevation view, the opposite rear elevation view being a mirror image contours;

FIG. 4 is a front elevation view with section lines **7-7, 8-8, 9-9, 10-10, 11-11 and 12-12**;


FIG. 5 is a left elevation view;

FIG. 6 is a right elevation view;

FIGS. 7, 8, 9, 10, 11 and 12 are sectional views along the lines shown in FIG. 4;























