(57) **CLAIM**

The ornamental design for a folding electrically assisted bicycle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left-side perspective view of a folding electrically assisted bicycle showing our new design; FIG. 2 is a left-side elevational view thereof; FIG. 3 is a right-side elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a front elevational view thereof; and, FIG. 6 is a top plan view thereof.

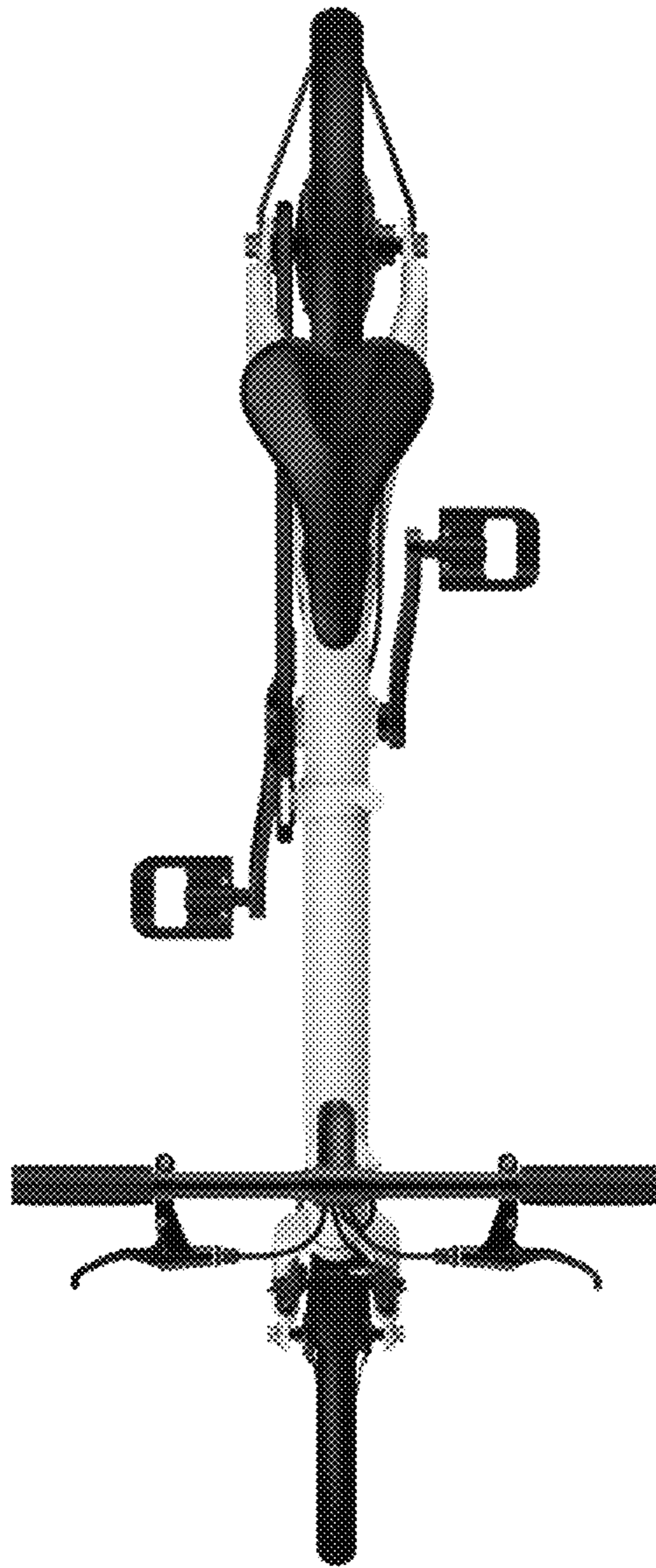
