(57) **CLAIM**

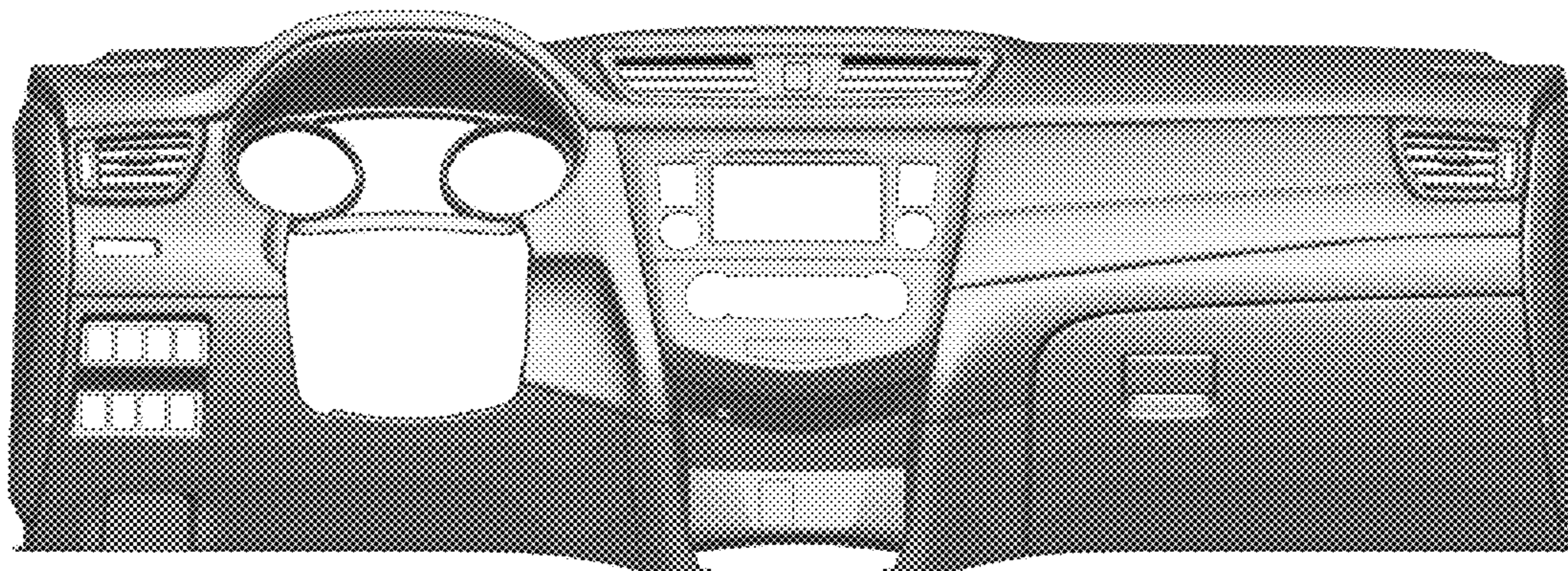
The ornamental design for an instrument panel for an automobile, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of an instrument panel for an automobile in accordance with our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a first side perspective view thereof; and, FIG. 7 is a second side perspective view thereof. In the drawings, the broken lines in FIGS. 2-7 depict portions of the article that form no part of the claimed design.

A second embodiment of our new design is identical to the first embodiment. The second embodiment of our new design includes the mirror image of the instrument panel shown in FIGS. 1 to 7.

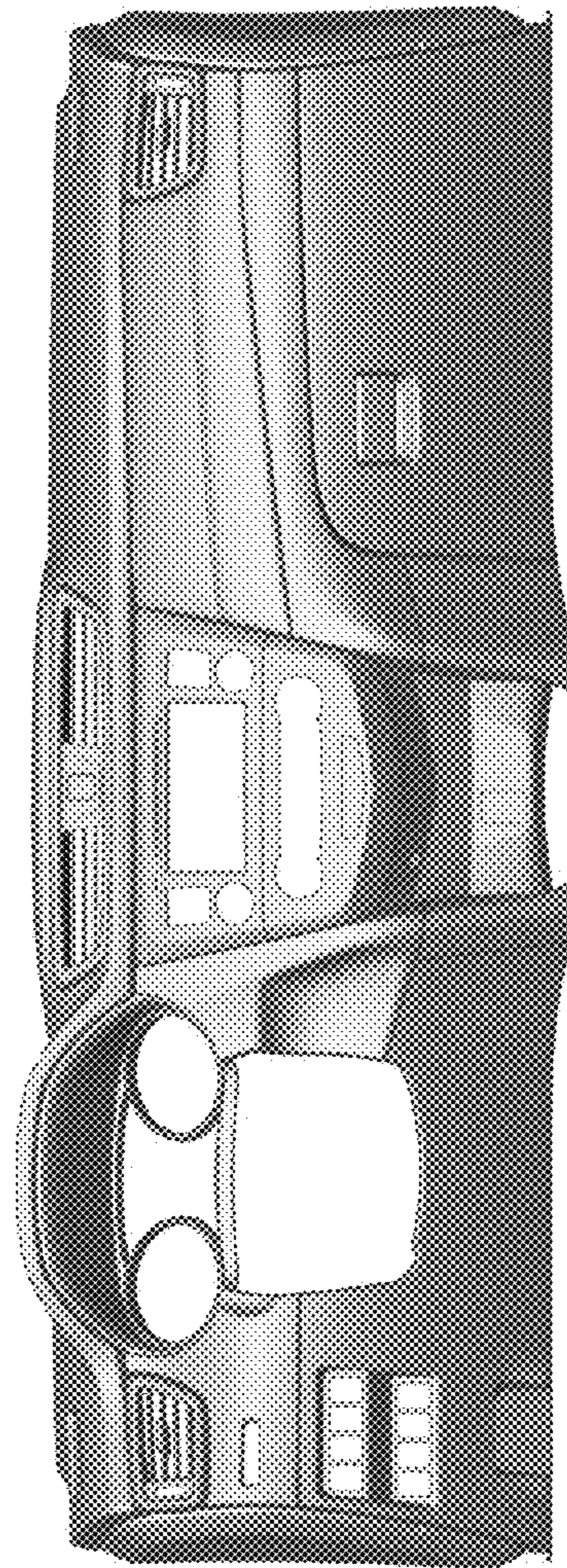

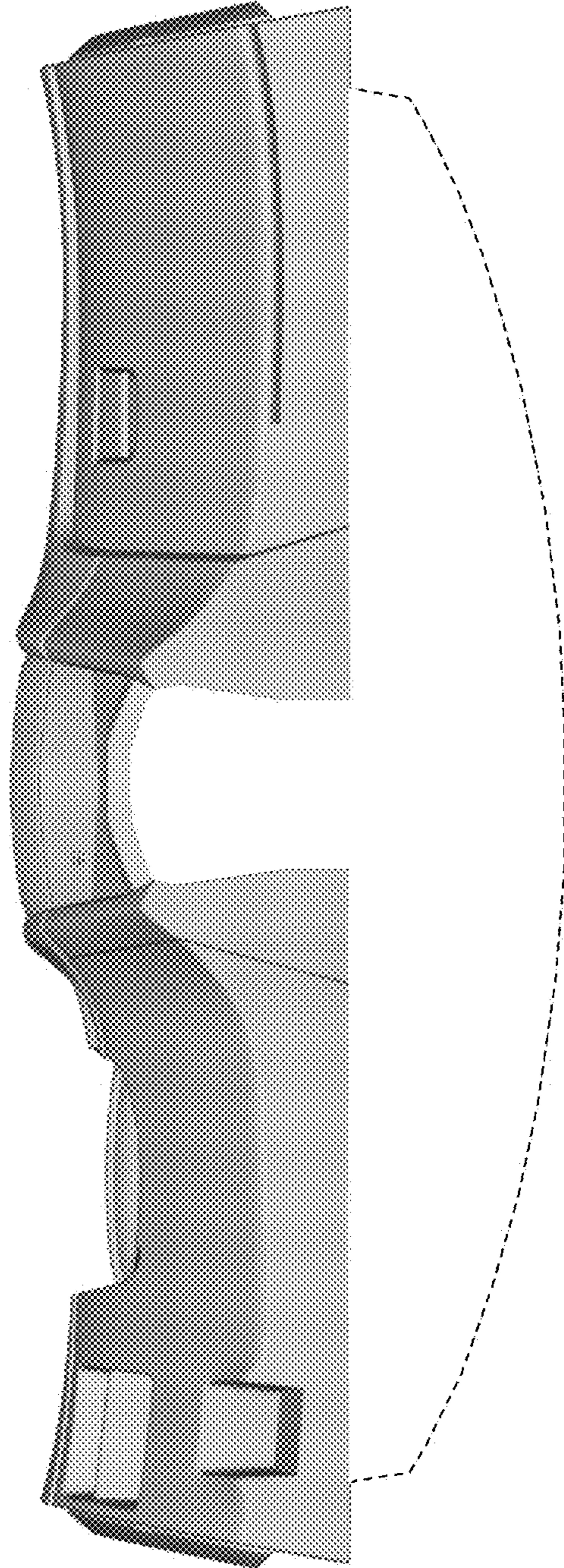

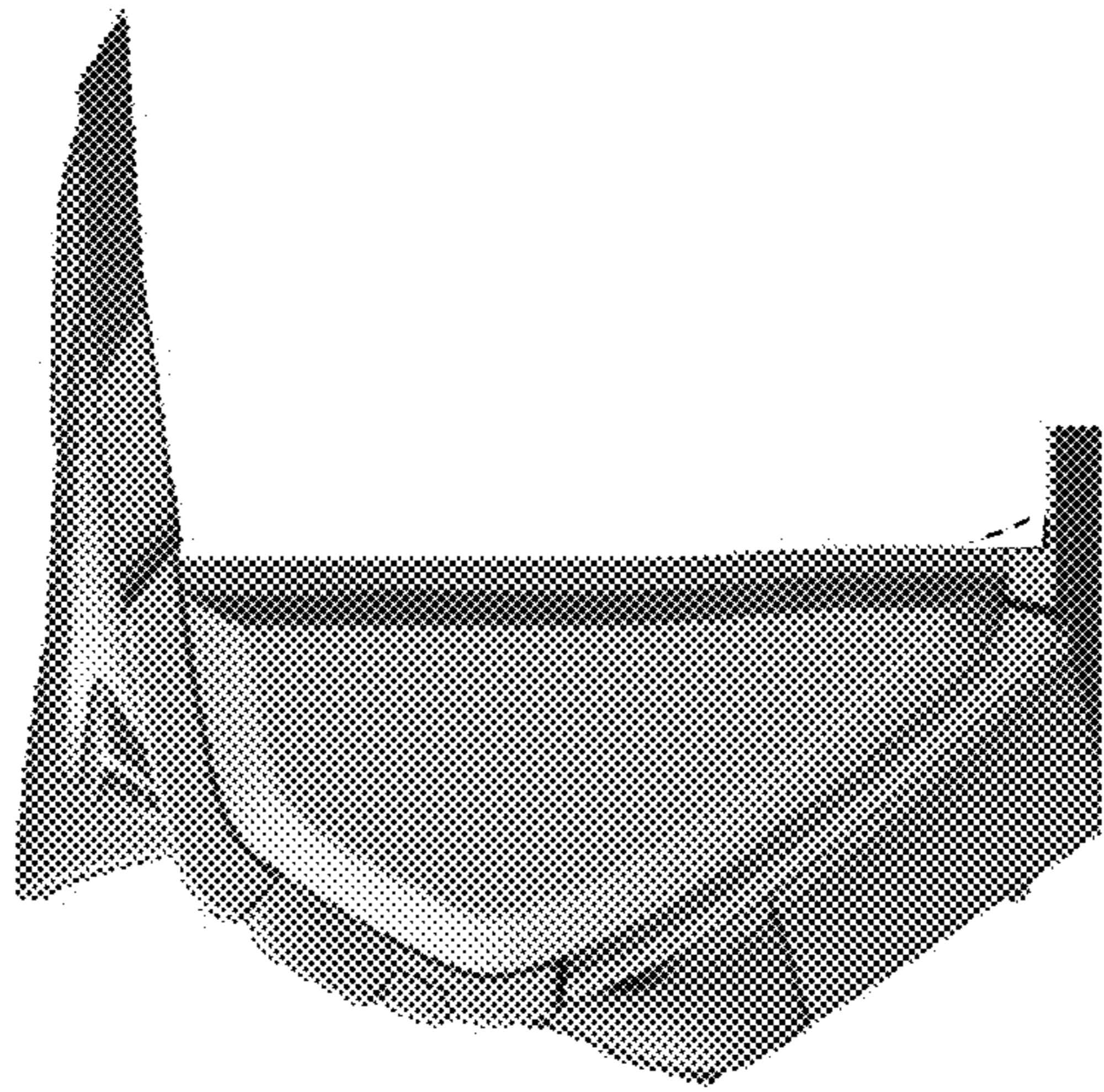

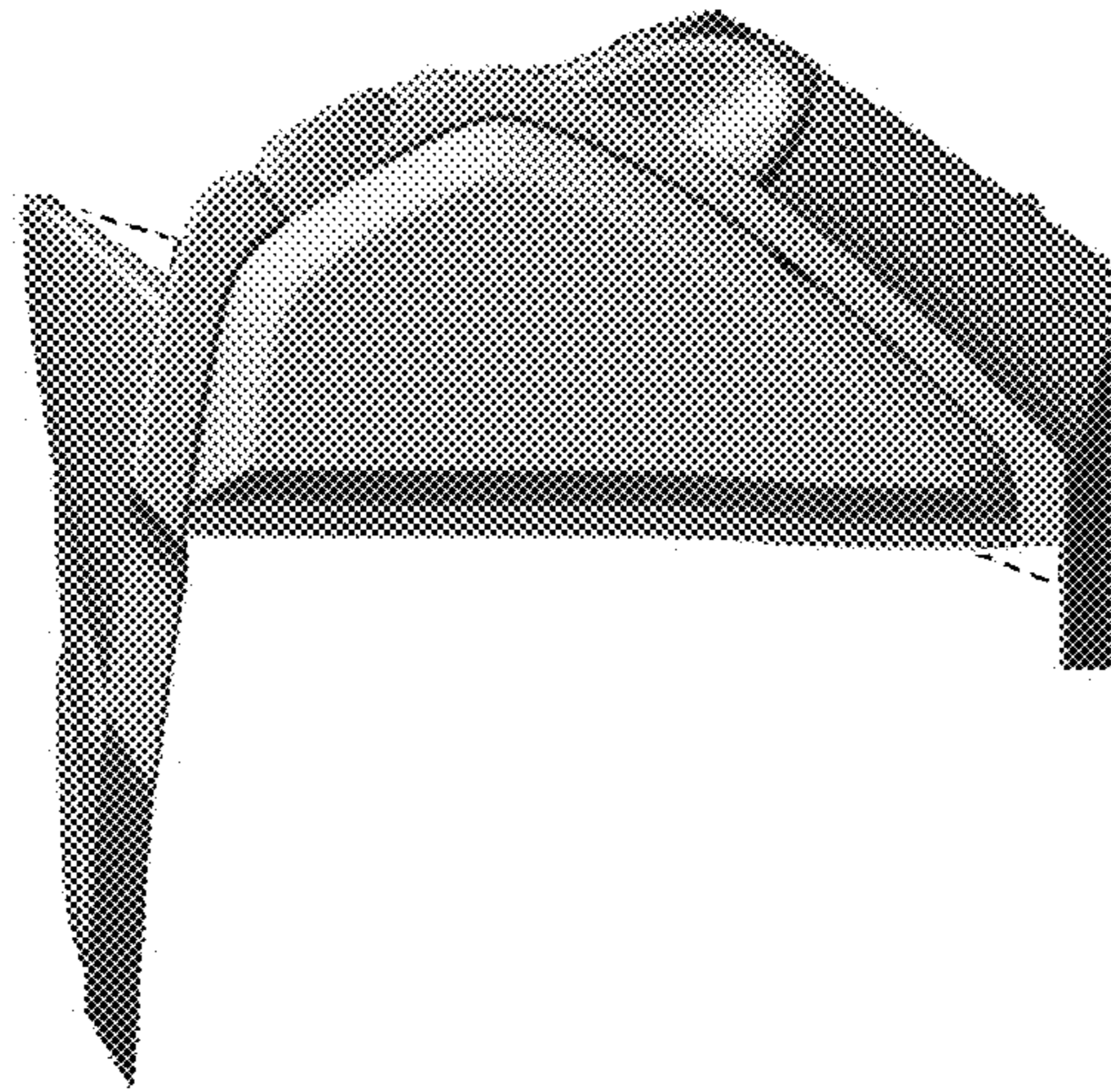

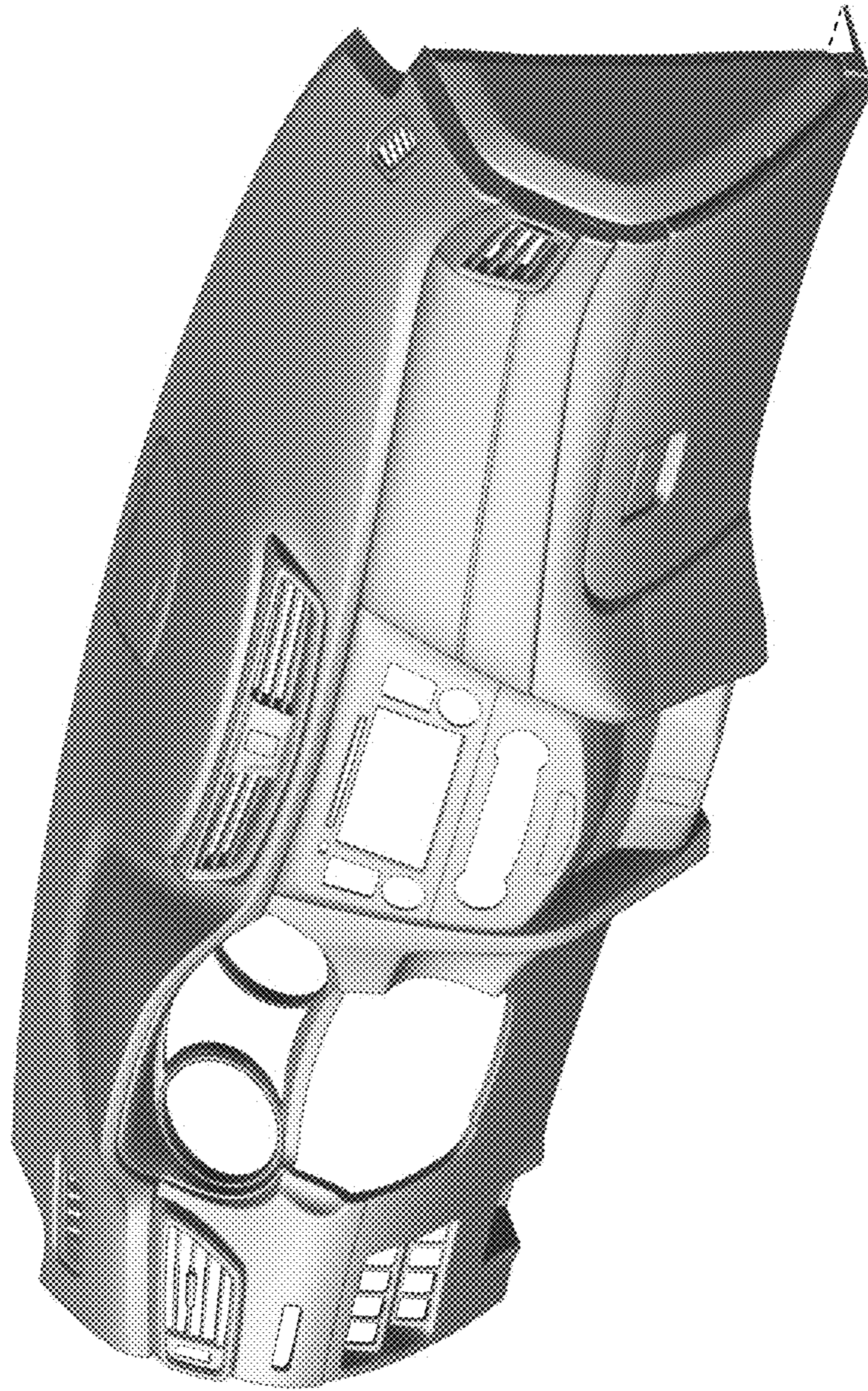

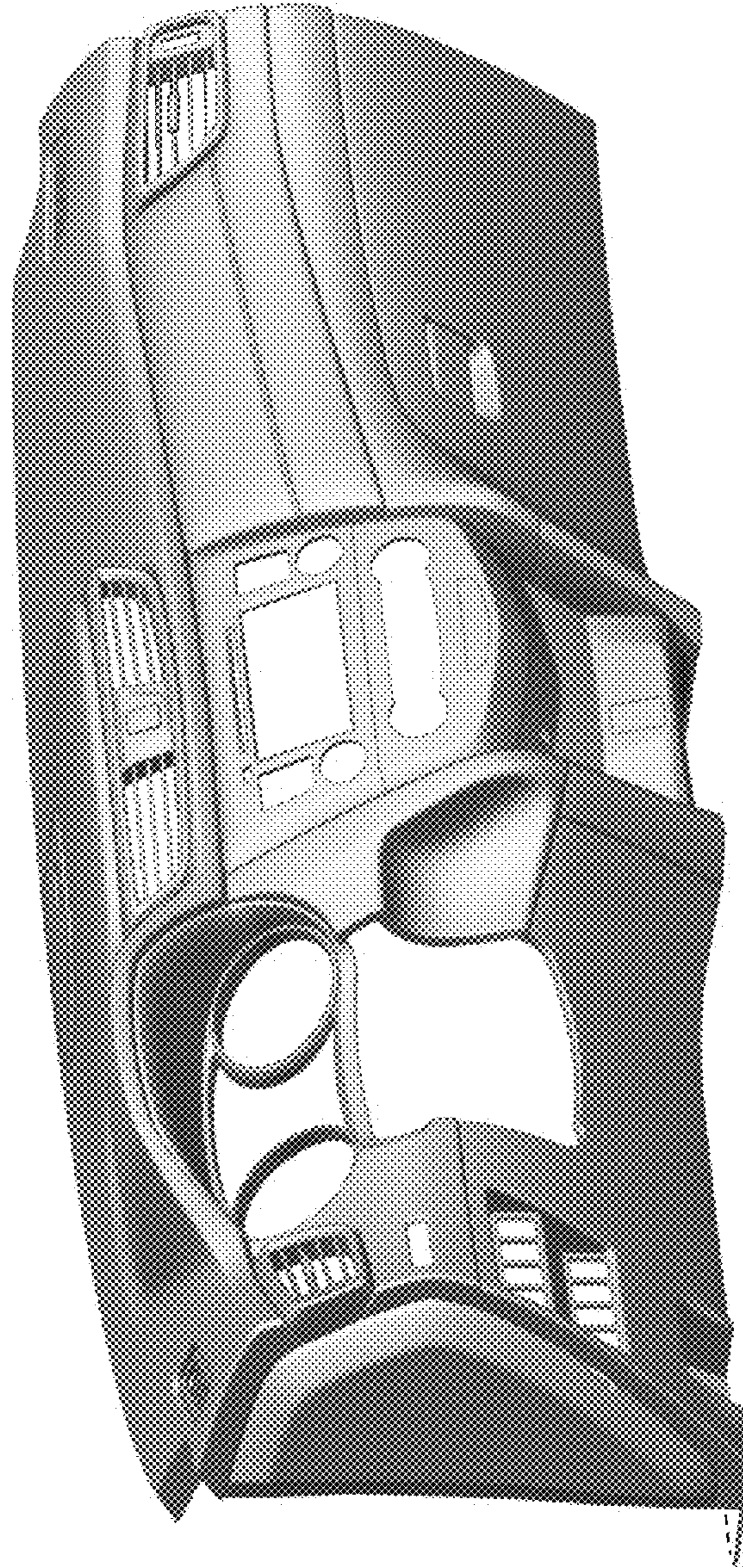
