The ornamental design for an electronic device, as shown and described.

DESCRIPTION

FIG. 23 is a bottom plan view thereof;
FIG. 24 is a top side perspective view thereof wherein the keyboard surface is face down on a supporting surface;

FIG. 26 is a top front side perspective view thereof;
FIG. 27 is a back elevational view thereof with the lid being in a fourth position, it being understood that all other surfaces are the same;

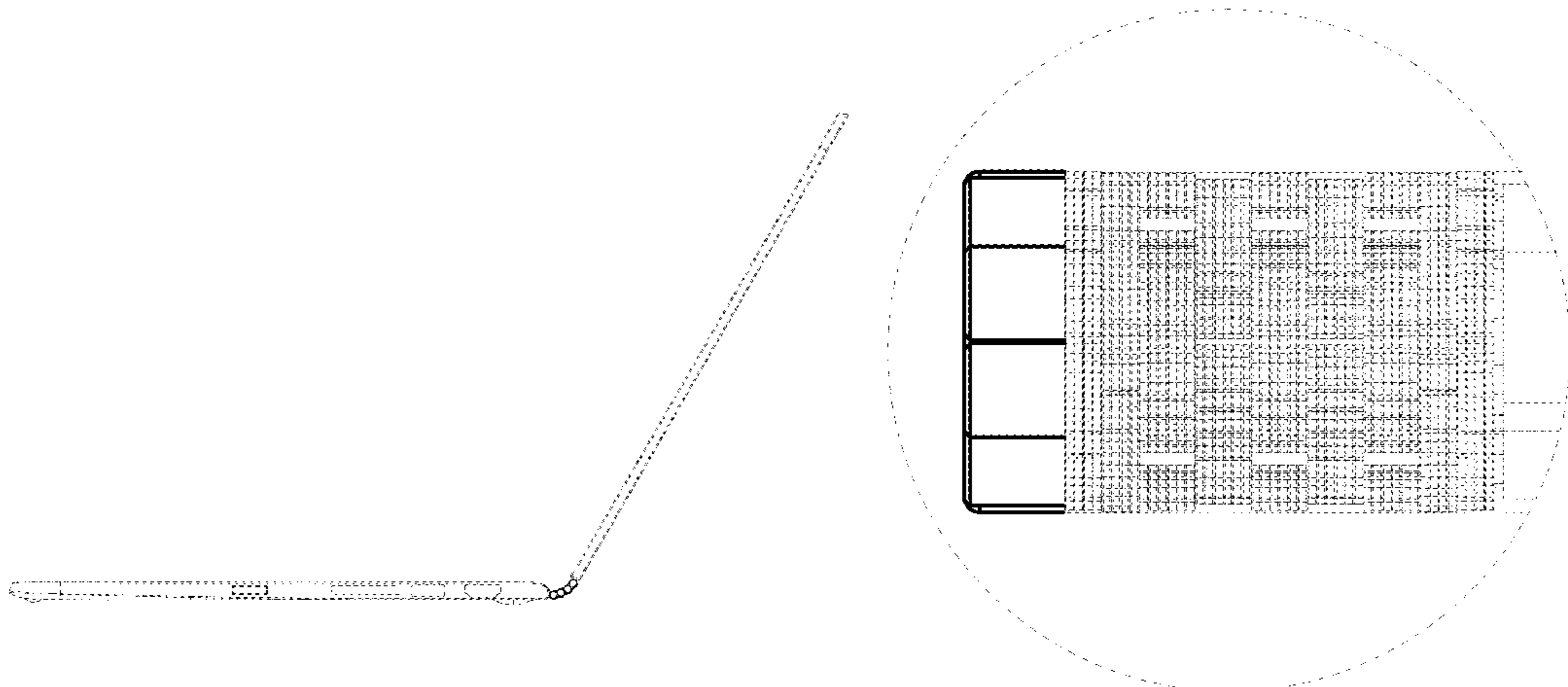


FIG. 28 is a left side elevational view thereof;

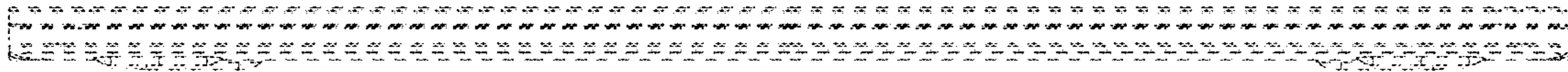

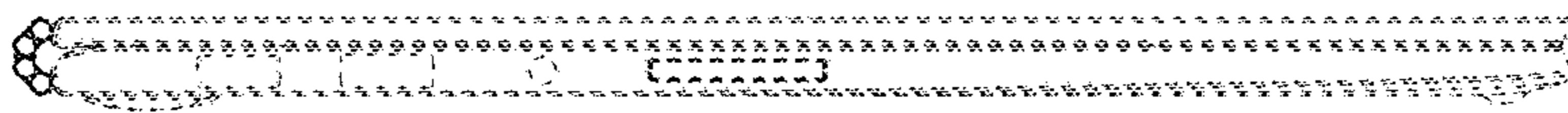

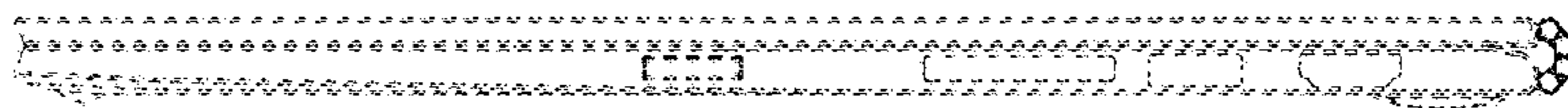

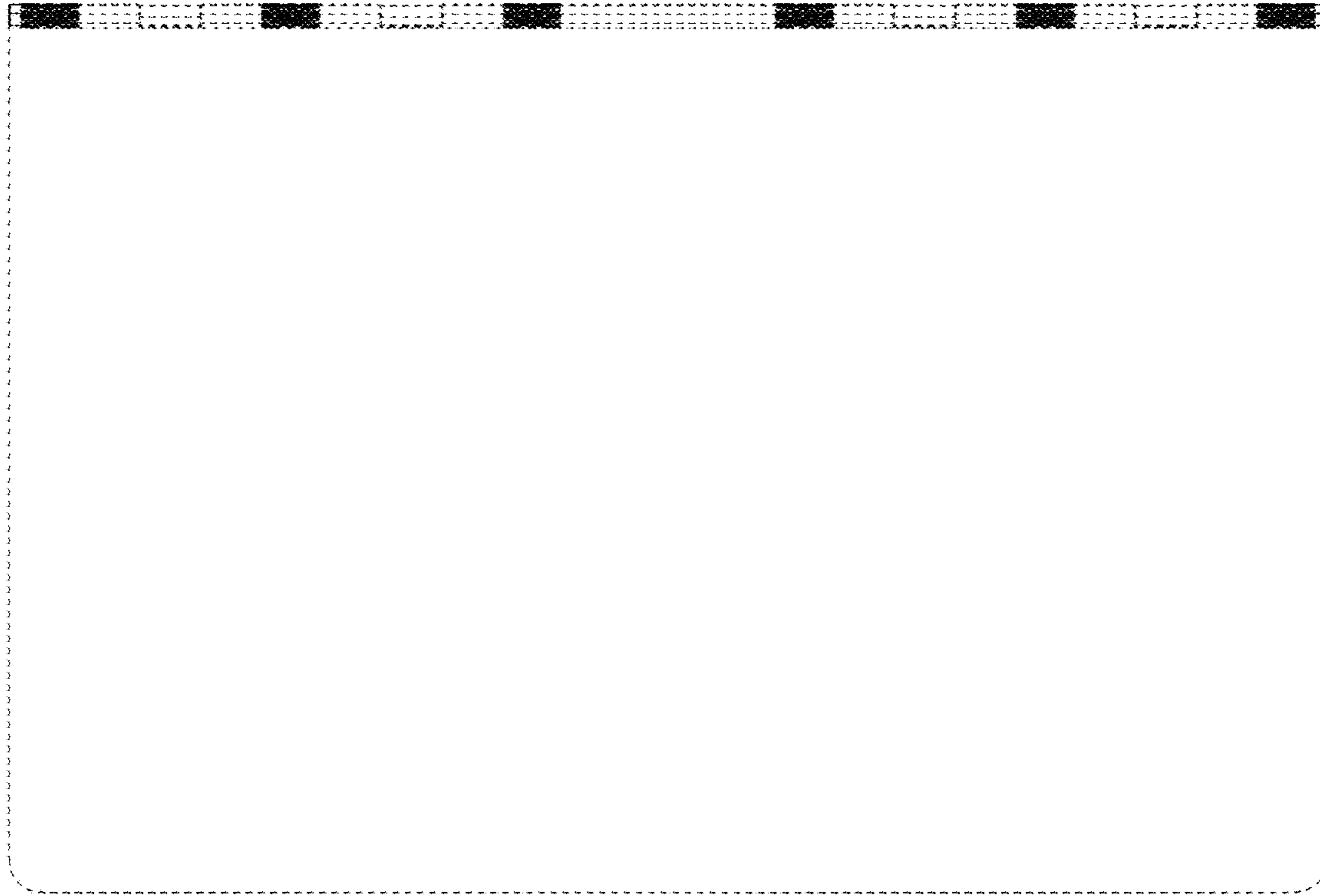

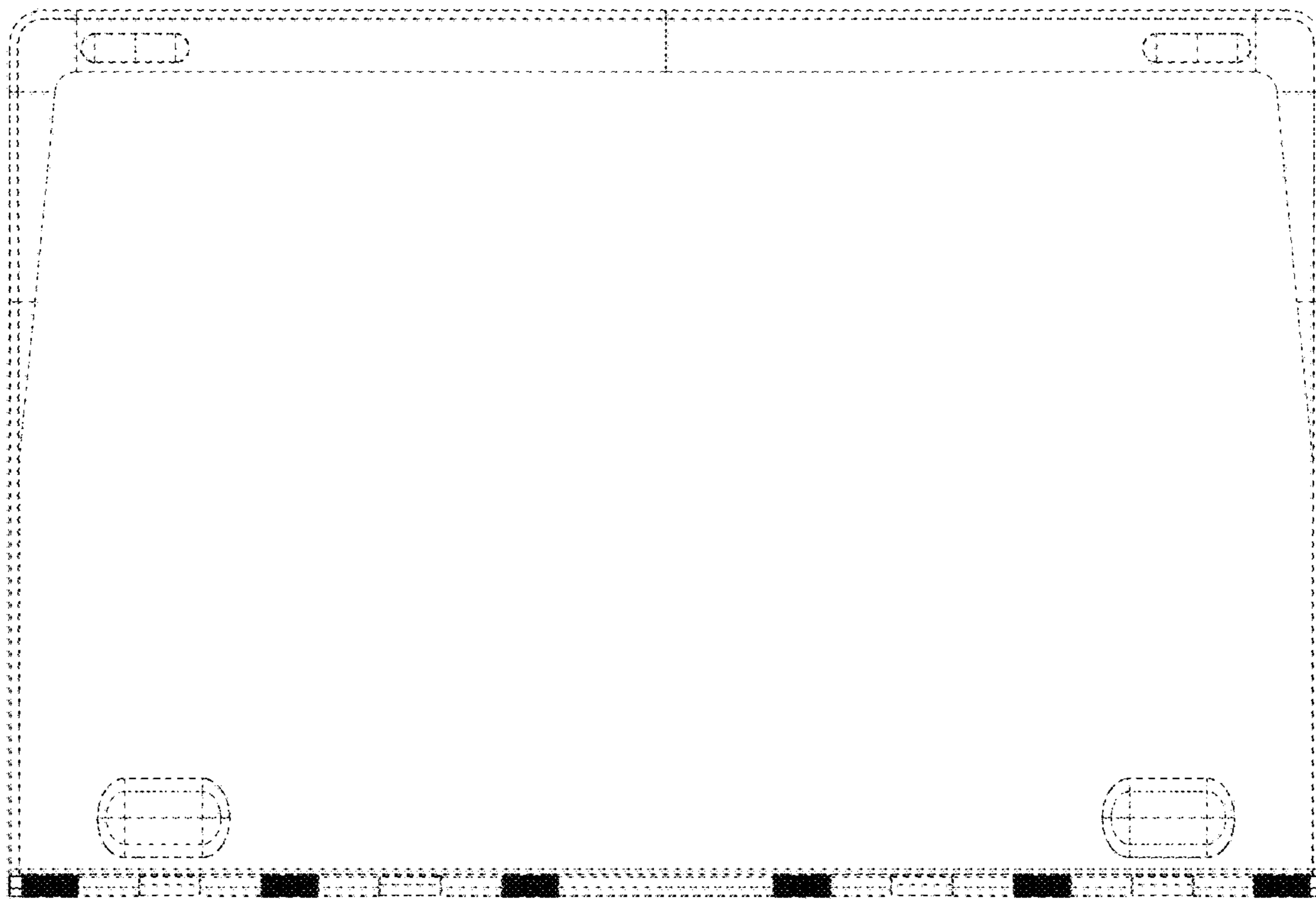

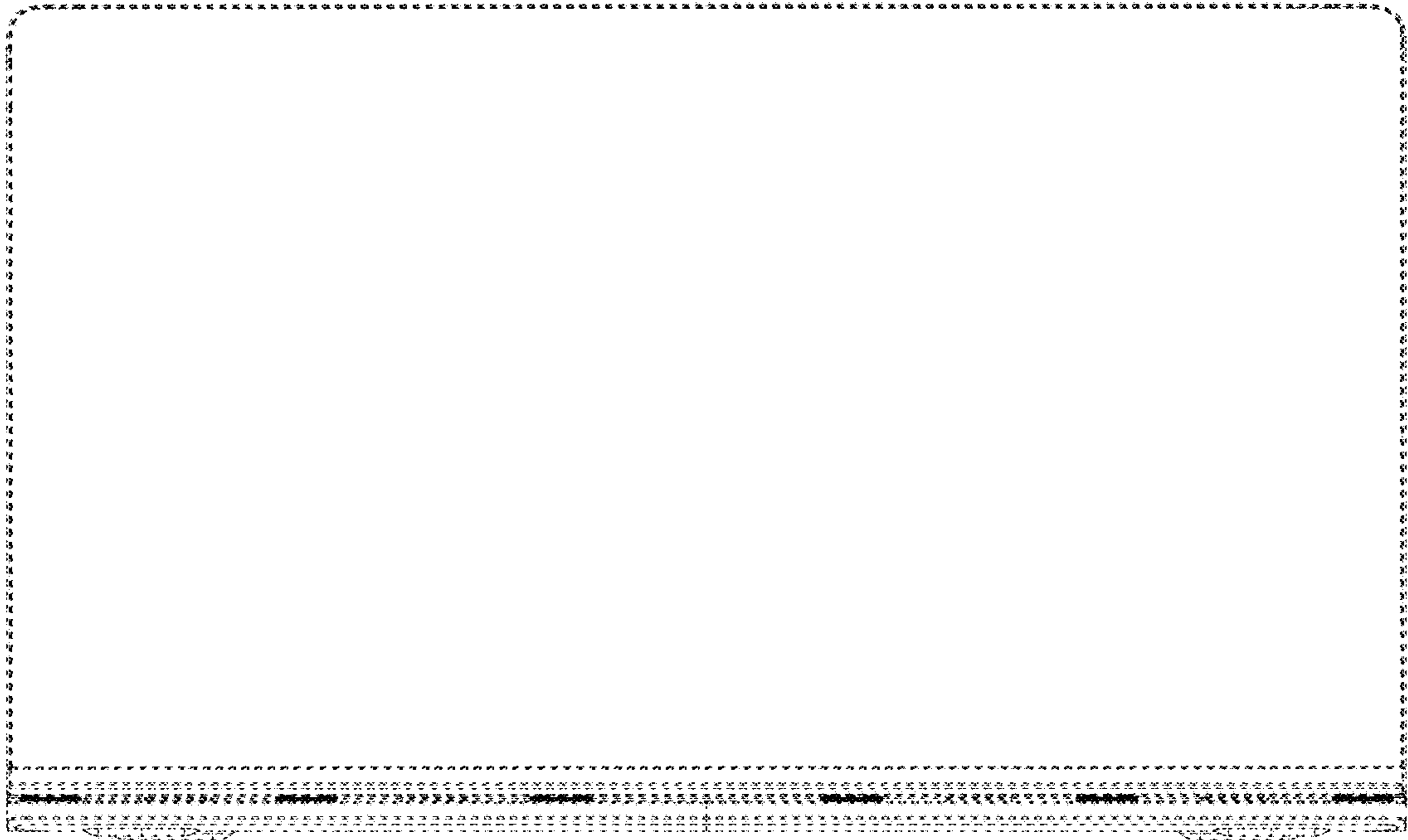

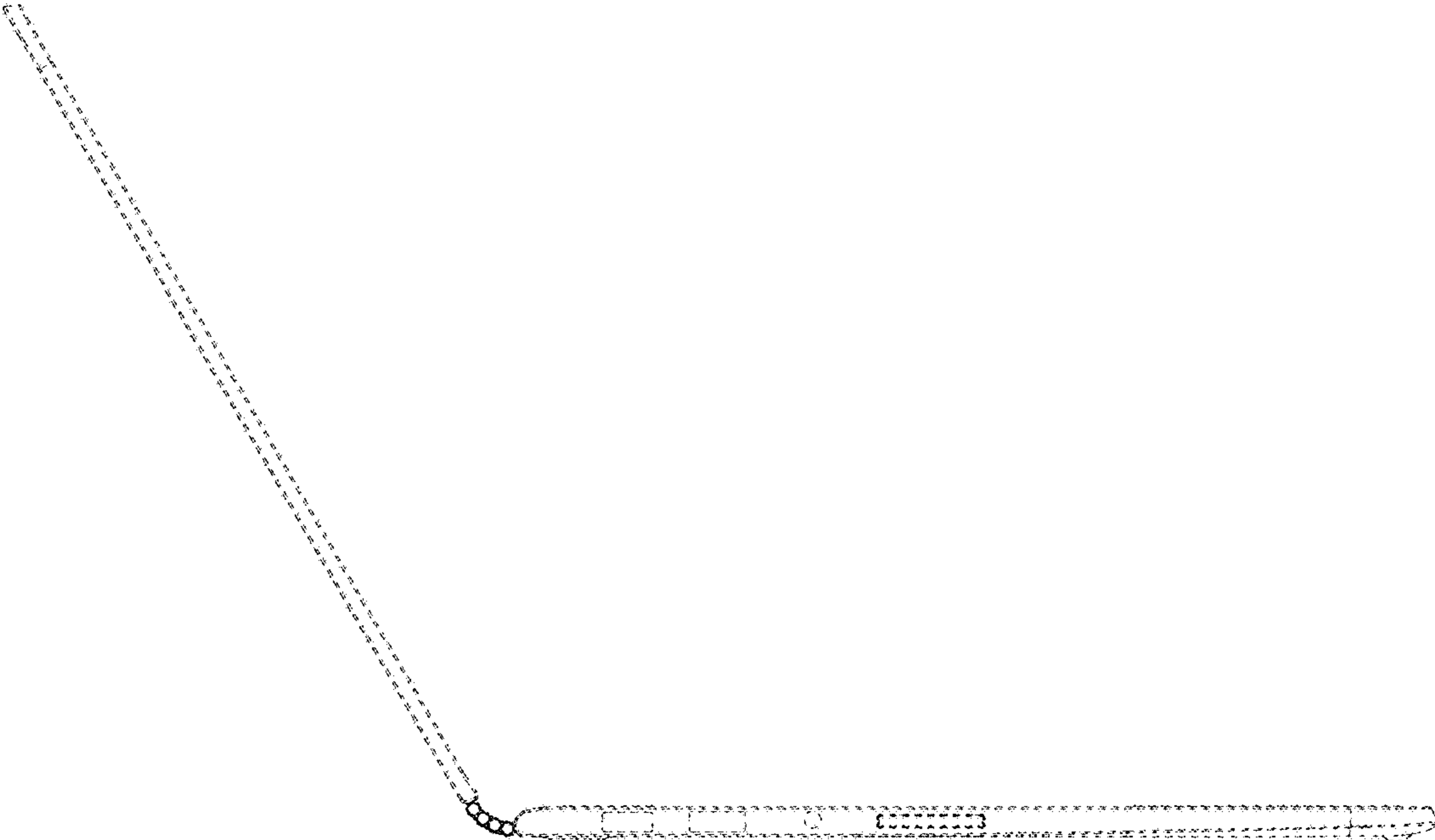

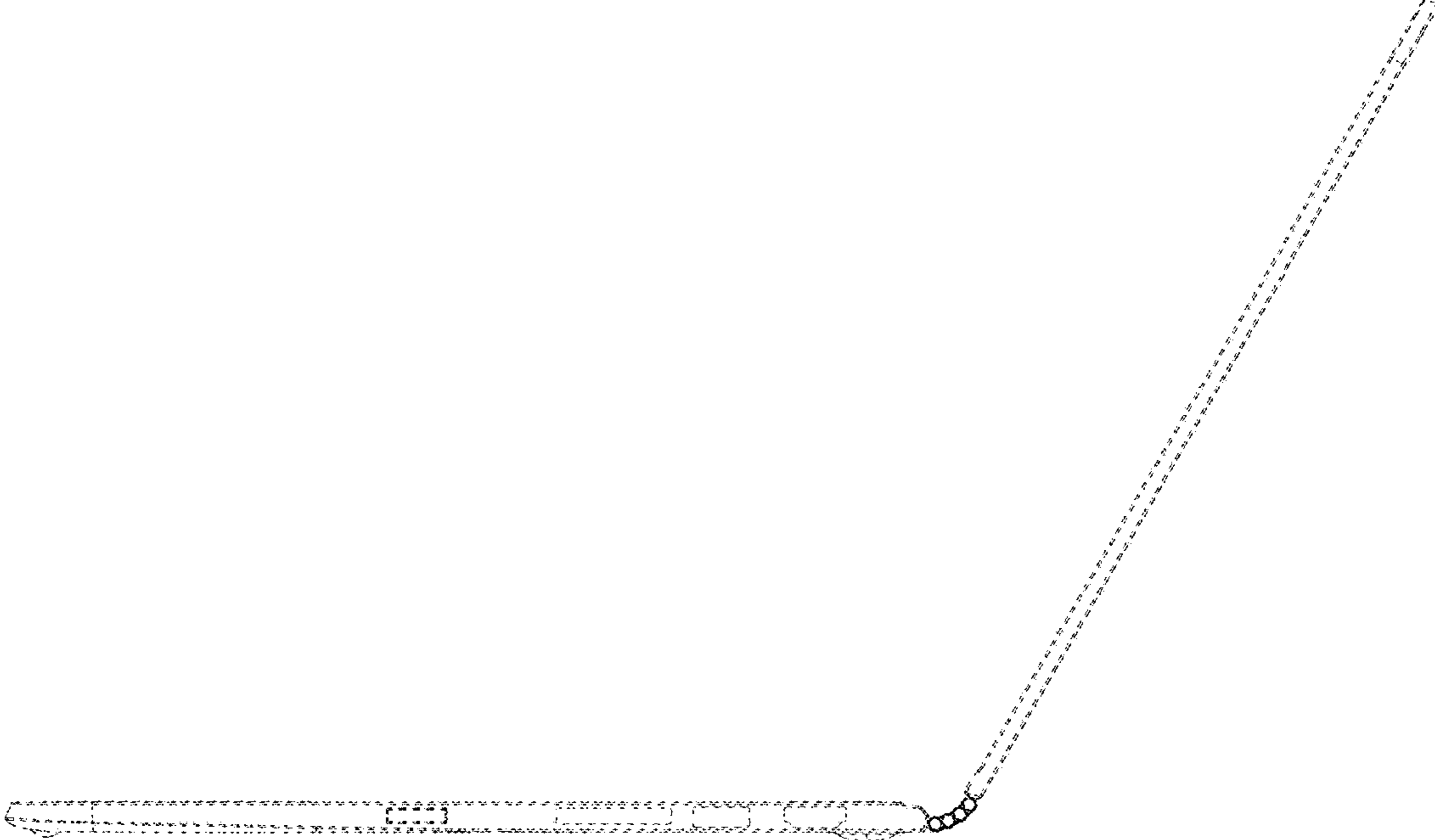

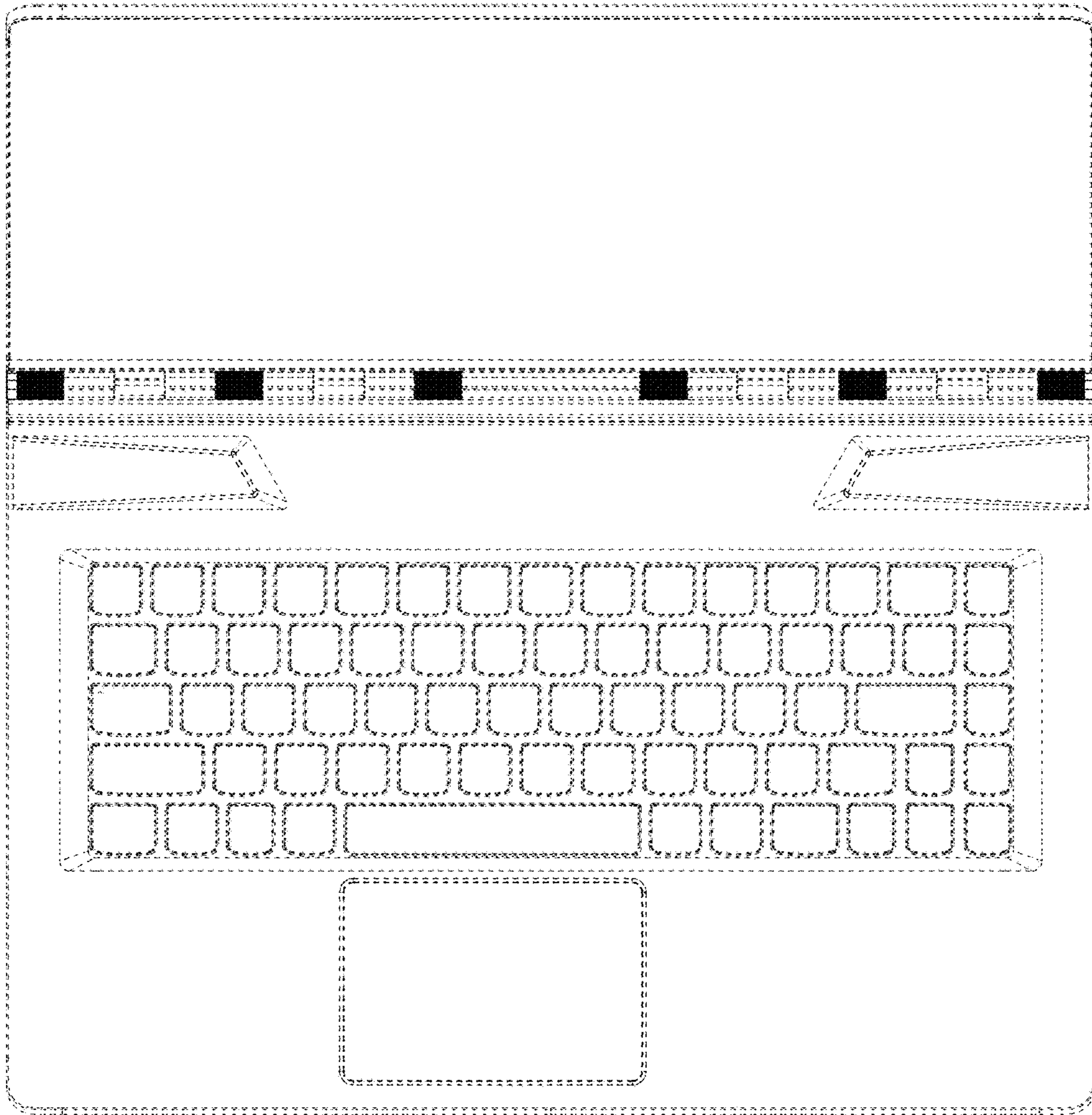

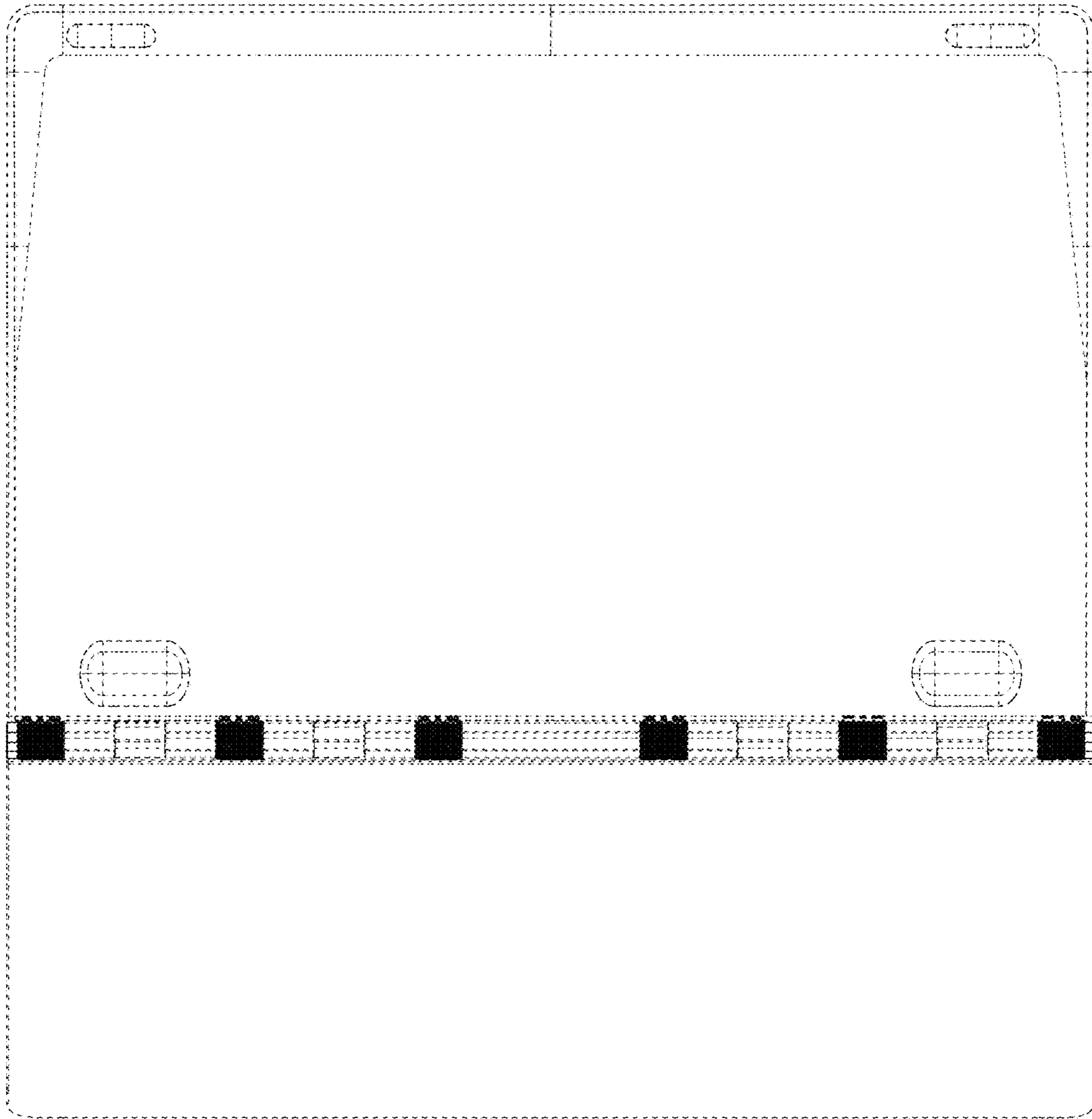

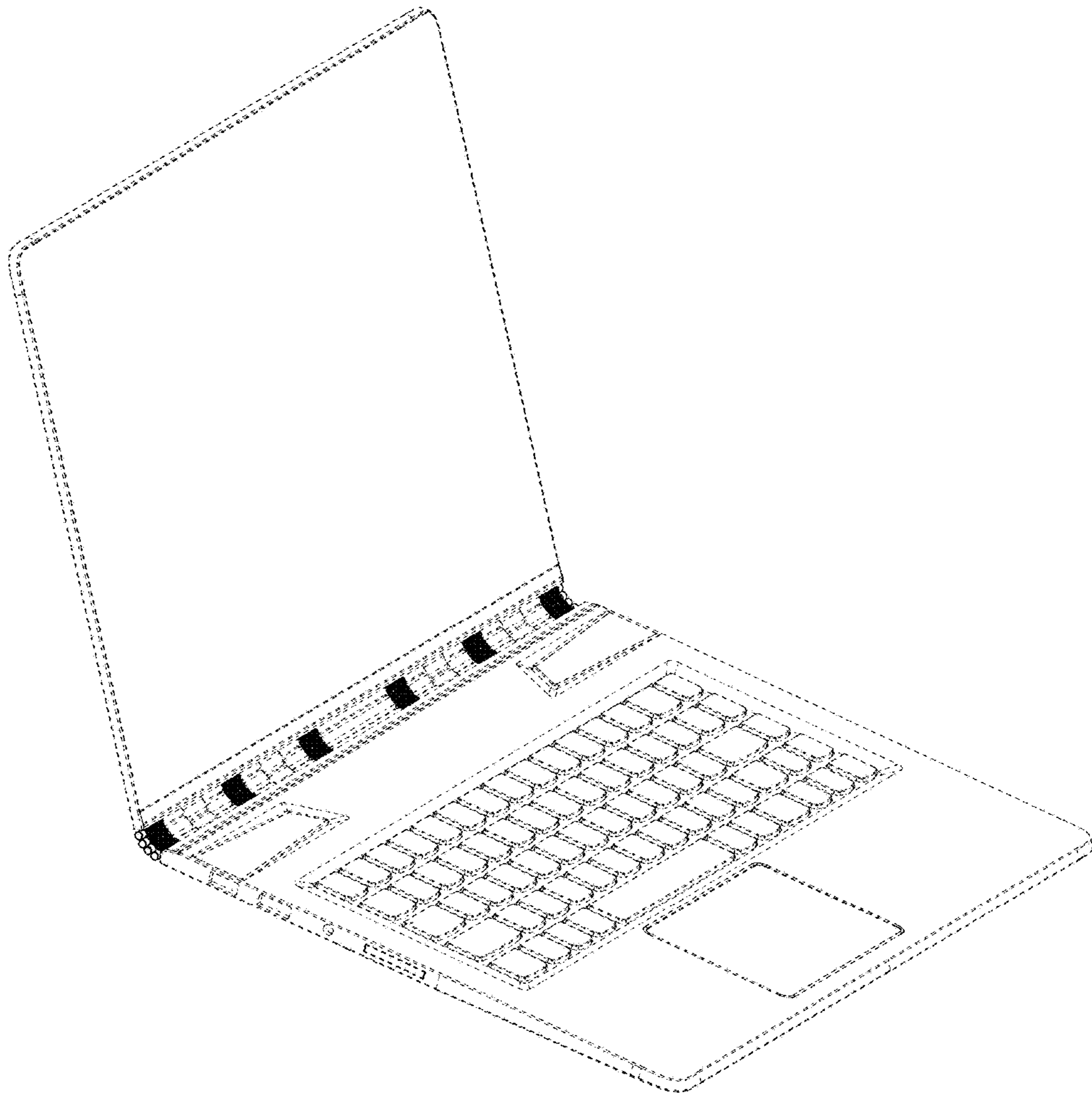

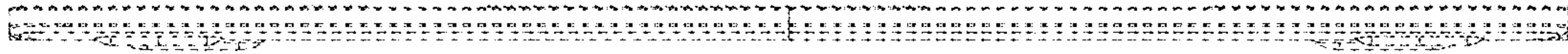

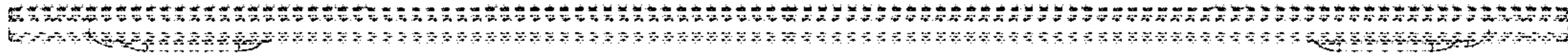

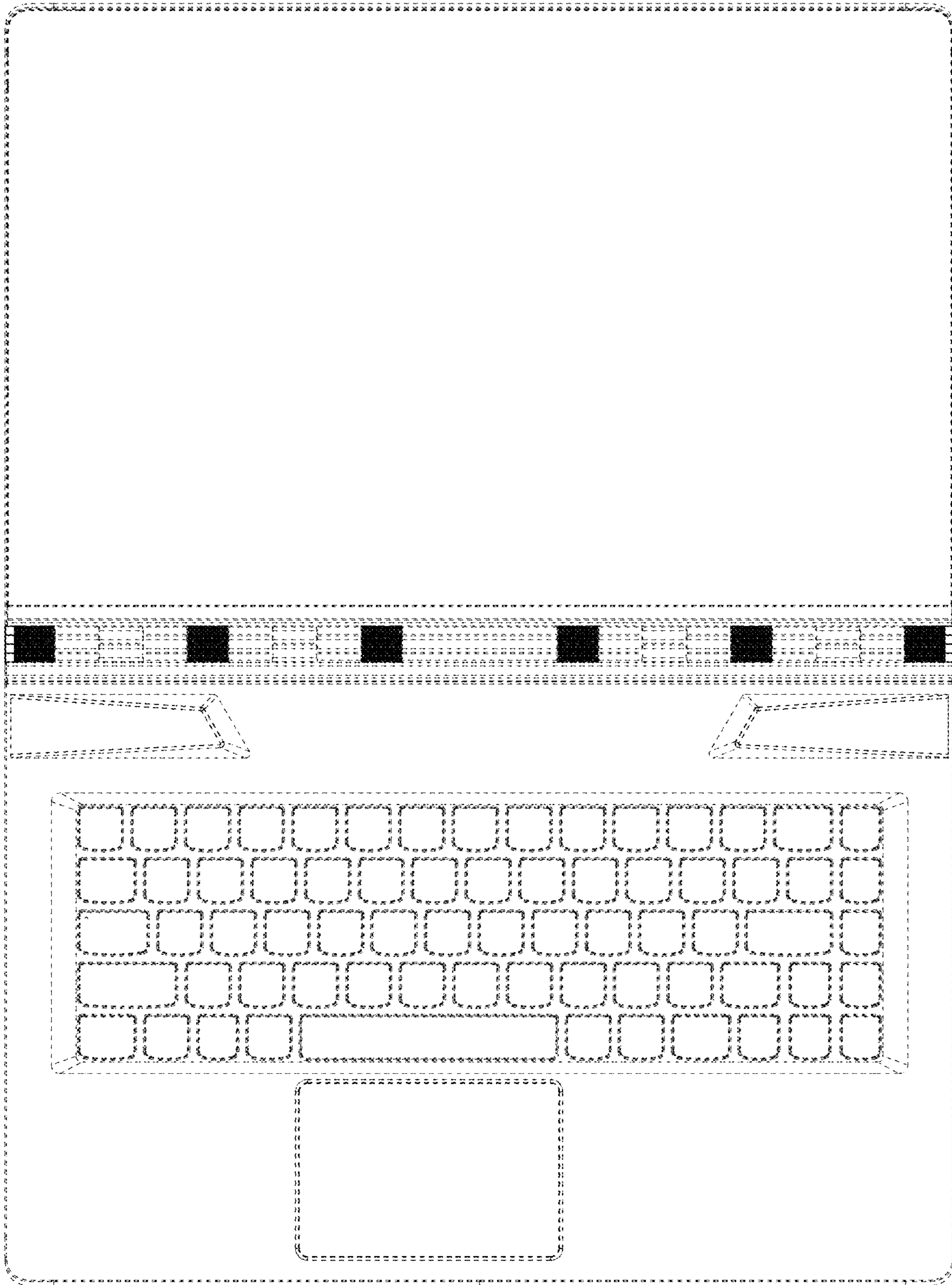

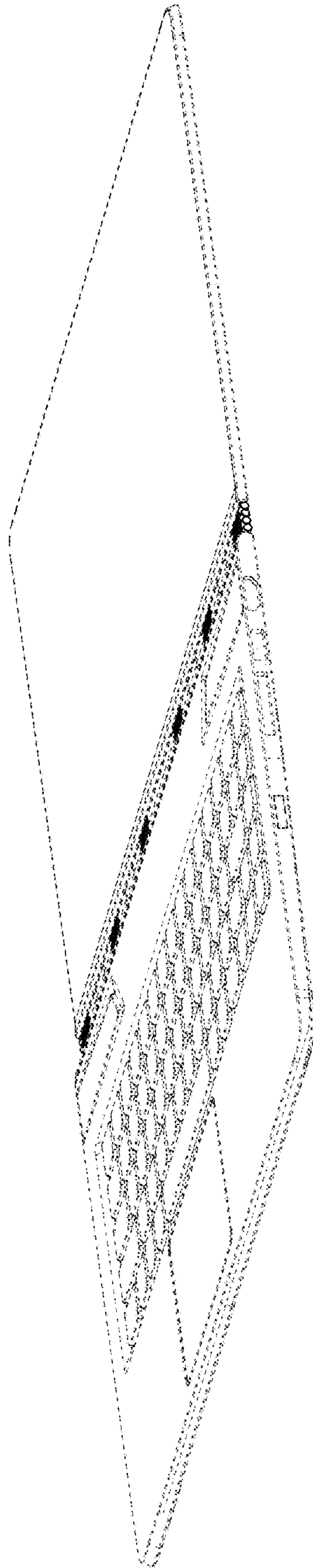

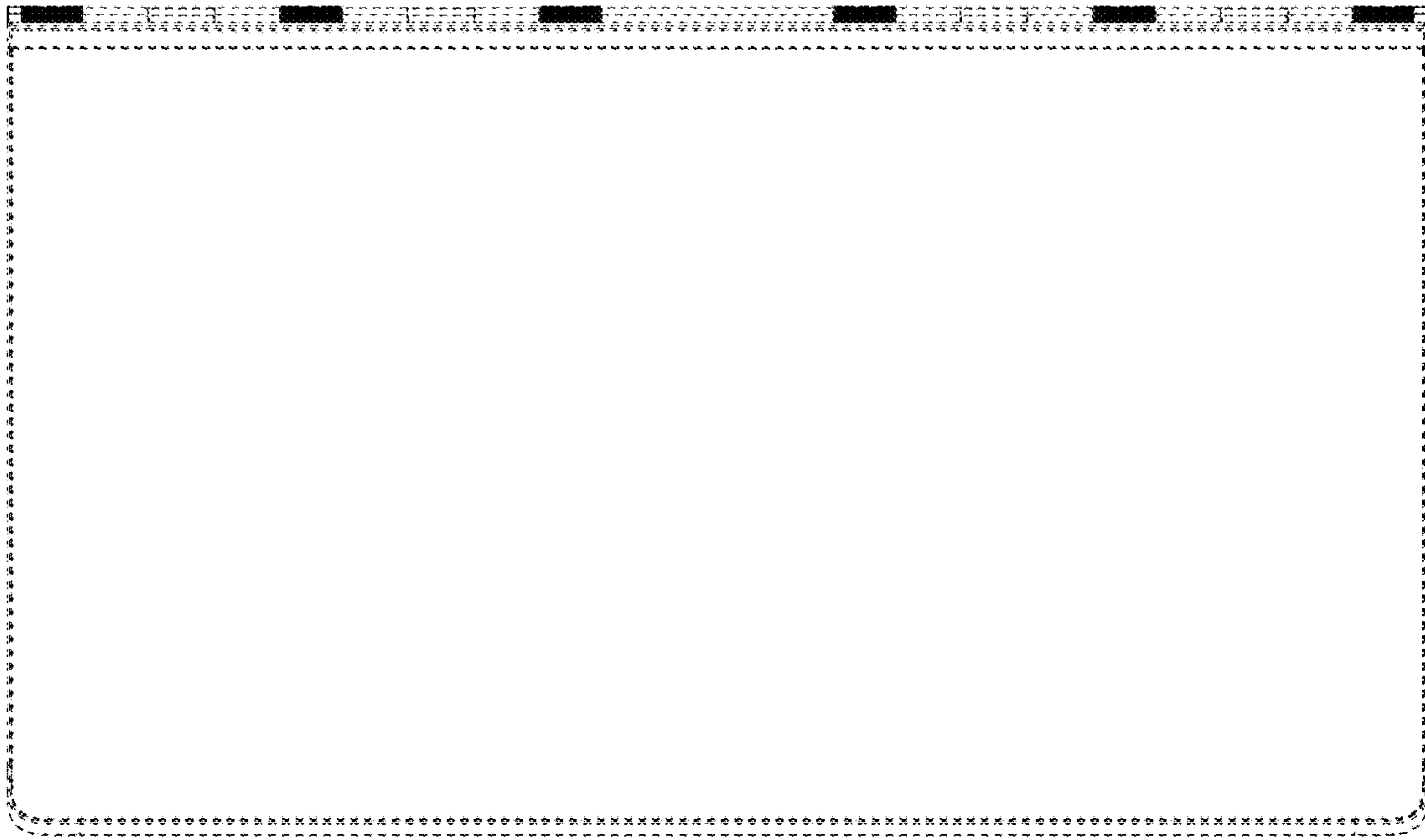

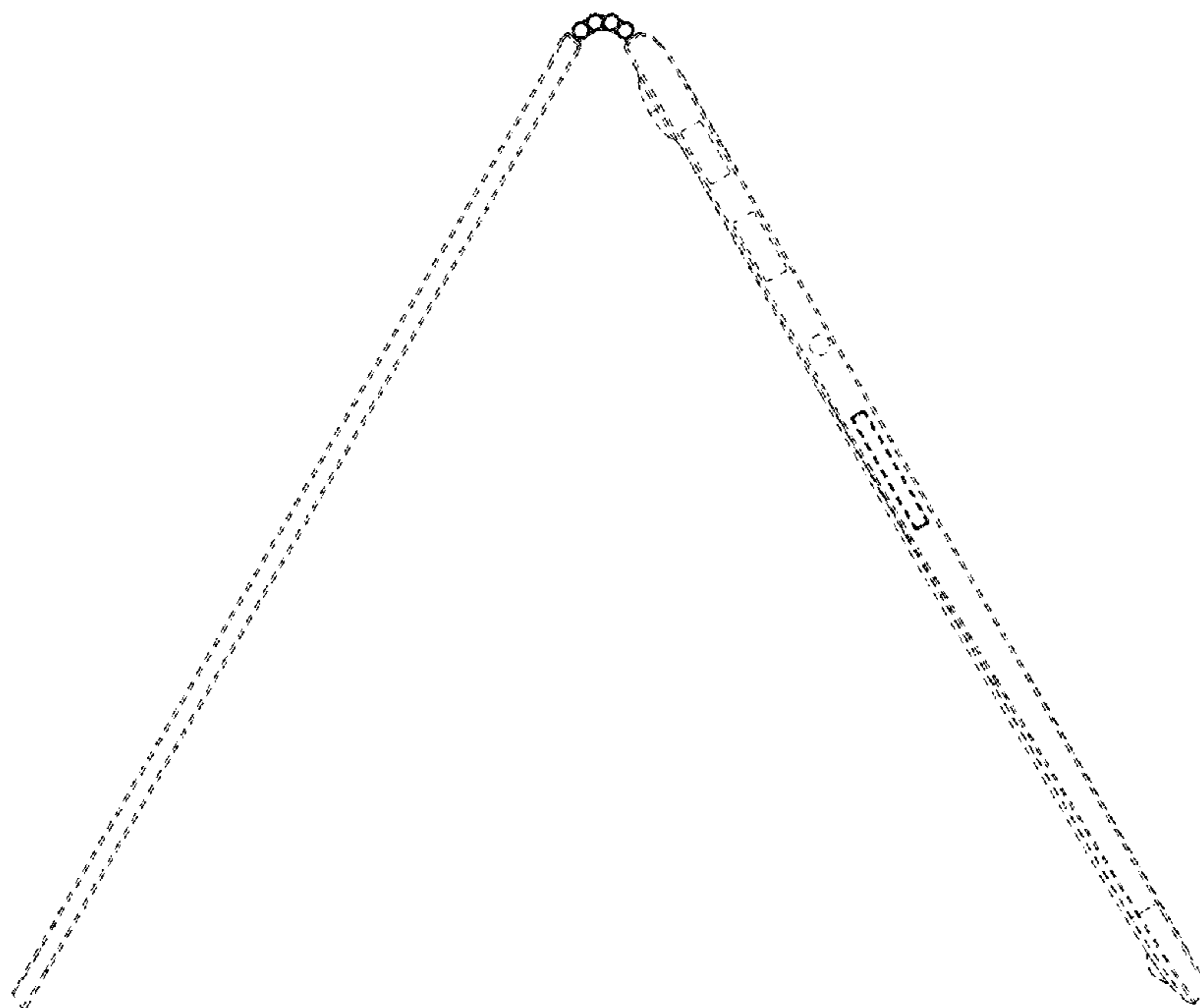

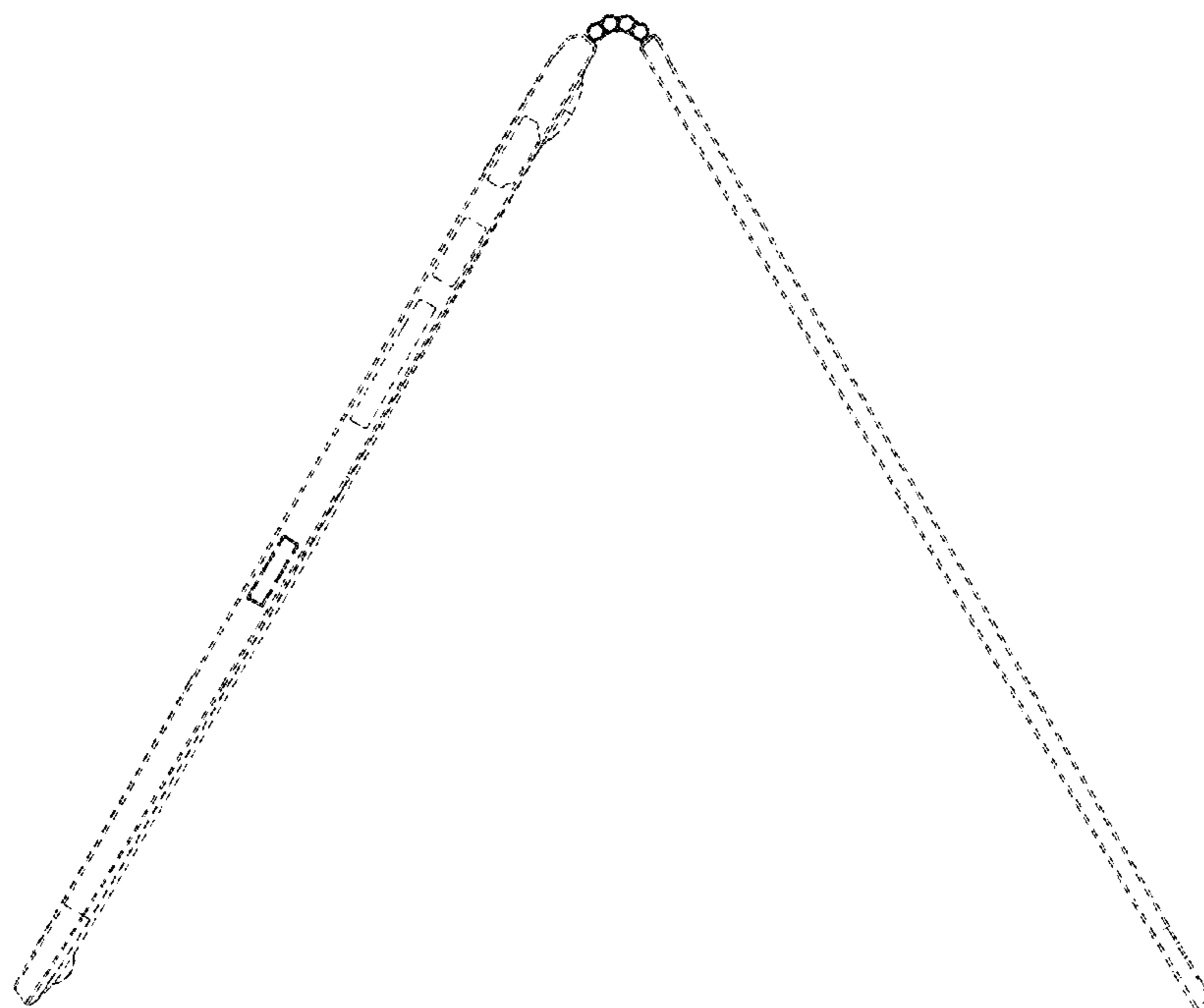

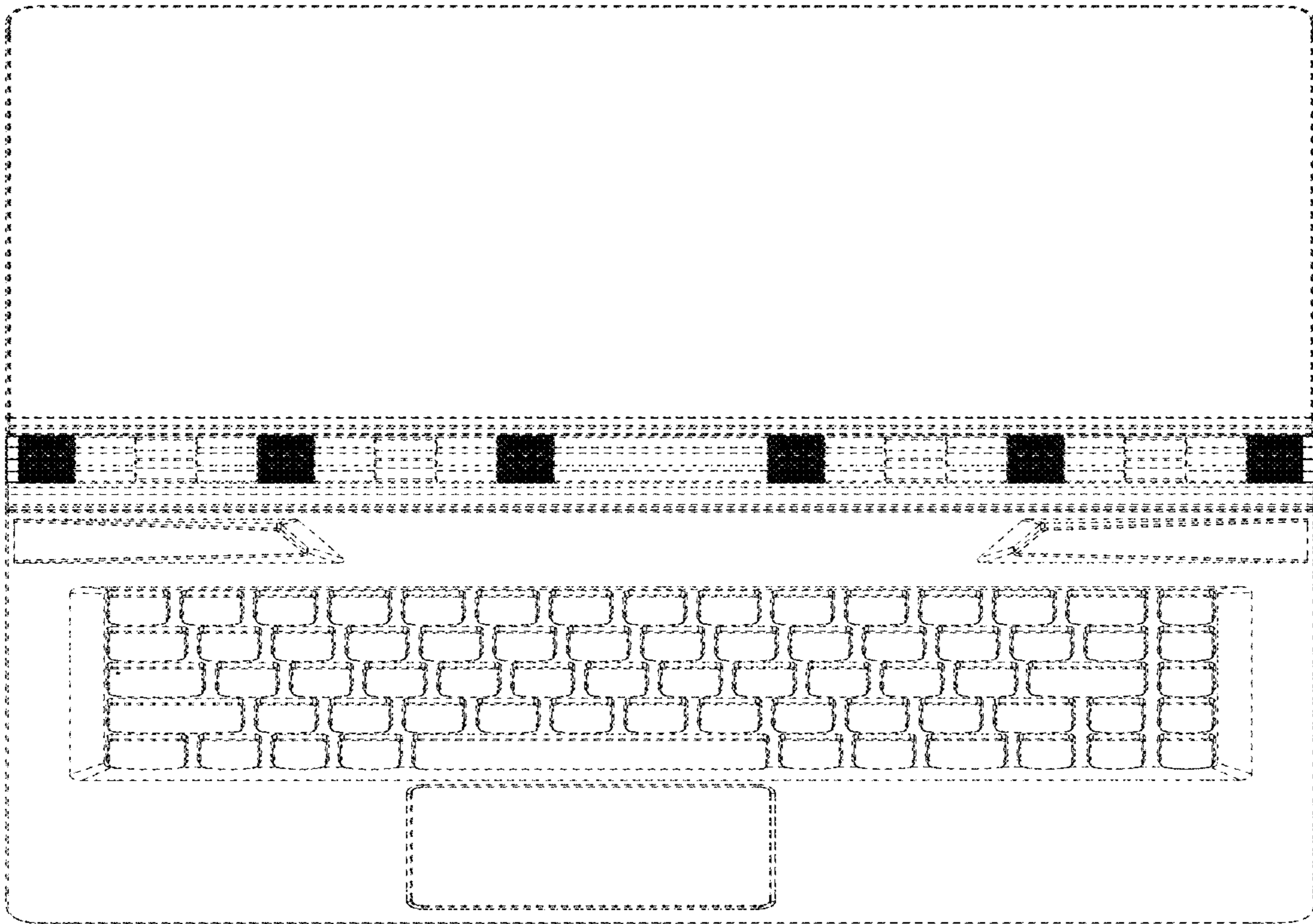

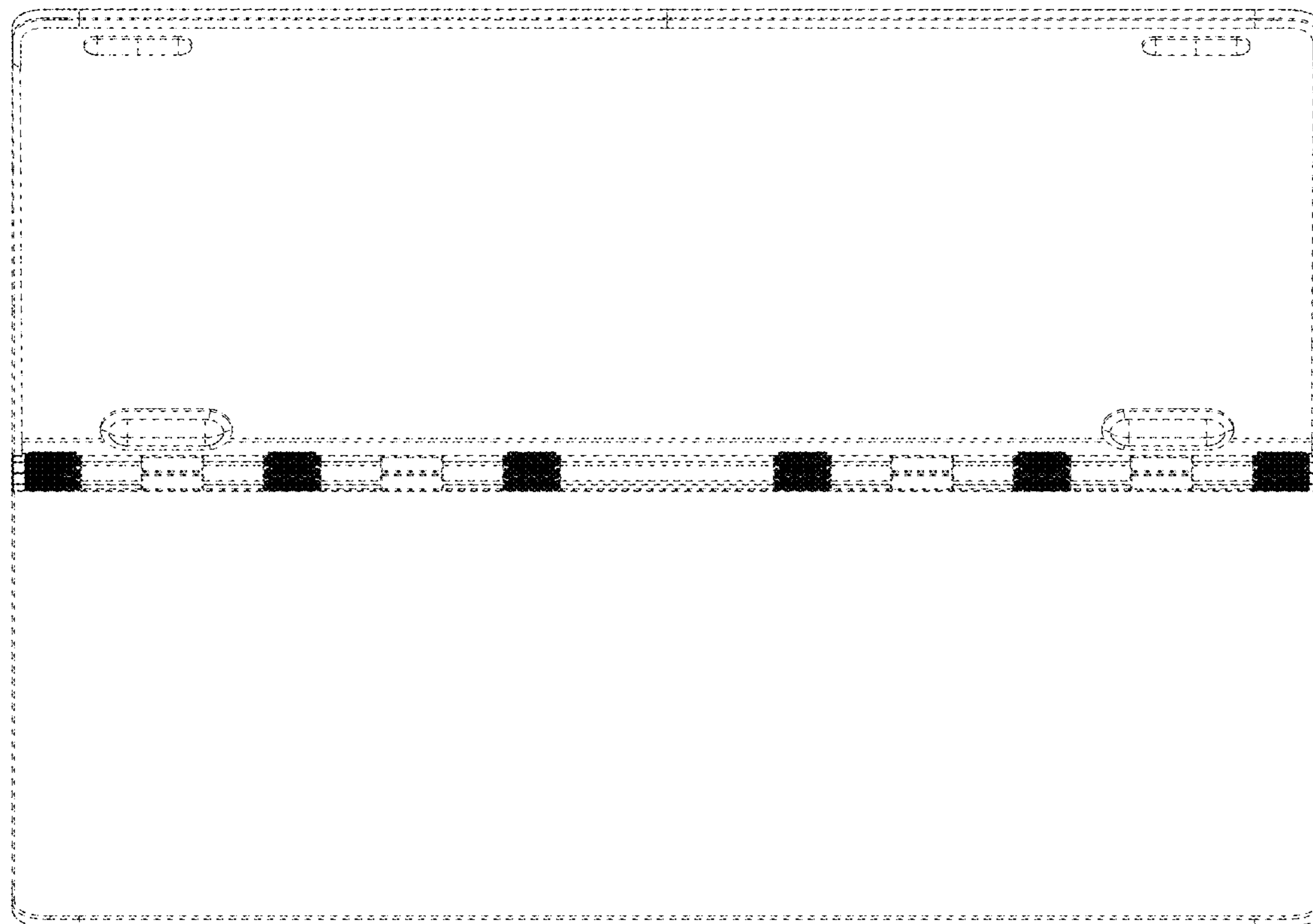

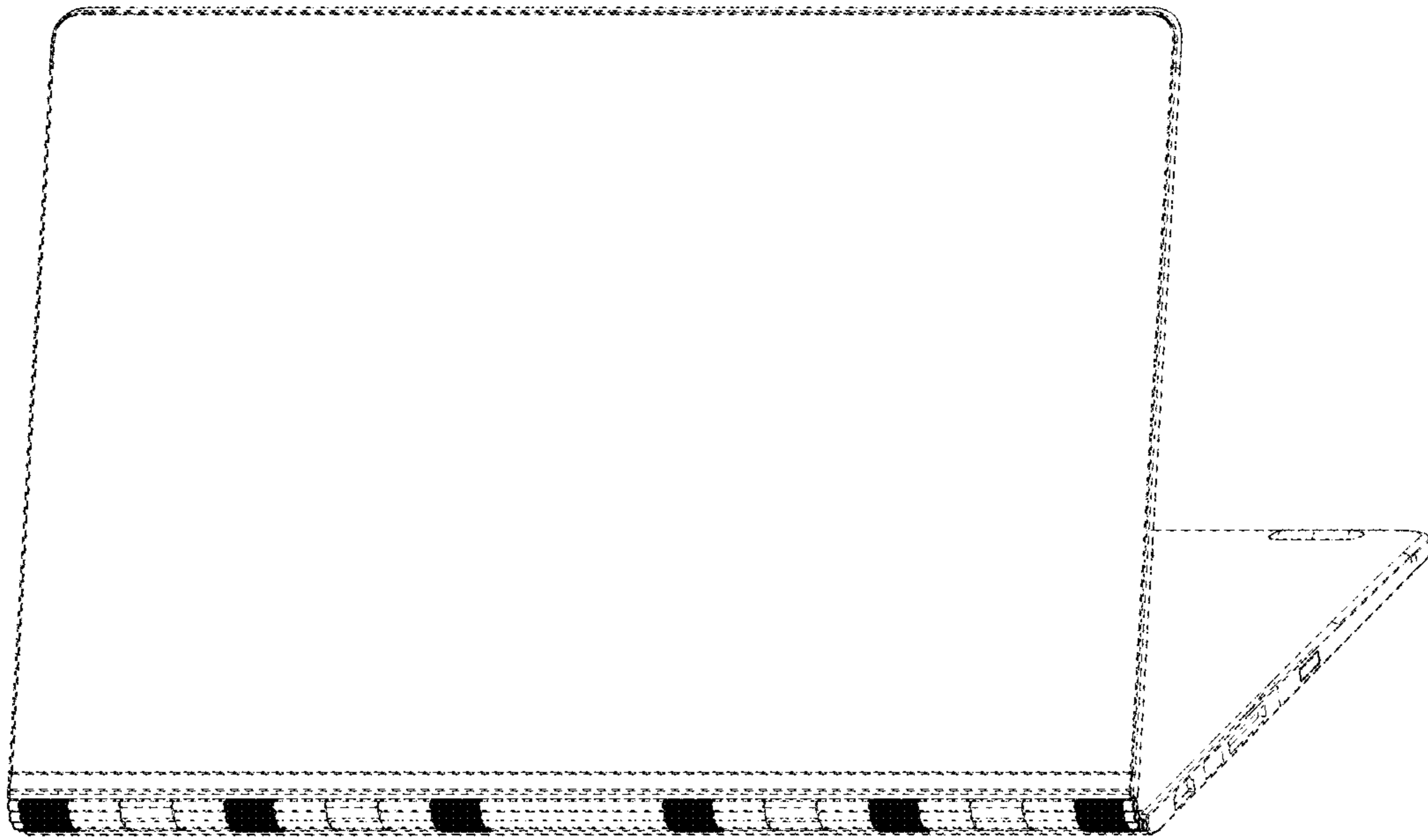

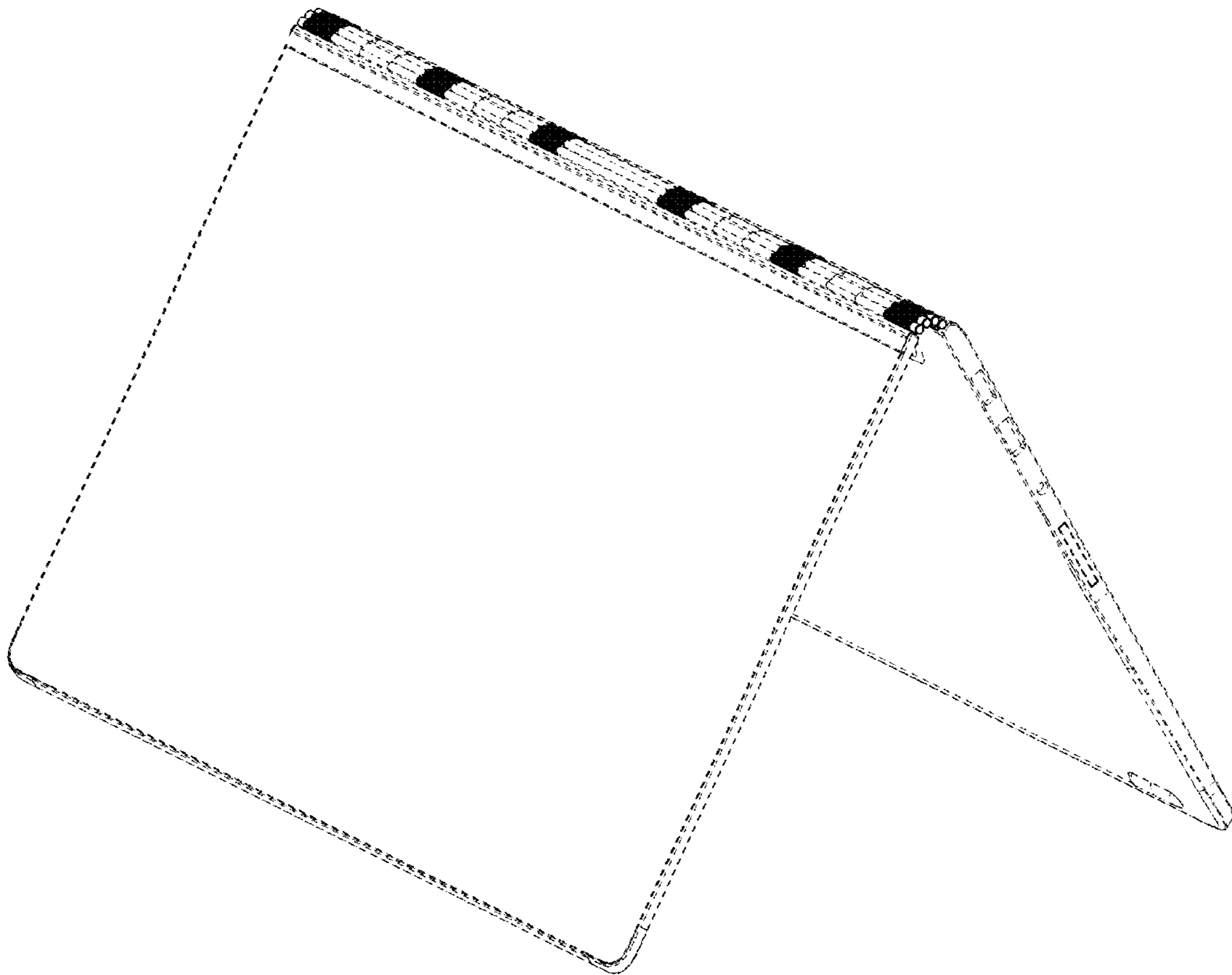

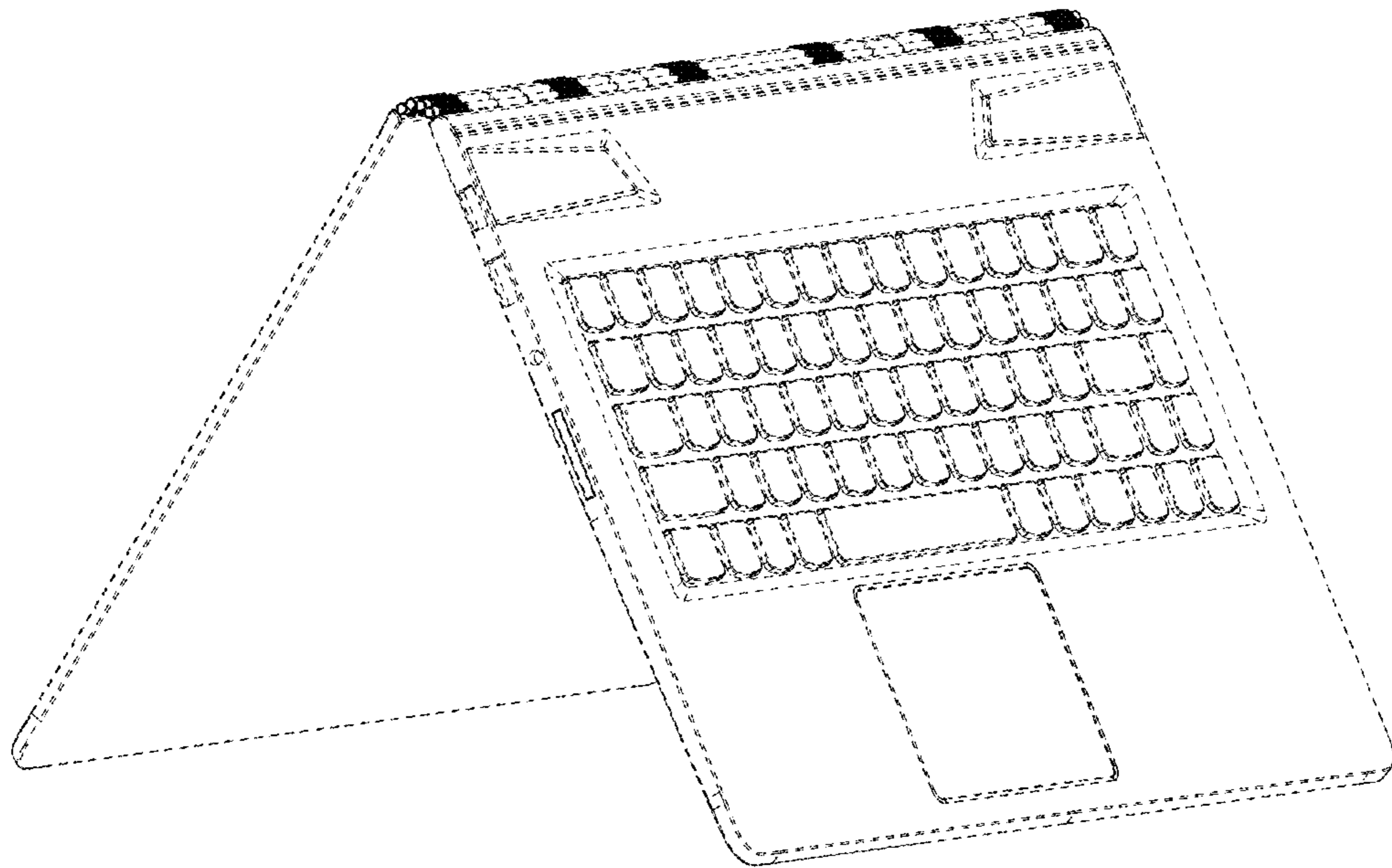

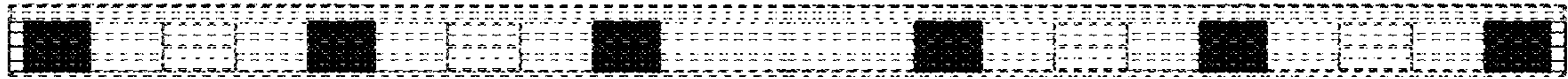

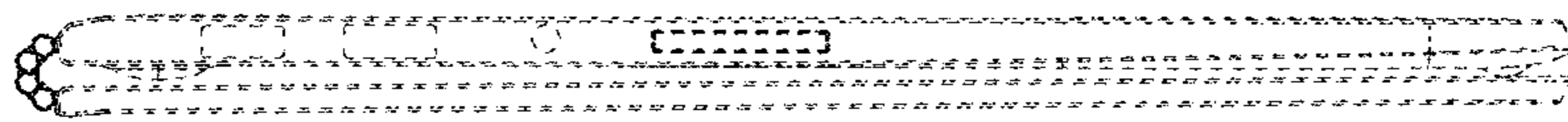

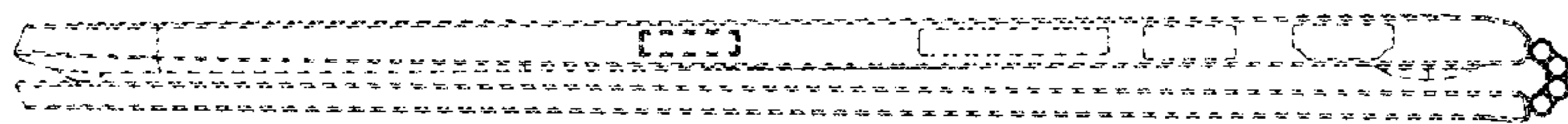

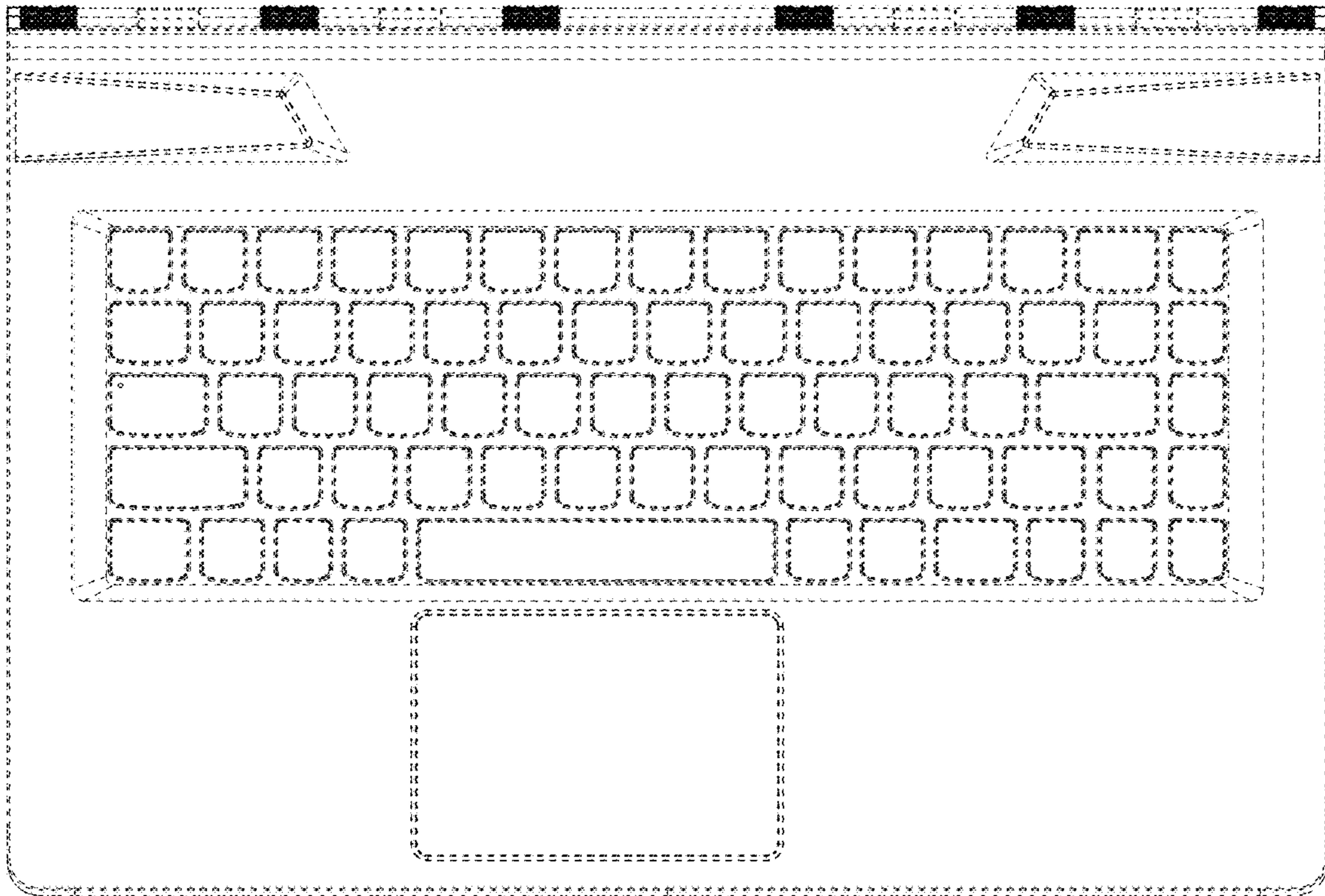

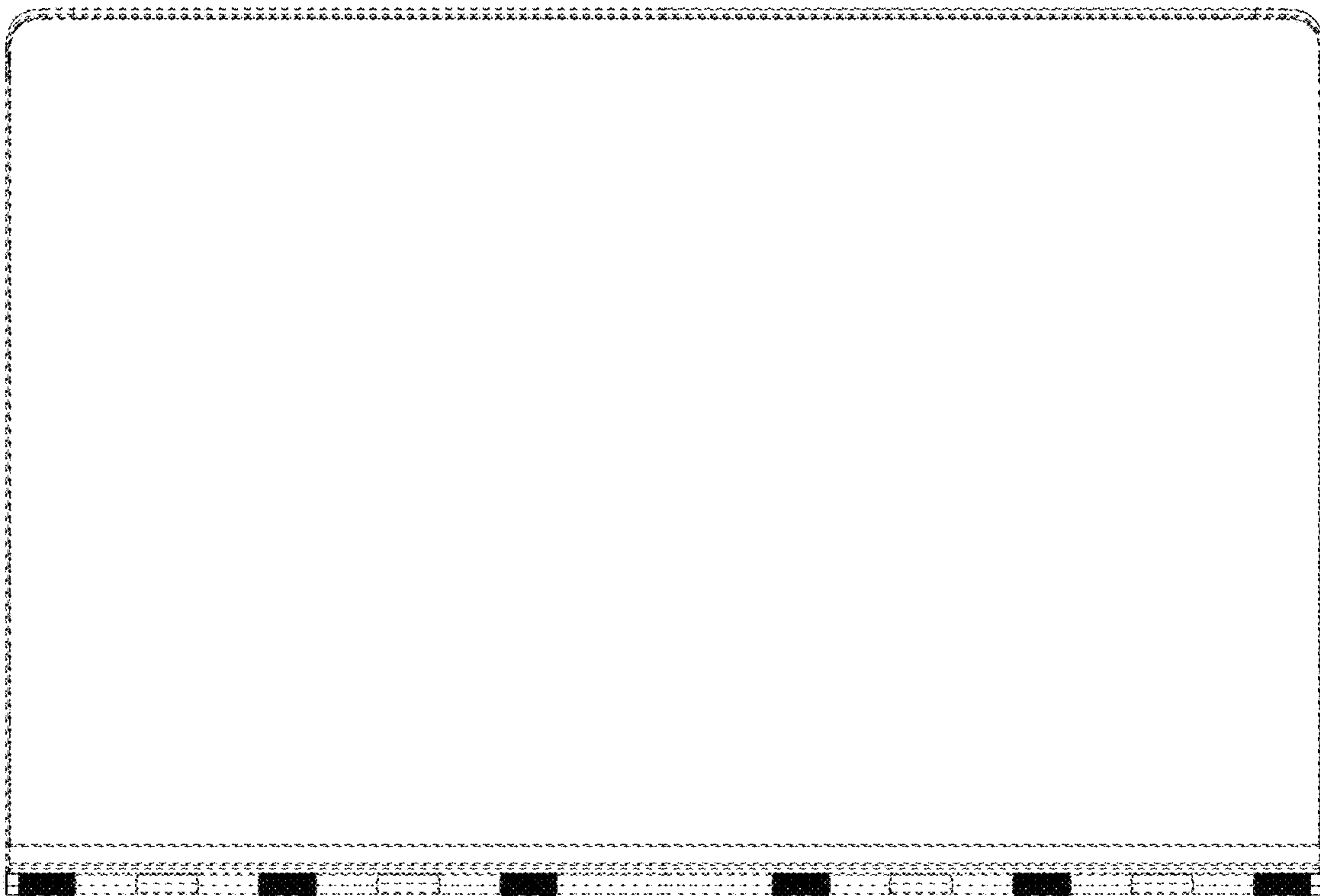

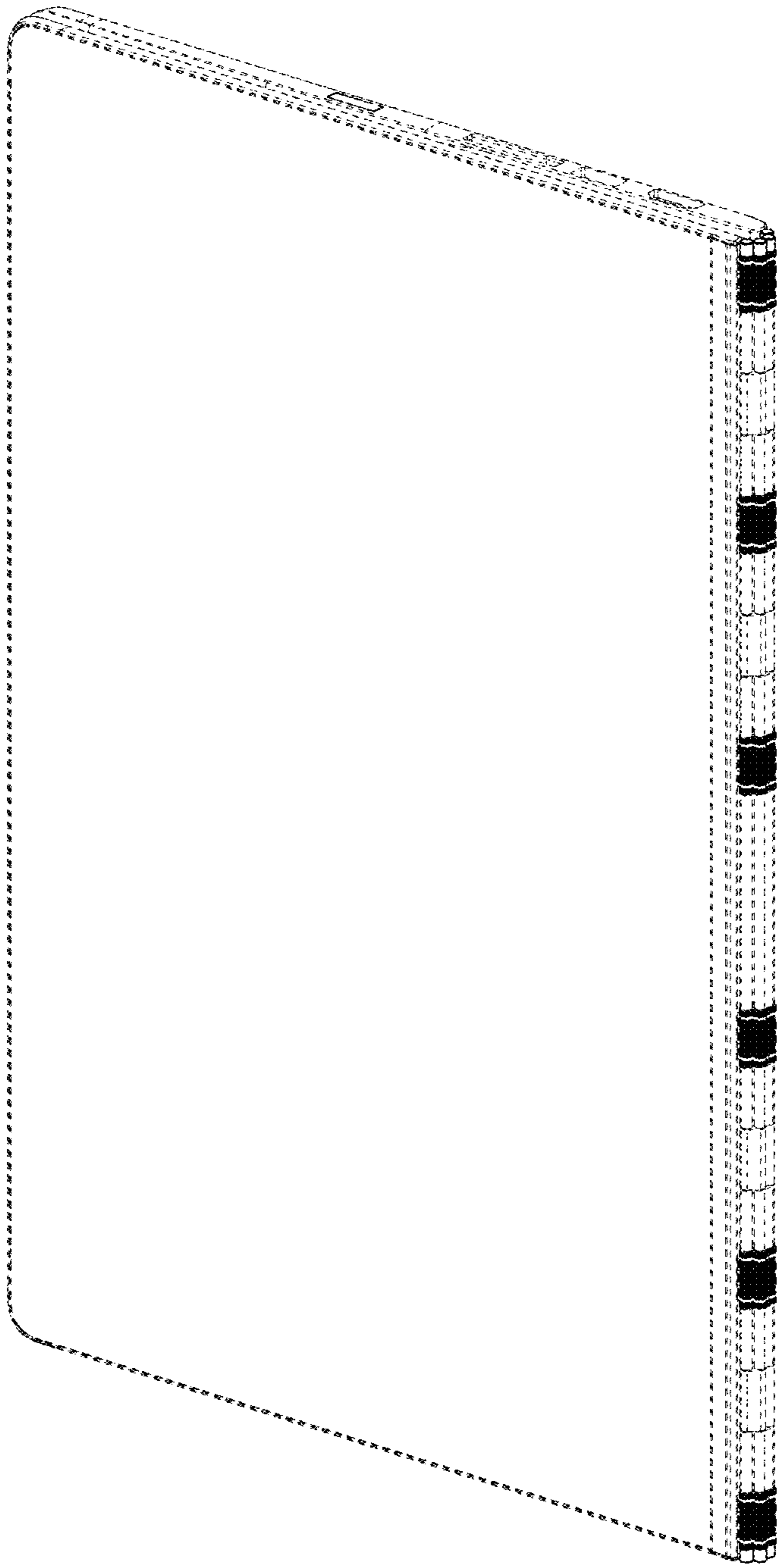

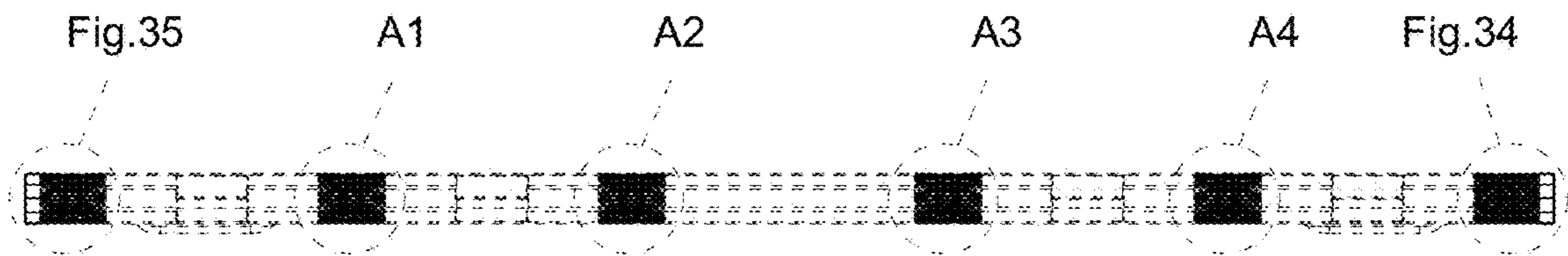

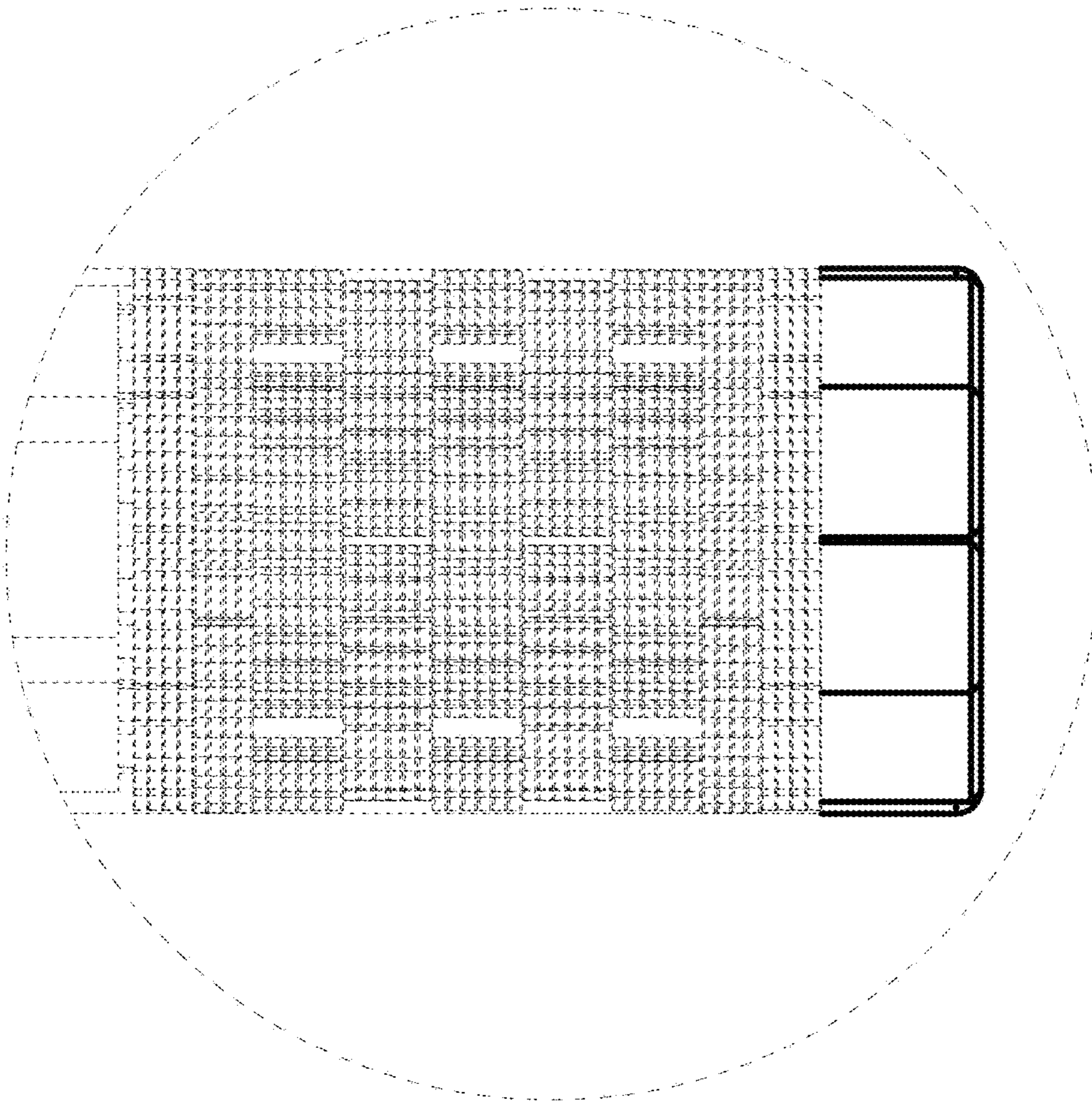

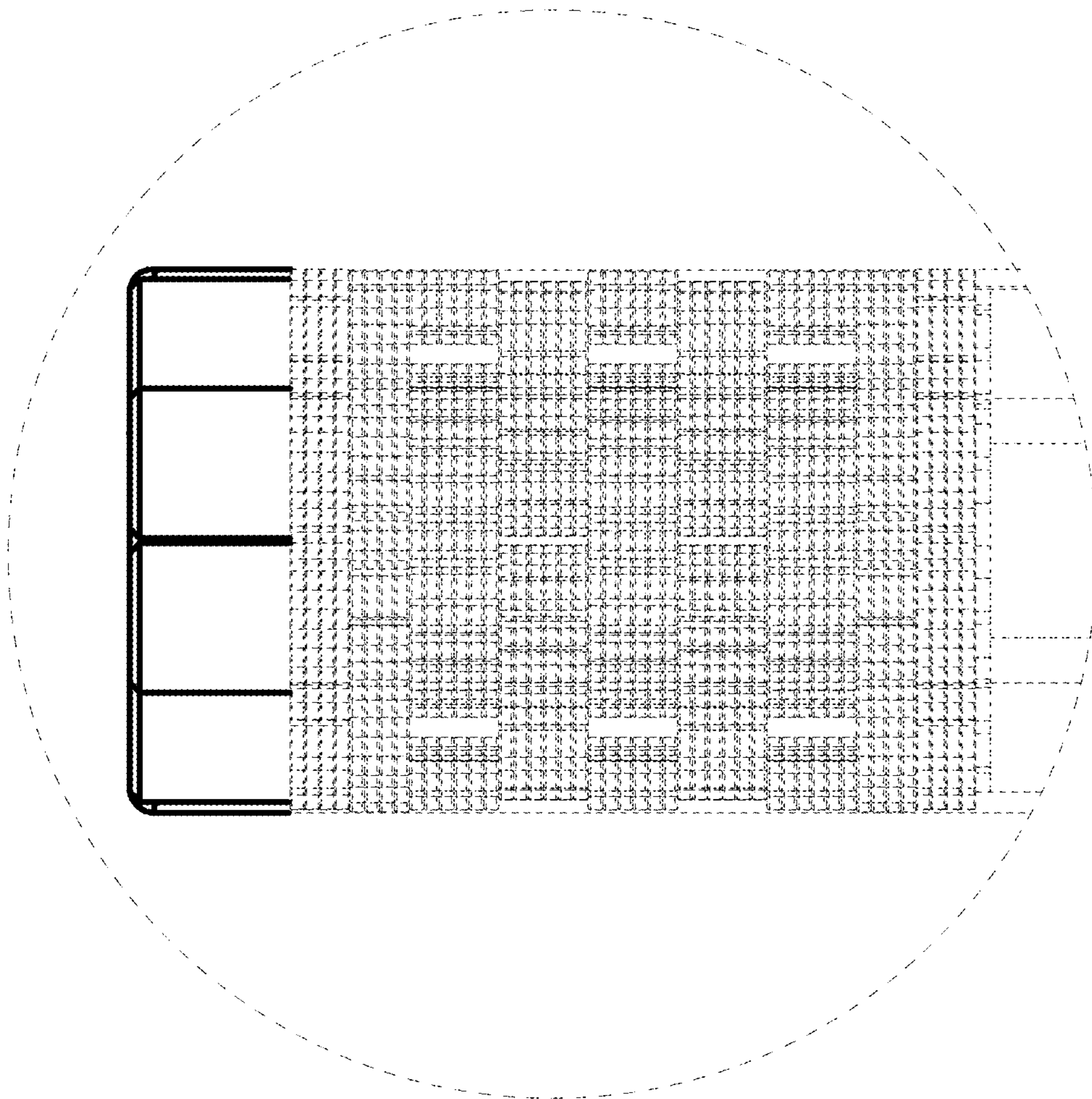
