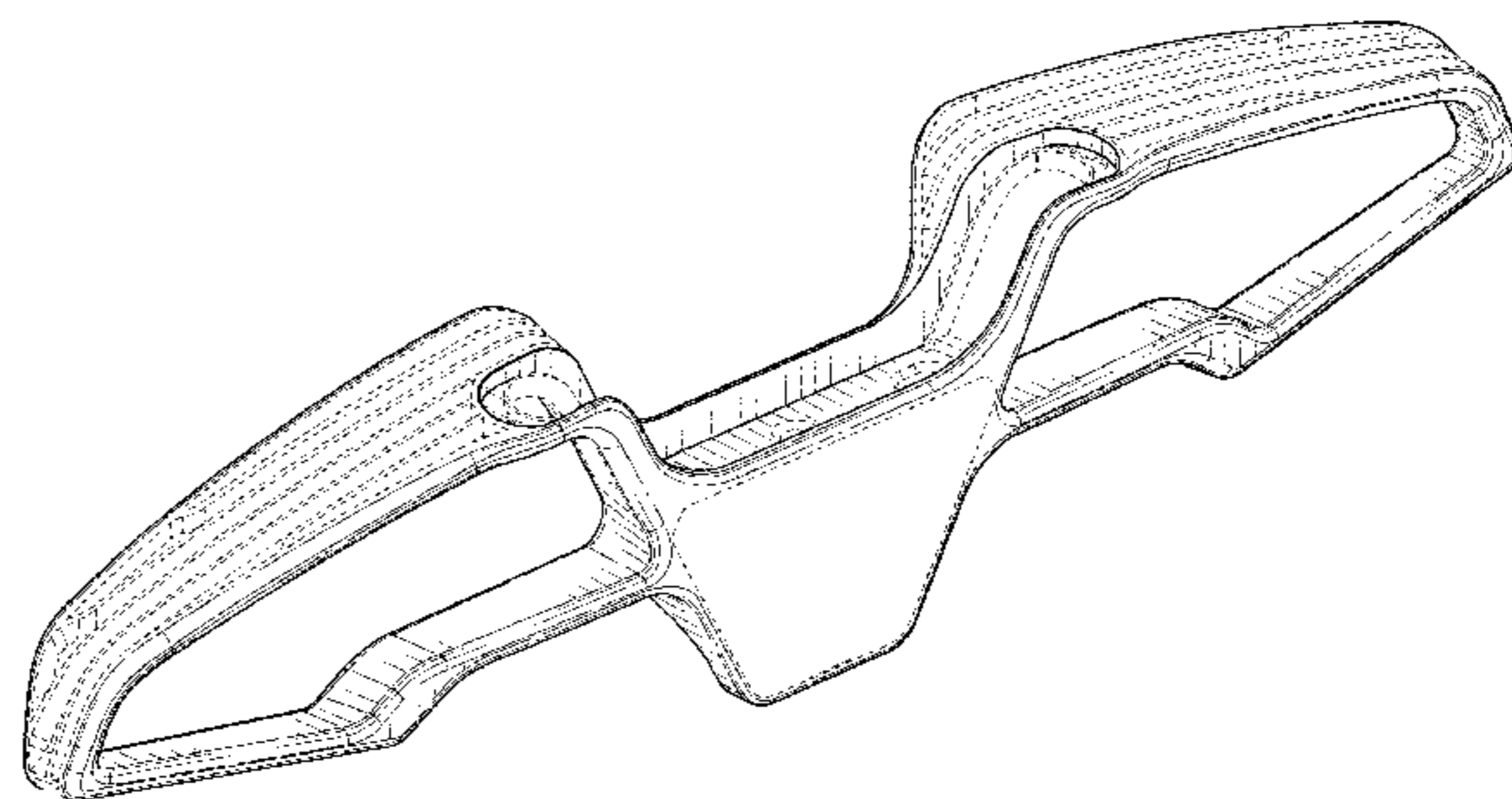
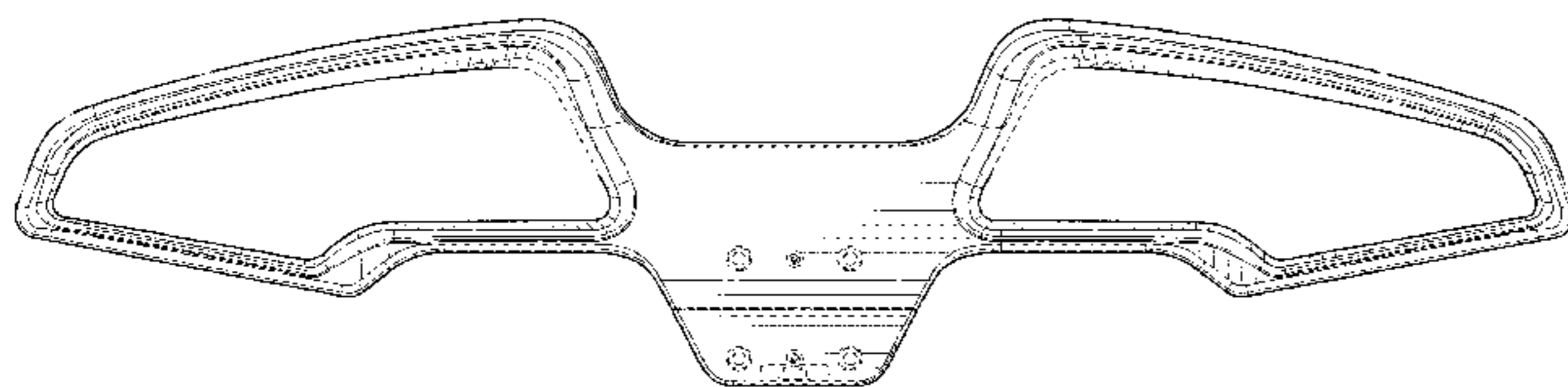
(57) **CLAIM**

I claim the ornamental design for a display attachment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, right perspective view of a display attachment;  
FIG. 2 is a front view thereof;

FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;

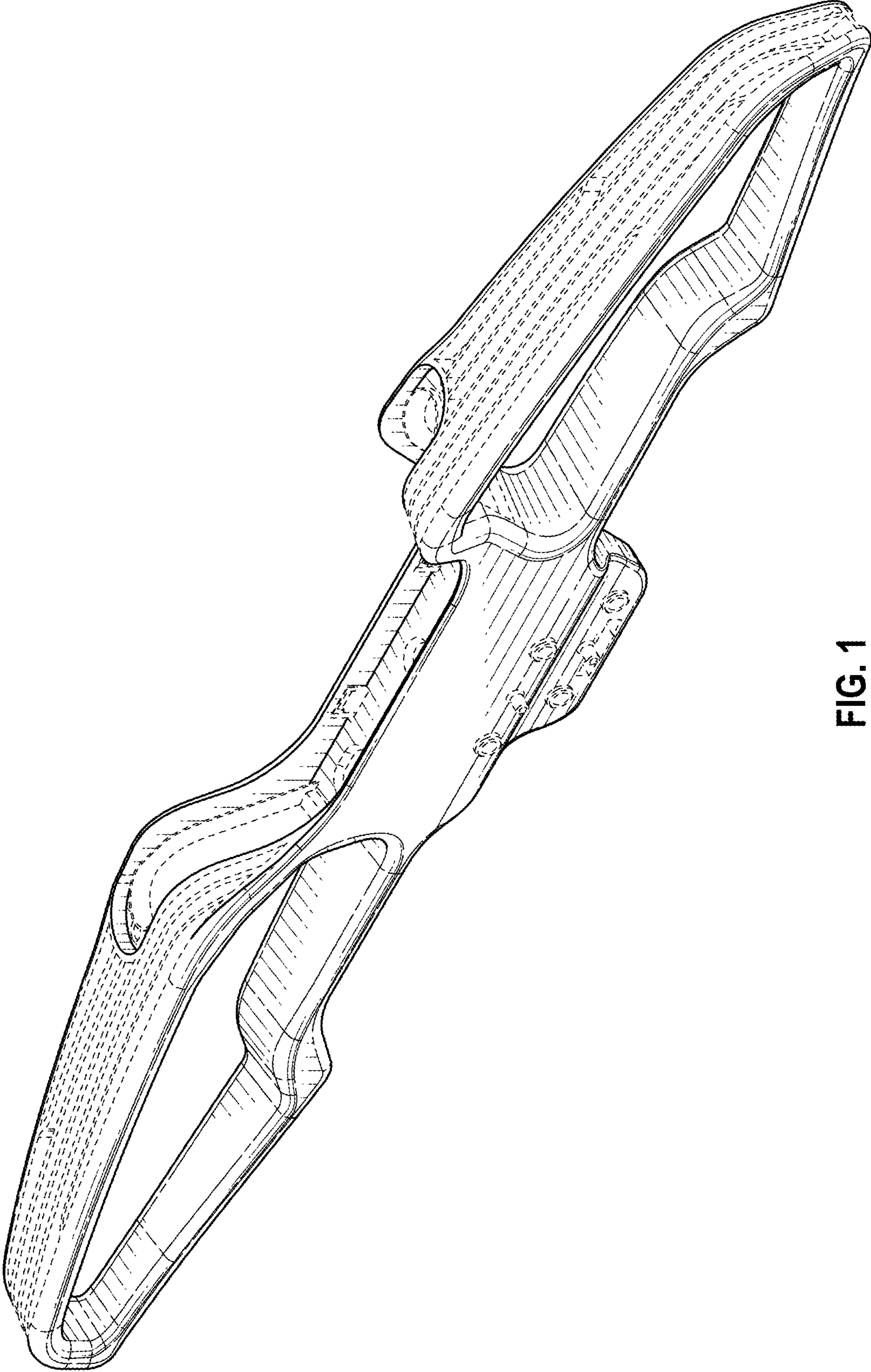

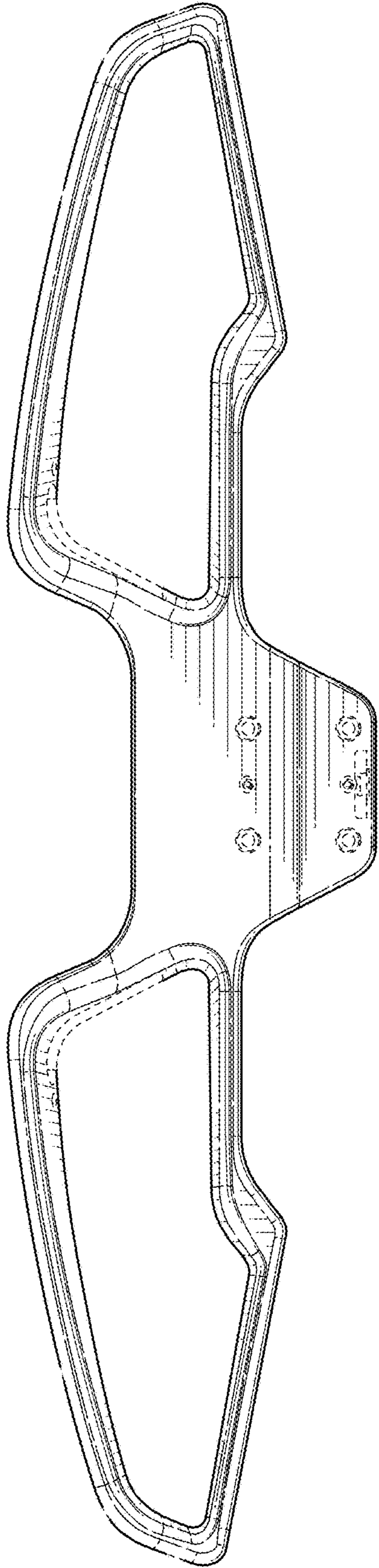

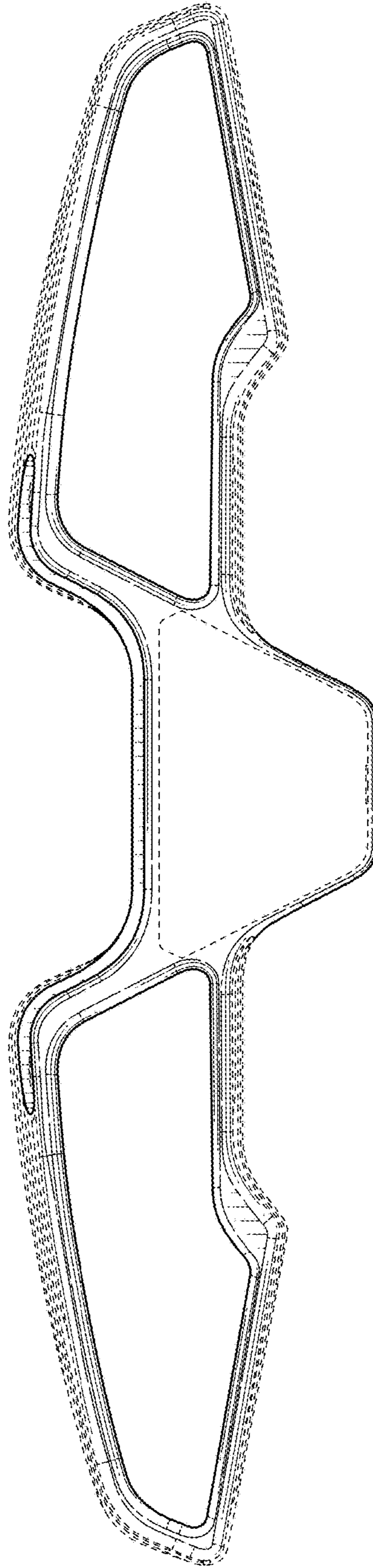

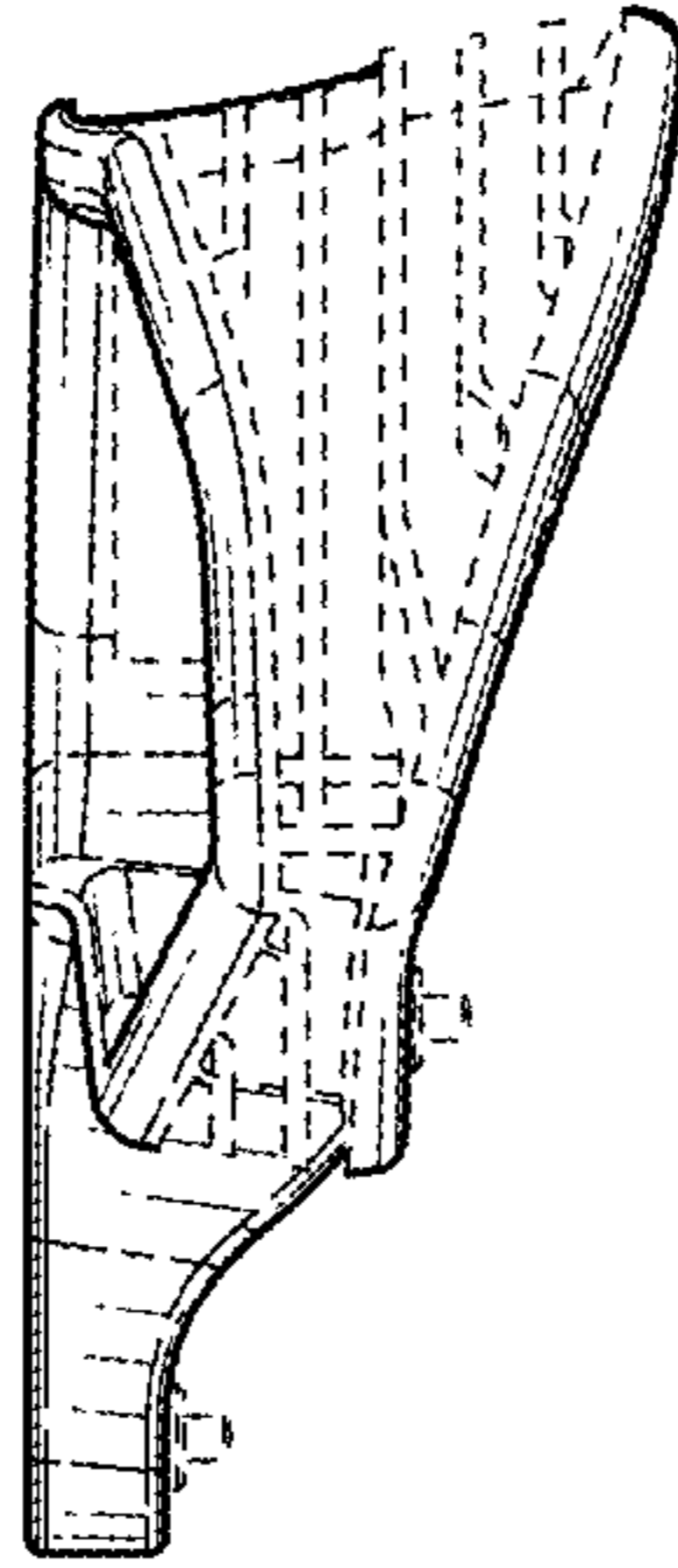

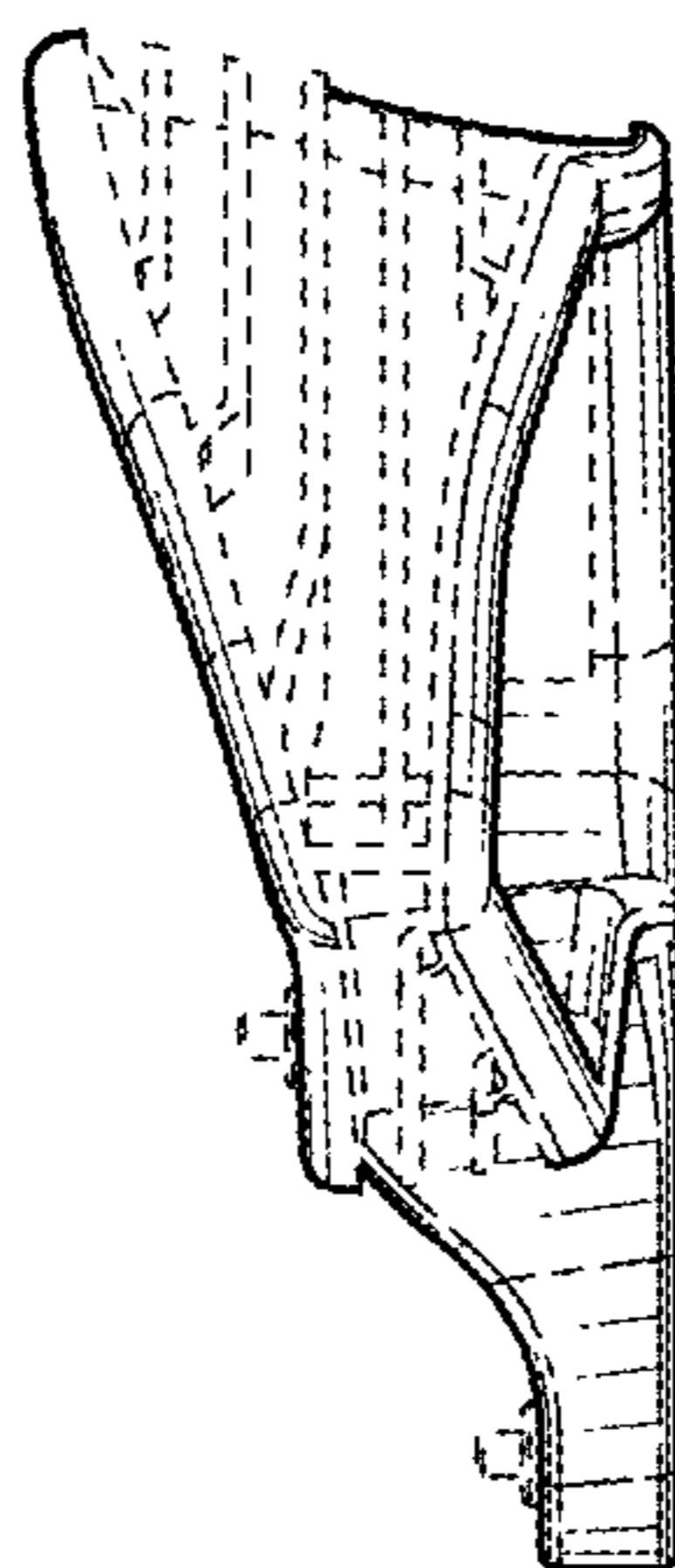

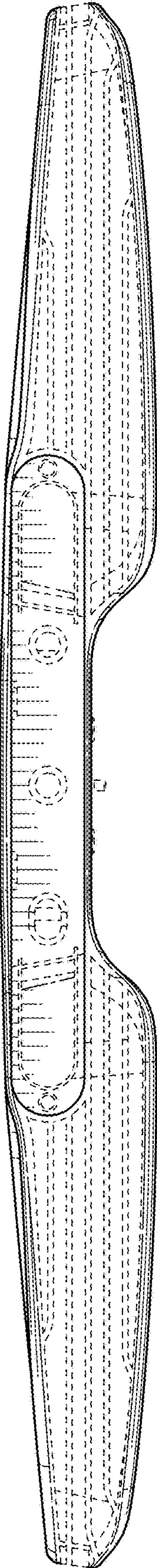

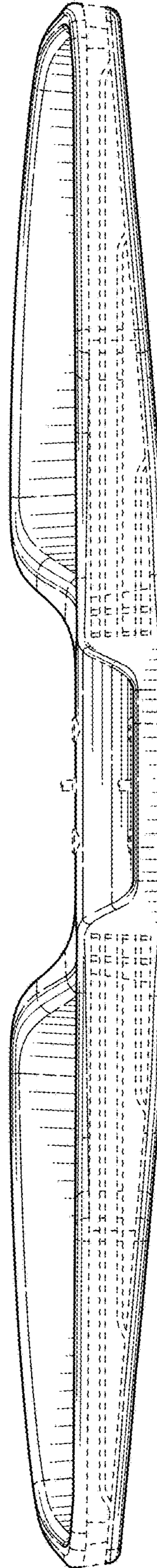

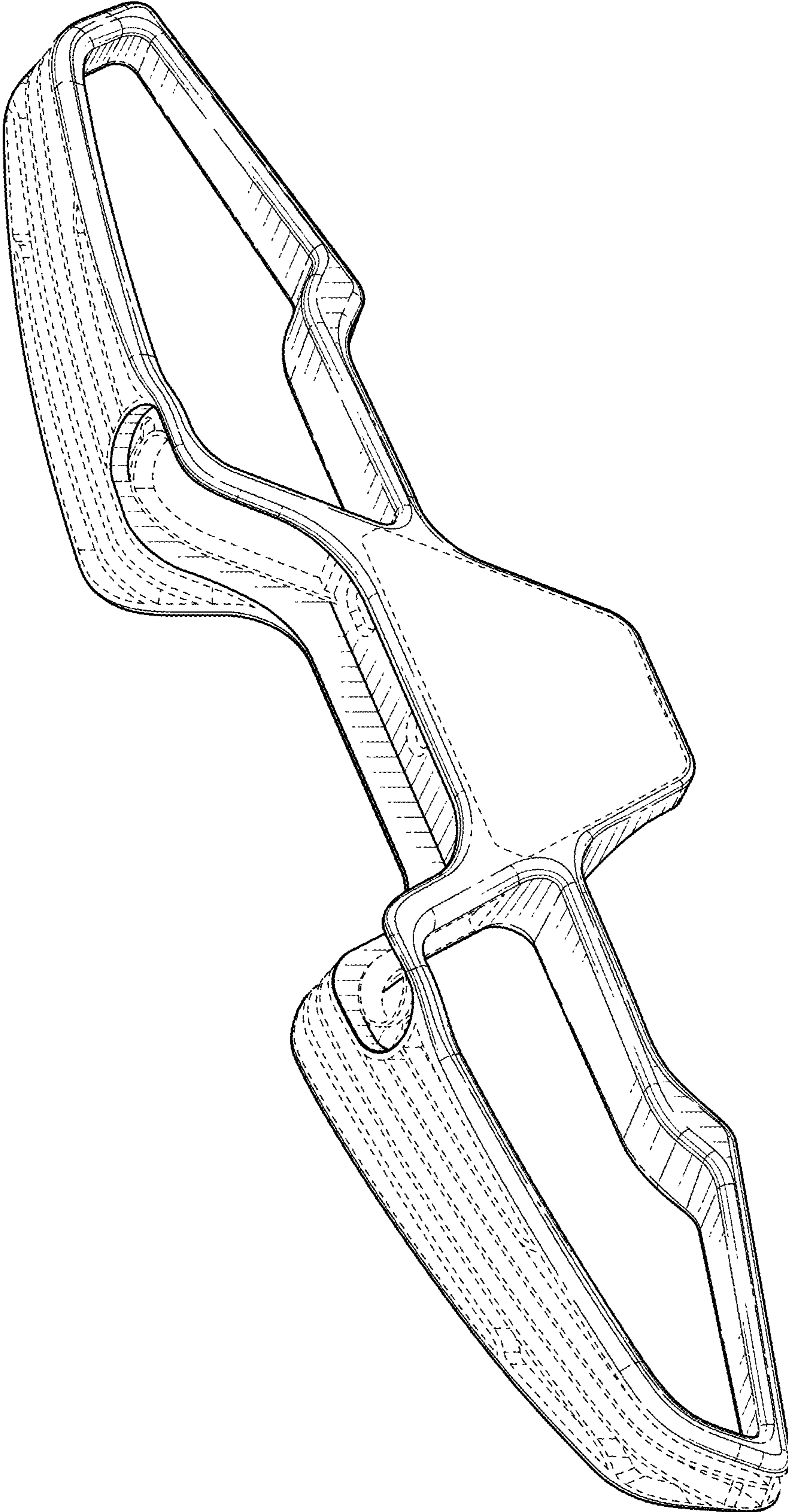
