(57) **CLAIM**

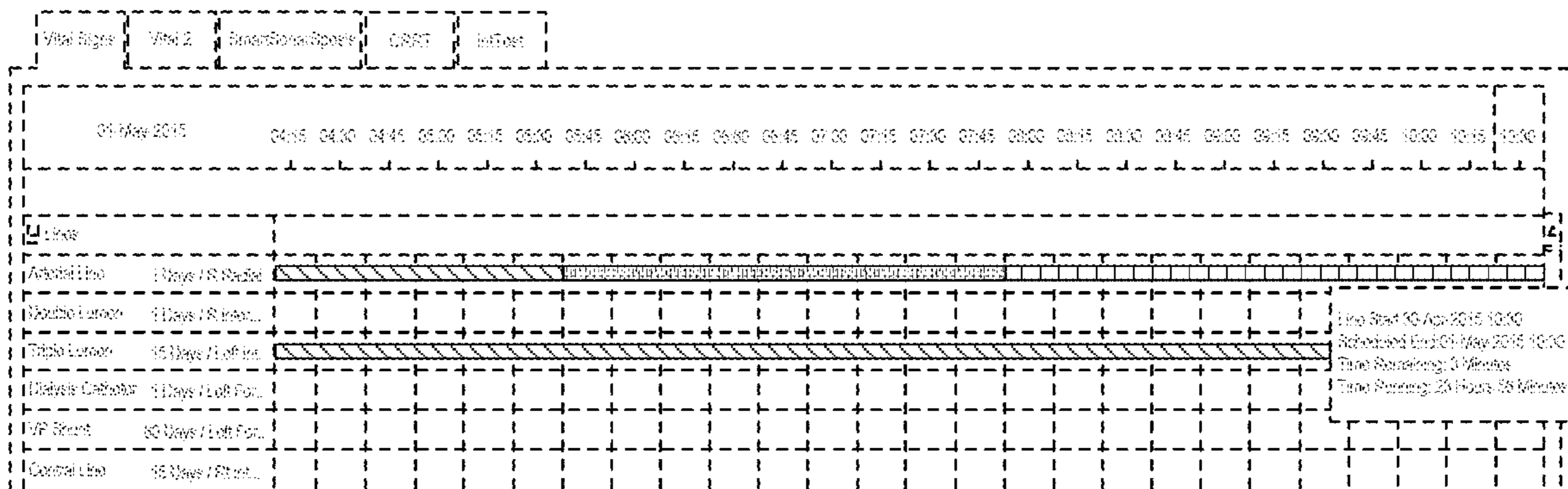
The ornamental design for a display screen with graphical user interface for displaying medical line status, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface for displaying medical line status. FIG. 2 is a front view of a second embodiment thereof. FIG. 3 is a front view of the embodiment of FIG. 1 shown in an alternative environment; and, FIG. 4 is a front view of the second embodiment of FIG. 2 shown in an alternative environment.

The outermost broken line rectangle illustrates a display screen and forms no part of the claimed design. The remaining broken lines illustrate portions of the graphical user

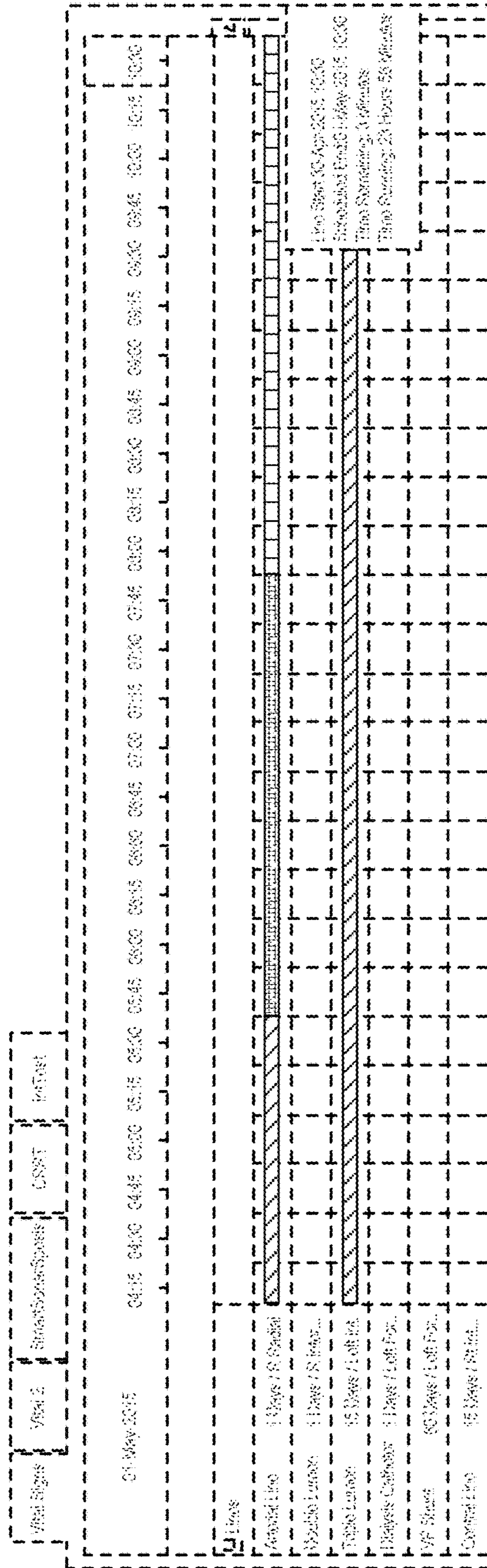

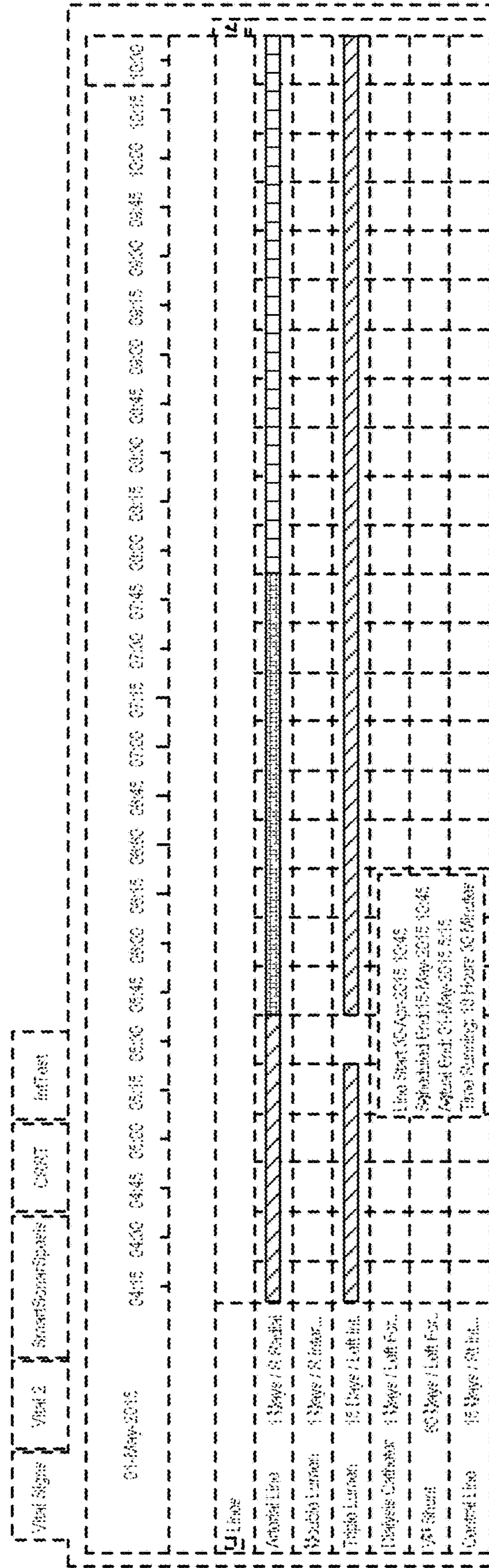

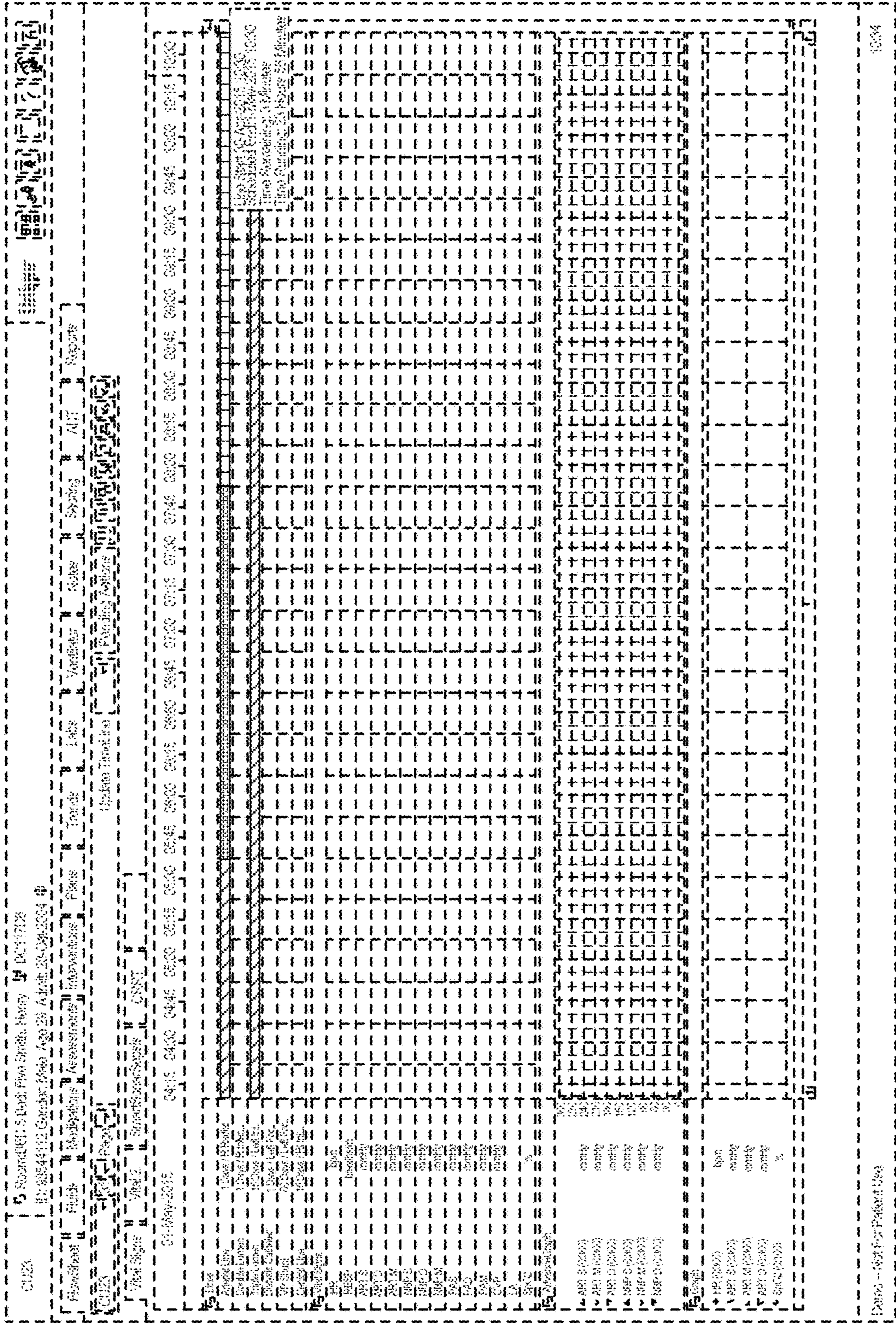

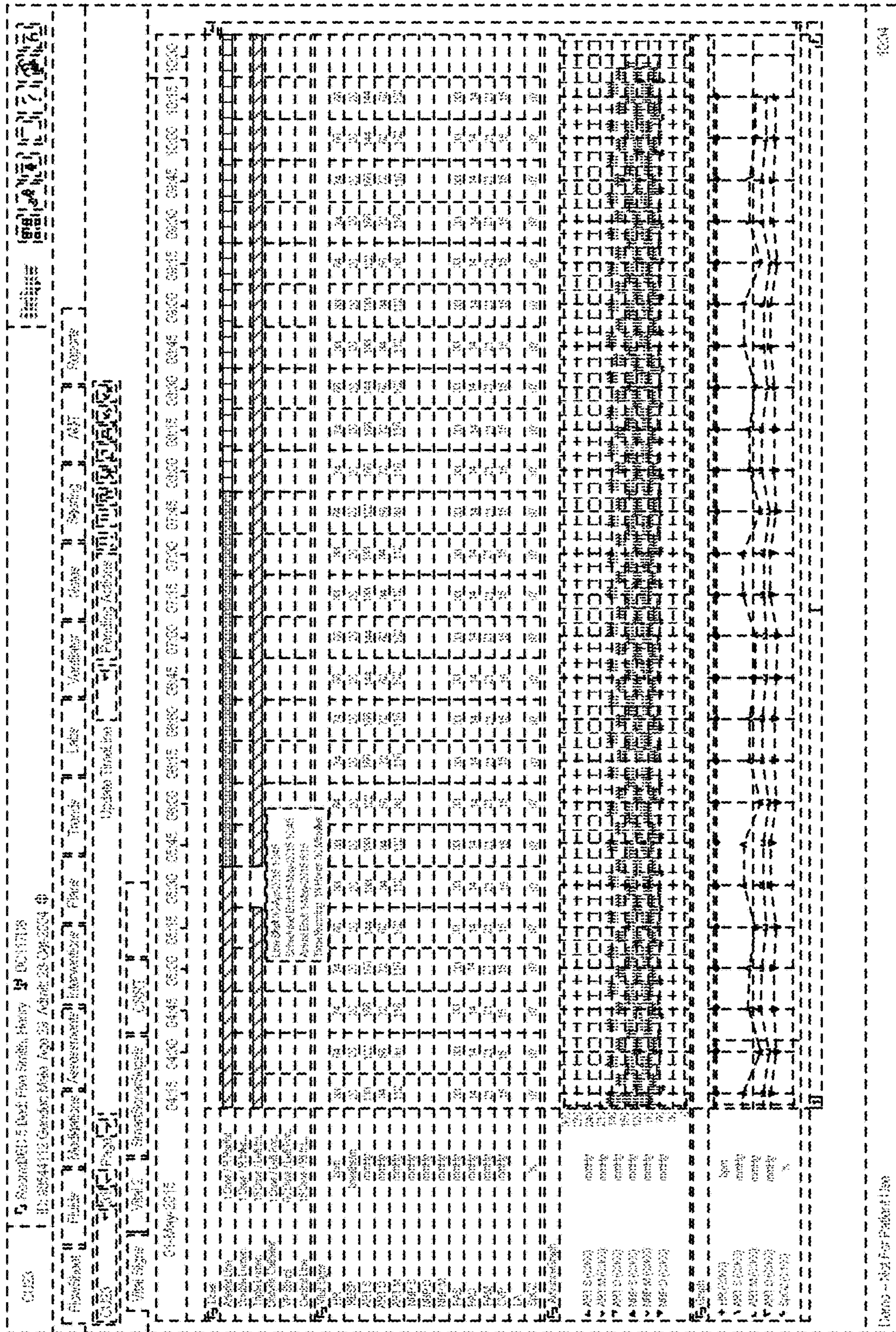
