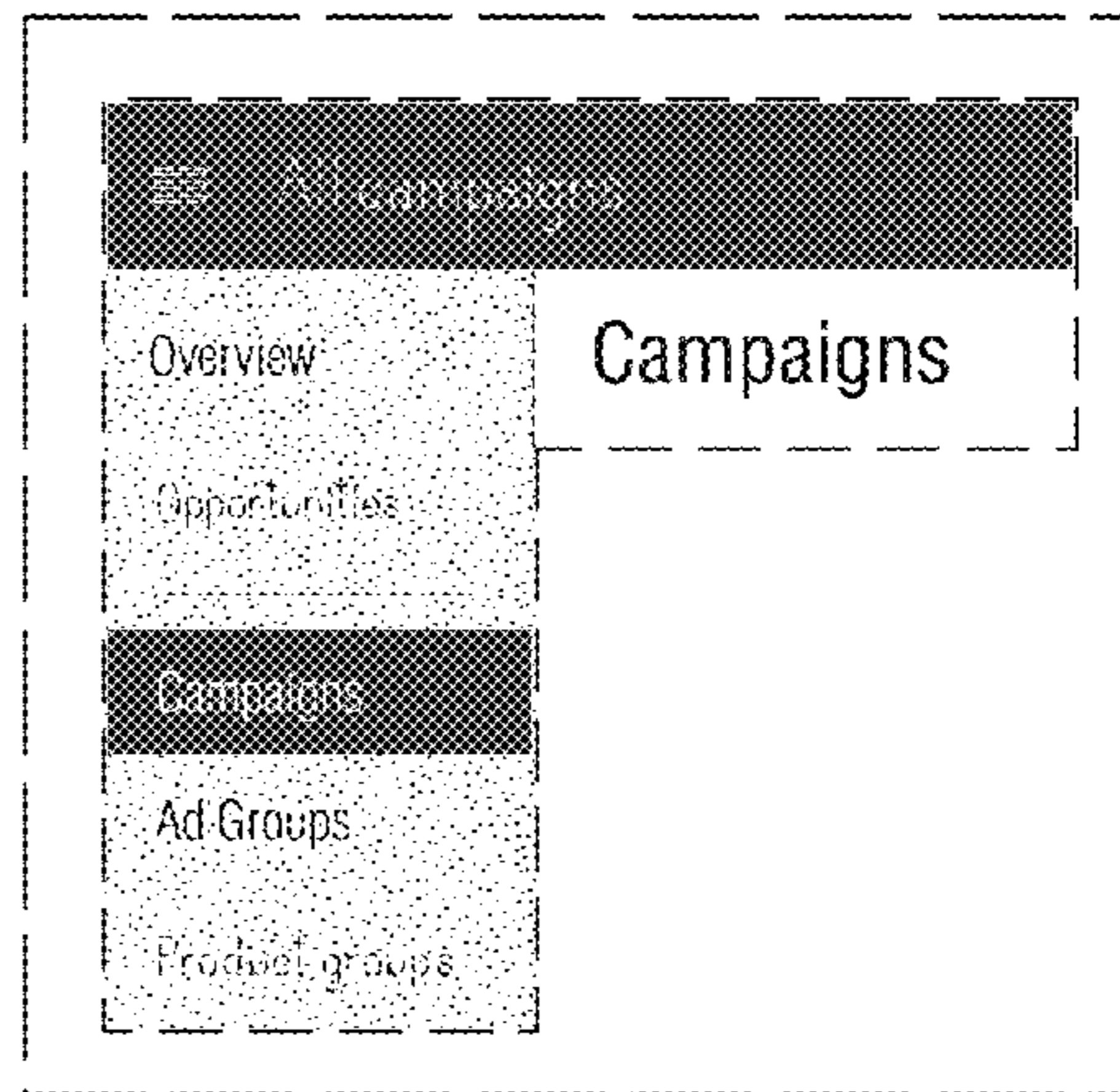
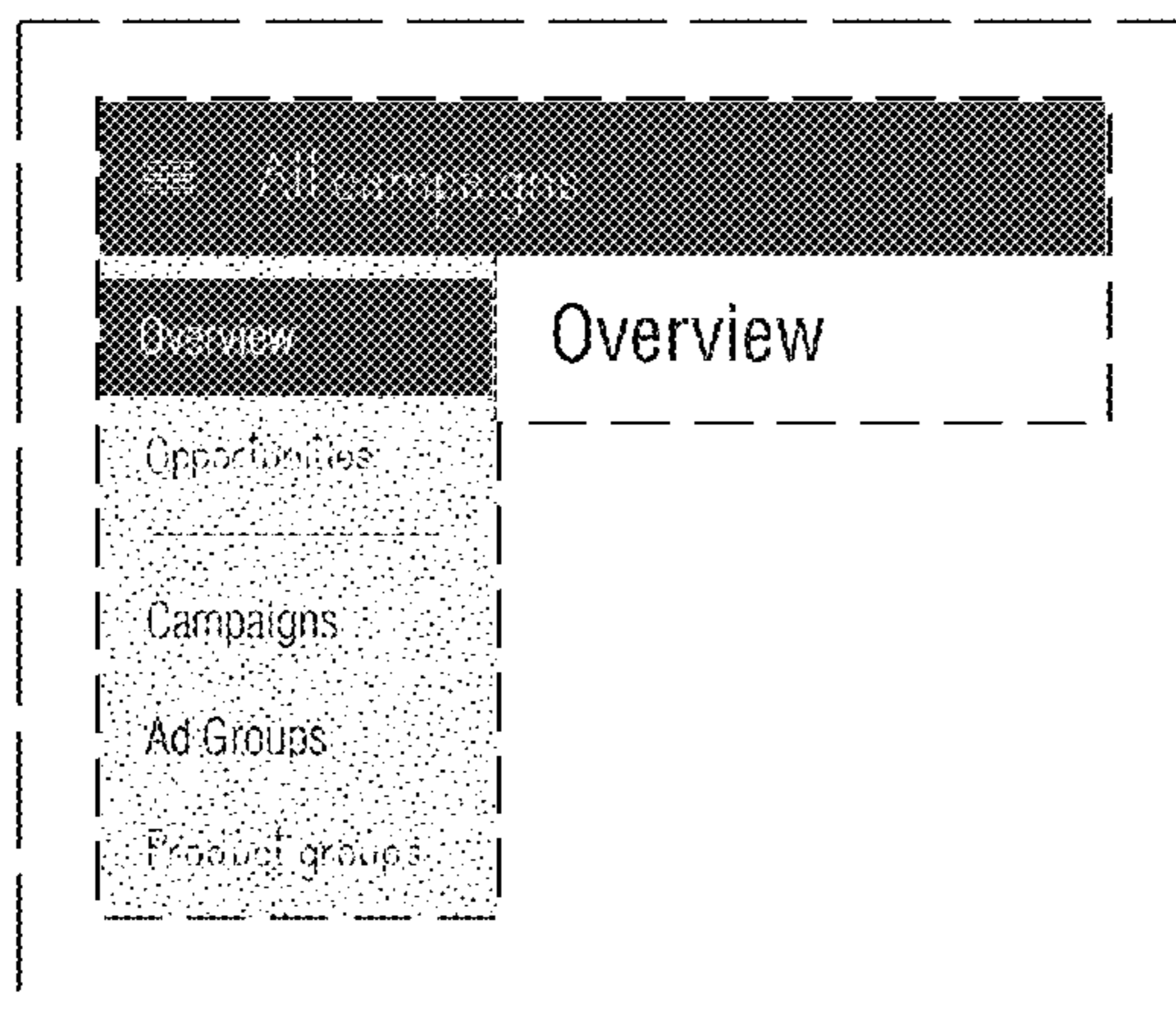


FIG. 15 is a front view of a third image included in the sequence of the fifth embodiment;

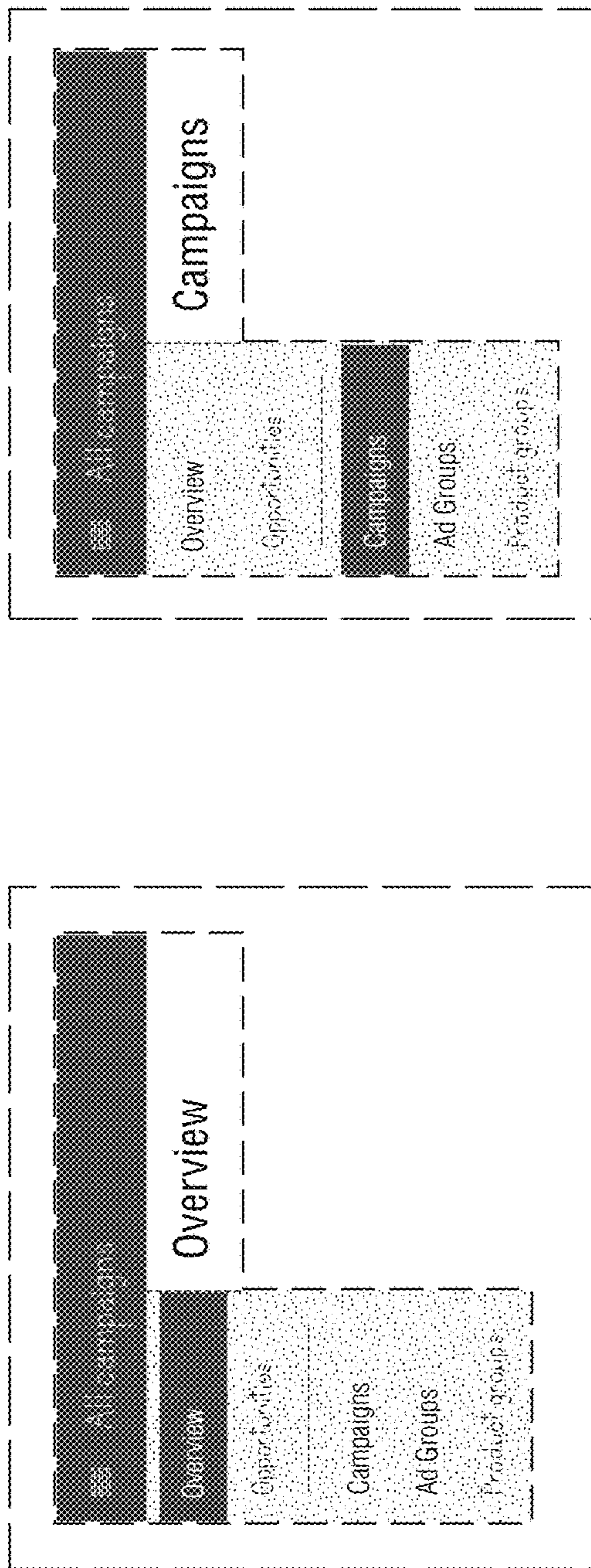

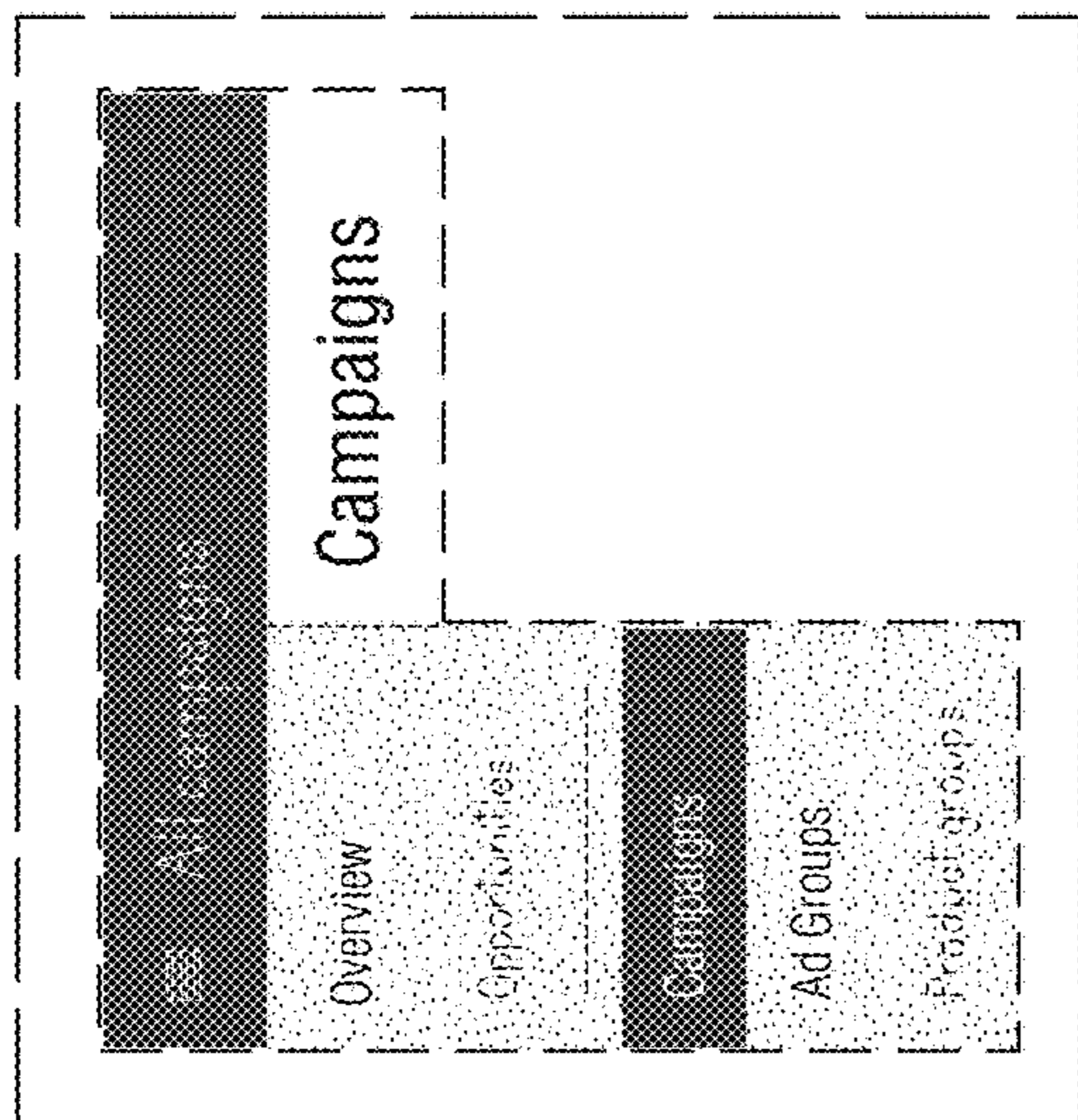

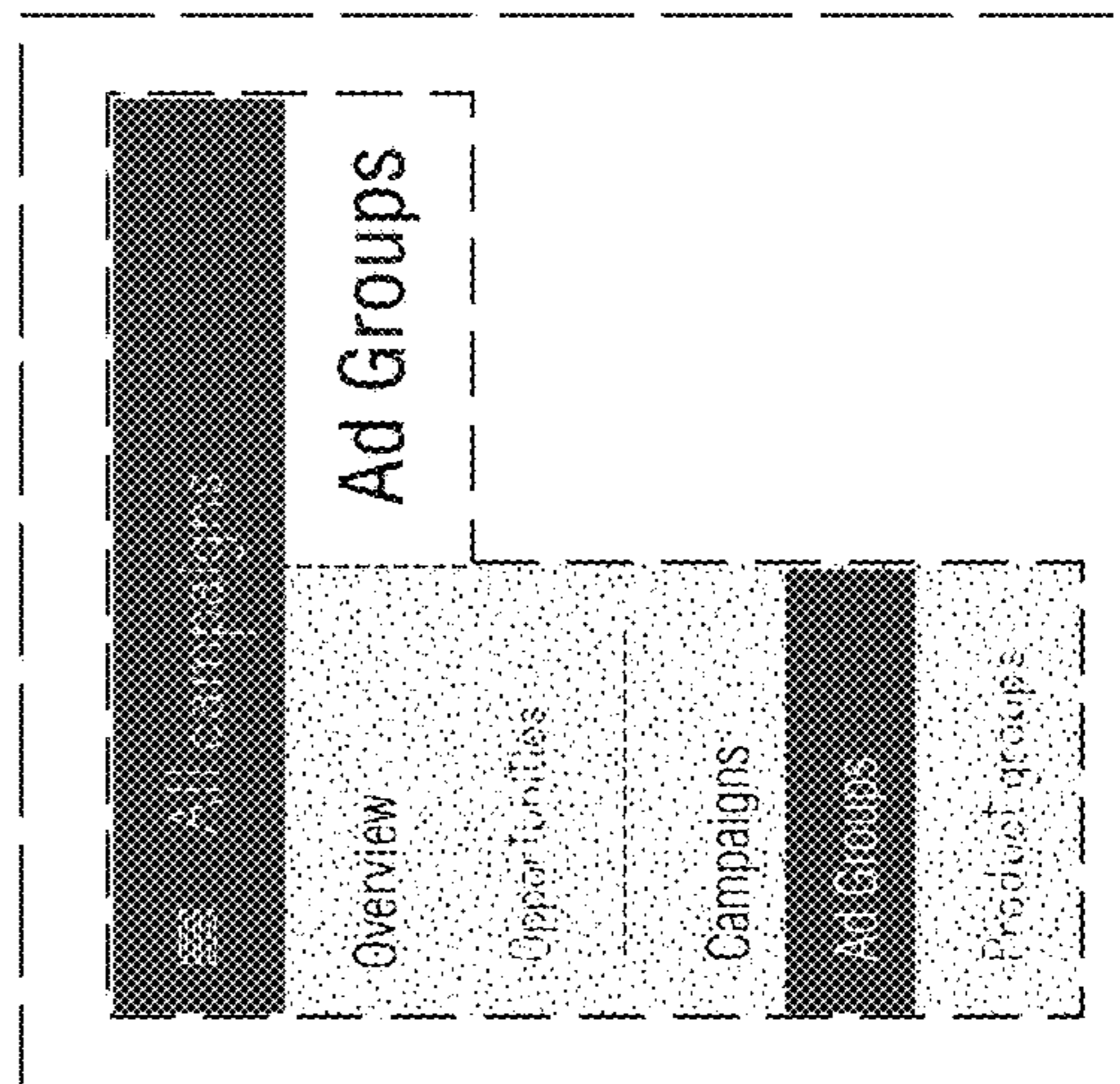

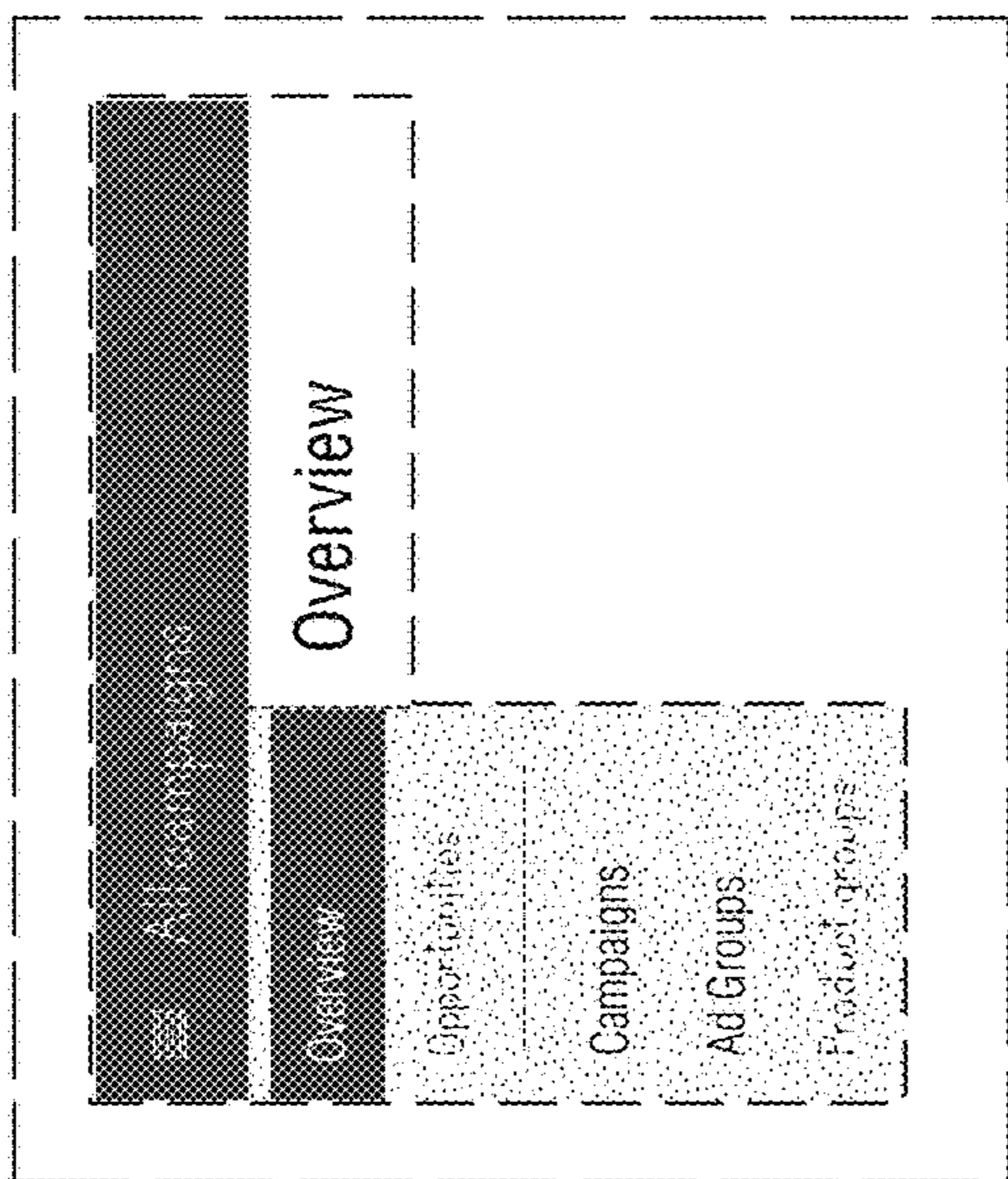

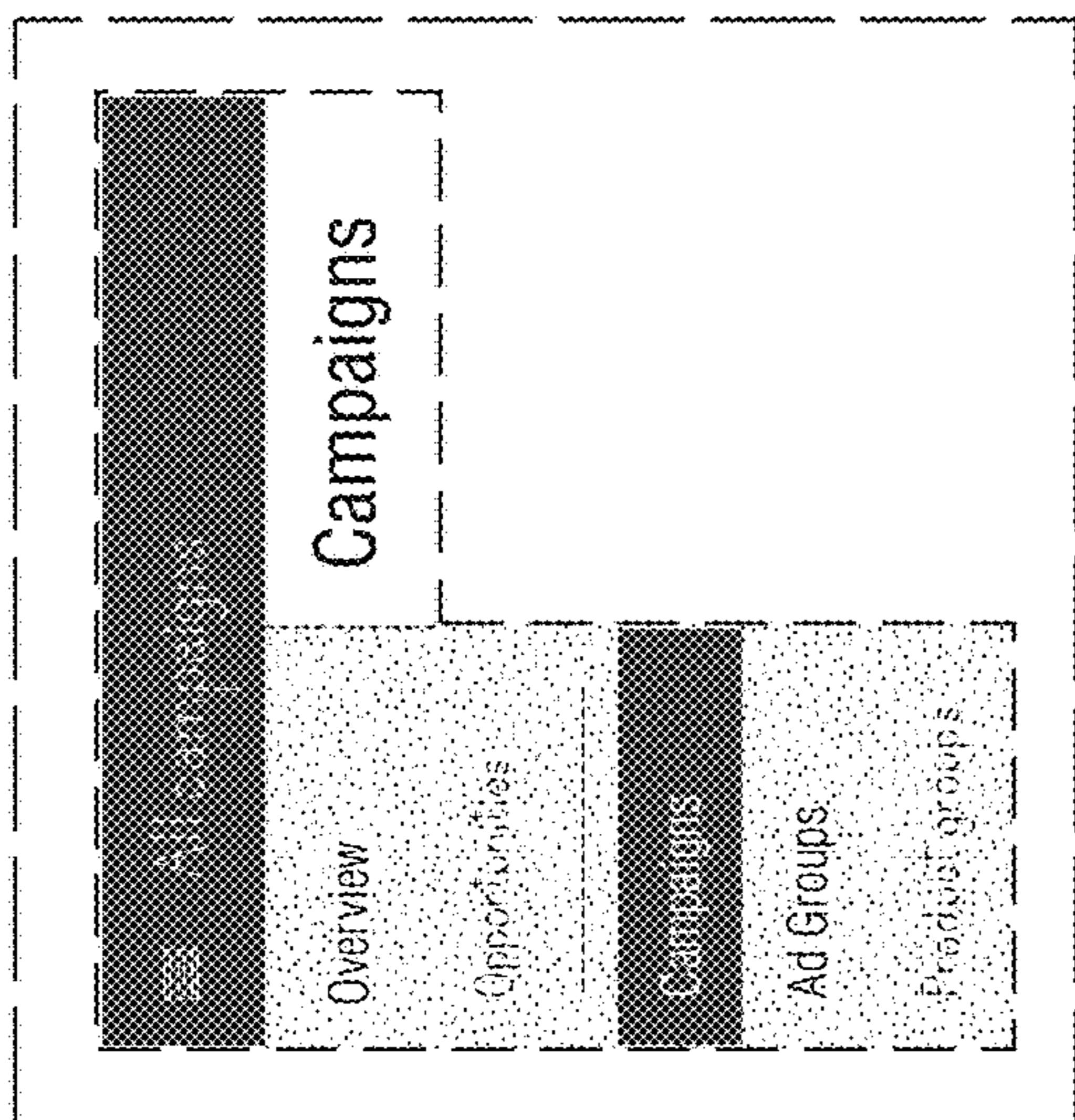

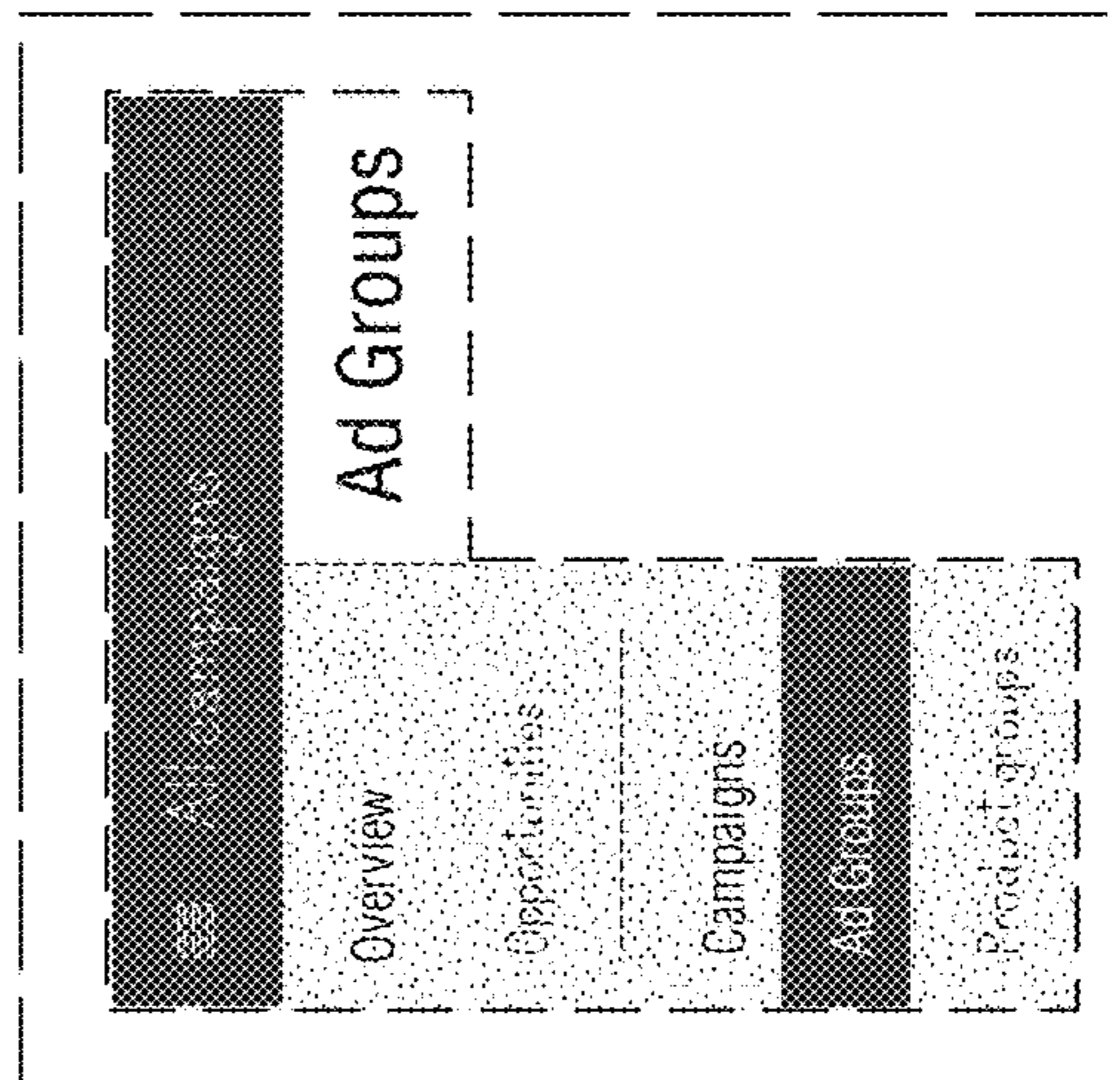

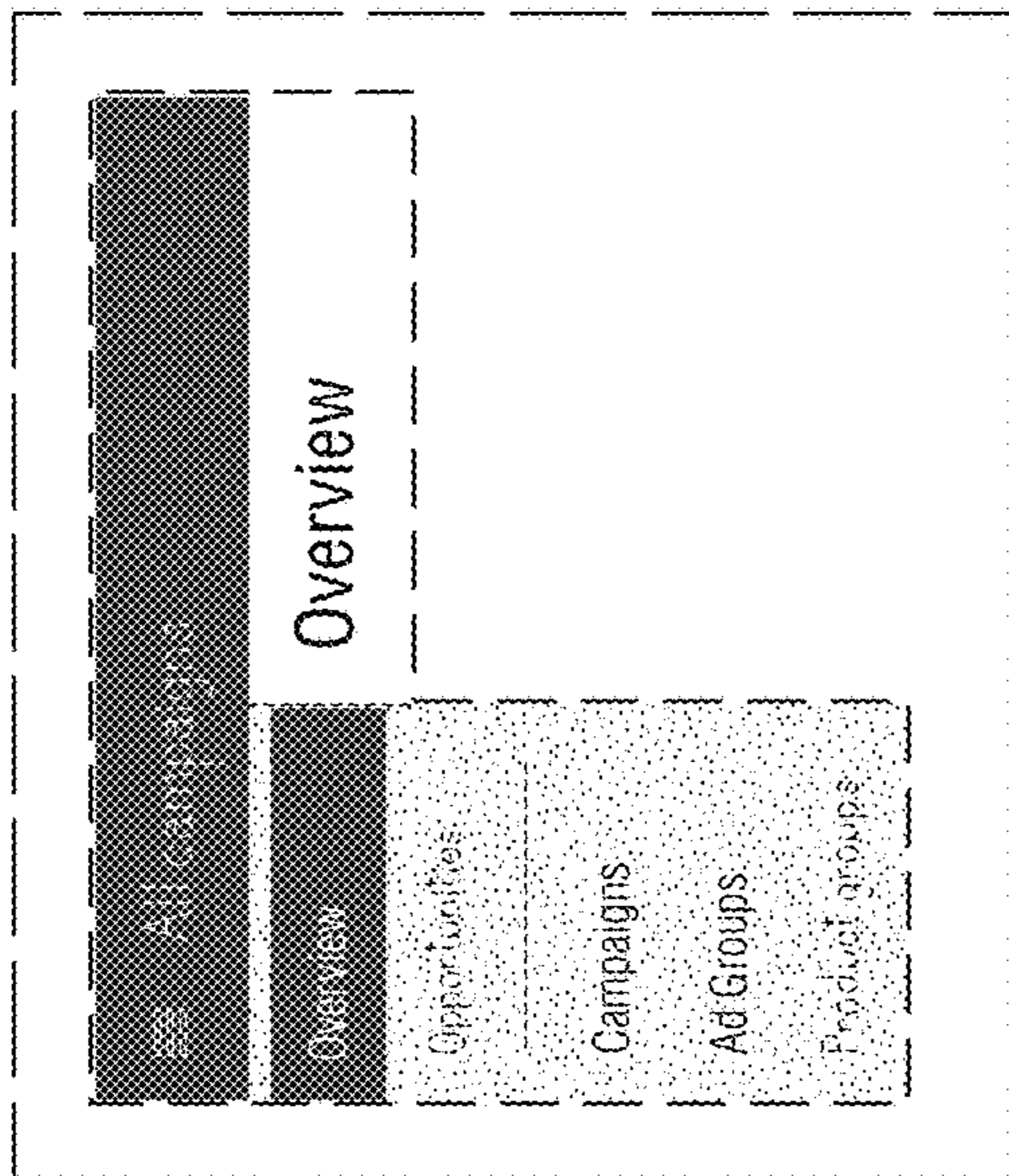
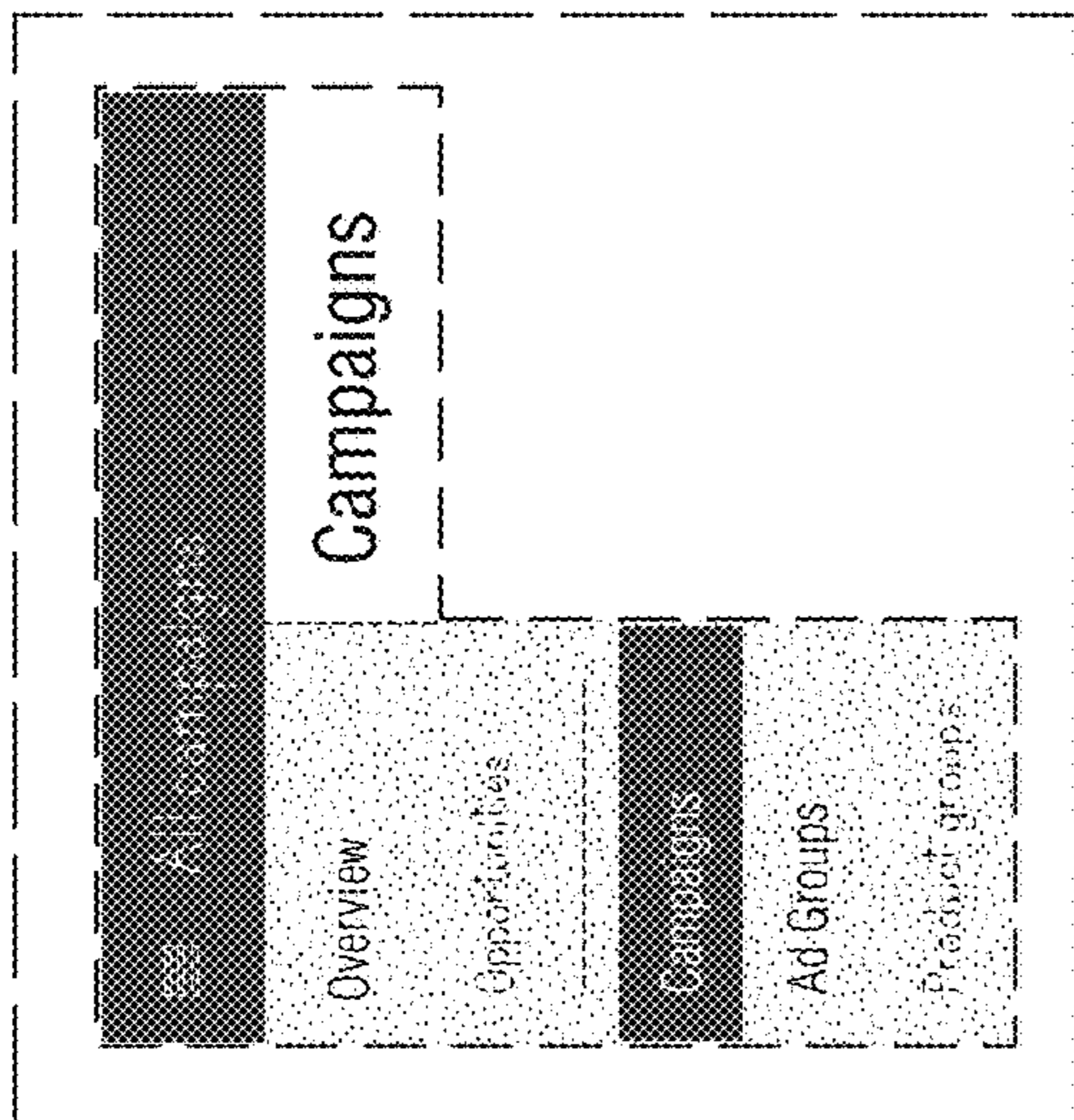

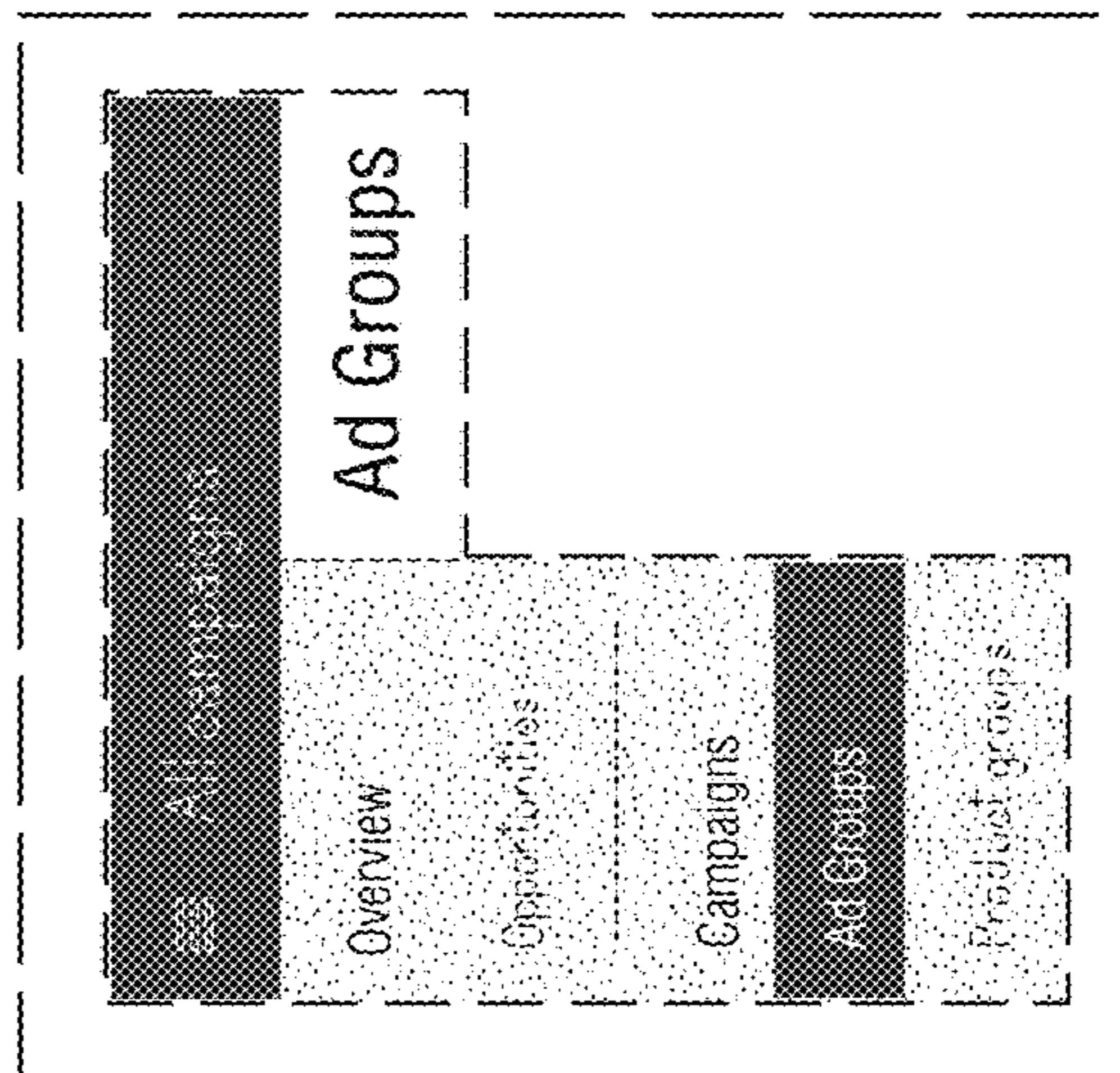

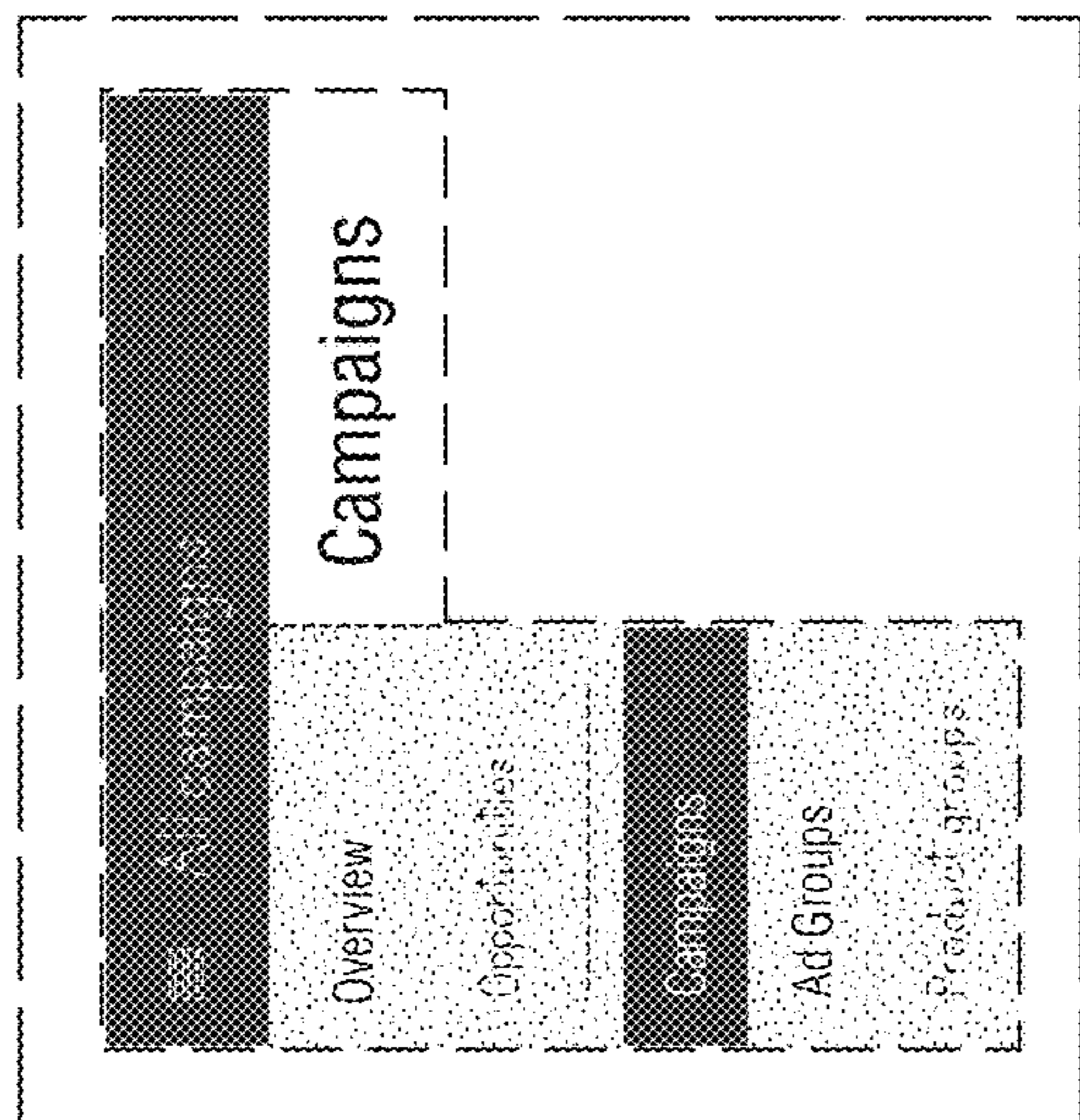

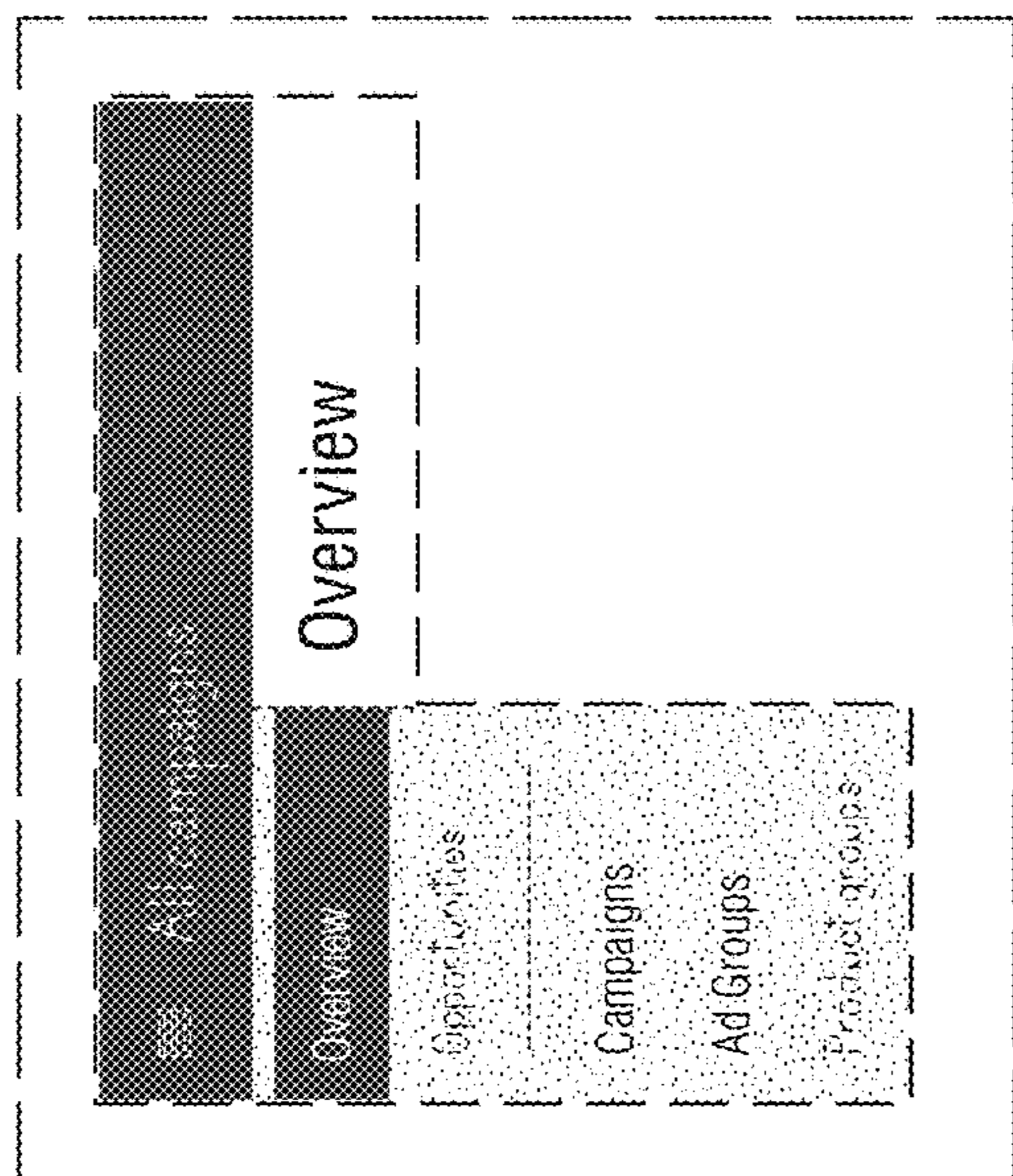

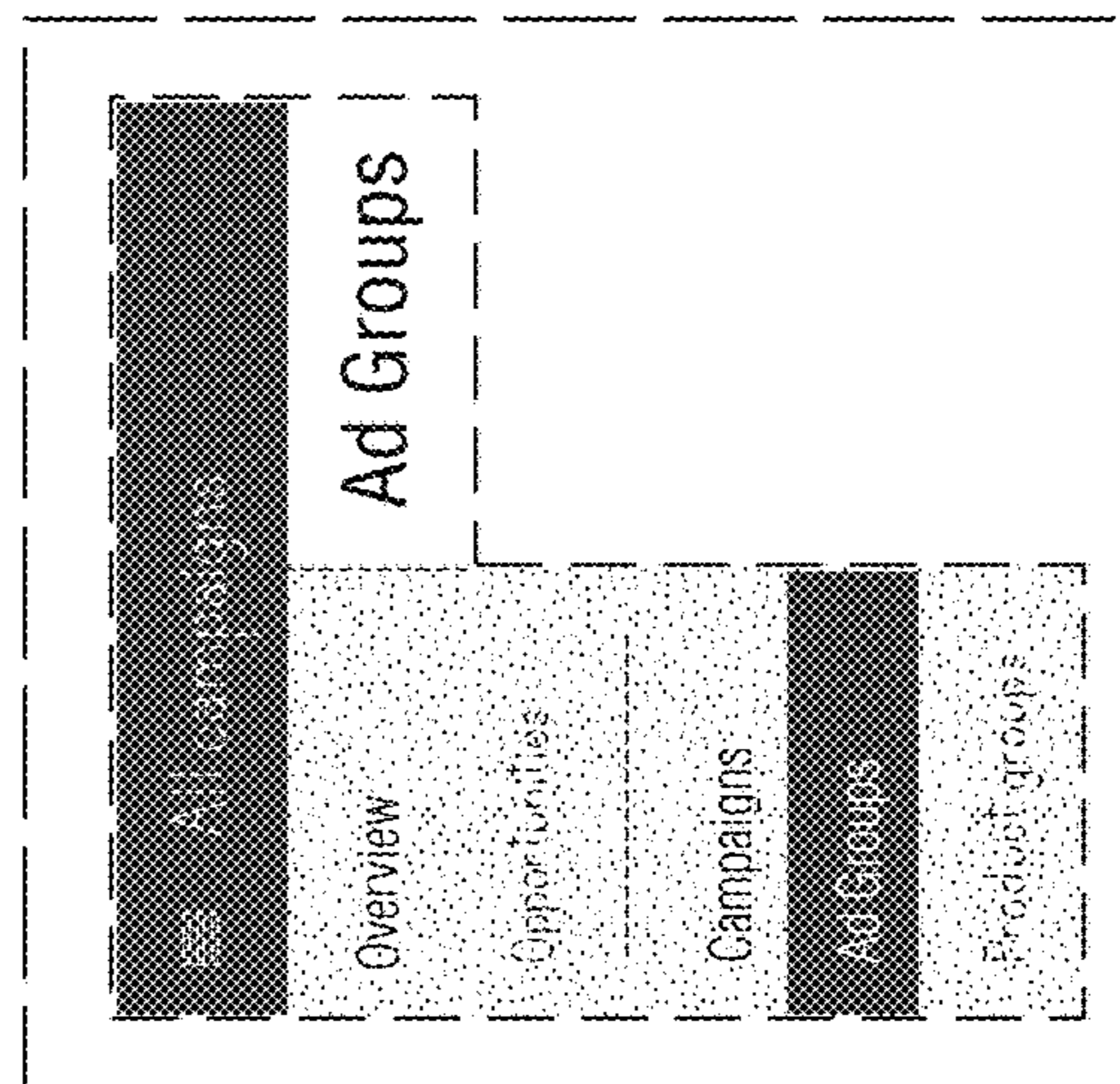

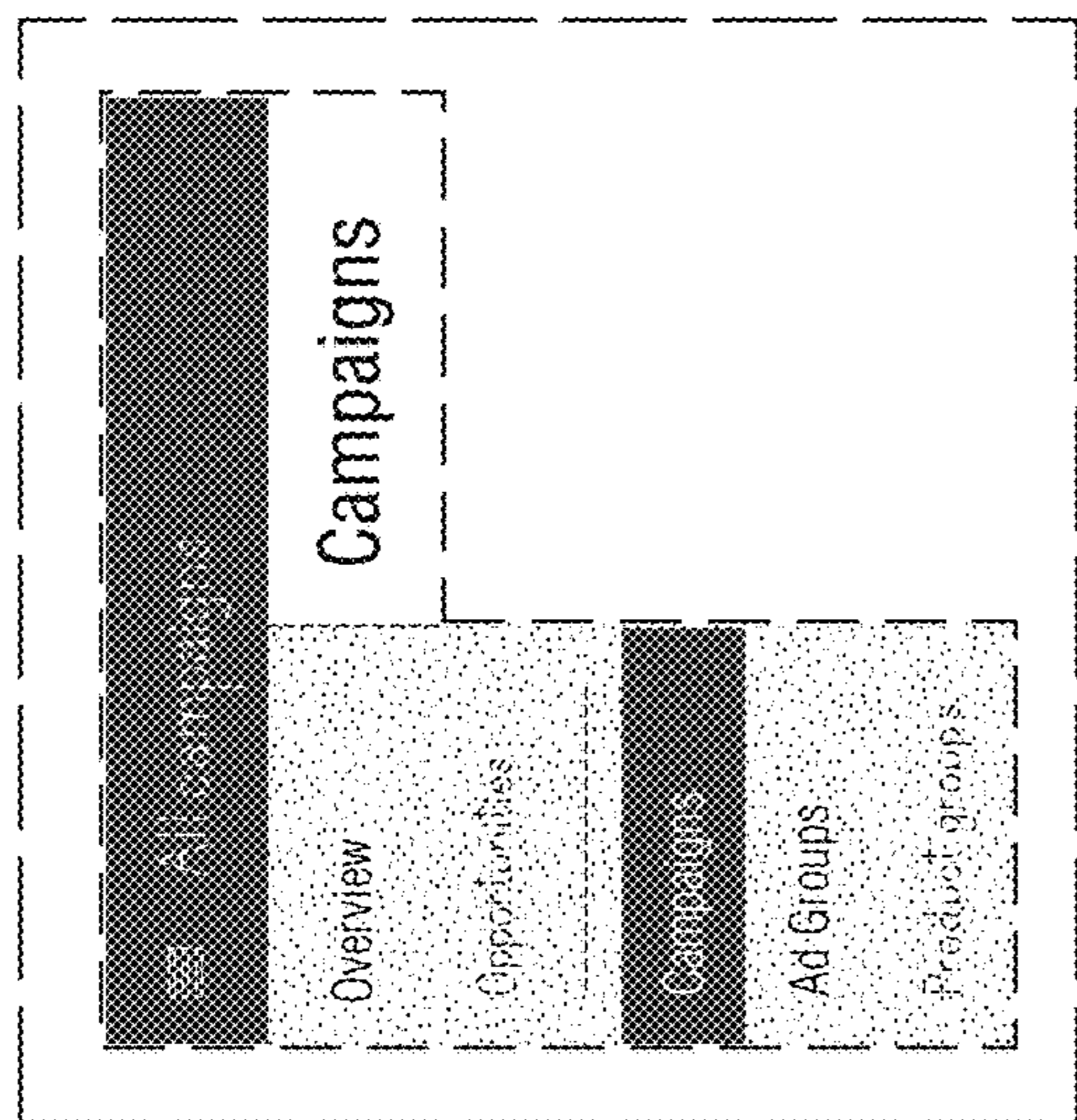

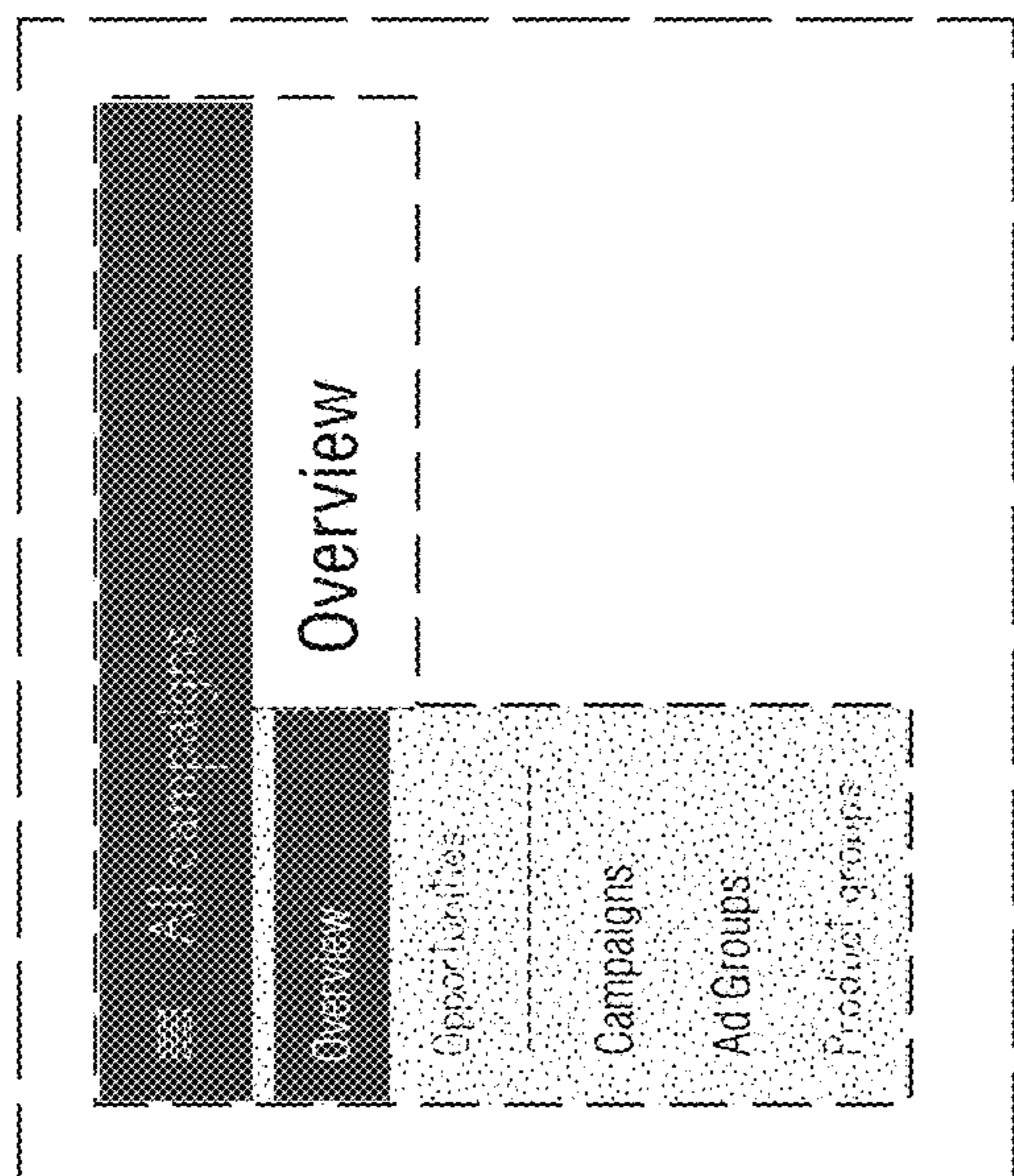

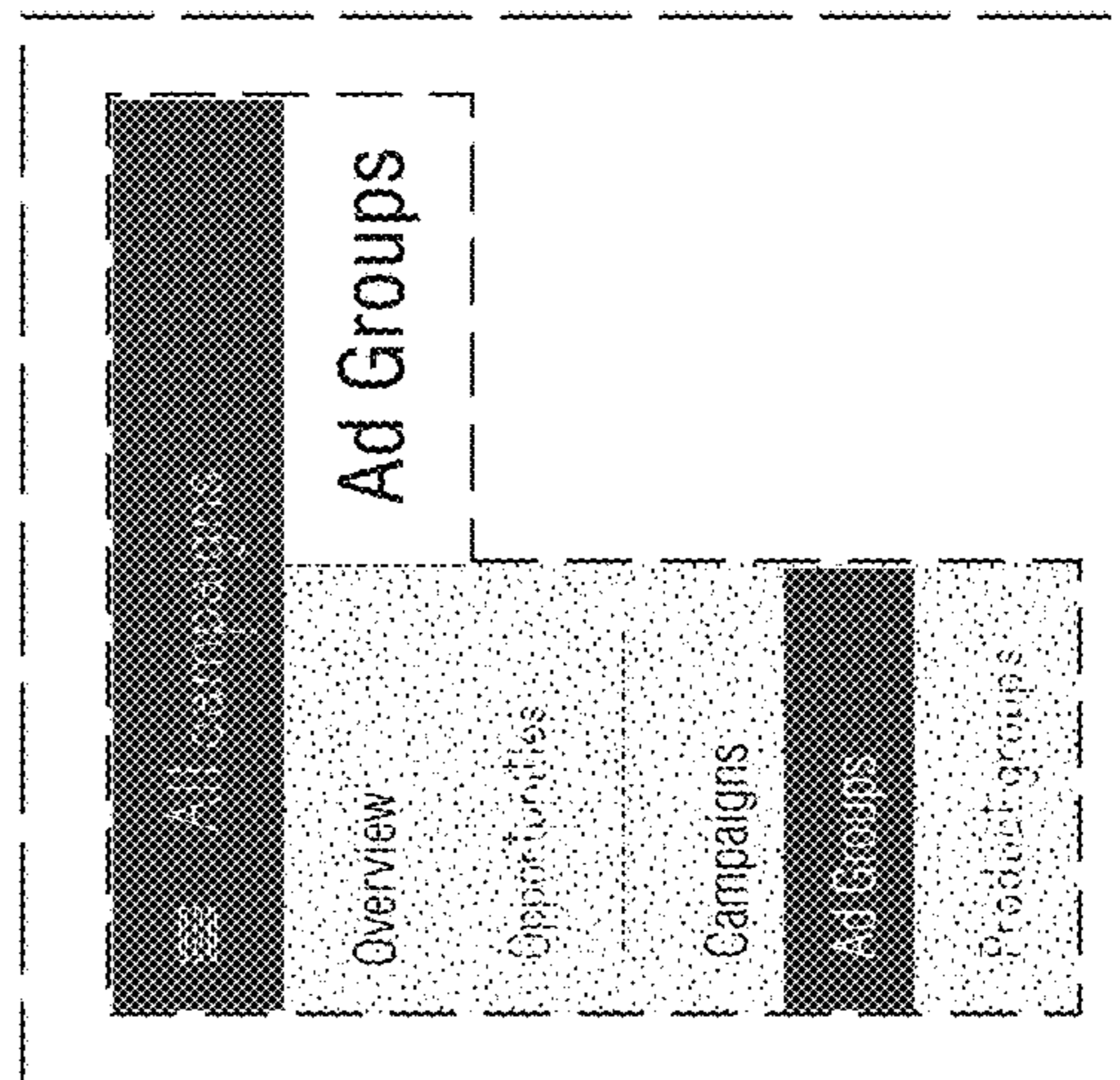

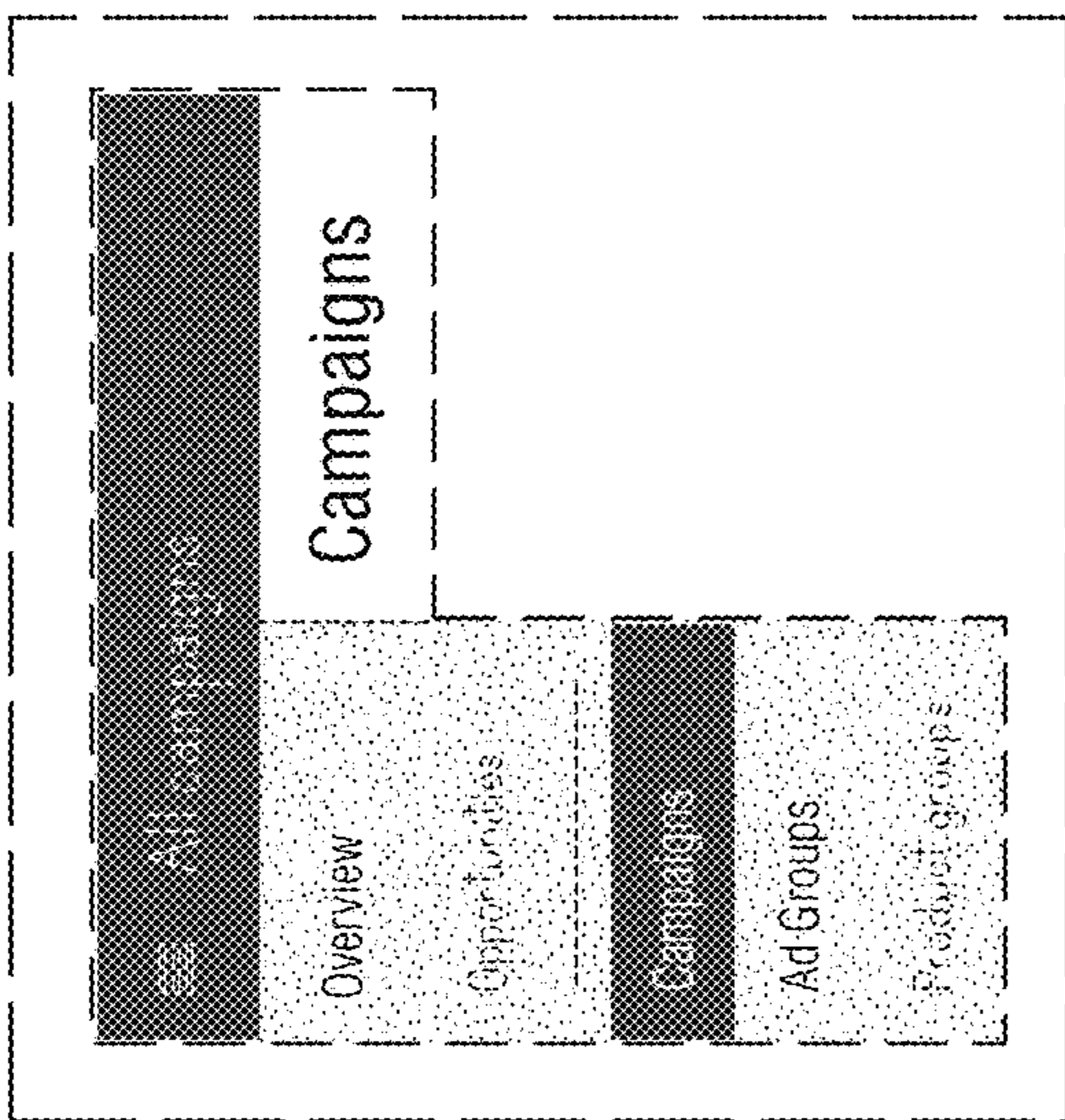

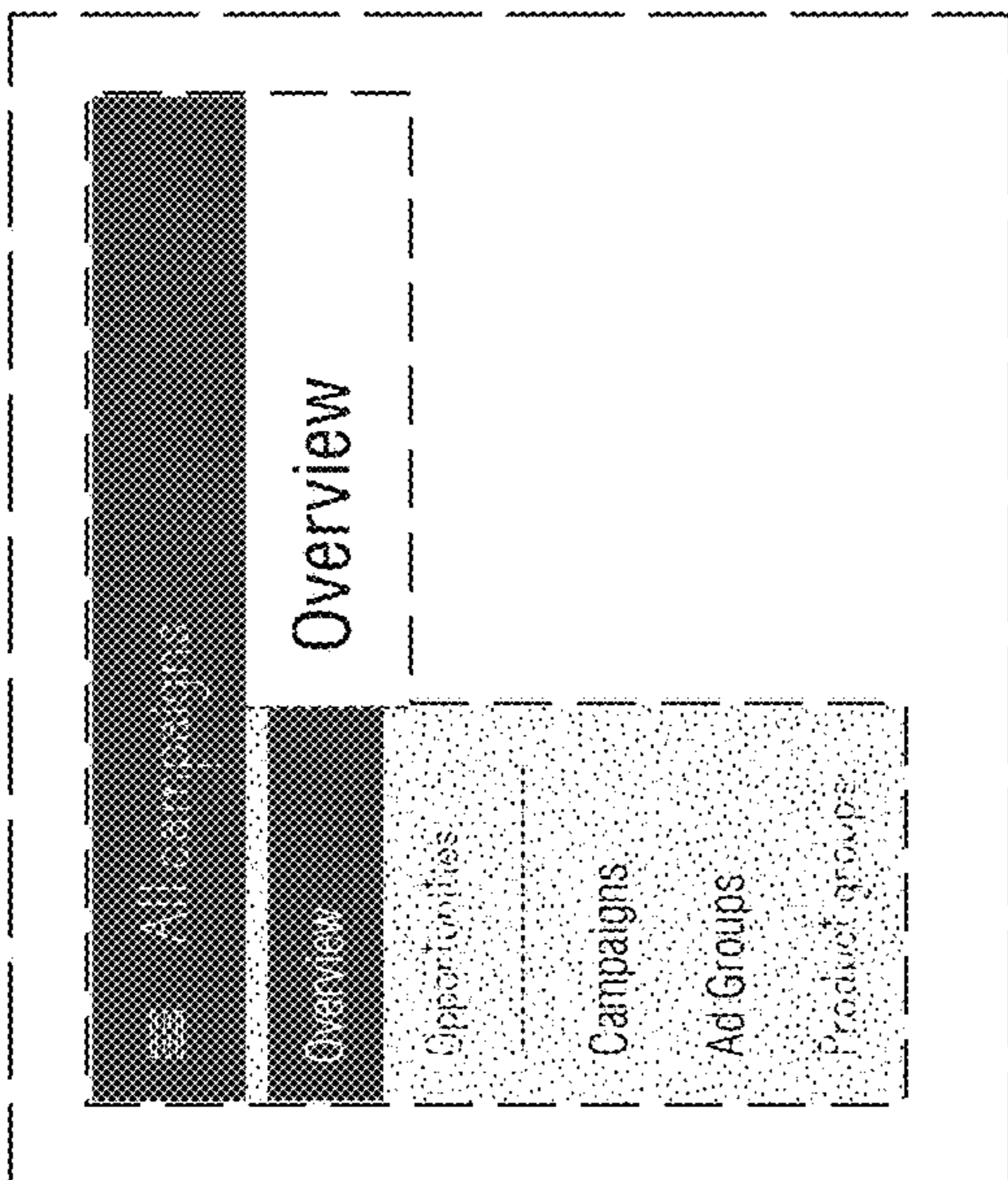

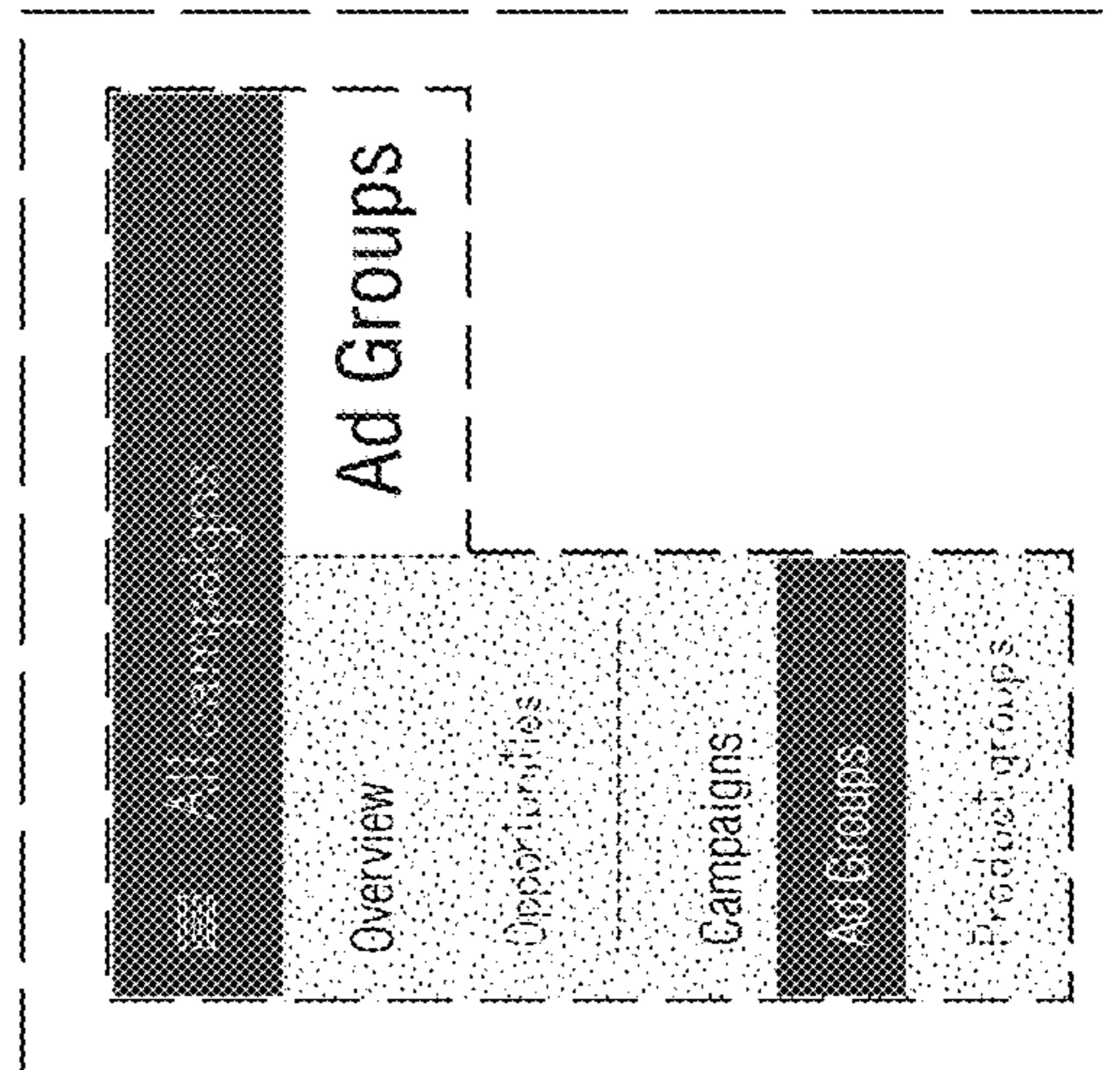
