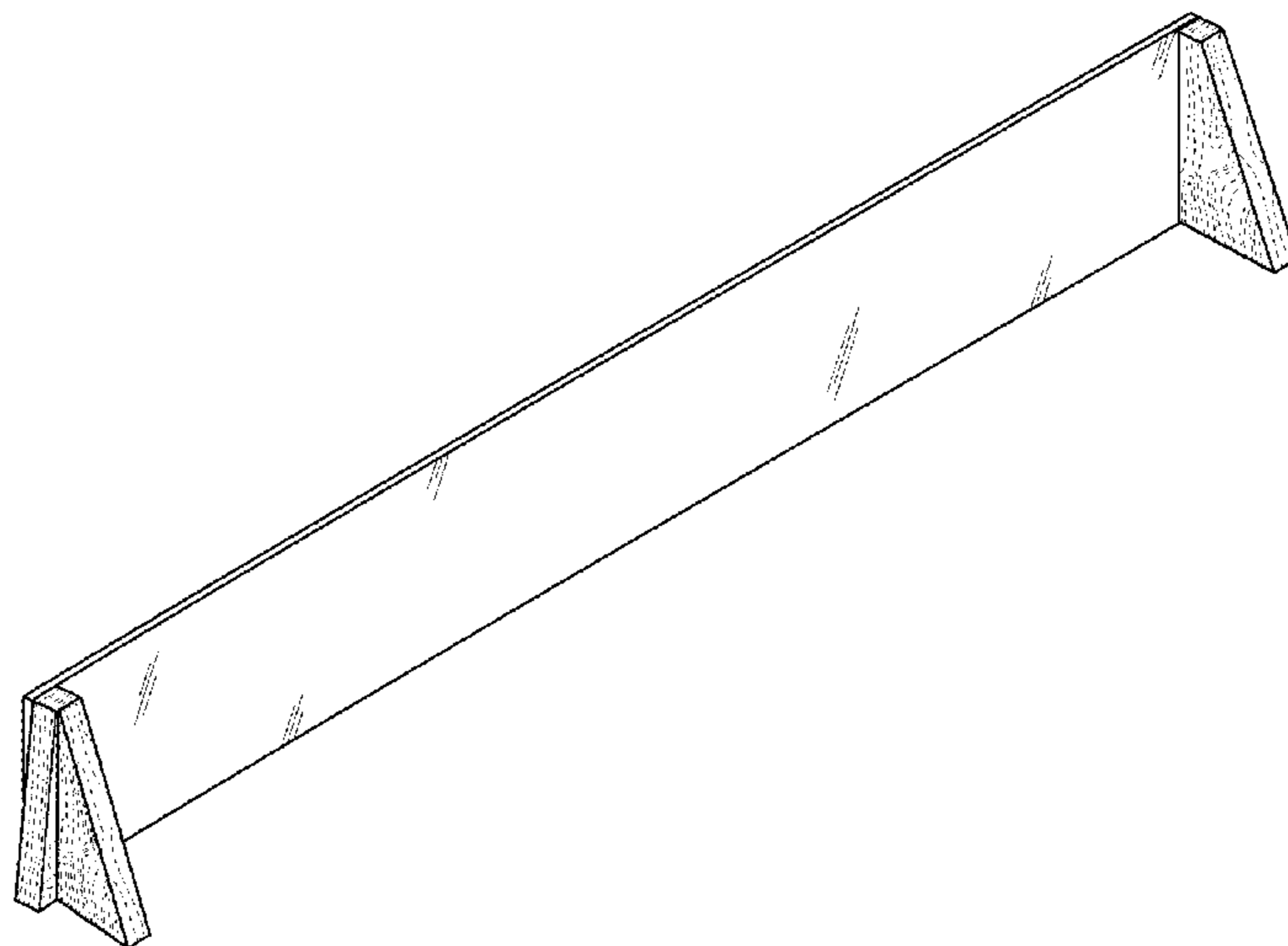
(57) **CLAIM**

The ornamental design for a music rest, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a music rest, shown with unclaimed environment;
 FIG. 2 is a left-side elevational view of the music rest in FIG. 1; and,
 FIG. 3 is a left perspective side view of the music rest in FIG. 1, the right side being a mirror image thereof.
 The broken line piano shown in FIG. 1 depicts unclaimed environment. The broken lines that appear on the music rest in FIGS. 1-3 illustrate unclaimed portions of the design. The oblique shading on the central portion of the music rest is understood to represent a smooth, shiny surface.

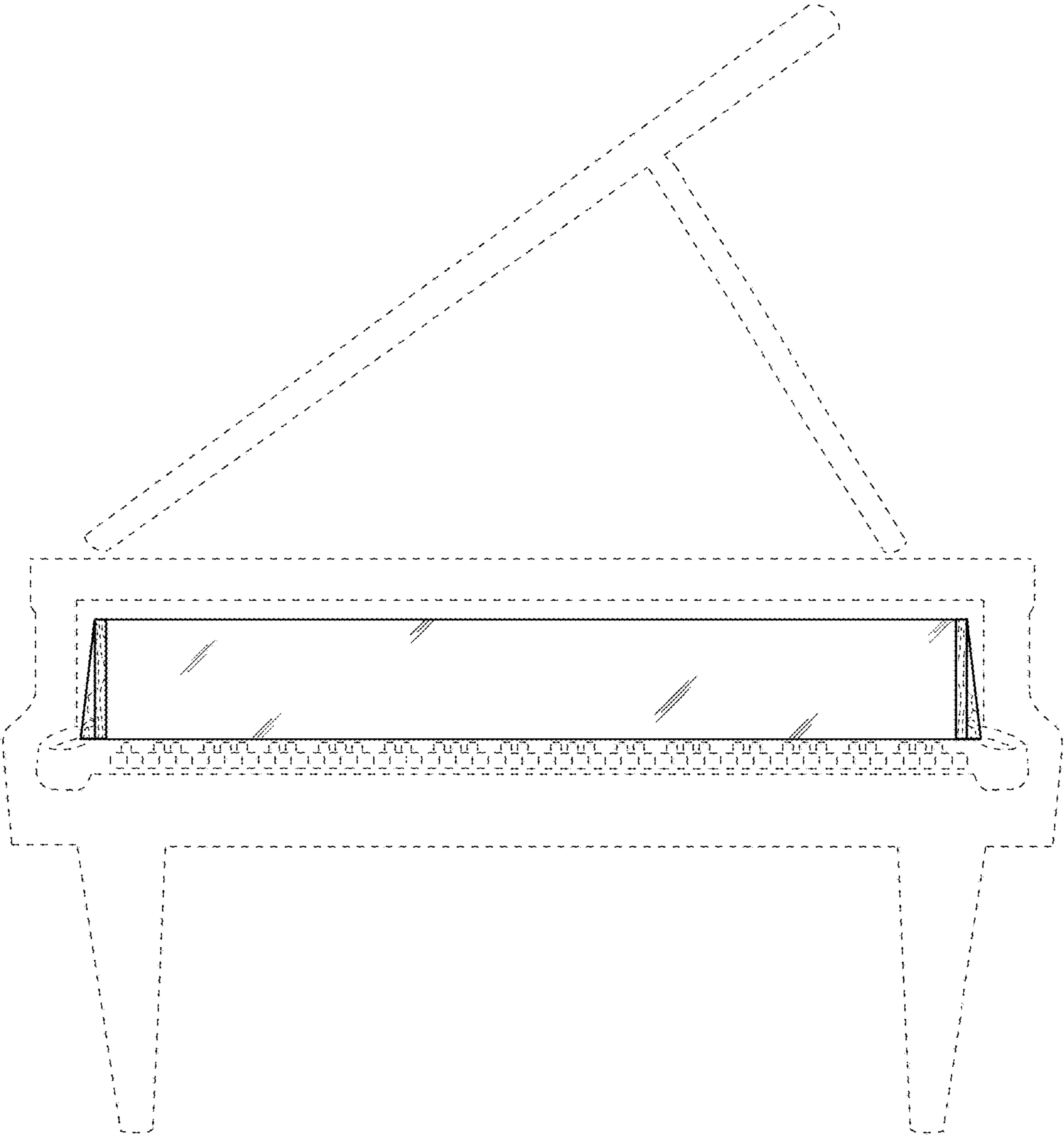

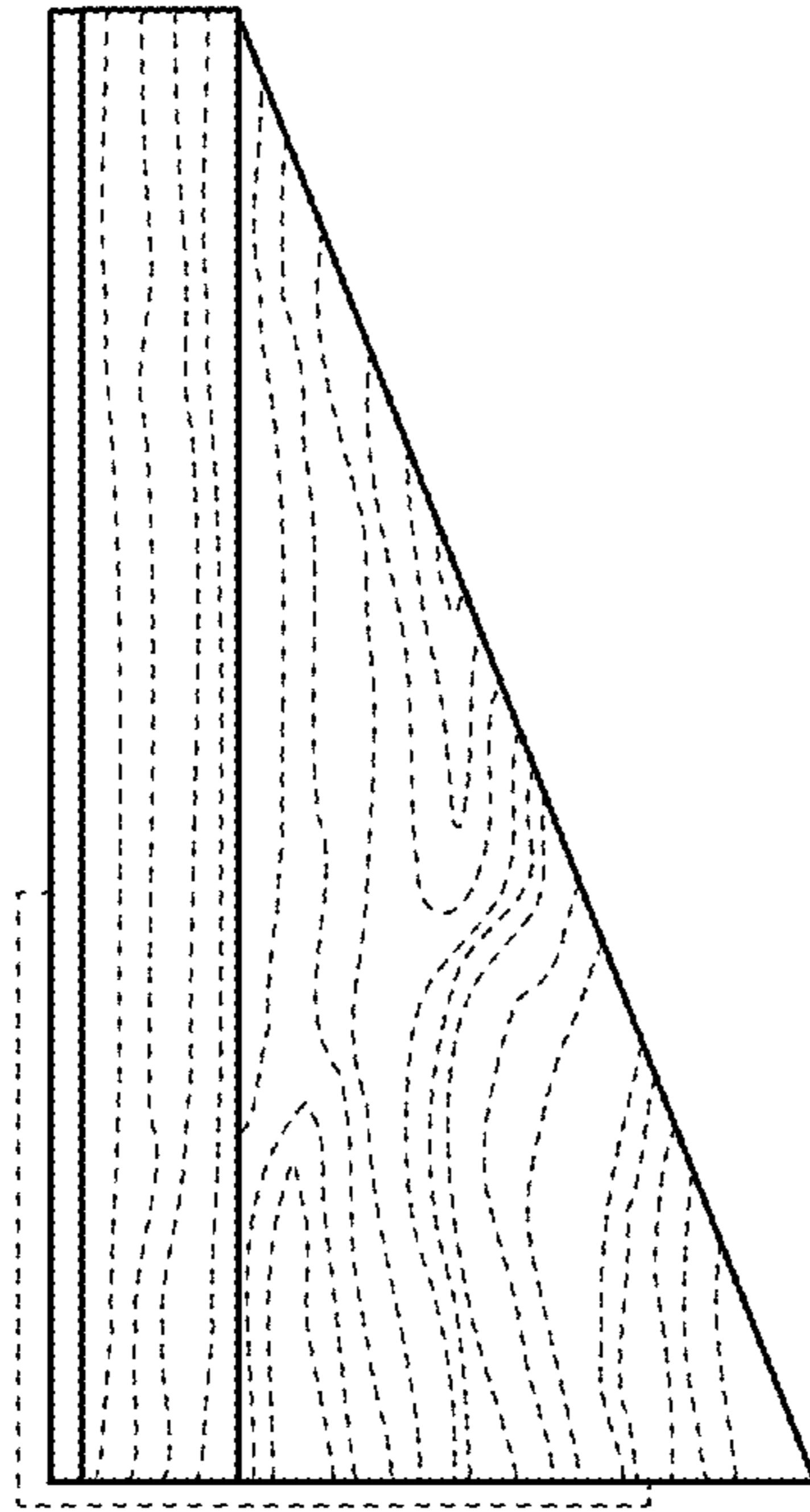

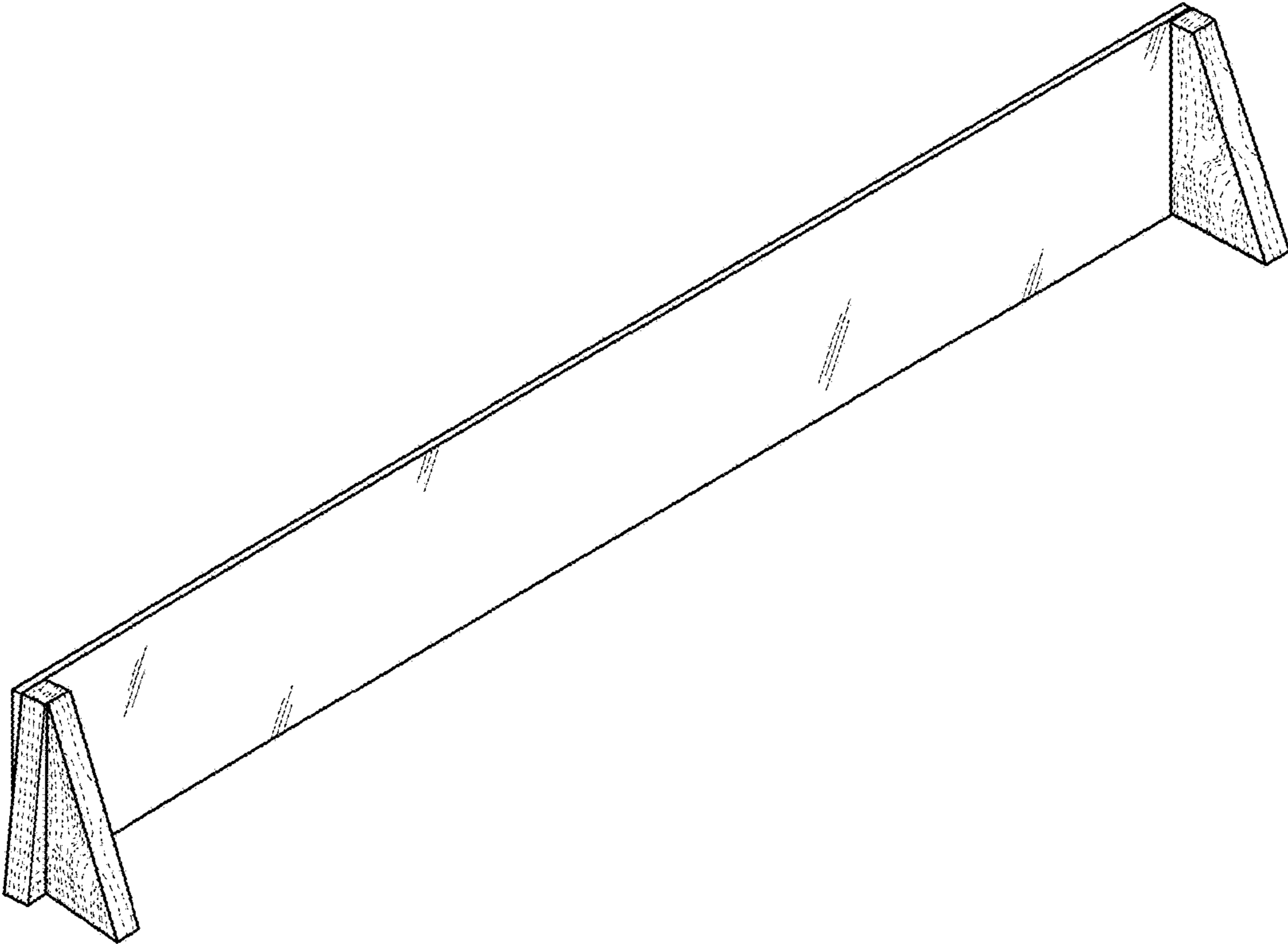
