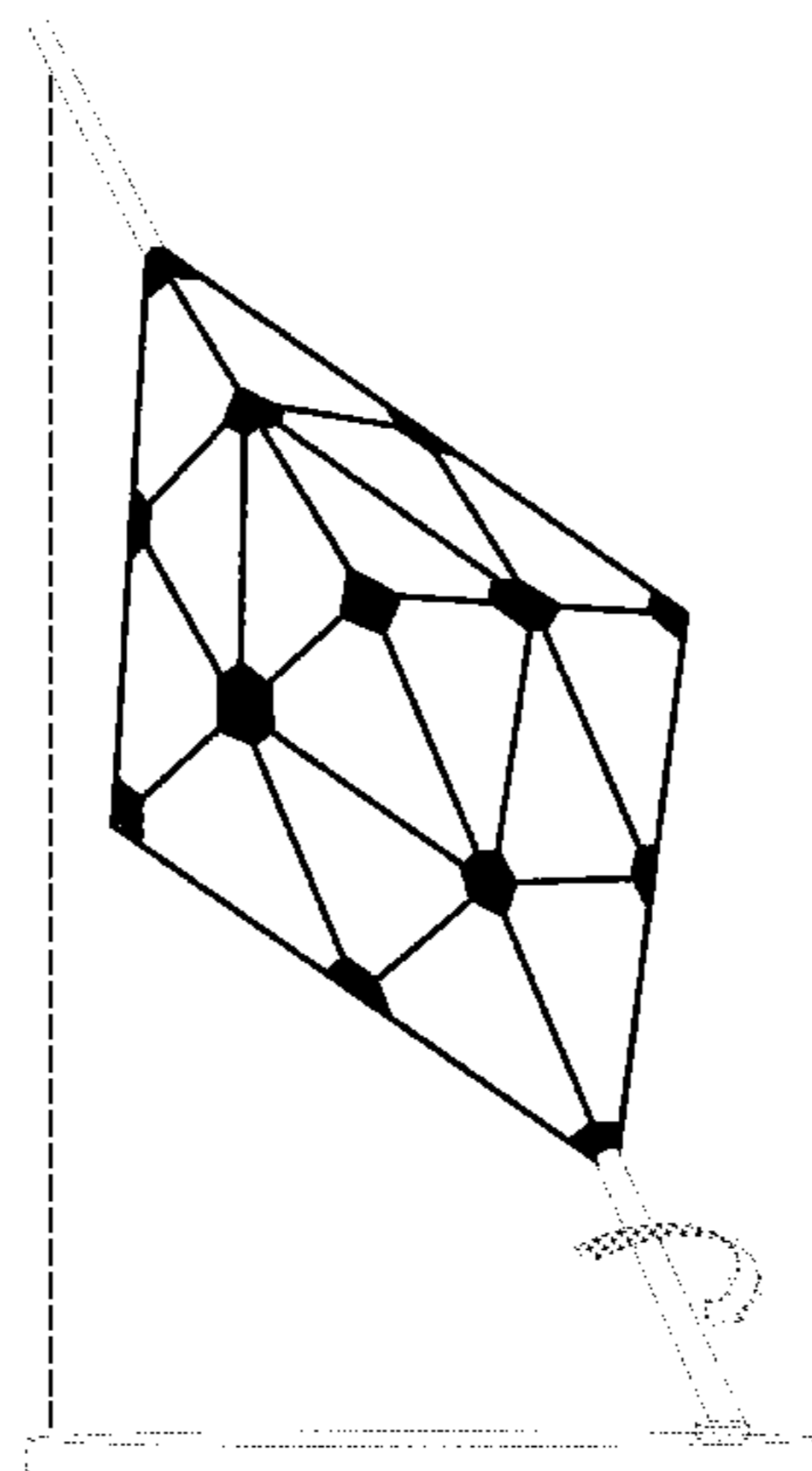
CLAIM

I claim the ornamental design for a three dimensional magnetic game board, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a three dimensional magnetic game board in accordance with my new design;
FIG. 2 is a left side elevation view thereof, the right side elevation being a mirror image;
FIG. 3 is a front elevation view thereof, the rear elevation being a mirror image; and,
FIG. 4 is an environmental perspective view thereof.
The broken line elements shown depict environment for illustrative purposes and form no part of the design claim.

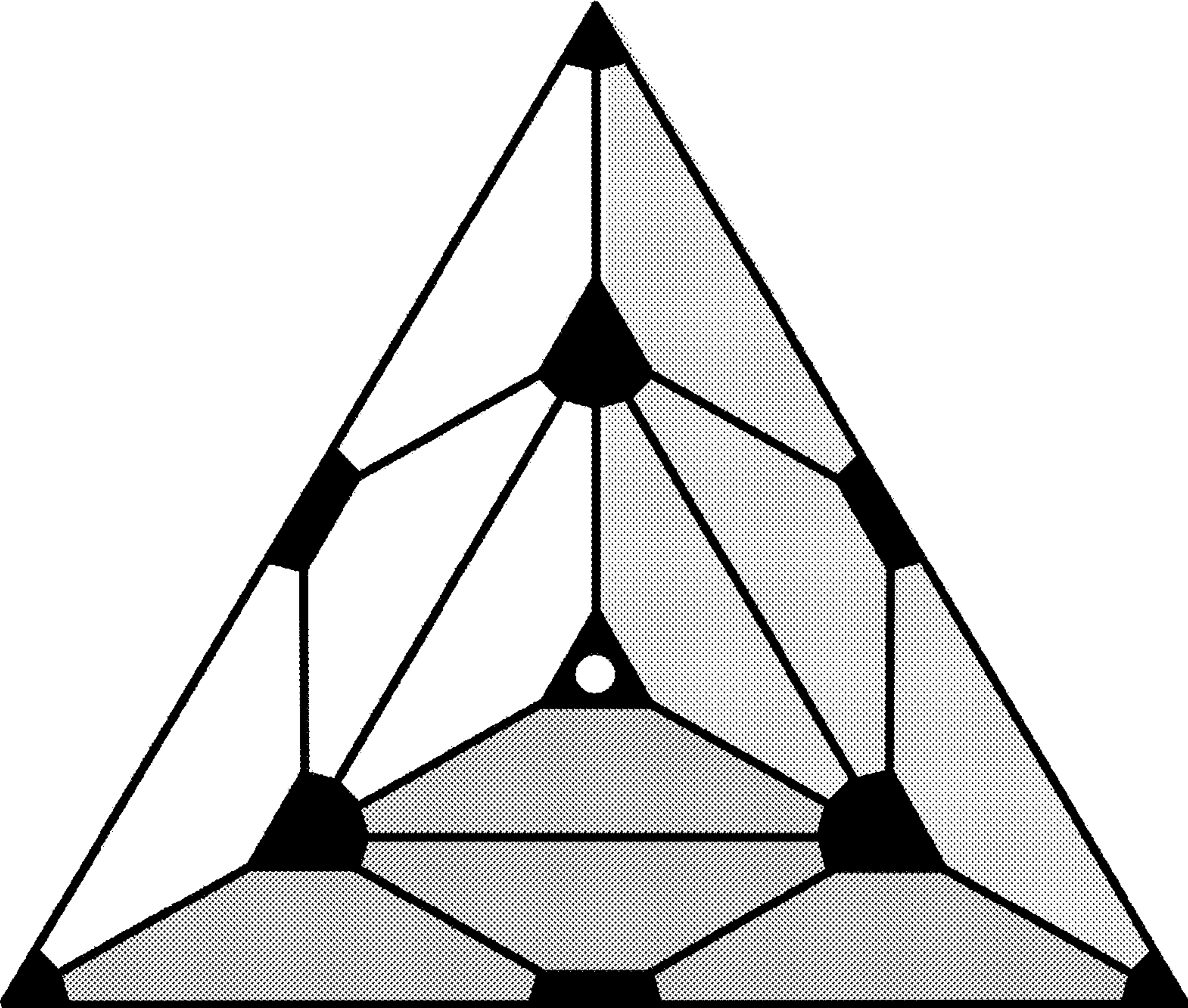

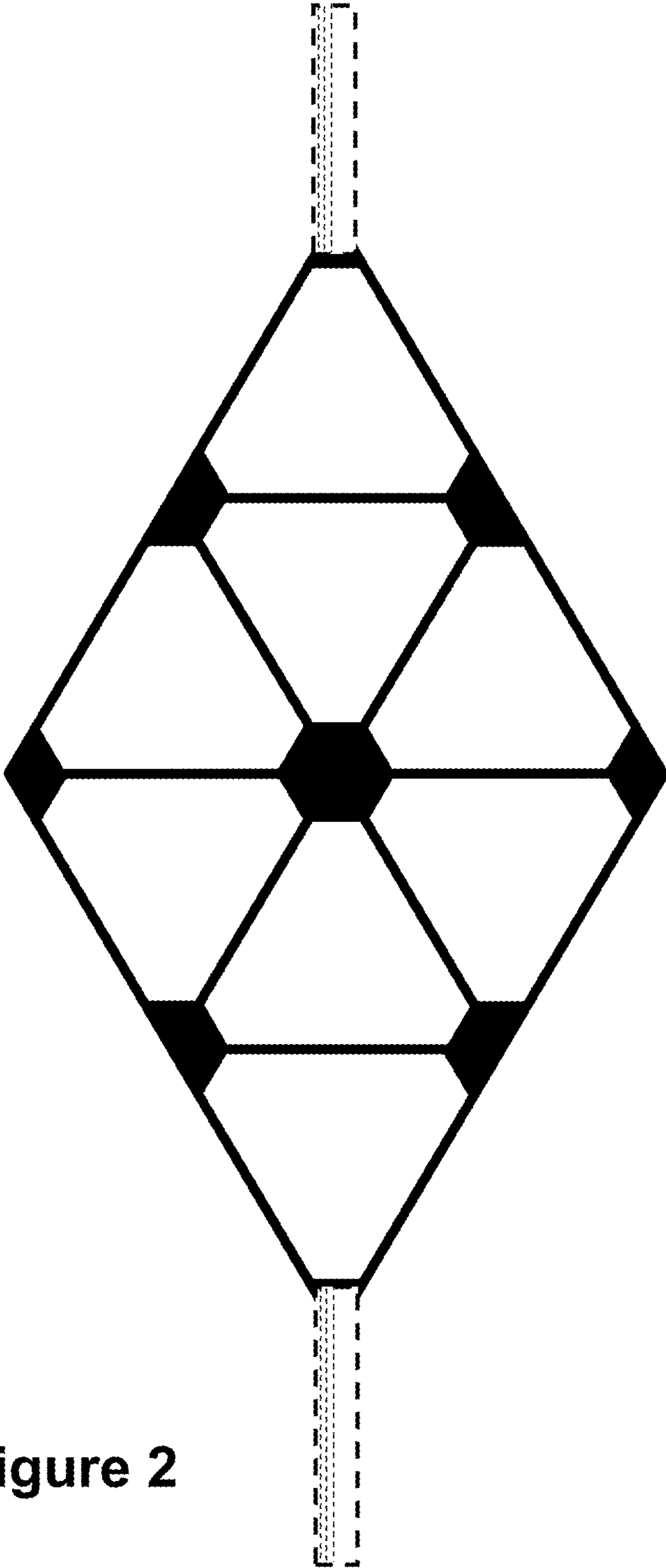

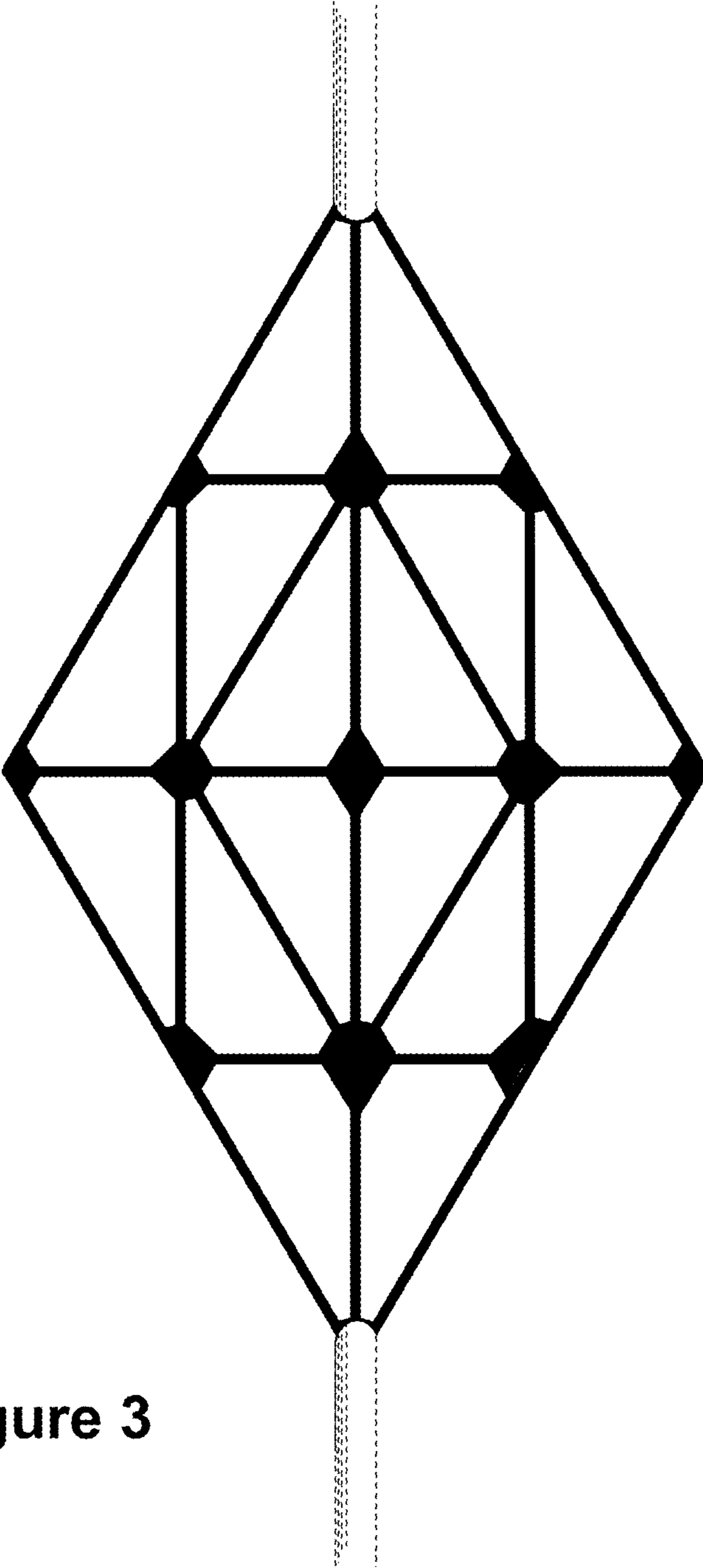

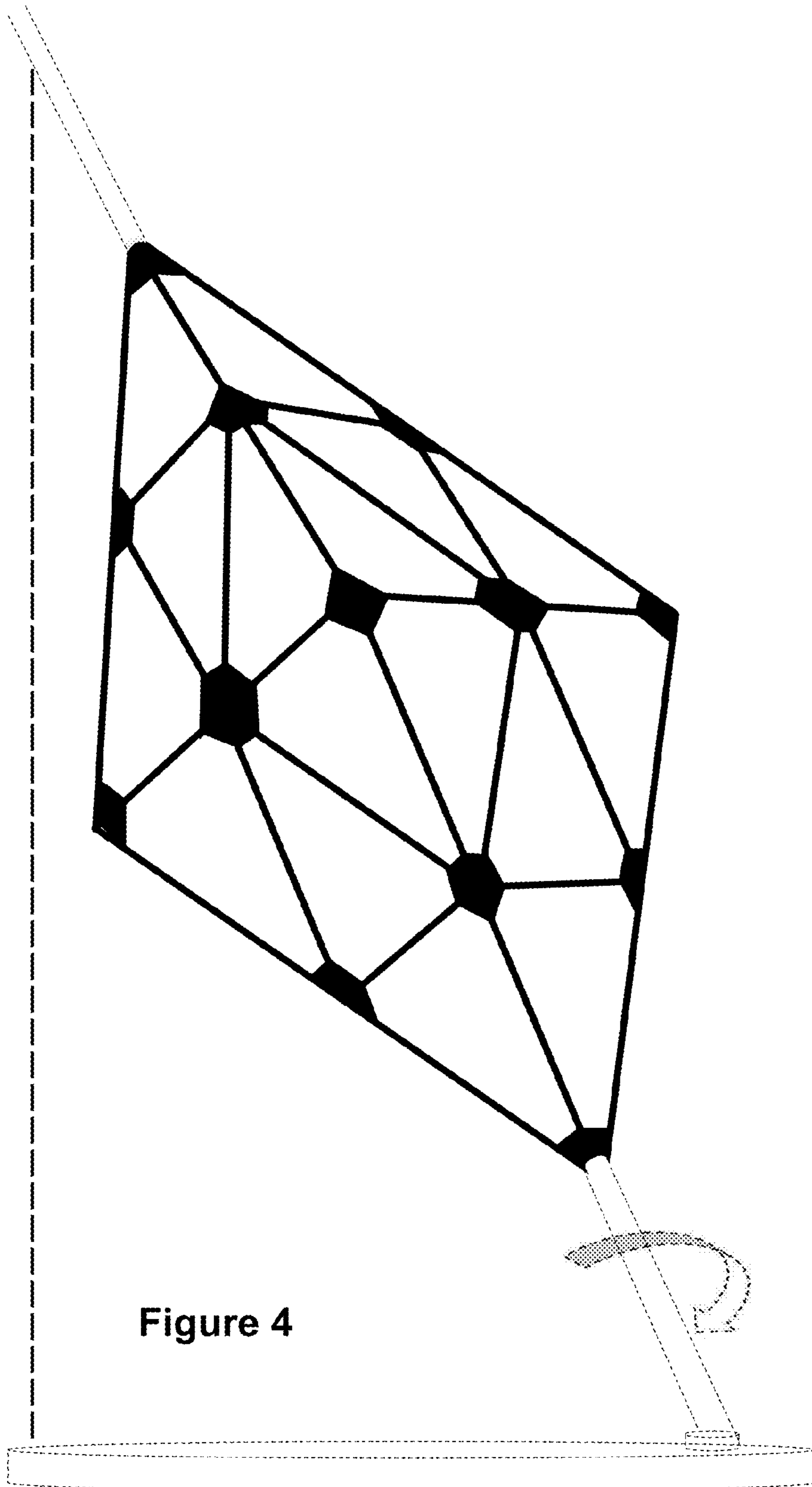
