(57) **CLAIM**

The ornamental design for an adjustable bench press machine, substantially as shown and described in the accompanying figures.

**DESCRIPTION**

FIG. 1 is a perspective view of an adjustable bench press machine in accordance with the present design.

FIG. 2 is a front view of the adjustable bench press machine of FIG. 1.

FIG. 3 is a rear view thereof.

FIG. 4 is a top view thereof.

FIG. 5 is a bottom view thereof.

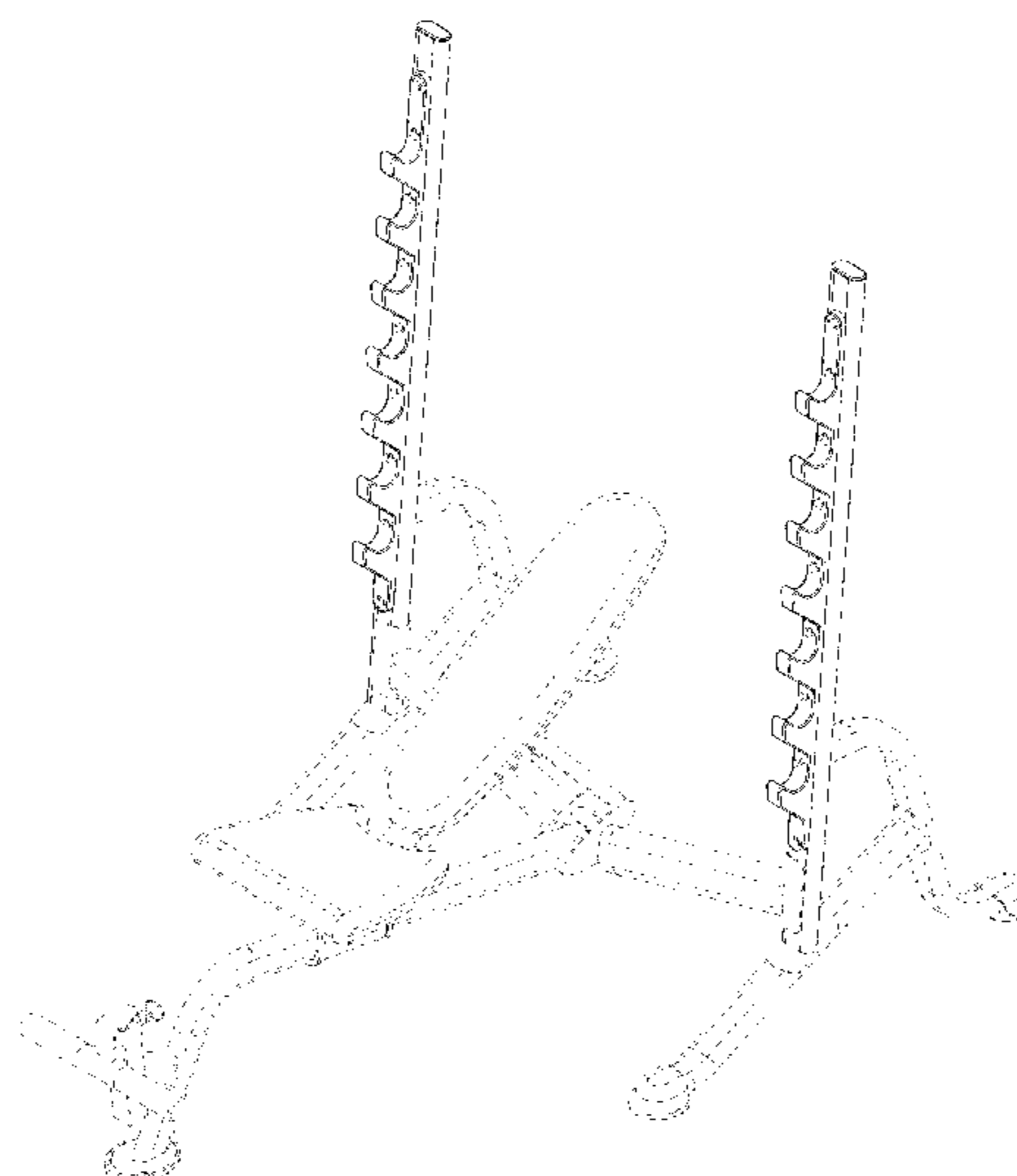
FIG. 6 is a left side view thereof; and,

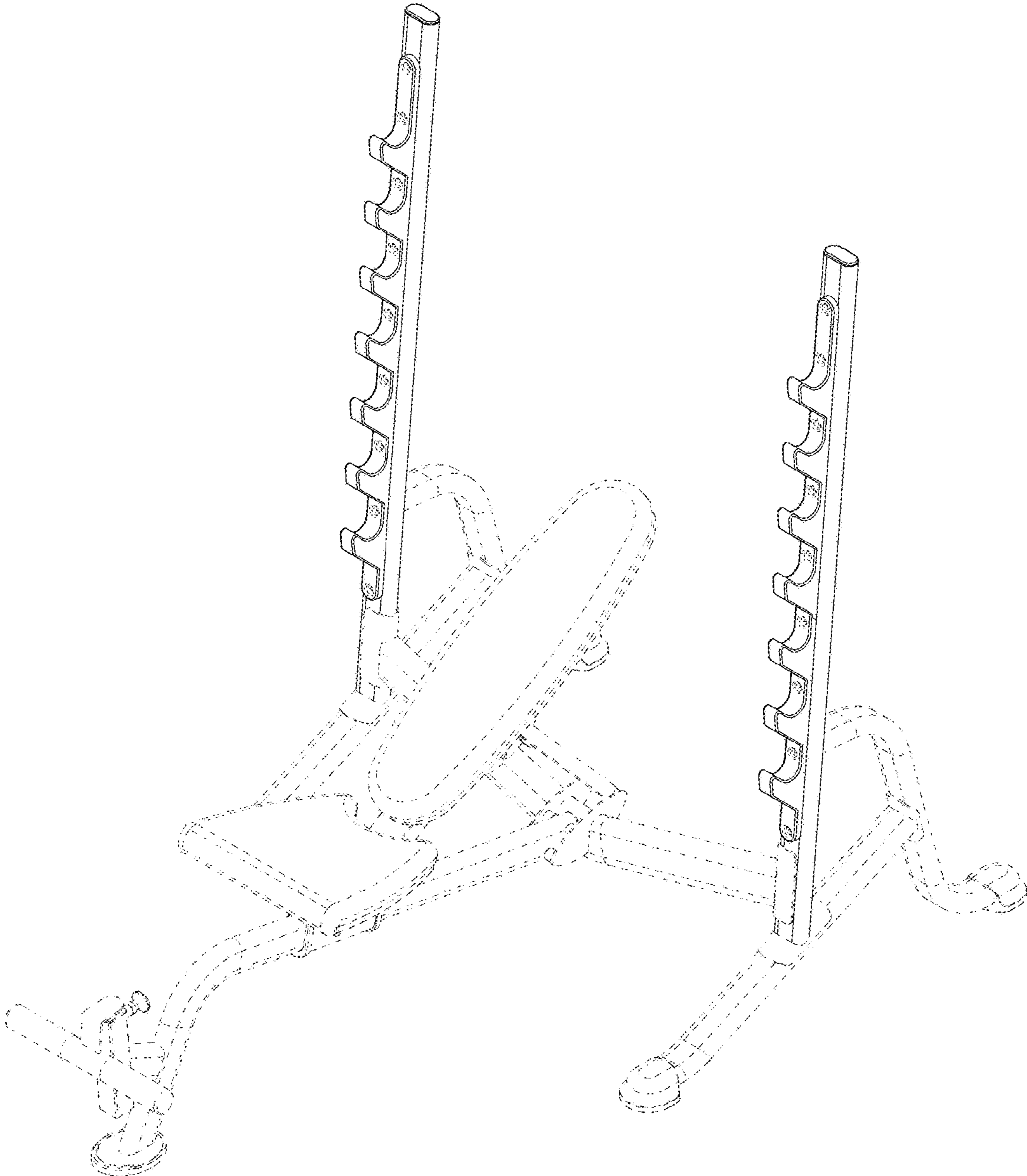

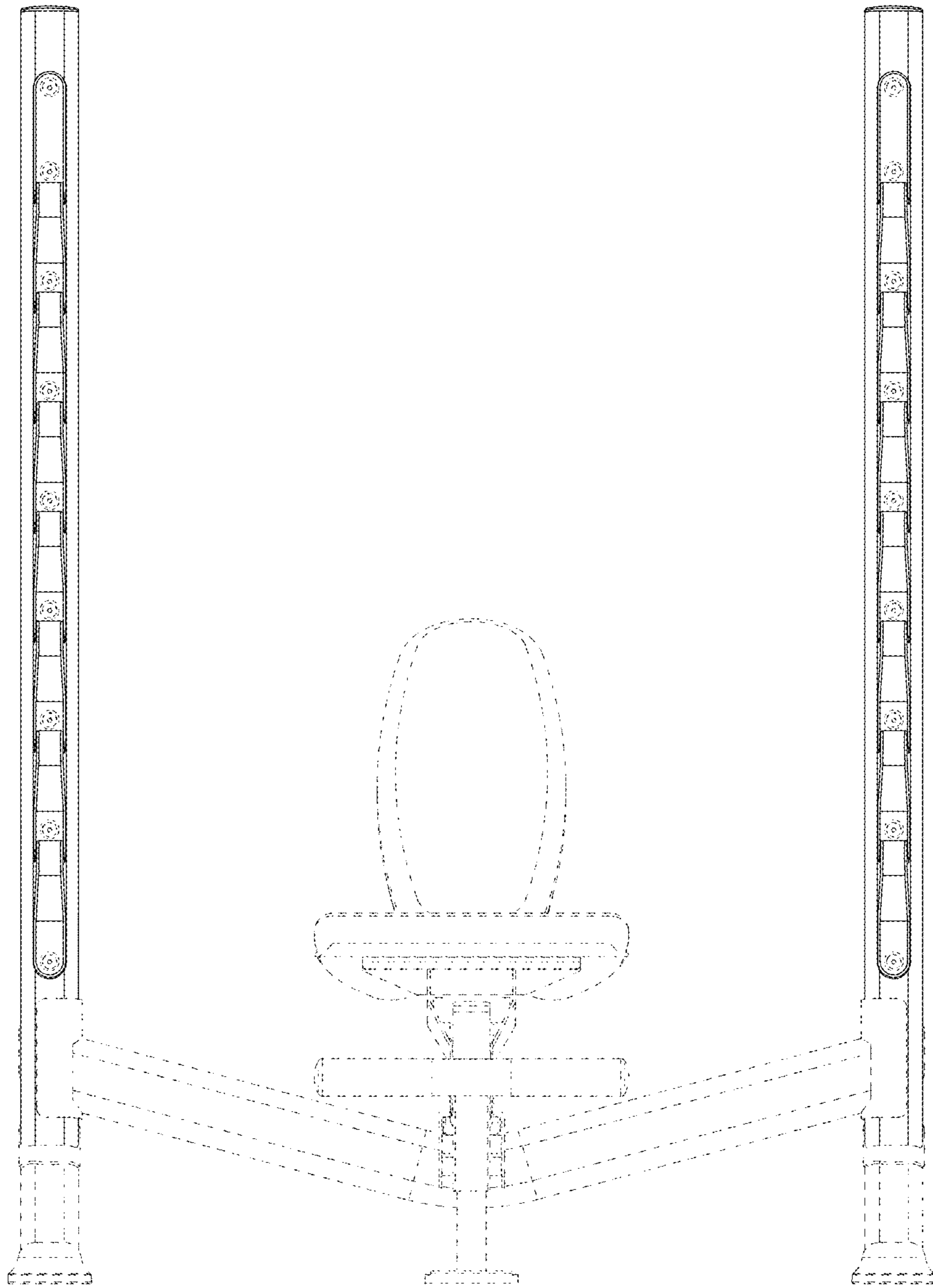

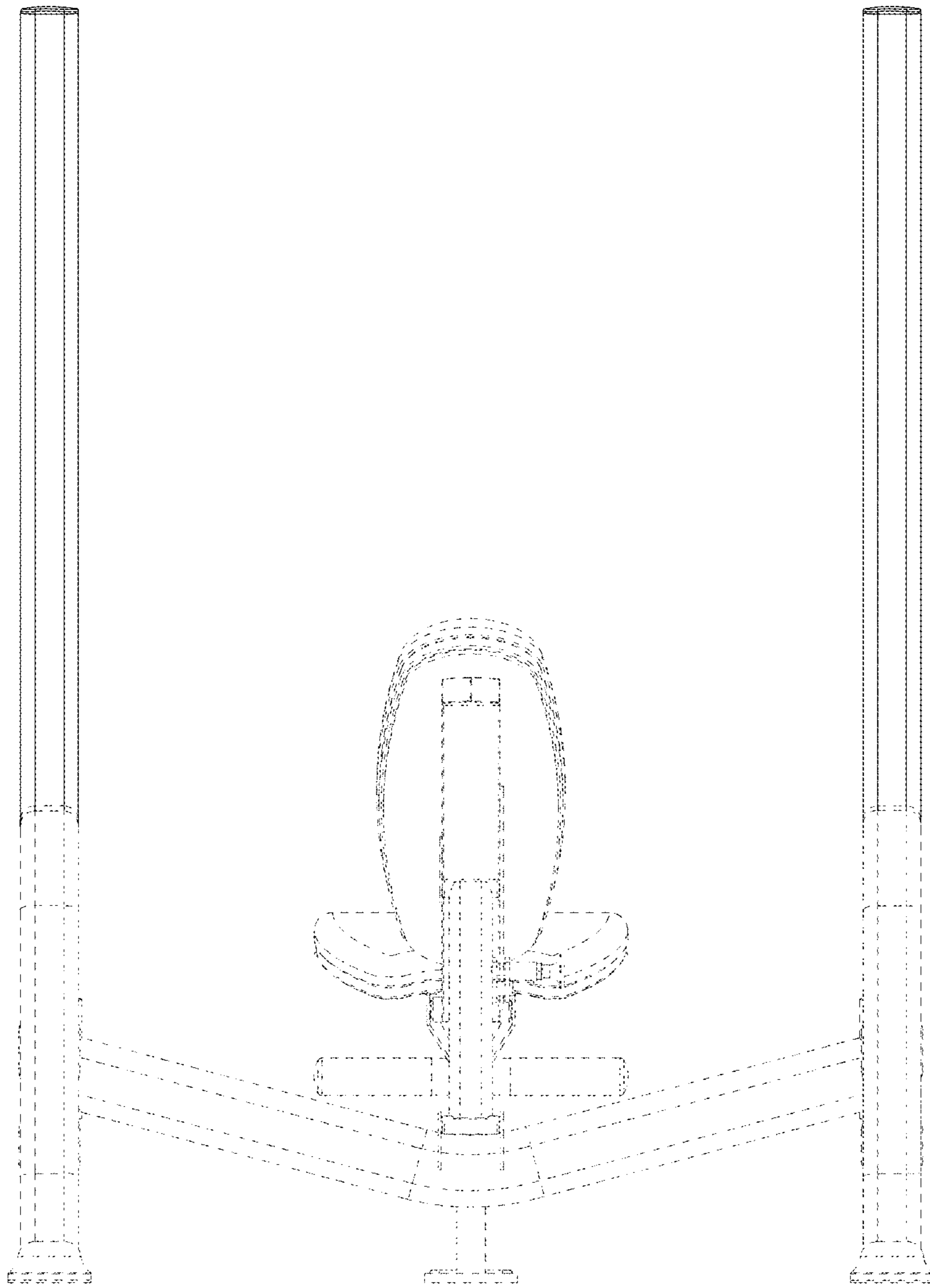

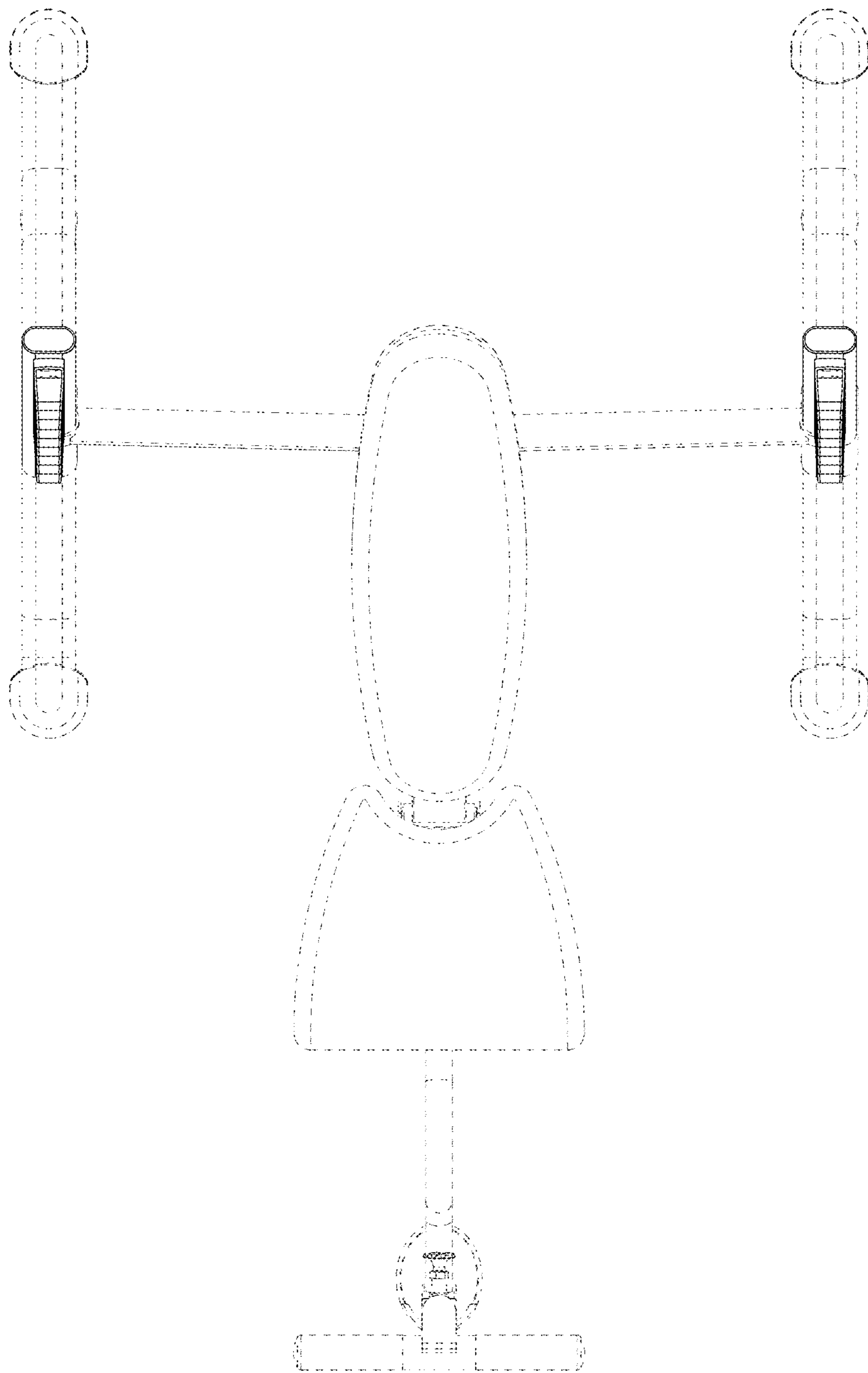

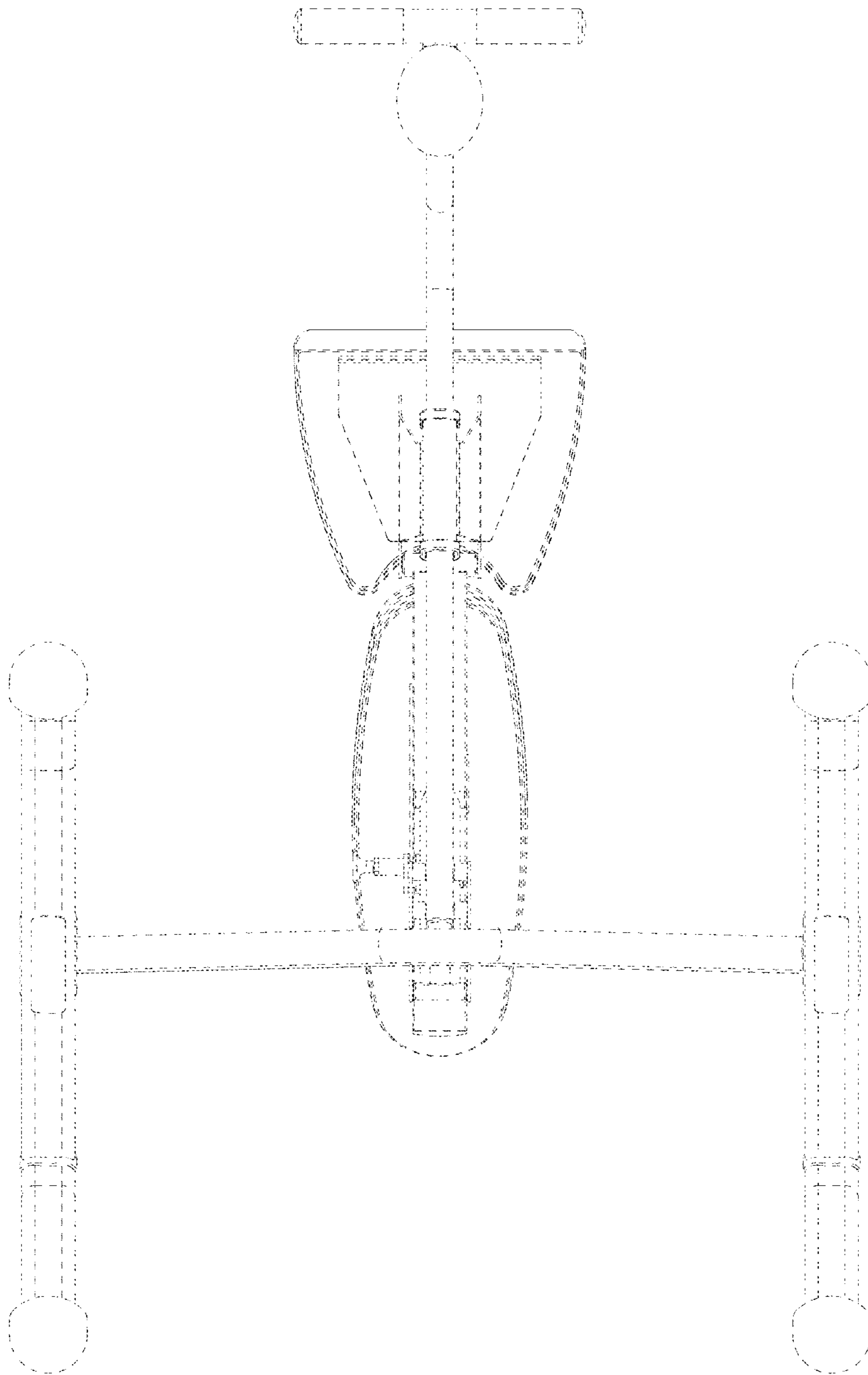

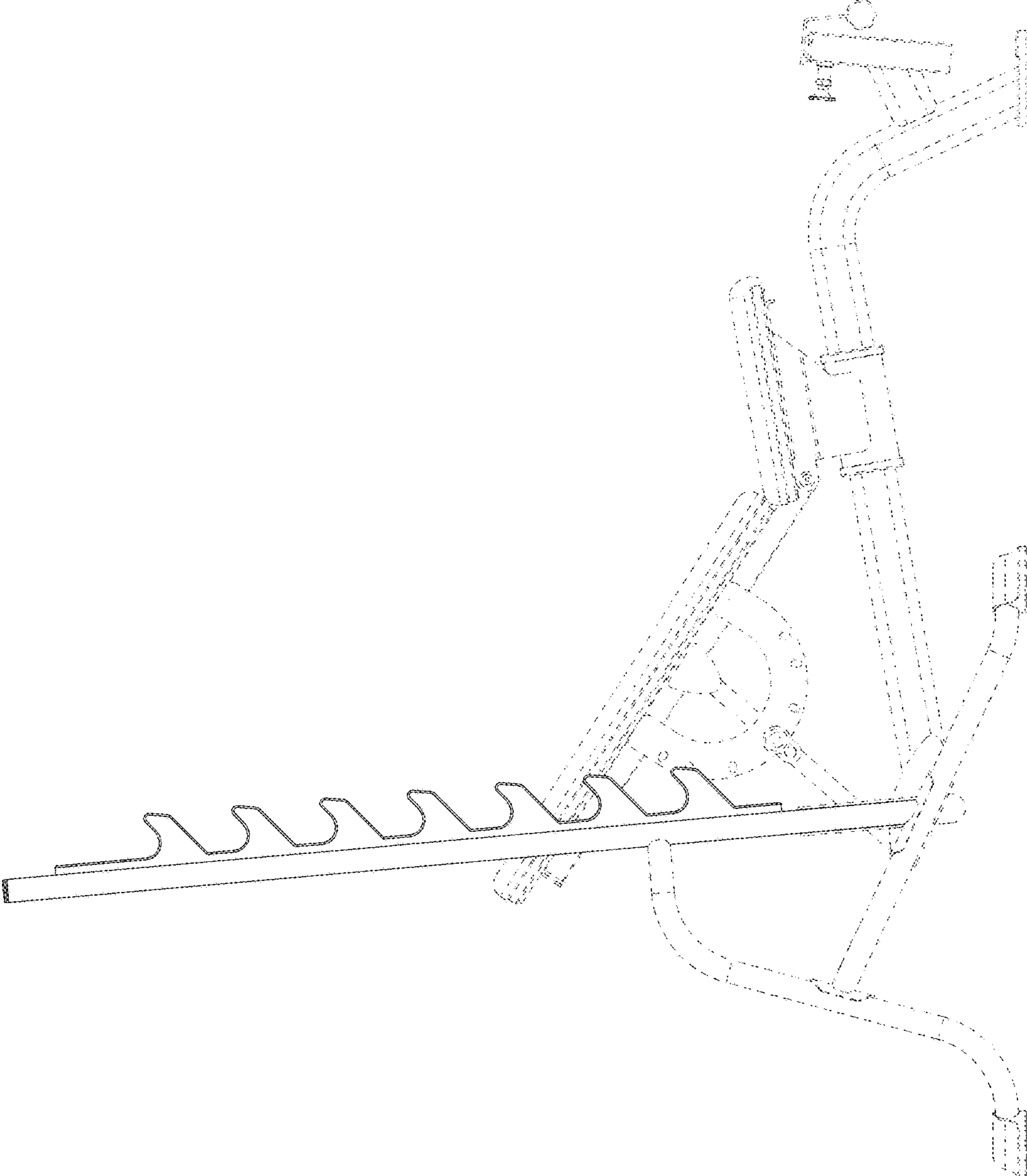

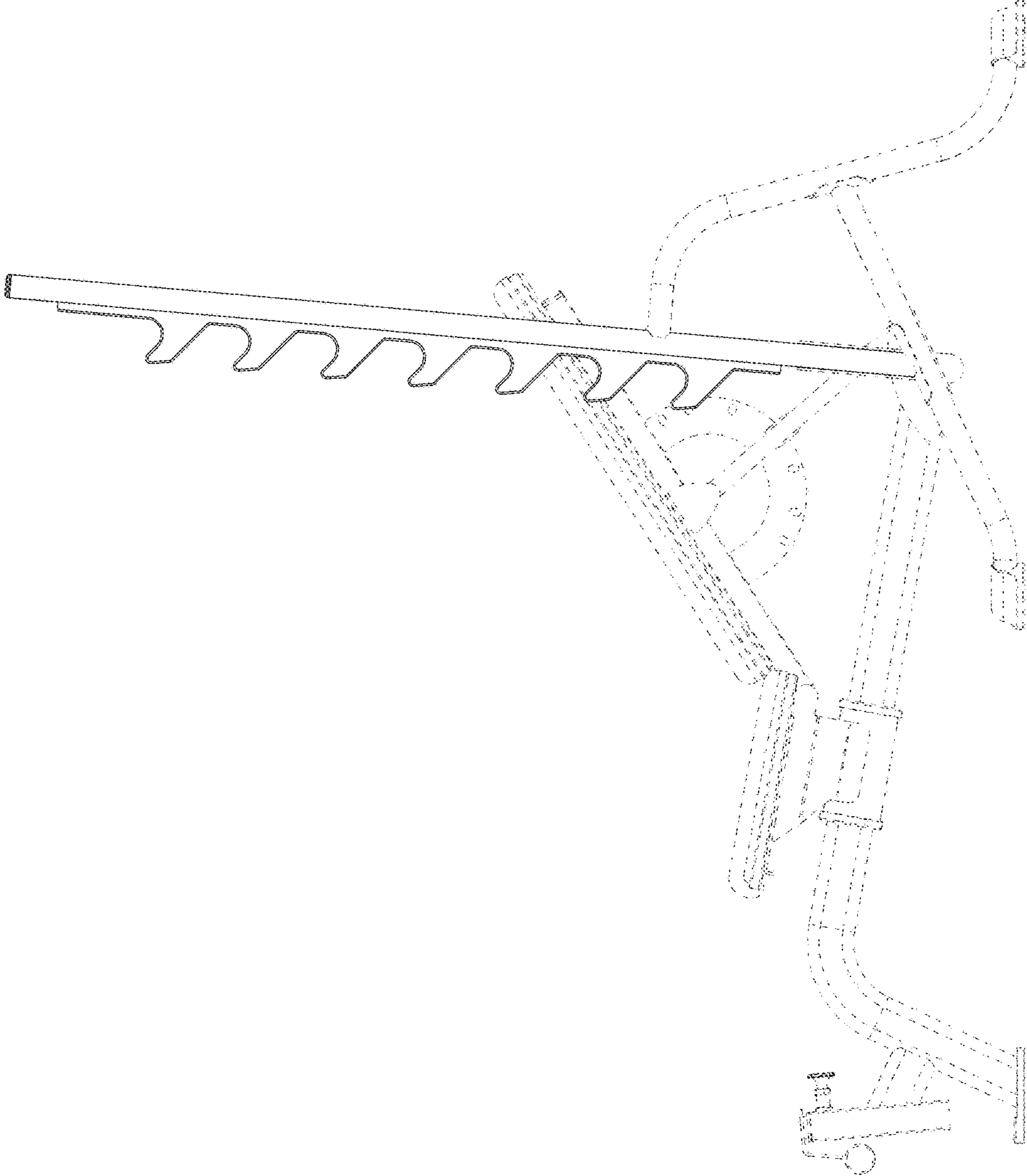
