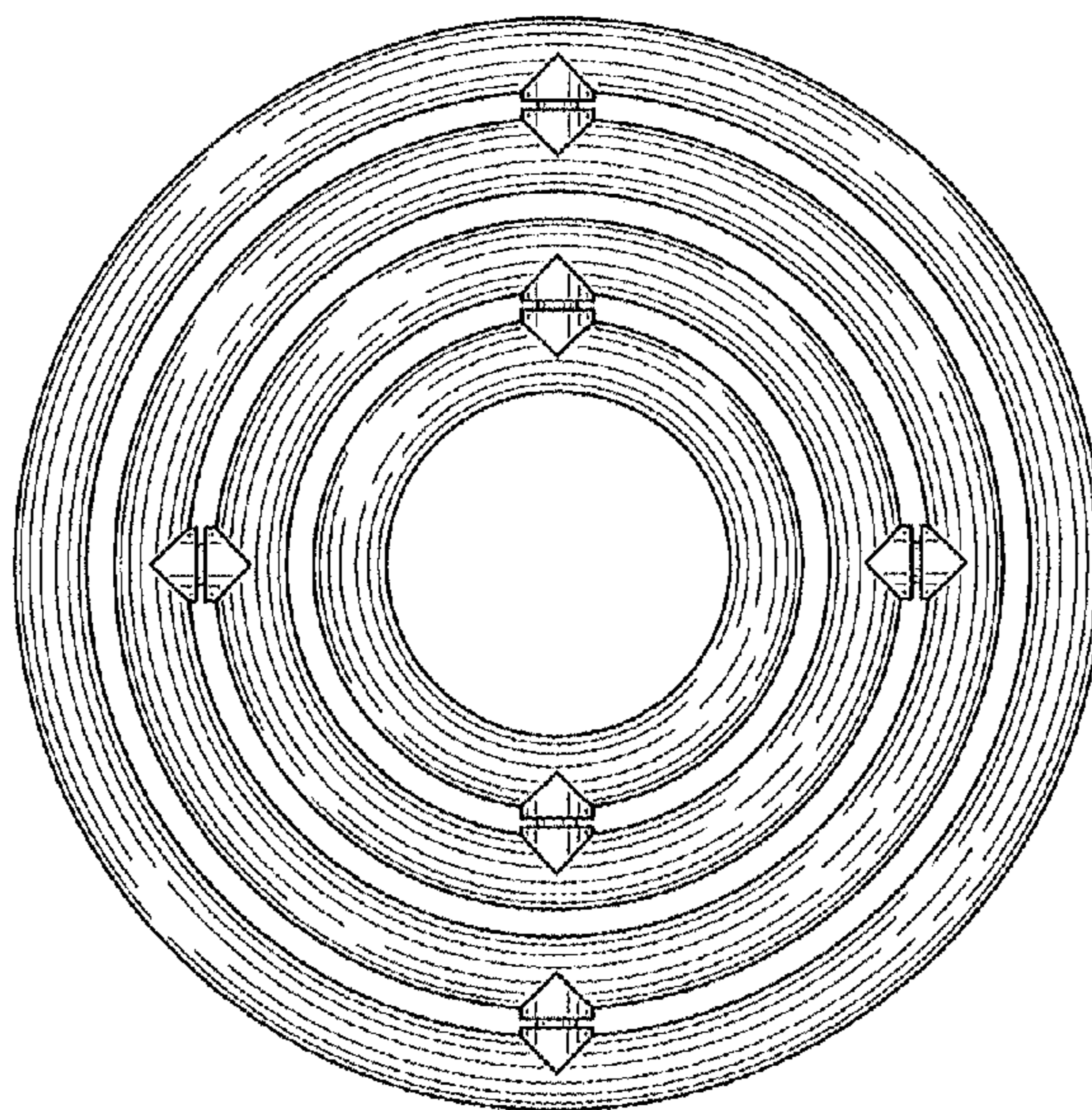
(57) **CLAIM**

An ornamental design for a manually manipulated therapeutic device, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a manually manipulated therapeutic device in accordance with the present invention;
FIG. 2 is a back view of a manually manipulated therapeutic device, of FIG. 1;
FIG. 3 is a left side of a manually manipulated therapeutic device of FIG. 1;
FIG. 4 is a right side view of a manually manipulated therapeutic device of FIG. 1;
FIG. 5 is a top view of a manually manipulated therapeutic device of FIG. 1;
FIG. 6 is a bottom view of a manually manipulated therapeutic device of FIG. 1;
FIG. 7 is a perspective view of a manually manipulated therapeutic device of FIG. 1;
FIG. 8 is a perspective view of a manually manipulated therapeutic device of FIG. 1 showing the inner most ring rotated about its axis;
FIG. 9 is a perspective view of a manually manipulated therapeutic device of FIG. 1 showing the inner most ring and the second inner most ring rotated about their axes; and,
FIG. 10 is a perspective view of a manually manipulated therapeutic device of FIG. 1 showing the inner most ring, the second inner most ring, and the third inner most ring rotated about their axes.

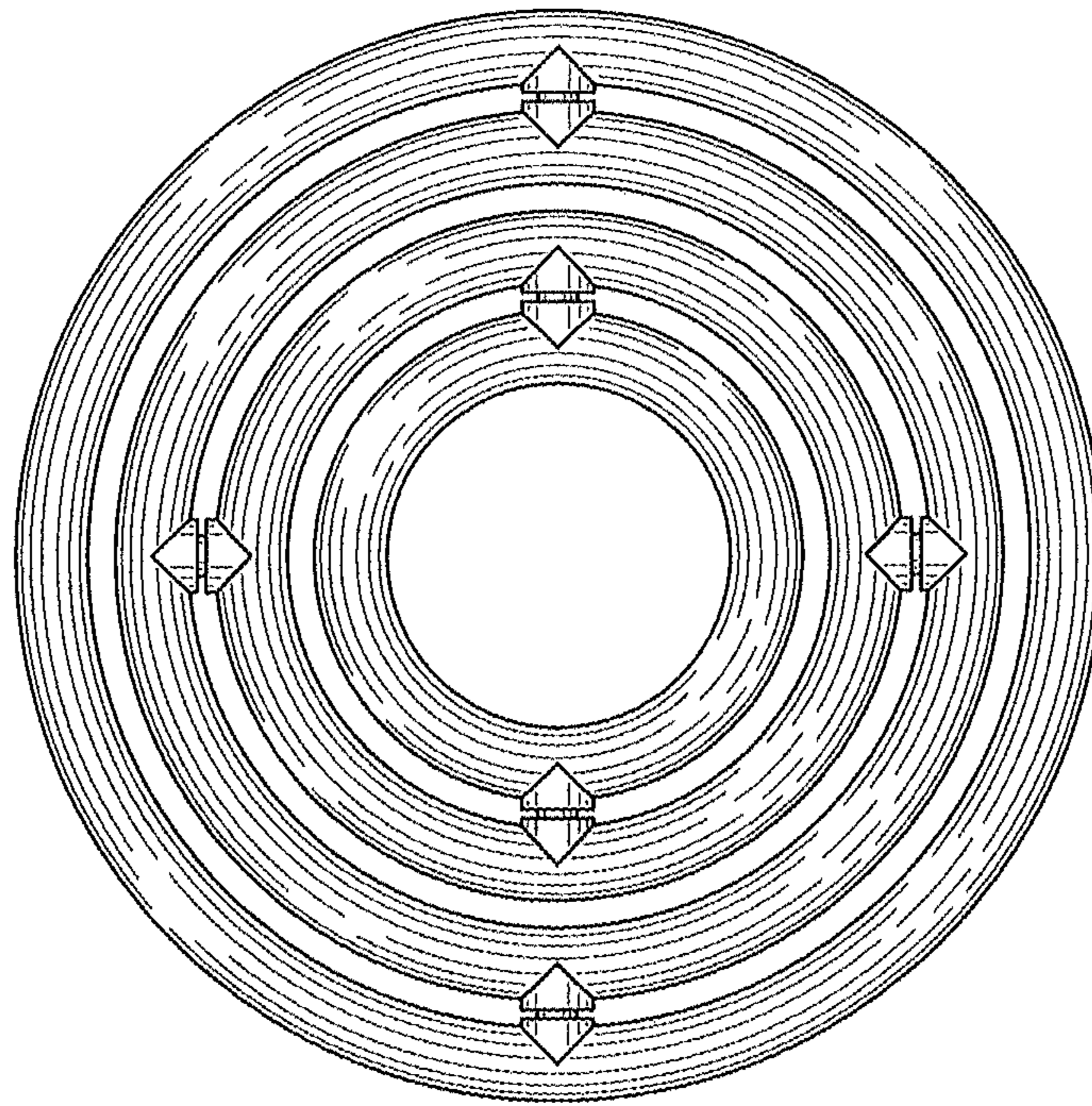

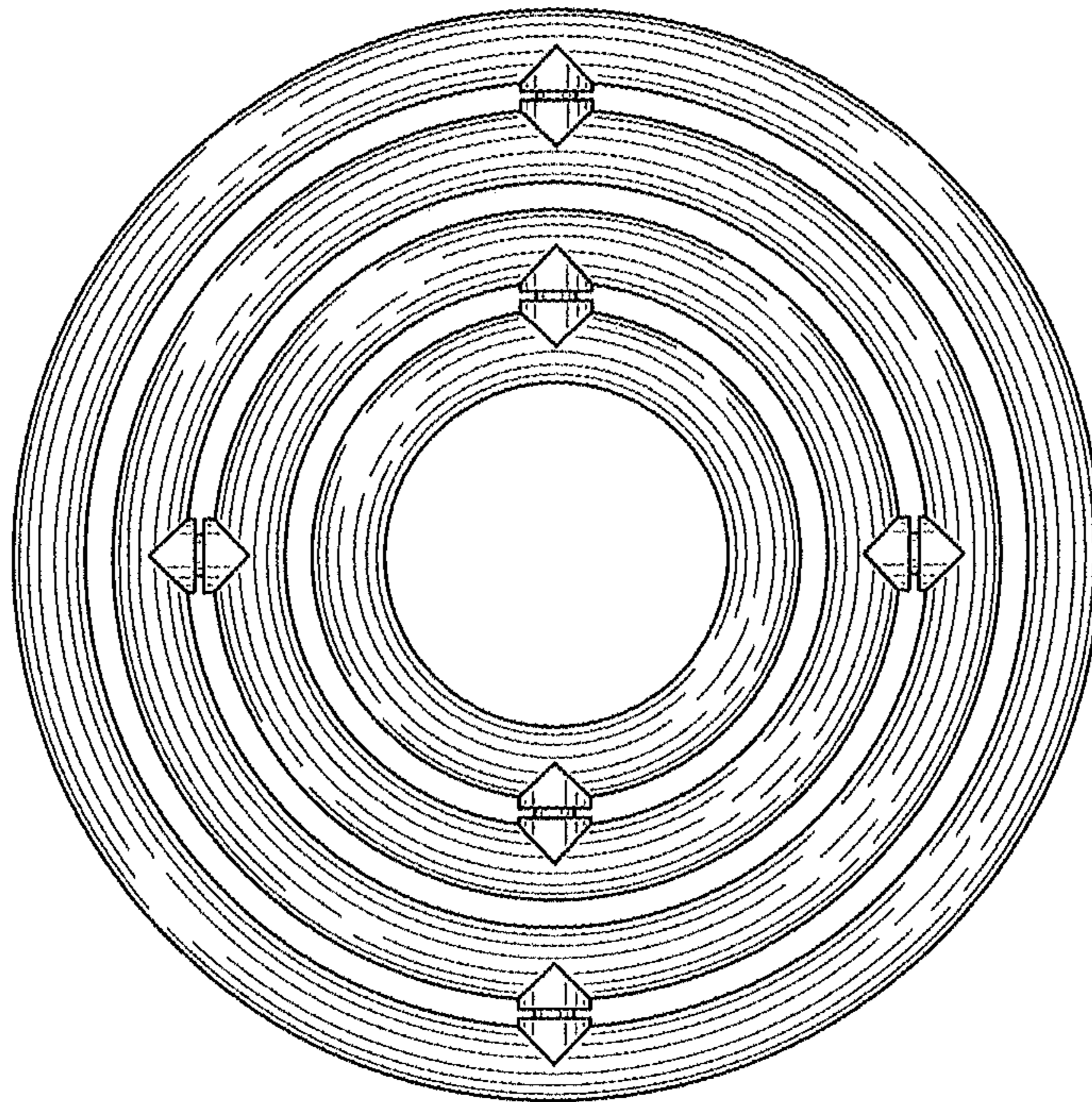

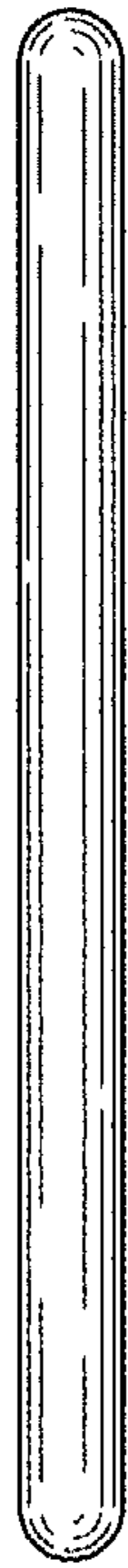

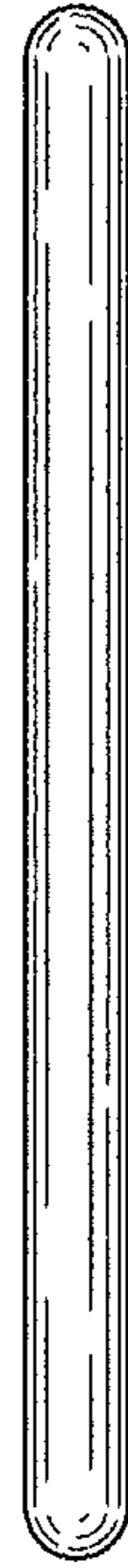

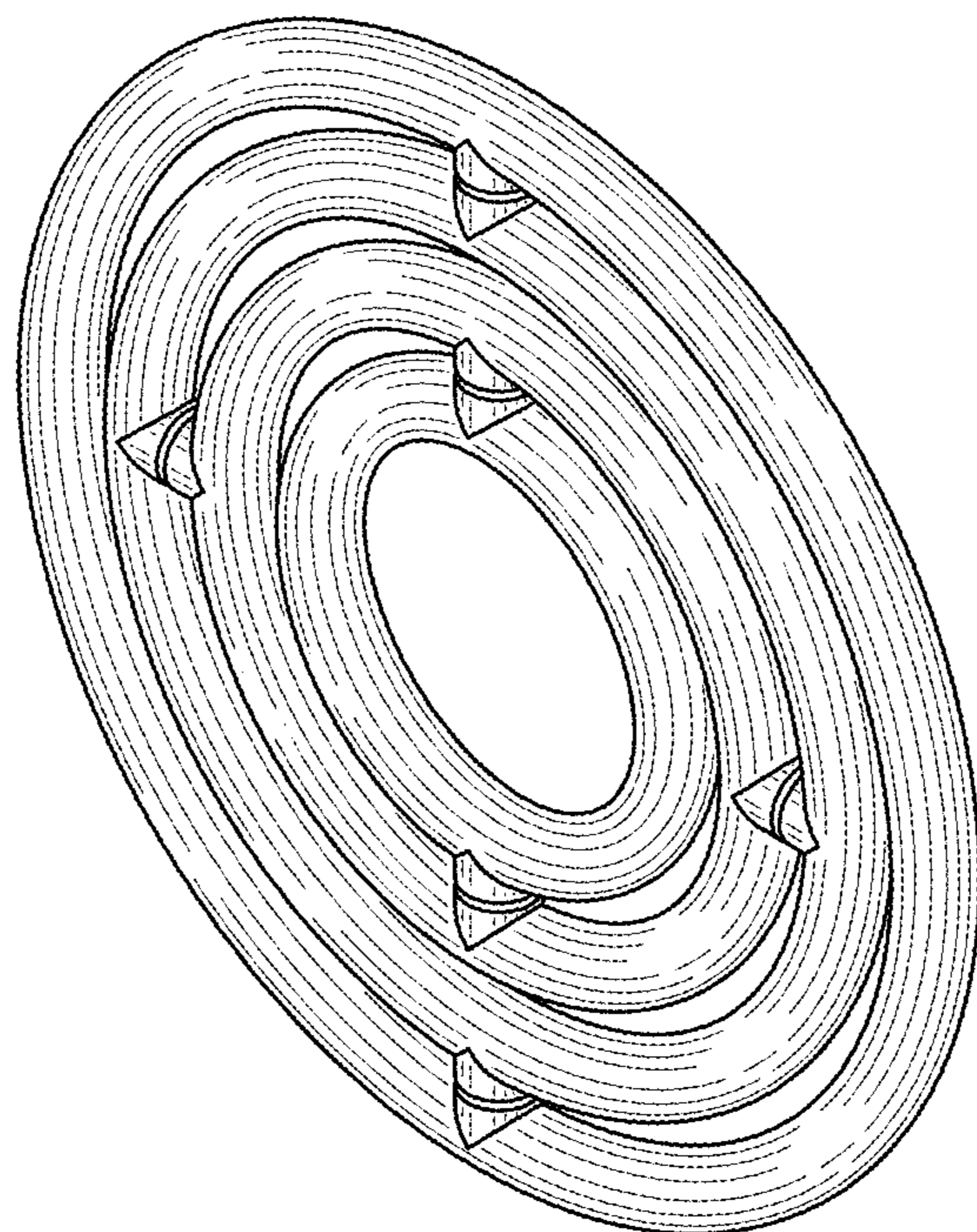

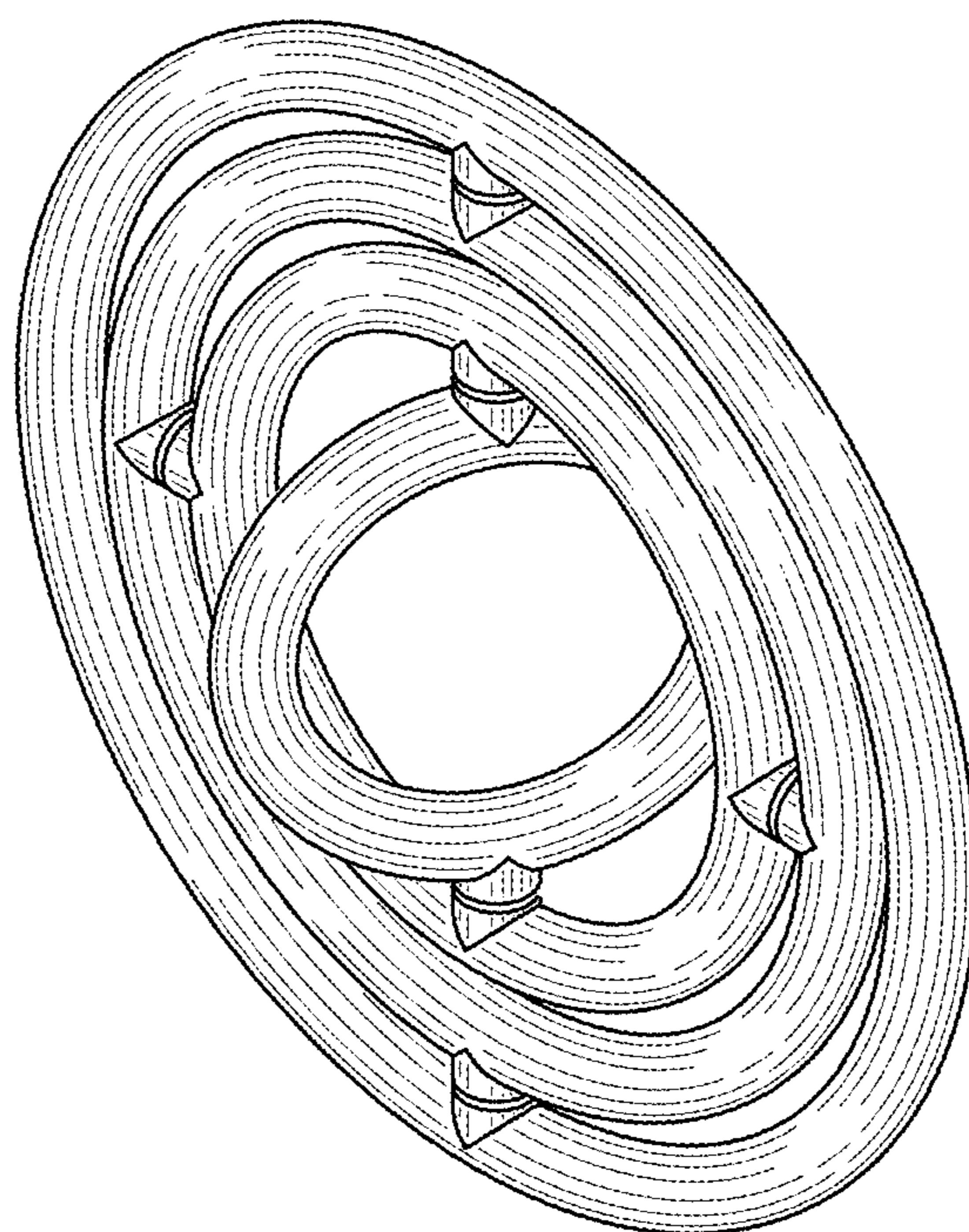

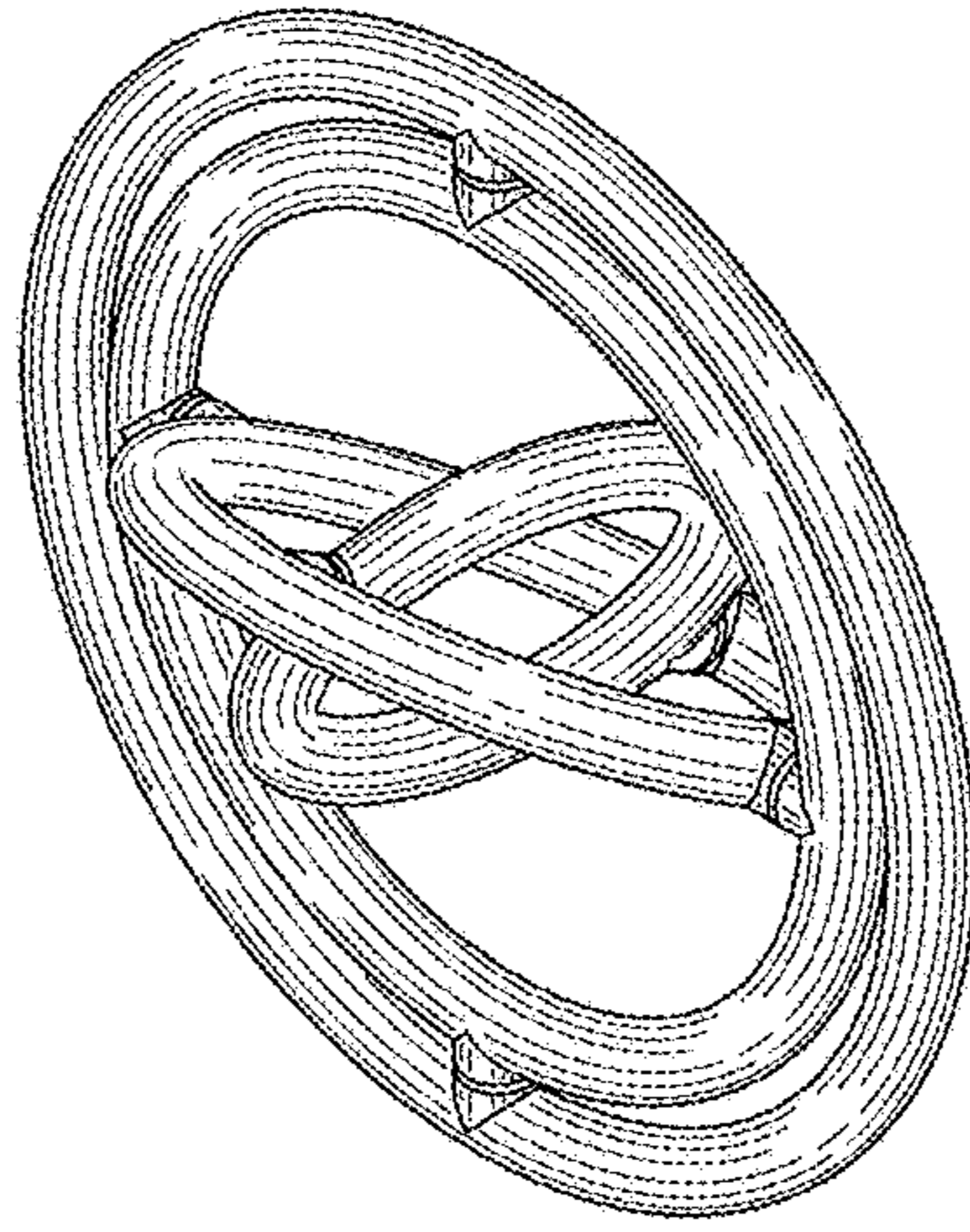

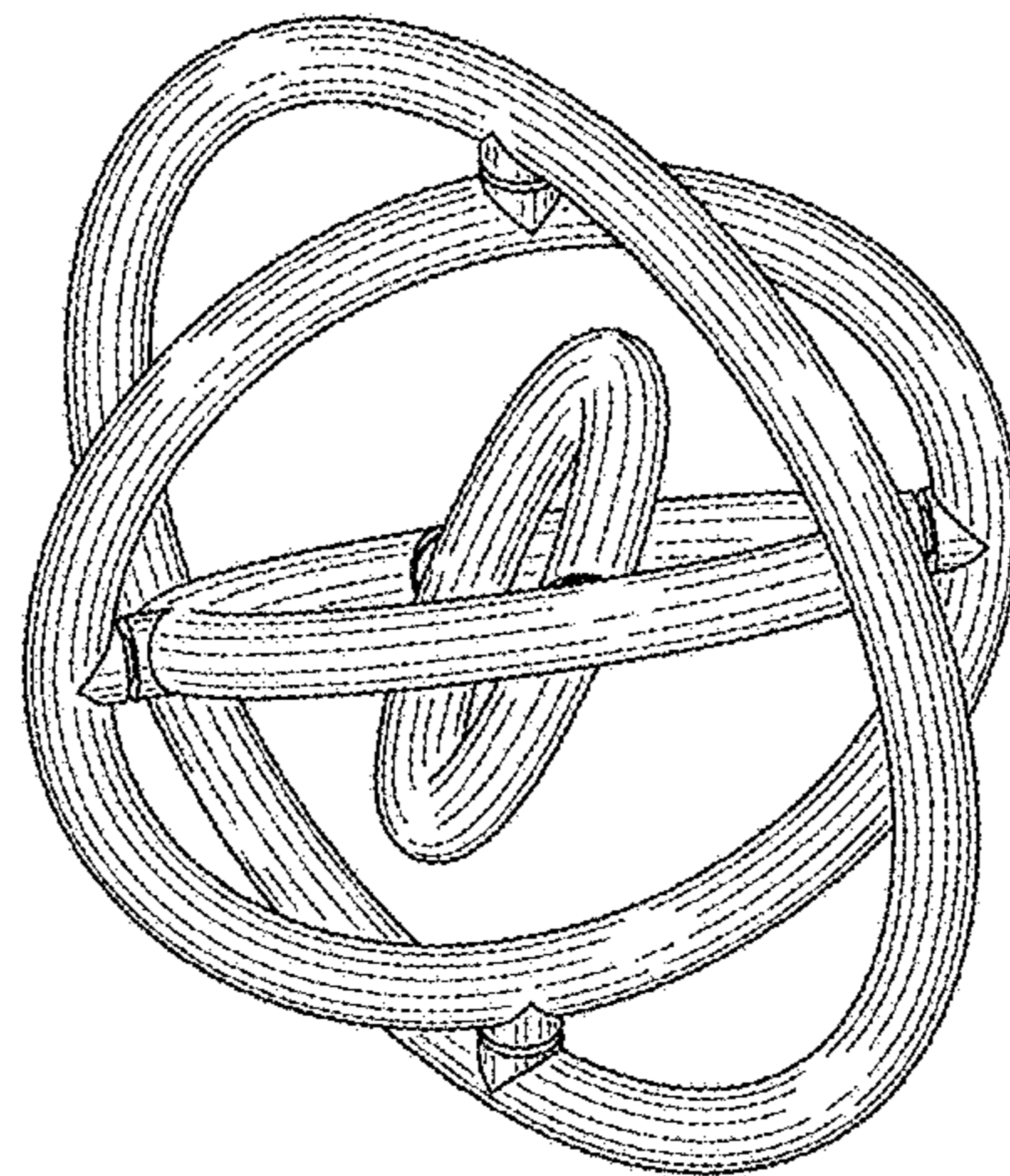
