(57) **CLAIM**

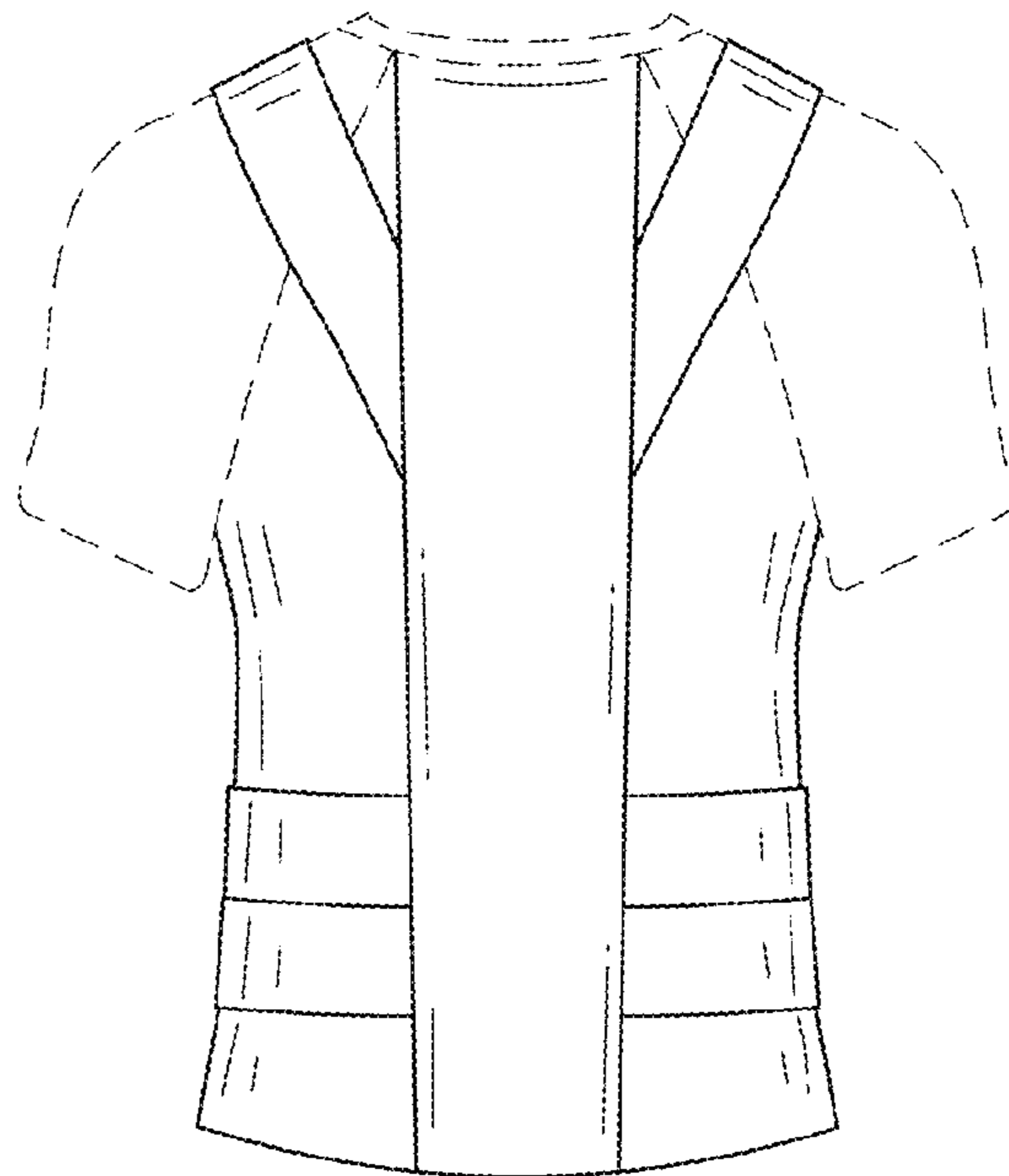
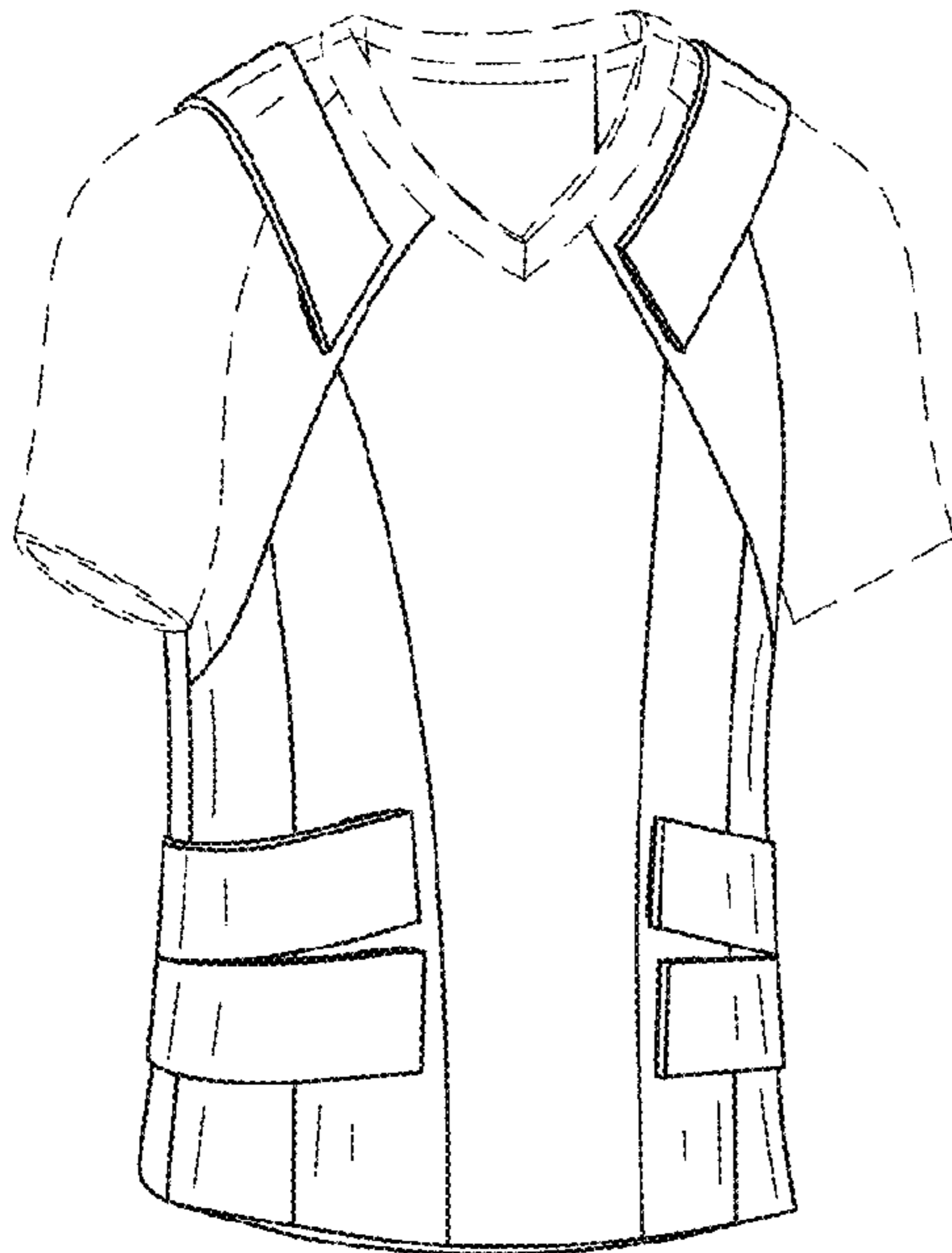
The ornamental design for a garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a garment;
FIG. 2 is a front elevation view thereof;
FIG. 3 is the rear elevation view thereof;
FIG. 4 is a left side elevation view thereof, the right side
elevation view being a mirror image thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is front view of the garment; and,
FIG. 8 is a front view of the garment showing the straps
unattached and extended.

The evenly dashed broken lines in the drawings are for the
purpose of illustrating portions of a garment and form no
part of the claim. The garment is shown with a symbolic
break in its length in FIG. 7. The appearance of any portion
of the article between the break lines forms no part of the
claim.

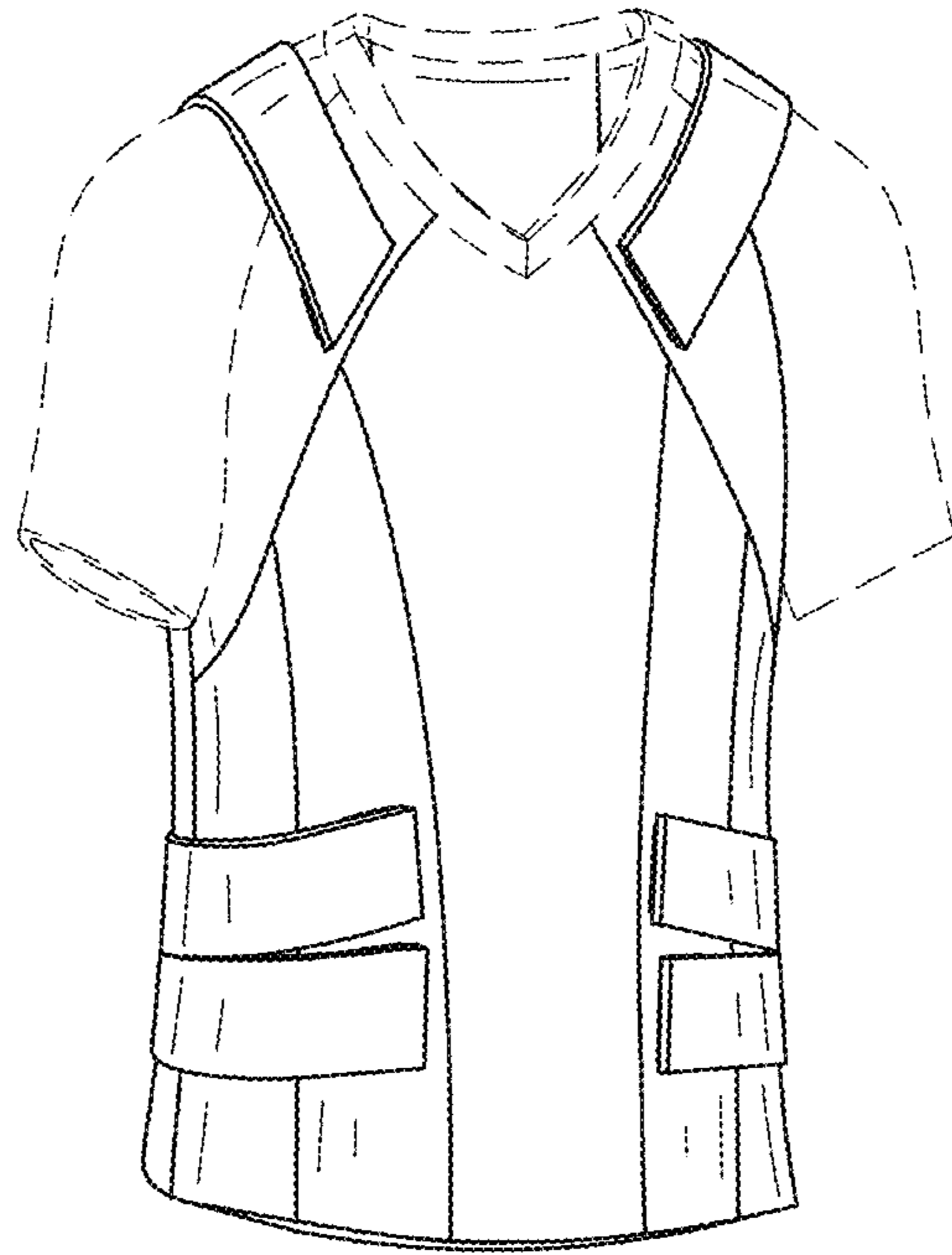

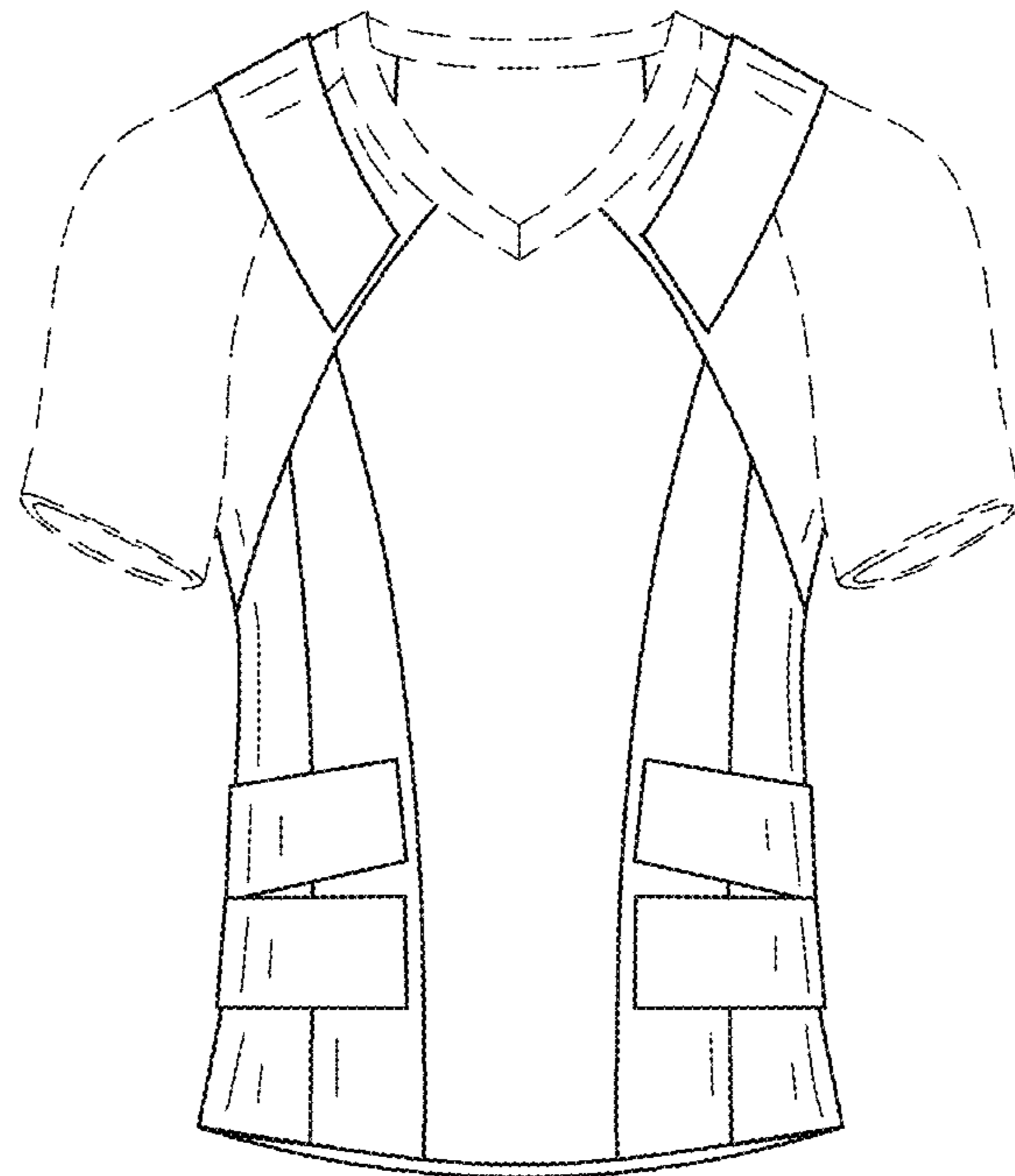

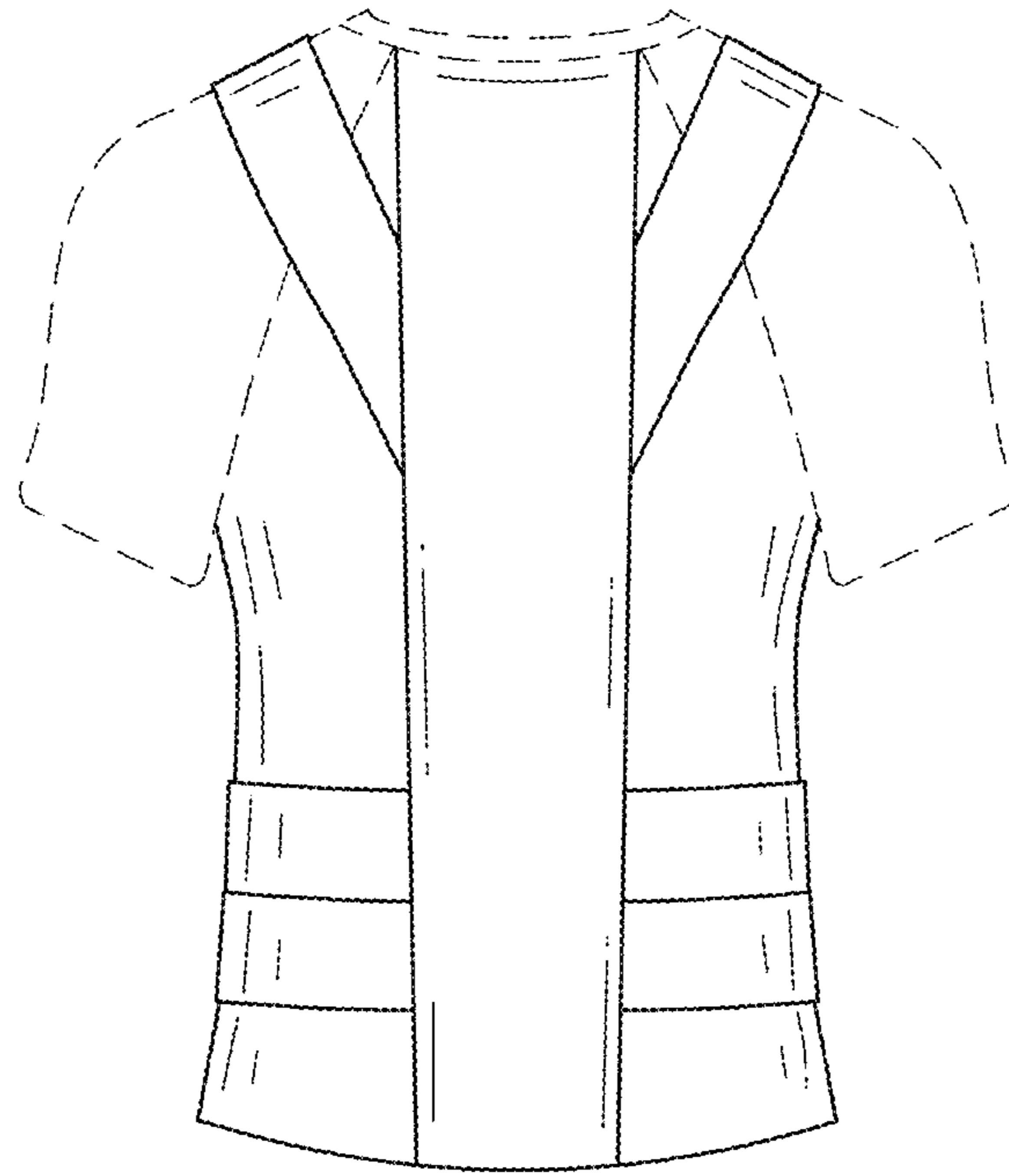

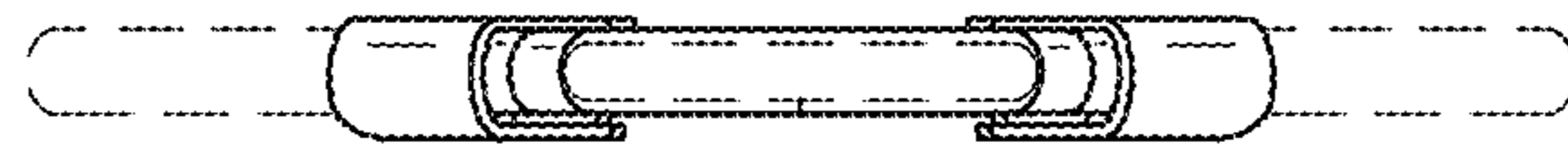

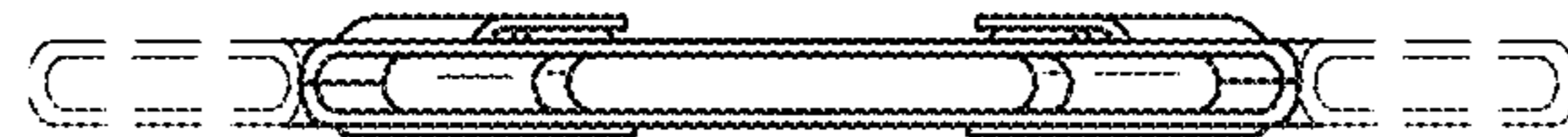

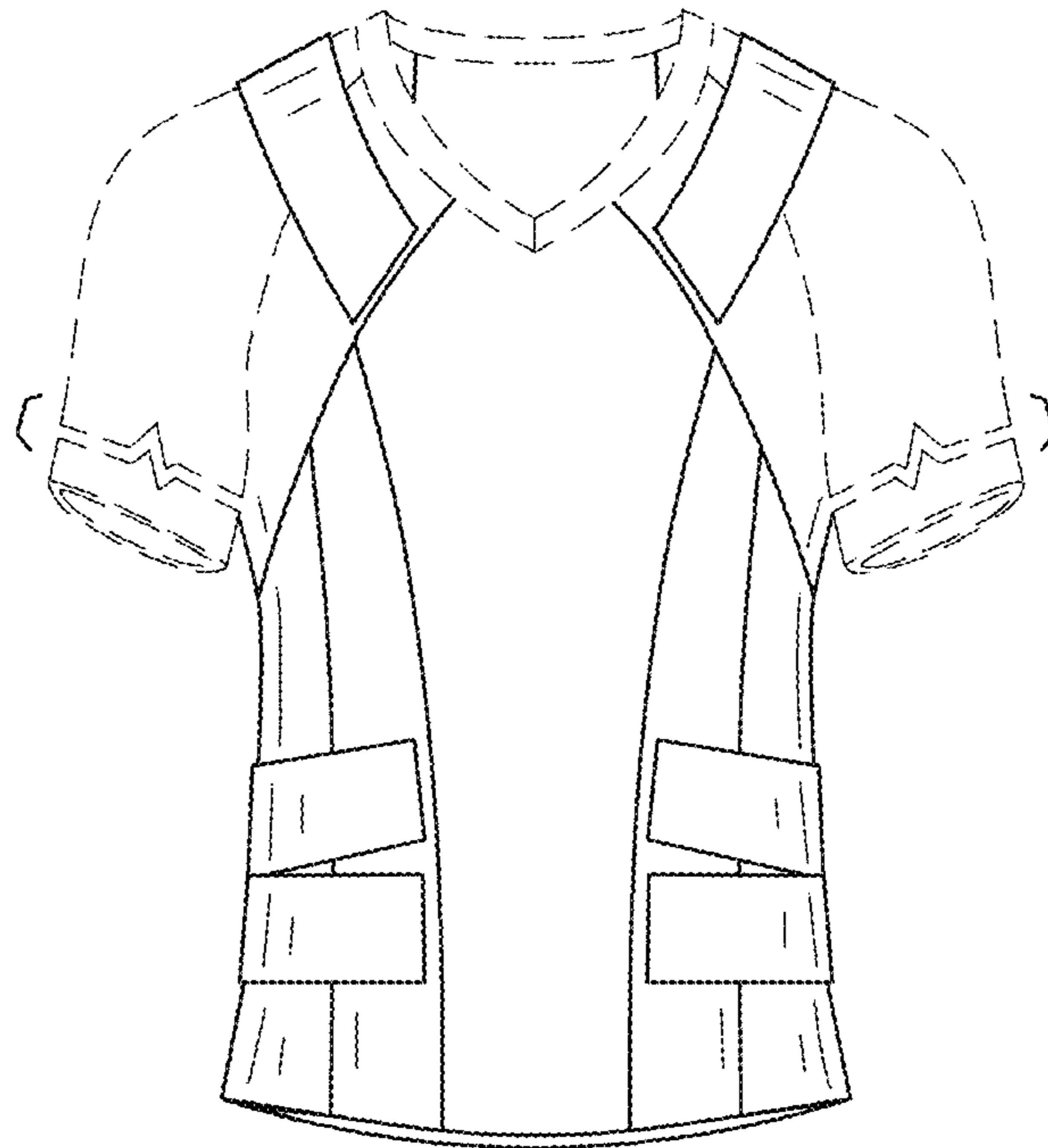

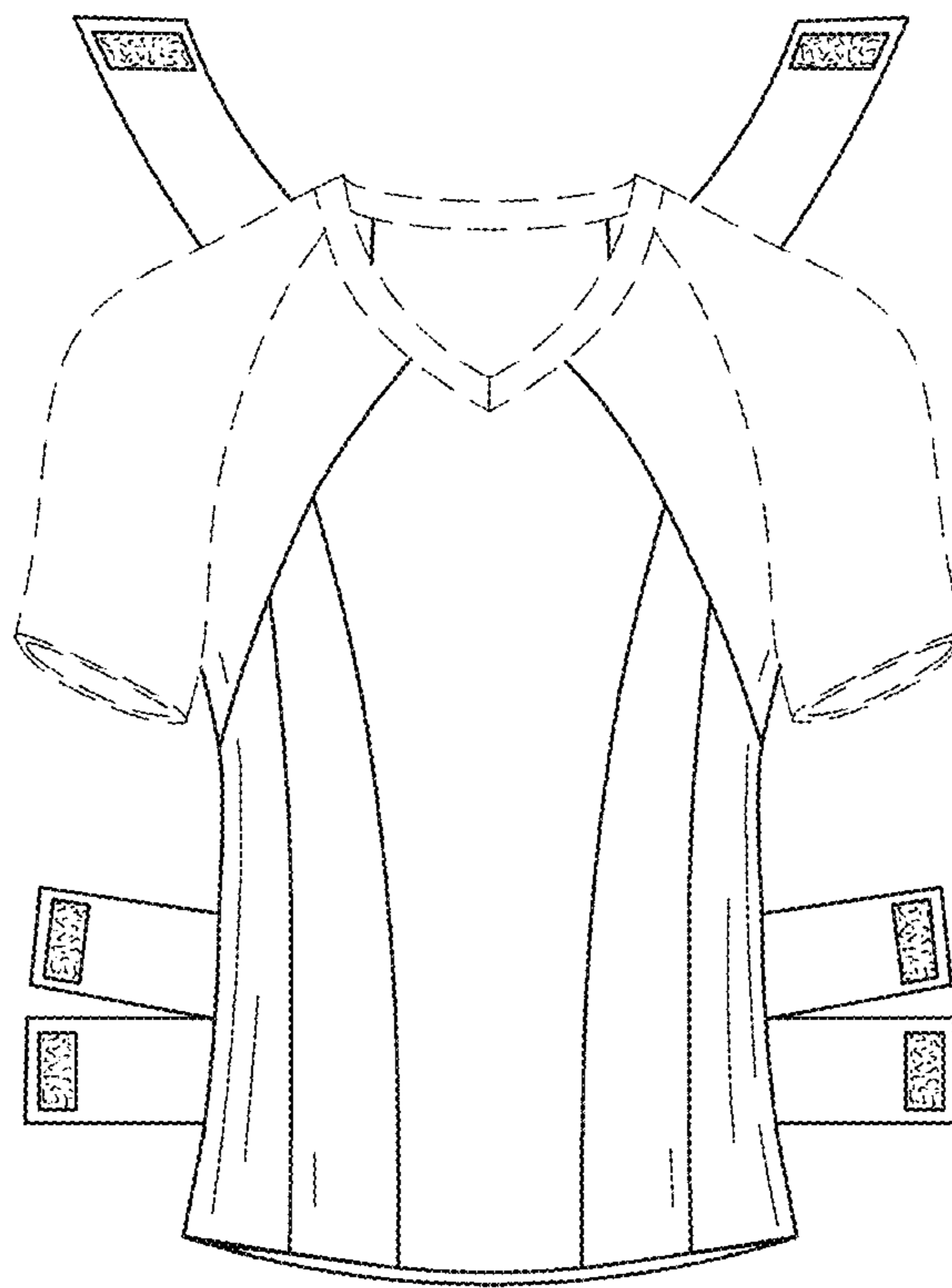
