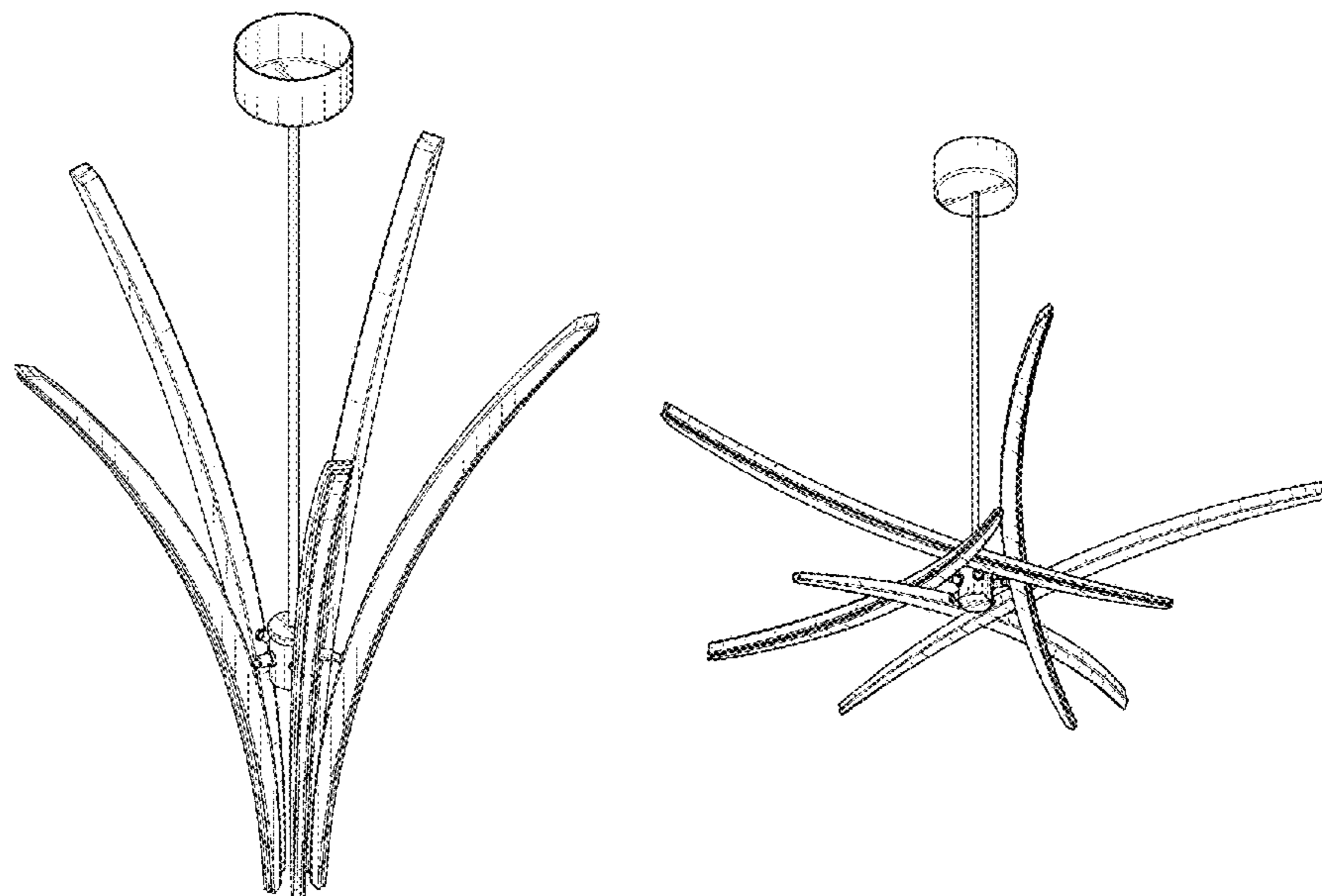
(57) **CLAIM**

The ornamental design for a pendant light having moveable arms, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an pendant light having moveable arms embodying my design;
 FIG. 2 is a front view of the pendant light having moveable arms;
 FIG. 3 is a rear view of the pendant light having moveable arms;
 FIG. 4 is a right view of the pendant light having moveable arms;
 FIG. 5 is a left view of the pendant light having moveable arms;
 FIG. 6 is a top view of the pendant light having moveable arms;
 FIG. 7 is a bottom view of the pendant light having moveable arms;
 FIG. 8 is a perspective view of the pendant light having moveable arms of the claimed design after pivoting the arms to more open positions than the positions shown in FIGS. 1-6; and,
 FIG. 9 is a perspective view of the pendant light having moveable arms aura light design after pivoting the arms to flattened, more open positions than the positions shown in FIGS. 1-6 and FIG. 7.

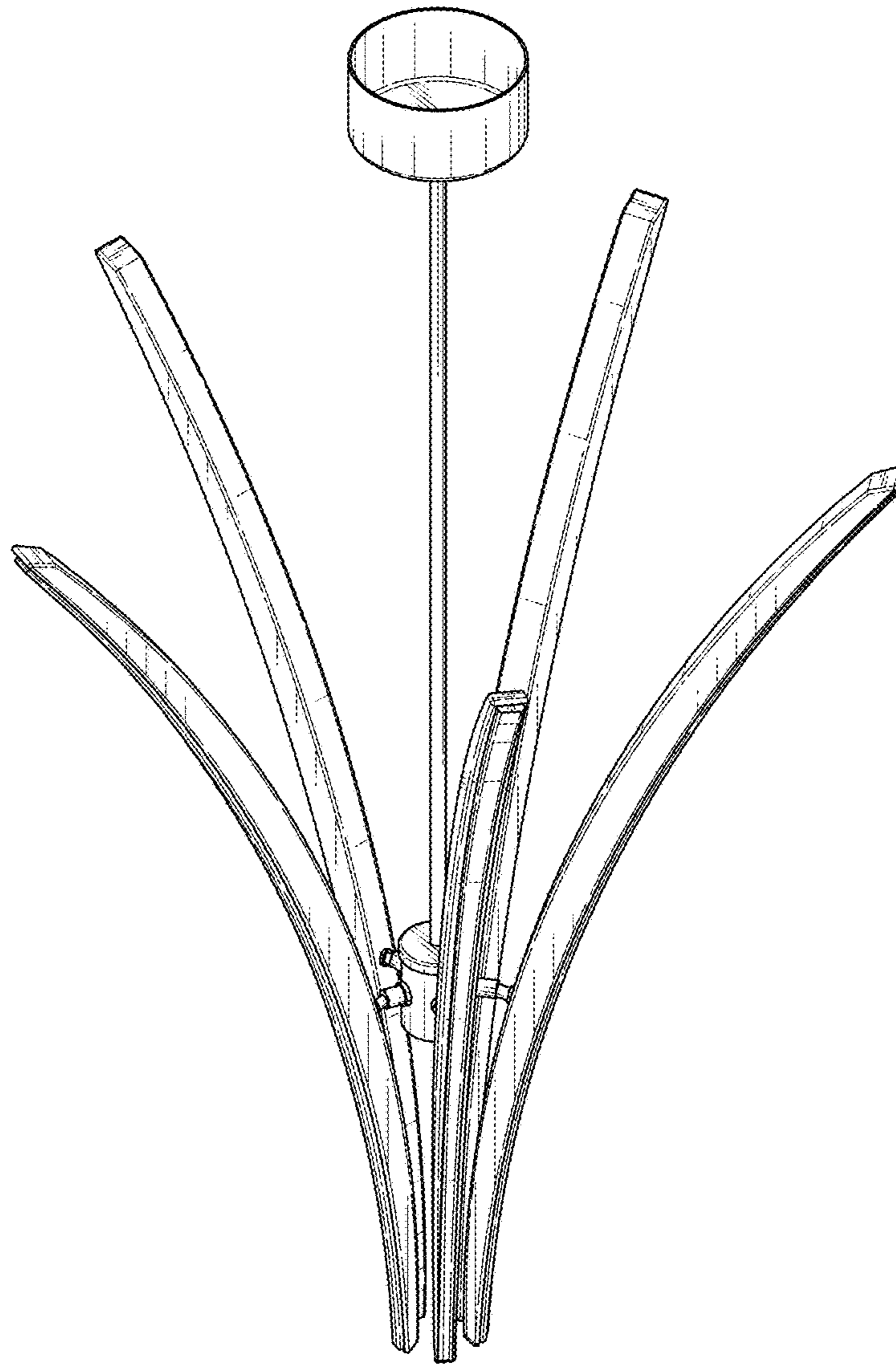

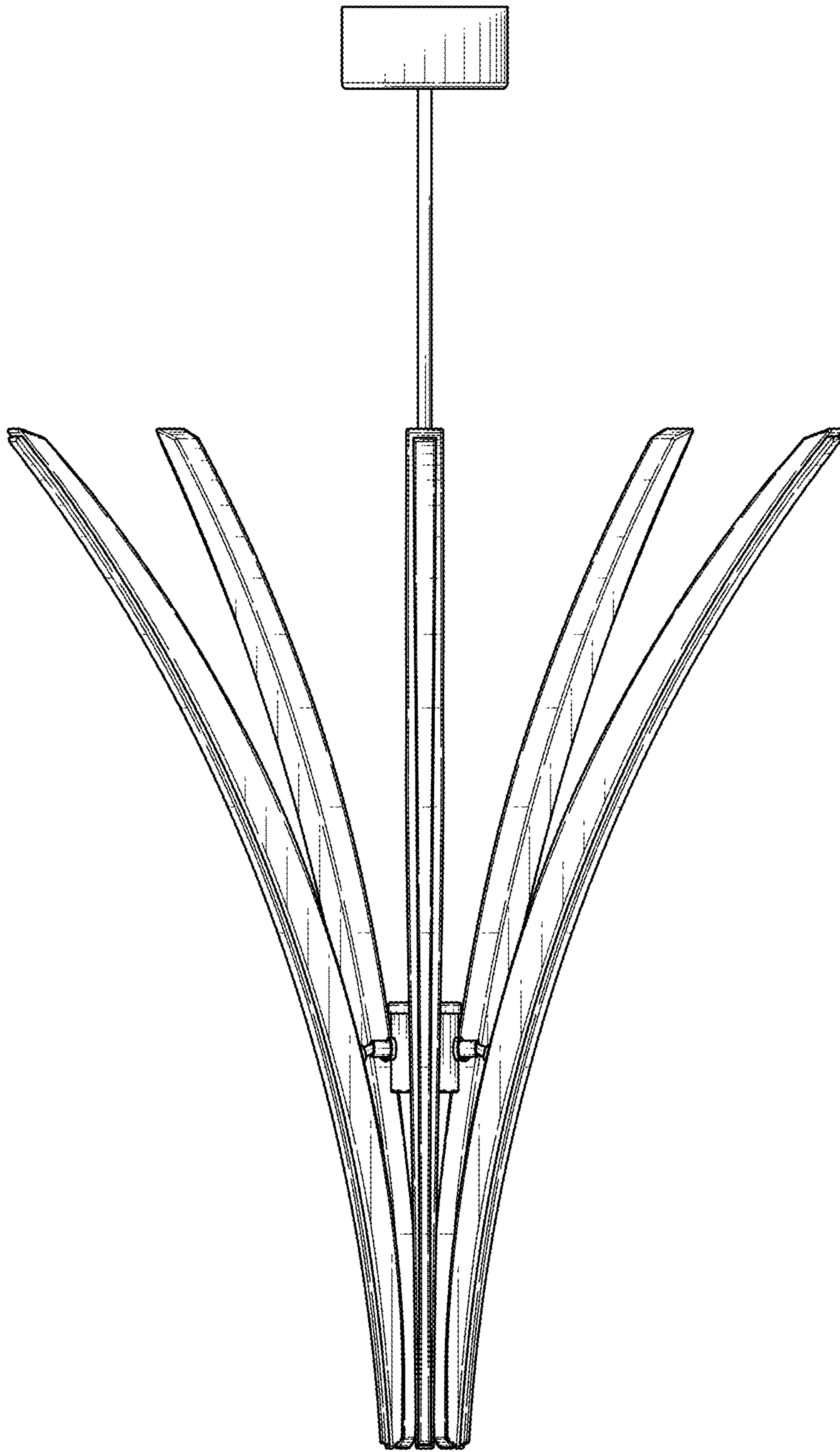

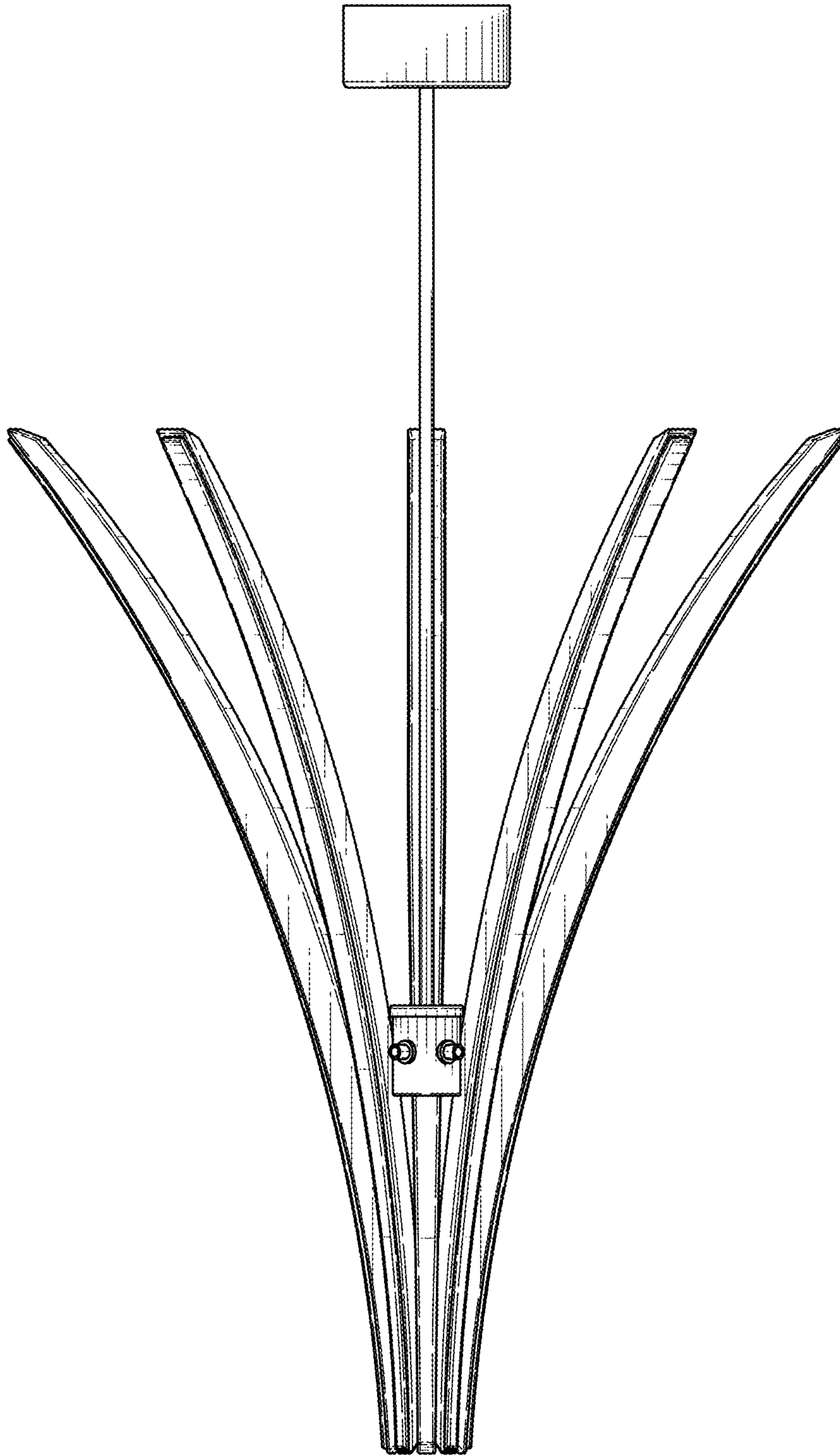

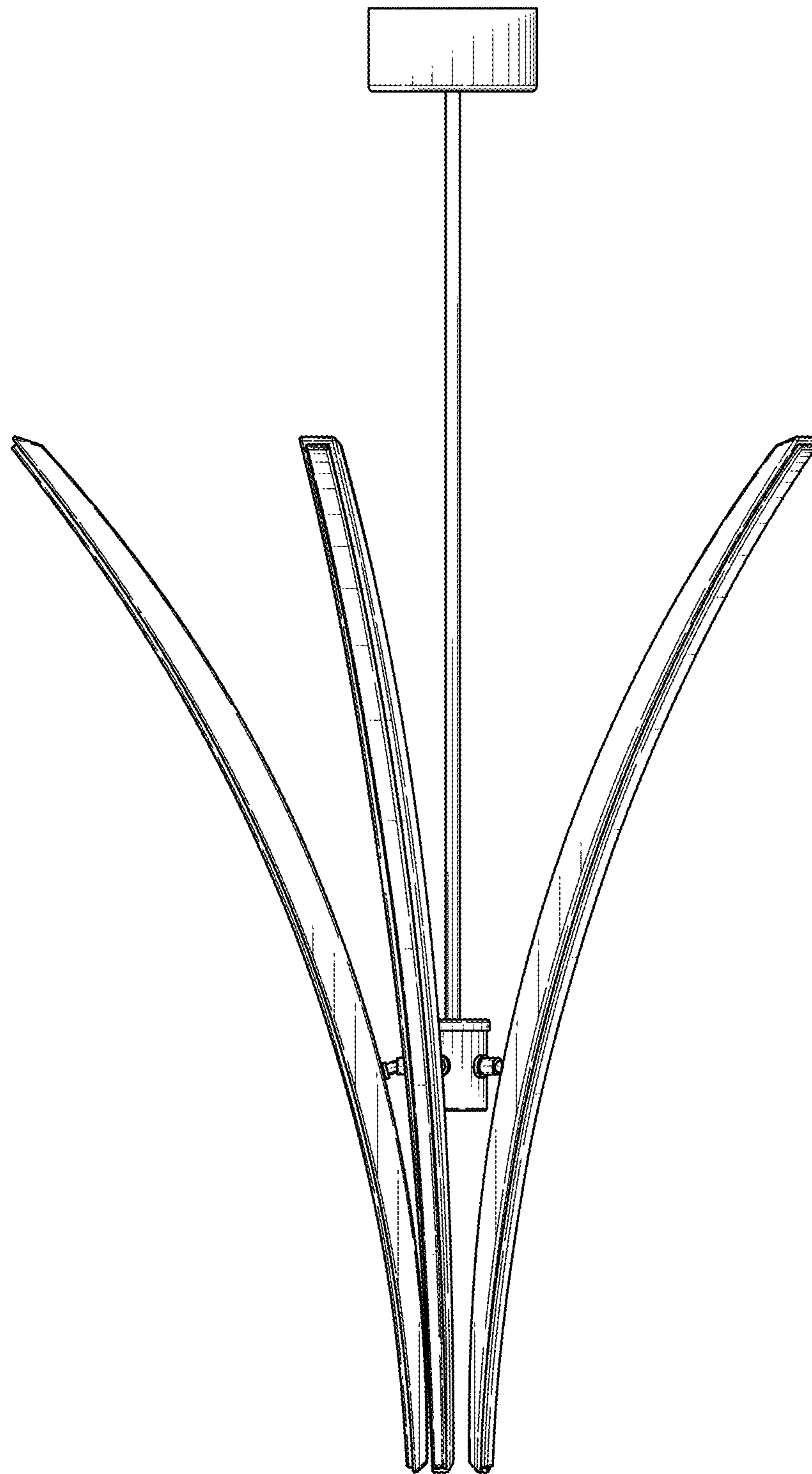

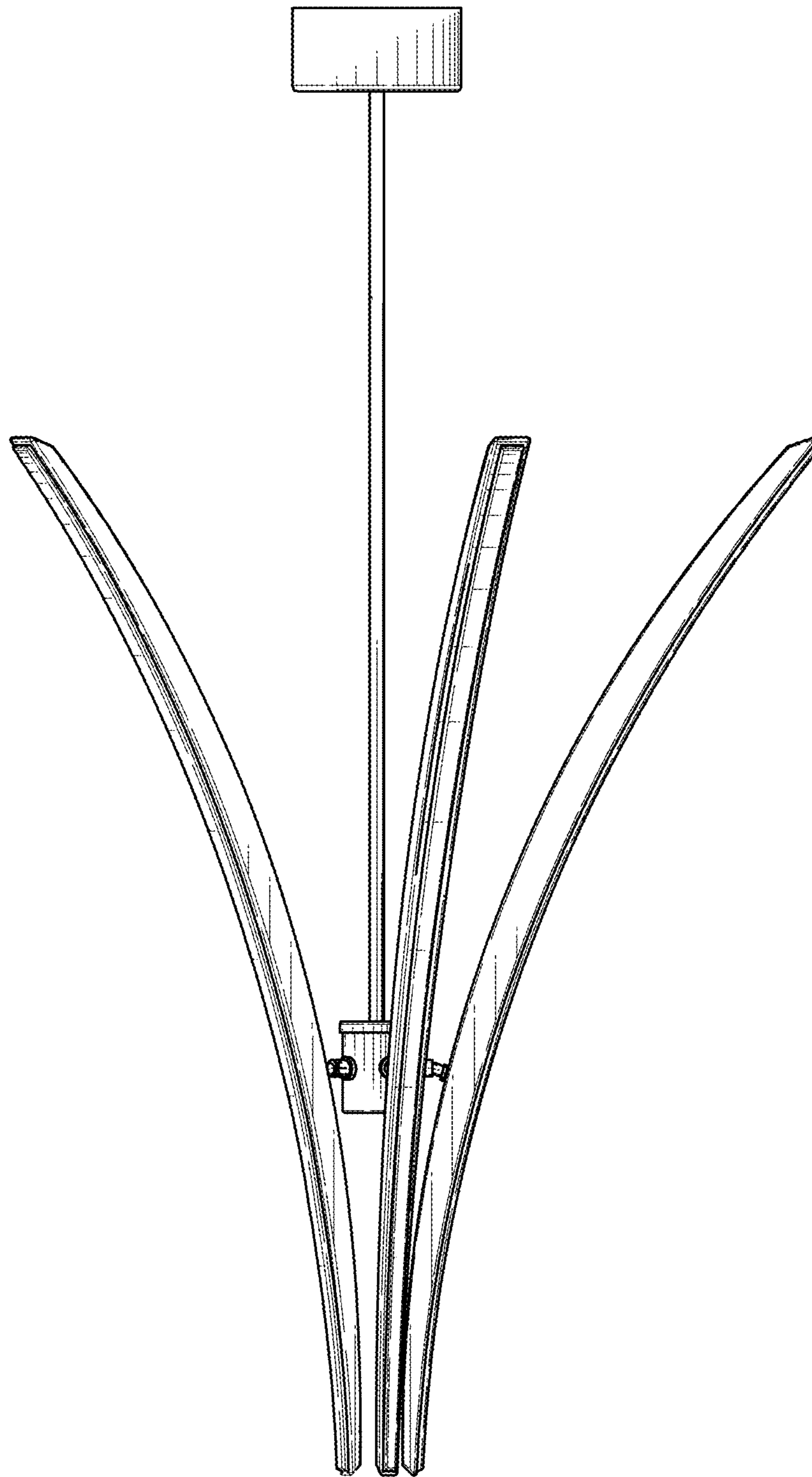

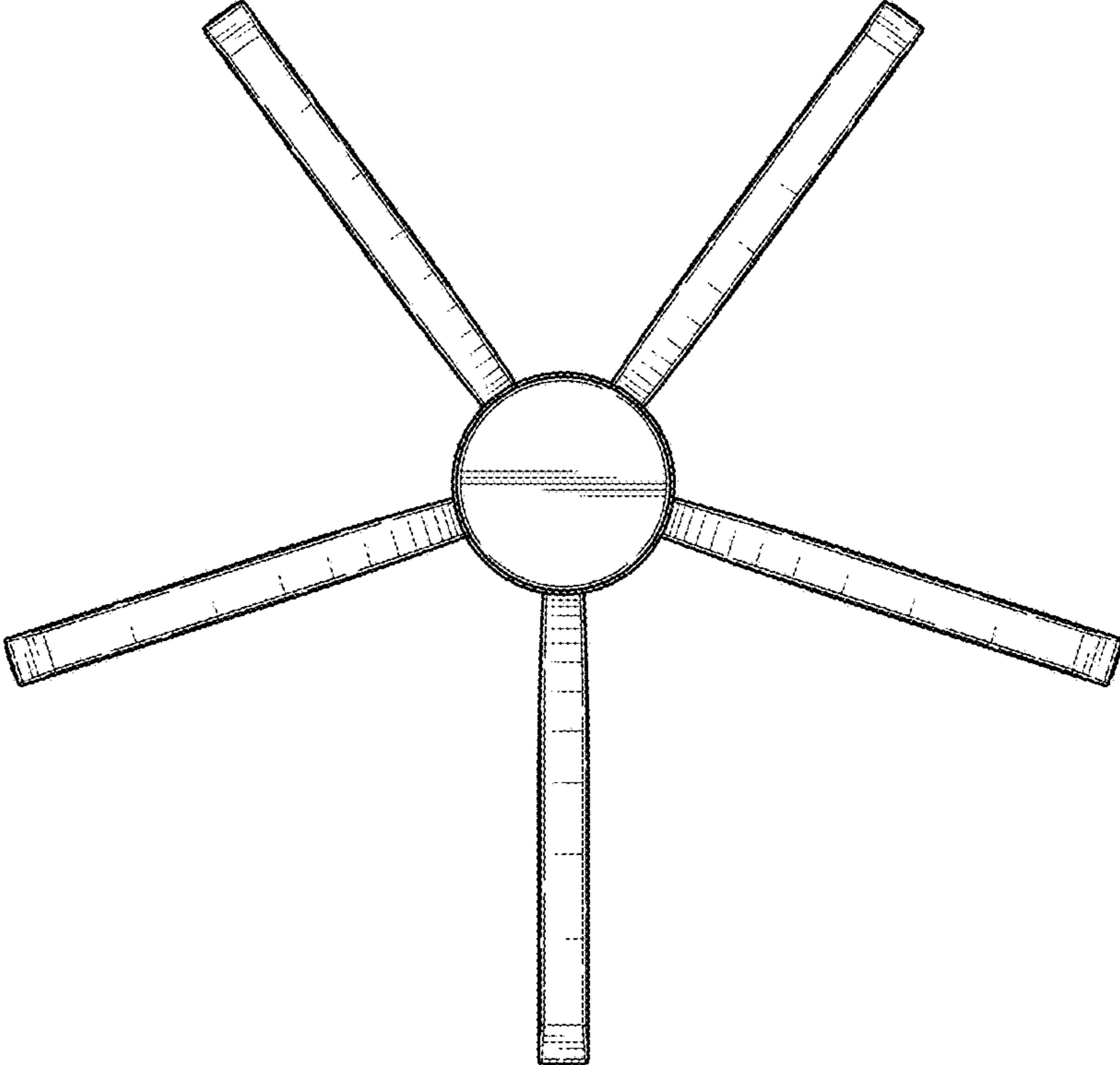

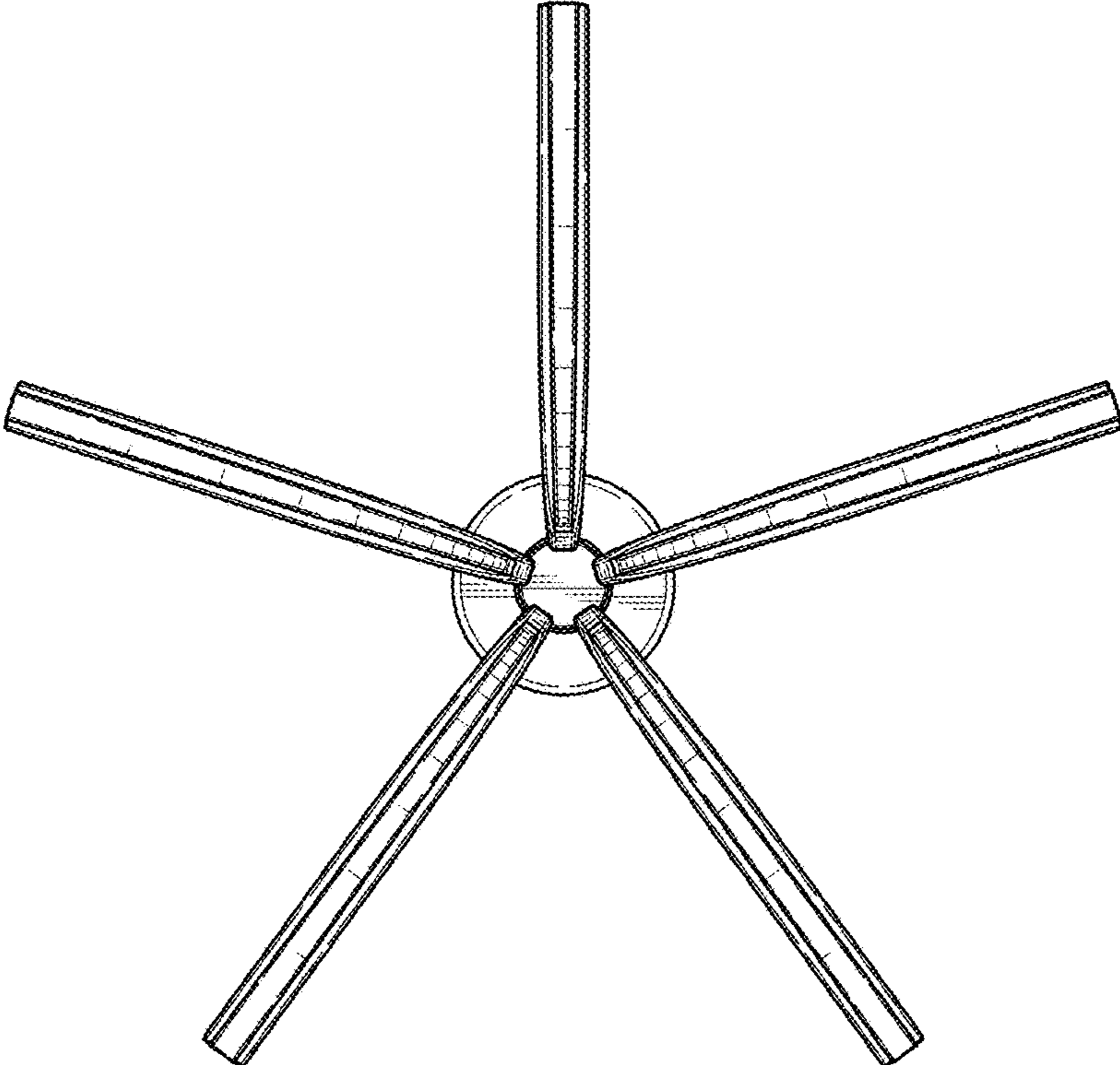

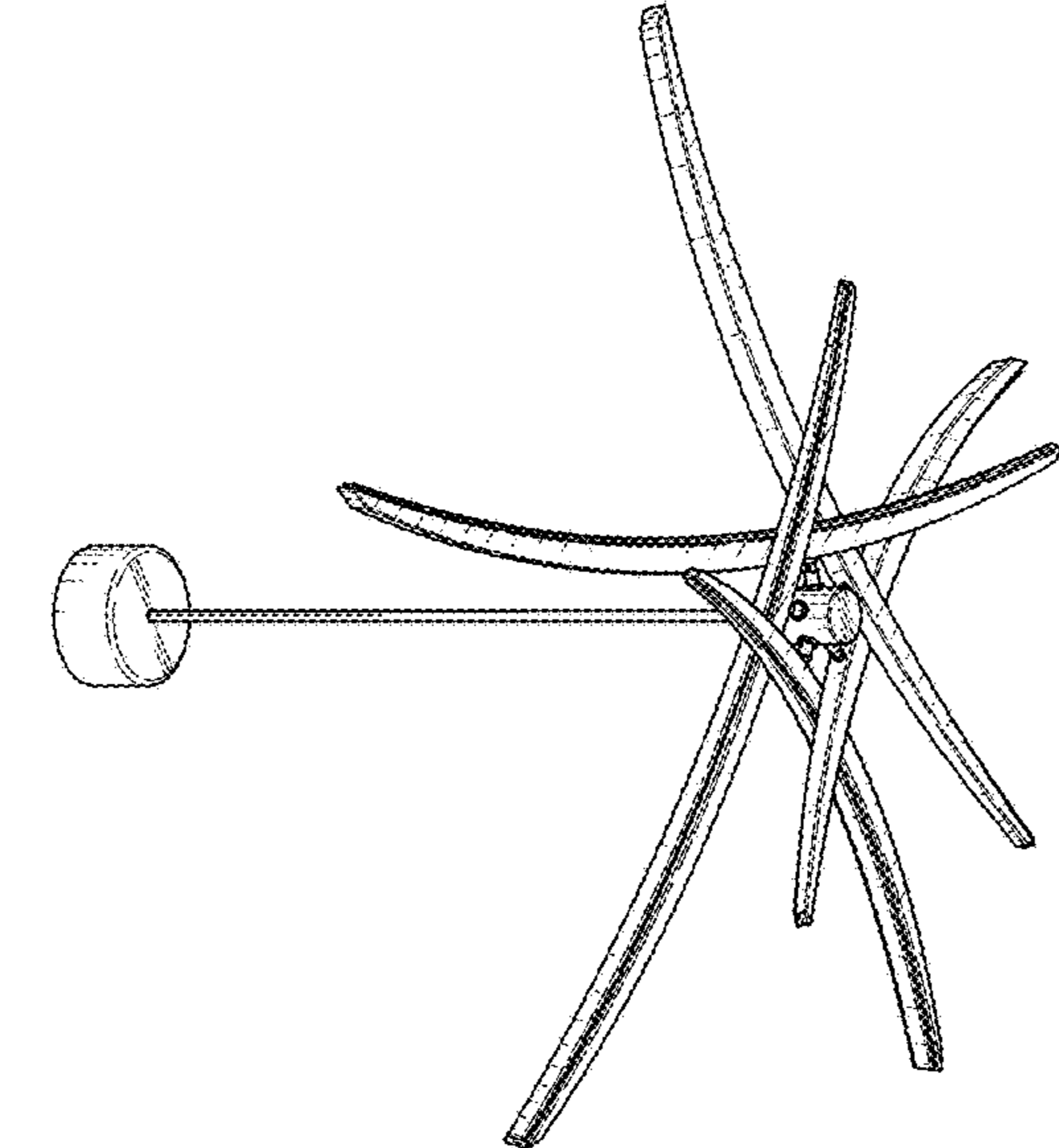

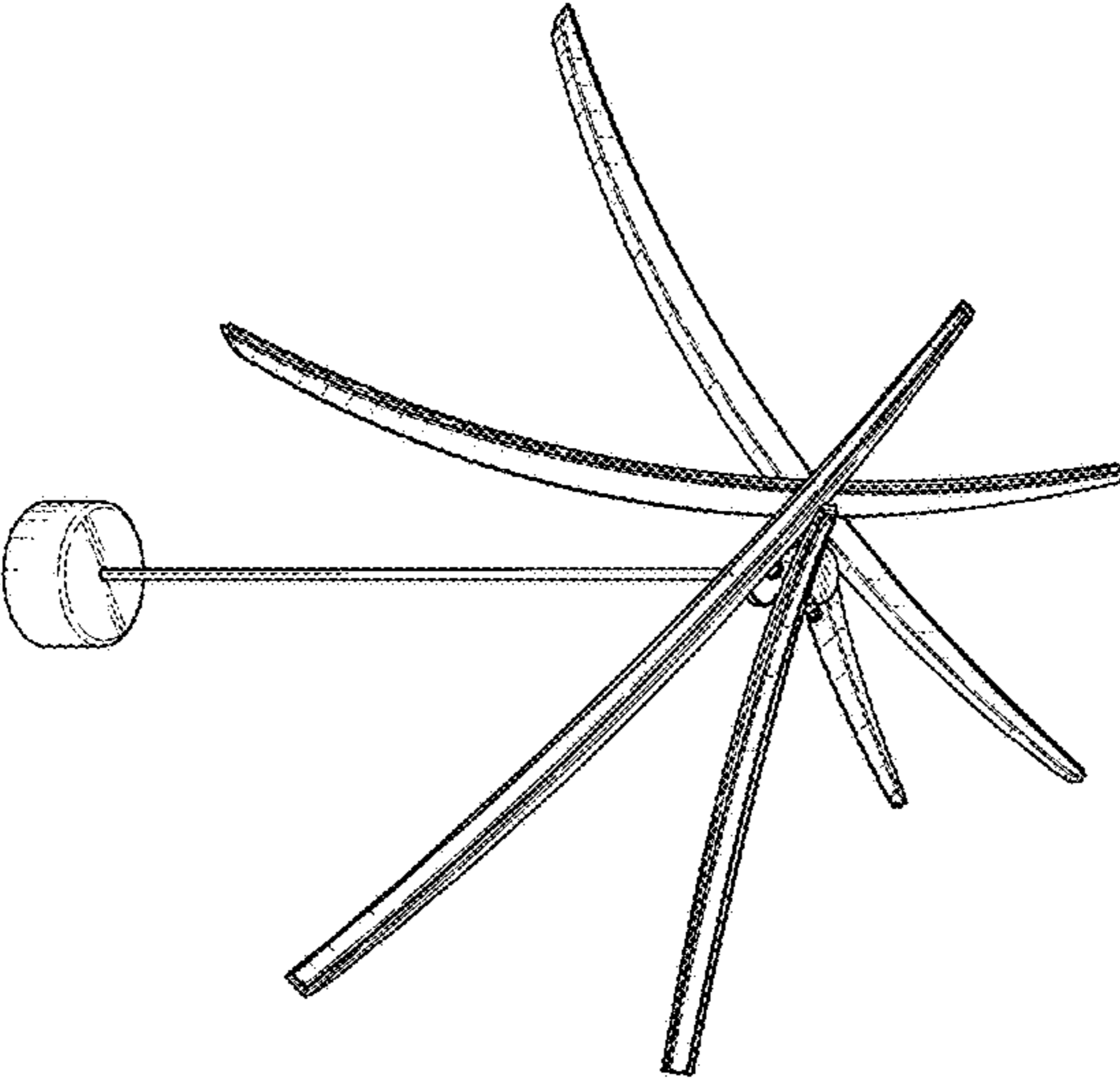
