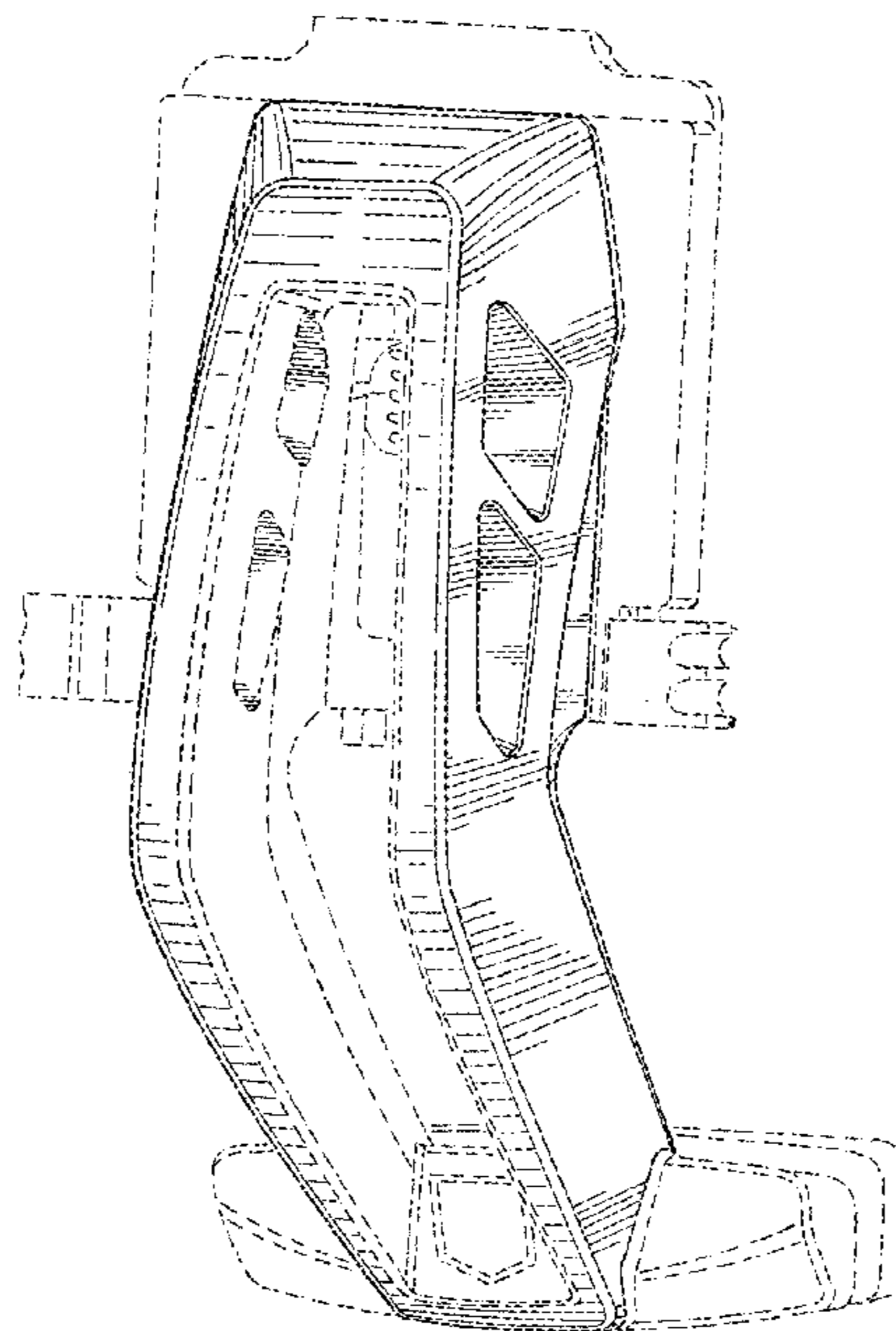
(57) **CLAIM**

The ornamental design for a visor support, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a visor support showing a first embodiment of our new design; FIG. 2 is a top, rear, right side perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a top, front, right side perspective view showing a second embodiment thereof; FIG. 10 is a top, rear, right side perspective view of FIG. 9; FIG. 11 is a front elevation view of FIG. 9; FIG. 12 is a rear elevation view of FIG. 9; FIG. 13 is a left side elevation view of FIG. 9; FIG. 14 is a right side elevation view of FIG. 9; FIG. 15 is a top plan view of FIG. 9; and, FIG. 16 is a bottom plan view of FIG. 9. The broken lines shown illustrate portions of the visor support that form no part of the claimed design.

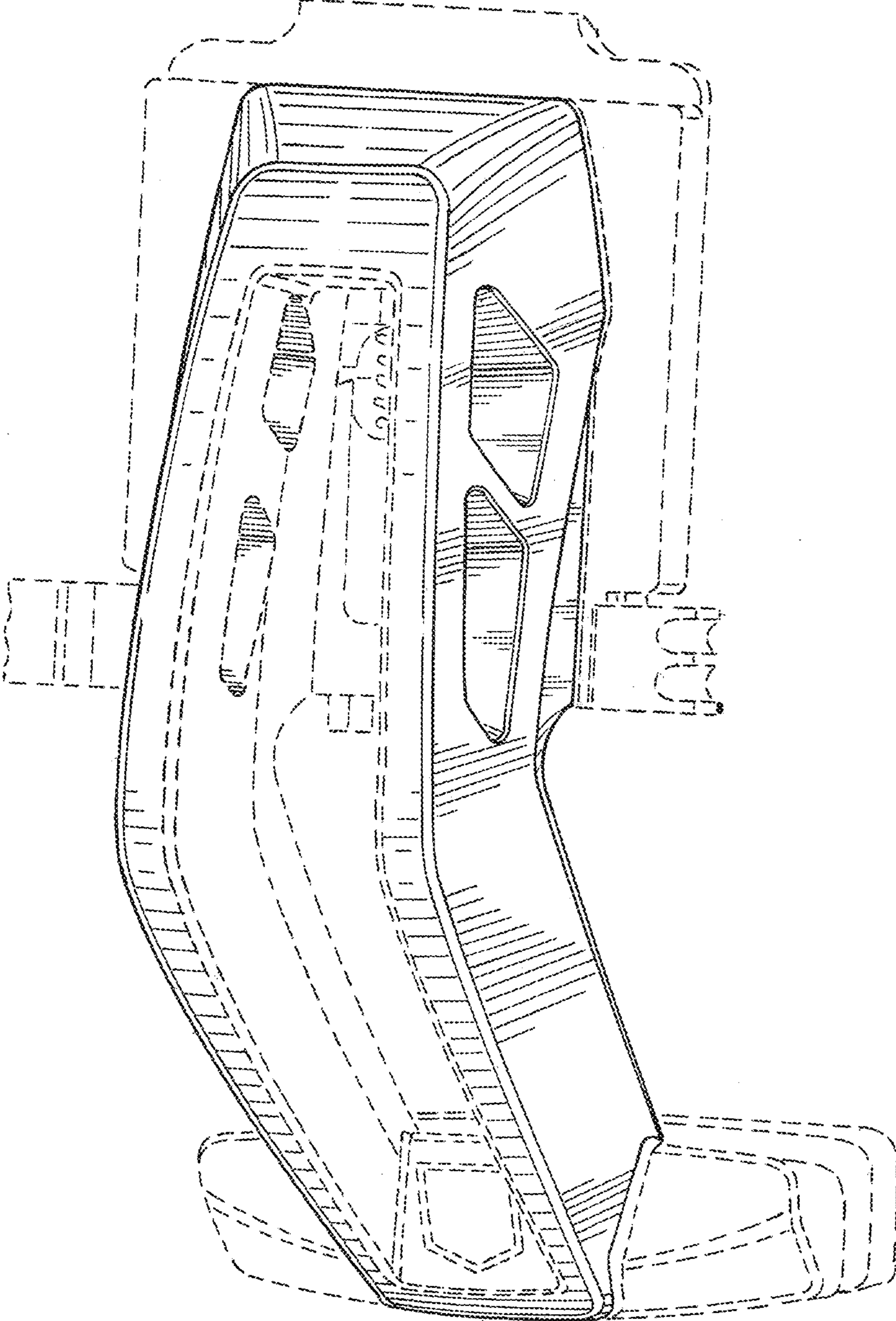

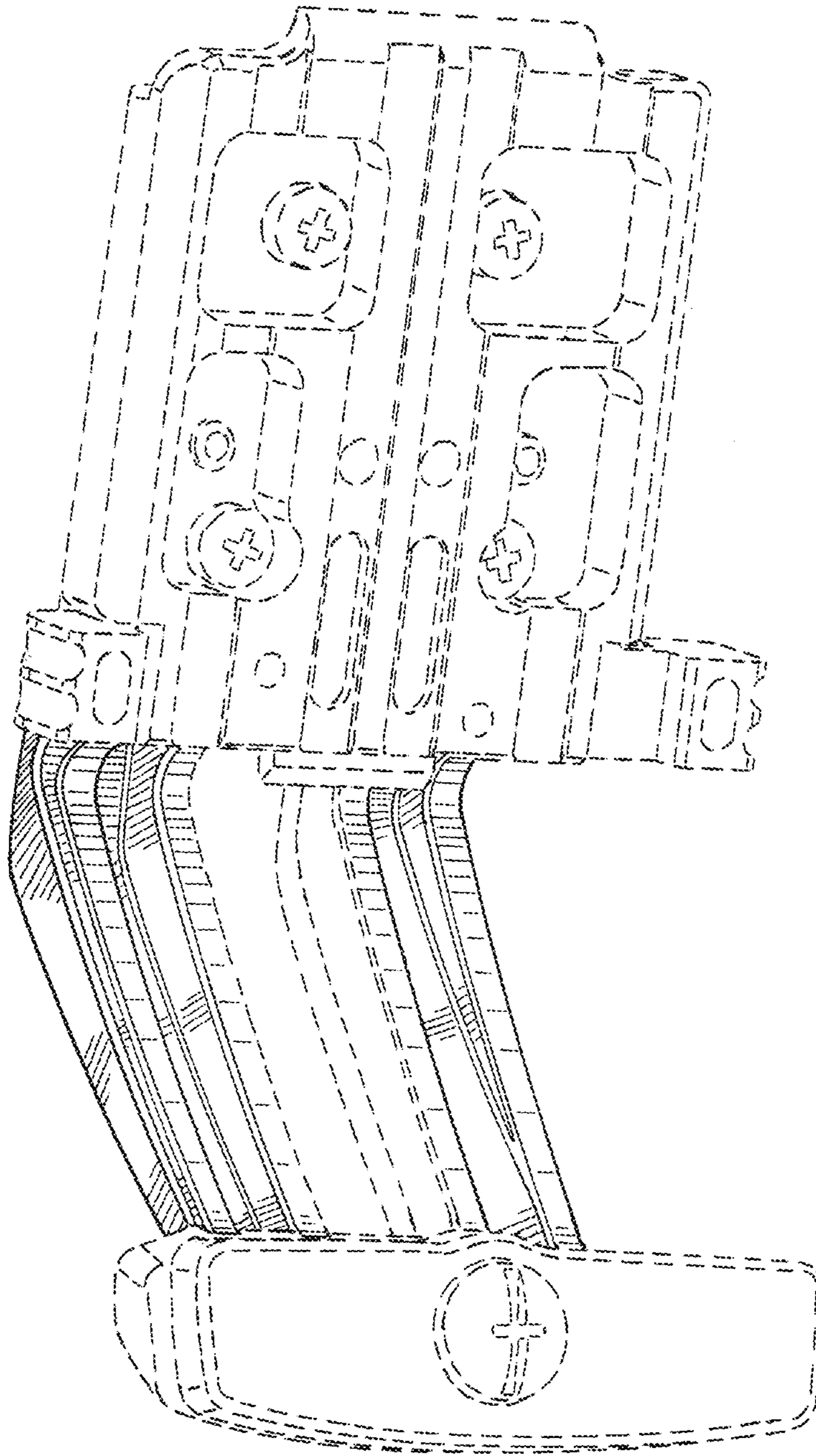

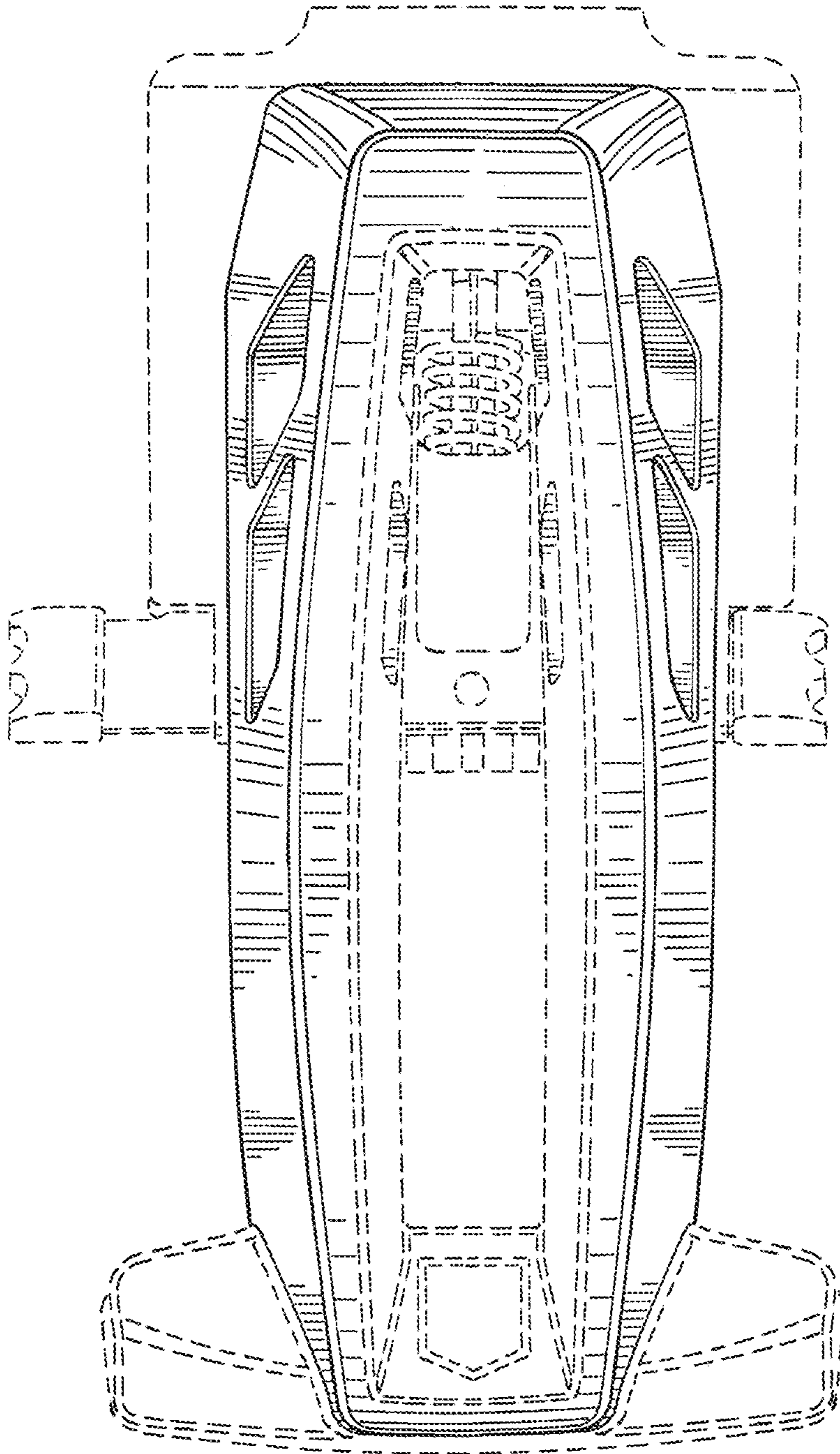

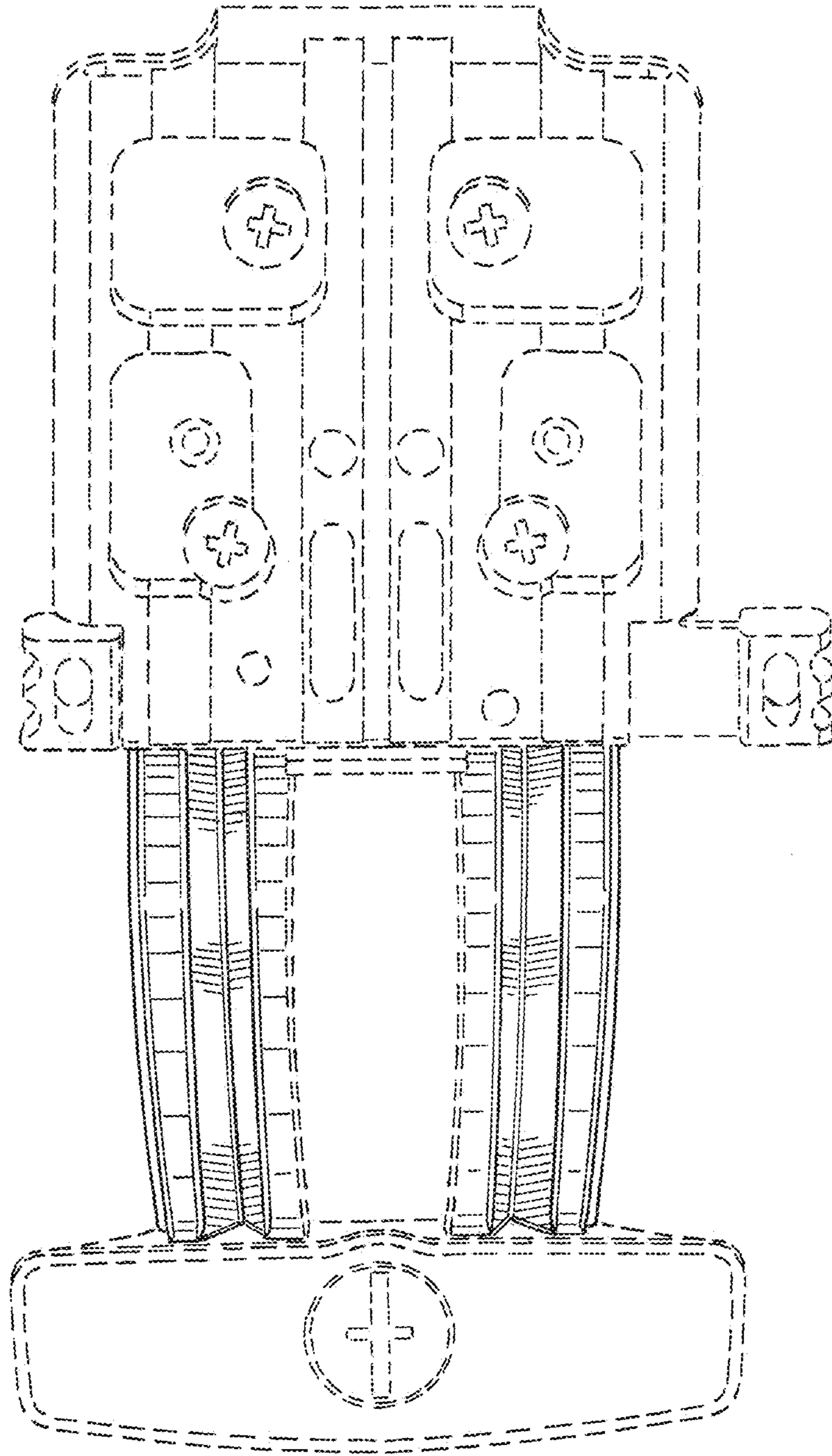

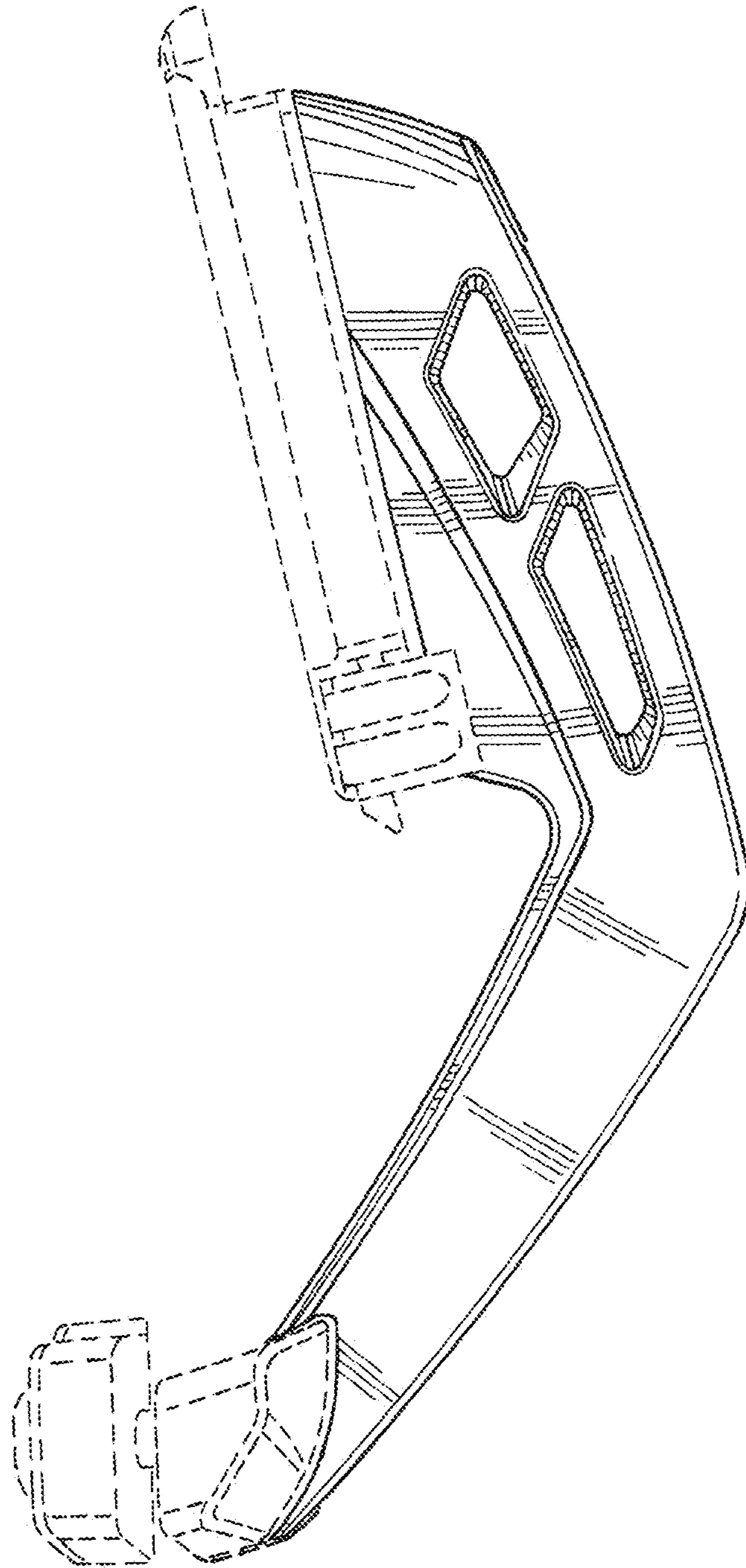

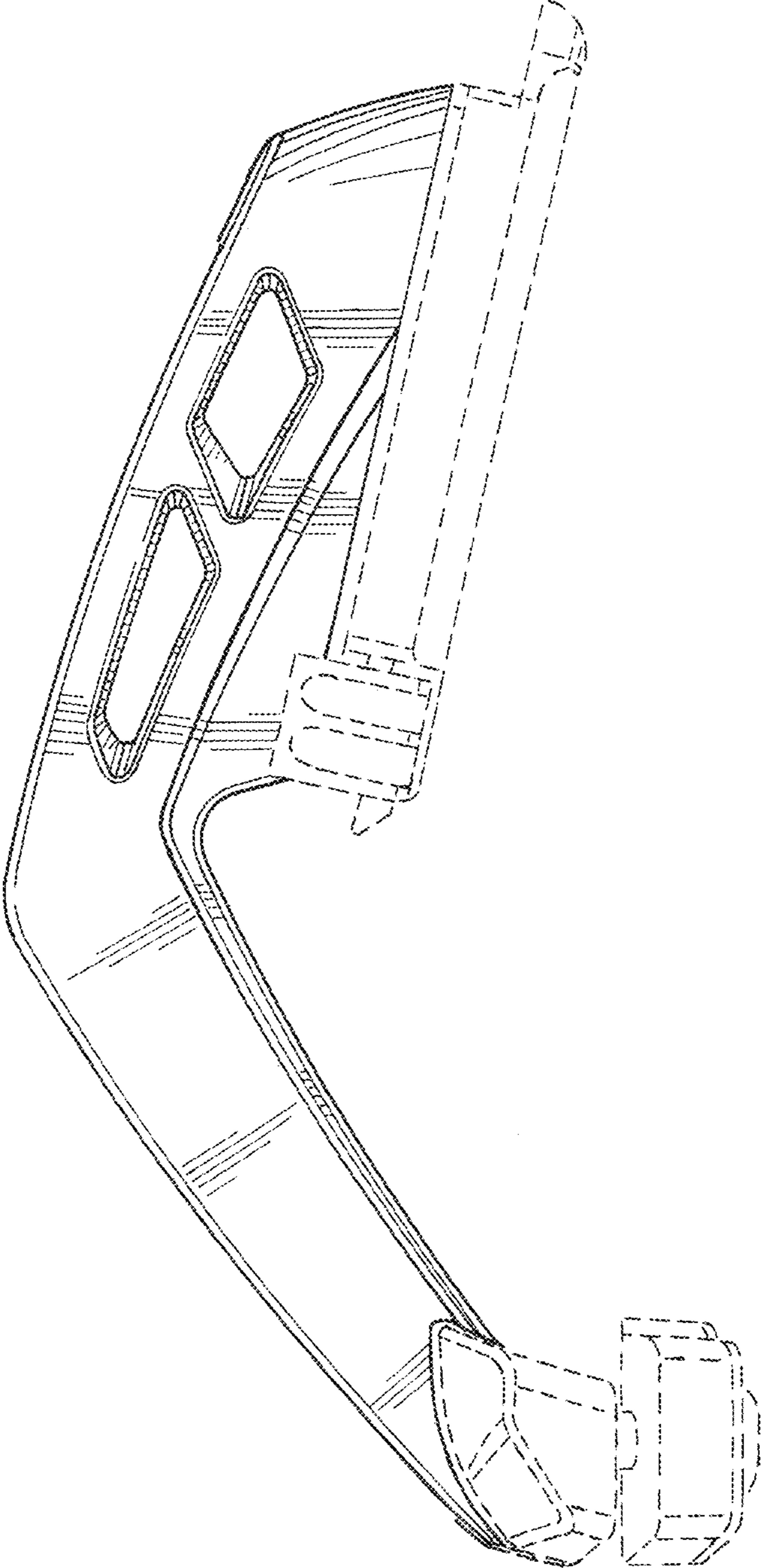

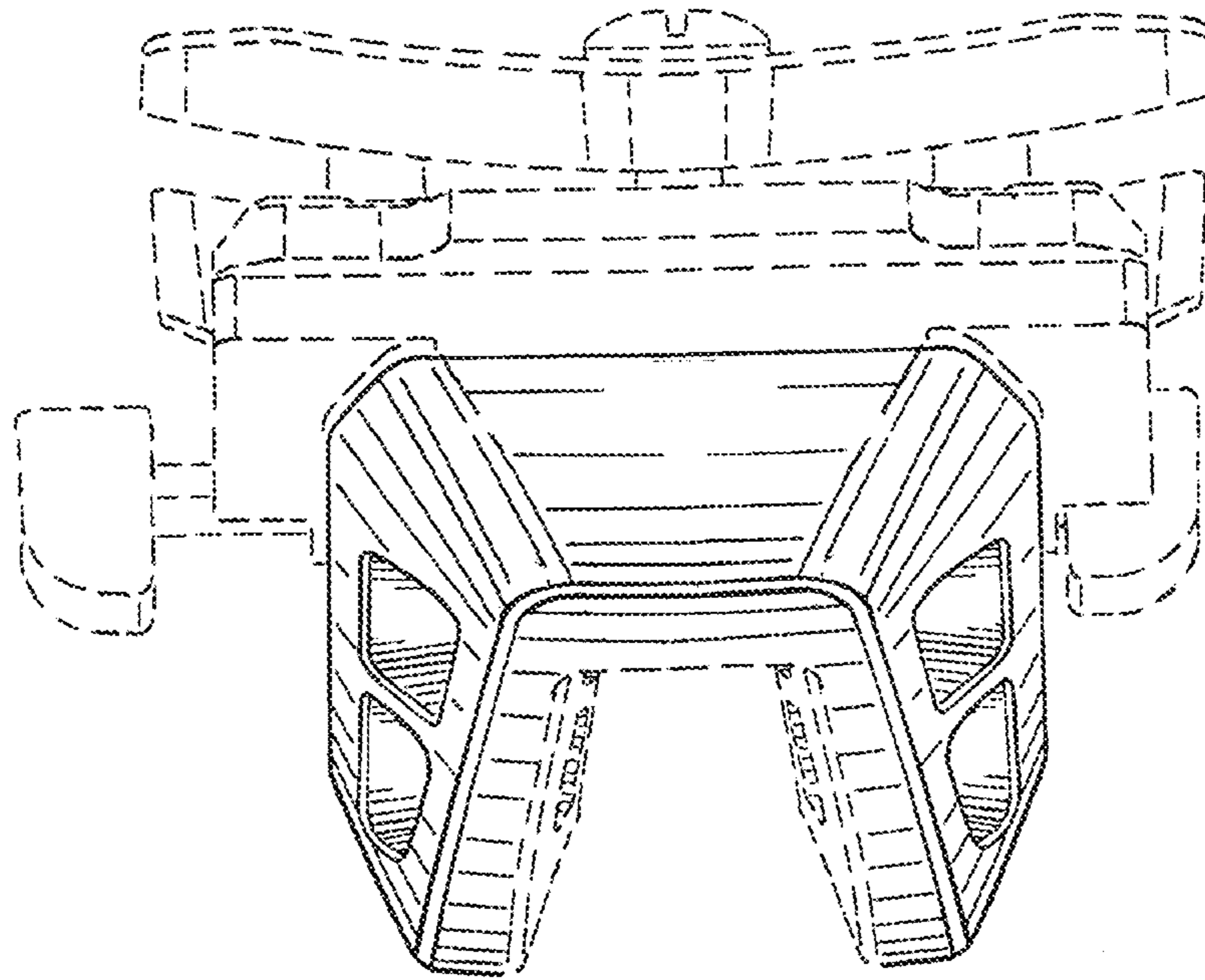

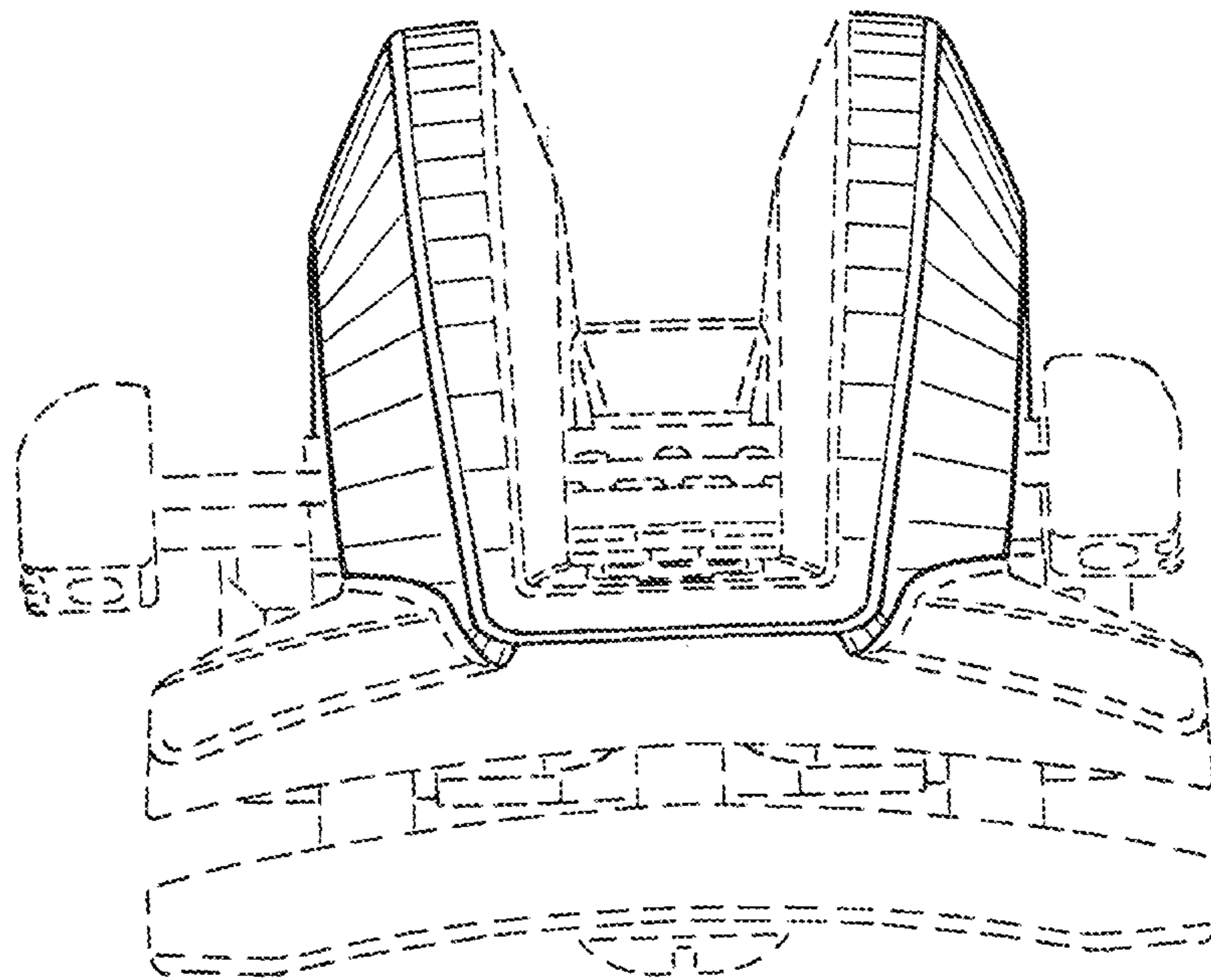

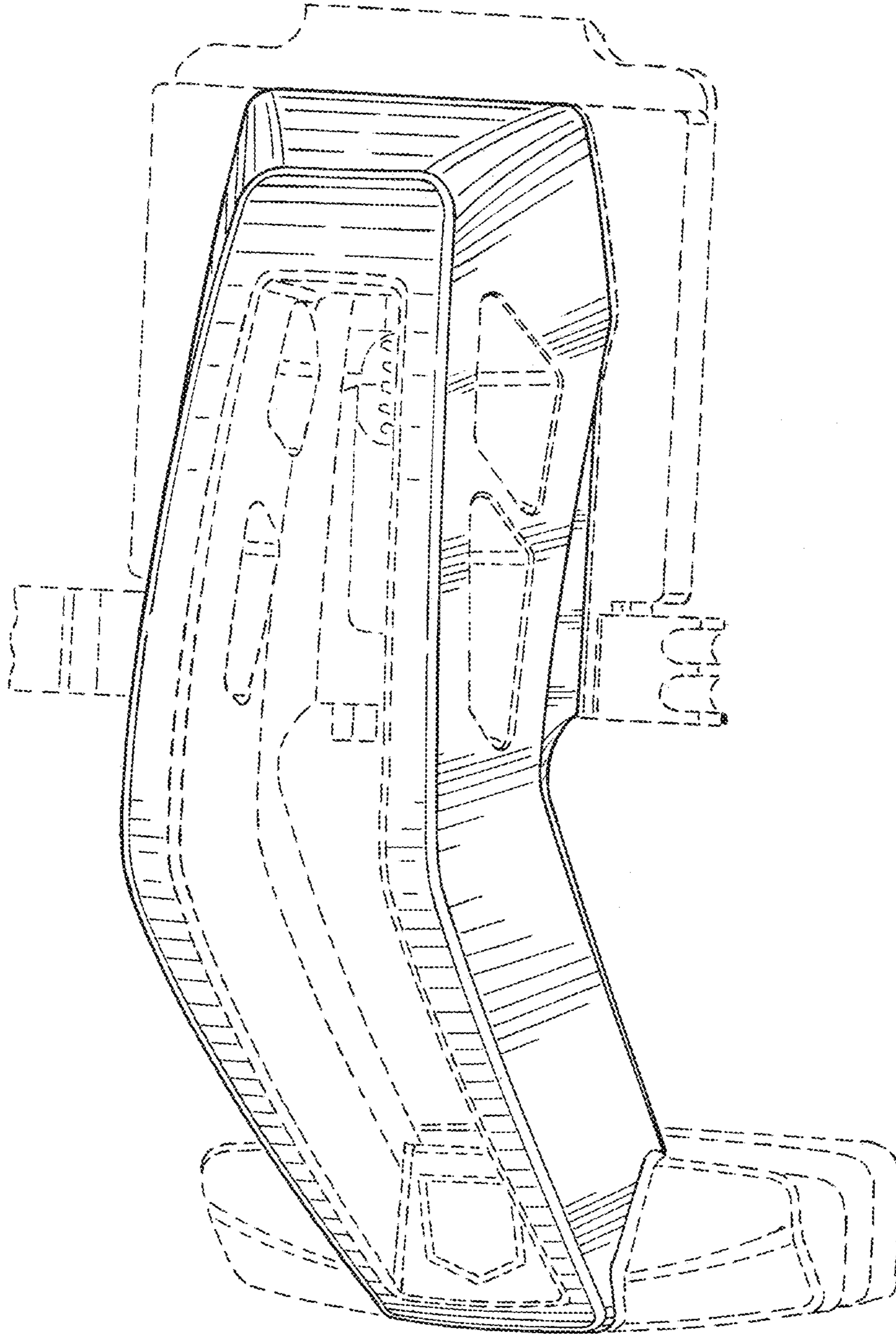

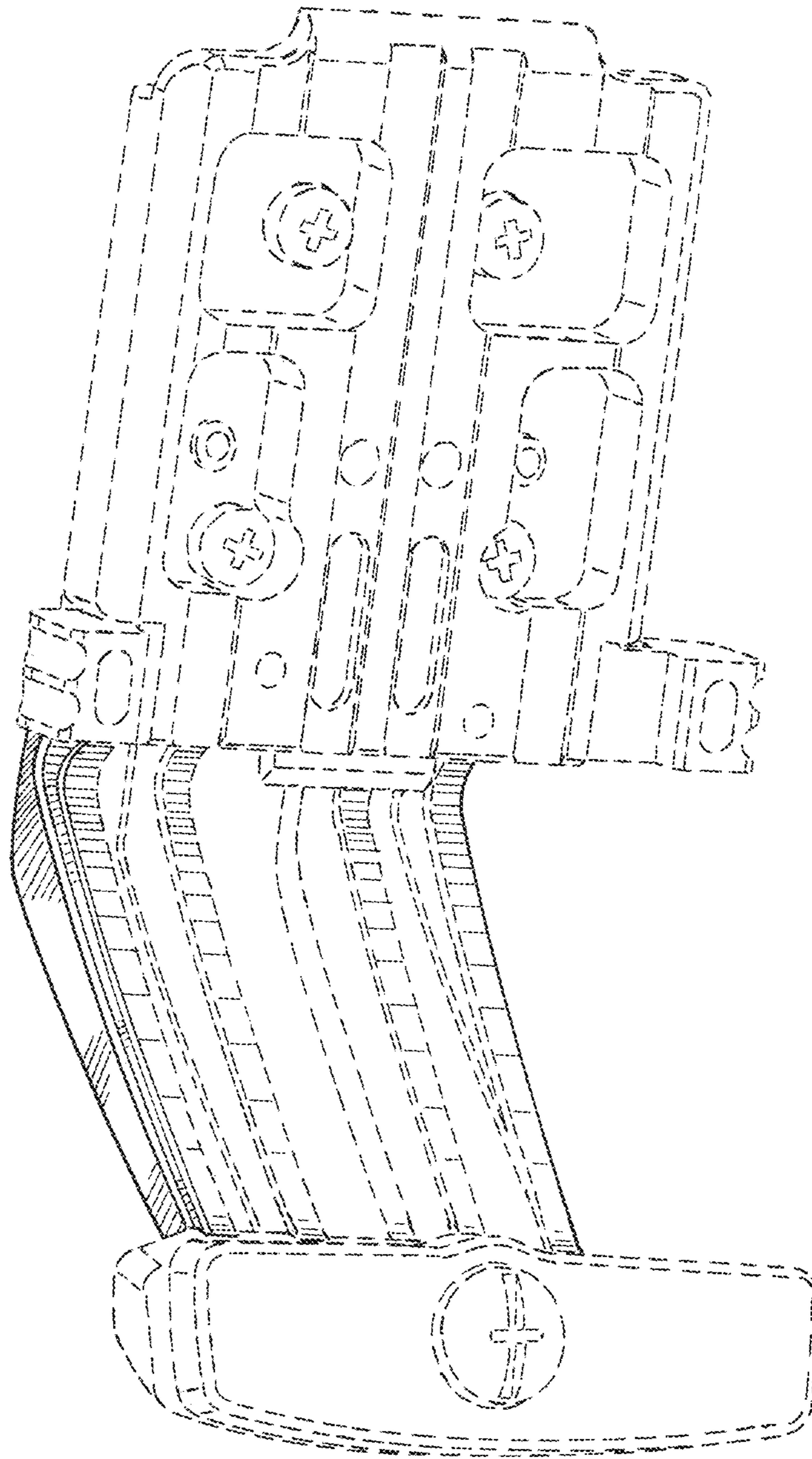

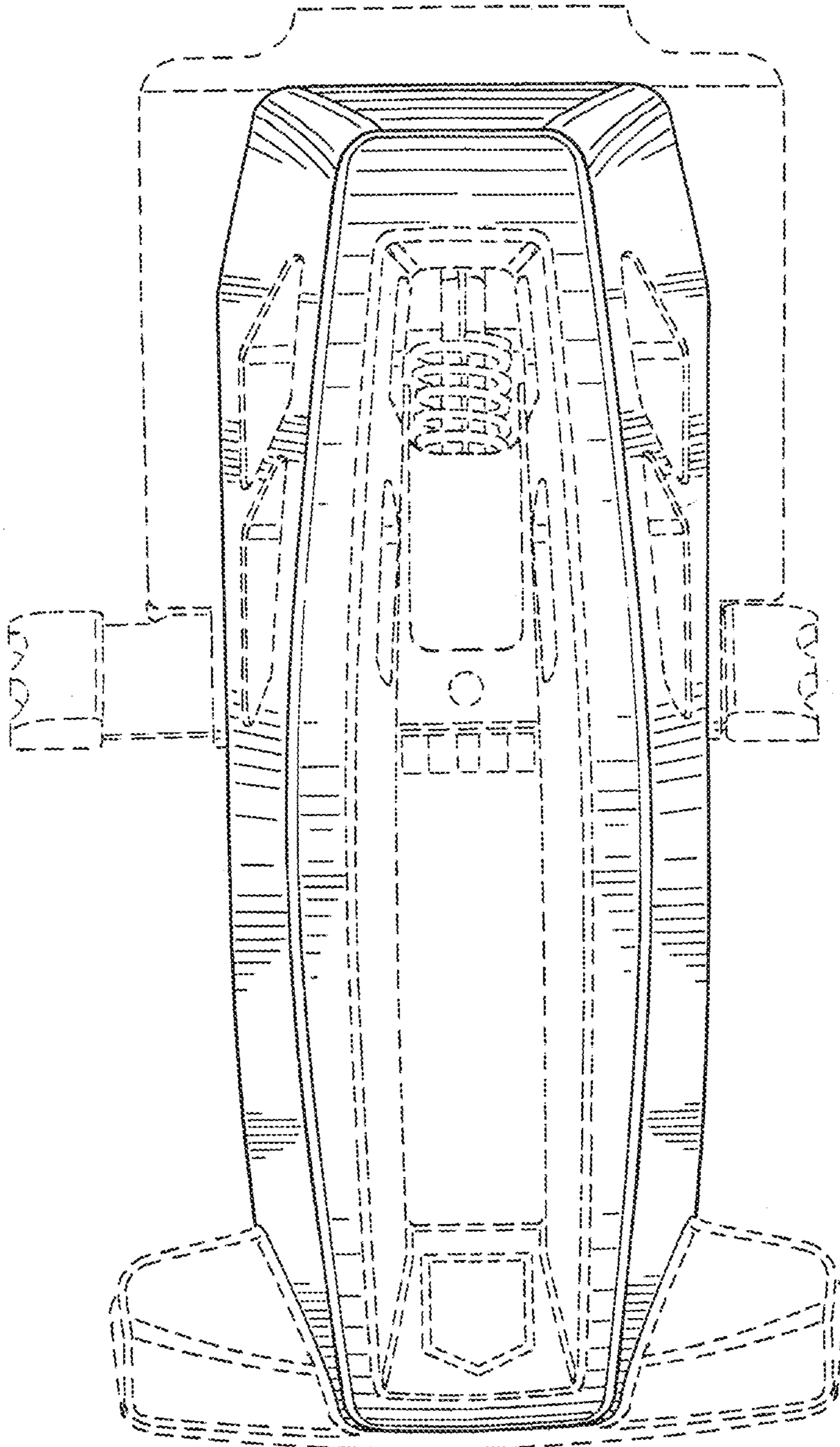

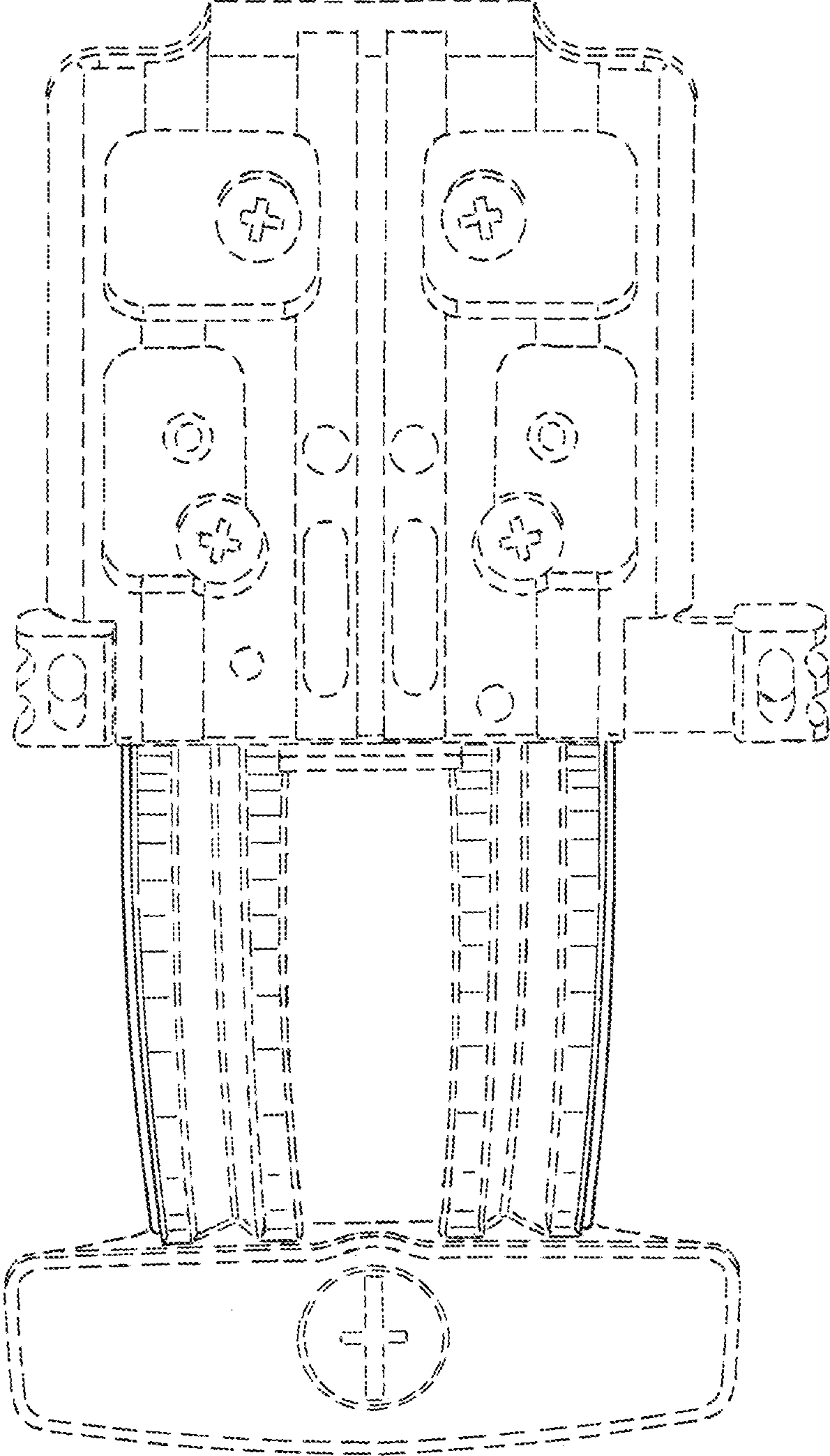

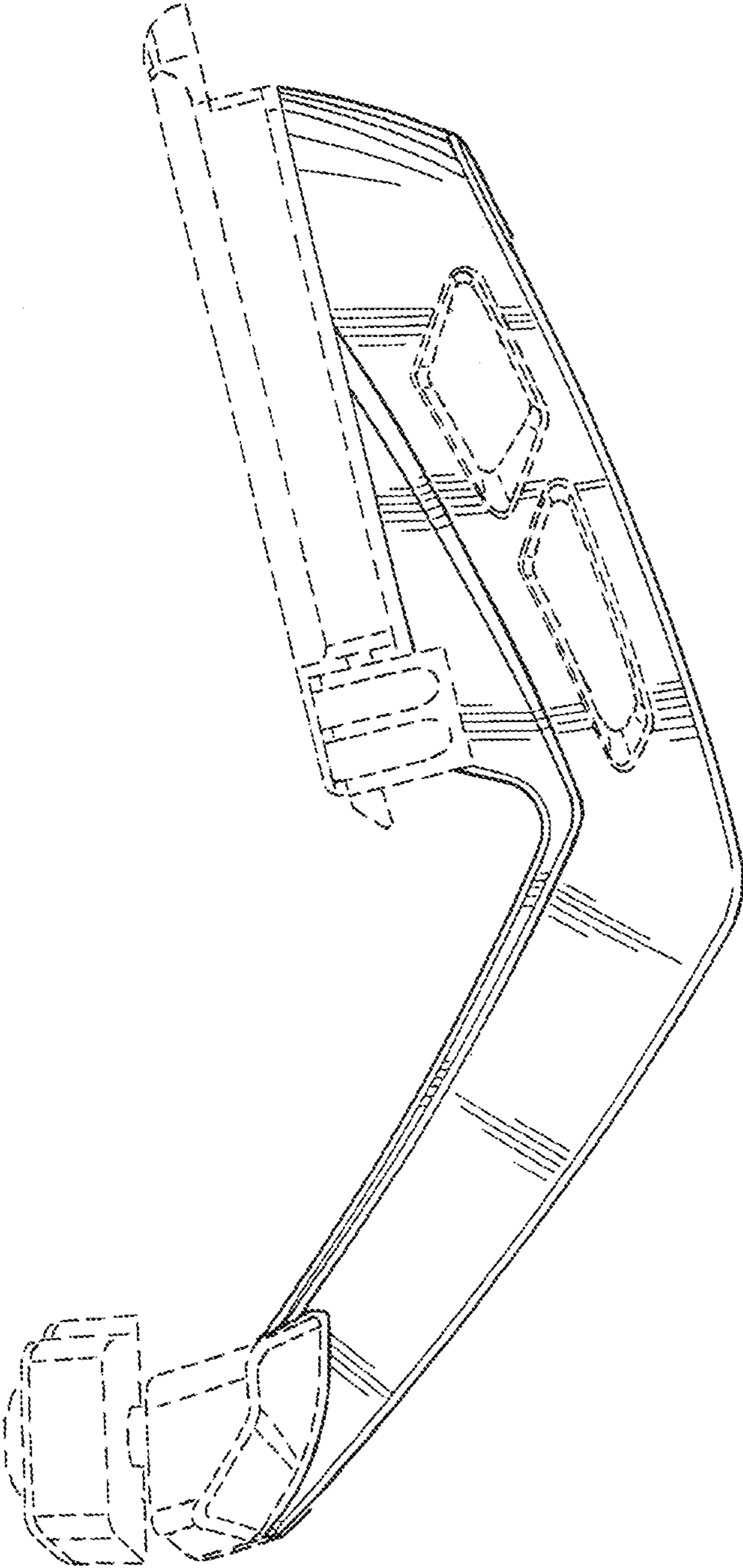

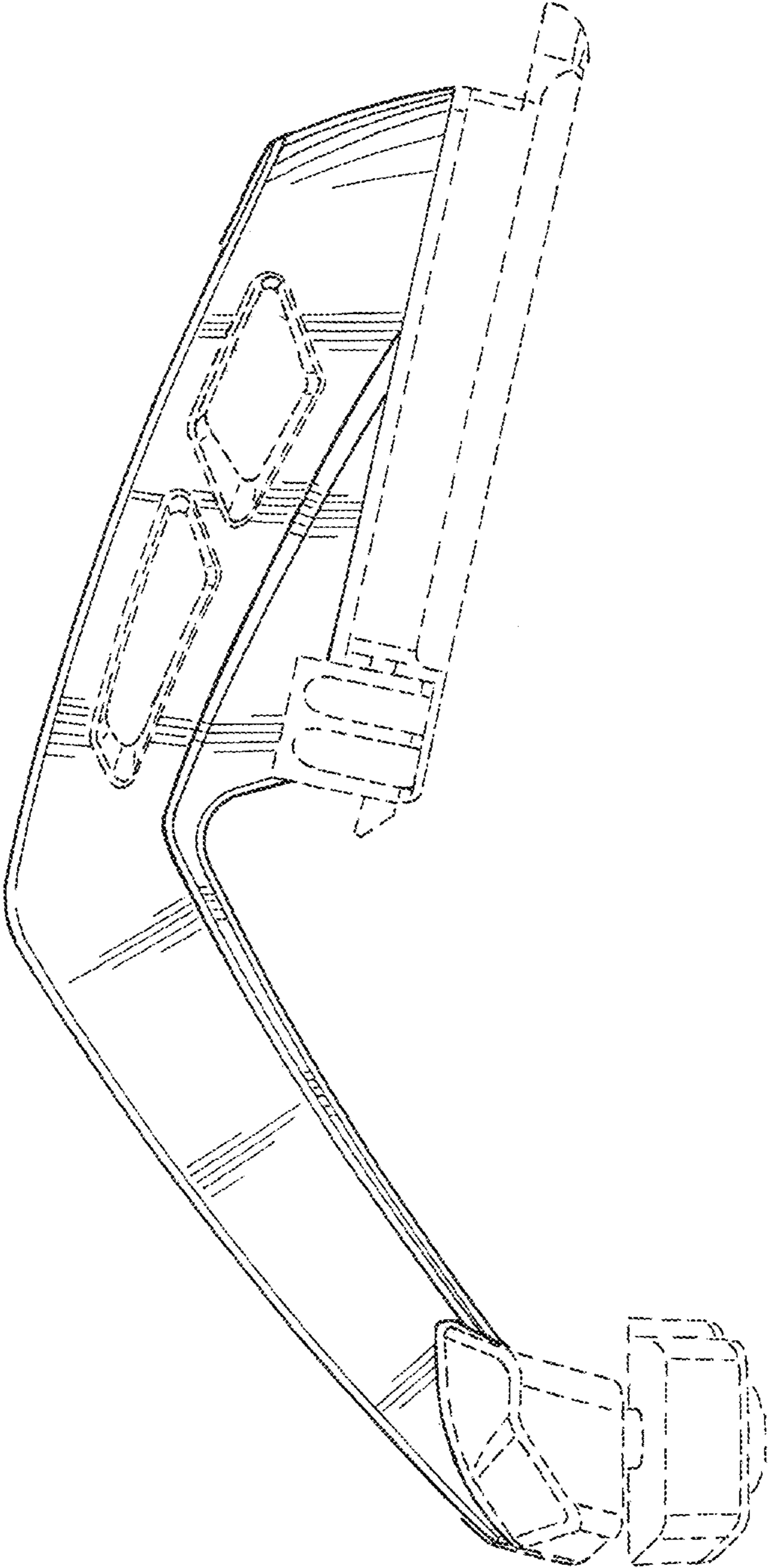

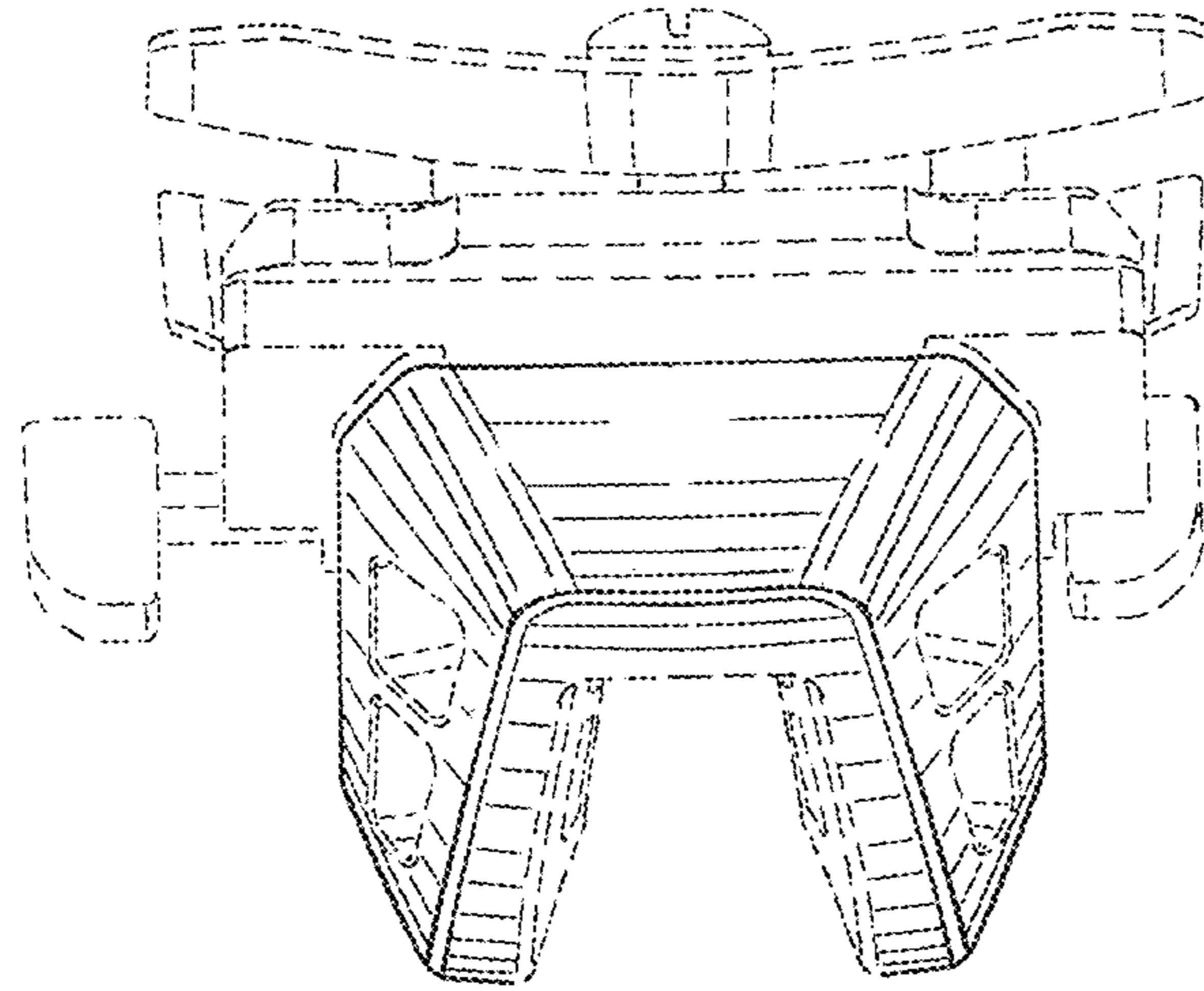

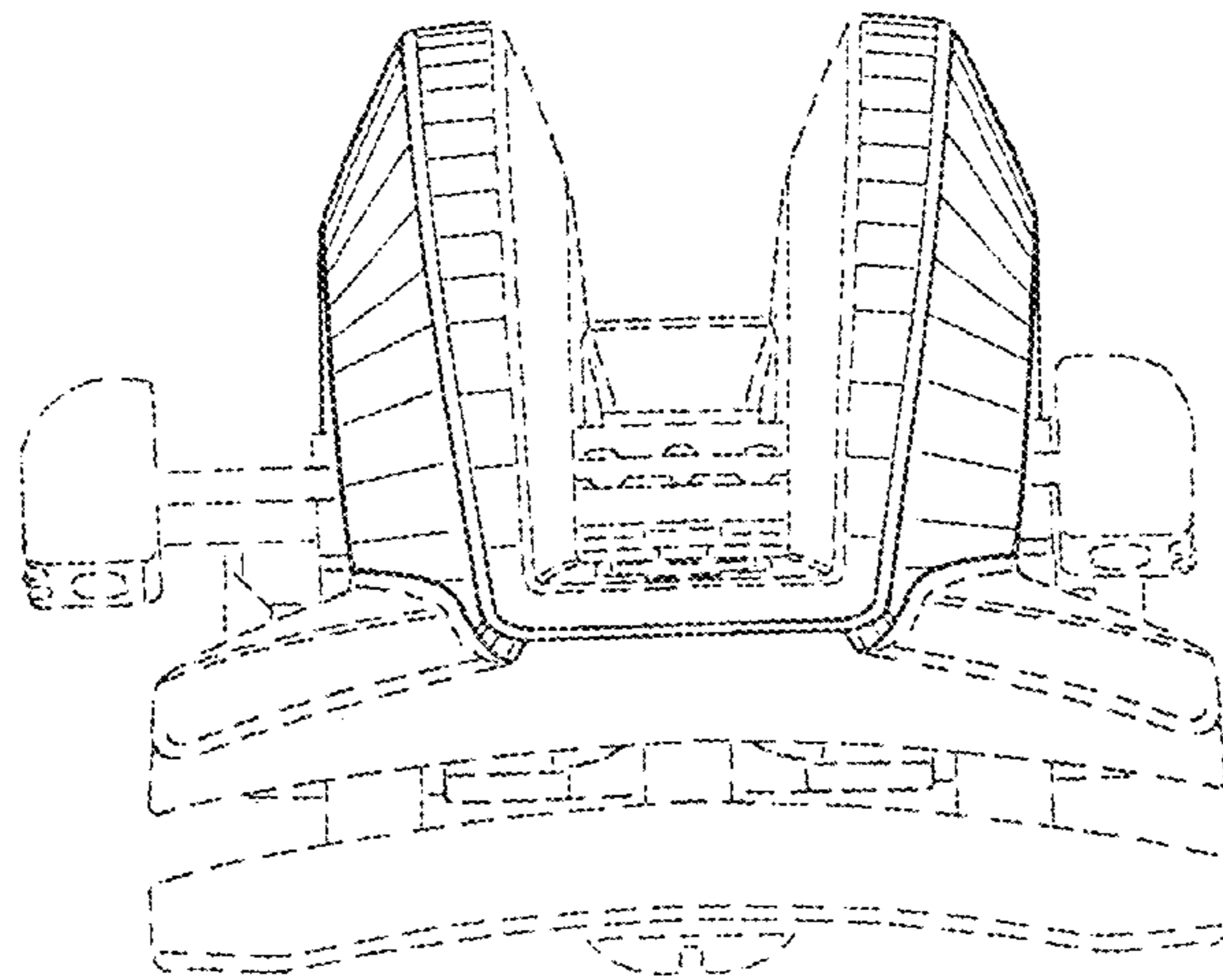
