The ornamental design for a foot sleeve for stretch device, as shown and described.

**DESCRIPTION**

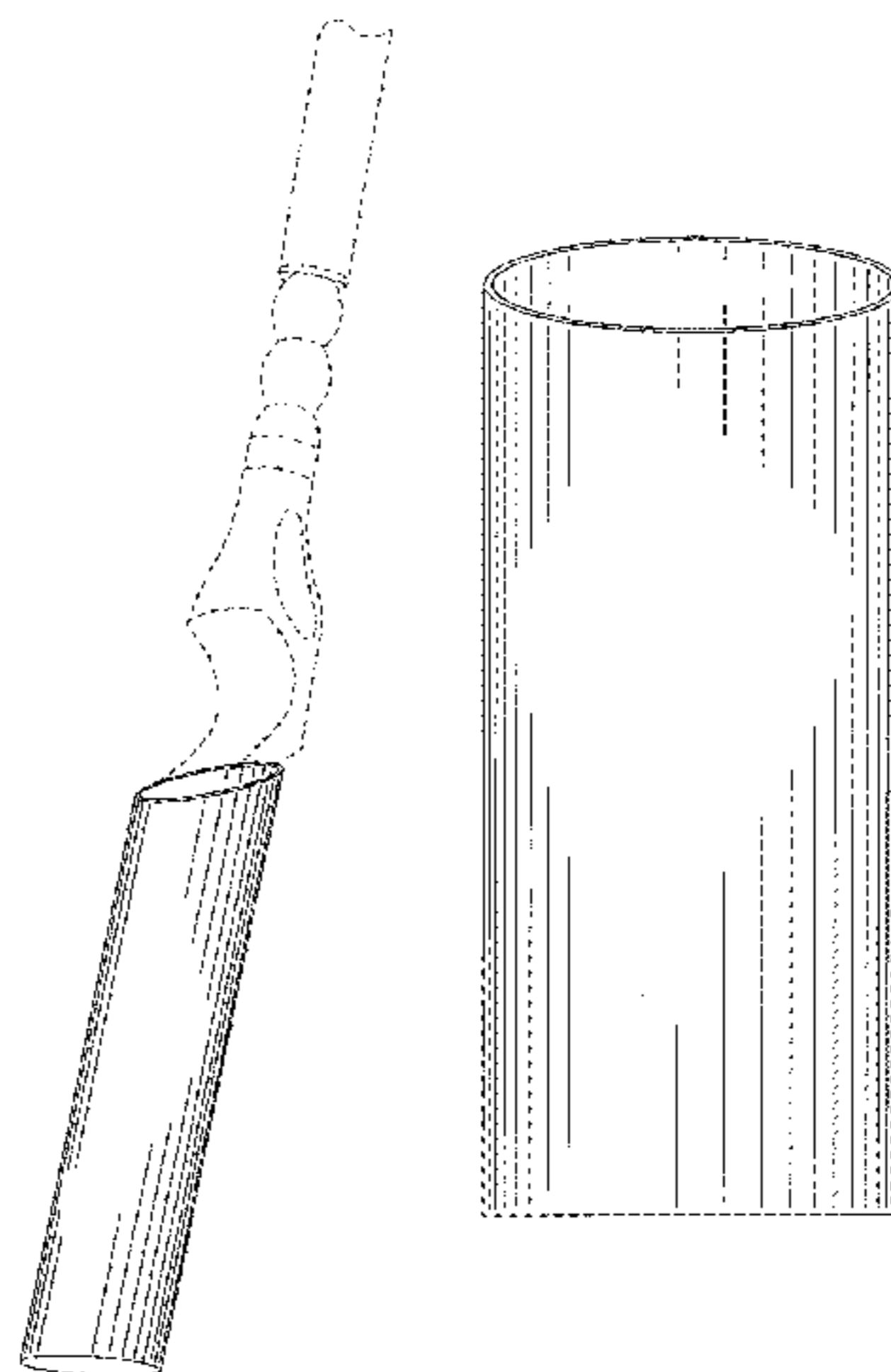
FIG. 1 is a front perspective view of a foot sleeve, shown attached to a stretch device, showing our new design; FIG. 2 is a front perspective view of a foot sleeve shown by itself; FIG. 3 is a front elevation view of the foot sleeve; FIG. 4 is a rear elevation view of the foot sleeve; FIG. 5 is a right elevation view of the foot sleeve; FIG. 6 is a left elevation view of the foot sleeve; FIG. 7 is a top plan view of the foot sleeve; and, FIG. 8 is a bottom plan view of the foot sleeve. The broken lines showing the stretch device are for the purpose of illustrating environmental structure and form no part of the claimed design.

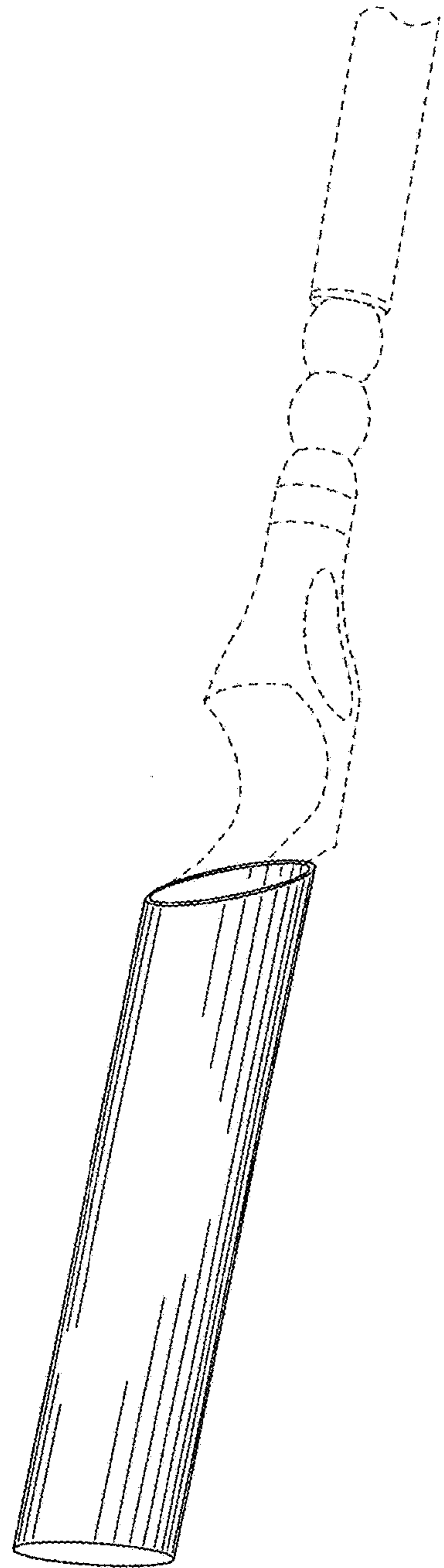

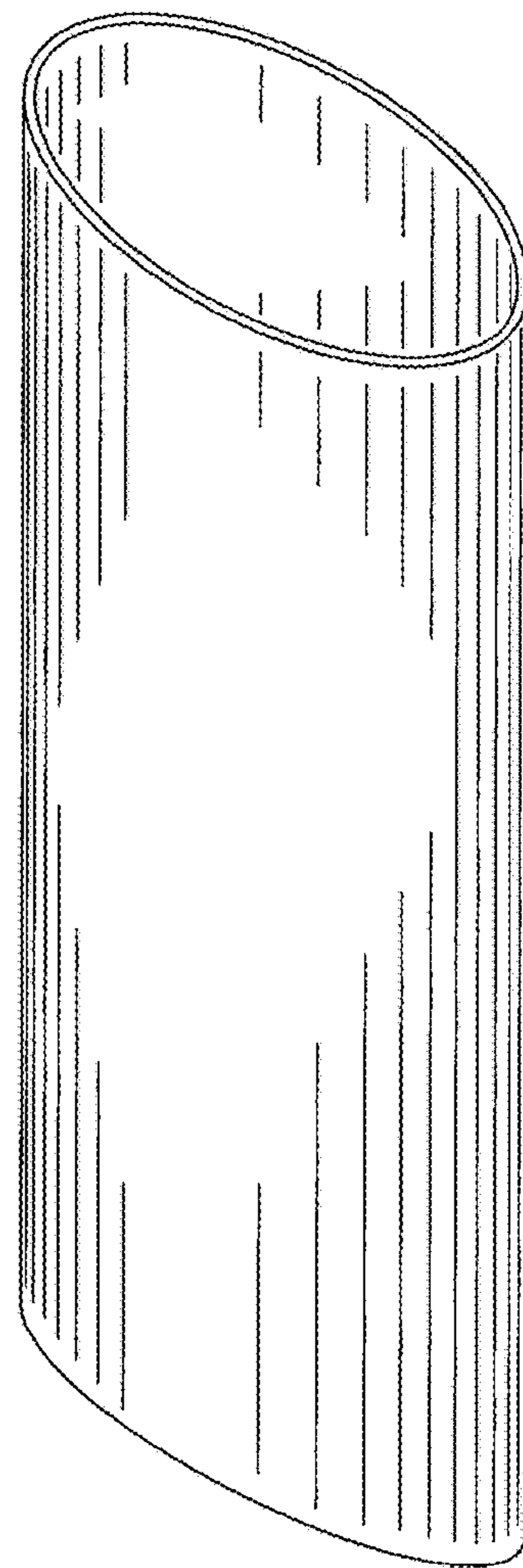

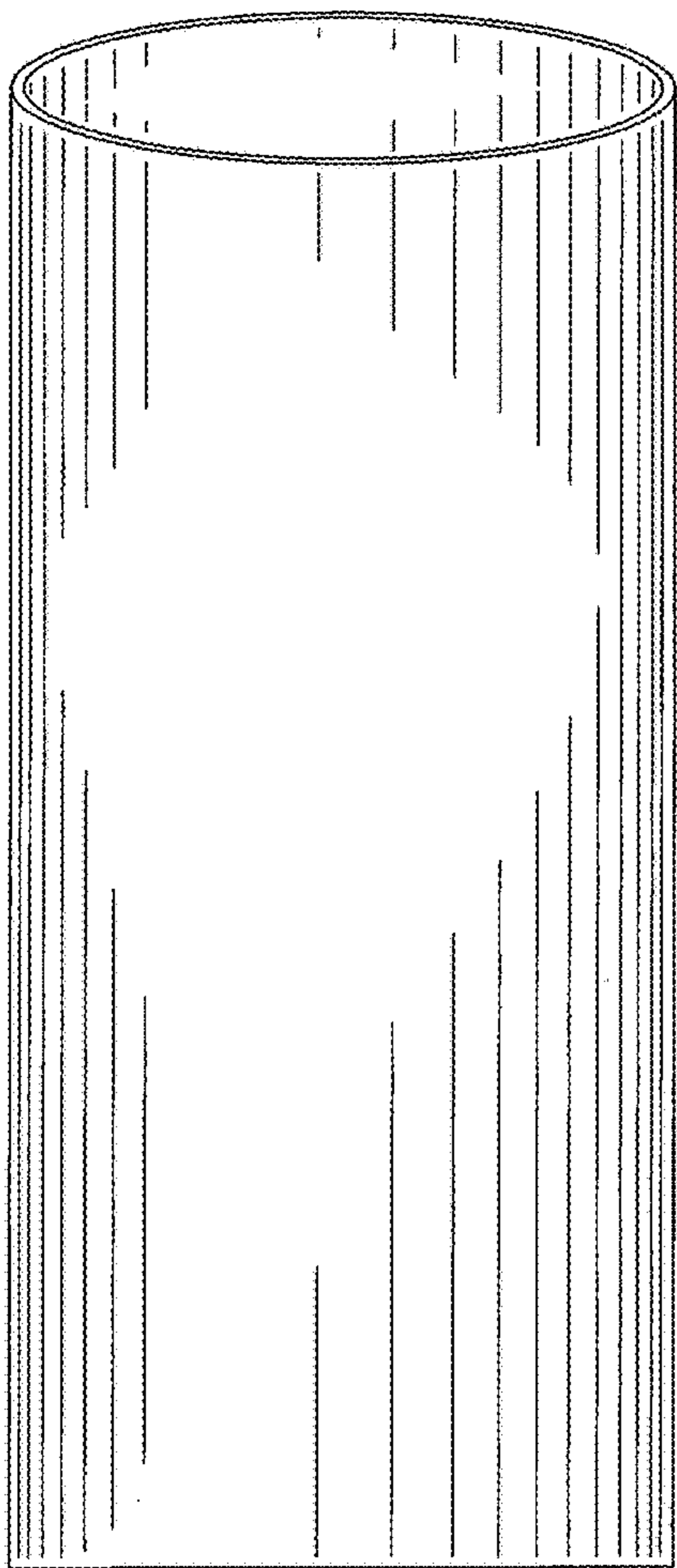

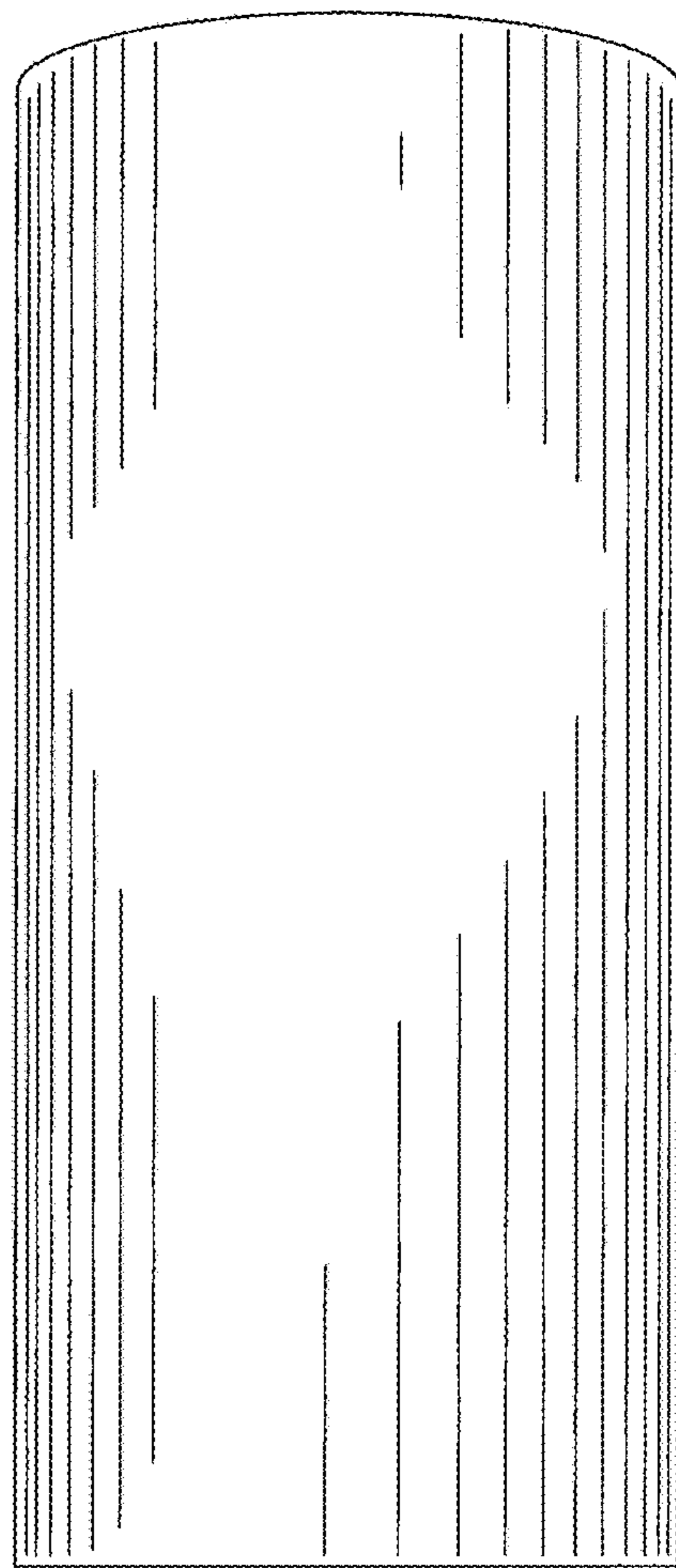

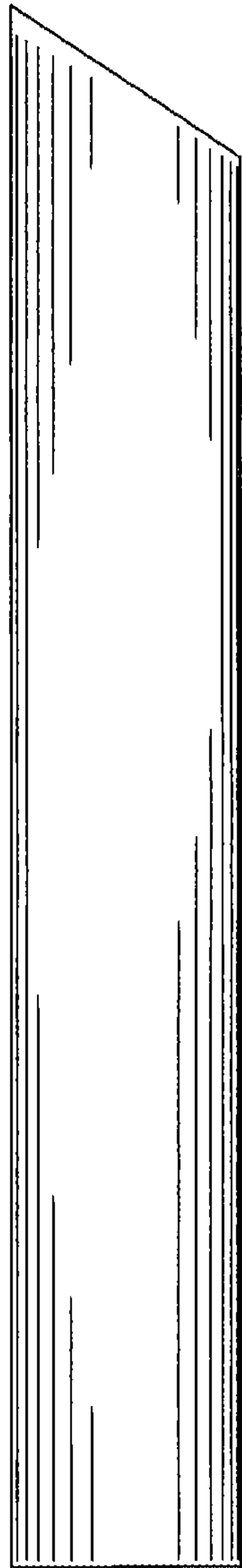

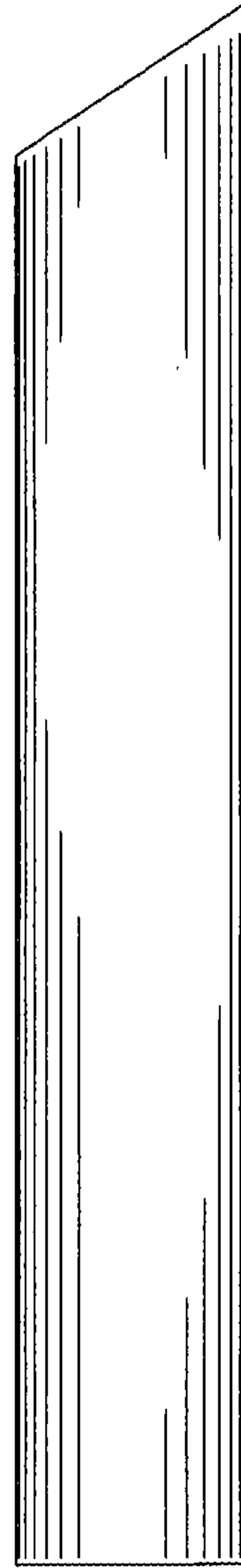

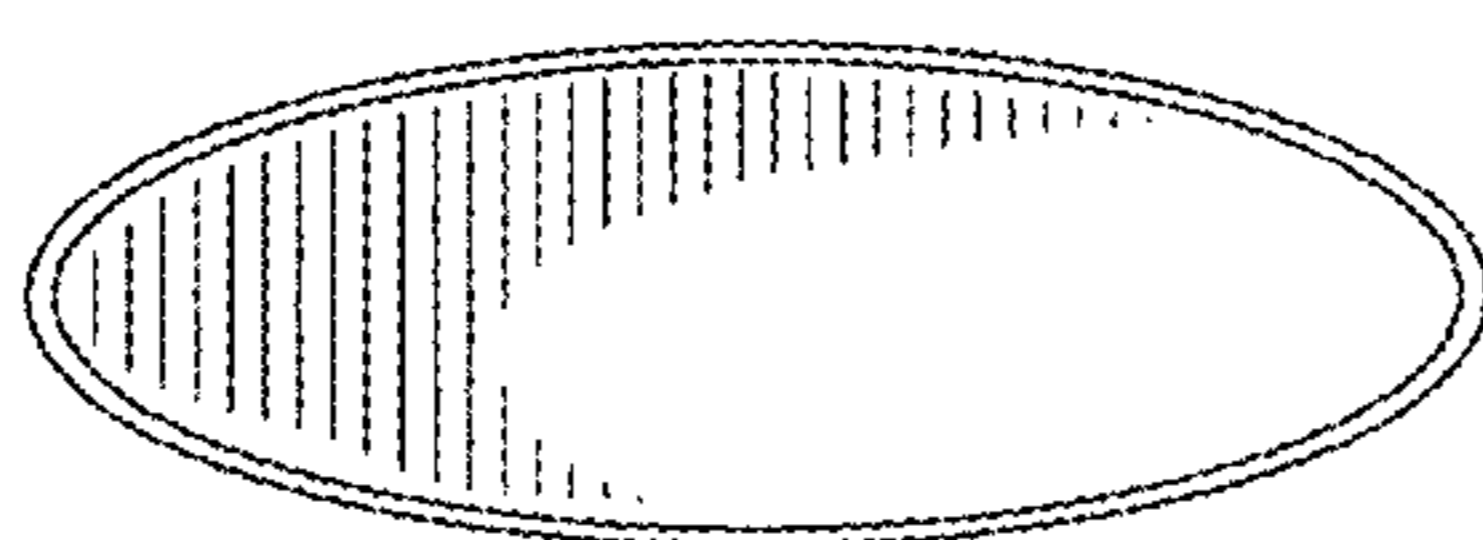

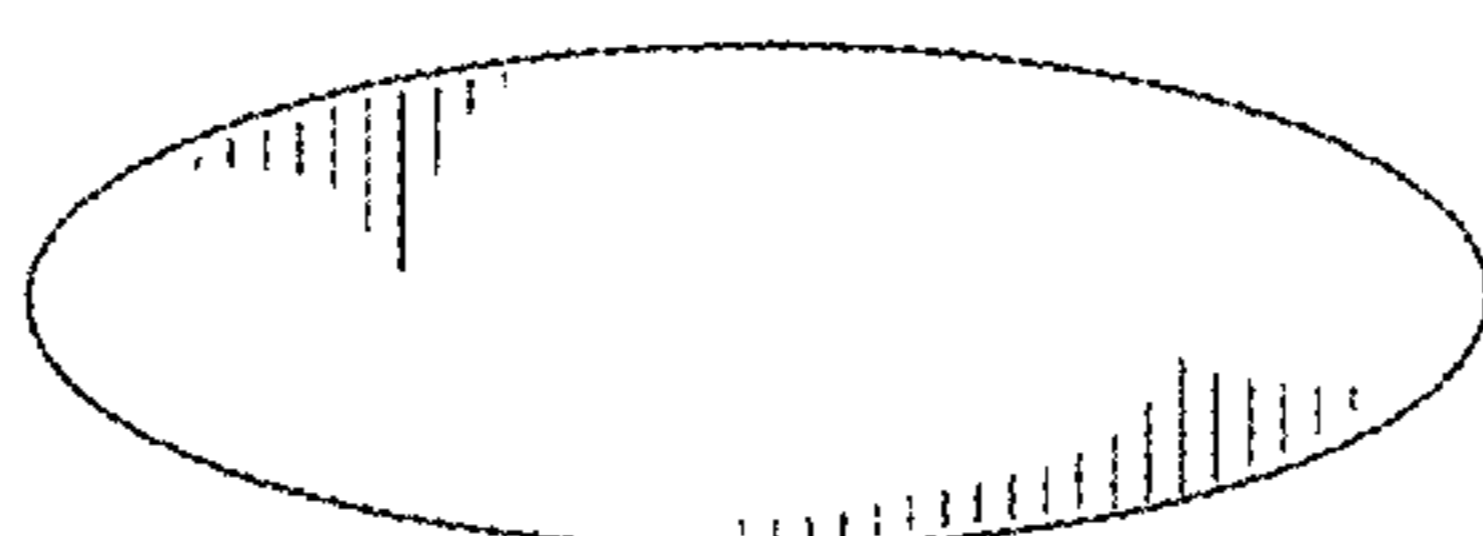
