FIG. 2 is a first perspective view thereof; and,

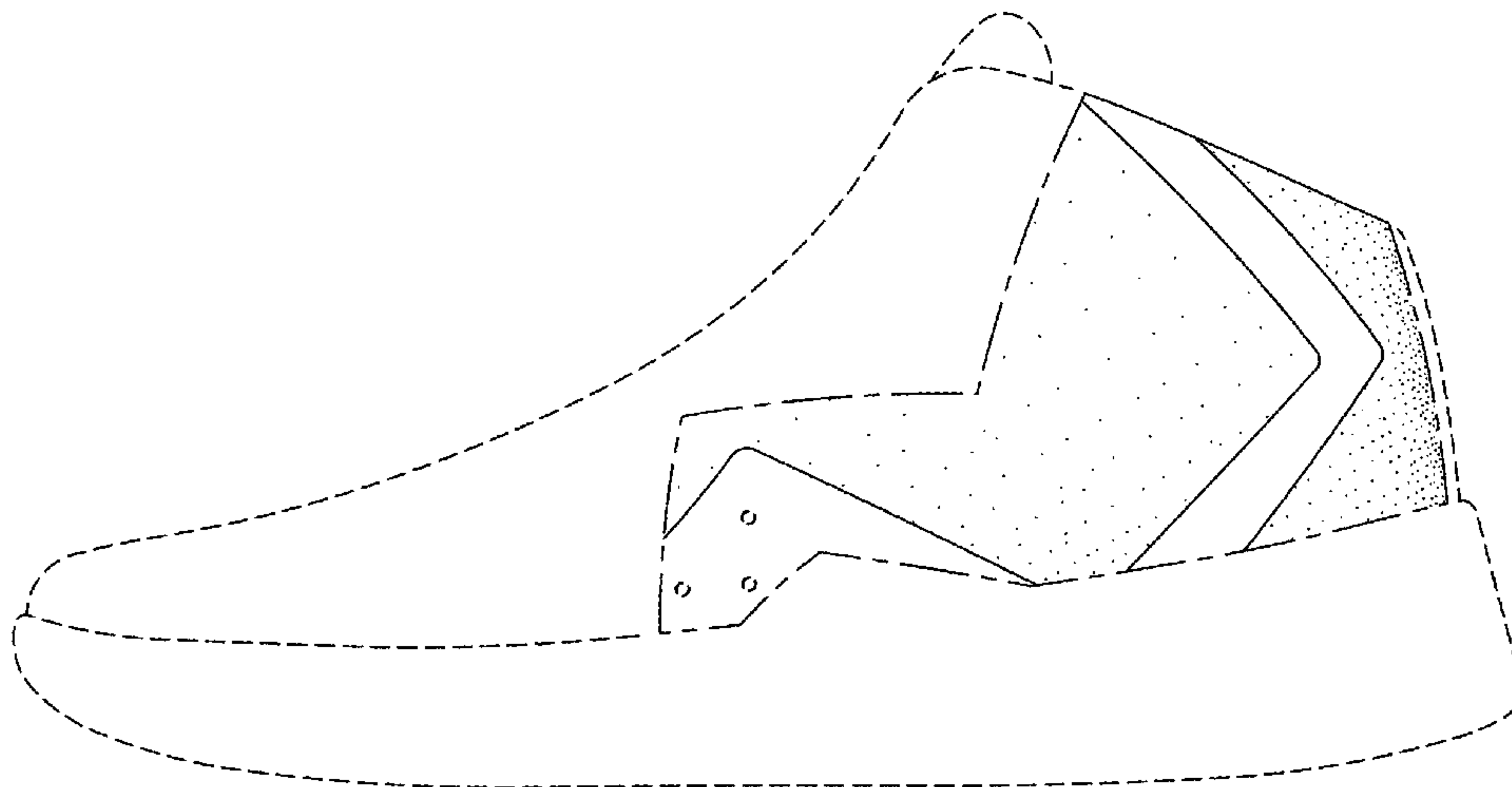
FIG. 3 is a second perspective view thereof.

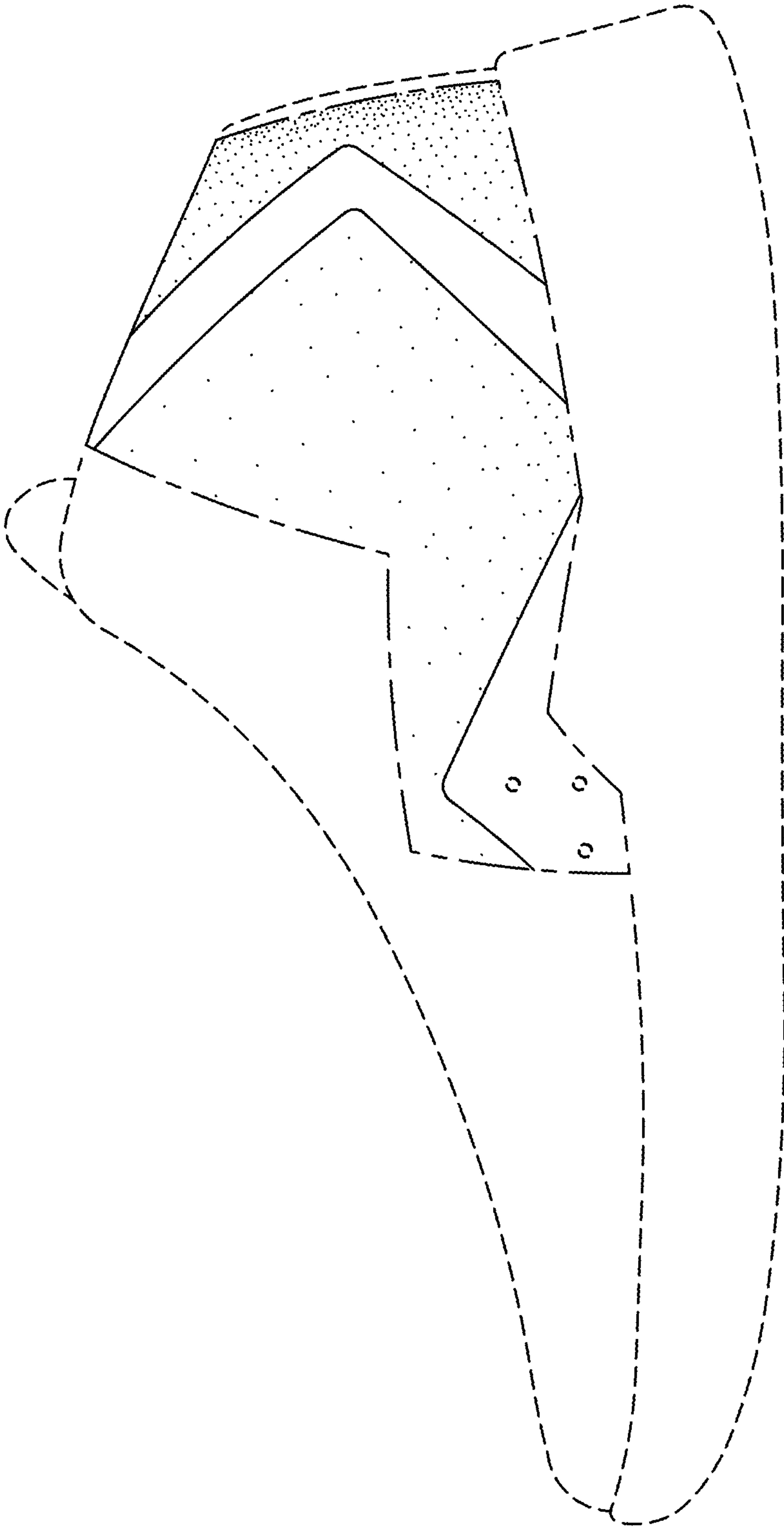

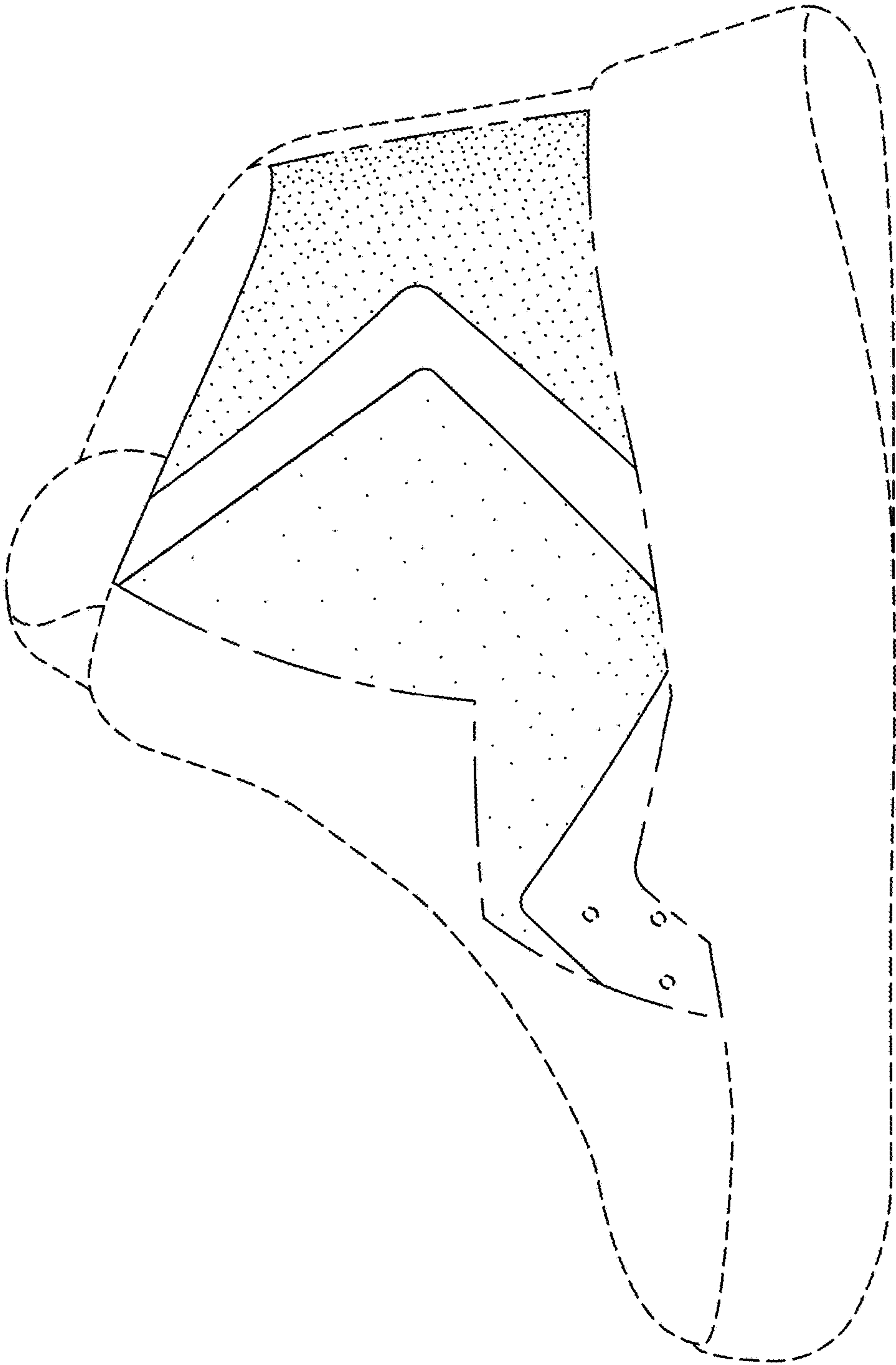

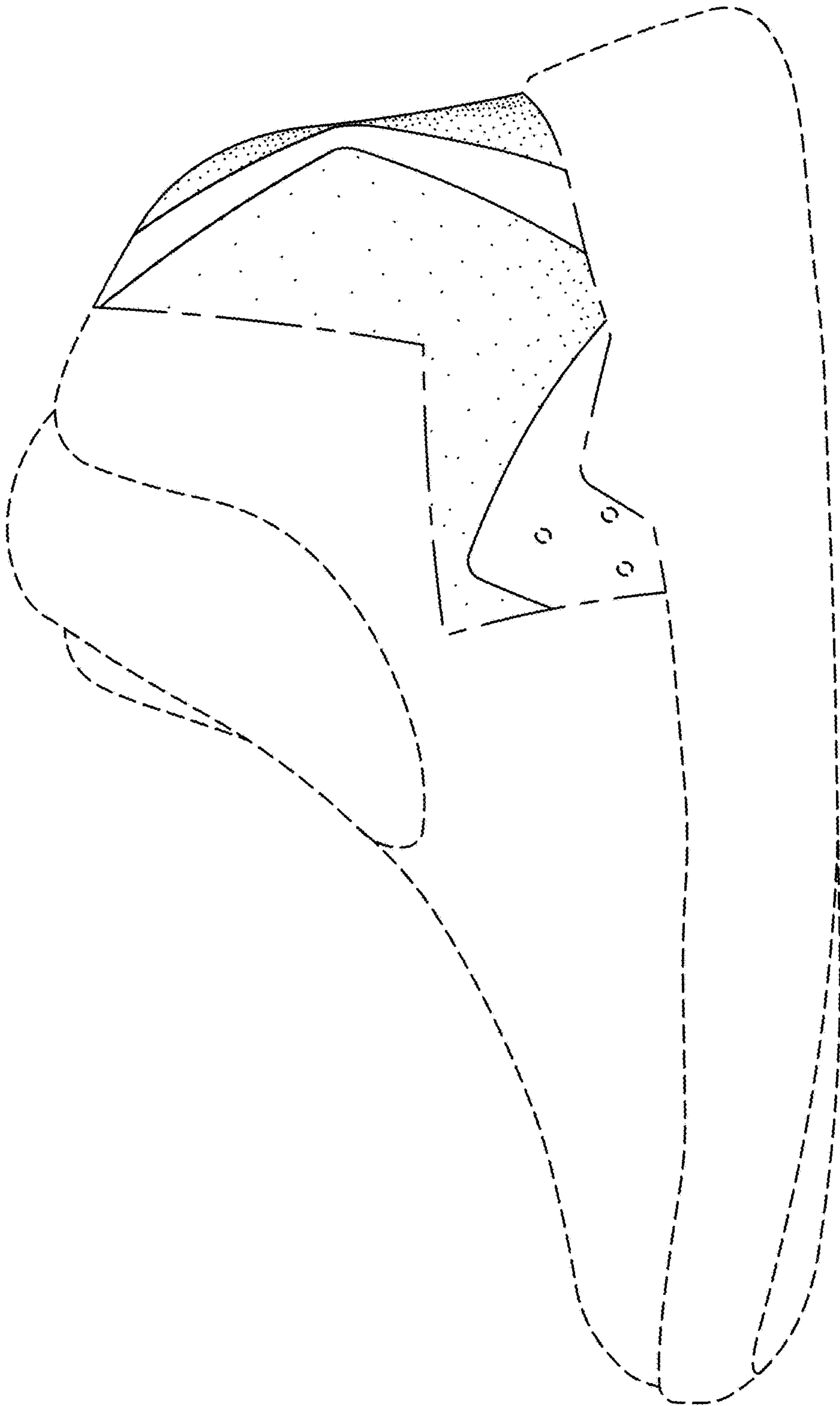
