(57) **CLAIM**

I claim the ornamental design for a glasses holder, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view an inventive glasses holder in accordance with the disclosure;

FIG. 2 shows a front view of the inventive glasses holder of FIG. 1;

FIG. 3 shows a back side view of the inventive glasses holder of FIG. 1;

FIG. 4 shows a left side view of the inventive glasses holder of FIG. 1;

FIG. 5 shows a right side view of the inventive glasses holder of FIG. 1;

FIG. 6 shows a top view of the inventive glasses holder of FIG. 1;

FIG. 7 shows a bottom view of the inventive glasses holder of FIG. 1

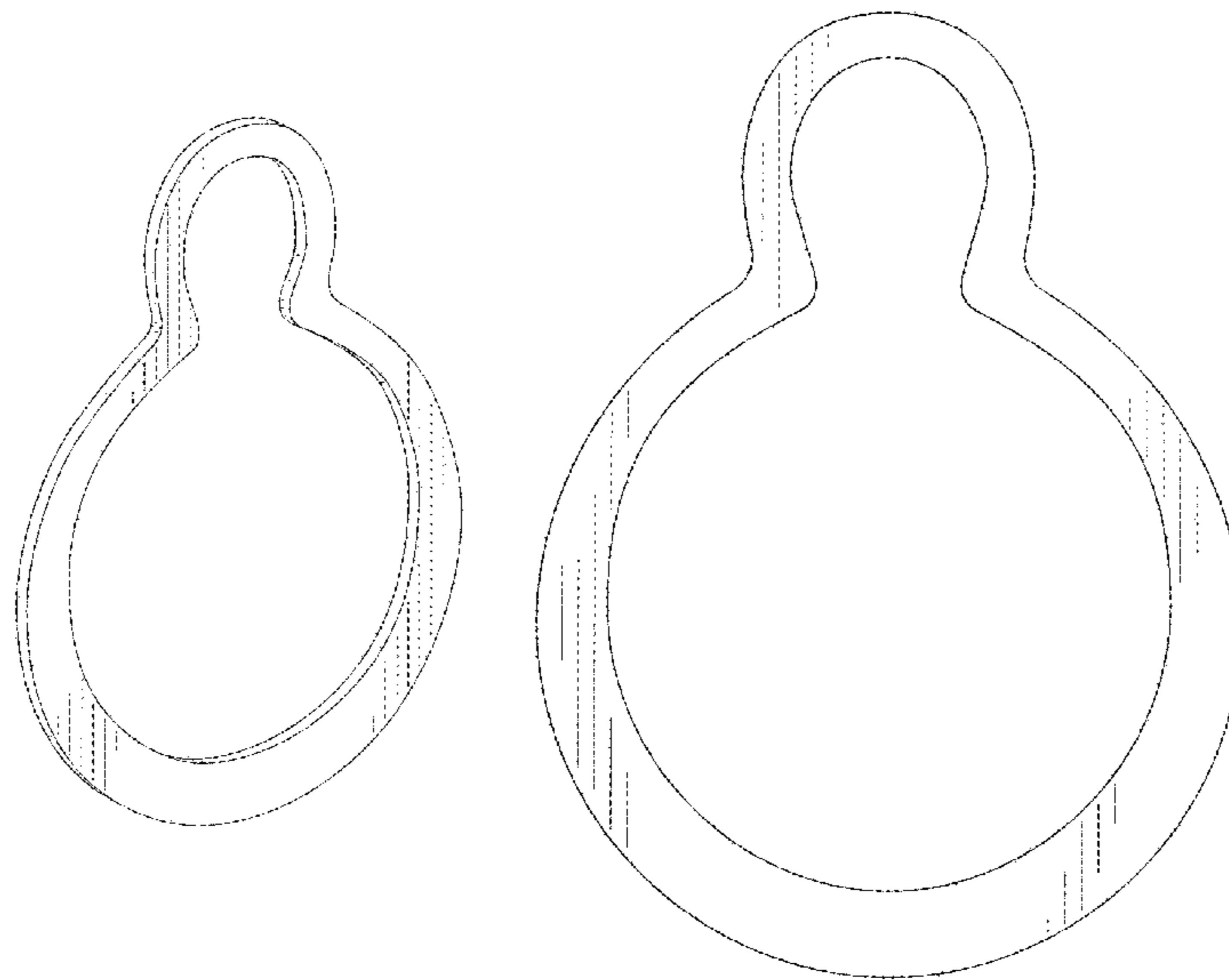
FIG. 8 shows a front view of the inventive glasses holder of FIG. 1 attached to clothing in accordance with the disclosure; and,

FIG. 9 shows a front view of the inventive glasses holder of FIG. 1 attached to clothing and holding glasses in accordance with the disclosure.

In the FIG. 8 and FIG. 9 views, portions of the claimed sunglasses holder seen in the FIG. 1 through FIG. 7 views are obscured by the unclaimed environmental structure shown with the design in these views.

Any surfaces of the design not shown, including interior surfaces, form no part of the claimed design. The broken lines depict environmental structure associated with the glasses holder in a condition of use. The broken lines and structure they depict also form no part of the claimed design.

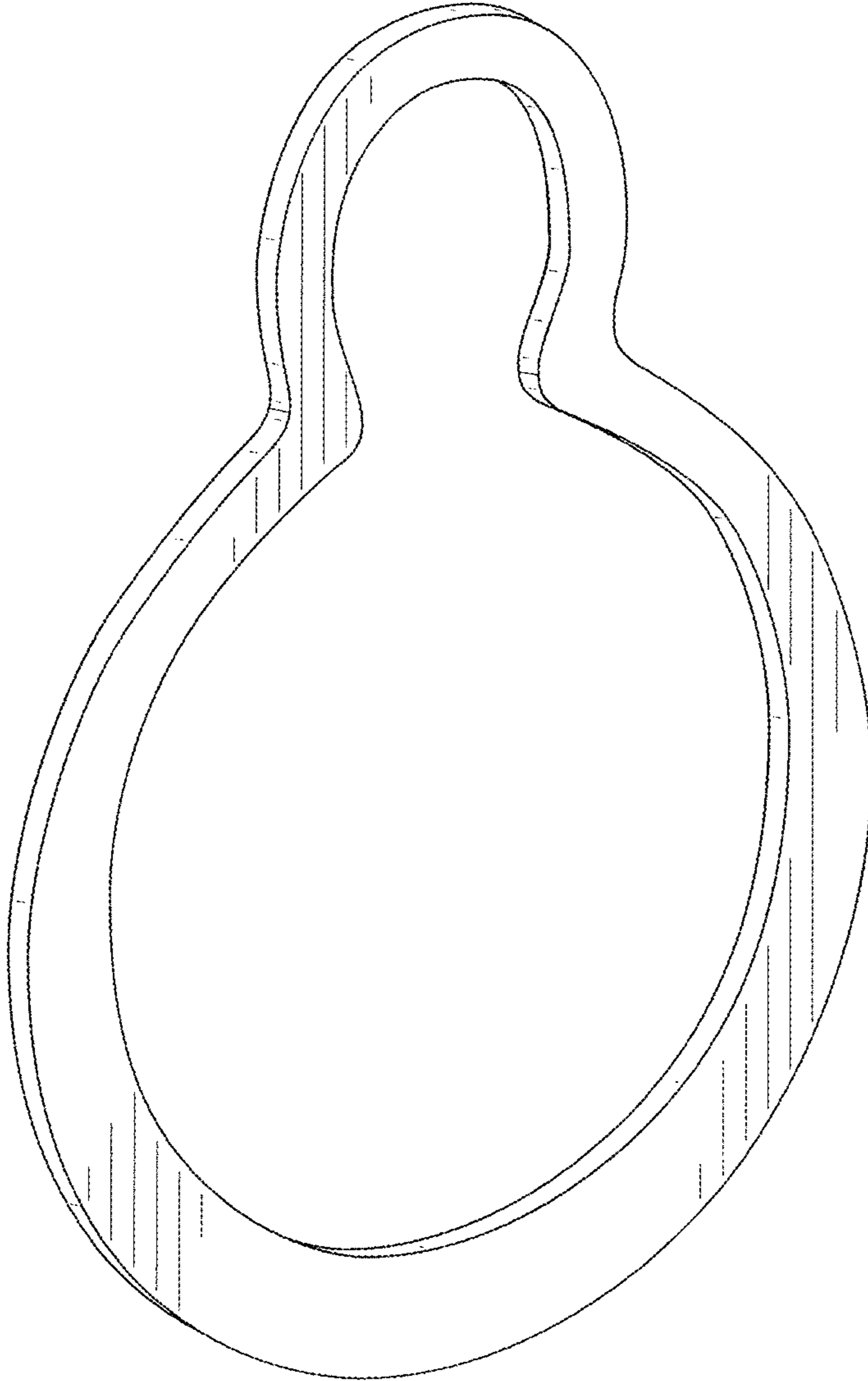

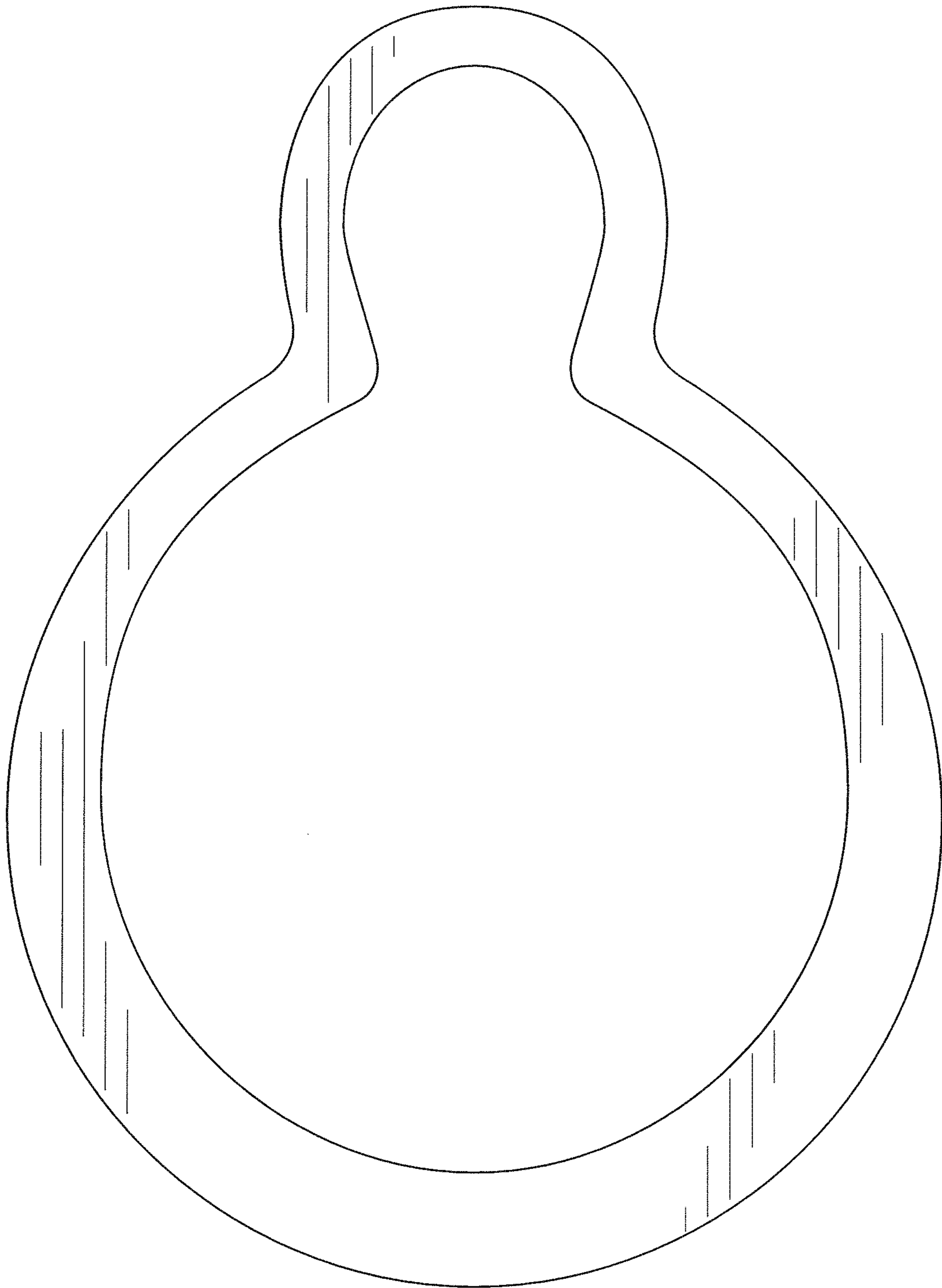

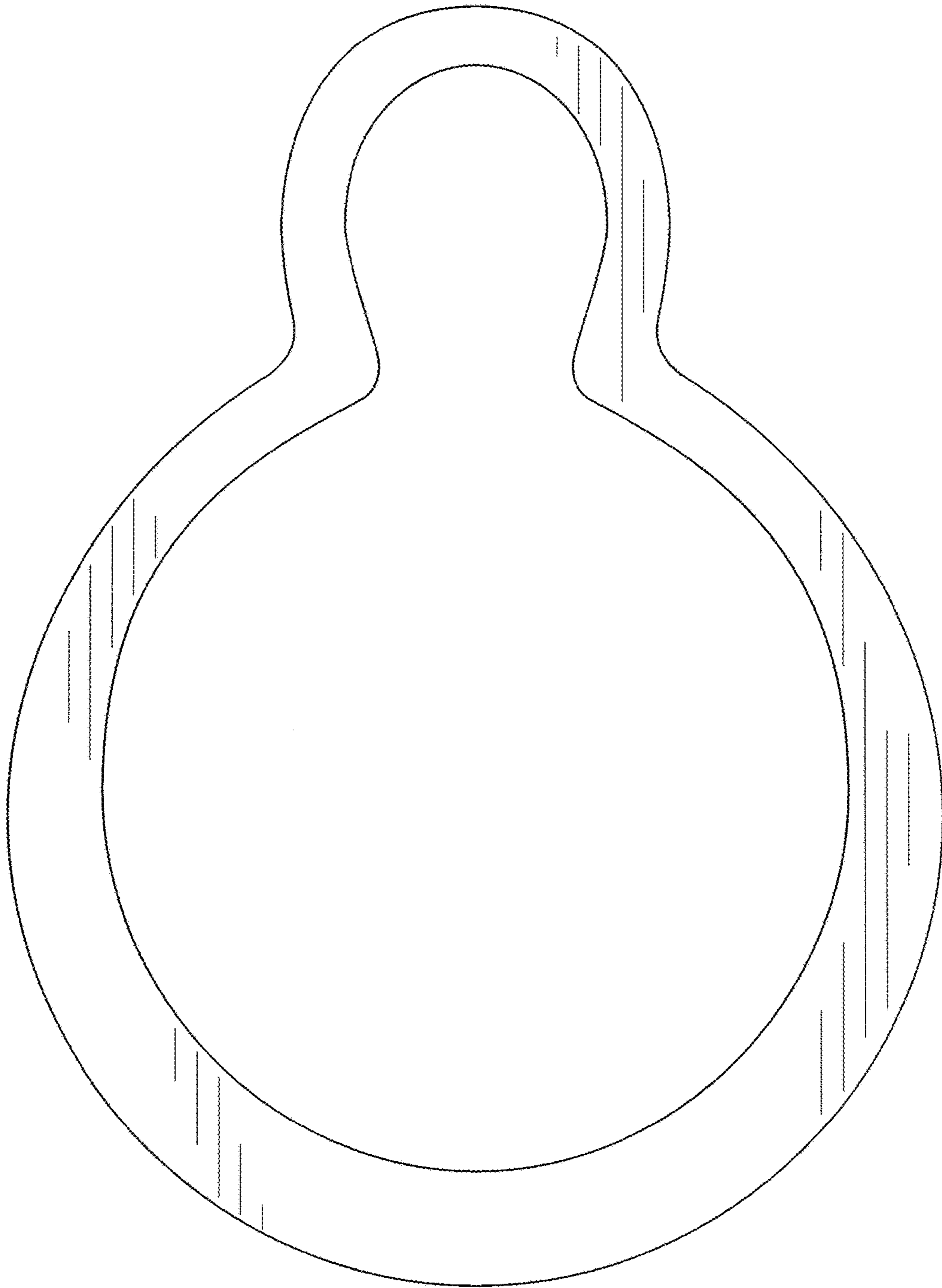

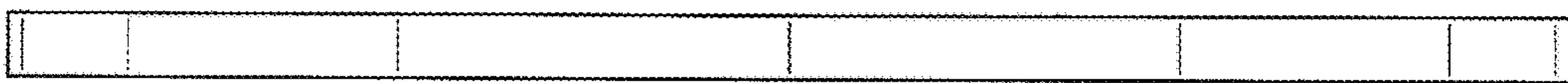

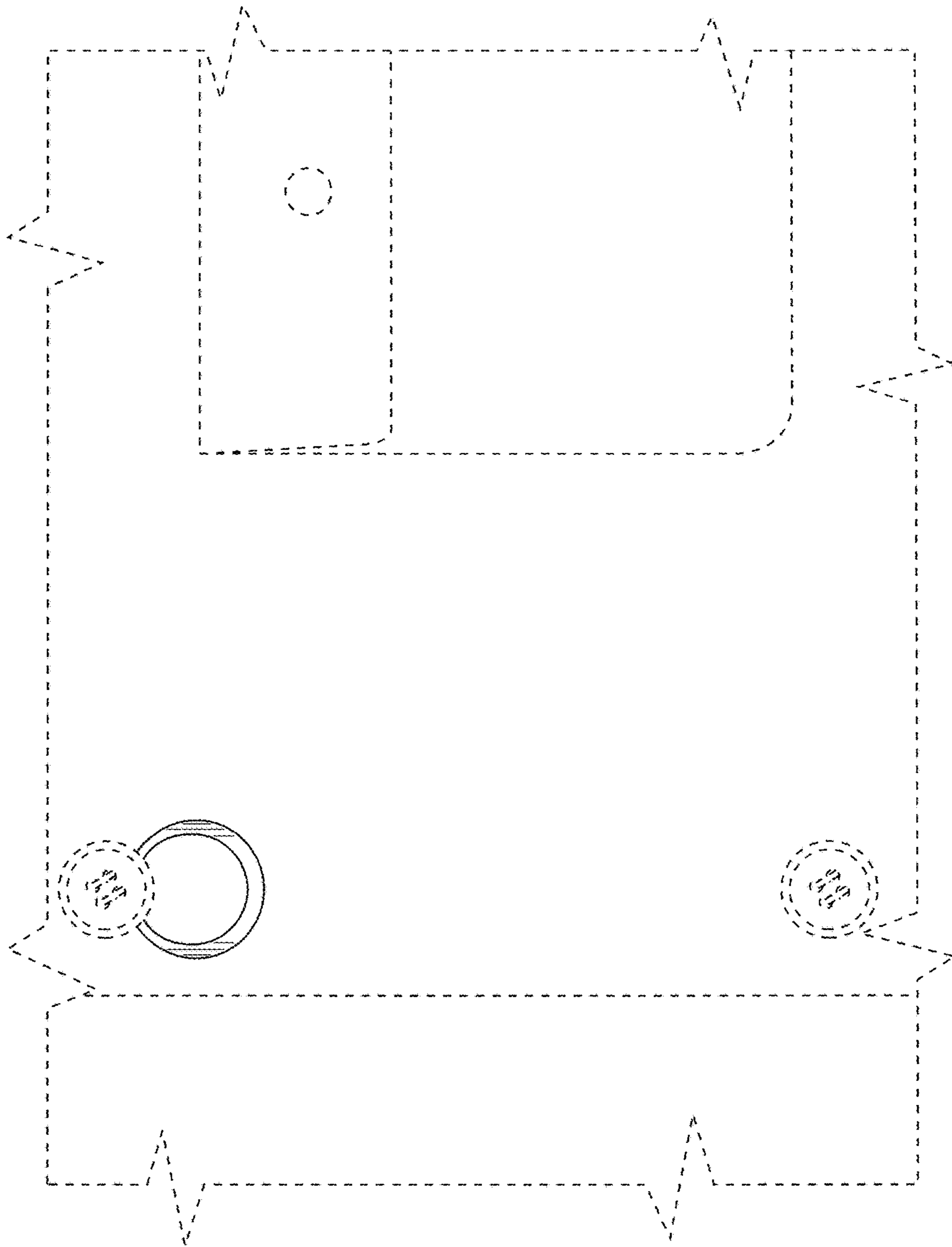

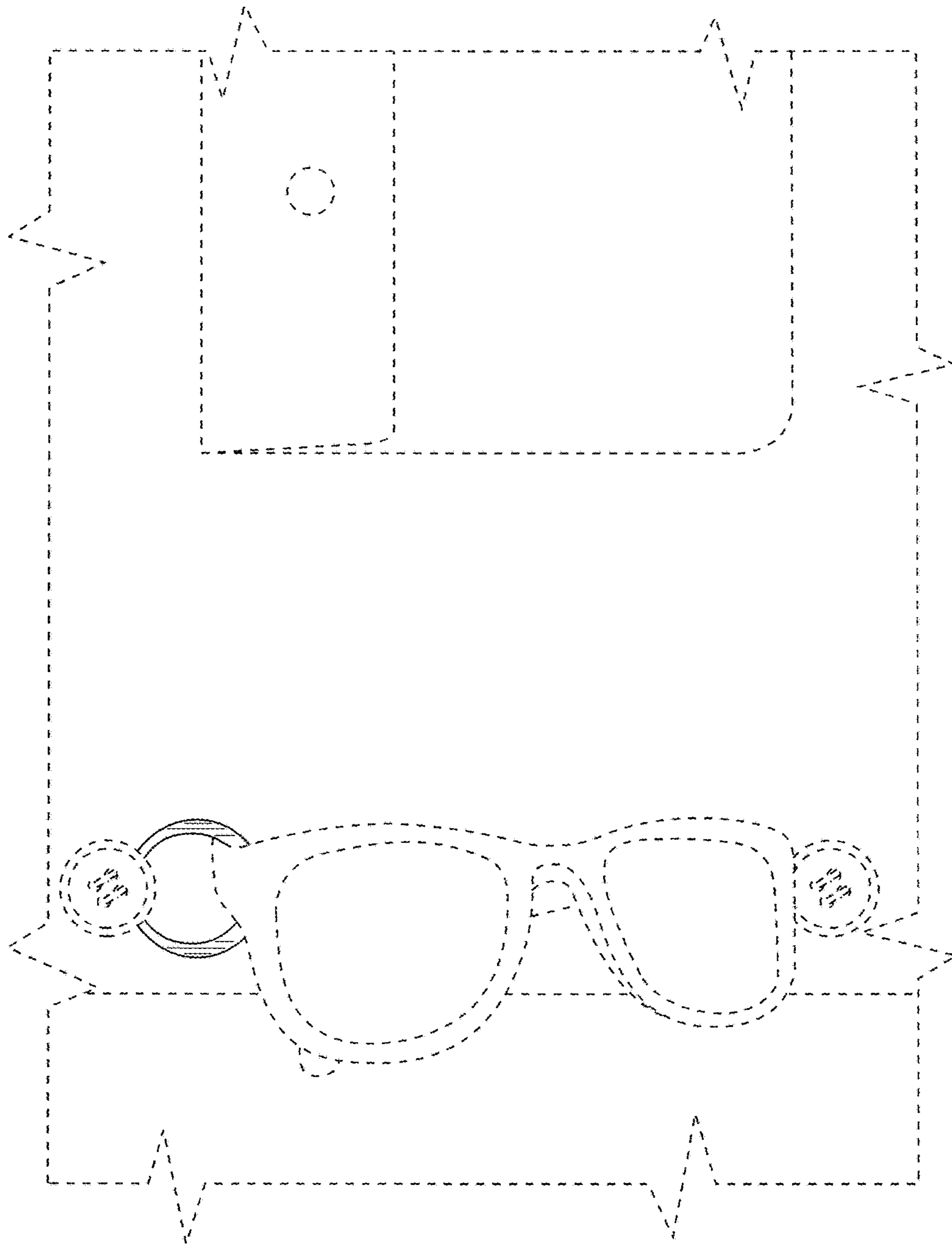
