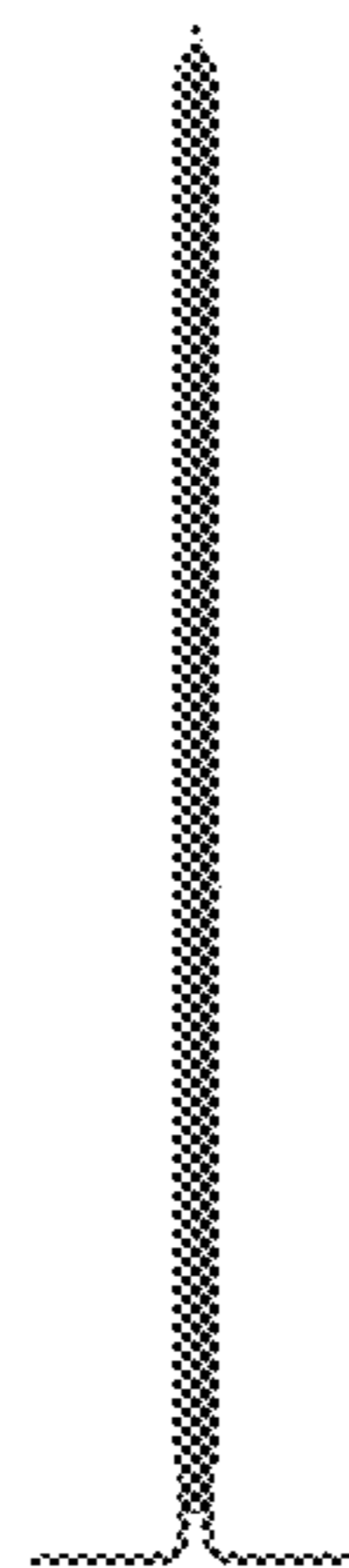
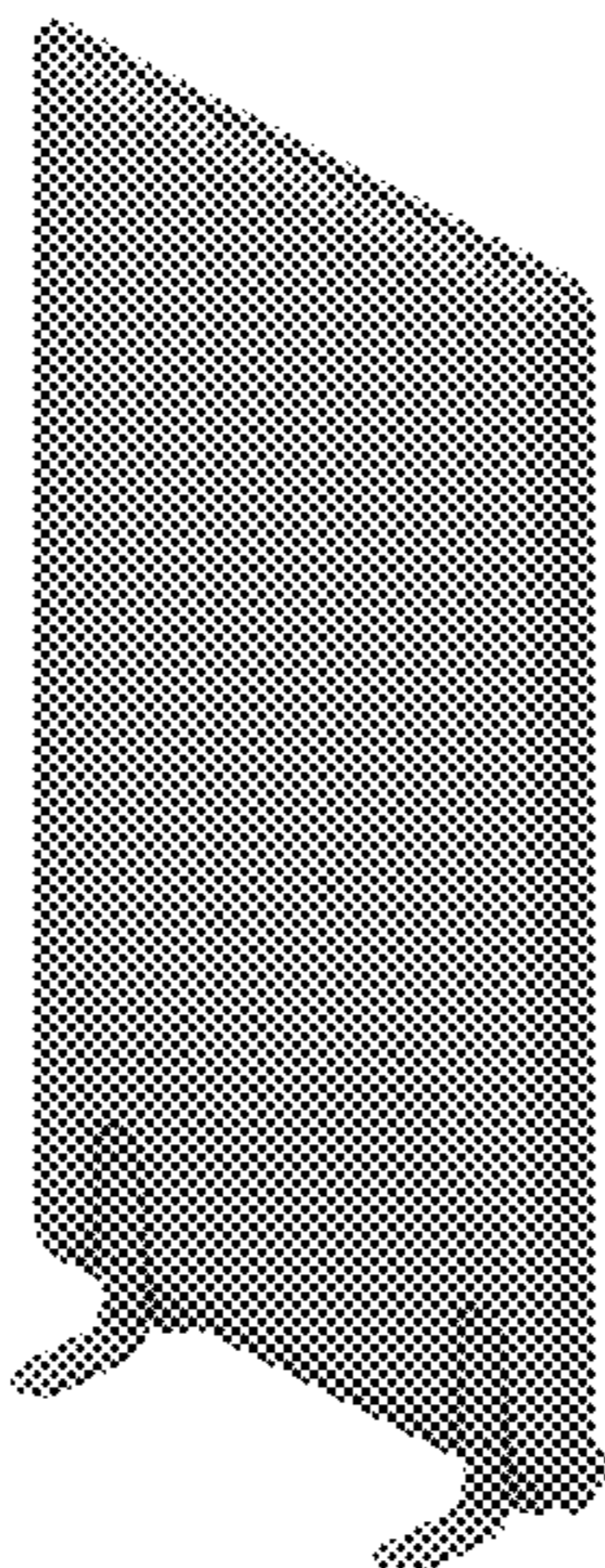
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a partition panel.  
FIG. 2 is a front elevation view thereof. A rear elevation  
view is identical to the front elevation view.  
FIG. 3 is a right side elevation view thereof. A left side  
elevation view is a mirror image of the right side elevation  
view.  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a bottom plan view thereof.

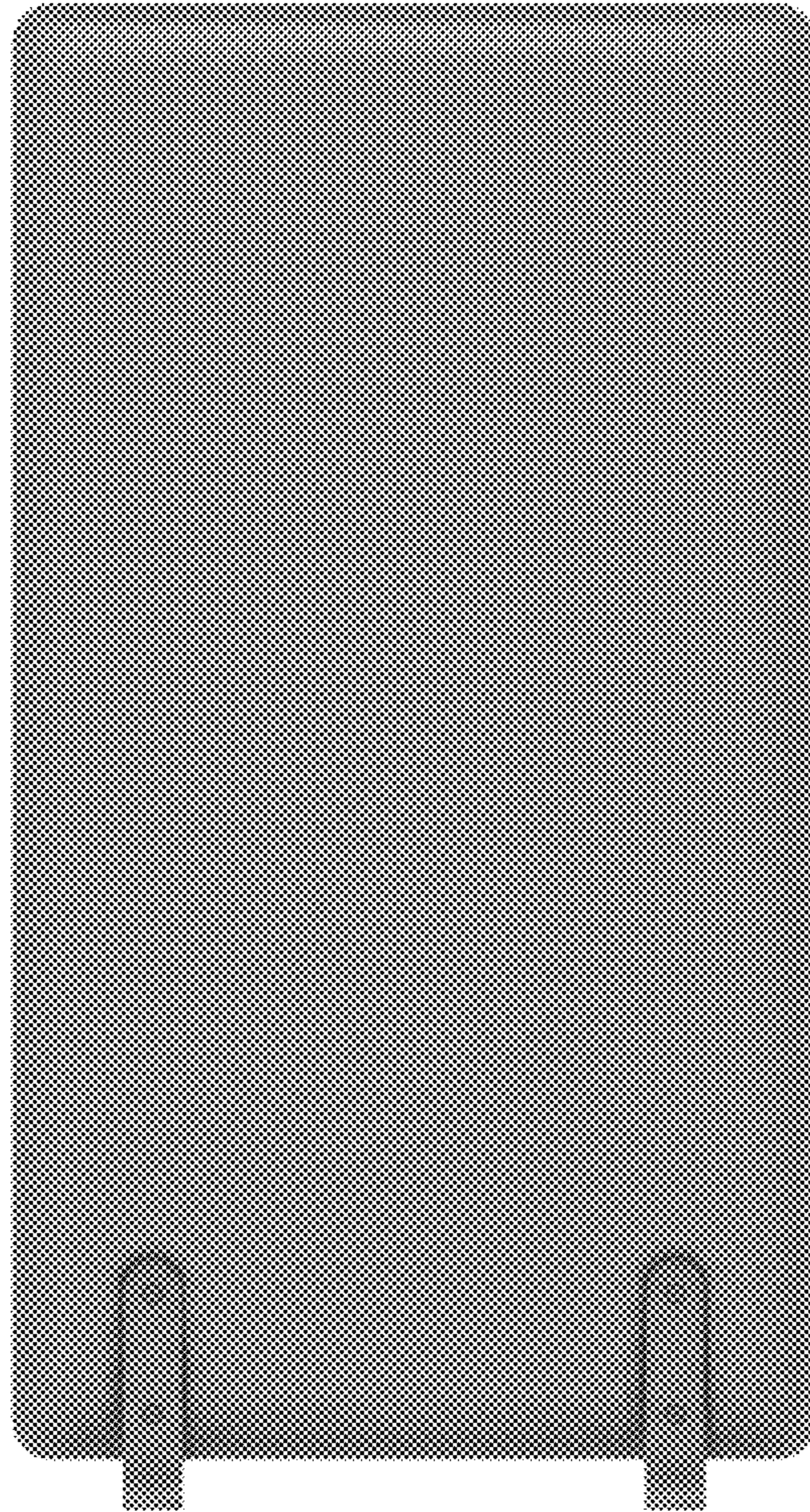

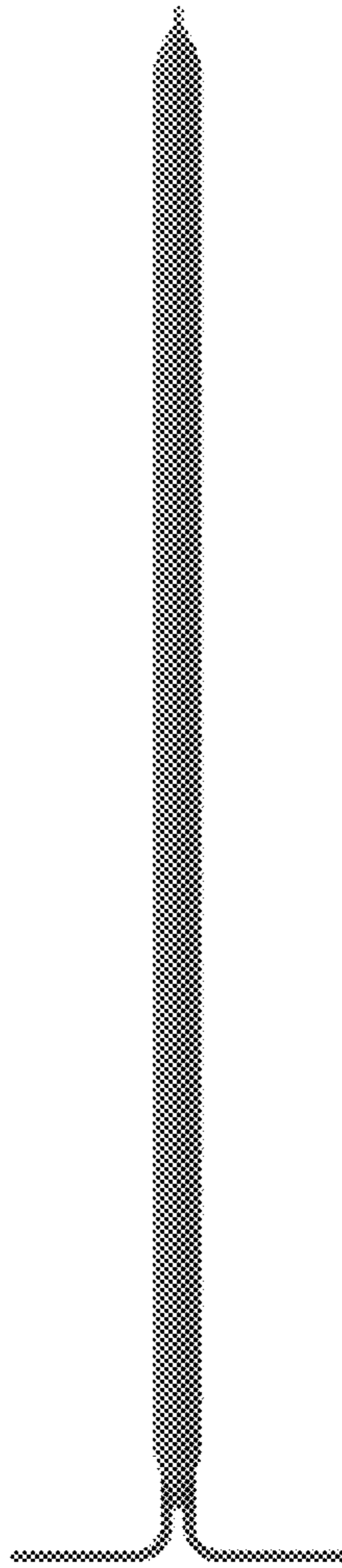
