**DESCRIPTION**

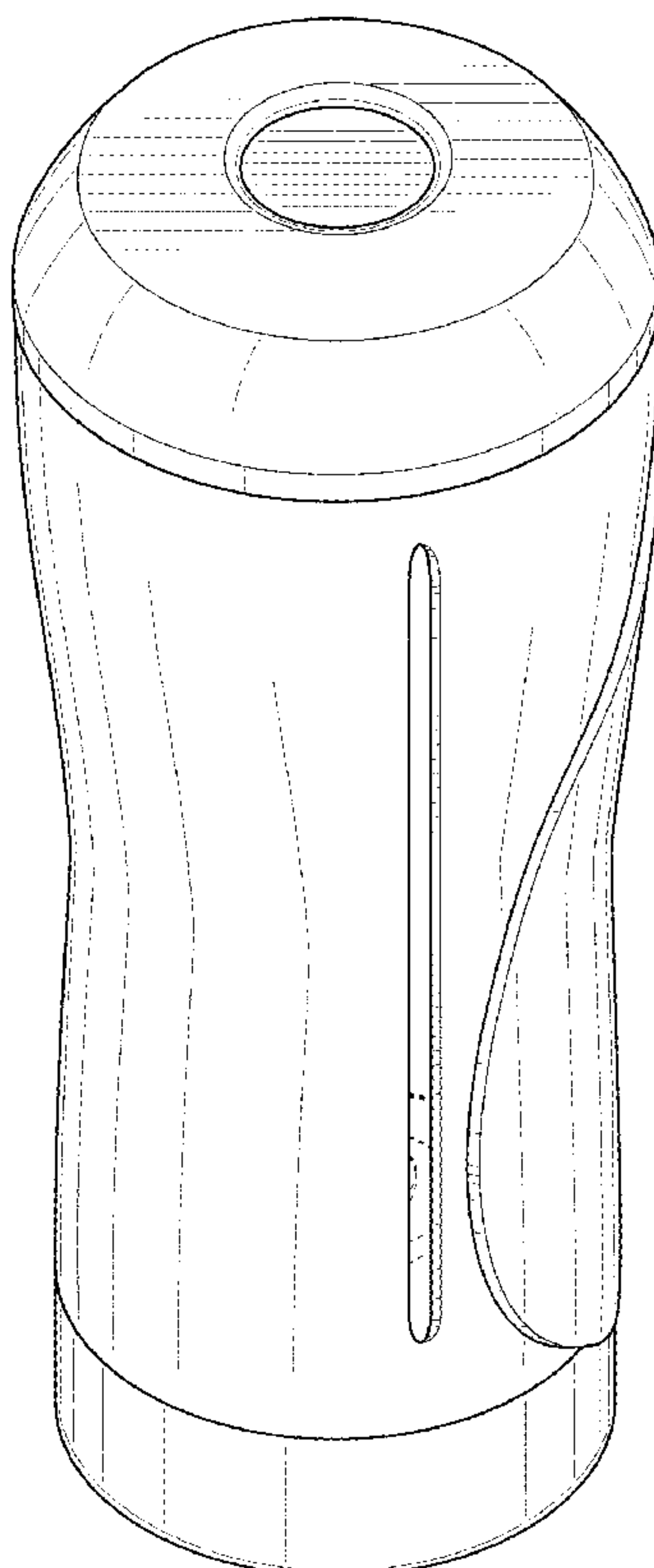
FIG. 1 is a perspective view of the automatic paper towel dispenser my new design;

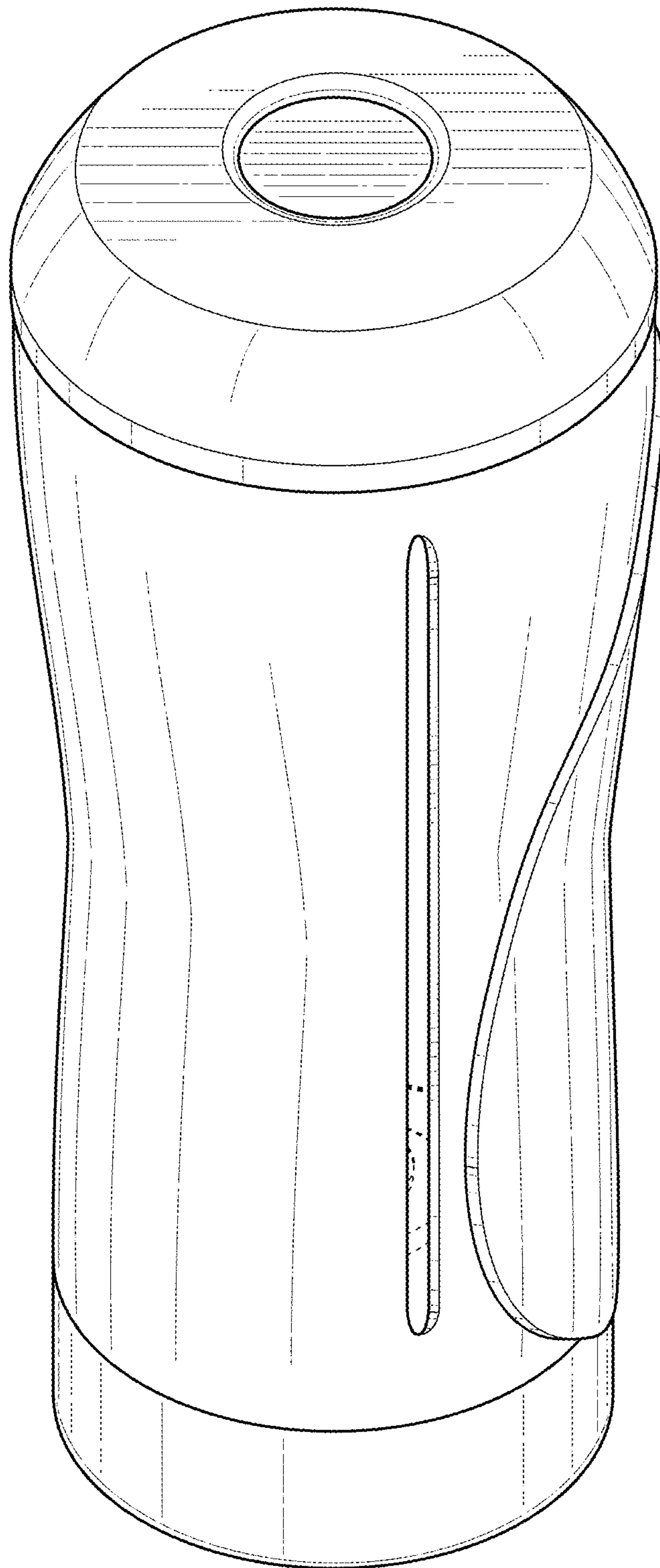

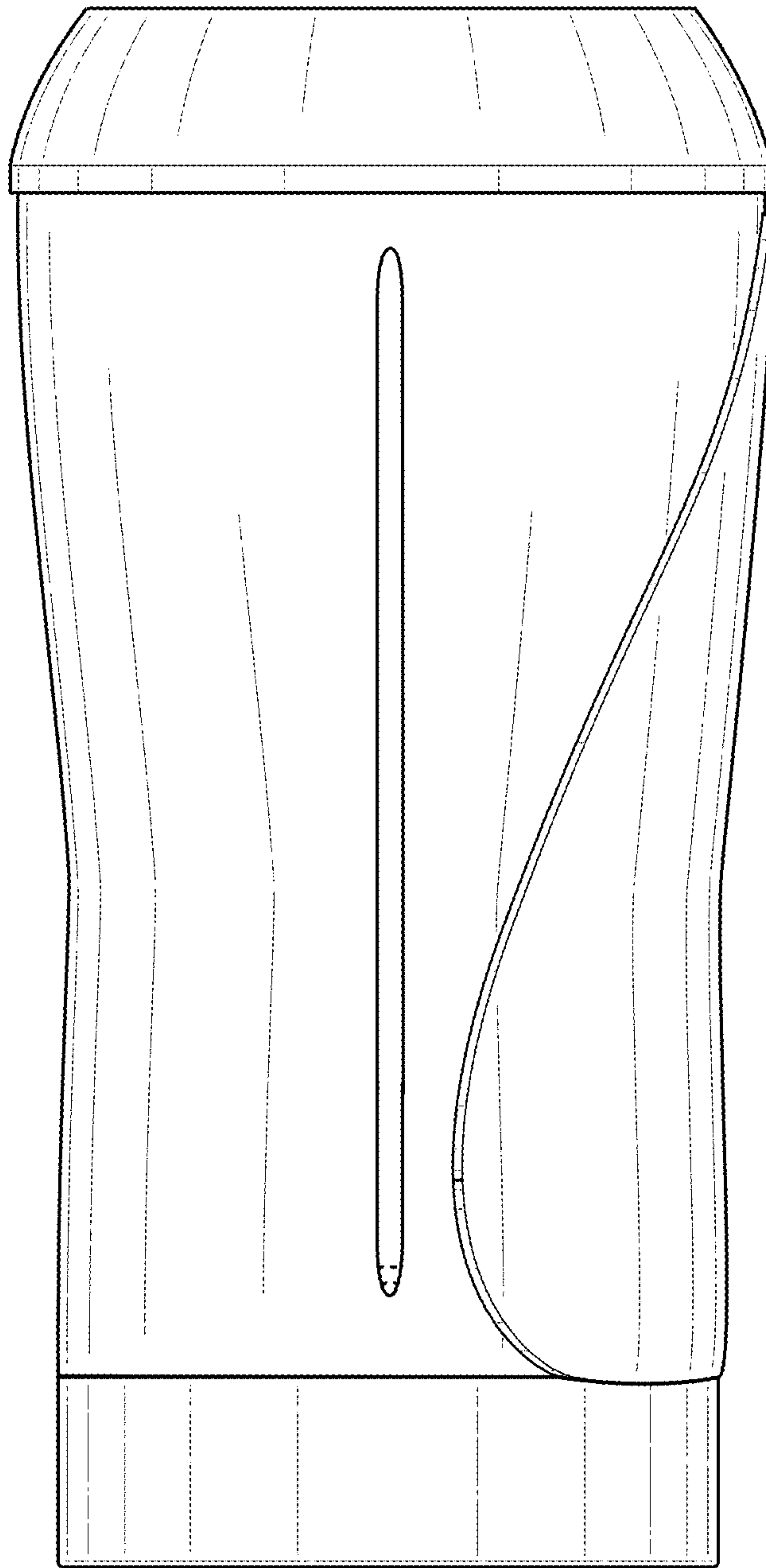
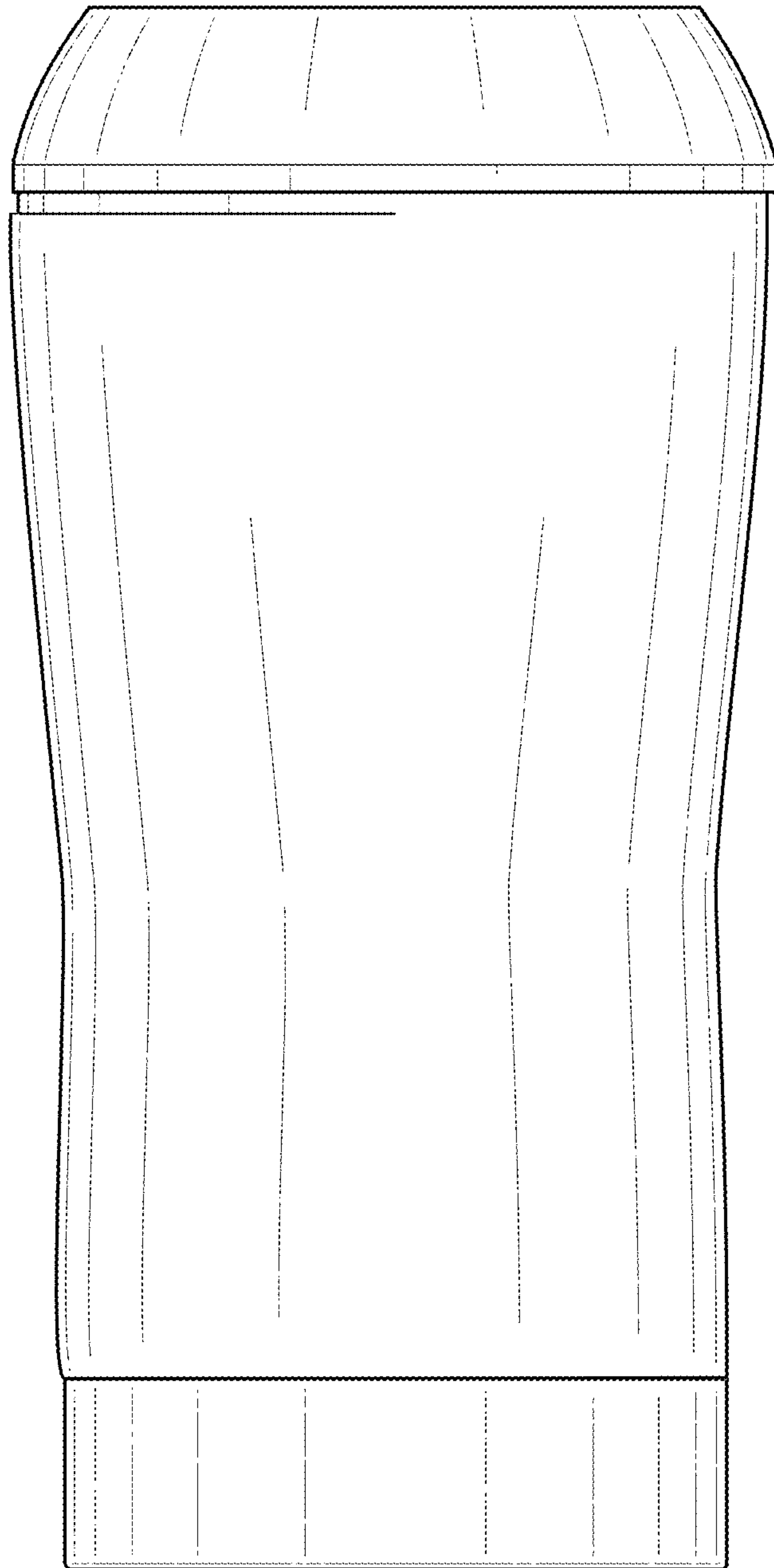

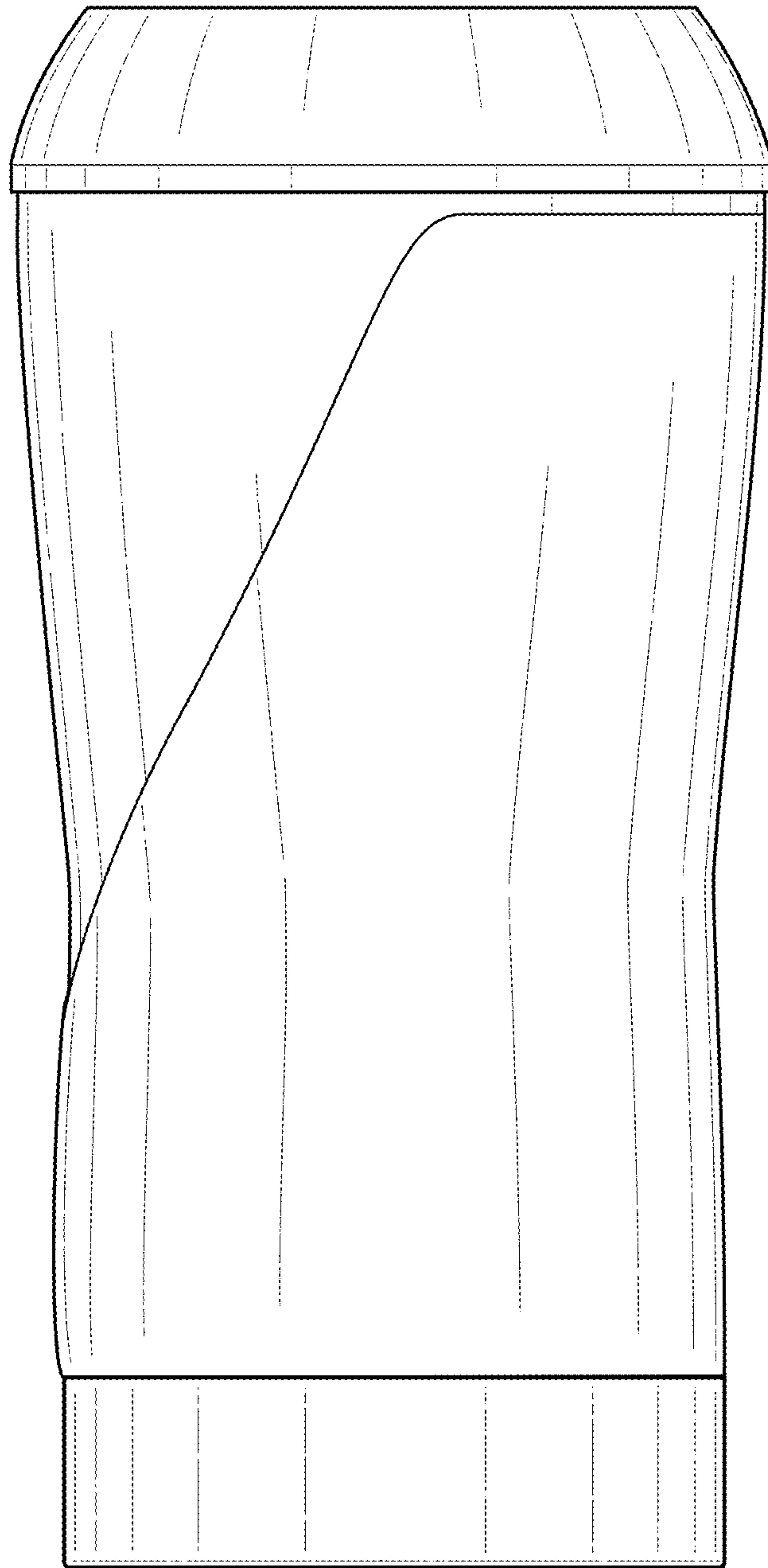

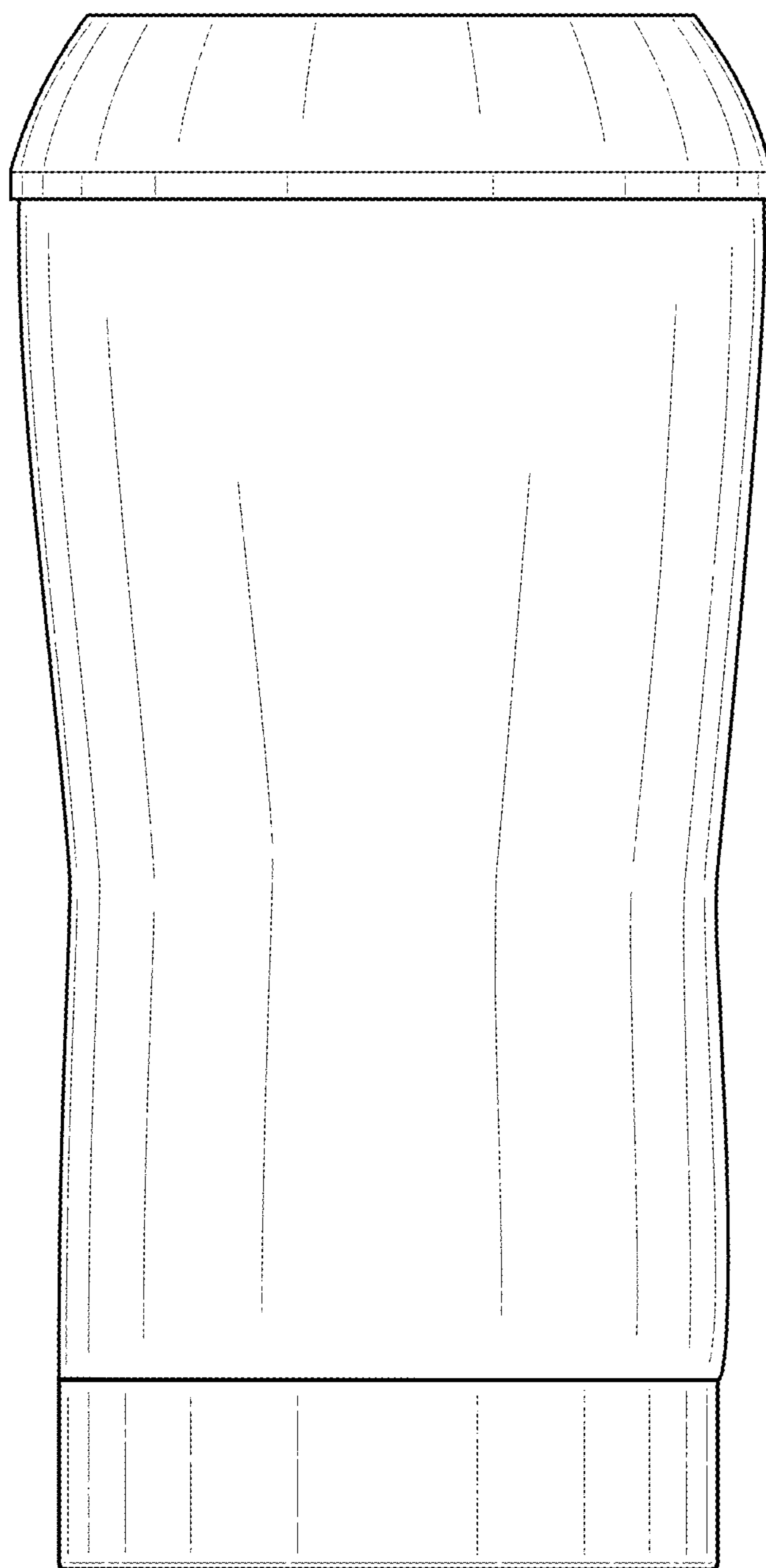
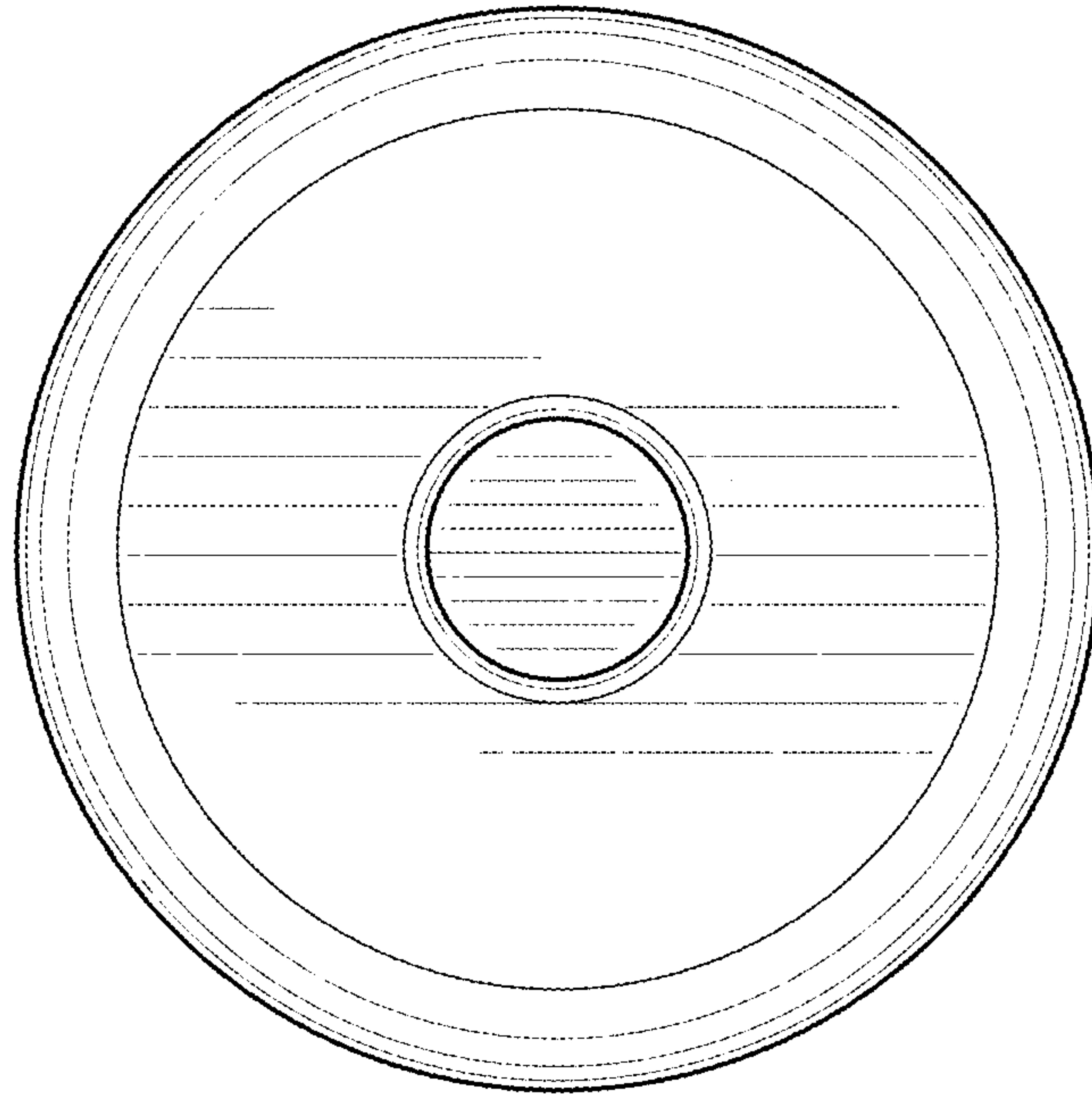
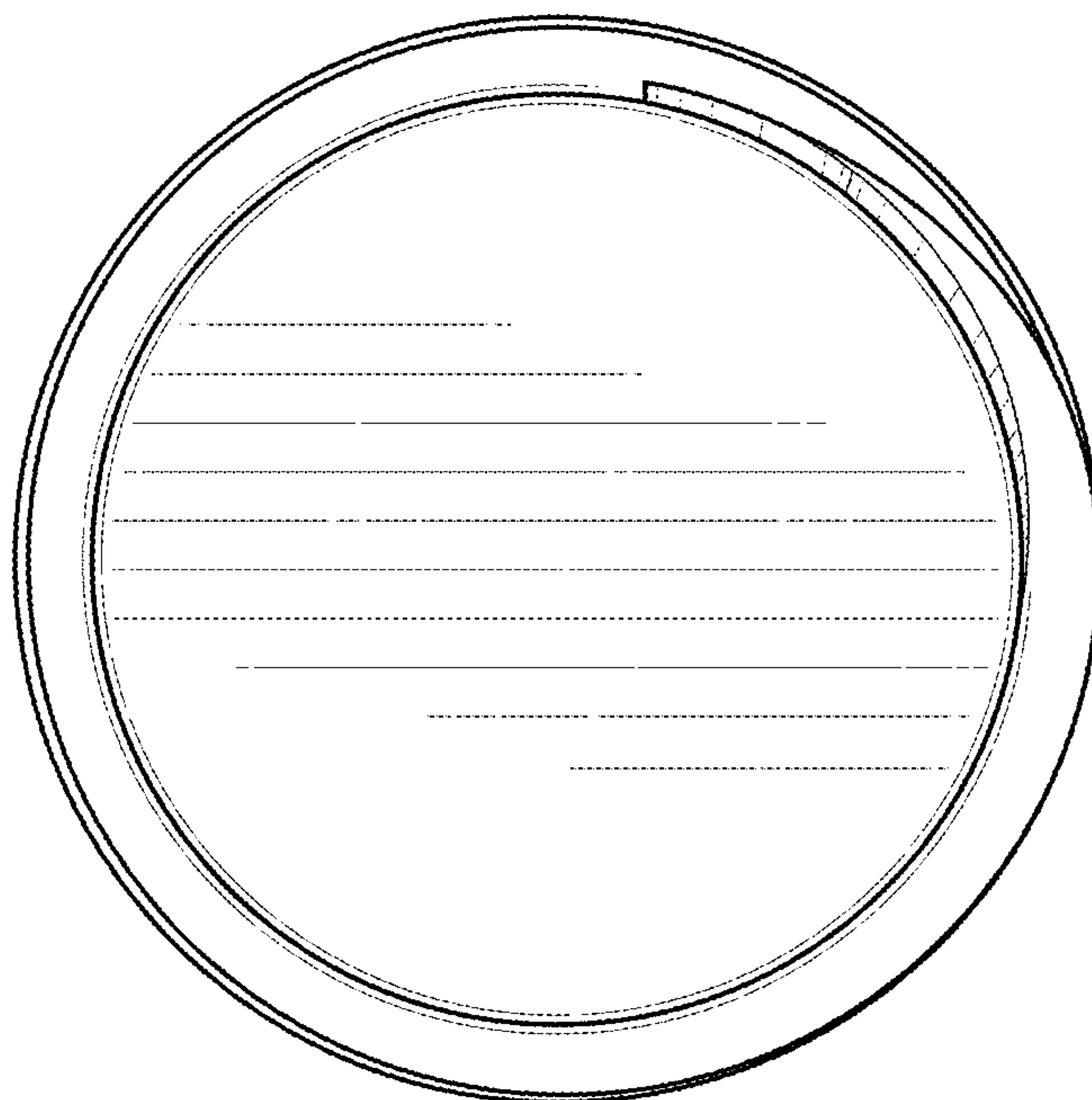
