We claim the ornamental design for a foldable mattress, as shown and described.

DESCRIPTION

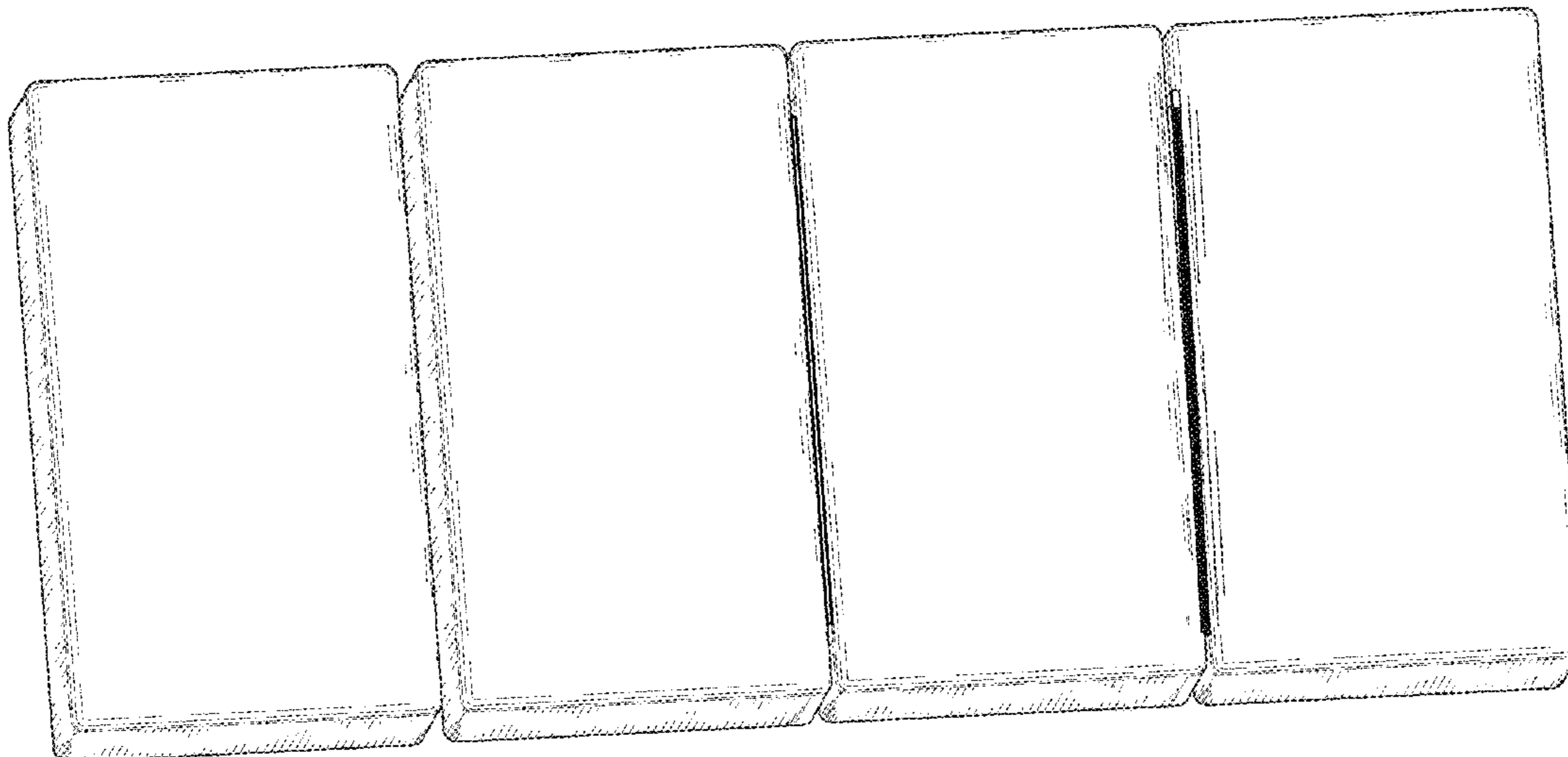
FIG. 1 is a perspective view of a foldable mattress with removable panel;
FIG. 2 is a perspective view of the foldable mattress of FIG. 1 in an alternate folded position;
FIG. 3 is a front view of the foldable mattress of FIG. 1;
FIG. 4 is a rear view of the foldable mattress of FIG. 1;
FIG. 5 is a left side view of the foldable mattress of FIG. 1;
FIG. 6 is a right side view of the foldable mattress of FIG. 1;
FIG. 7 is top view of the foldable mattress of FIG. 1; and, FIG. 8 is a bottom view of the foldable mattress of FIG. 1. Portions of the figures shown in broken lines form not part of the claimed design.

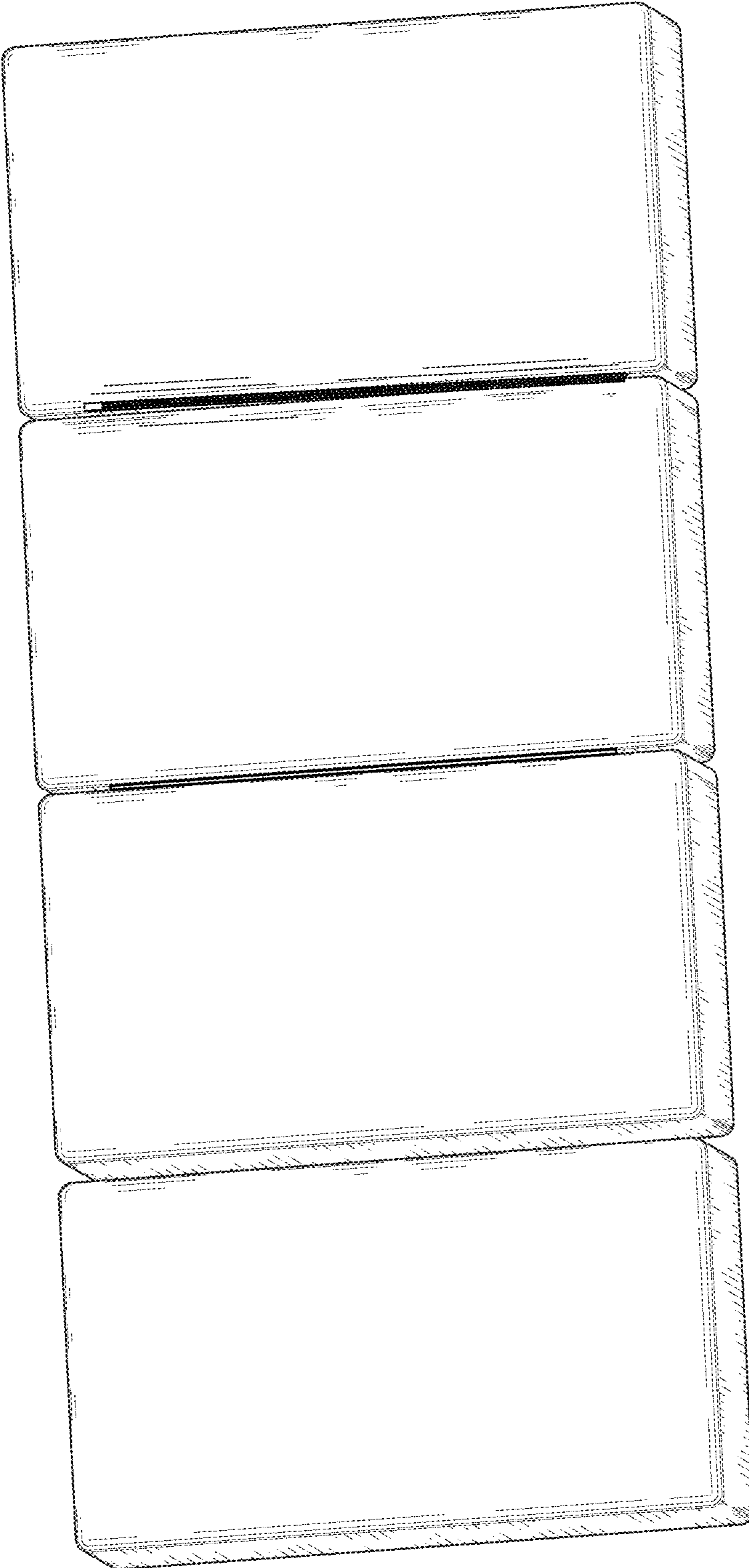

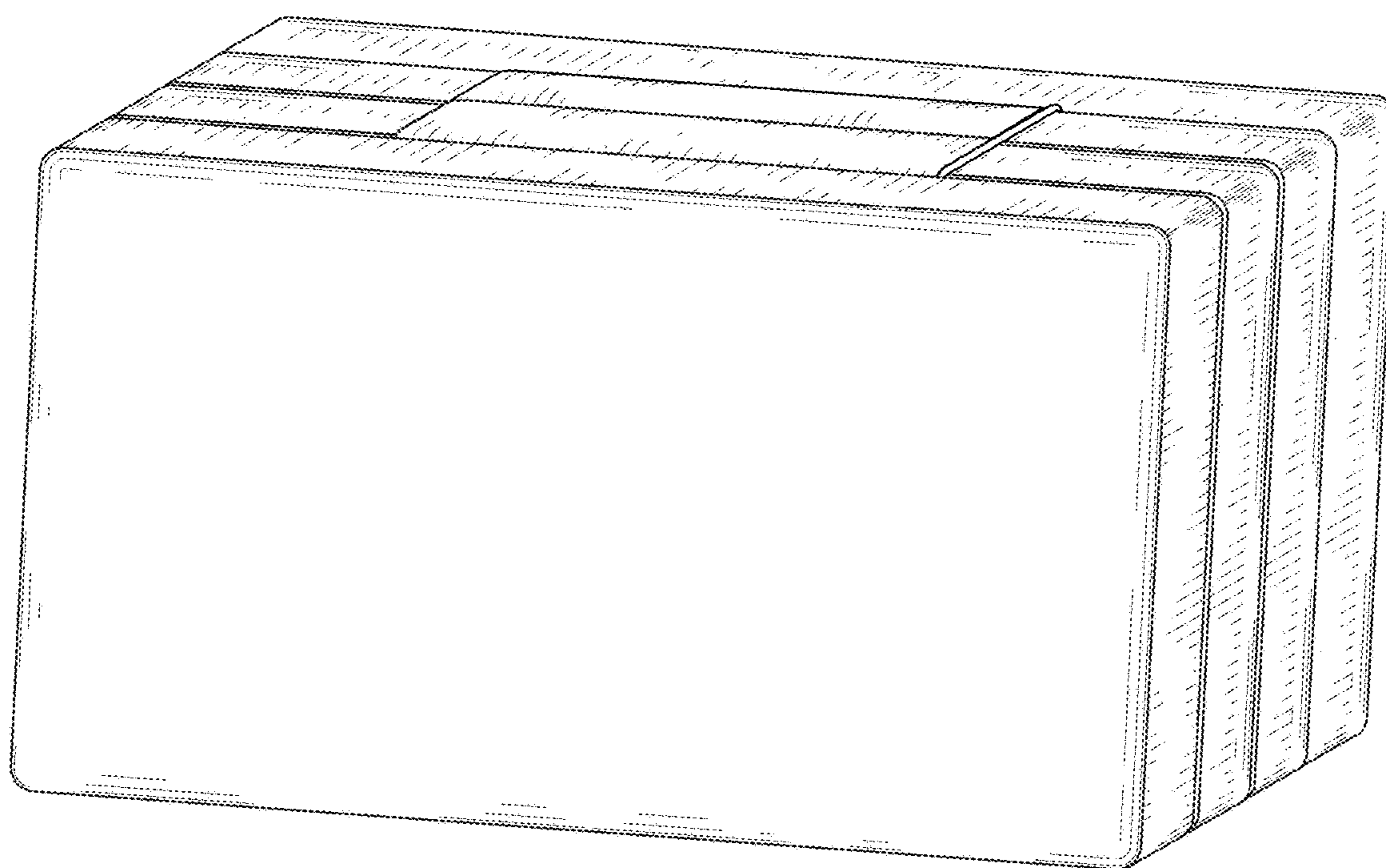

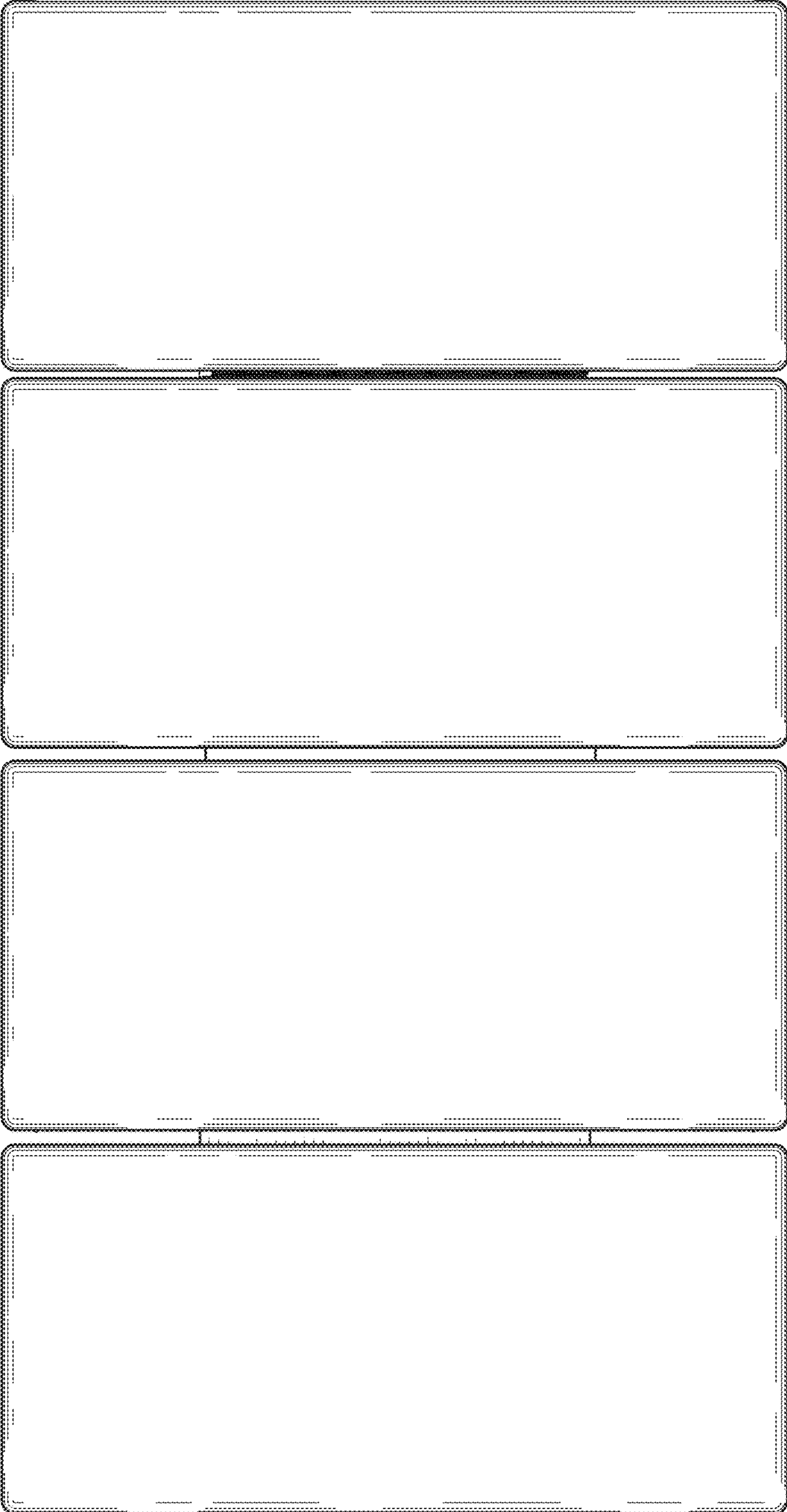

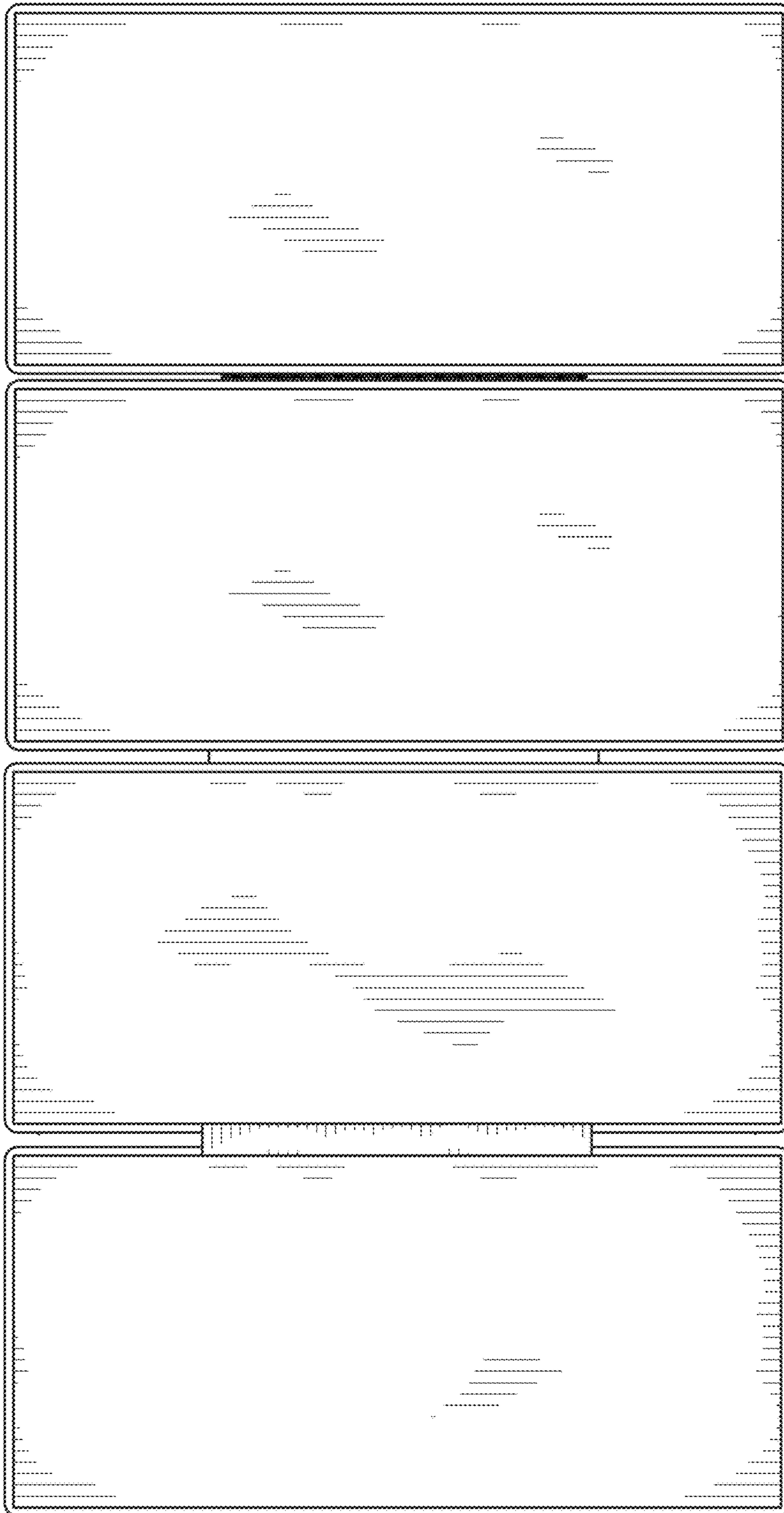

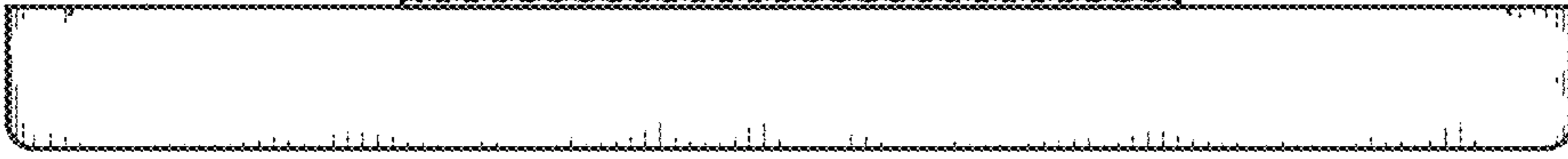

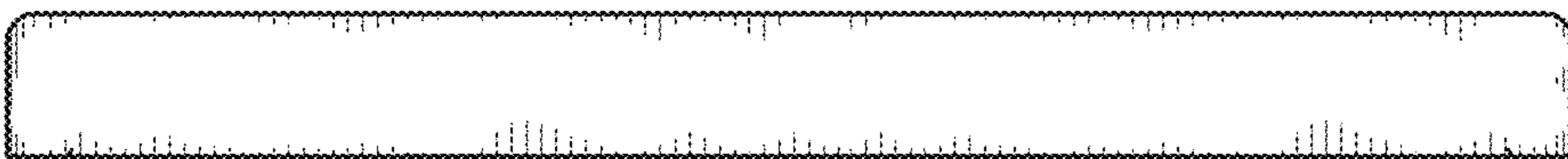

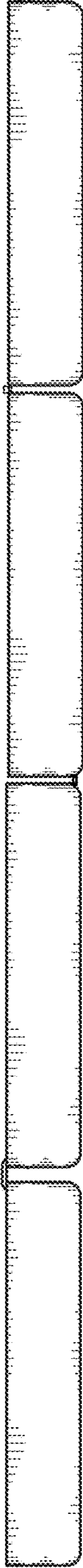

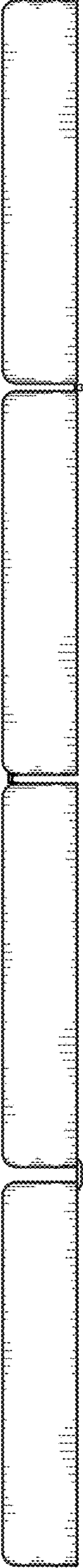
