FIG. 8 is another isometric view of the implement attachment bracket of FIG. 1.

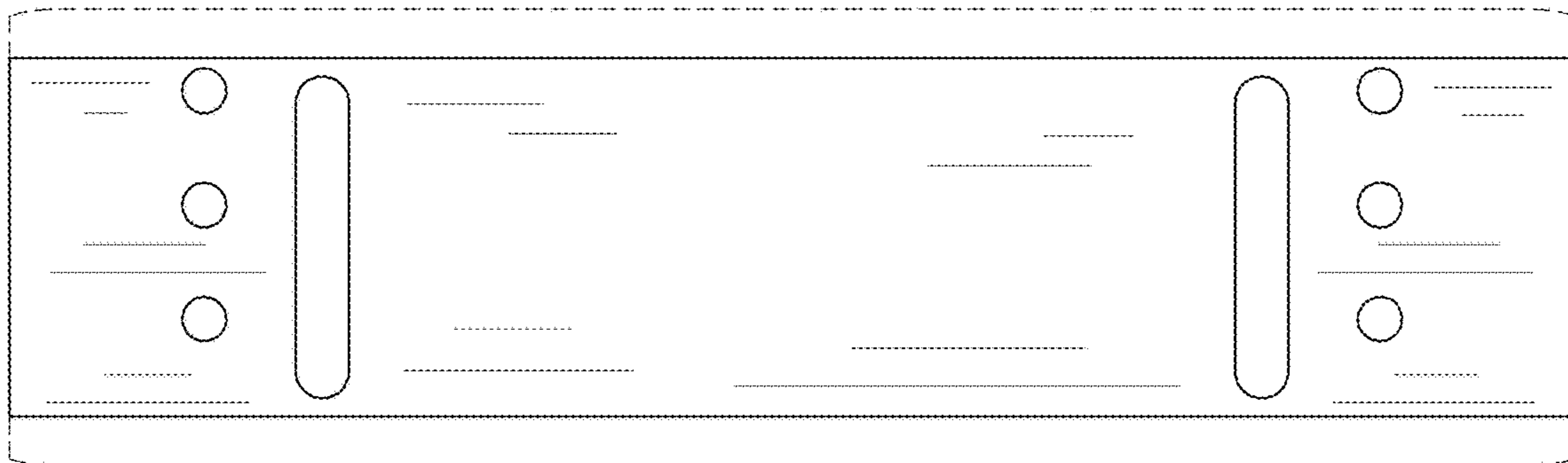
The broken lines in the FIGS. 1-8 illustrate portions of the implement attachment bracket which forms no part of the claimed design.

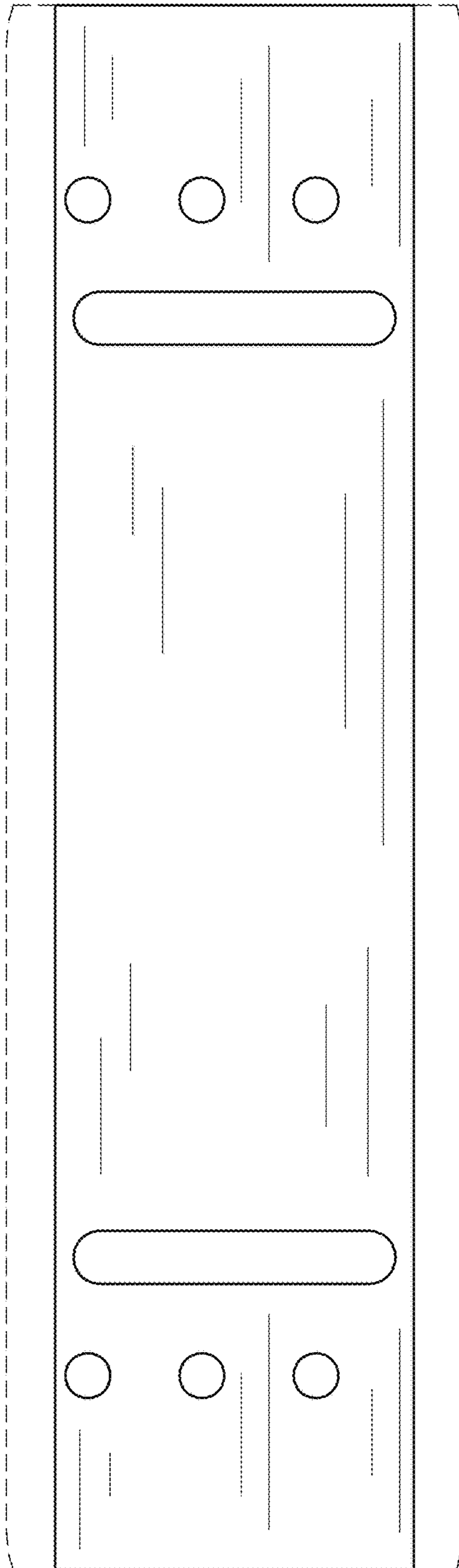

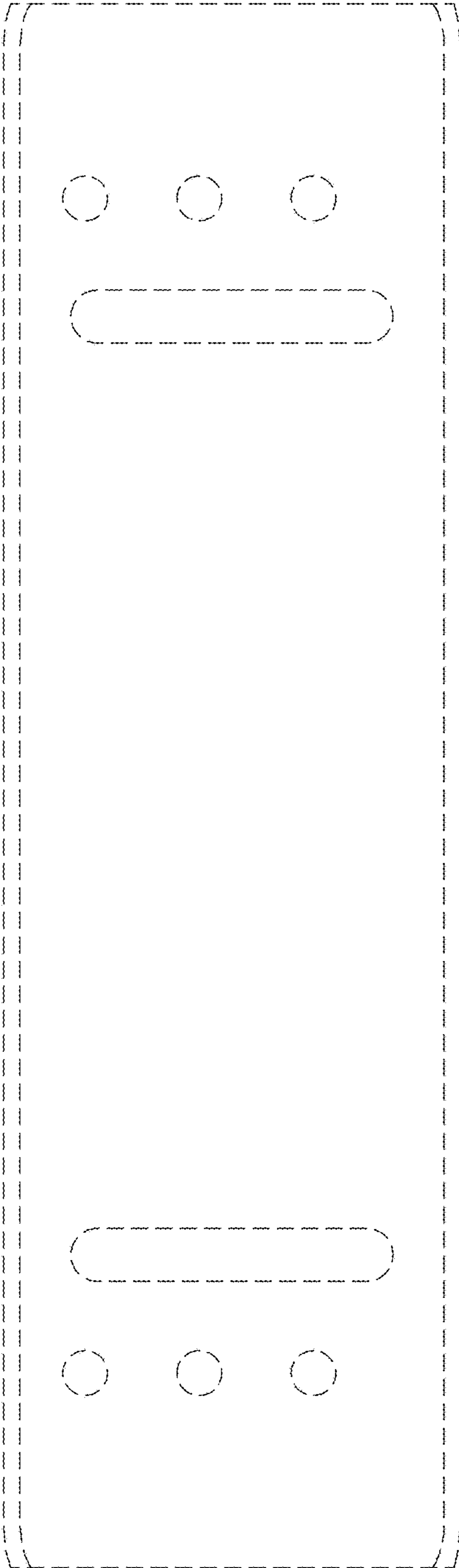

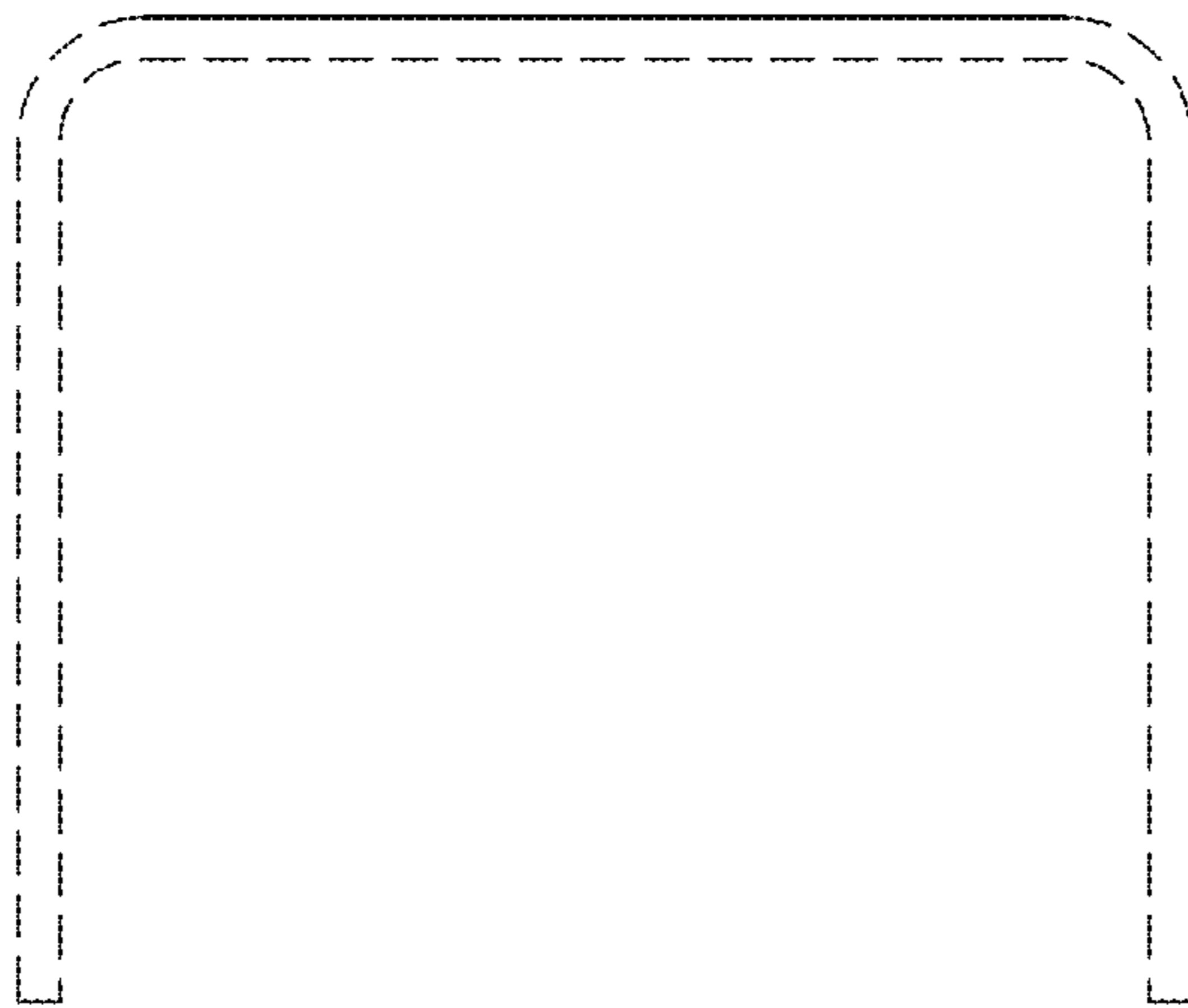

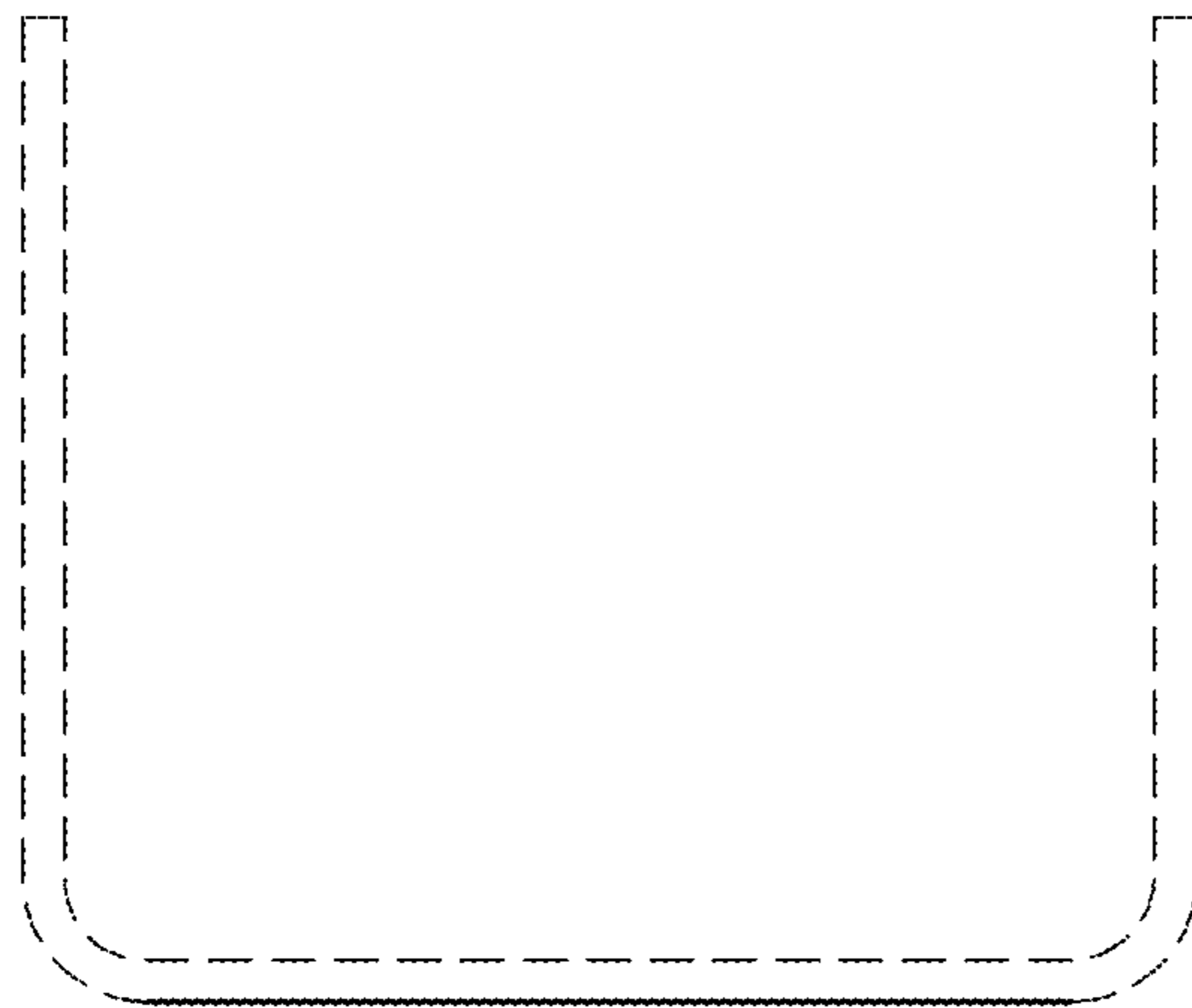

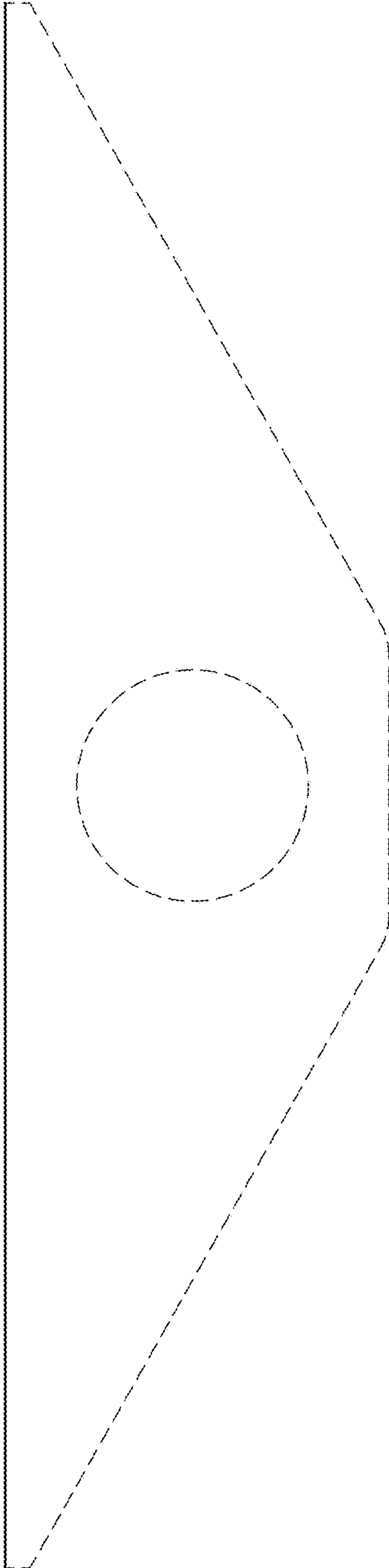

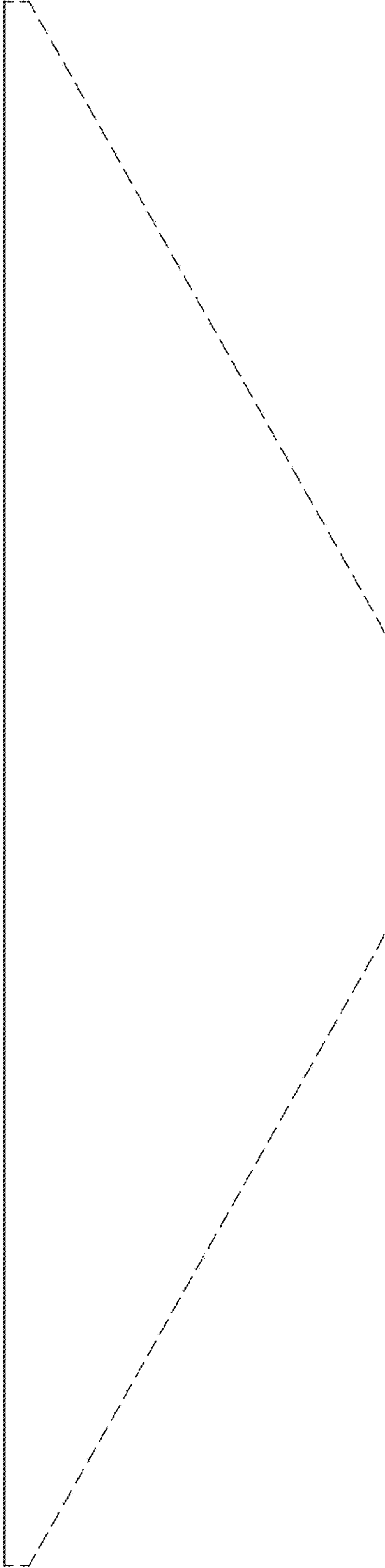

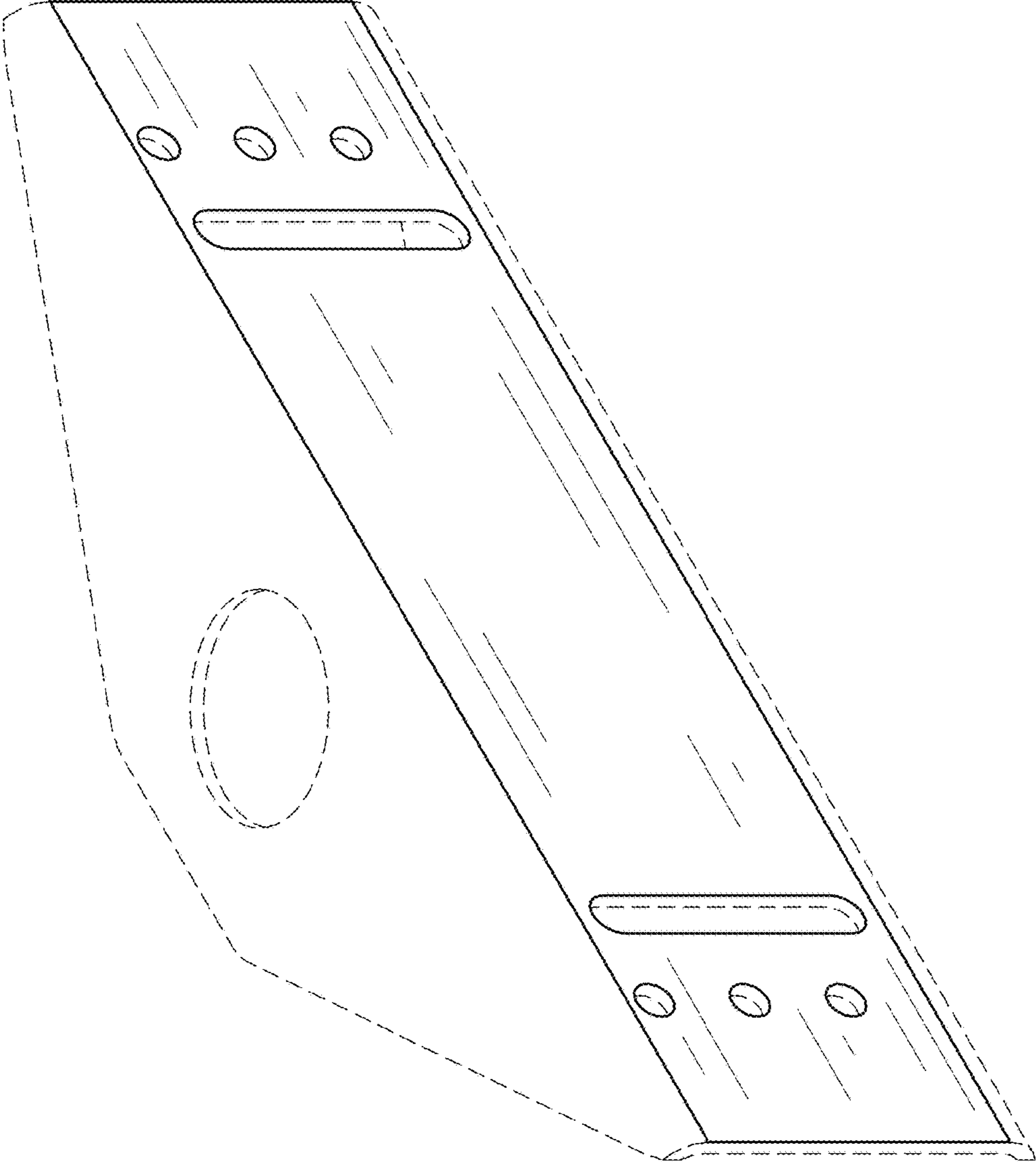

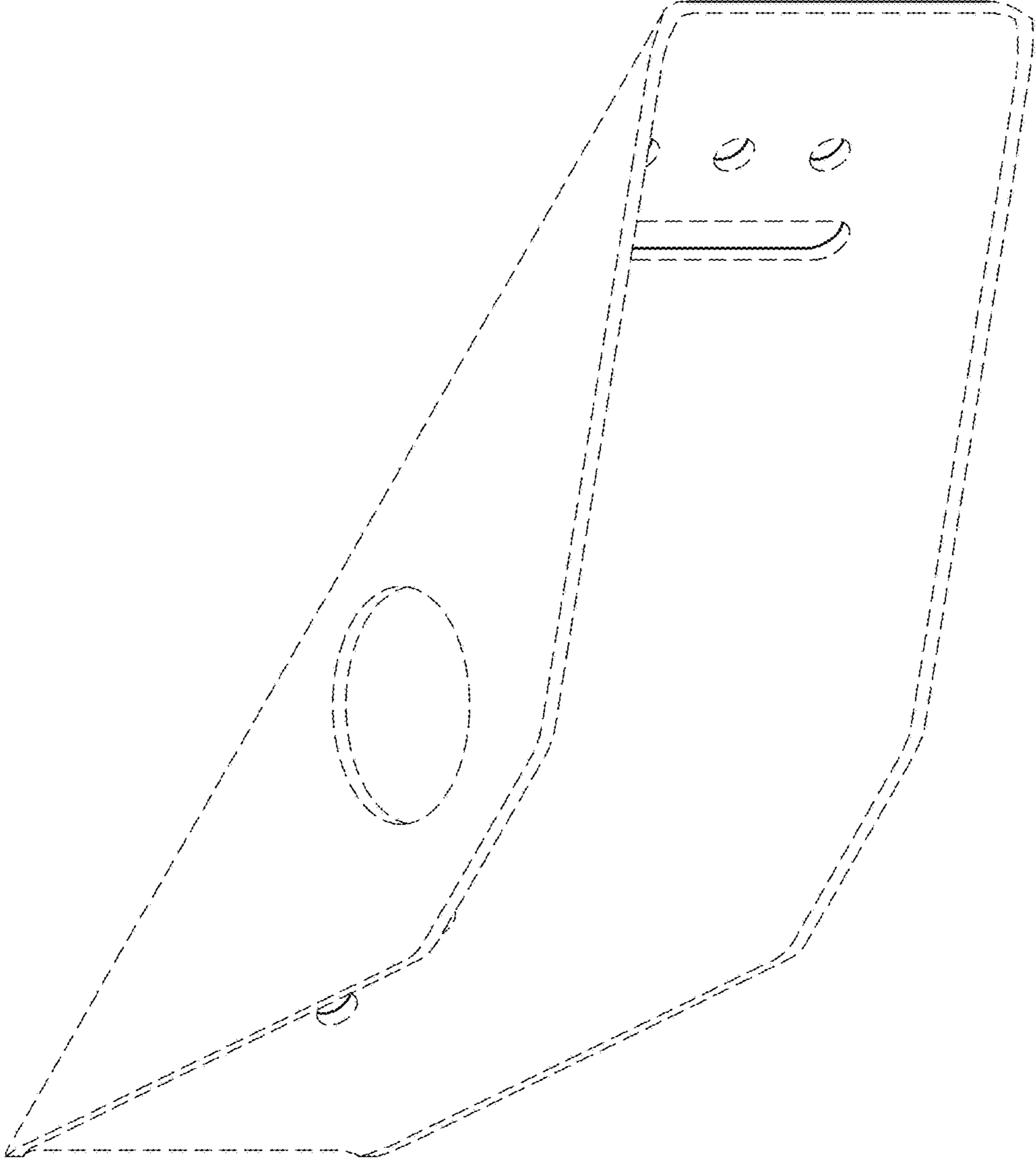
