FIG. 25 is a rear view thereof; and

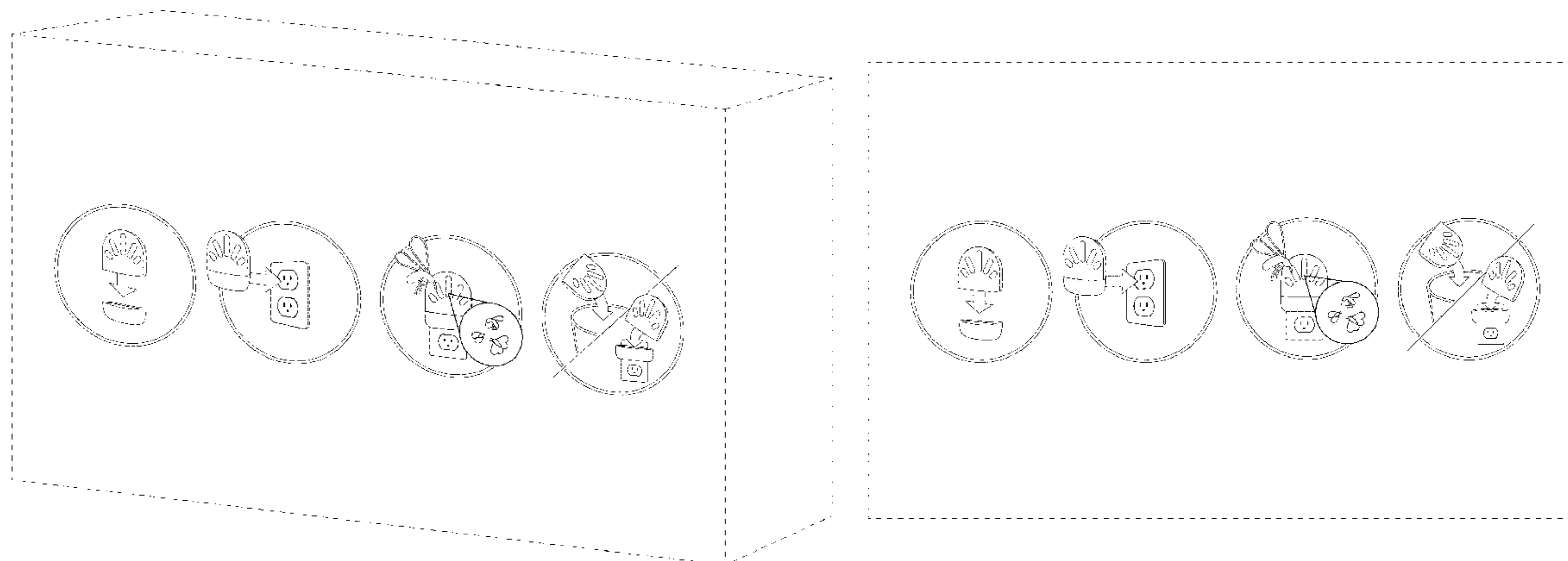
FIG. 26 is a right side view thereof;

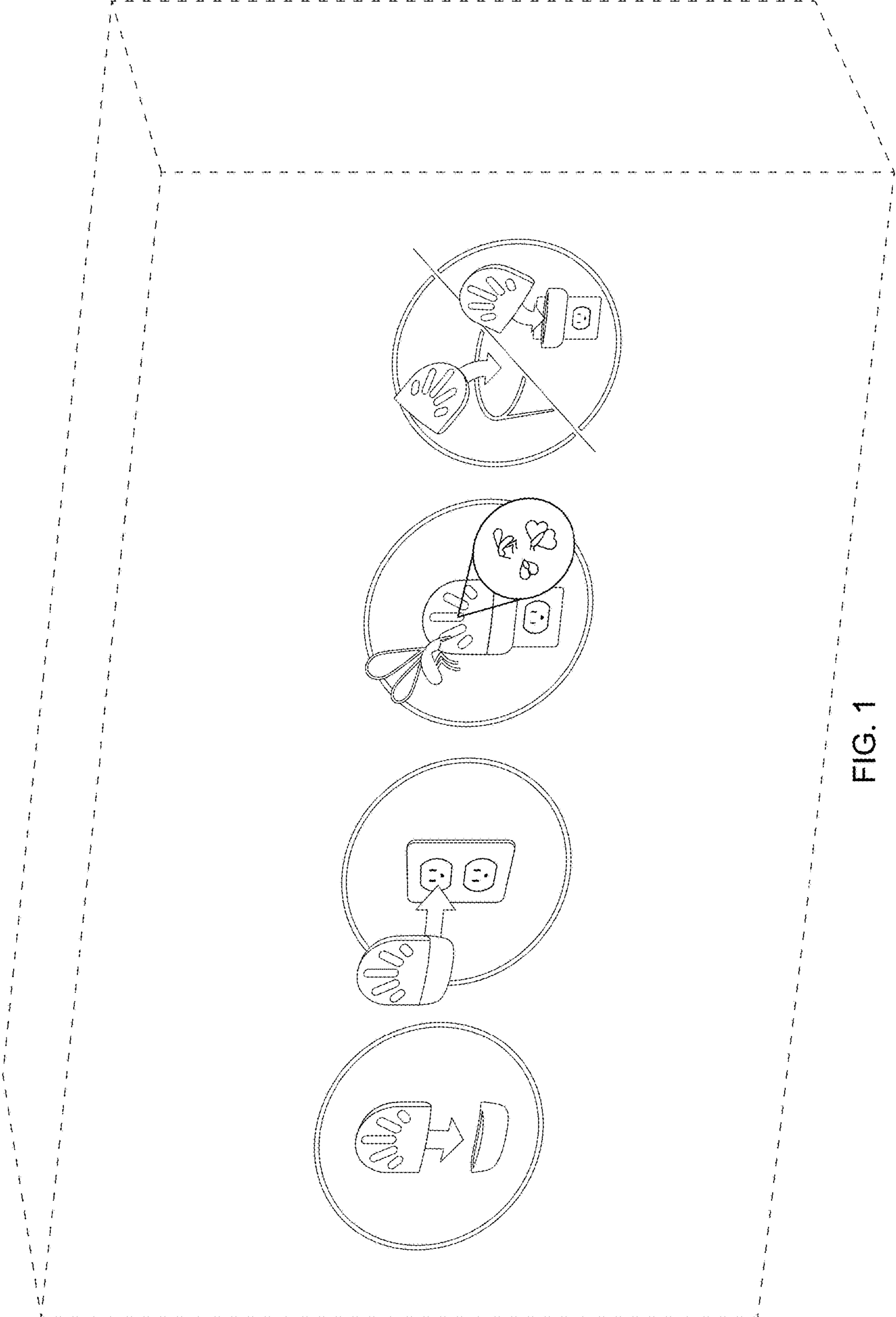

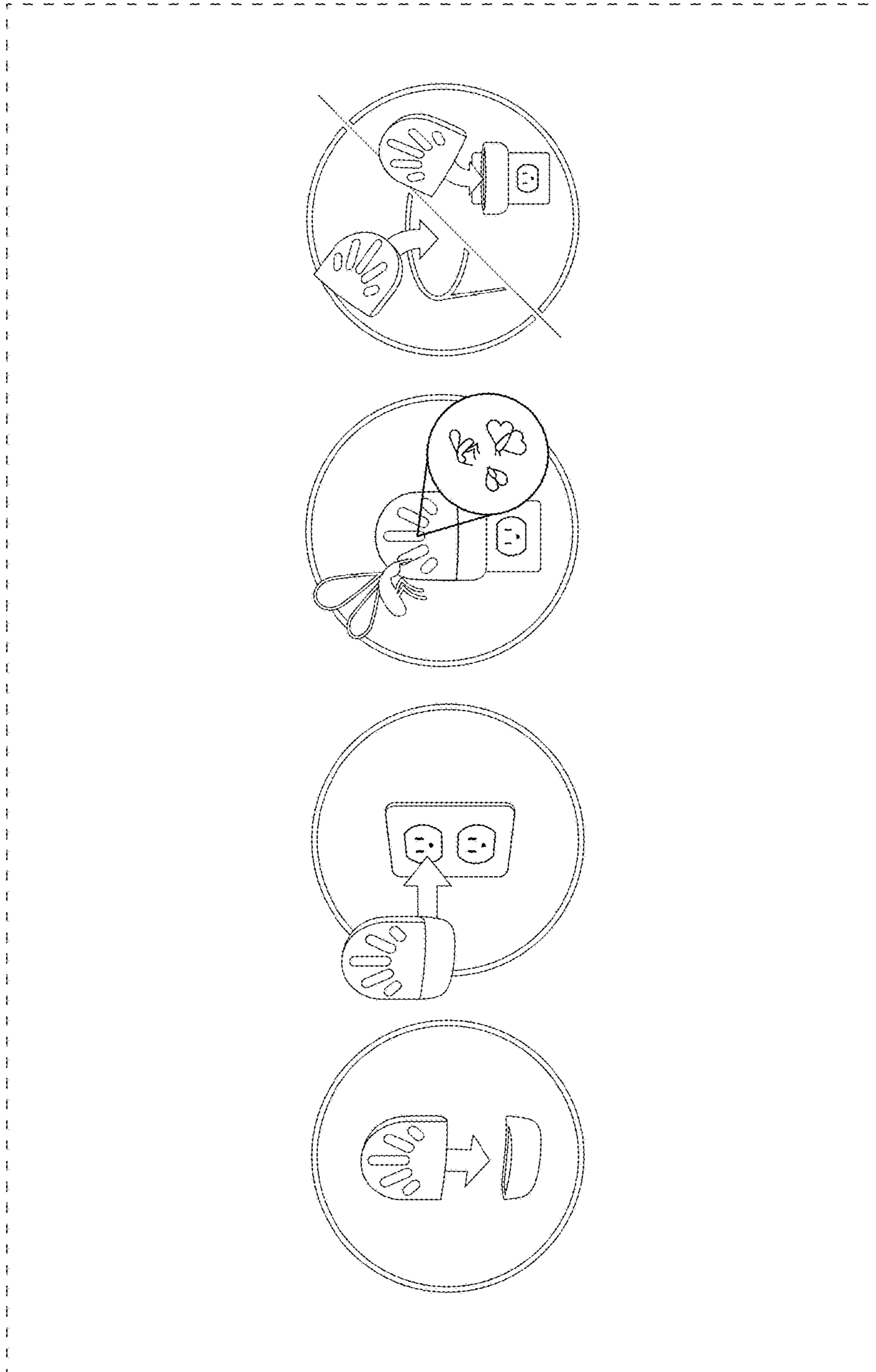

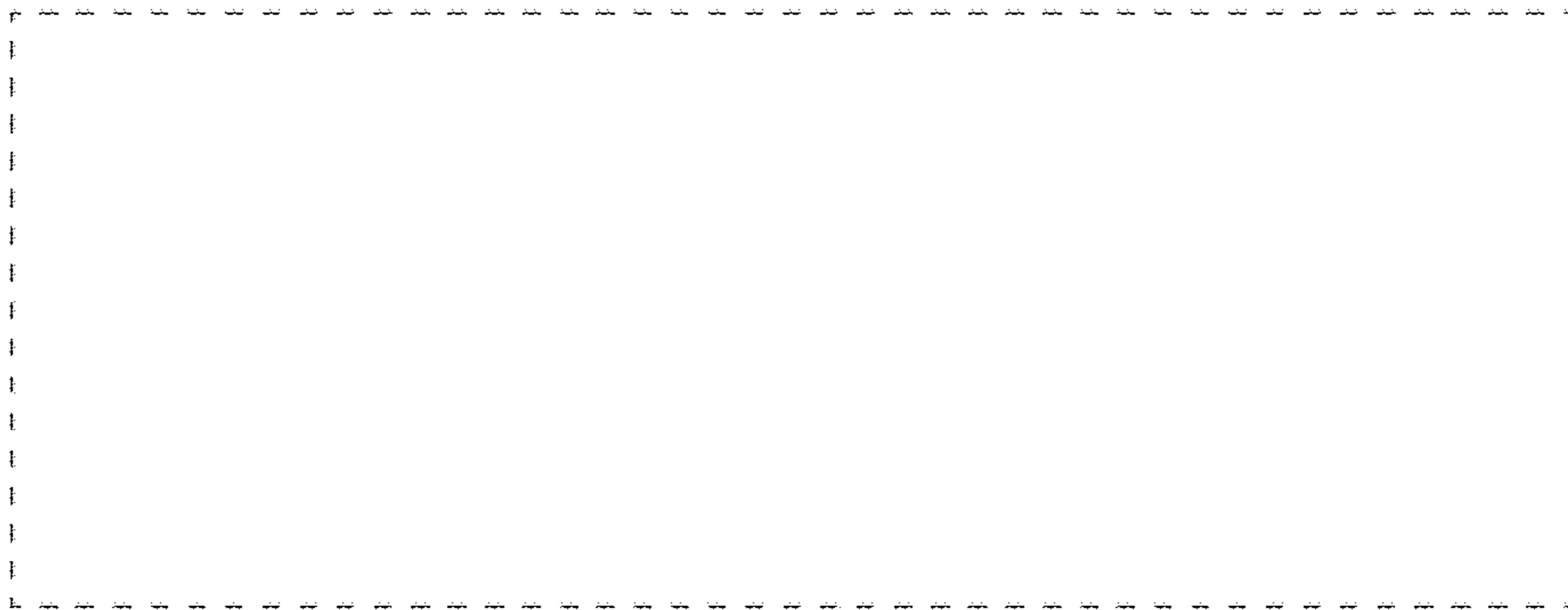

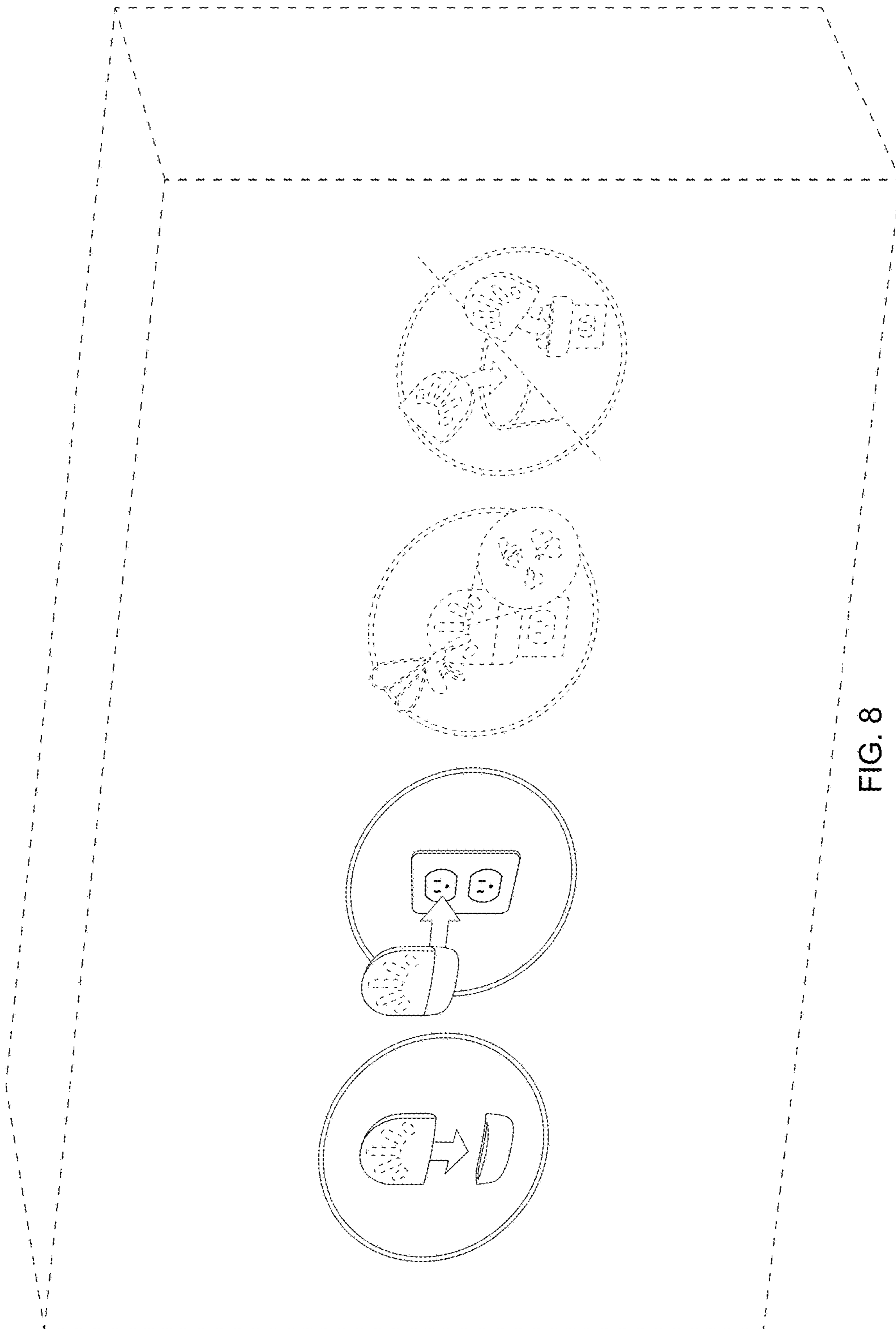

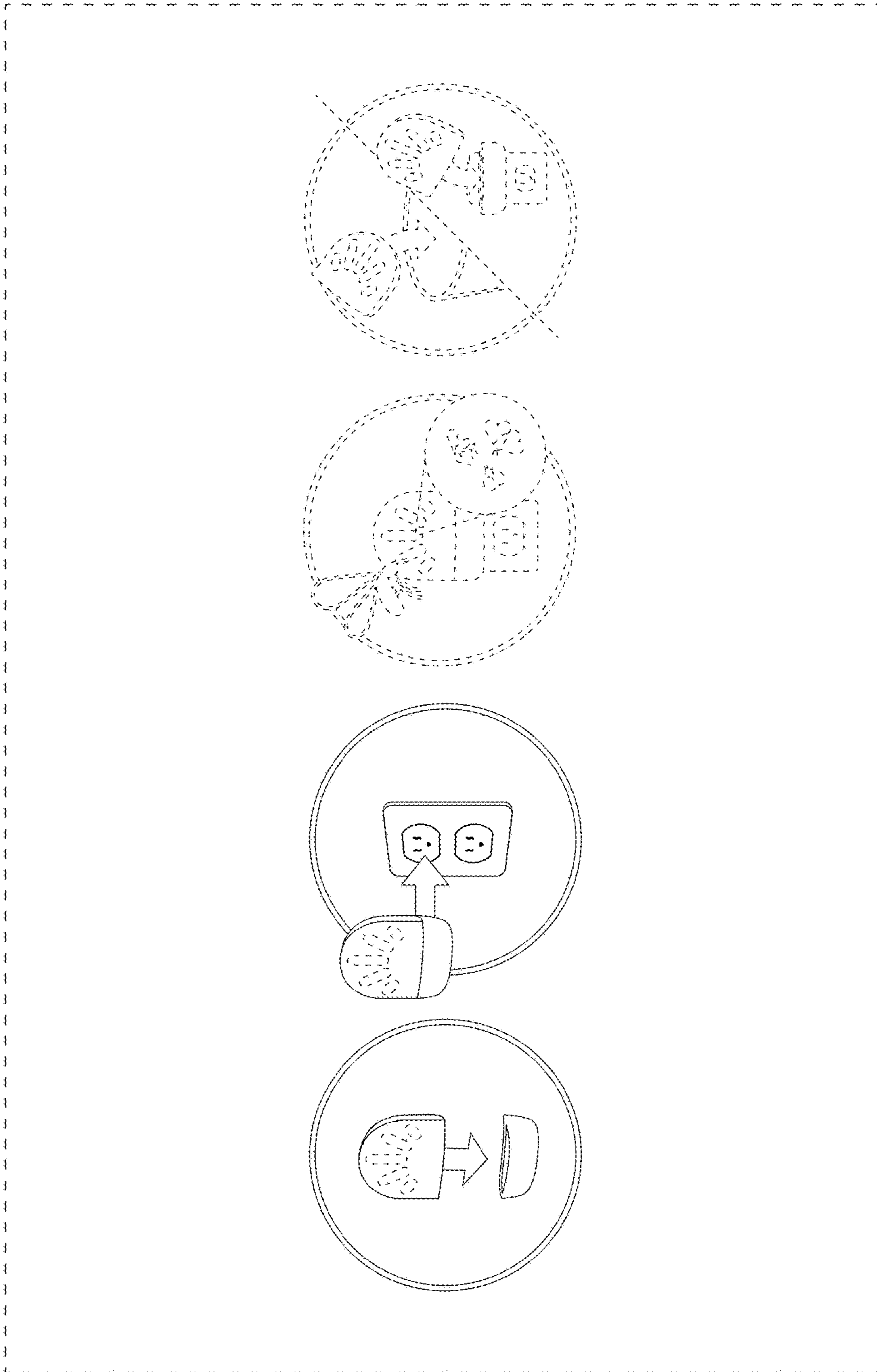

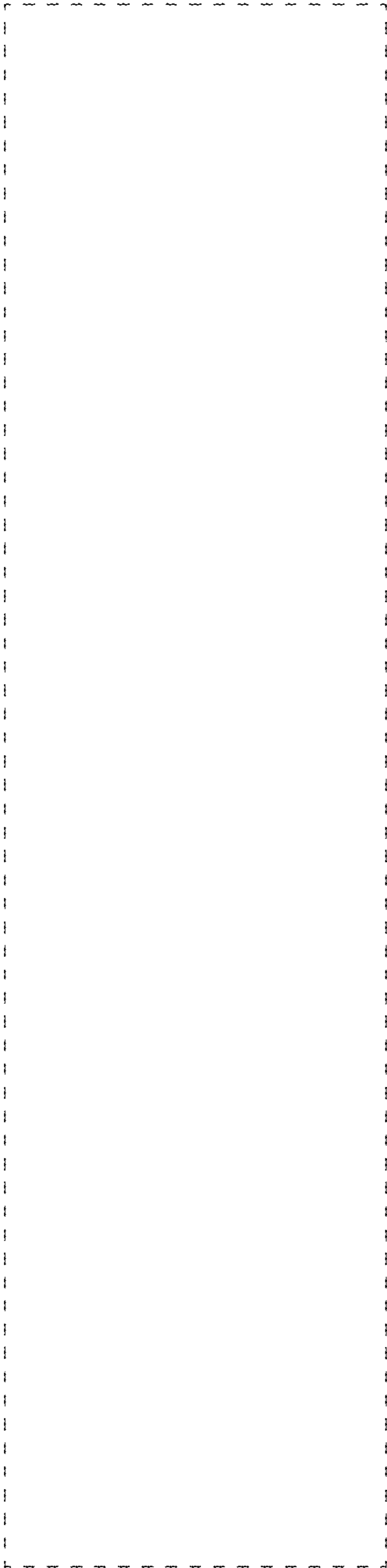

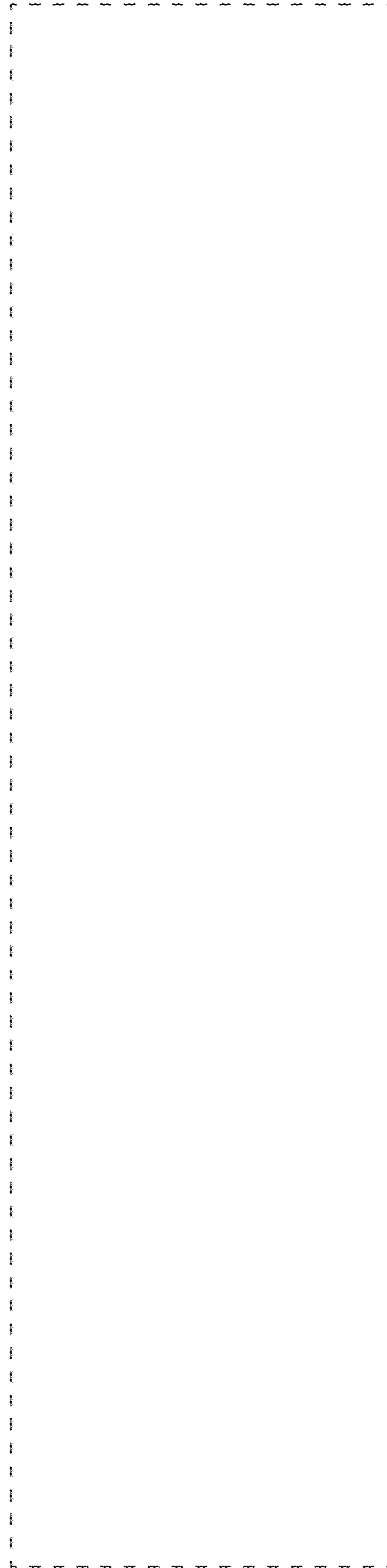

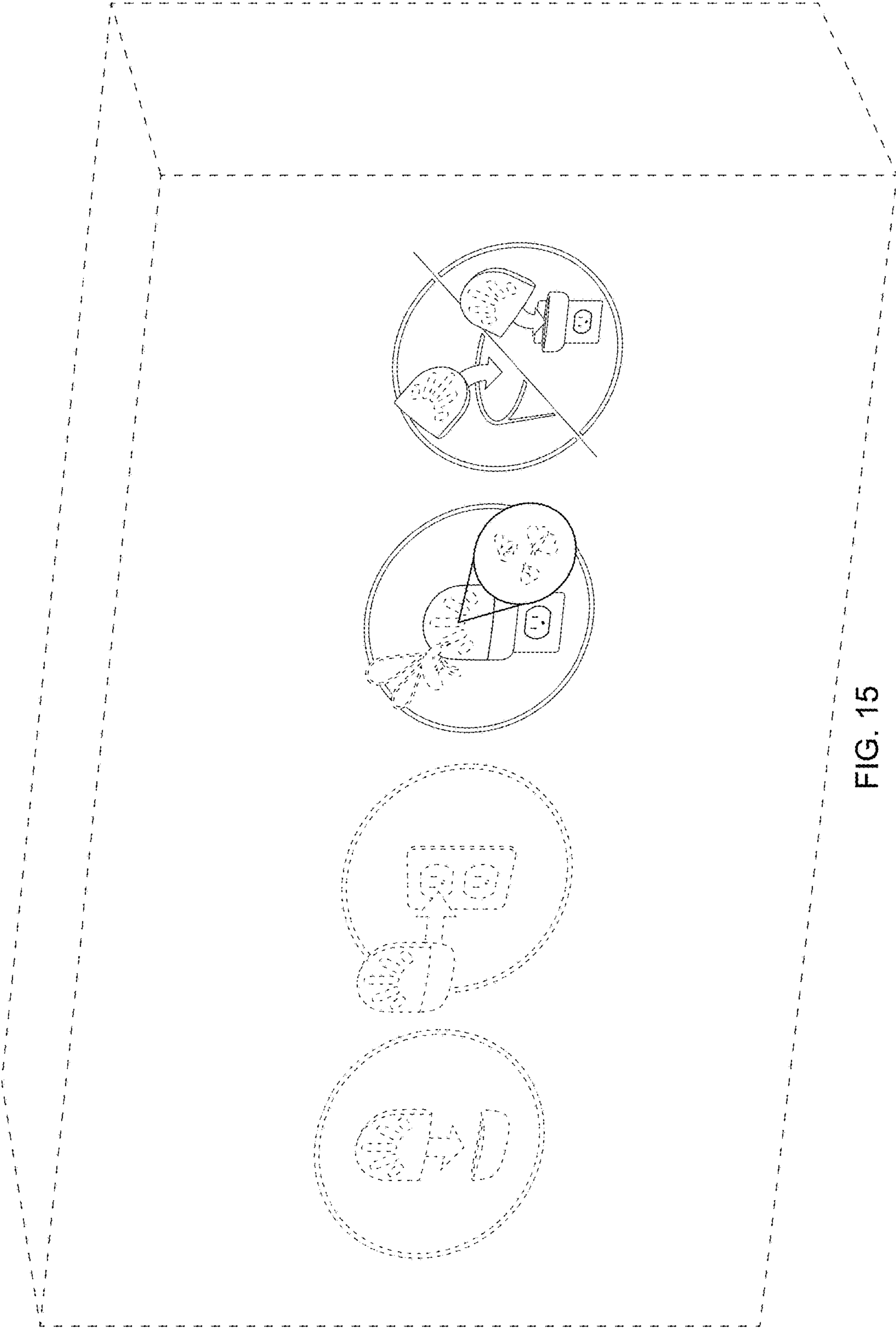

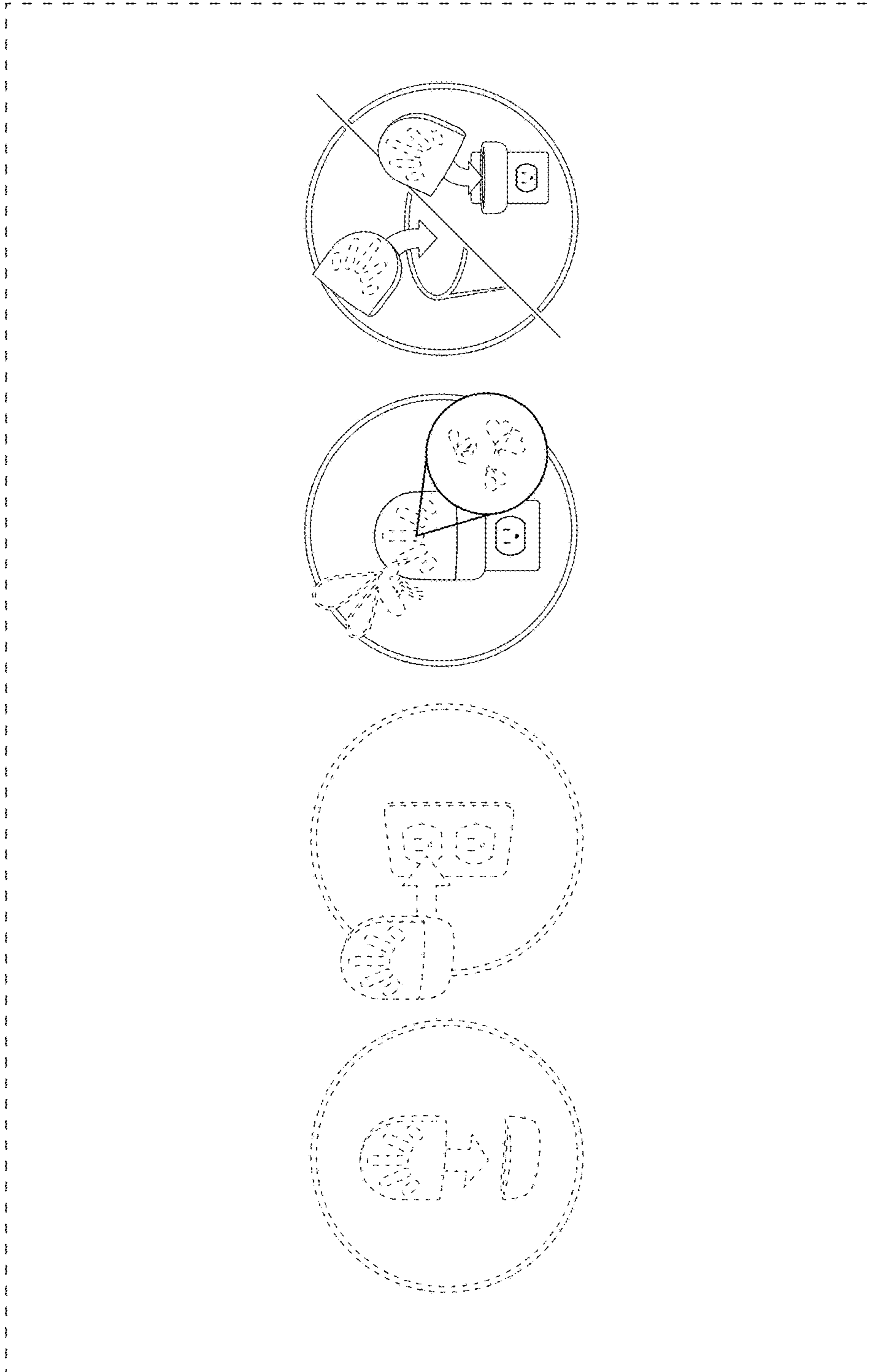

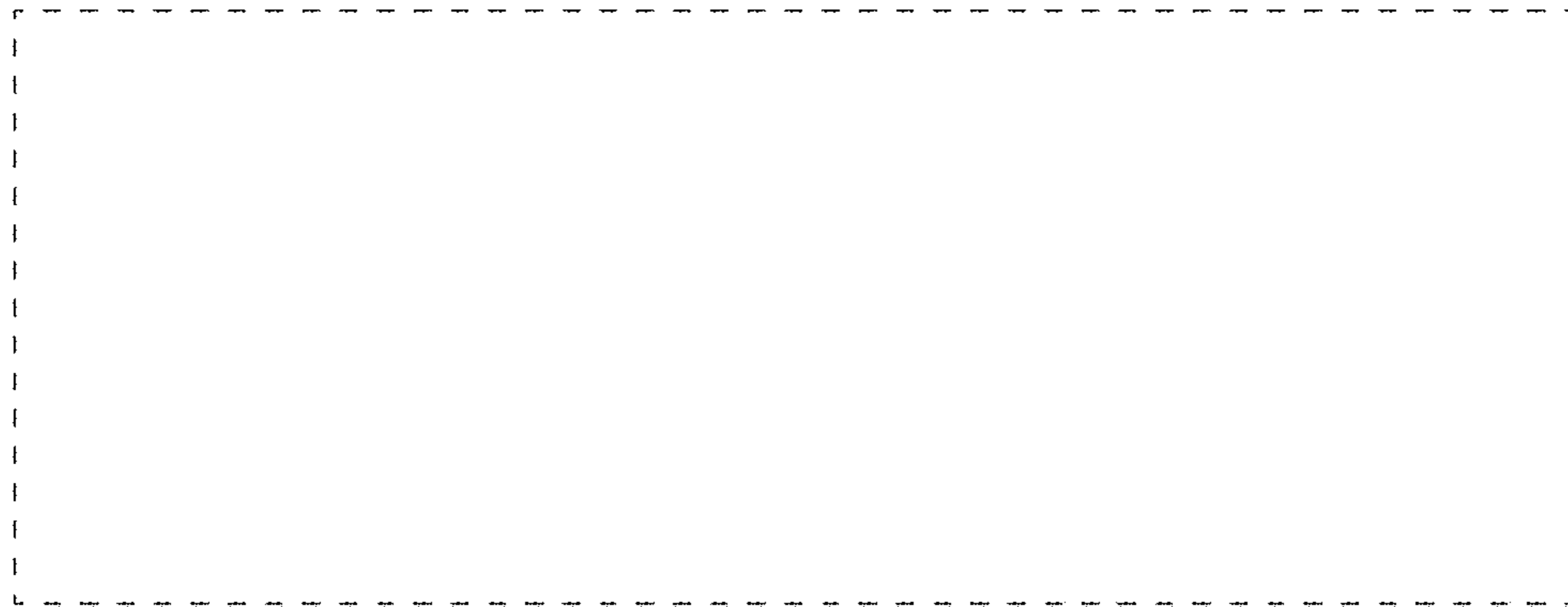

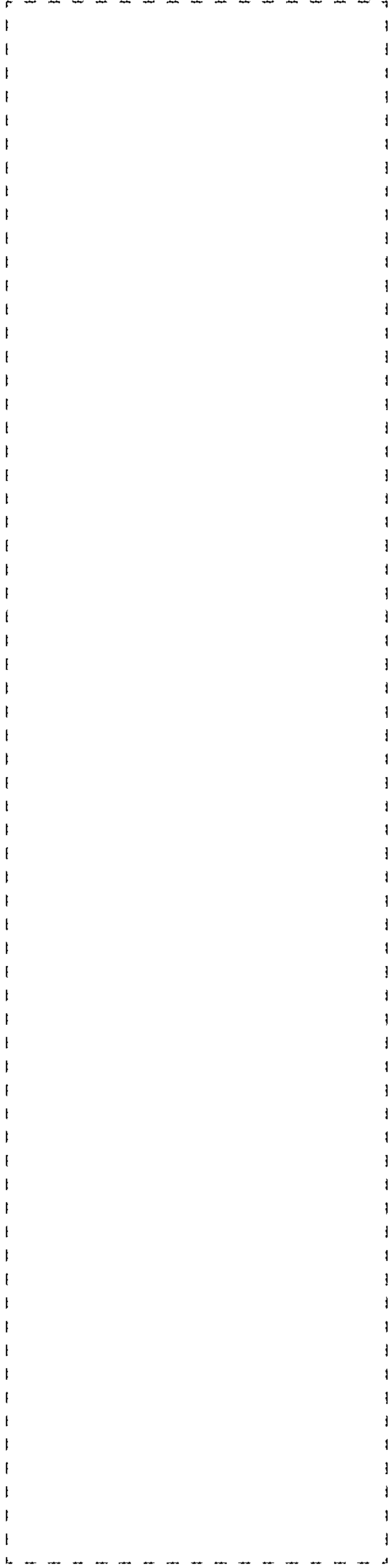

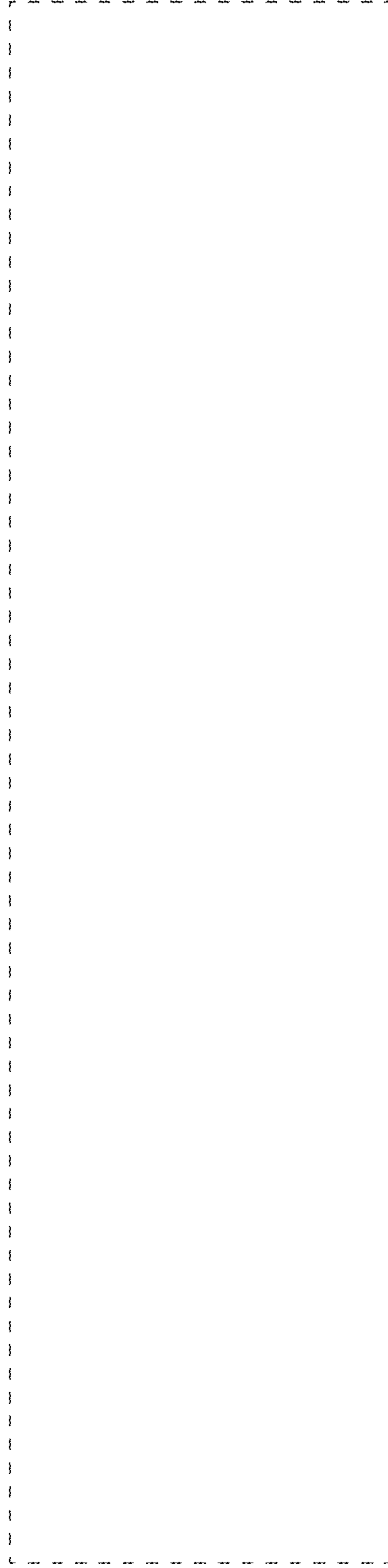

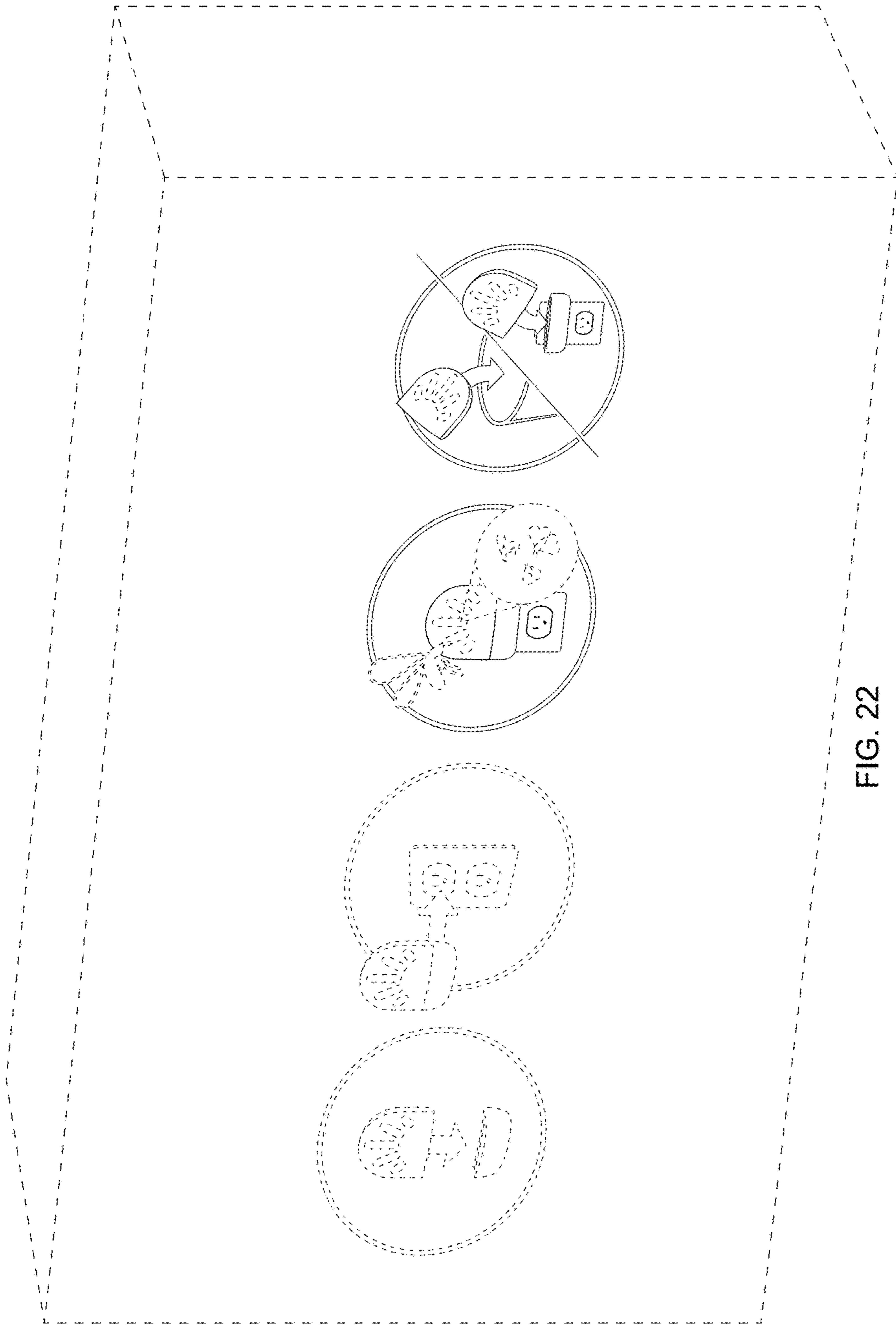

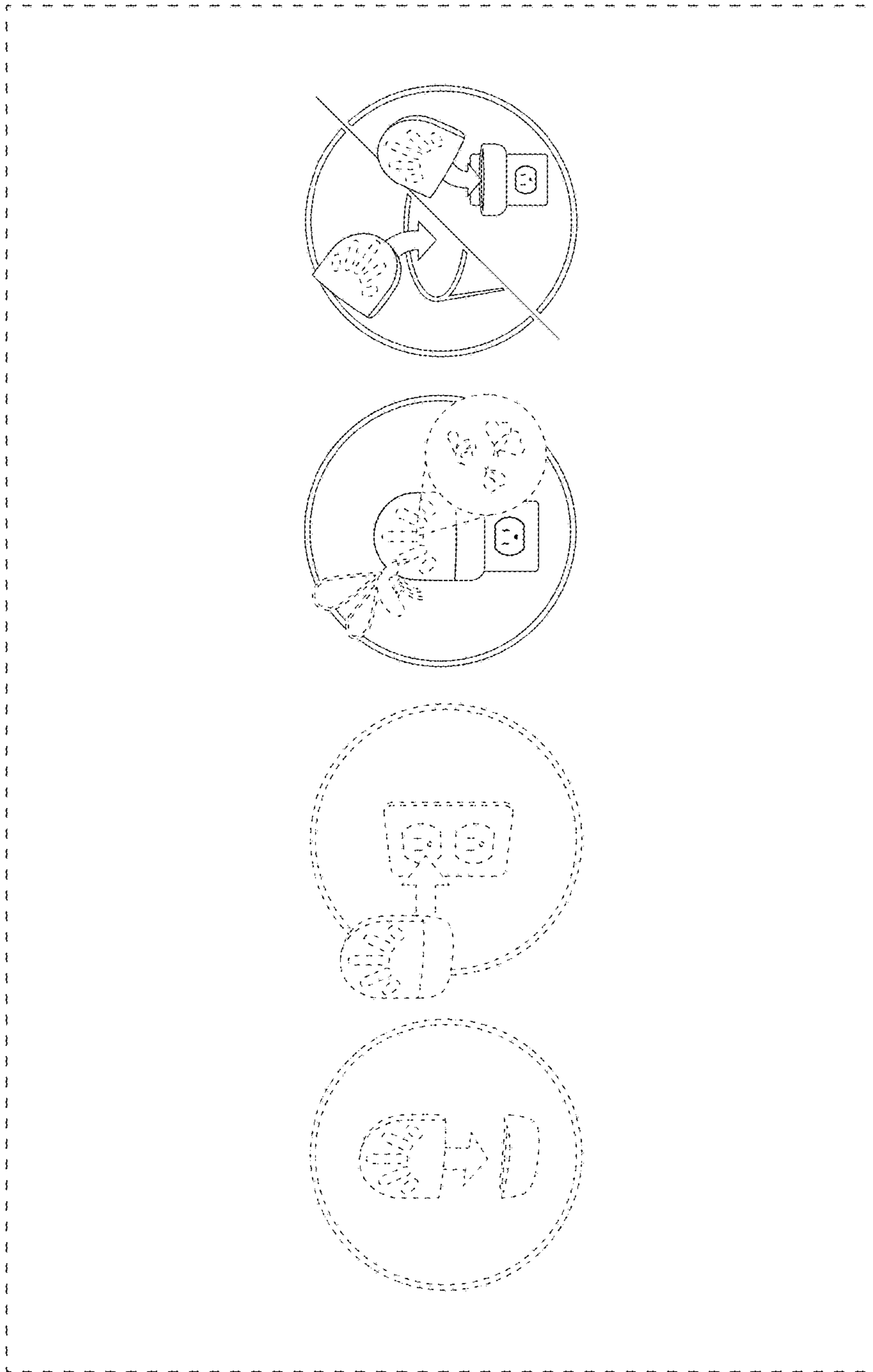

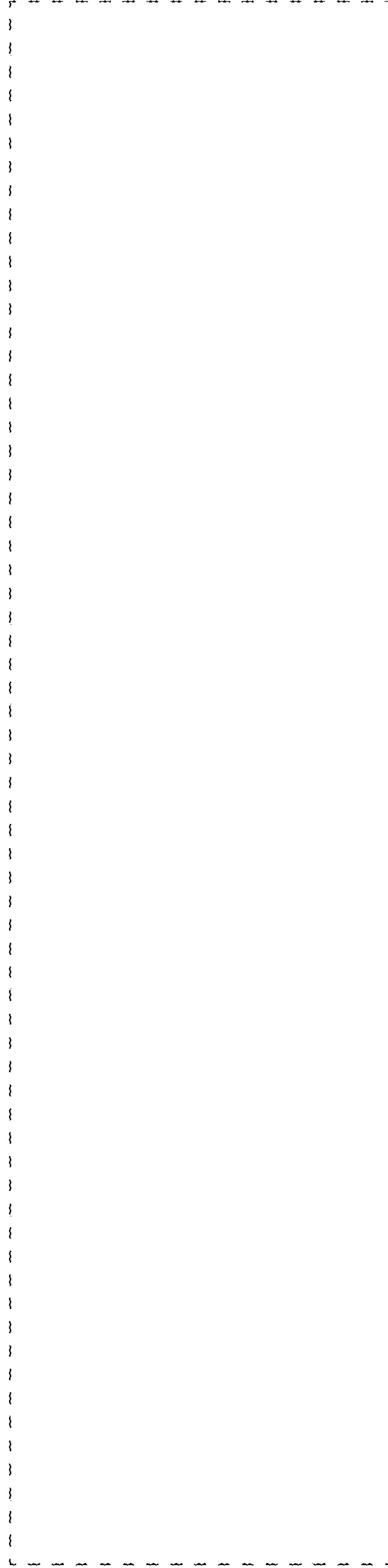
