The ornamental design for a finish, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, top perspective view of a finish showing my new design;
 FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a right side elevational view thereof; and,
 FIG. 5 is a top plan view.
 The dash-dot-dash lines depict changes in contour and are part of the claim.
 The dash-dot-dot-dash broken lines depict portions of the finish that form no part of the claim.

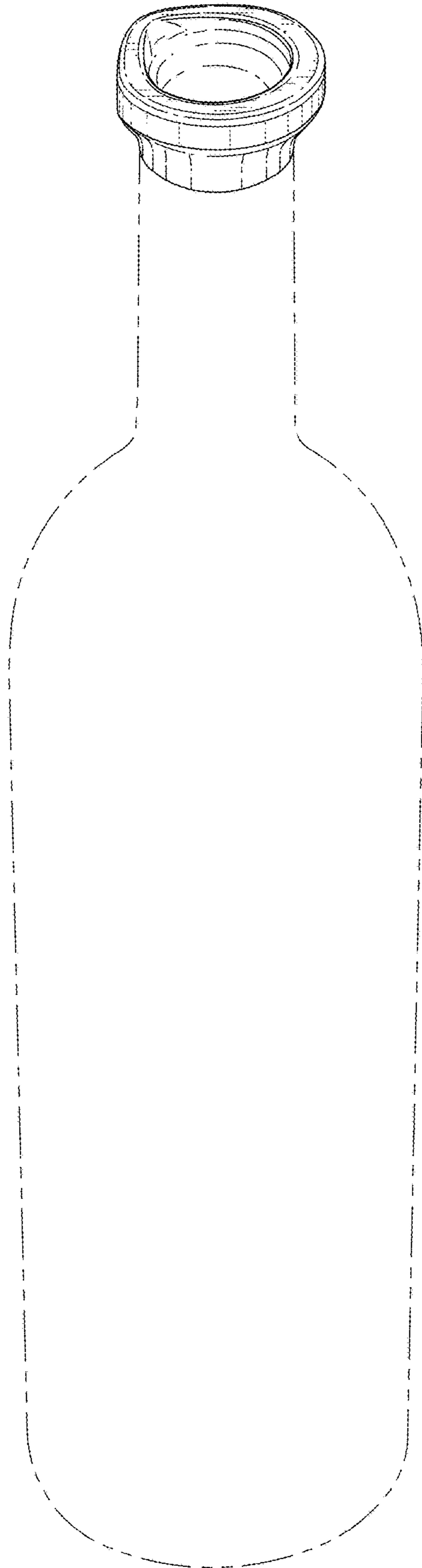

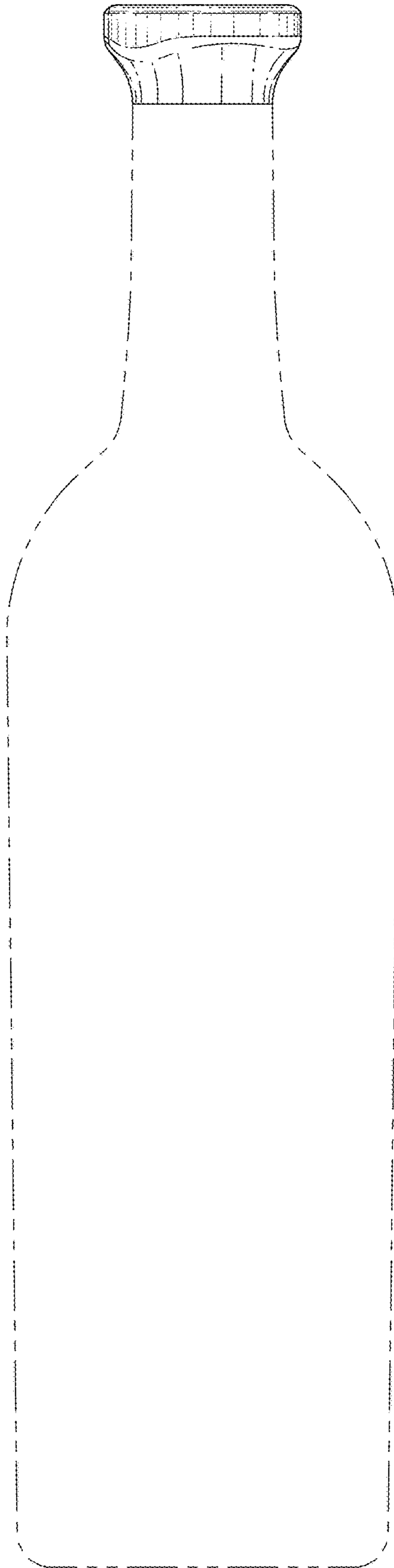

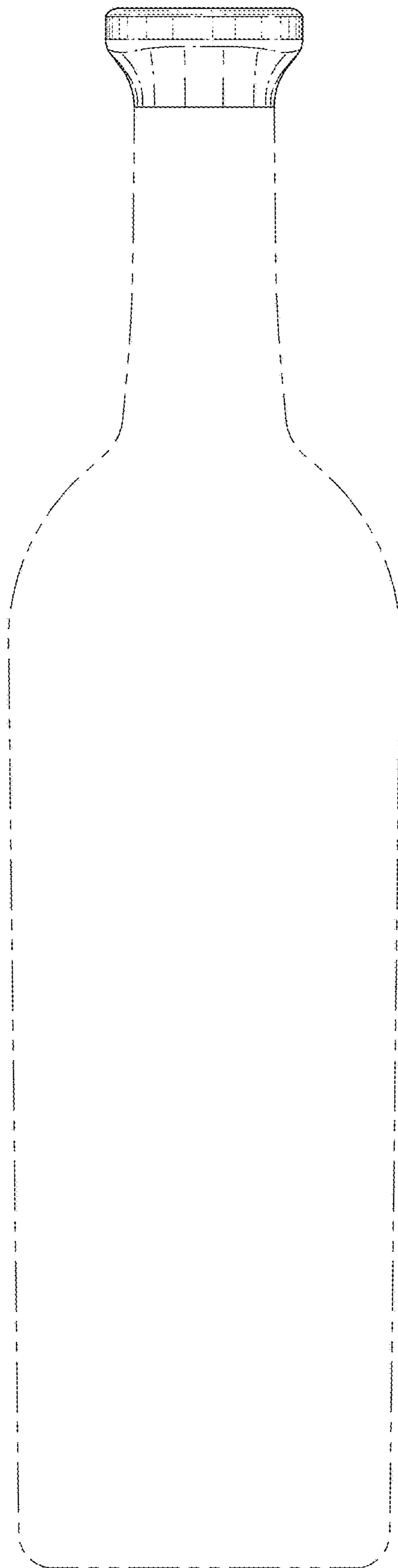

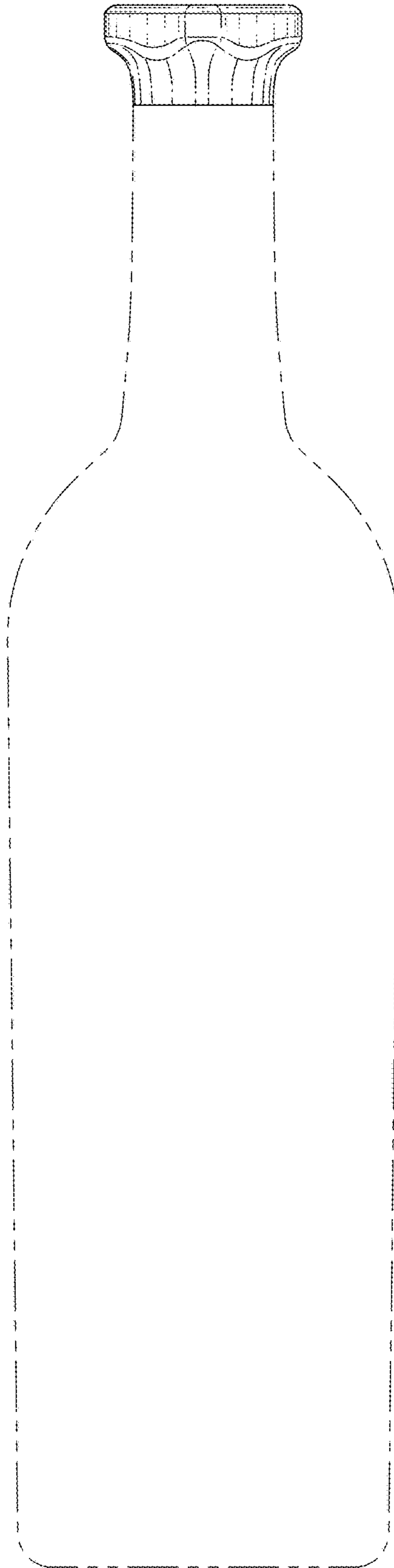

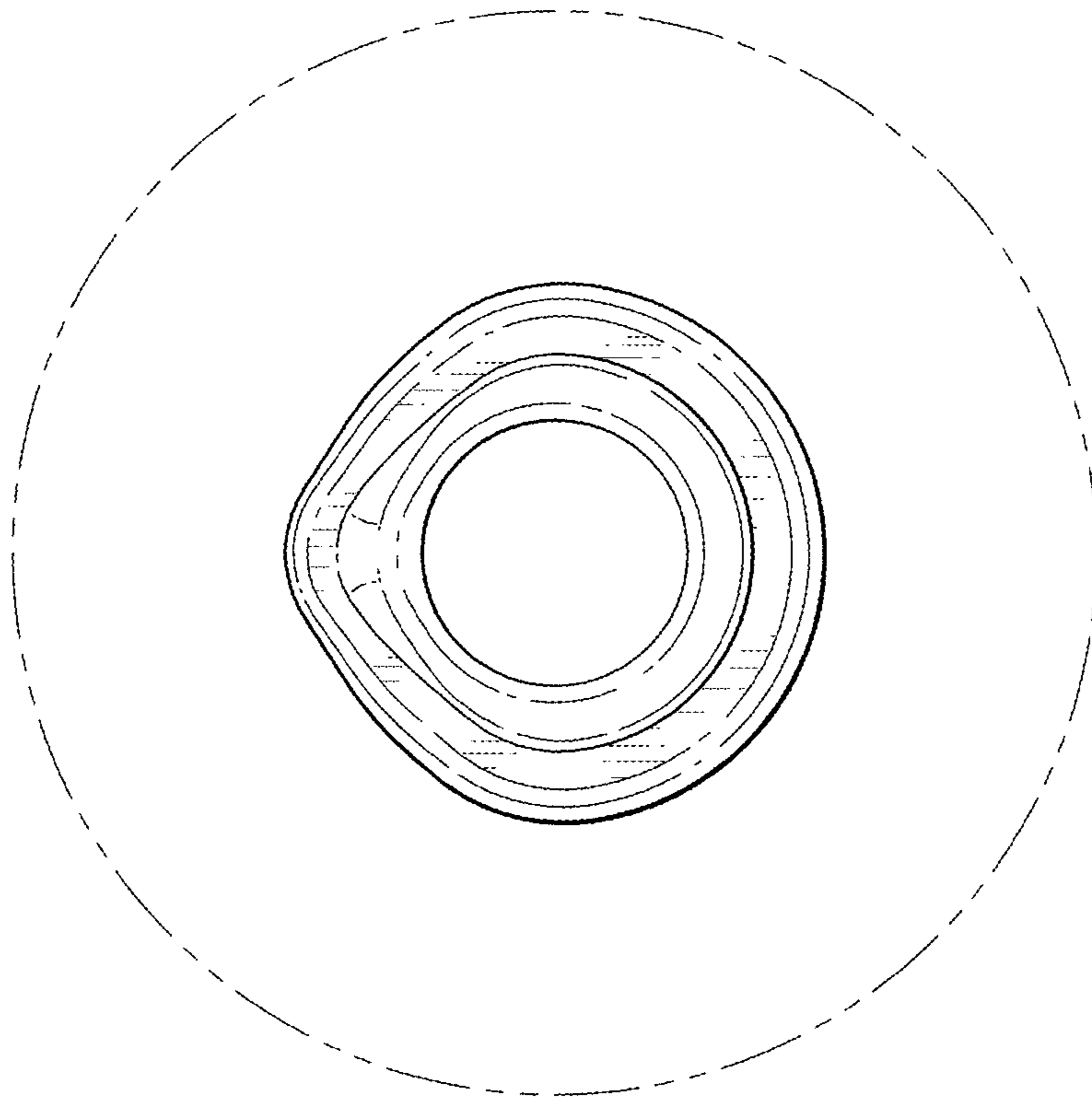
