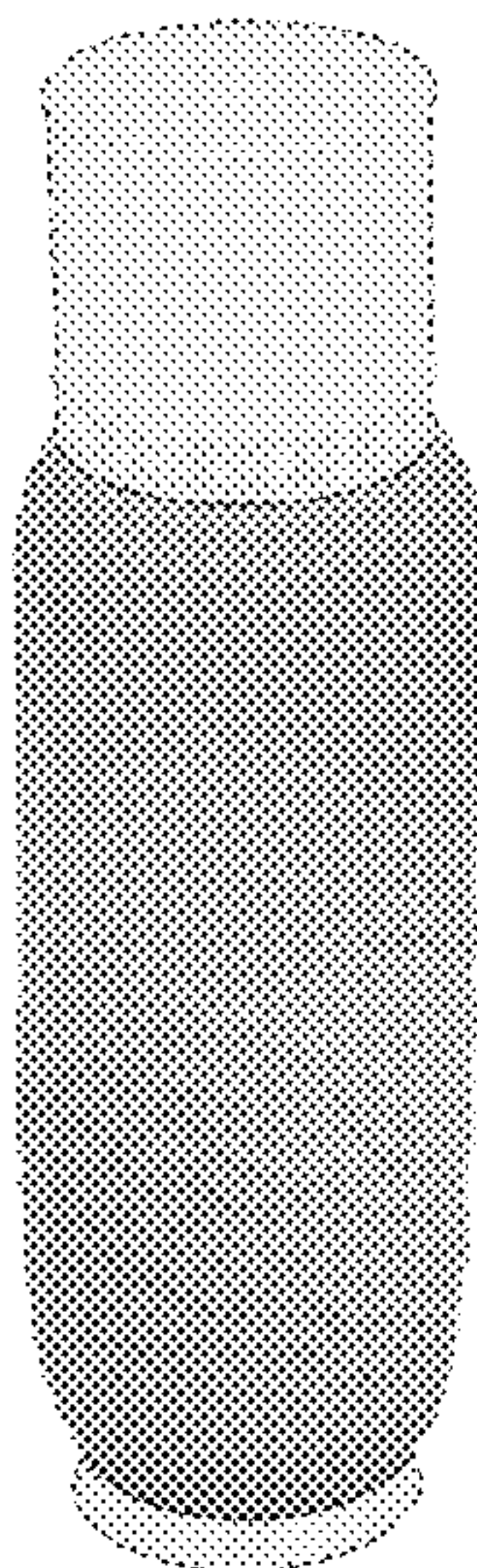
(57) **CLAIM**

The ornamental design for a cosmetic vessel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cosmetic vessel according to the present invention.
FIG. 2 is a front view of the cosmetic vessel of FIG. 1.
FIG. 3 is a rear view of the cosmetic vessel of FIG. 1.
FIG. 4 is a left side view of the cosmetic vessel of FIG. 1.
FIG. 5 is a right side view of the cosmetic vessel of FIG. 1.
FIG. 6 is an enlarged top view of the cosmetic vessel of FIG. 1; and,
FIG. 7 is an enlarged bottom view of the cosmetic vessel of FIG. 1.
The broken lines, and the areas shown in lighter gray within, show portions of the cosmetic vessel that form no part of the claimed design.

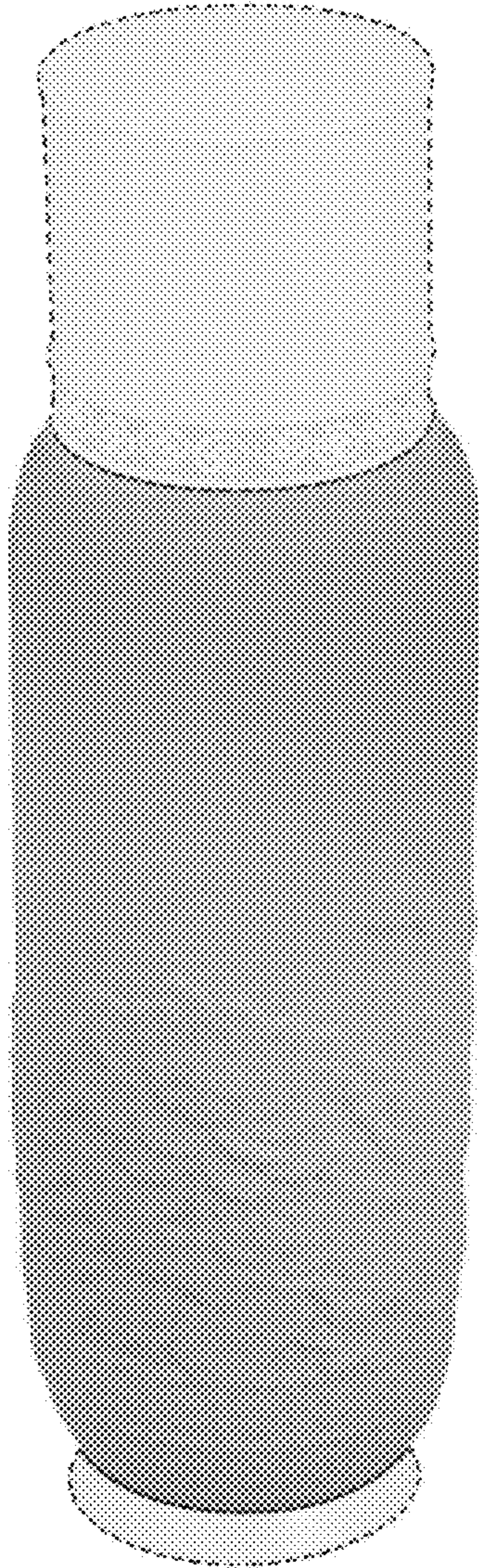

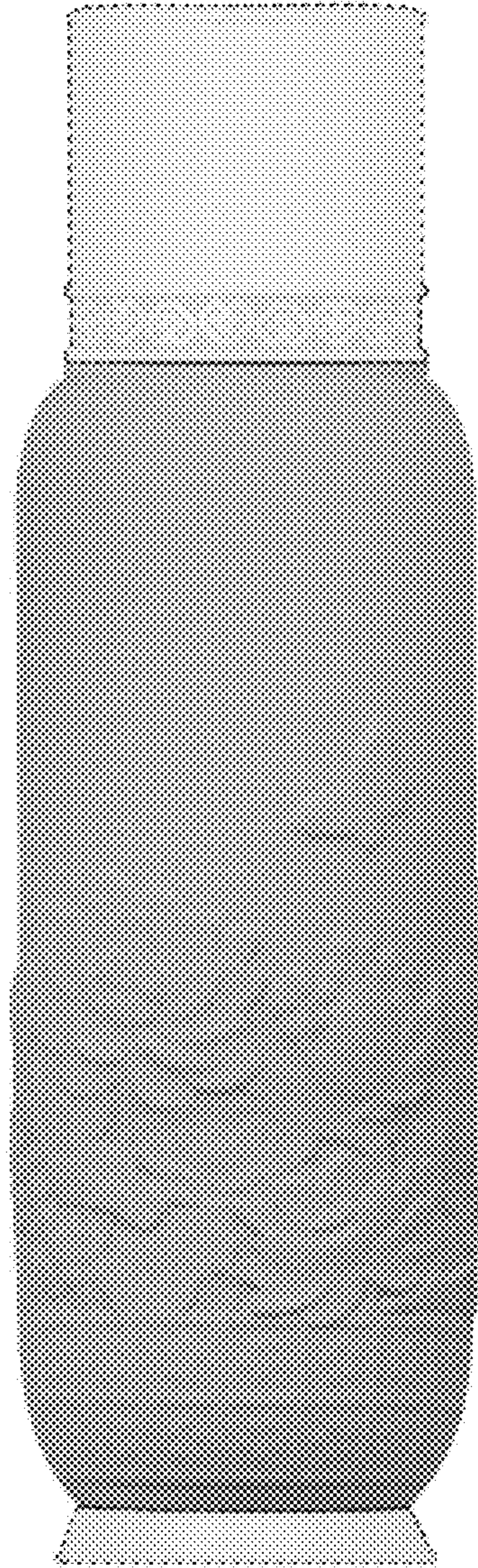

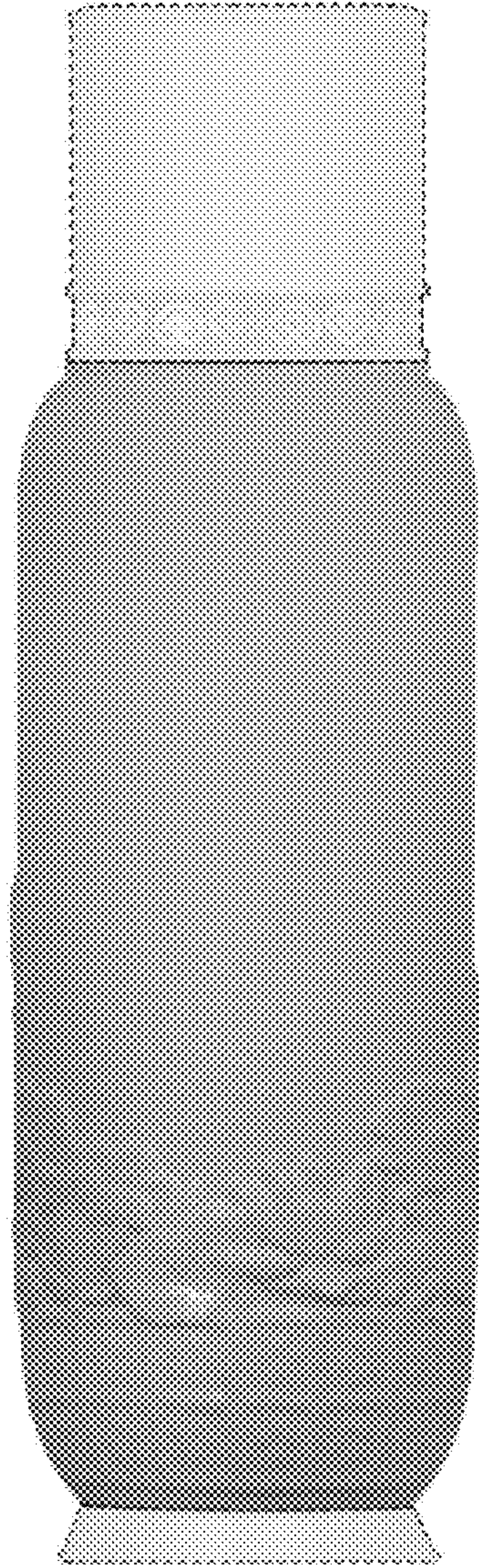

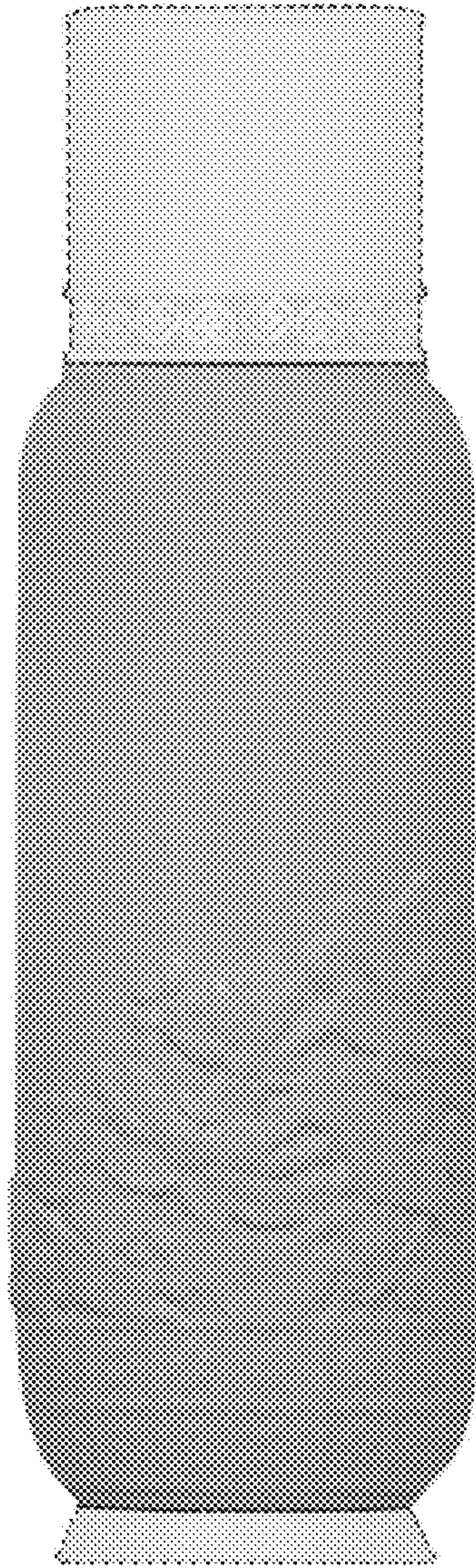

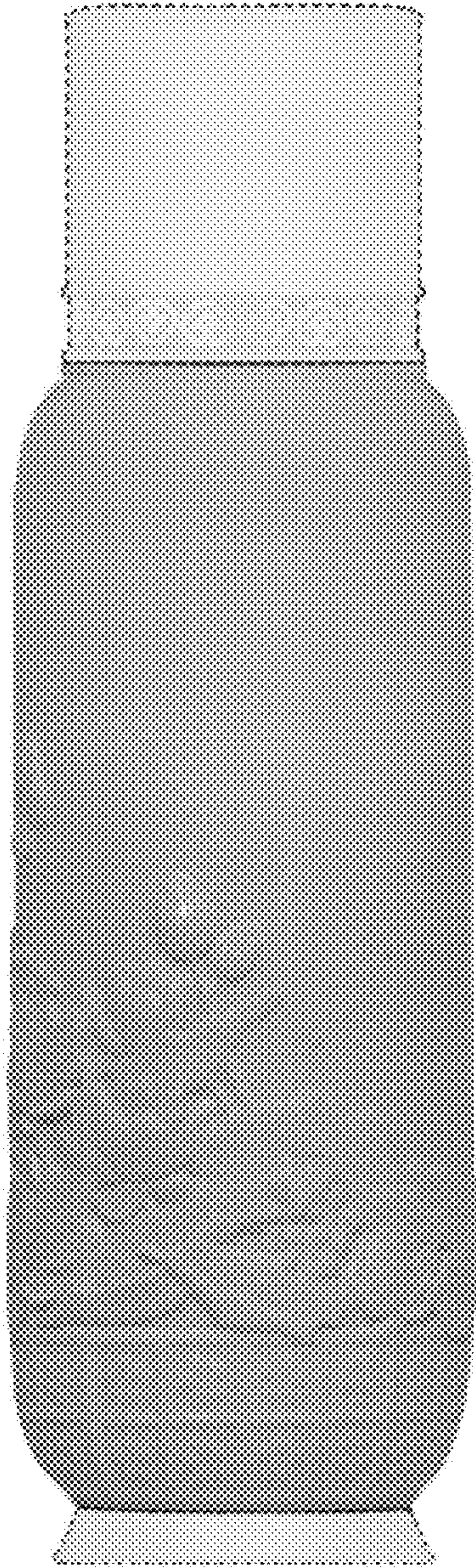

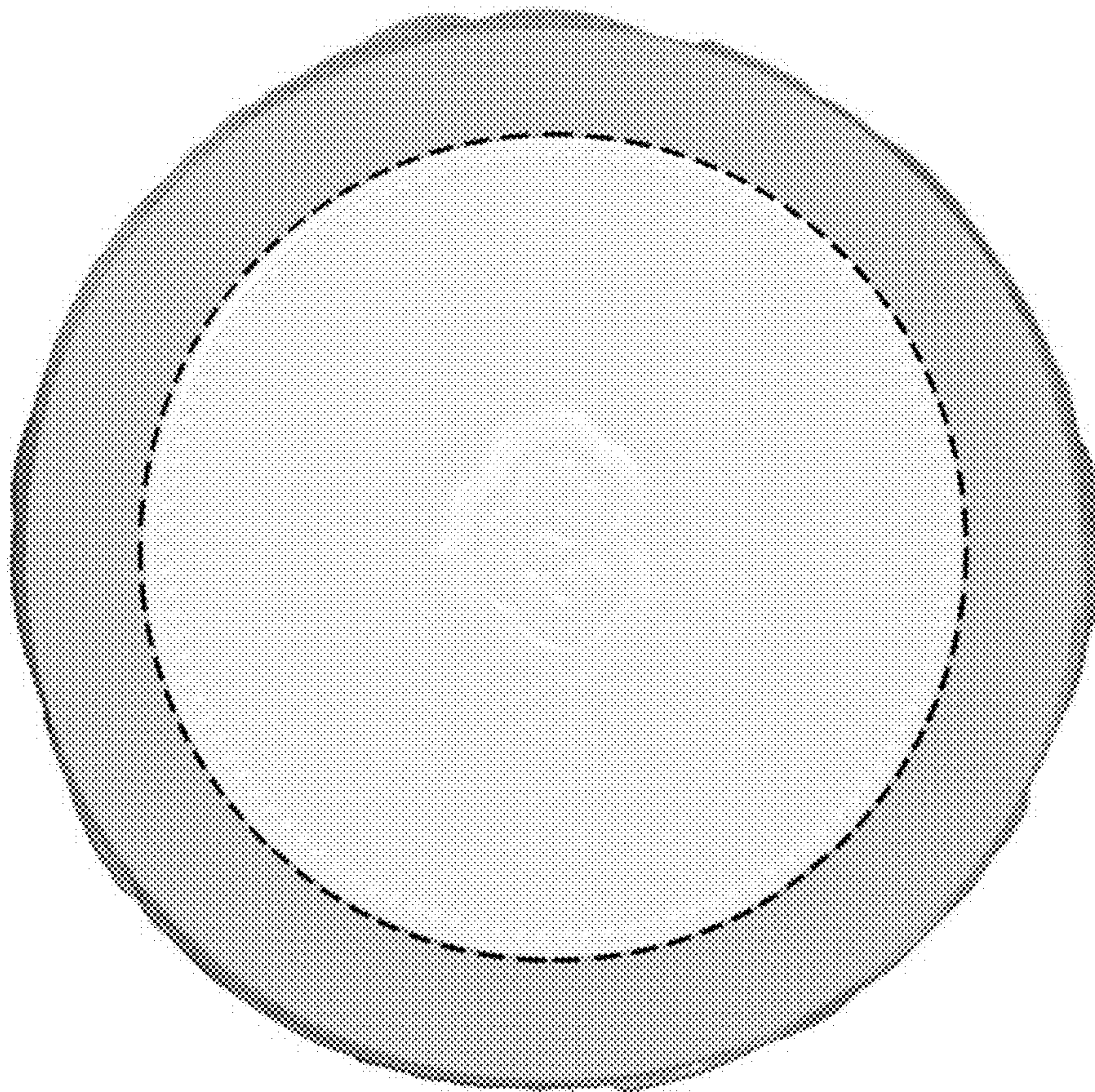

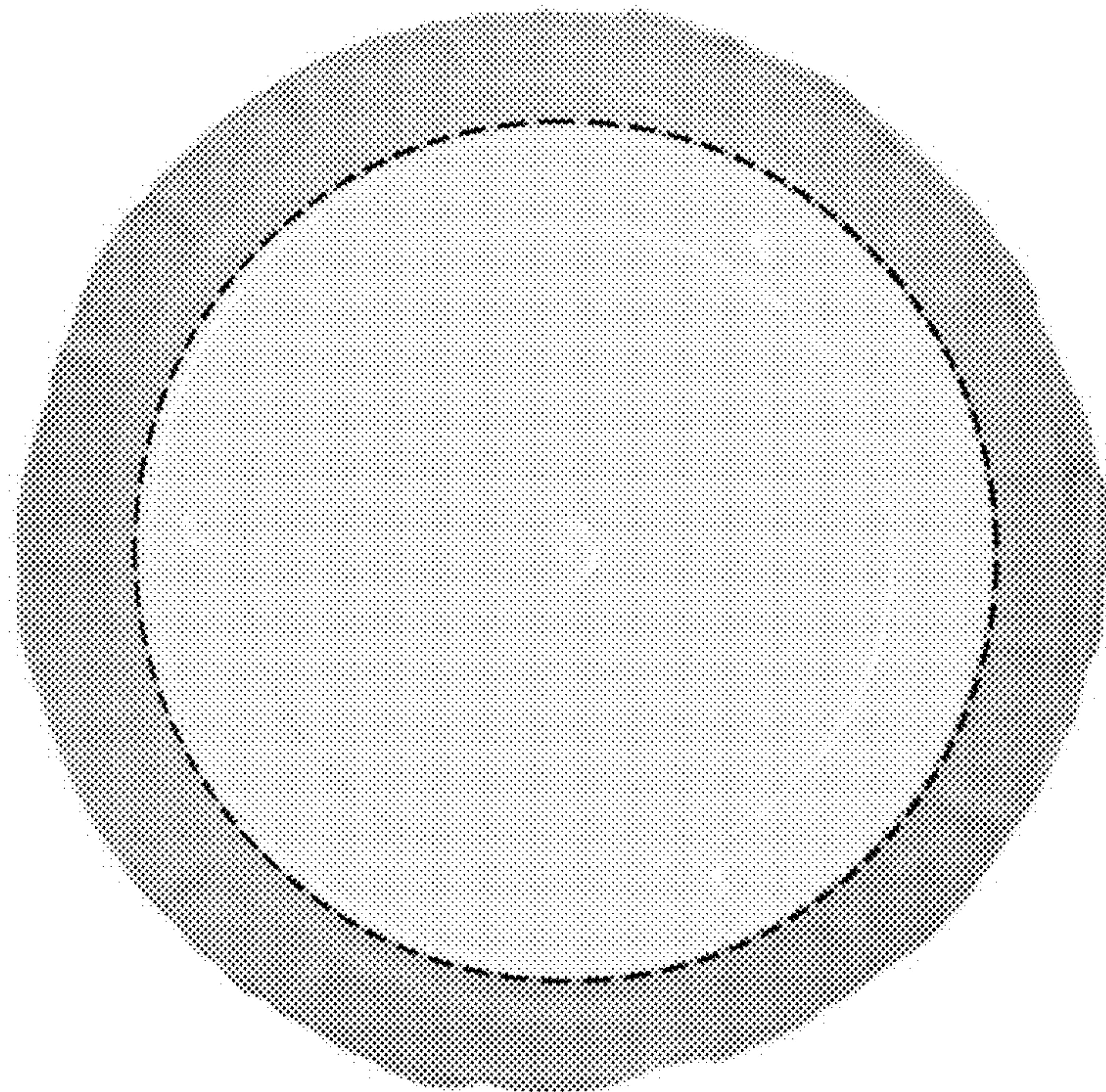
