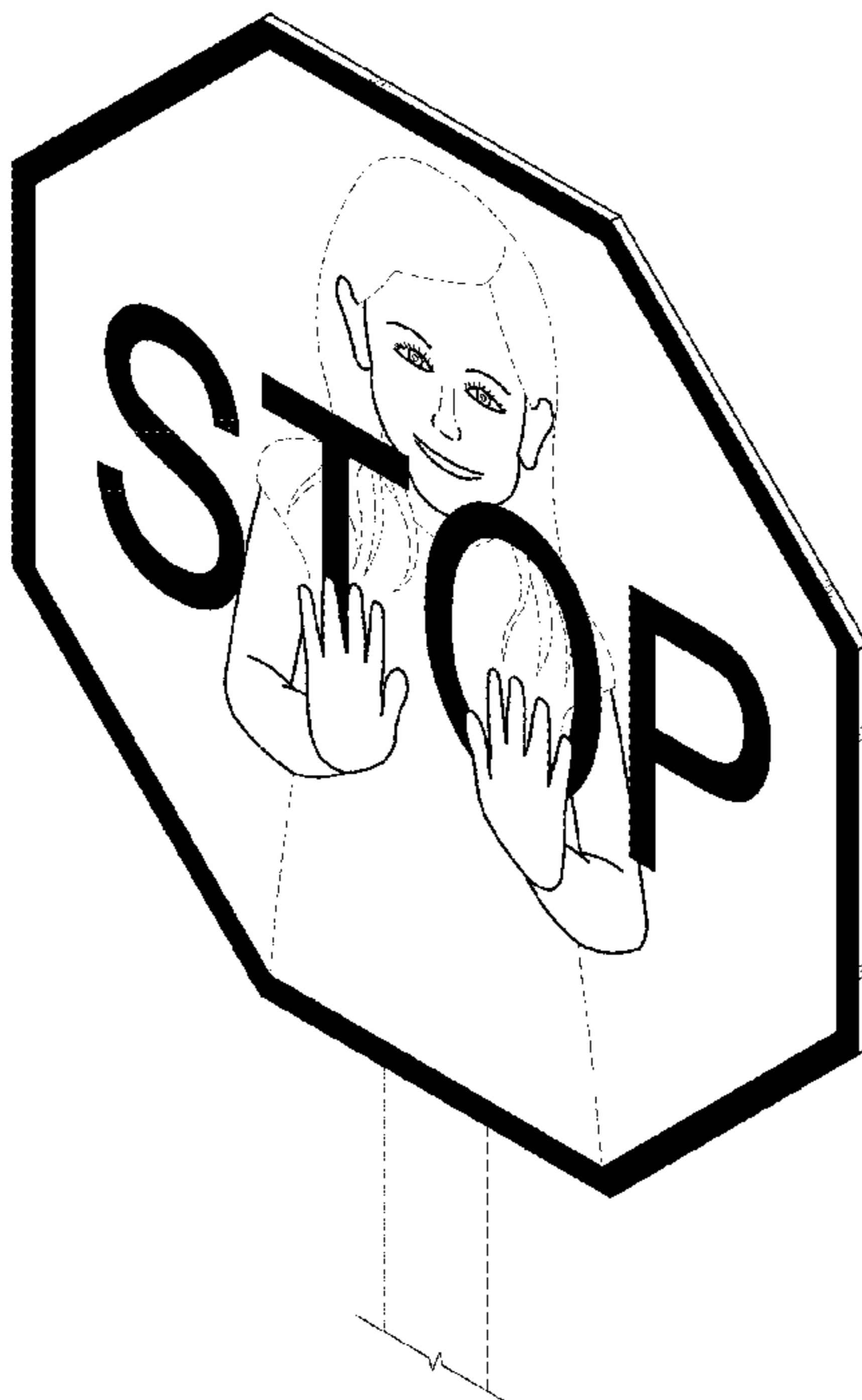
(57) **CLAIM**

The ornamental design for a stop sign with subject's hands in a stop position.

DESCRIPTION

FIG. 1 is a front perspective view of a stop sign illustrating a subject's hands raised in a stop position.
FIG. 2 is a front view of a stop sign illustrating a subject's hands raised in a stop position; and,
FIG. 3 is a front view of a stop sign illustrating a subject's hands raised in a stop position.
In the drawings, the broken lines depict environmental subject matter only and form no part of the claimed design.
The unclaimed sign post is shown with a symbolic break in its length. The appearance of any portion of the article after the break lines forms no part of the claimed design.

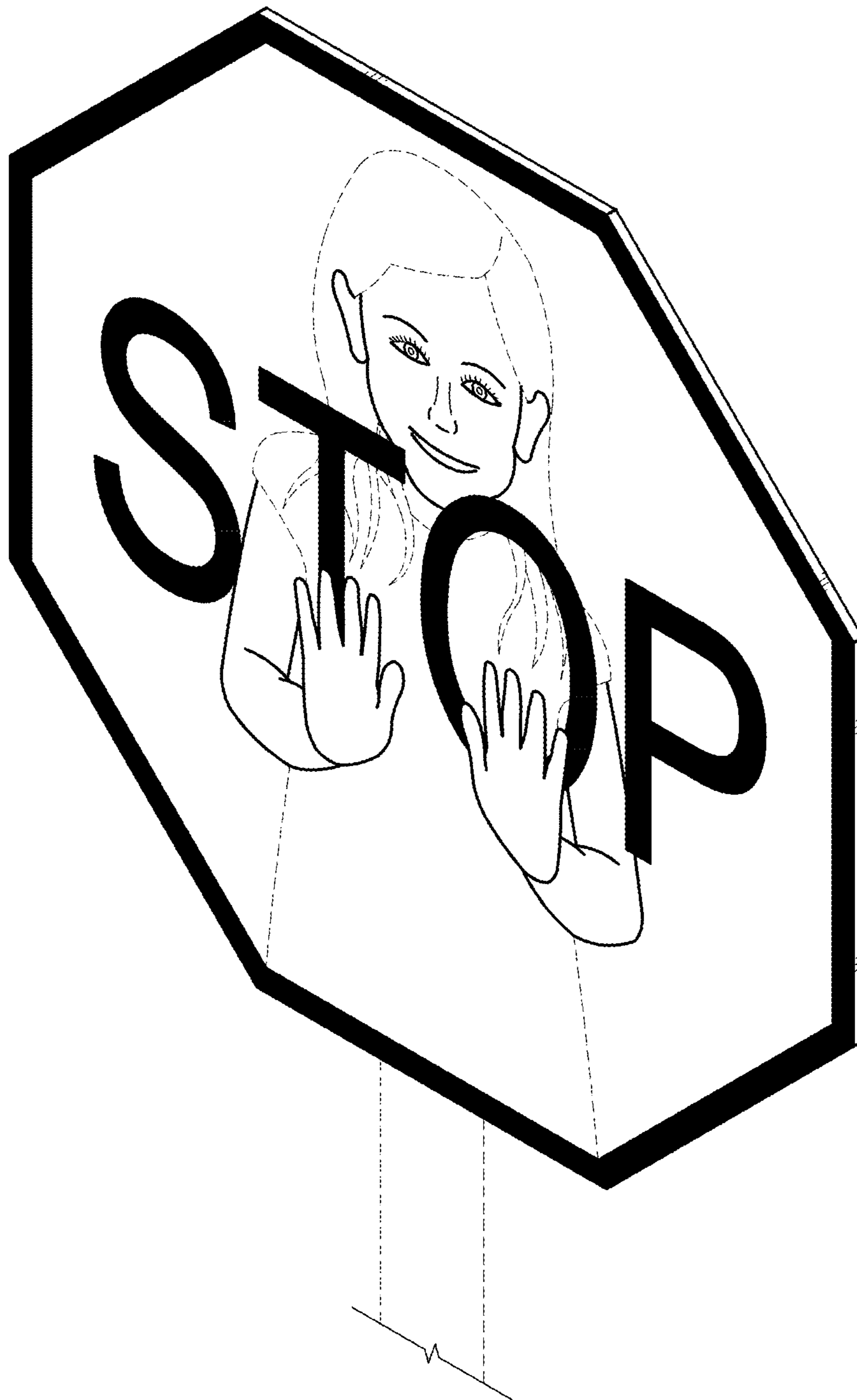

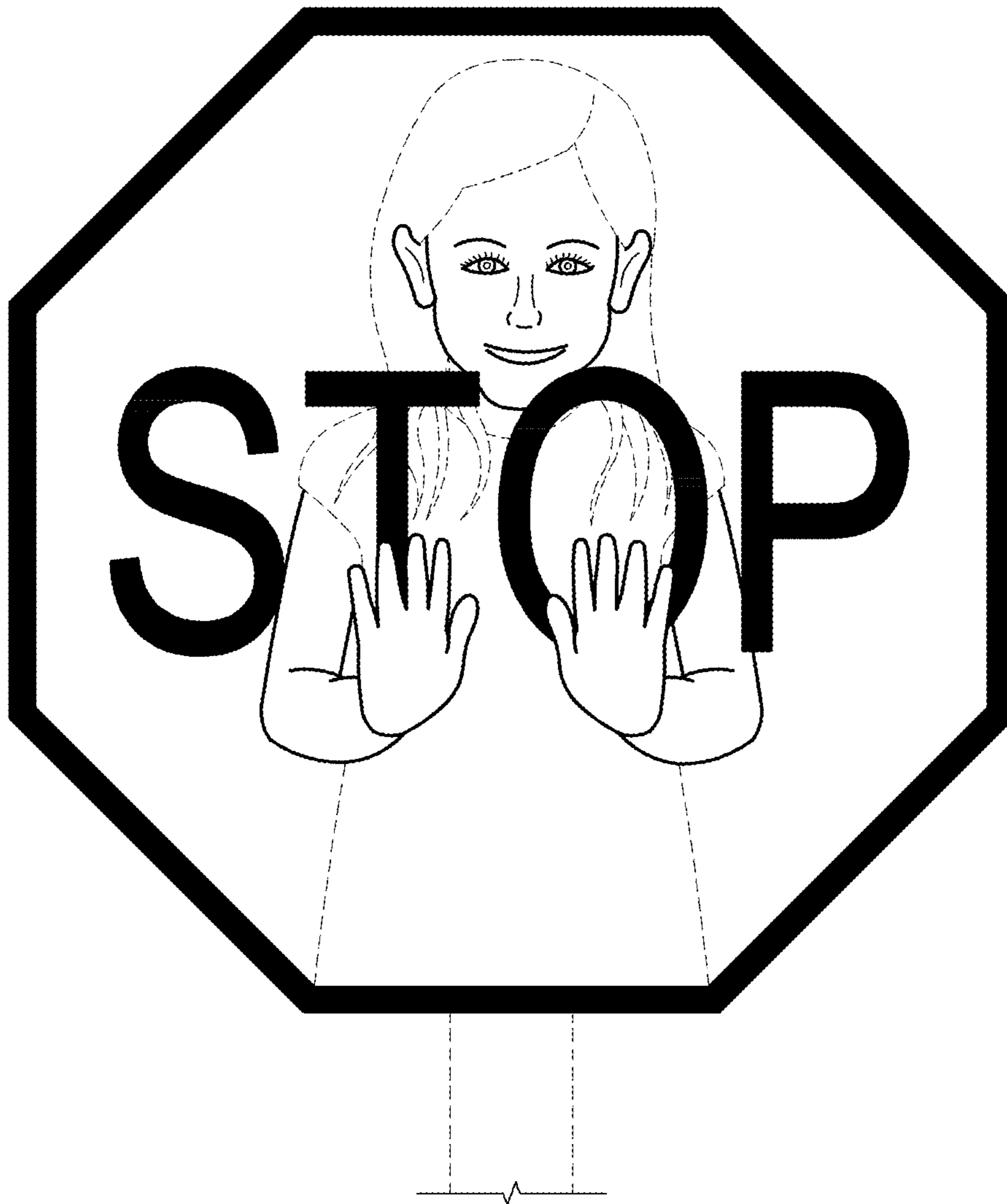

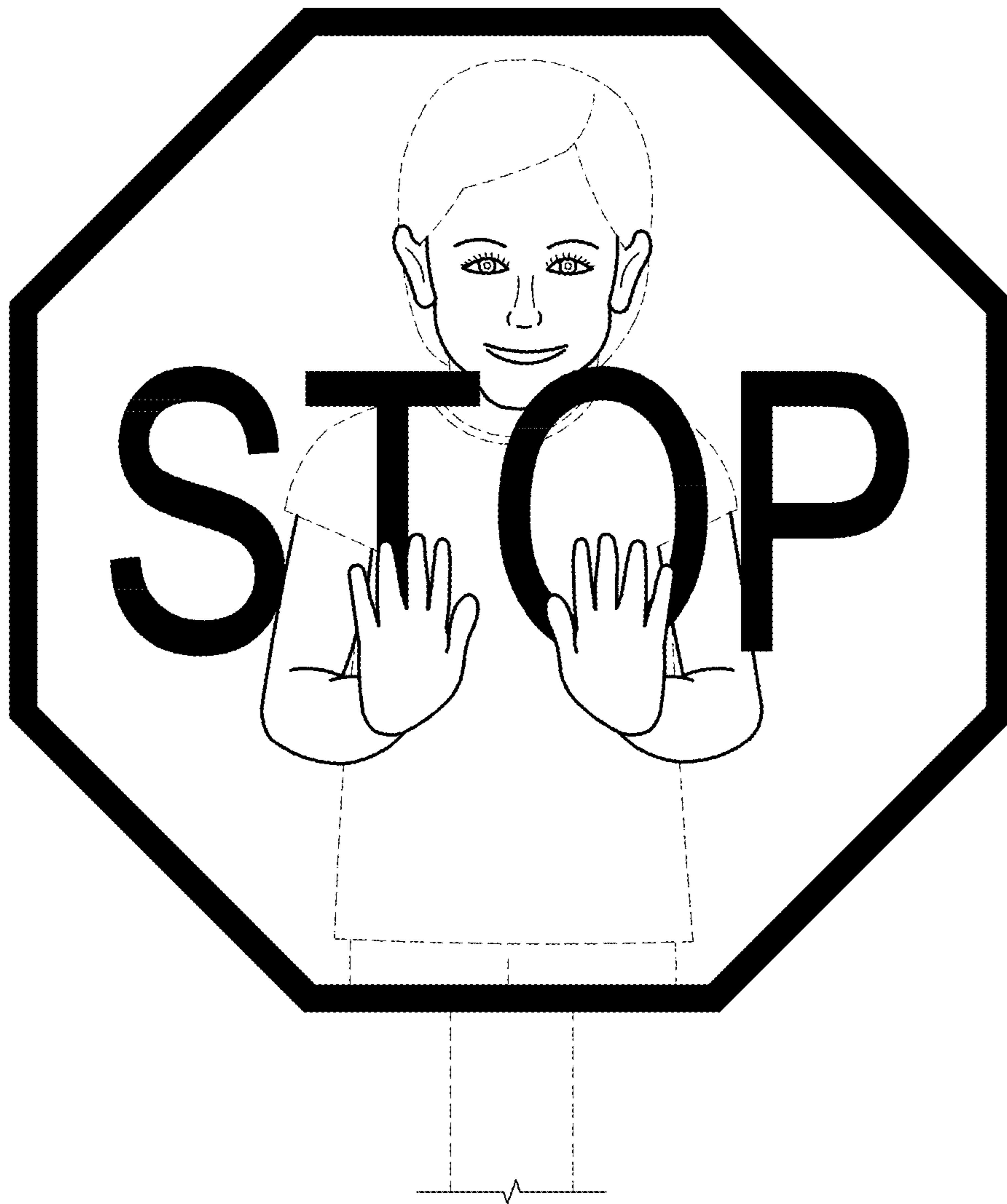
