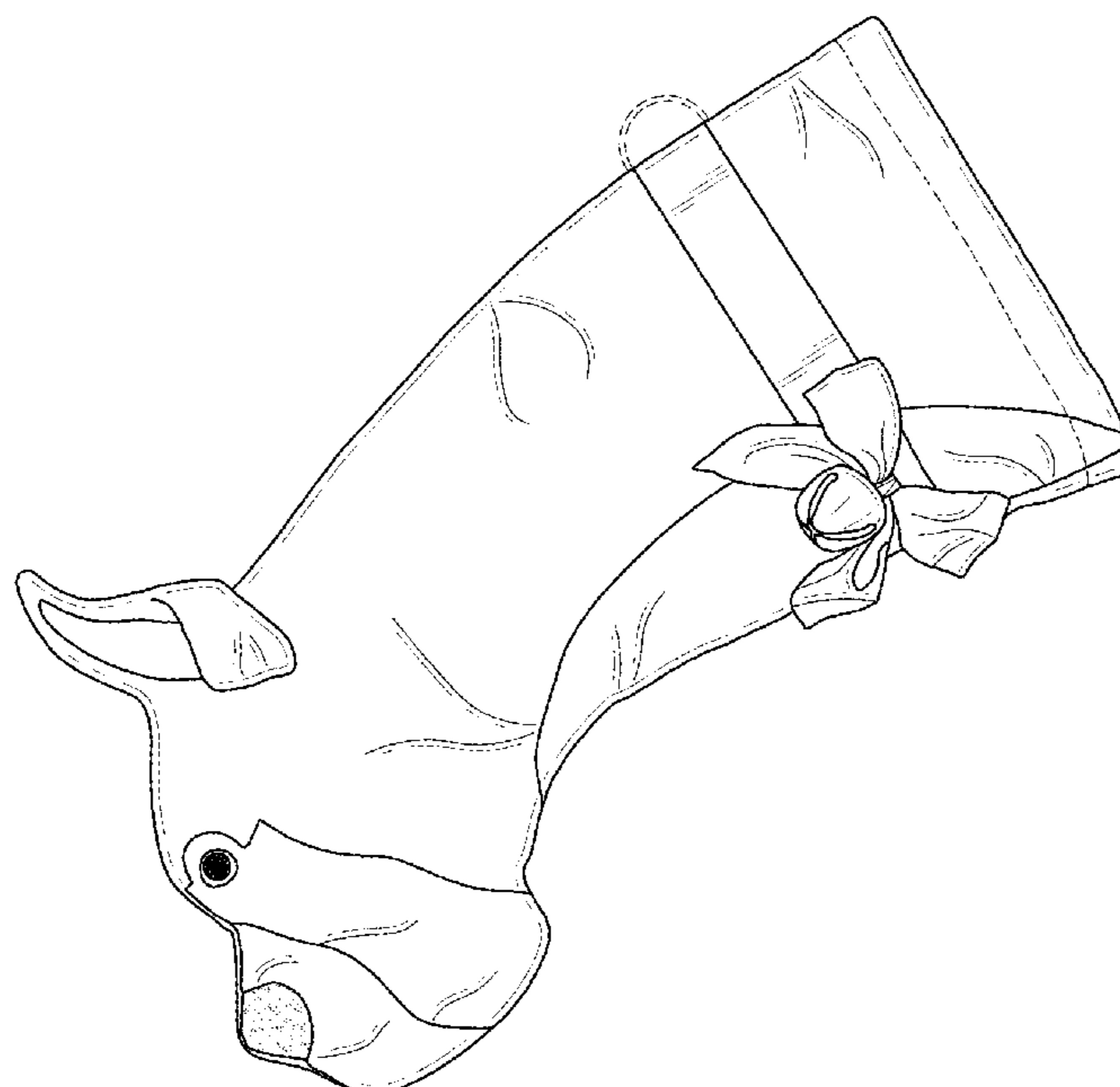
(57) **CLAIM**

The ornamental design for a boxer Christmas stocking, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a boxer Christmas stocking showing our new design; FIG. 2 is a back elevation view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a right side elevation view thereof; and, FIG. 6 is a left side elevation view thereof. The broken lines shown in the drawings represent portions of the boxer Christmas stocking that form no part of the claimed design.

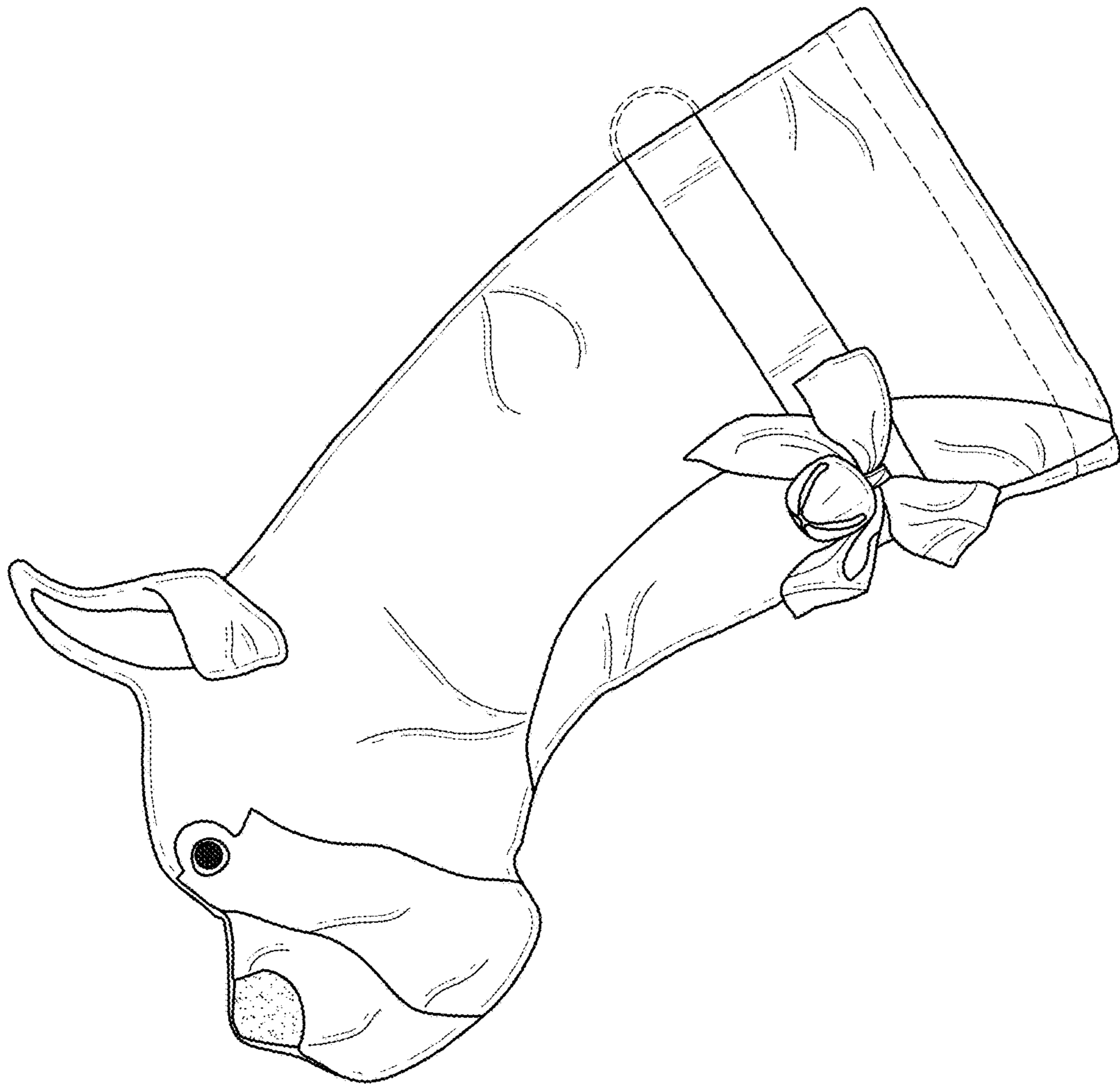

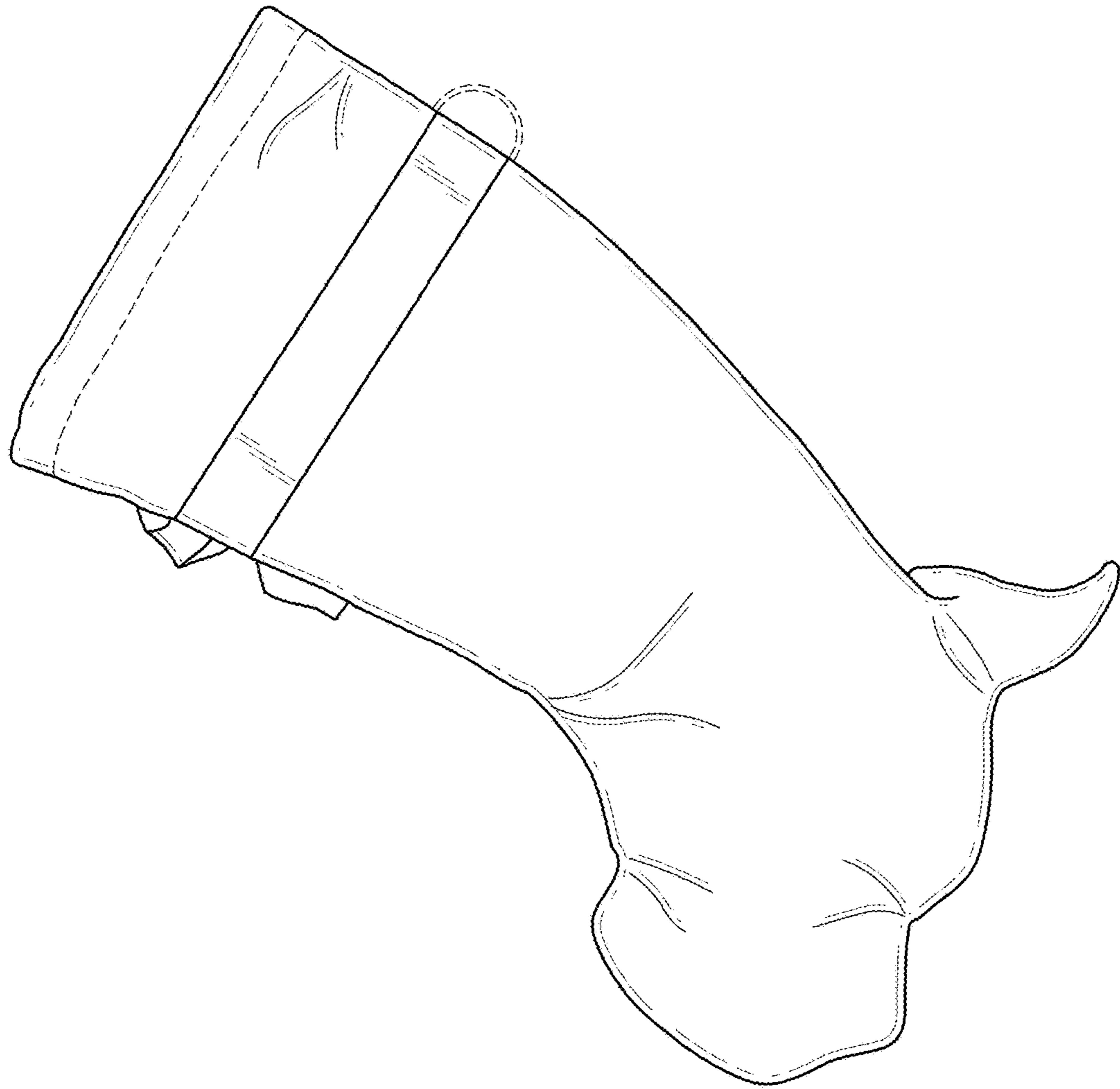

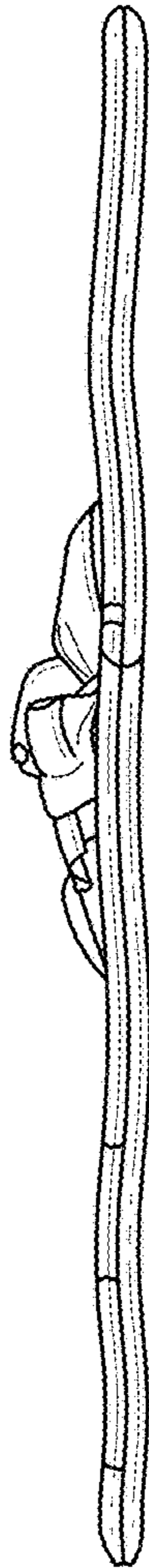

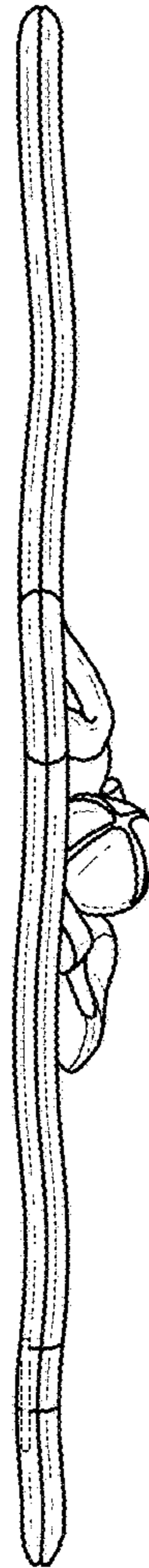

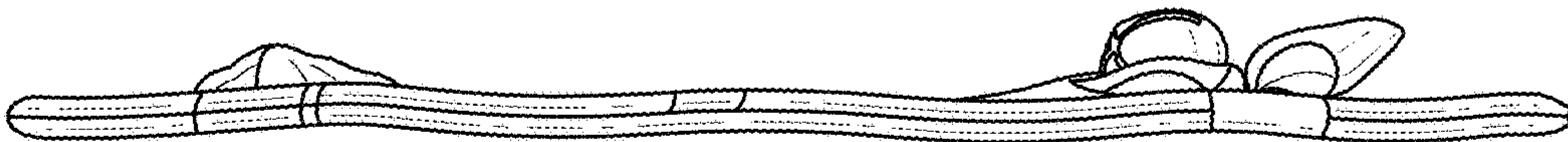
