**DESCRIPTION**

FIG. 1 is a front left perspective view of a wheel for a vehicle according to the present invention.

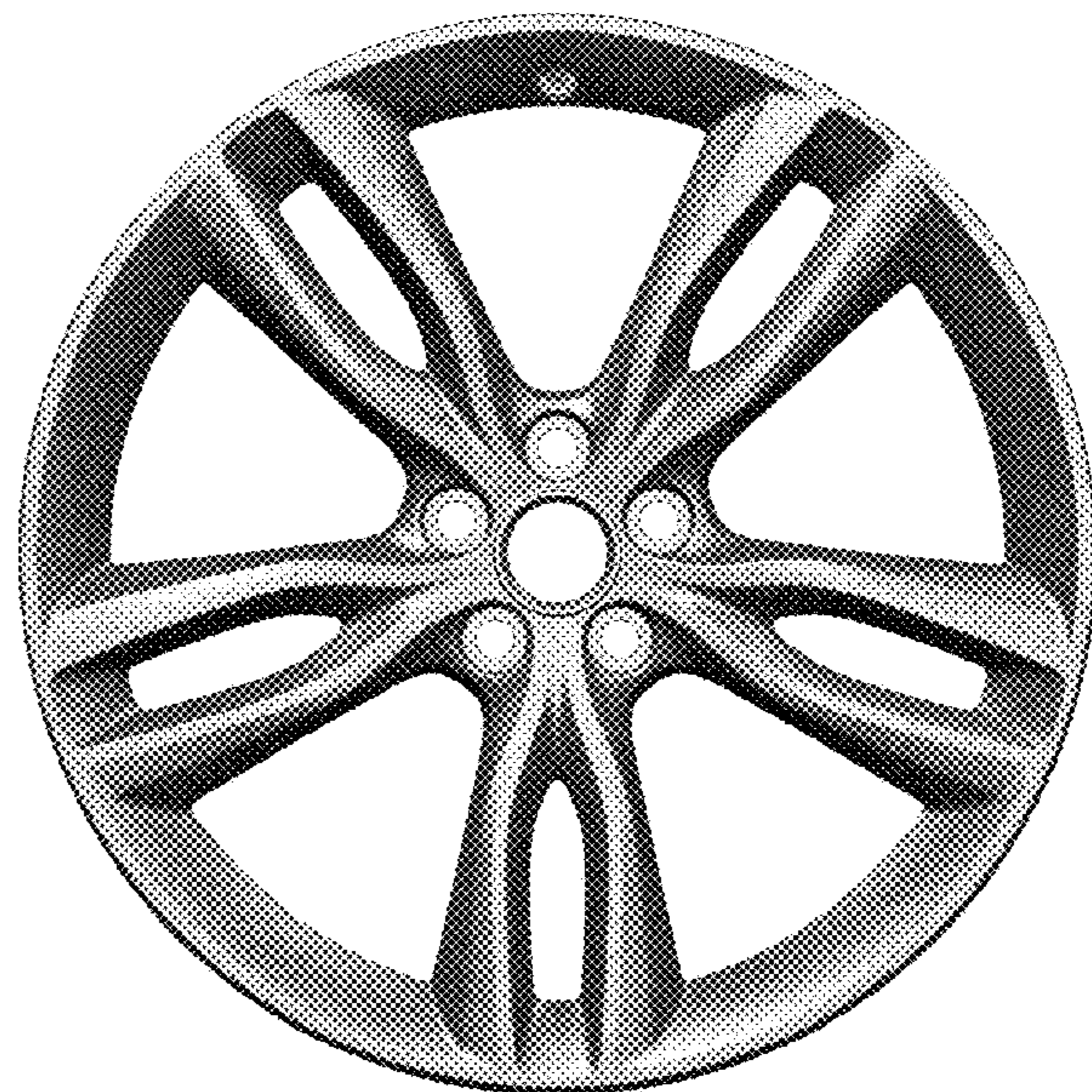

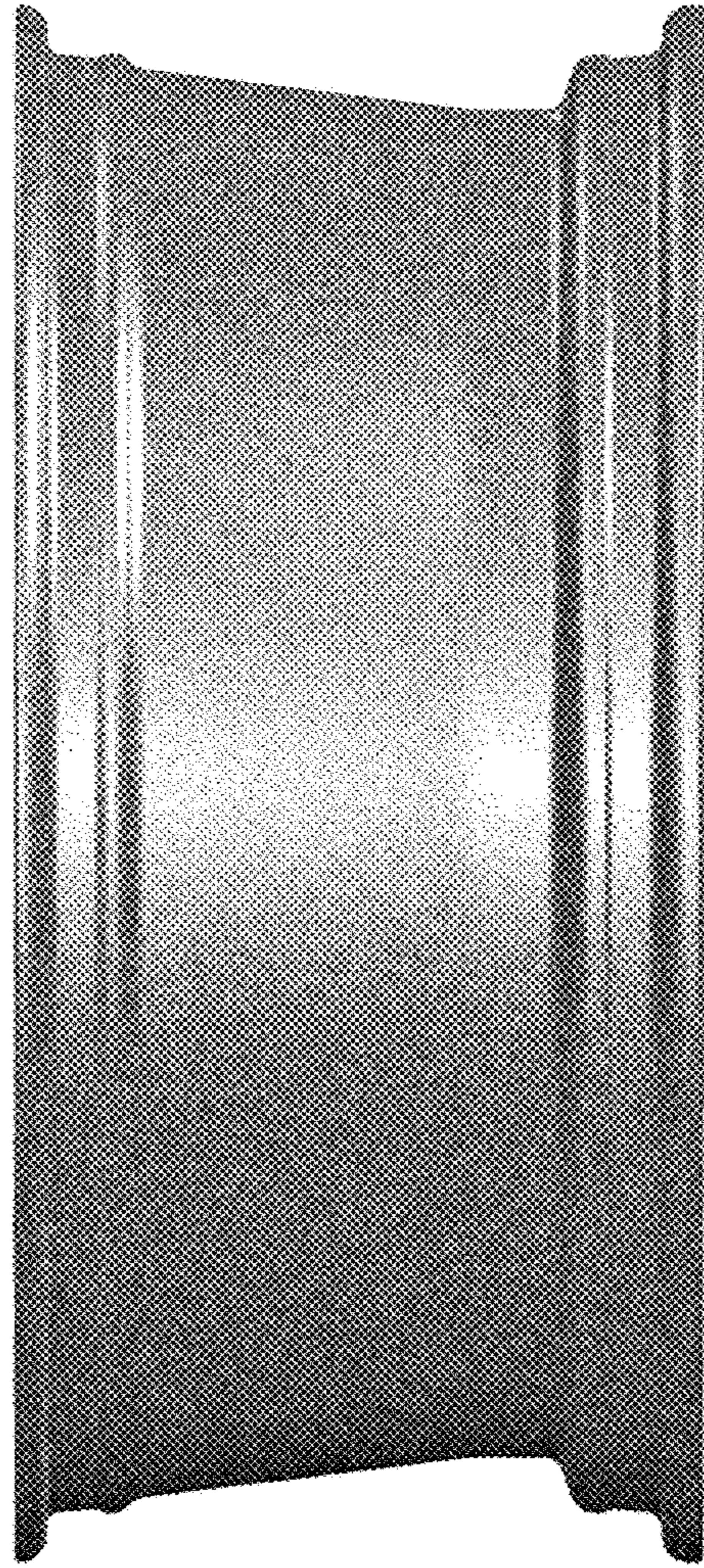
