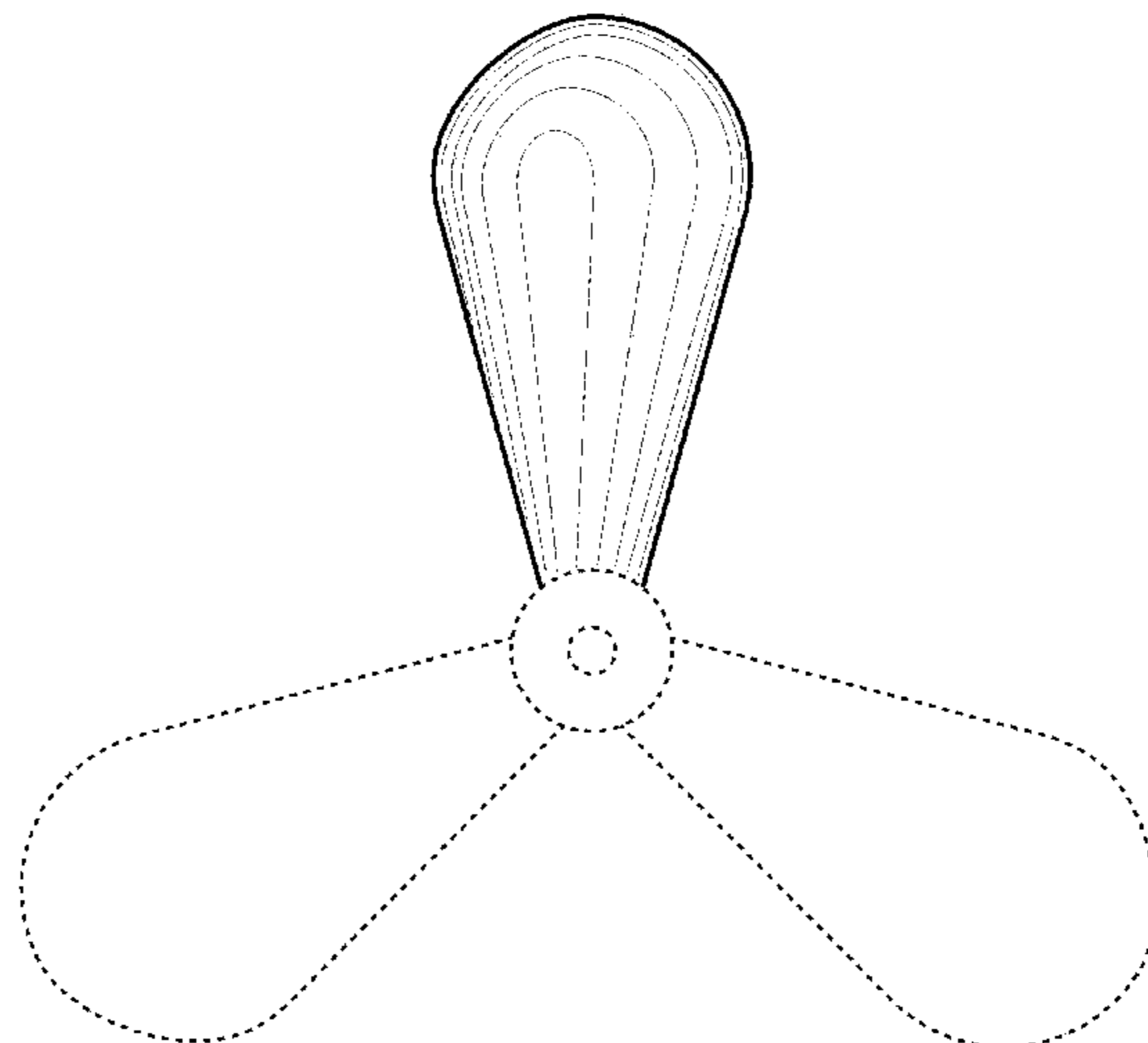

(57) **CLAIM**
 The ornamental design for a rotor blade for wind turbine, as shown and described.

DESCRIPTION
 FIG. 1 is a front elevational view of a rotor blade for wind turbine showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a sectional view taken along the line 6-6 in FIG. 1;
 FIG. 7 is a sectional view taken along the line 7-7 in FIG. 1;
 FIG. 8 is a sectional view taken along the line 8-8 in FIG. 1;
 FIG. 9 is a sectional view taken along the line 9-9 in FIG. 1;
 FIG. 10 is a sectional view taken along the line 10-10 in FIG. 1;
 FIG. 11 is a sectional view taken along the line 11-11 in FIG. 1;
 FIG. 12 is a sectional view taken along the line 12-12 in FIG. 1;
 FIG. 13 is a sectional view taken along the line 13-13 in FIG. 1;
 FIG. 14 is a sectional view taken along the line 14-14 in FIG. 1; and,
 FIG. 15 is a front elevational view showing the rotor blade for wind turbine shown in an environment of use, installed in a rotor for a wind turbine.

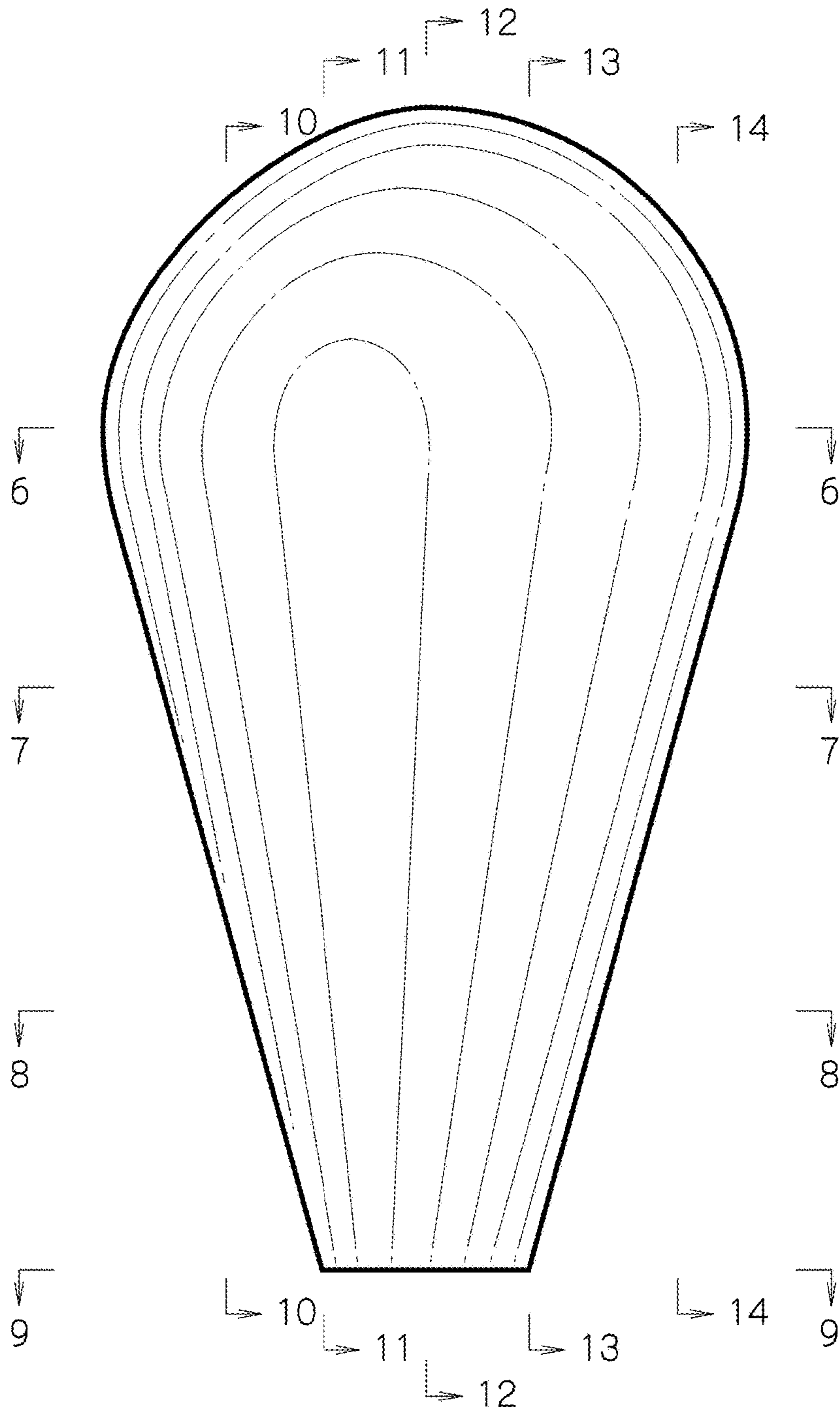

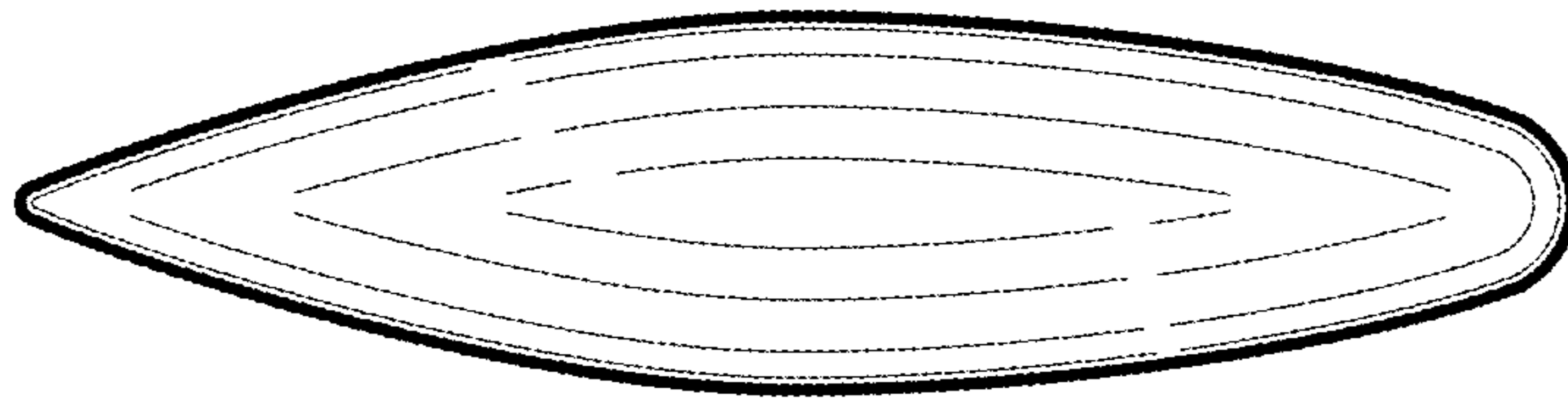

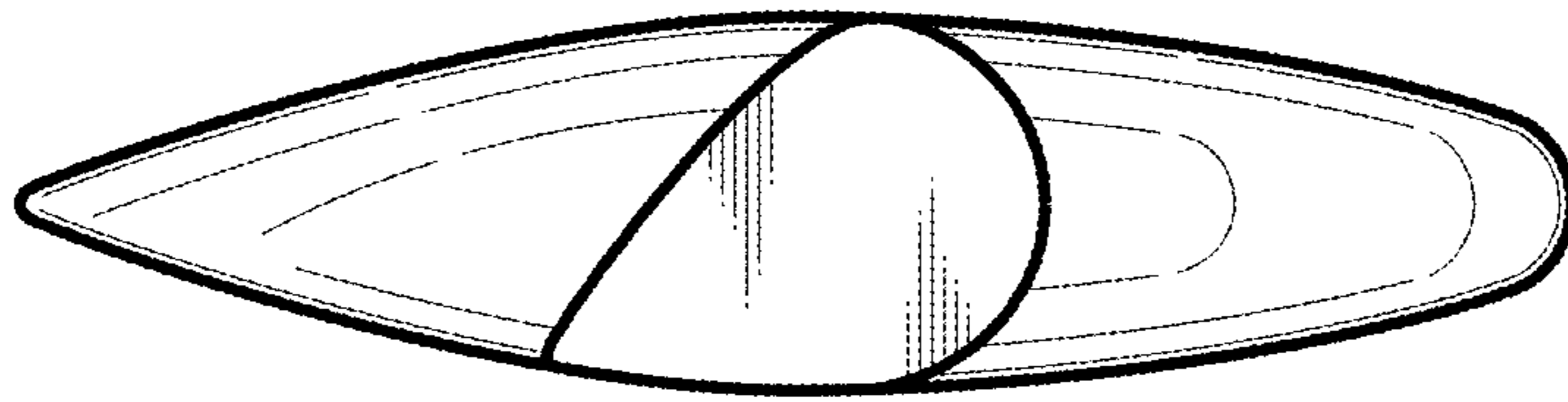

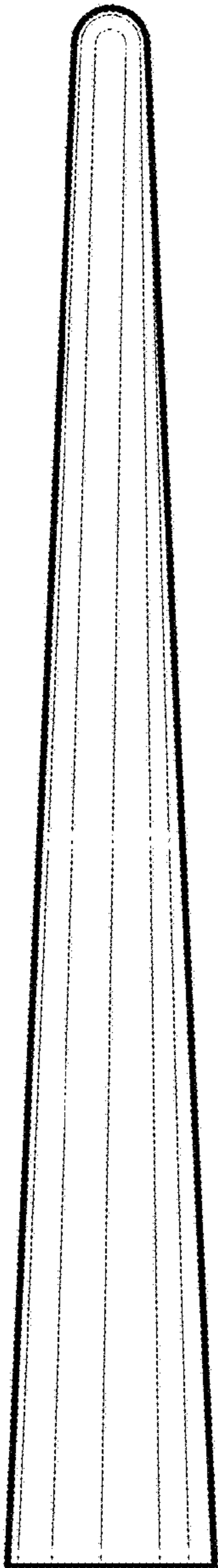

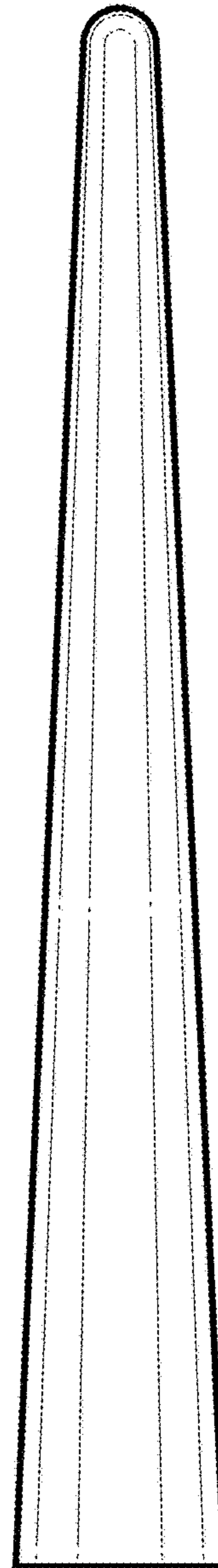

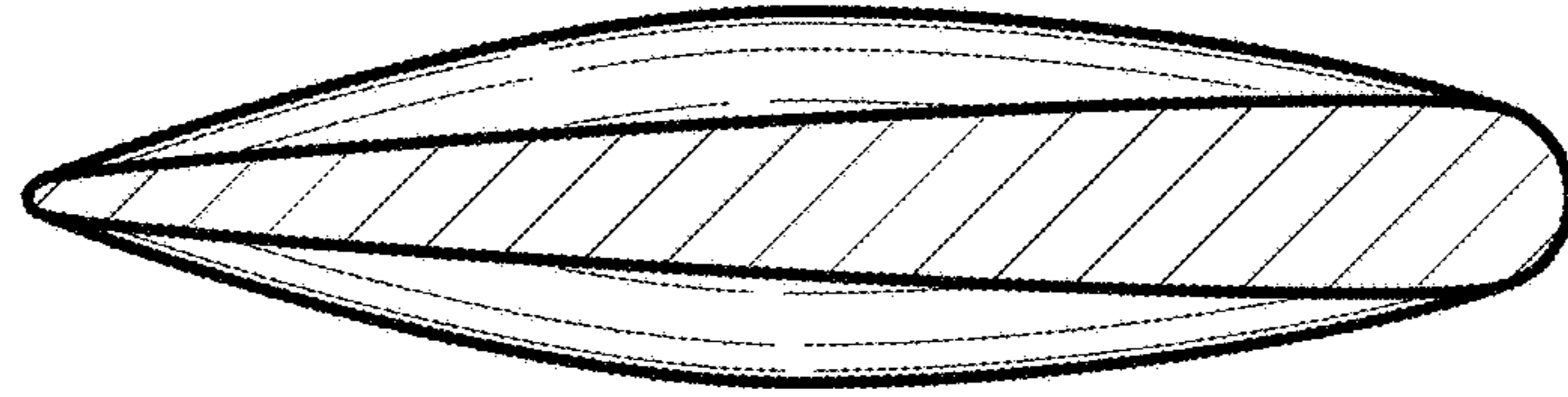

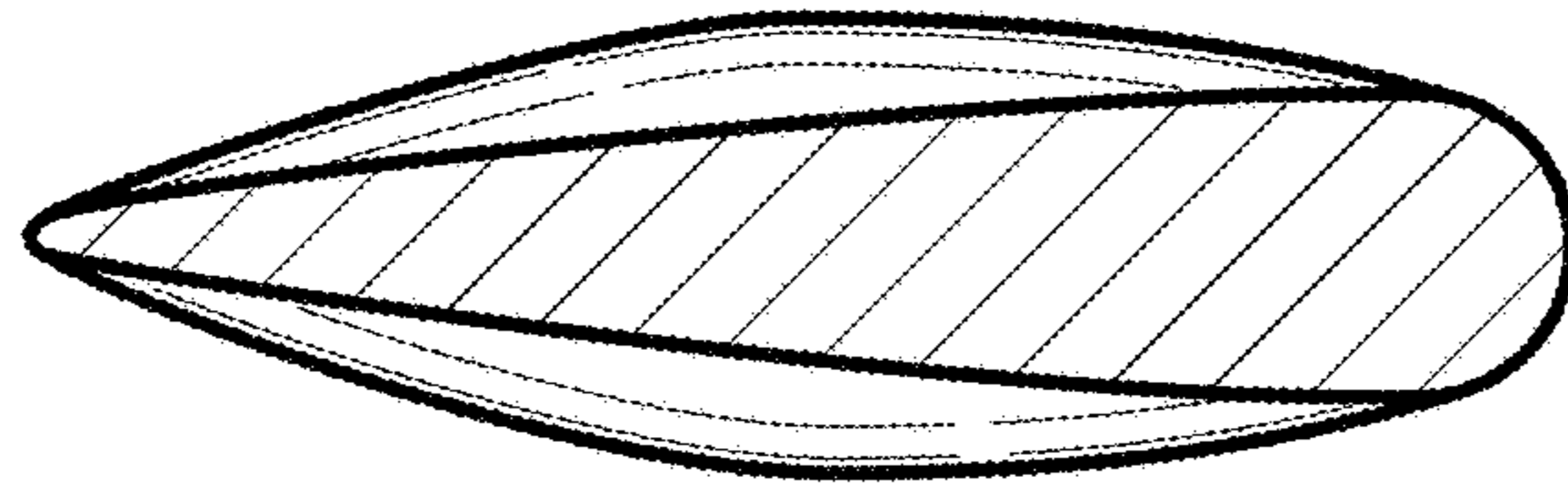

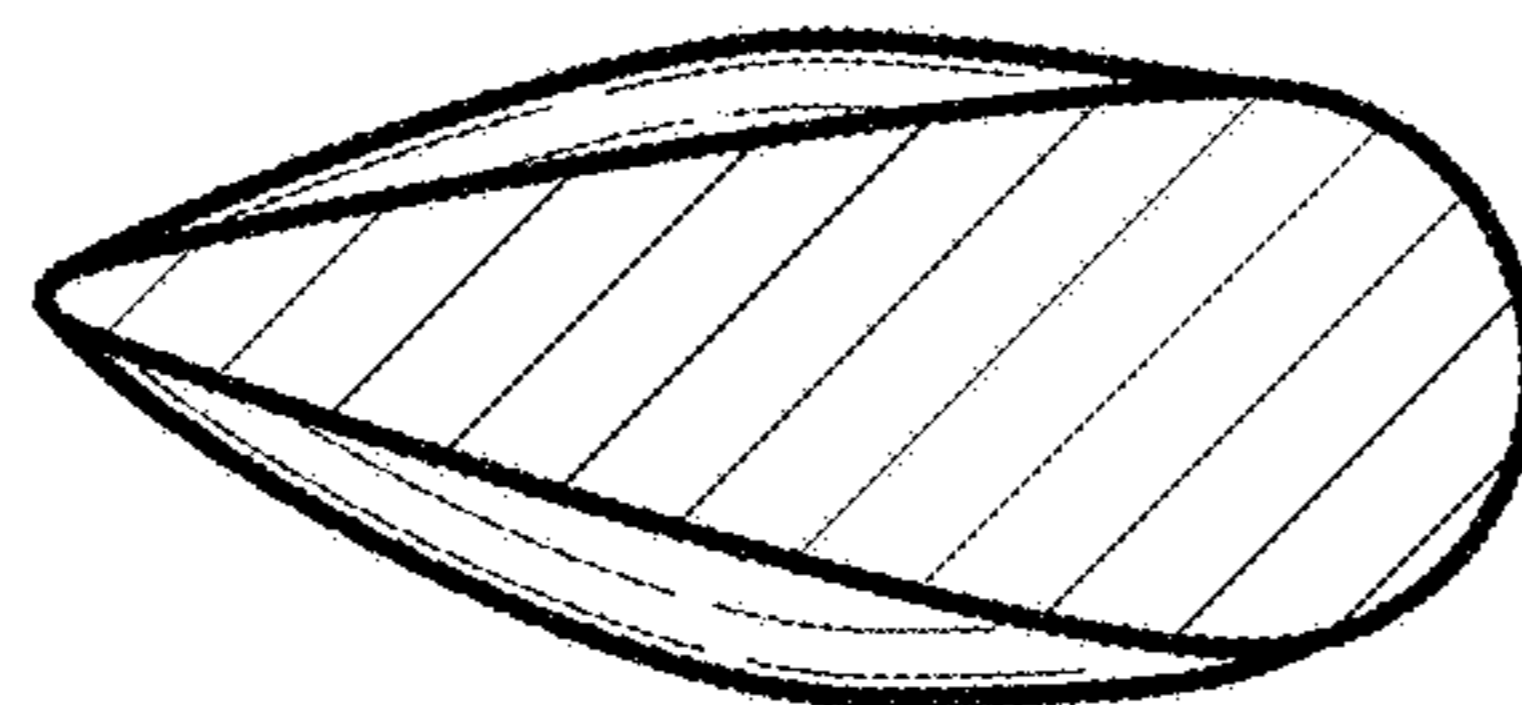

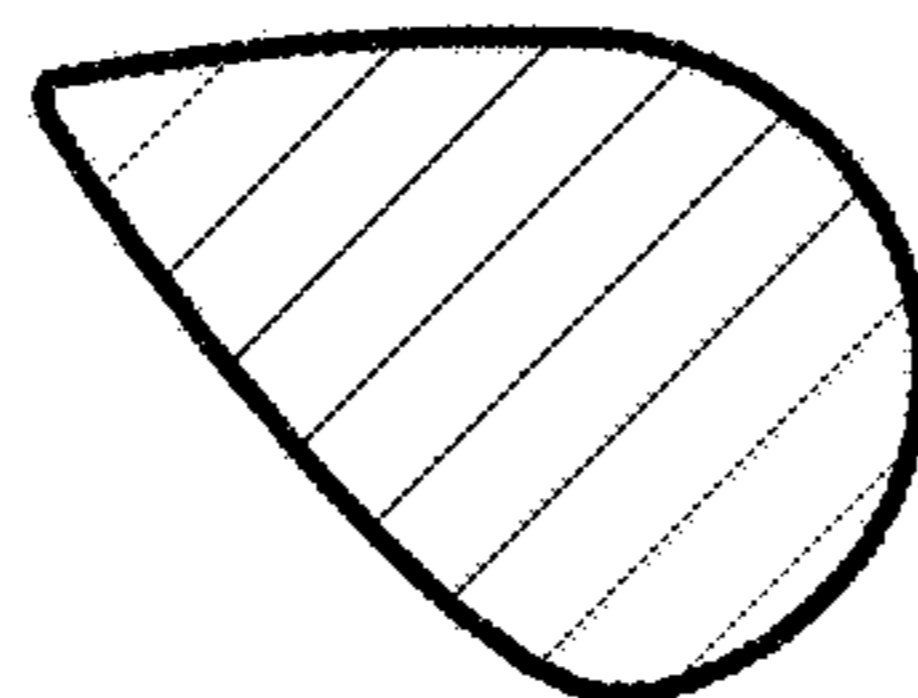

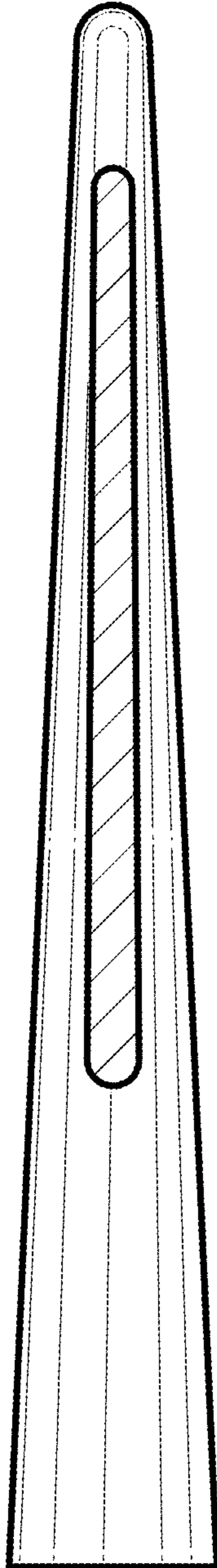

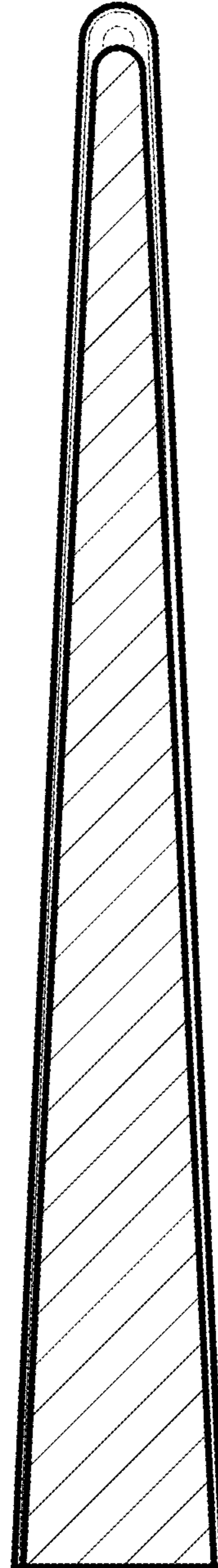

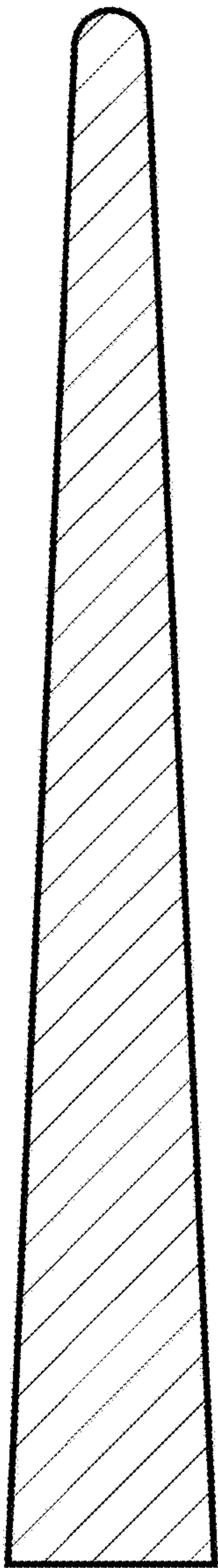

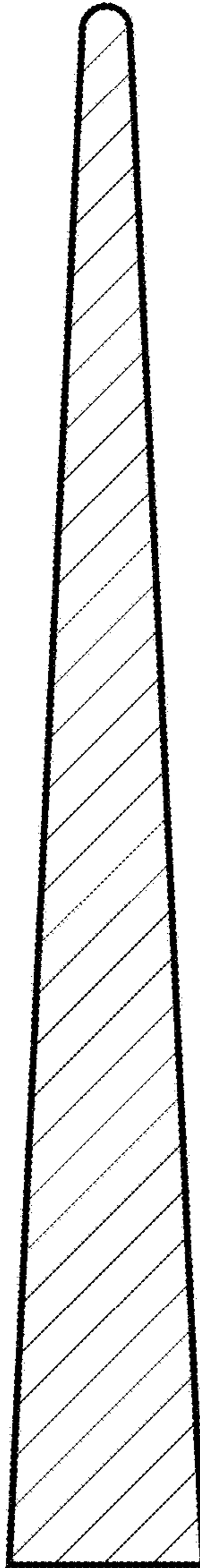
