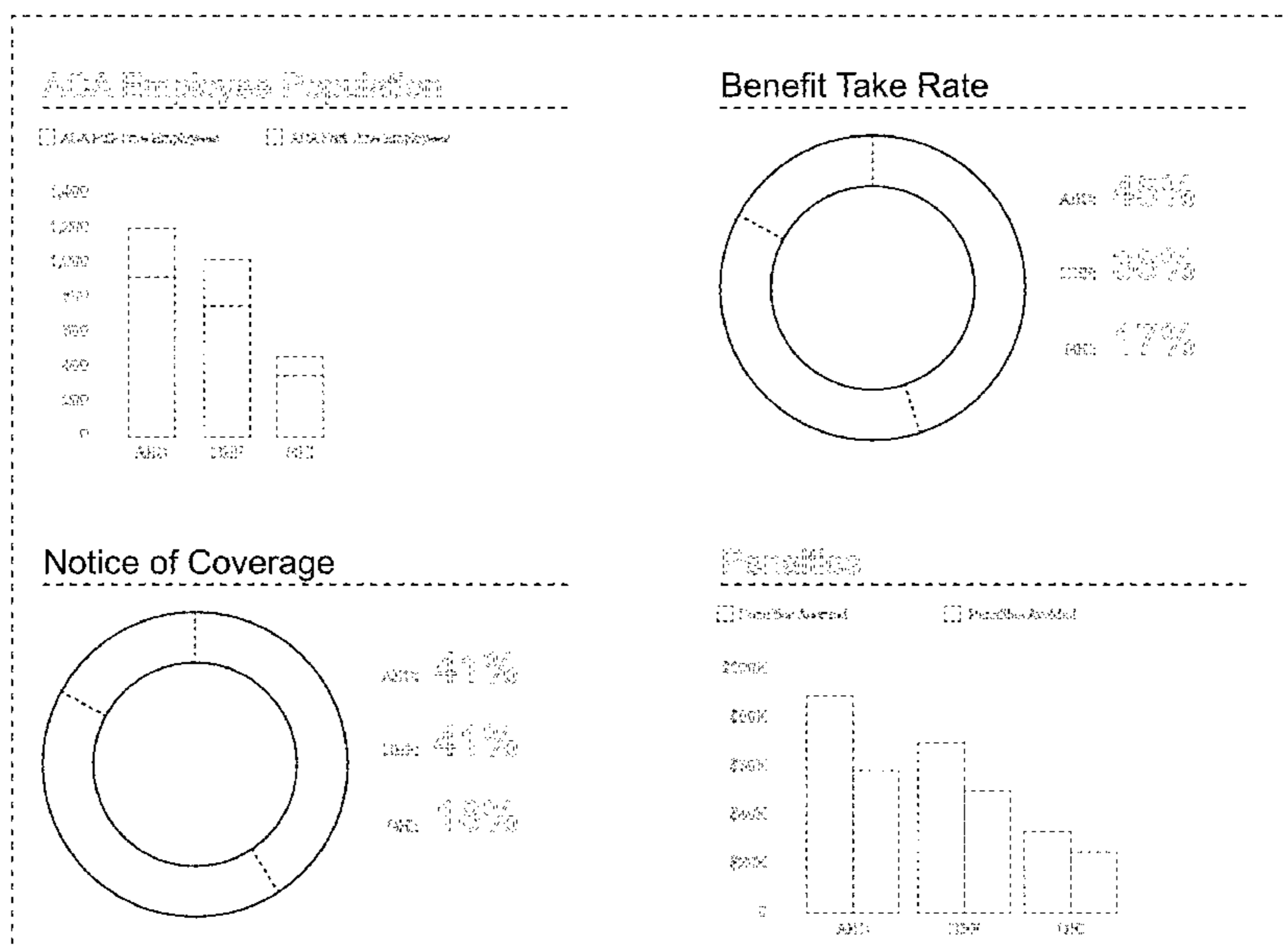
(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of the display screen or portion thereof with graphical user interface; FIG. 2 is a front view of a second embodiment of the display screen or portion thereof with graphical user interface; and, FIG. 3 is a front view of a third embodiment of the display screen or portion thereof with graphical user interface. The outermost broken line perimeter showing the display screen and the broken lines within showing portions of the graphical user interface, including the broken line text, are provided for the purpose of illustrating portions of the article and forms no part of the claimed design. The dashed broken lines showing the outlined text is provided for the purpose of illustrating portions of the graphical user interface that forms no part of the claimed design.

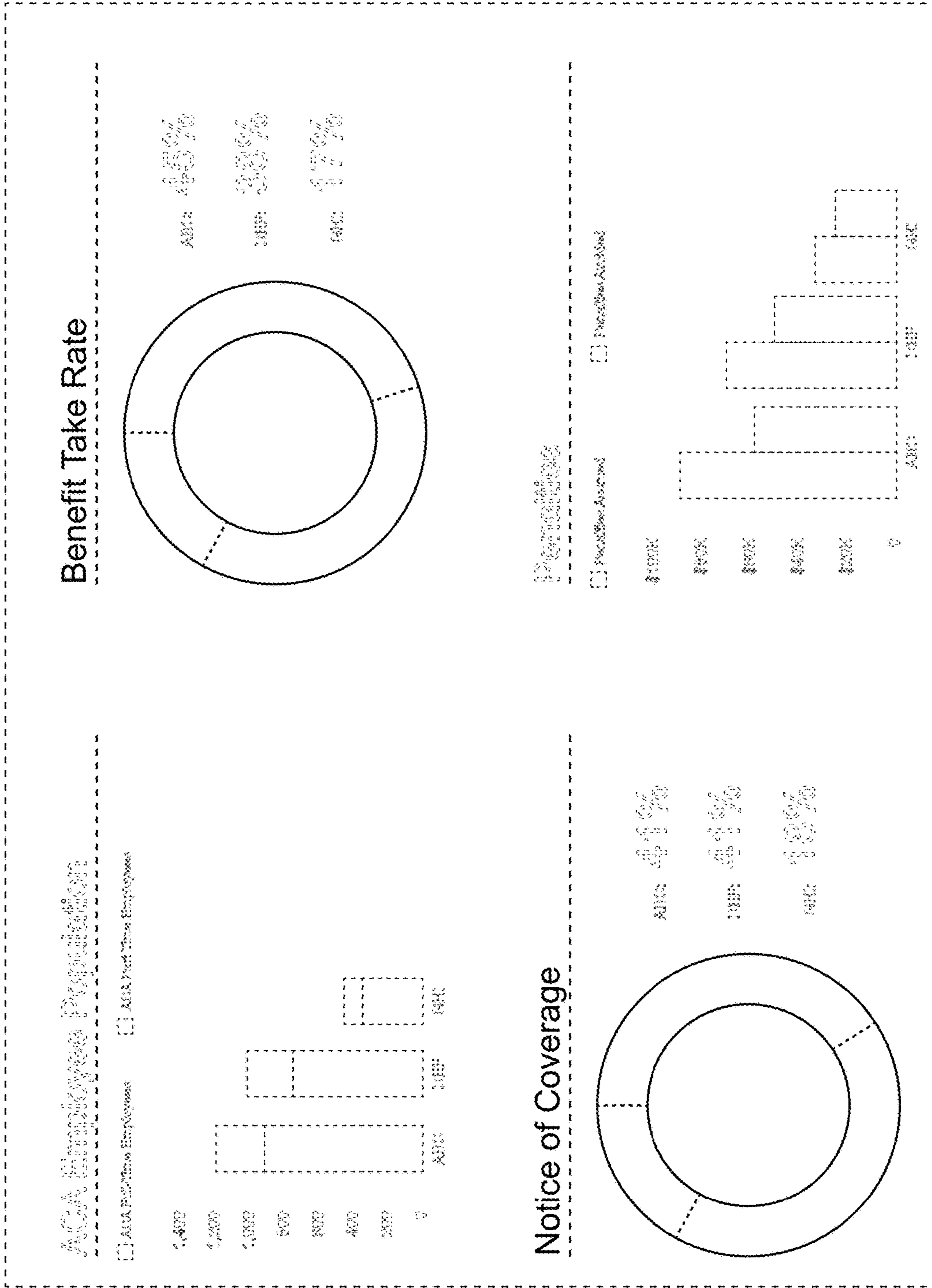

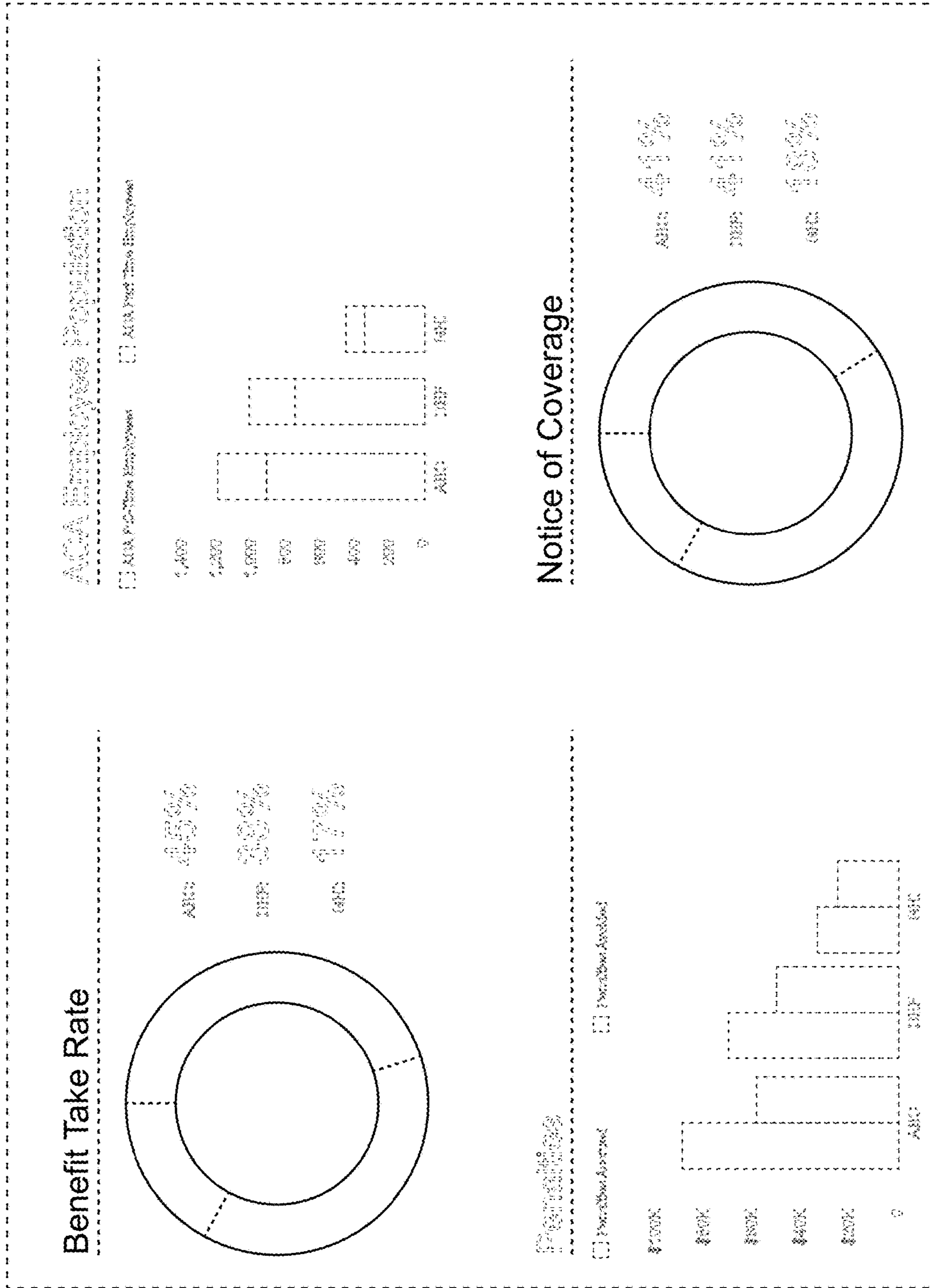

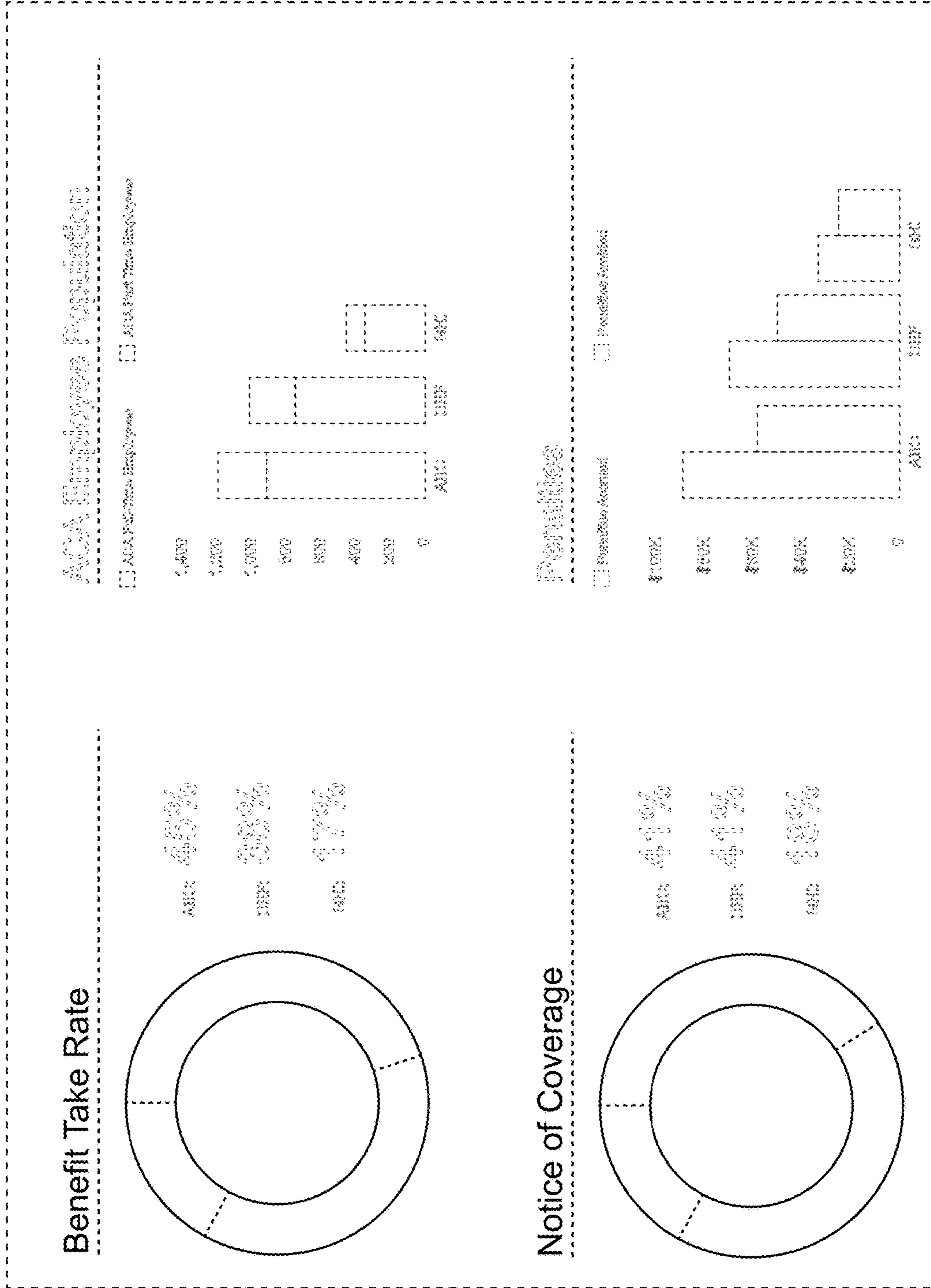
