(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1.1 is a front view of a display screen or portion thereof with graphical user interface showing the new design; and FIG. 1.2 is an enlarged partial view of the display screen or portion thereof with graphical user interface of FIG. 1.1.

The evenly-spaced broken lines in FIG. 1.1 illustrate the display screen or portion thereof with graphical user interface and form no part of the claimed design. The unevenly-sized broken lines in FIGS. 1.1 and 1.2 illustrate an enlargement and form no part of the claimed design. The dotted lines showing graphic features within the graphical user interface form no part of the claimed design.

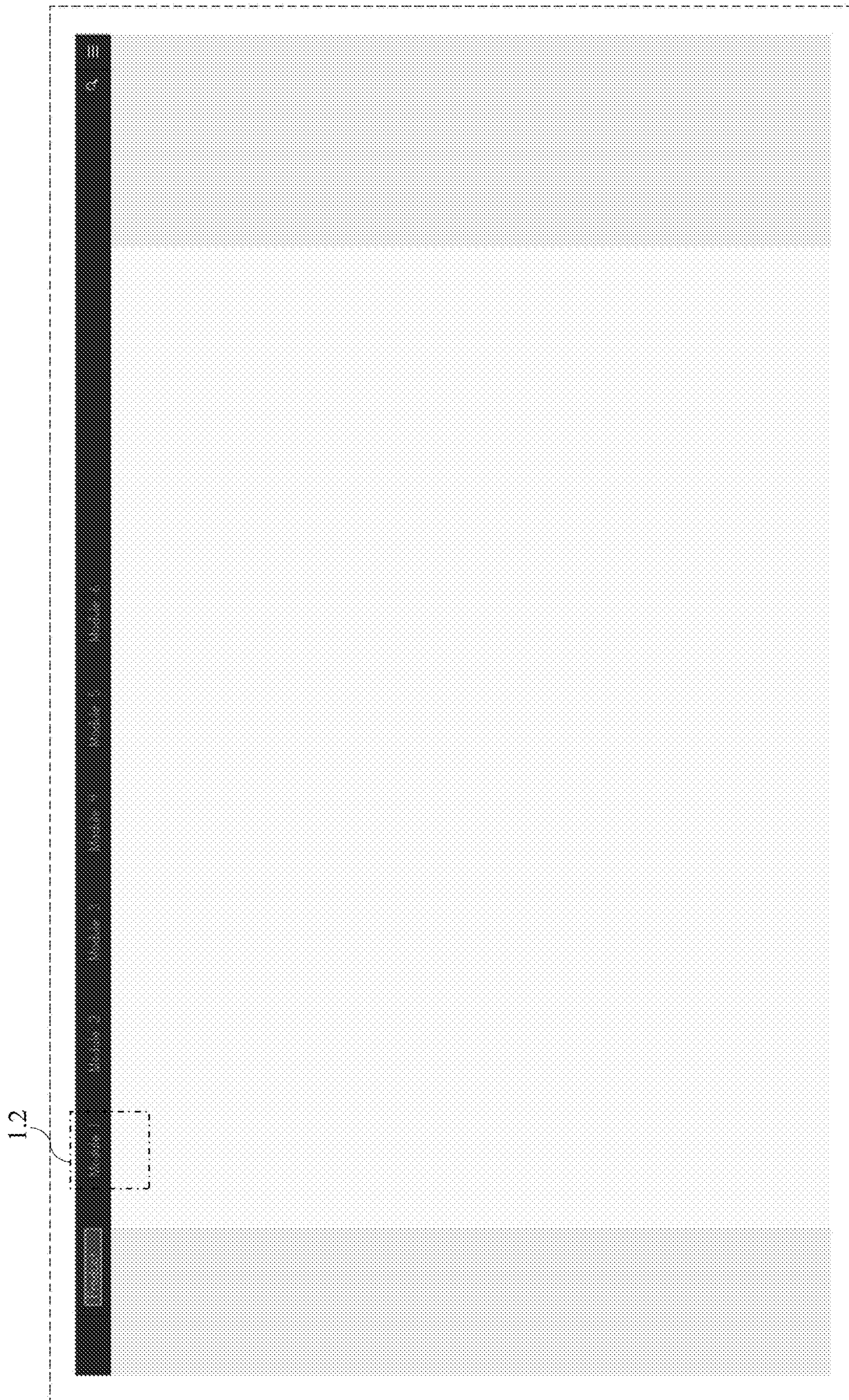

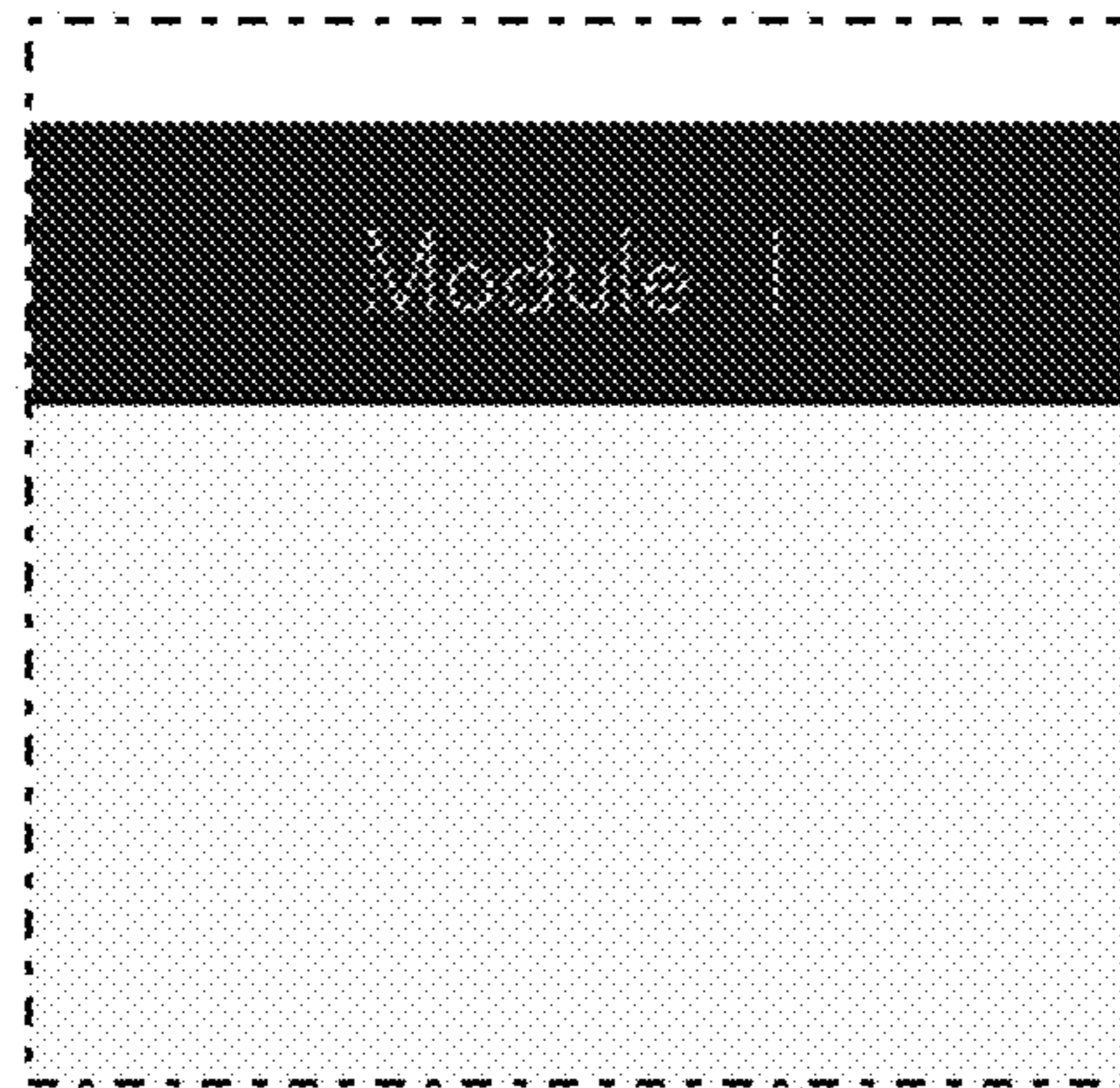
