(57) **CLAIM**

The ornamental design for a display screen or a portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a first image of a first embodiment of a display screen or a portion thereof with animated graphical user interface;

FIG. 2 is a second image of a display screen or a portion thereof with animated graphical user interface;

FIG. 3 is a third image of a display screen or a portion thereof with animated graphical user interface;

FIG. 4 is a first image of a second embodiment of a display screen or a portion thereof with animated graphical user interface;

FIG. 5 is a second image of a display screen or a portion thereof with animated graphical user interface;

FIG. 6 is a third image of a display screen or a portion thereof with animated graphical user interface;

FIG. 7 is a first image of a third embodiment of a display screen or a portion thereof with animated graphical user interface;

FIG. 8 is a second image of a display screen or a portion thereof with animated graphical user interface; and,

FIG. 9 is a third image of a display screen or a portion thereof with animated graphical user interface.

The broken lines showing a display screen or portion thereof and other elements in the figures form no part of the claimed design.

In the first embodiment, the appearance of the animated graphical user interface sequentially transitions from FIG. 1 to FIG. 3. In the second embodiment, the appearance of the animated graphical user interface sequentially transitions from FIG. 4 to FIG. 6. In the third embodiment, the appearance of the animated graphical user interface sequentially transitions from FIG. 7 to FIG. 9. The process or period in which one image transitions to another image forms no part of the claimed design.

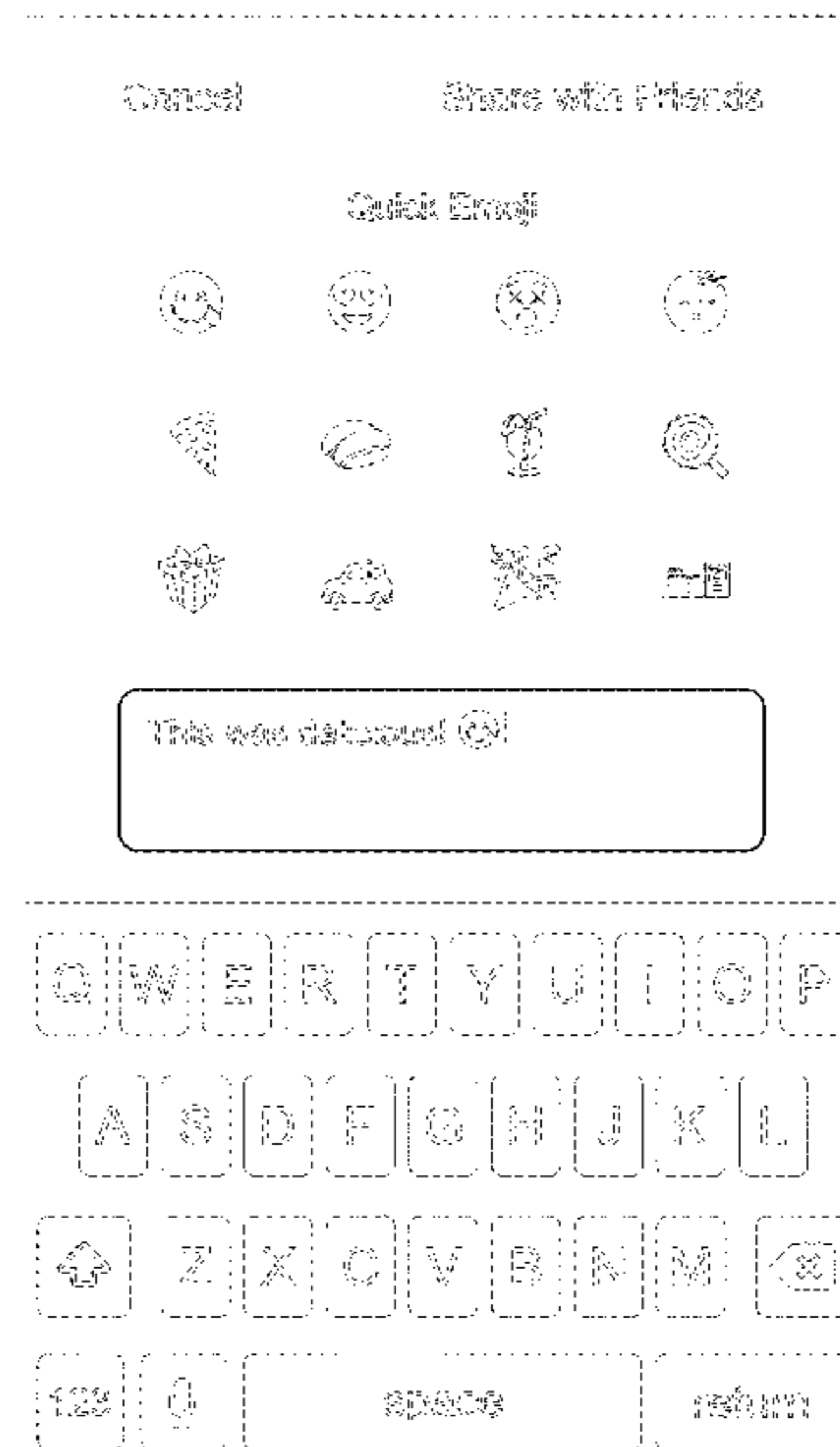
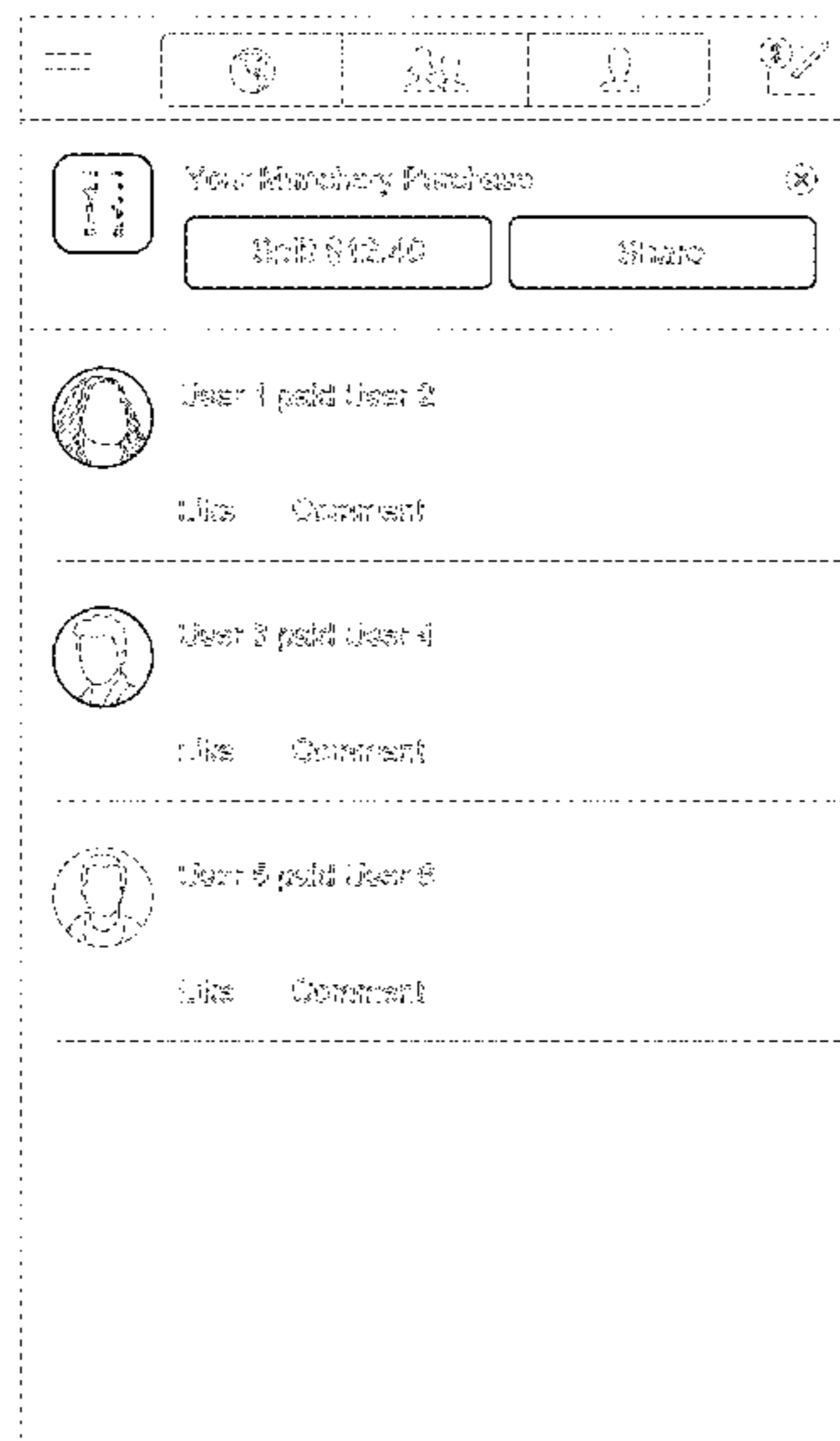

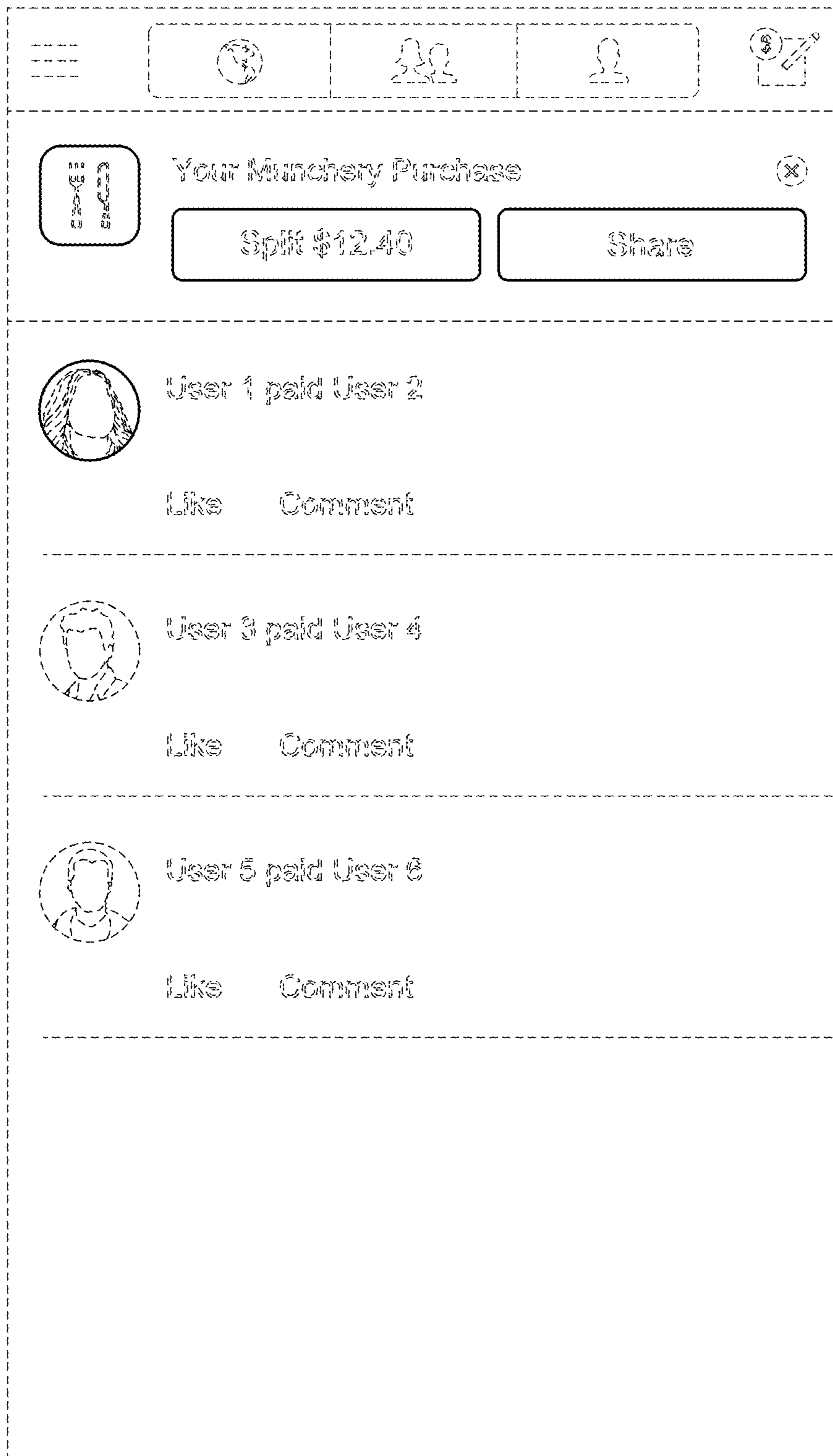

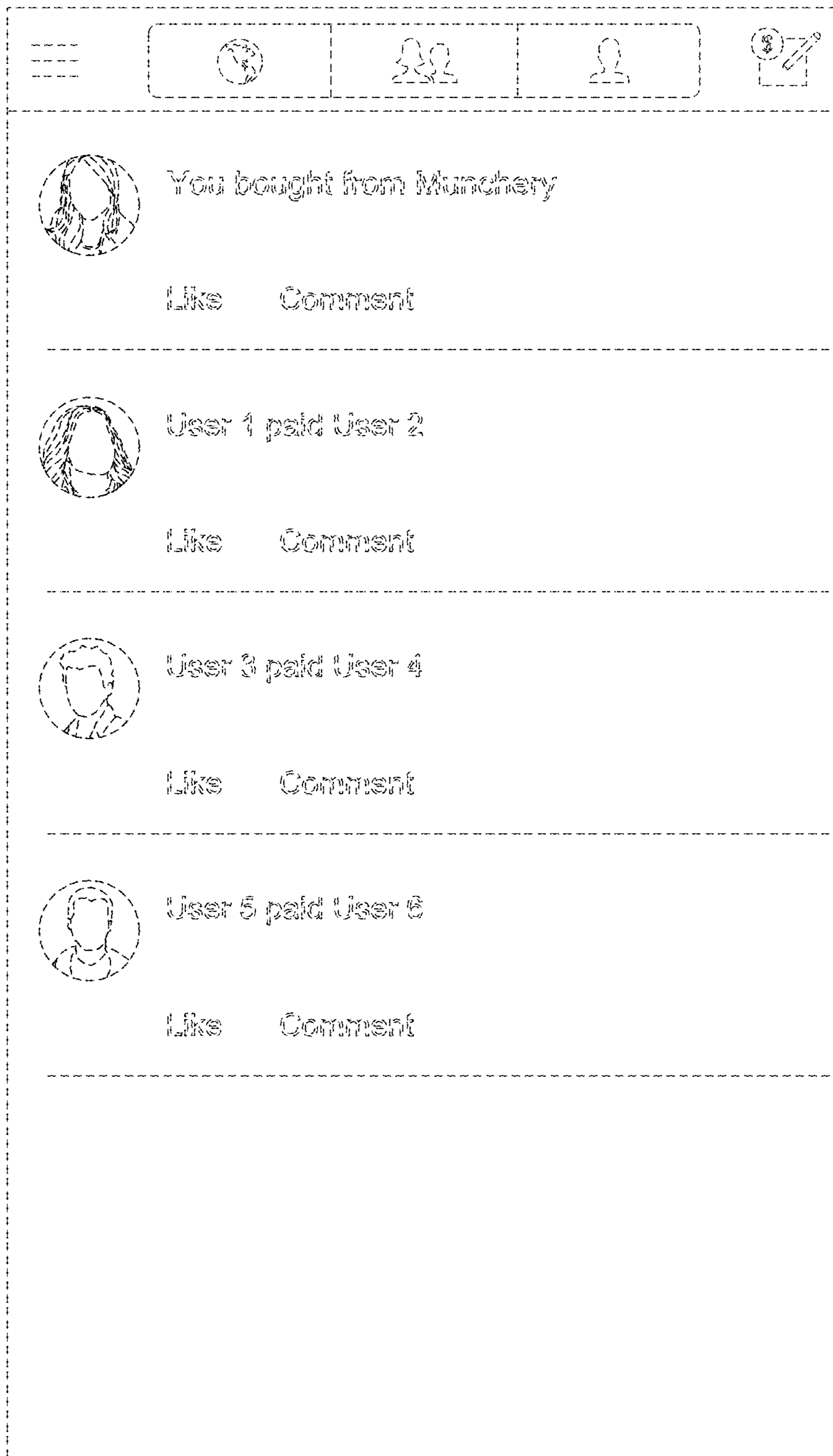

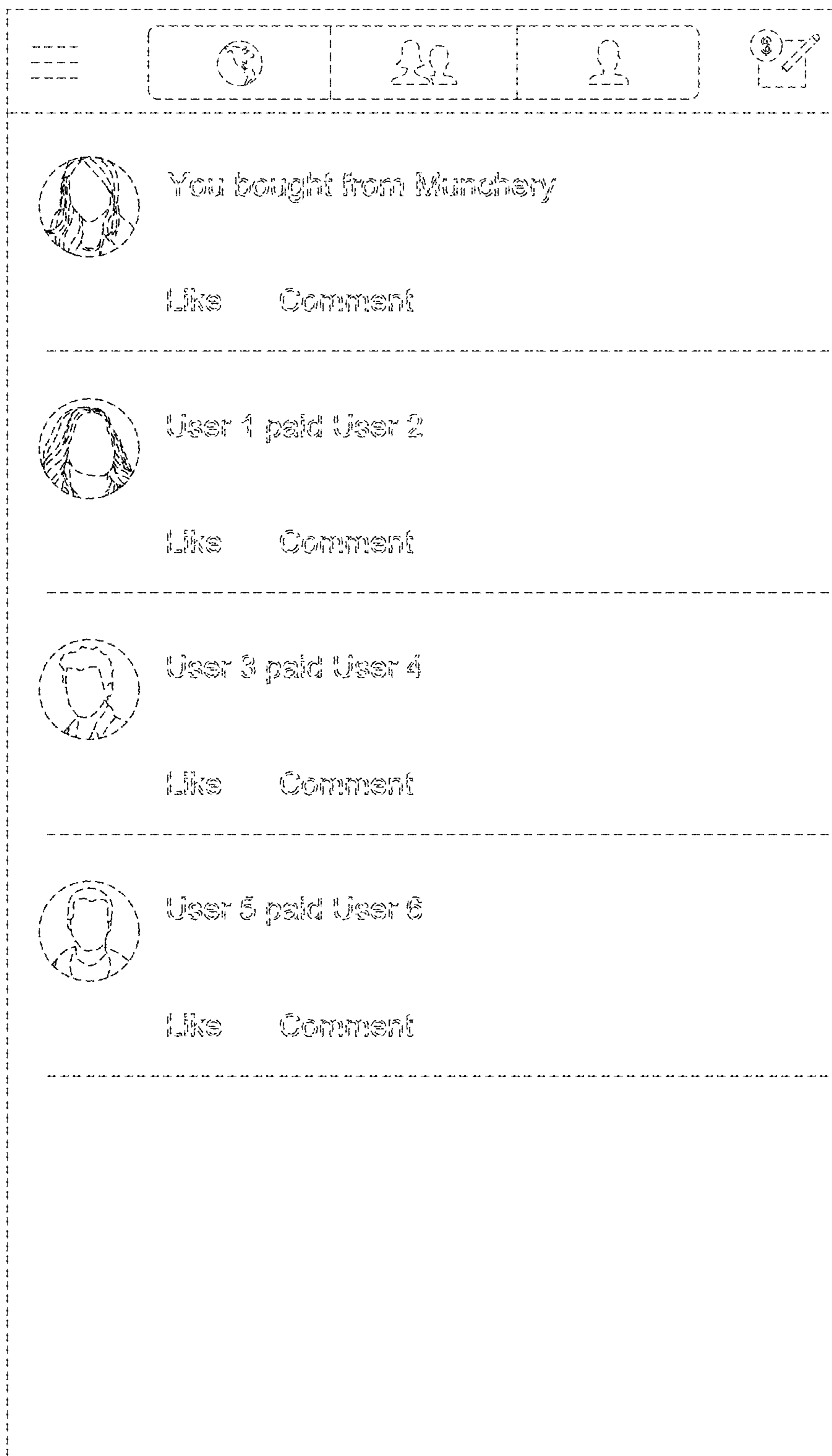
