FIG. 9 is a front view of a ninth image thereof;

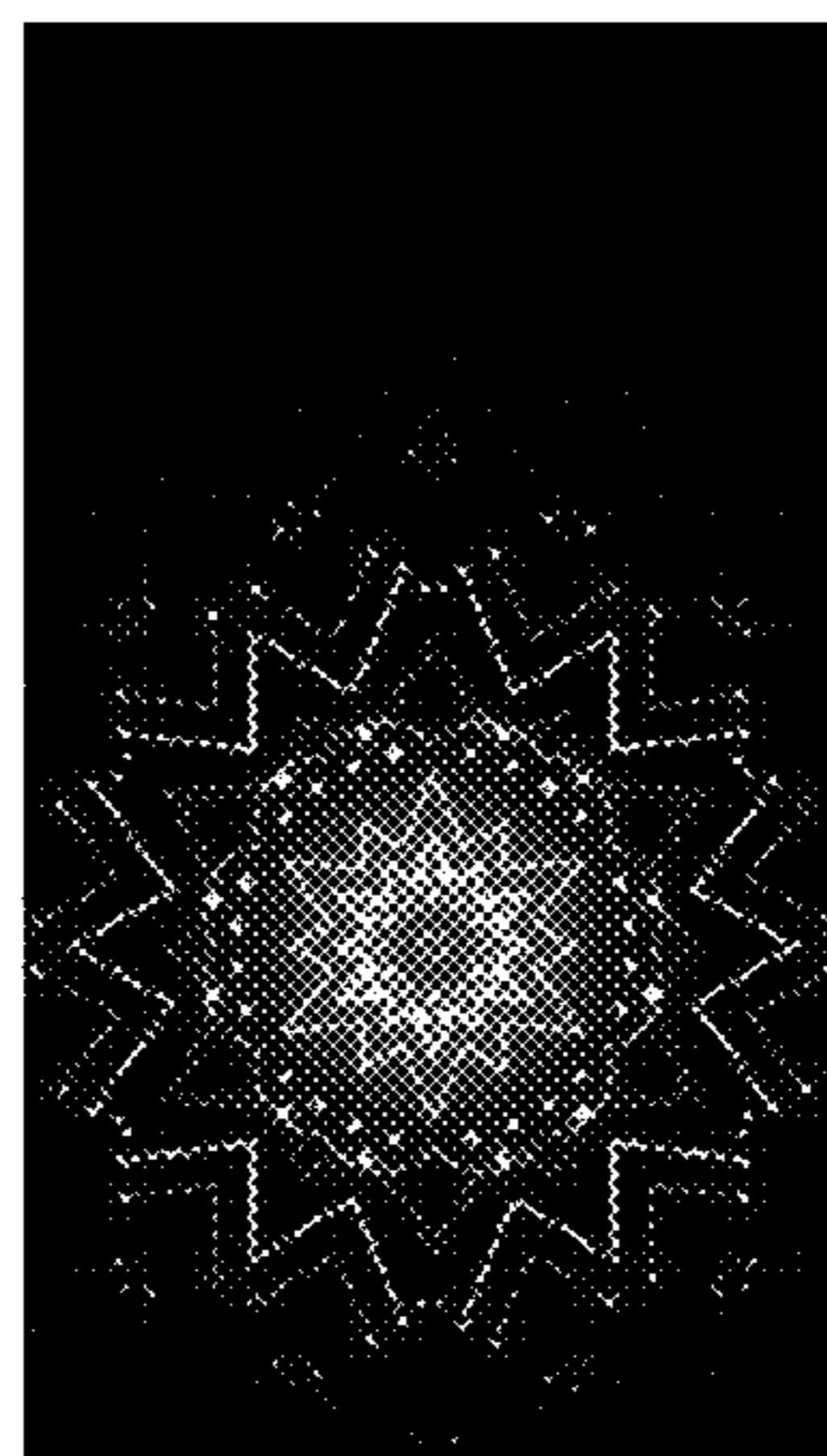
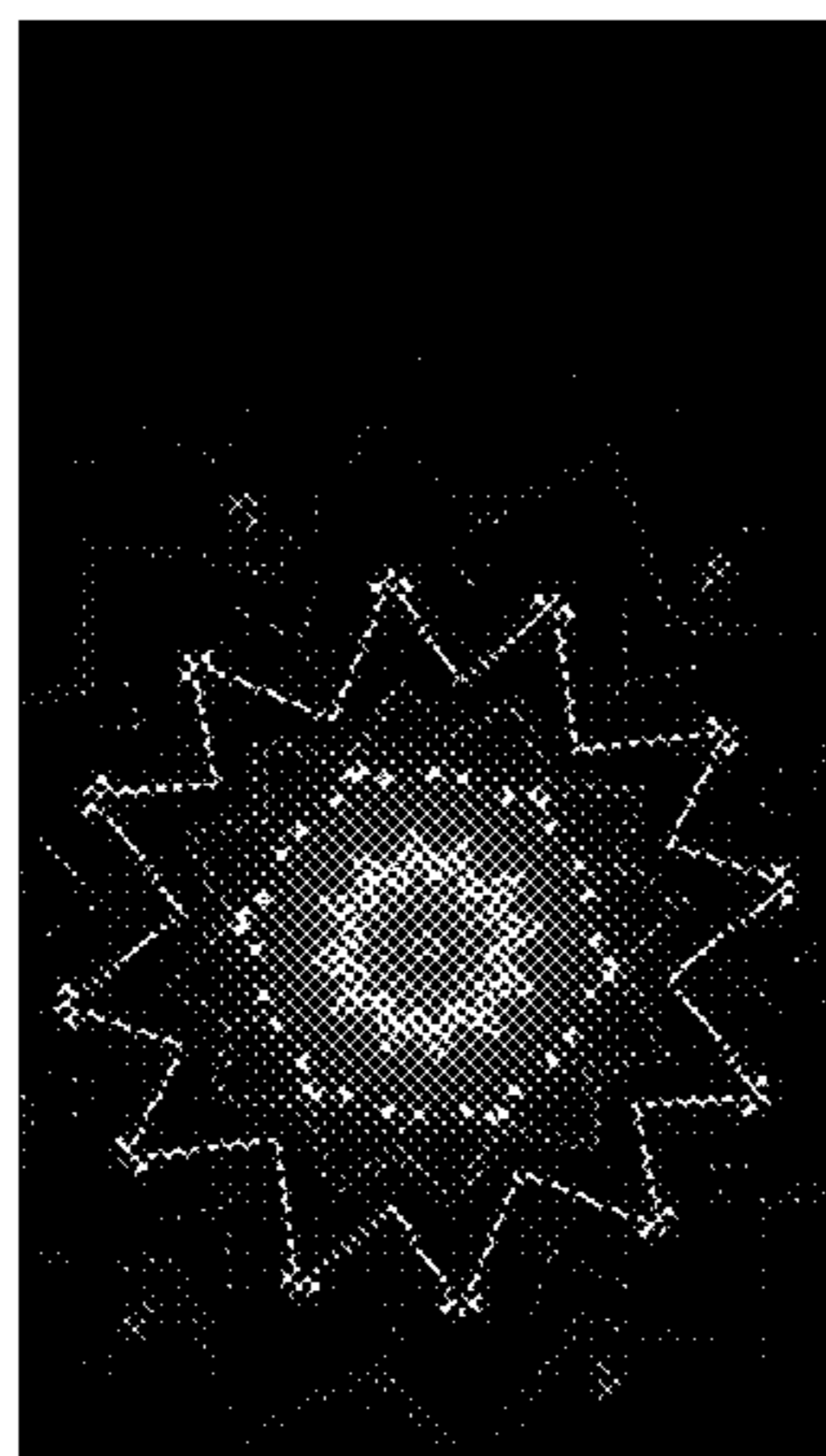
FIG. 10 is a front view of a tenth image thereof;

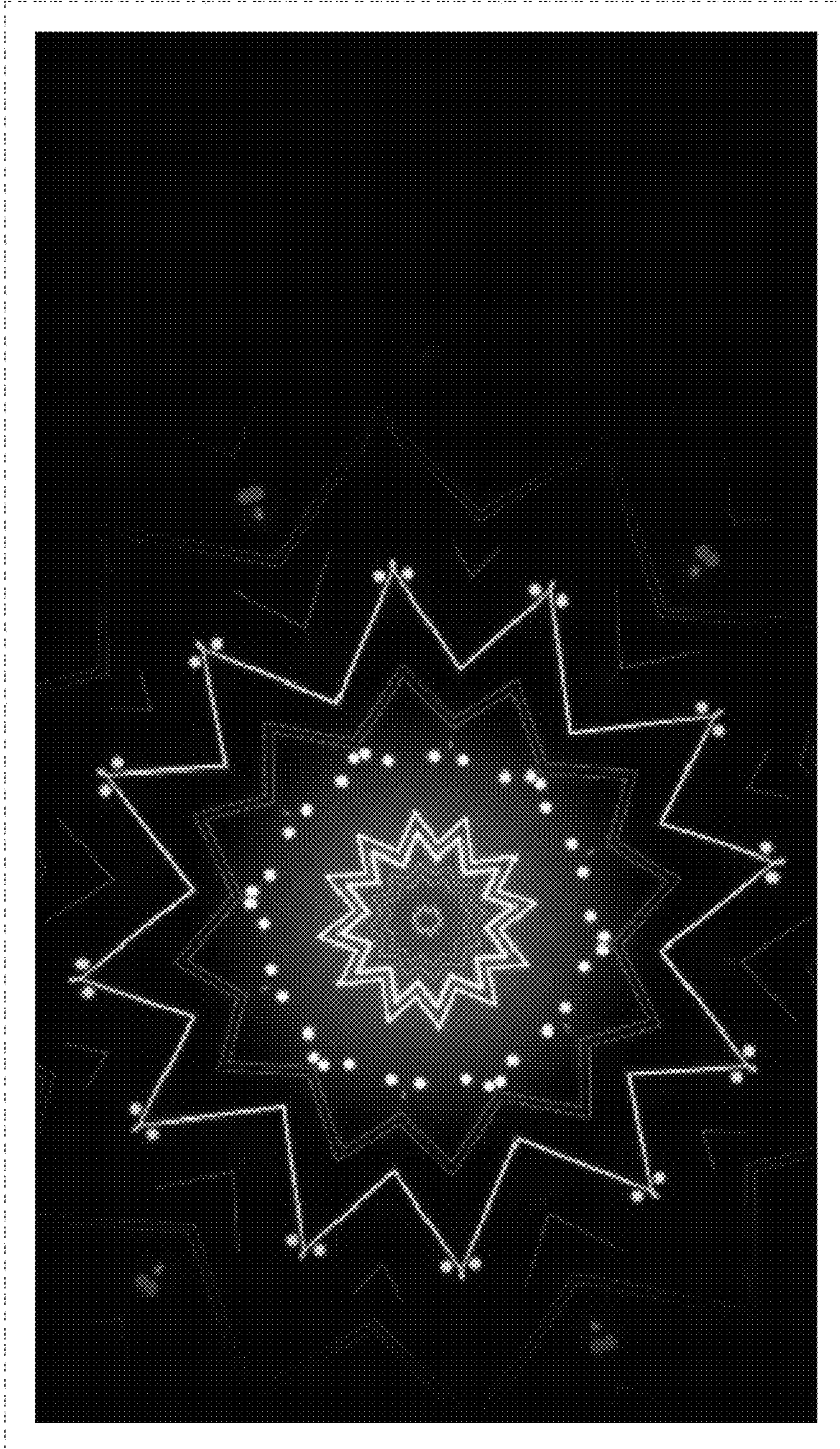

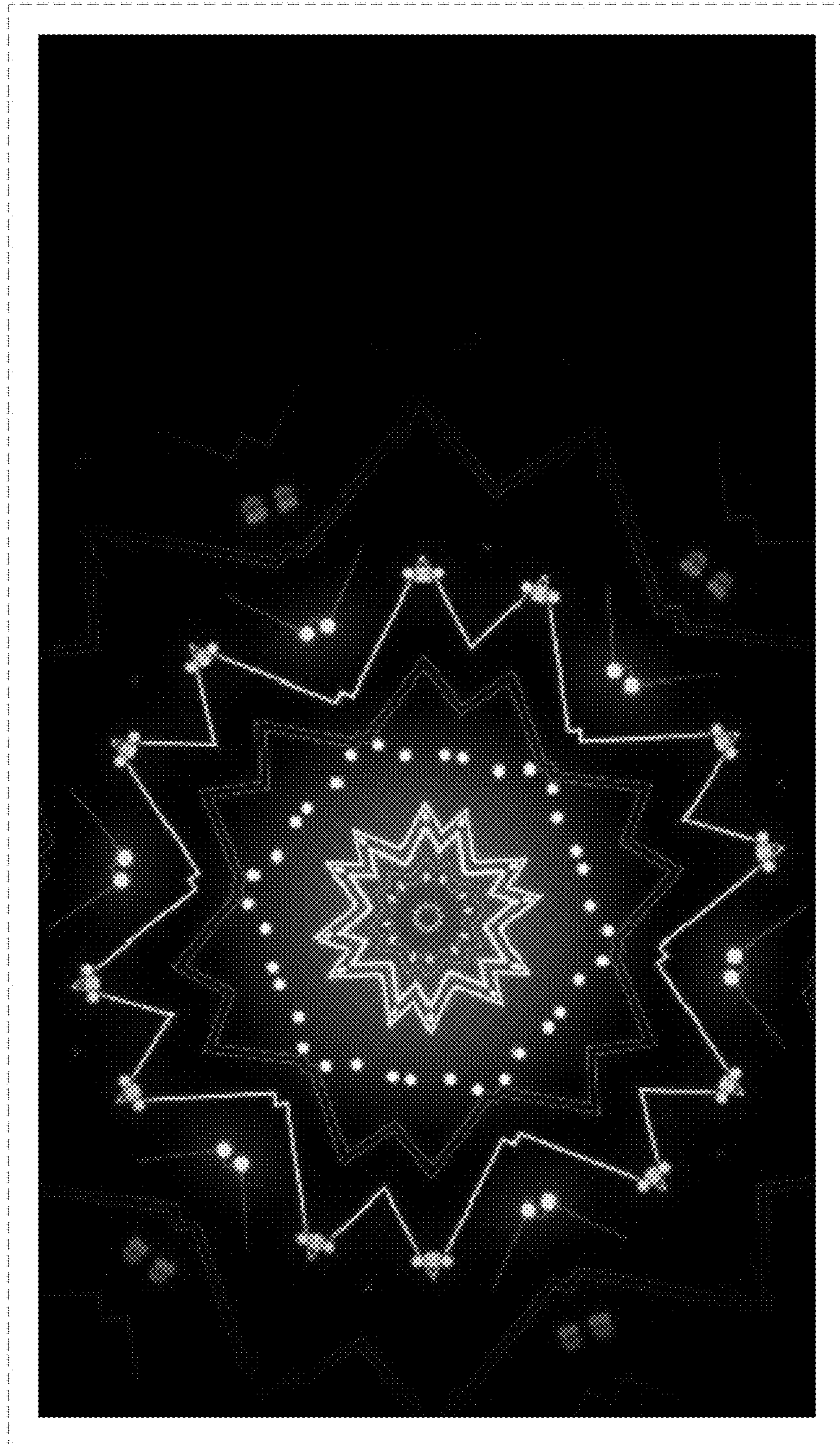

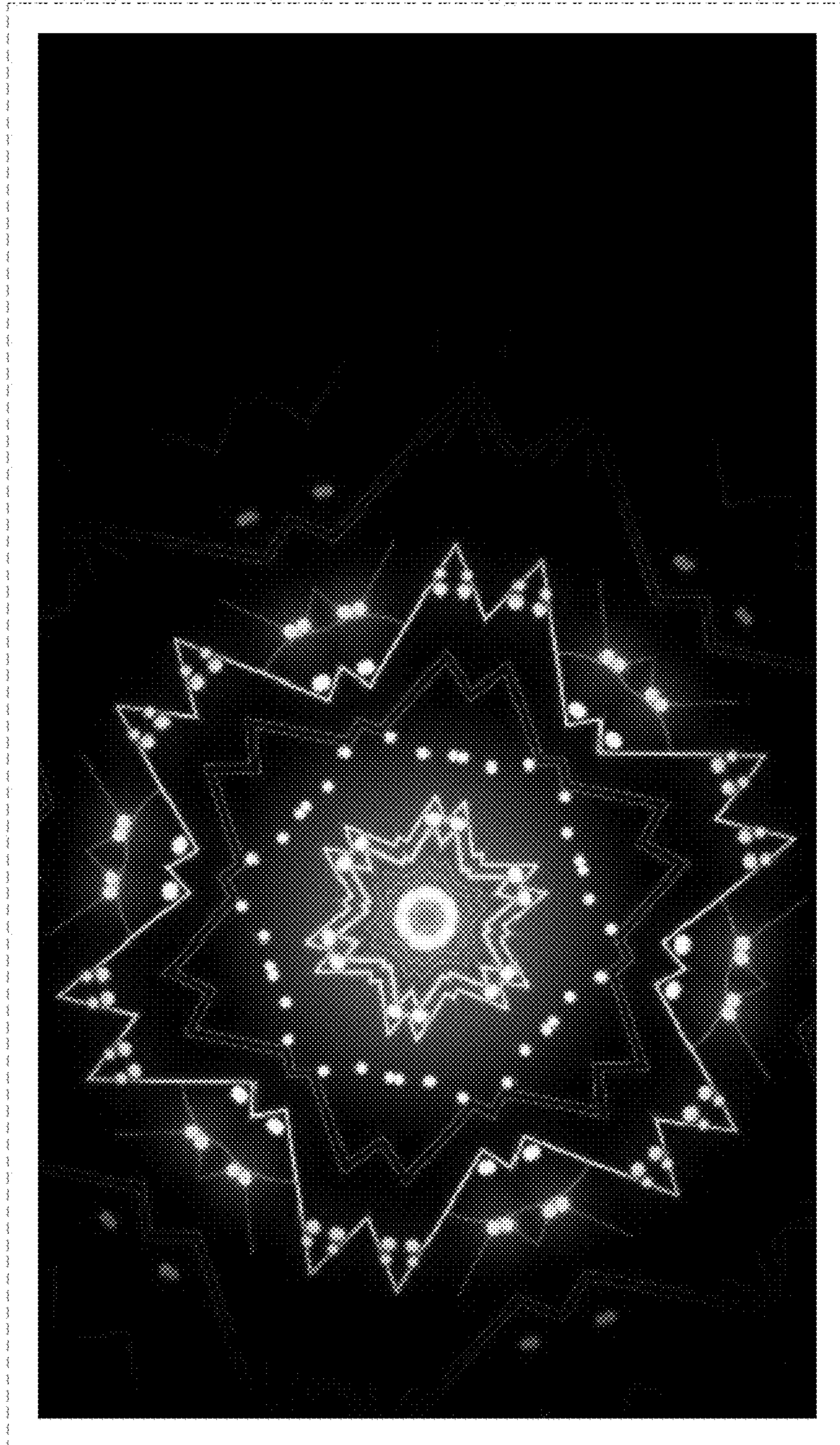

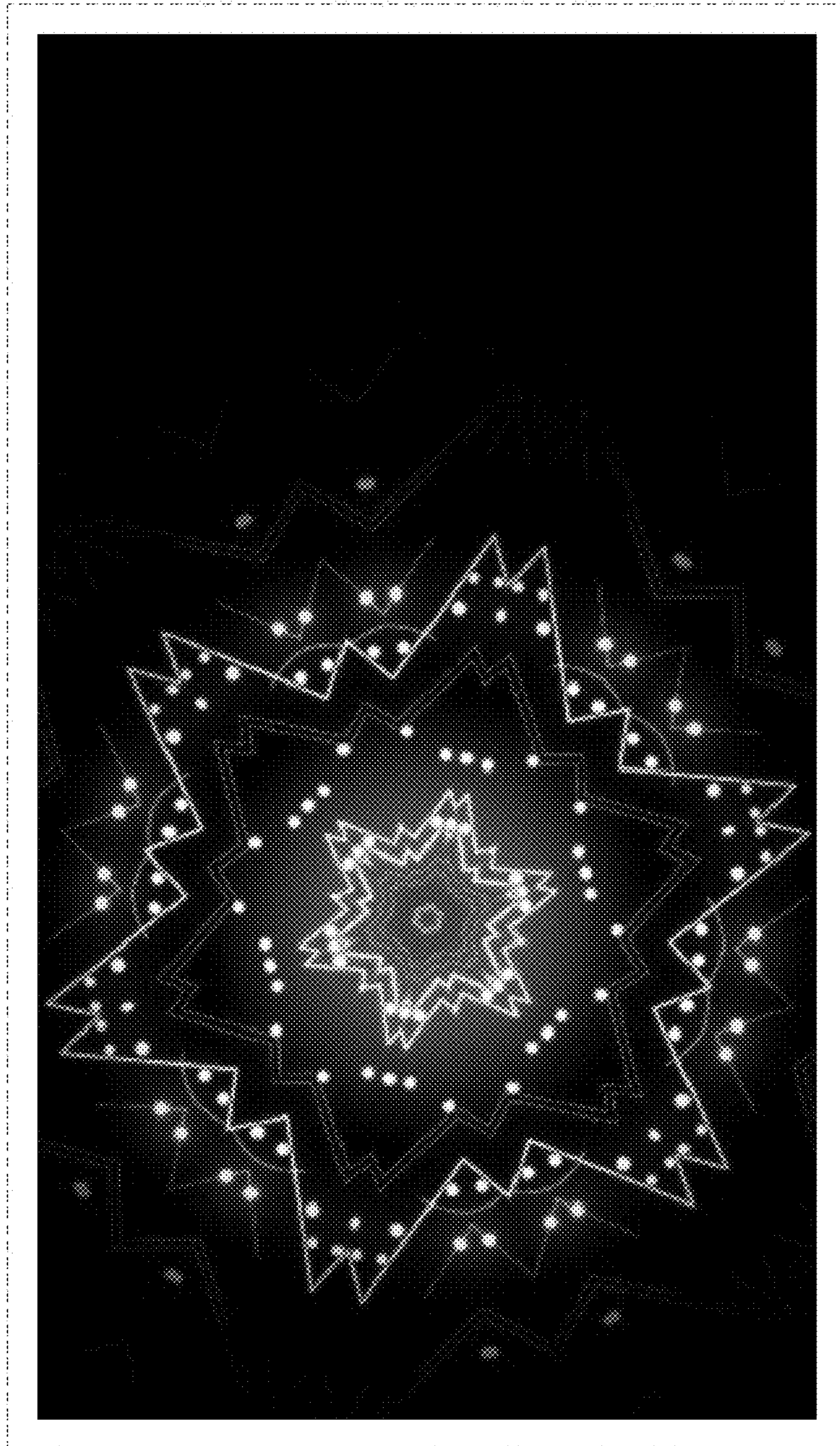

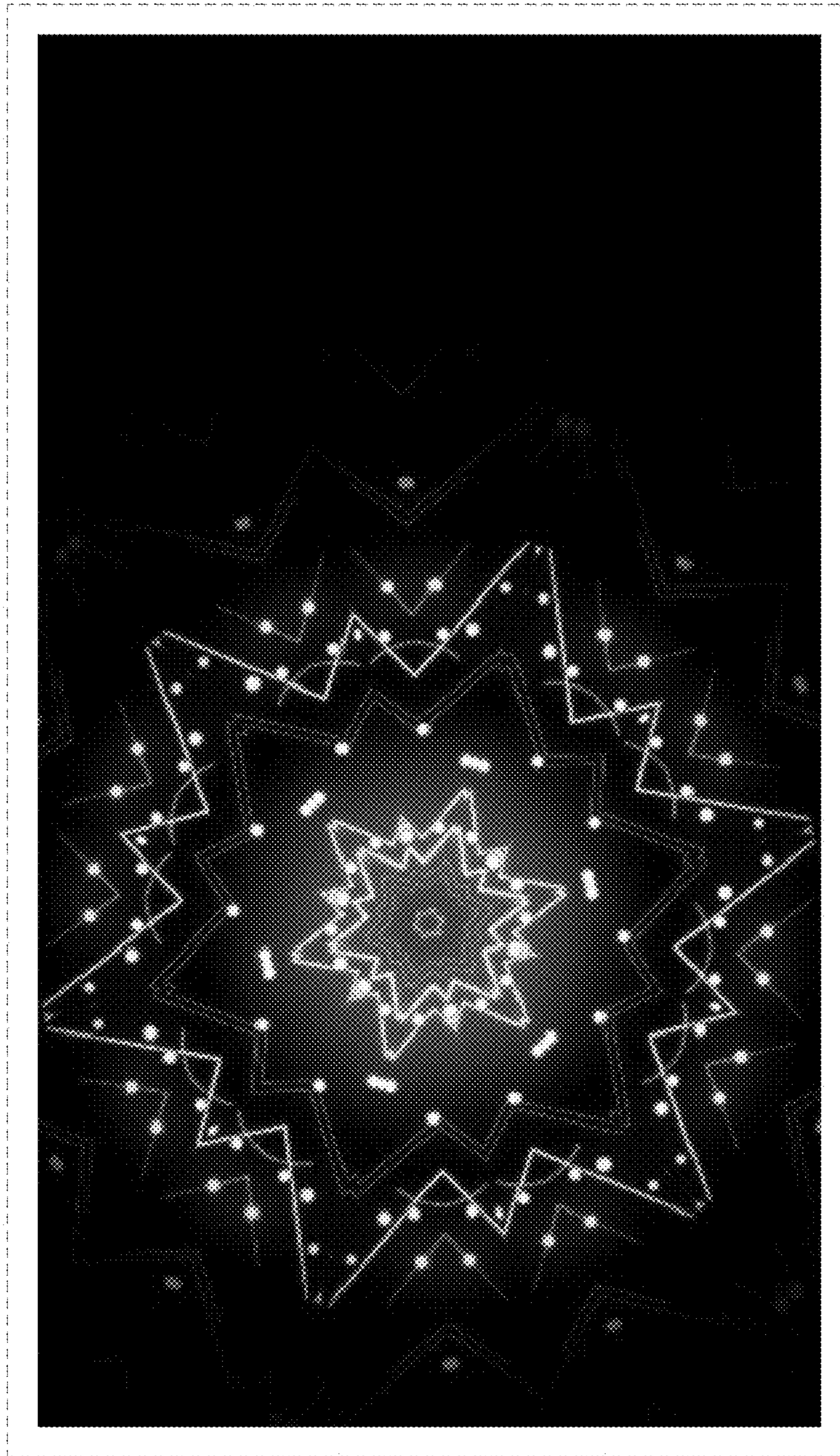

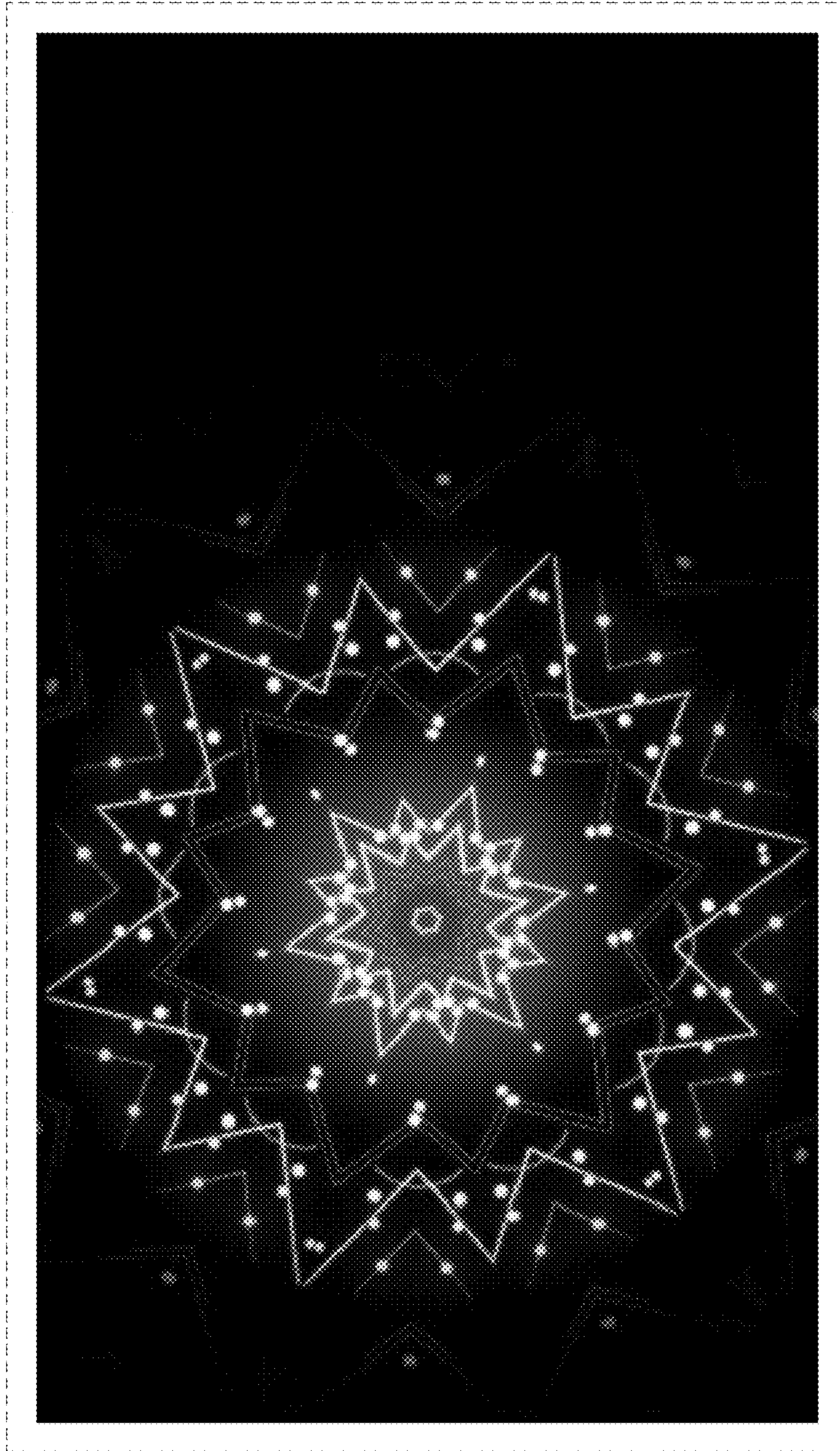

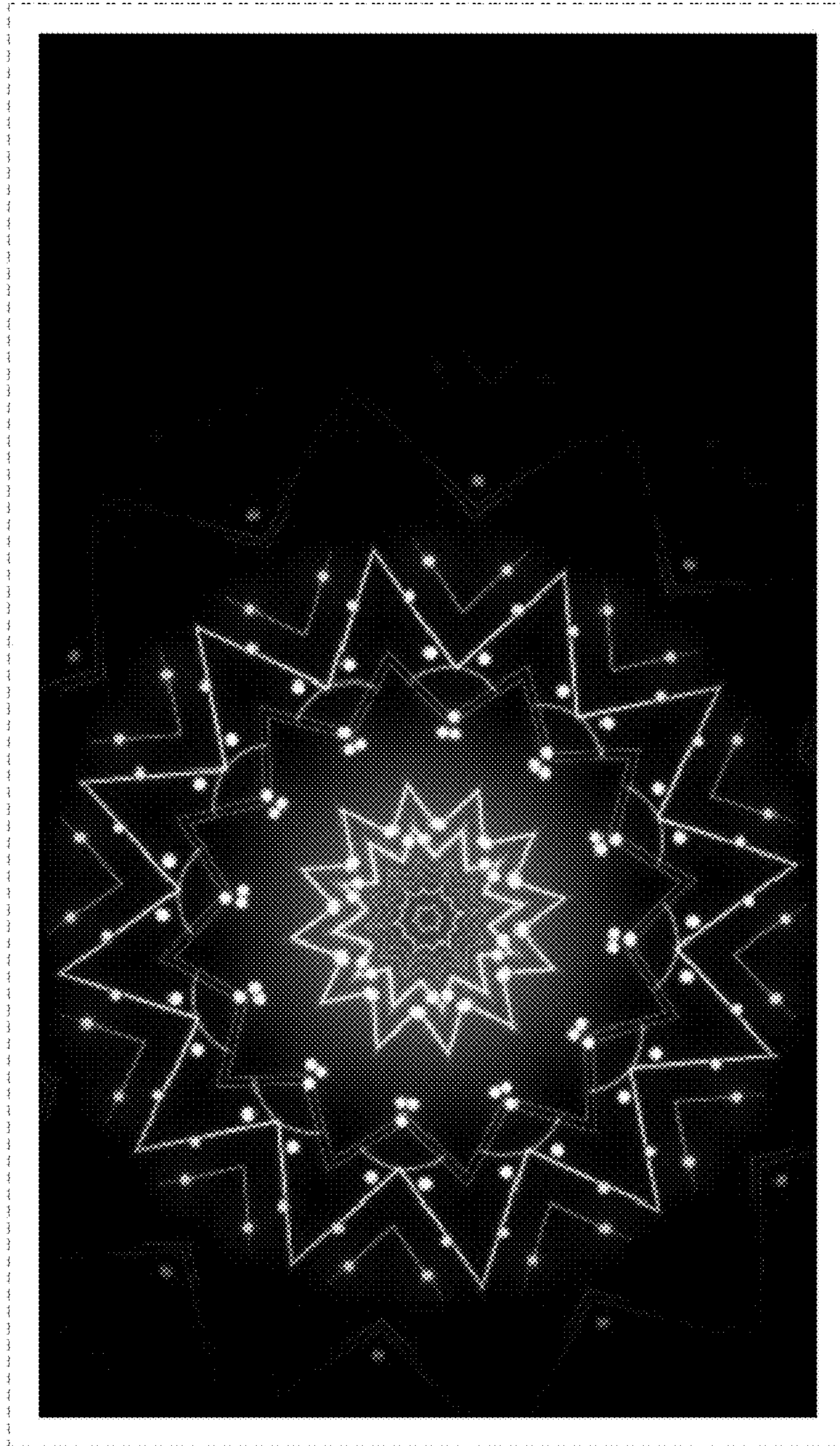

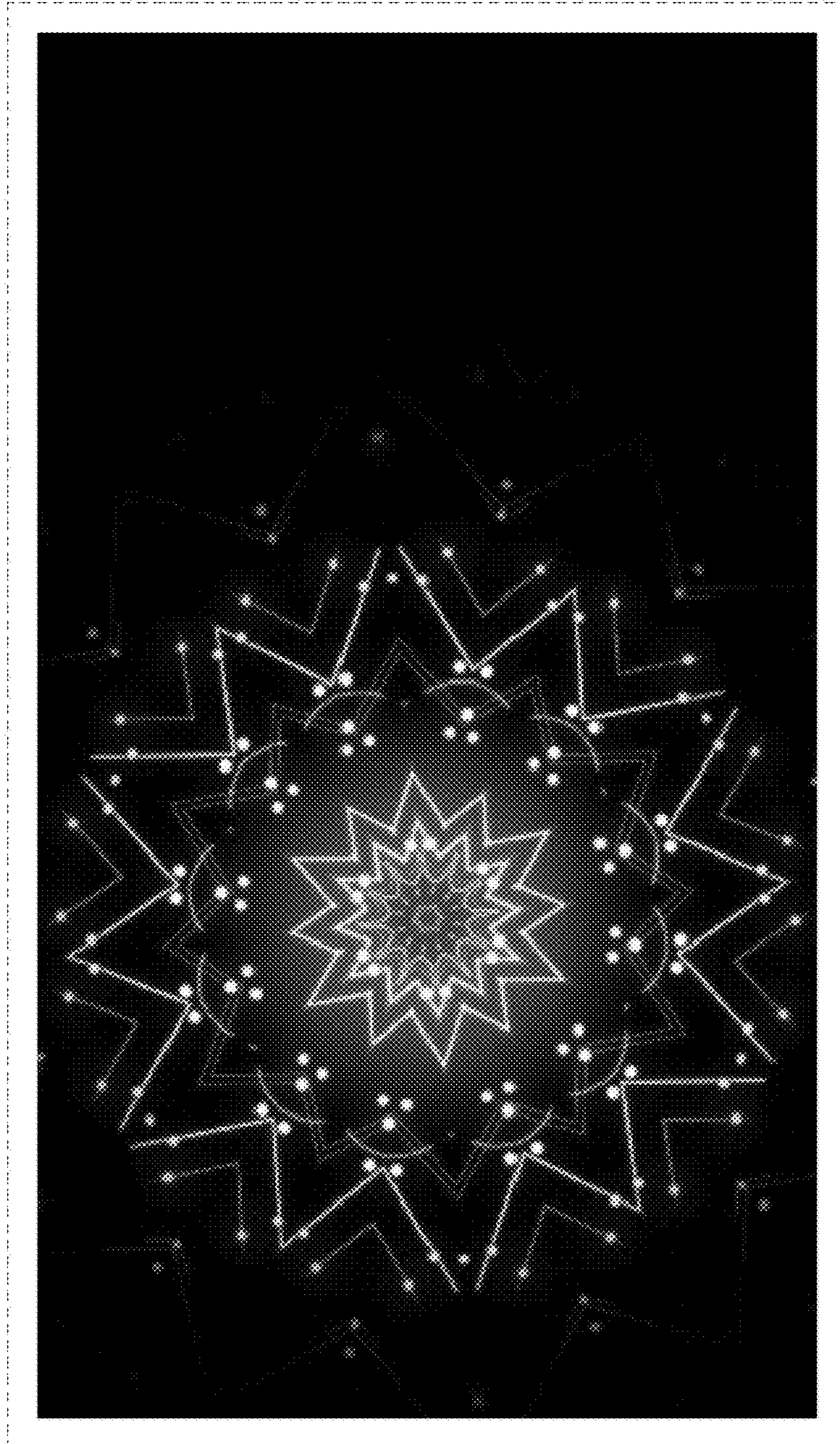

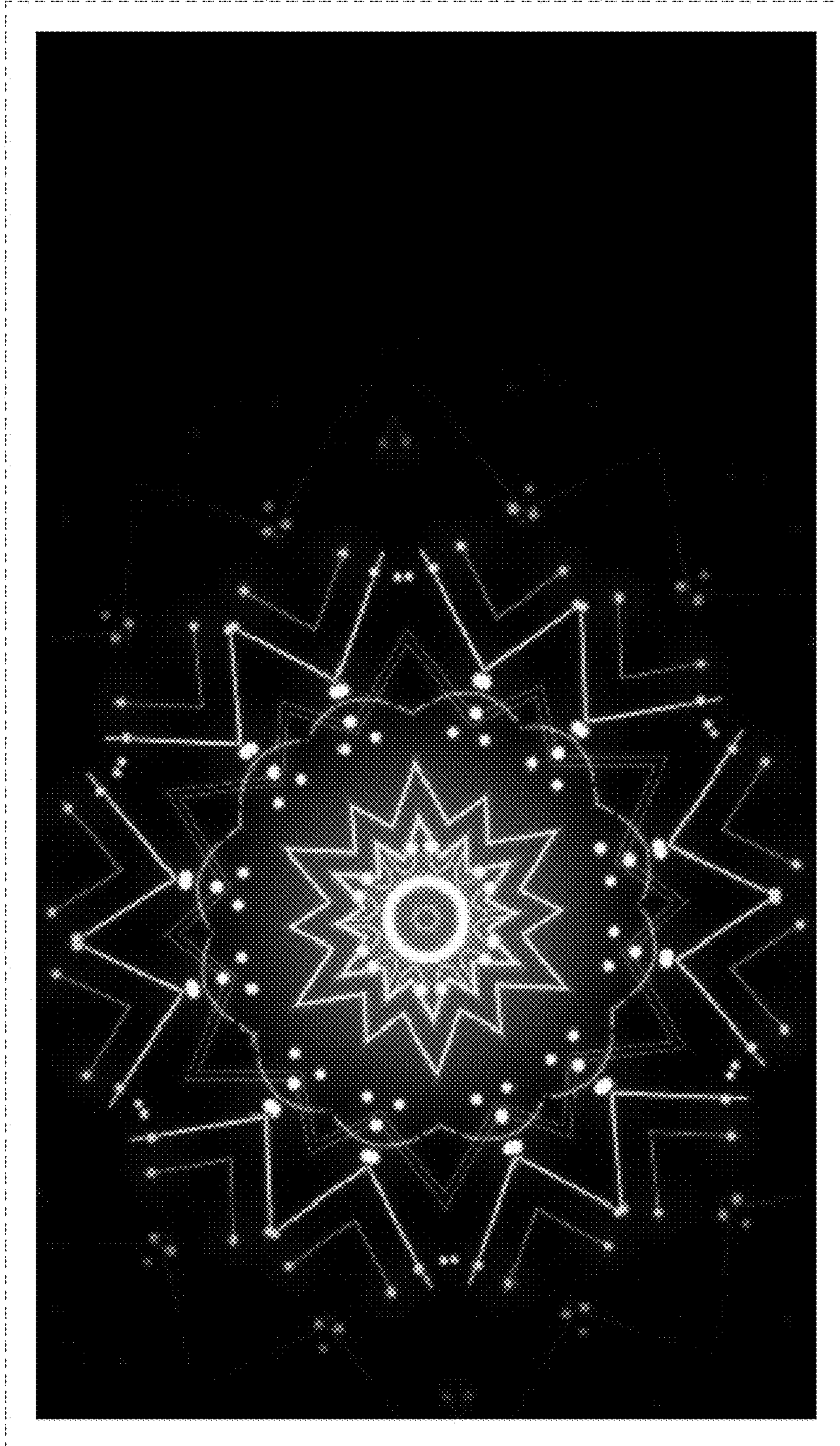

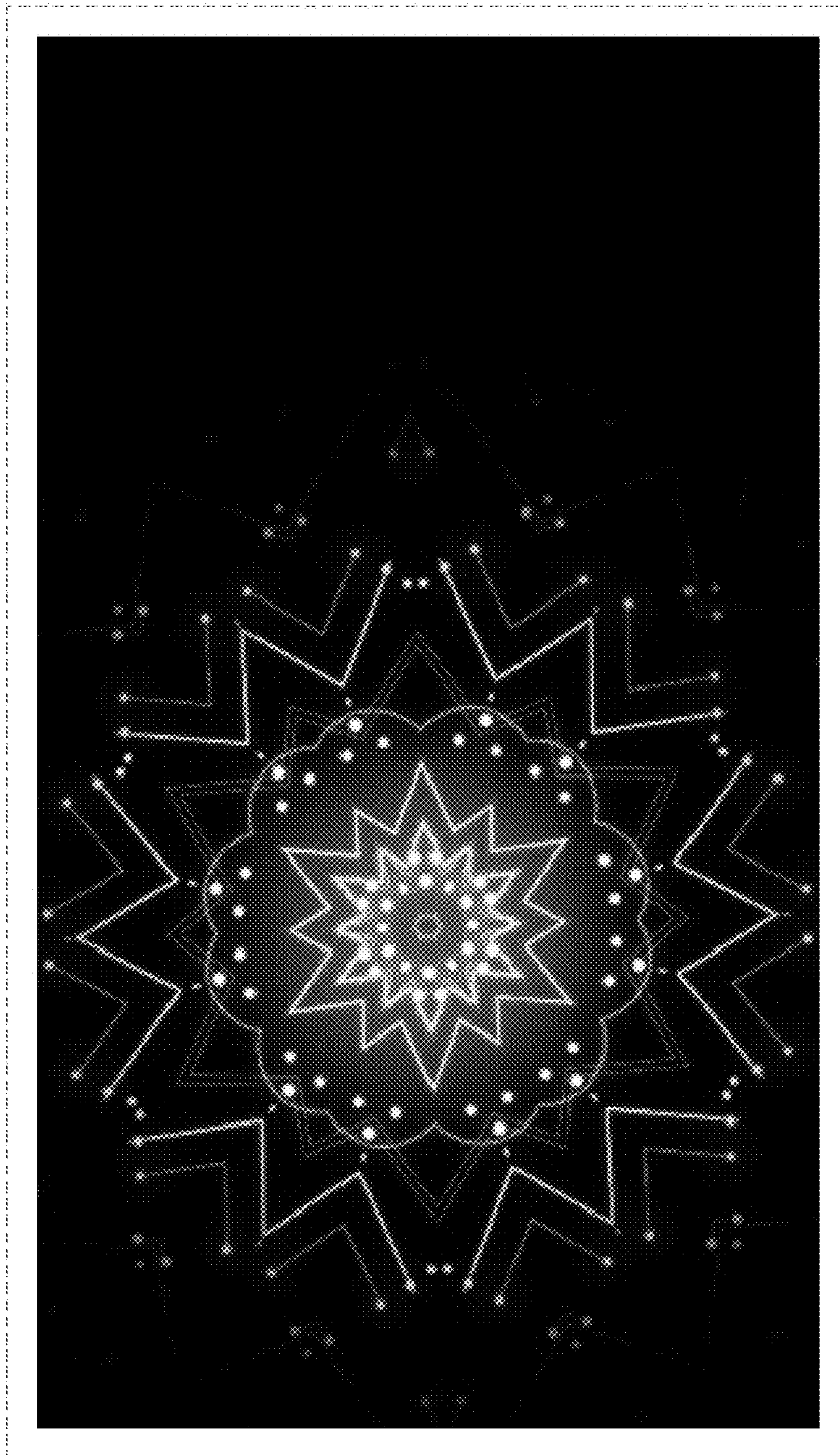

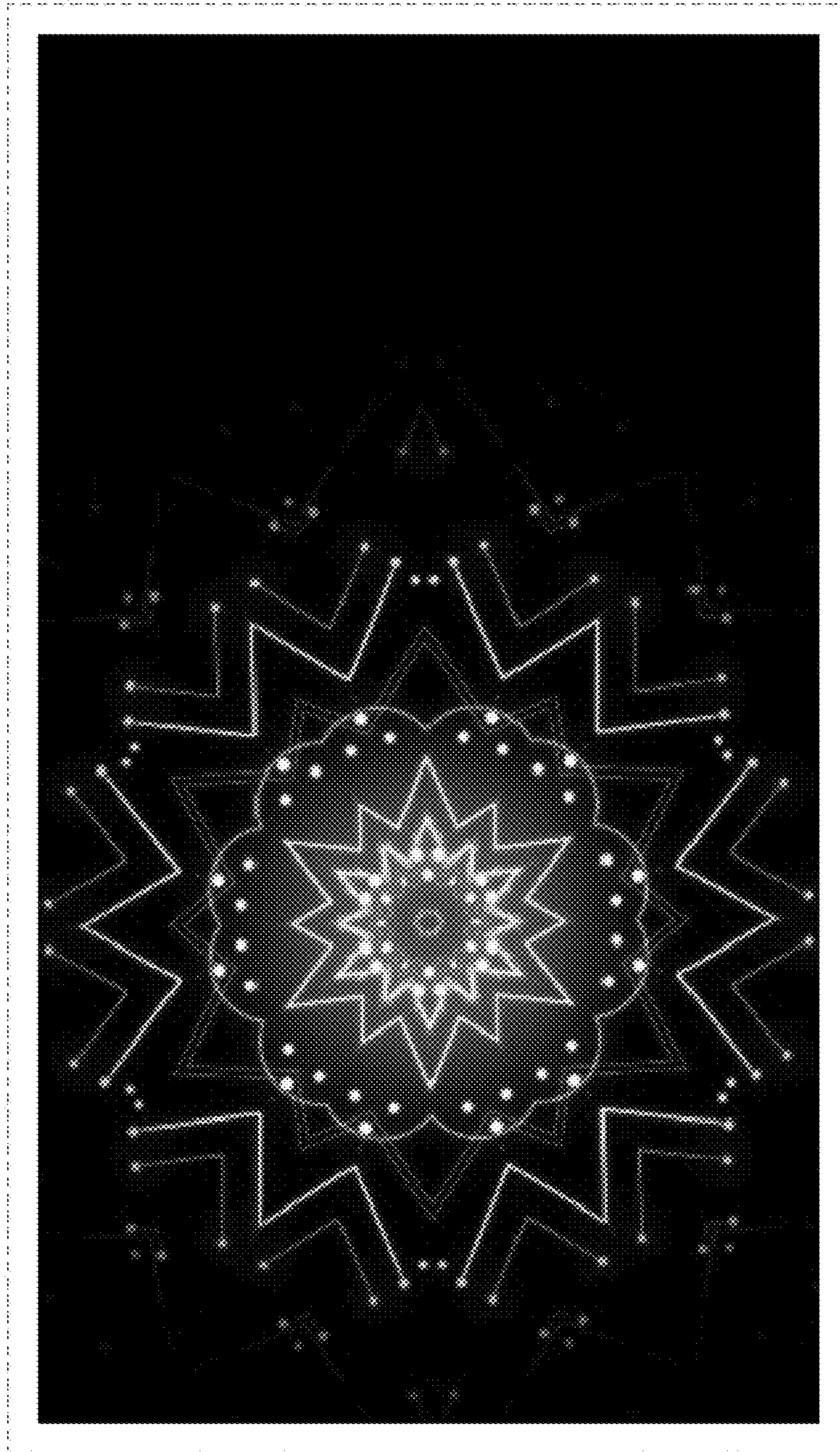
