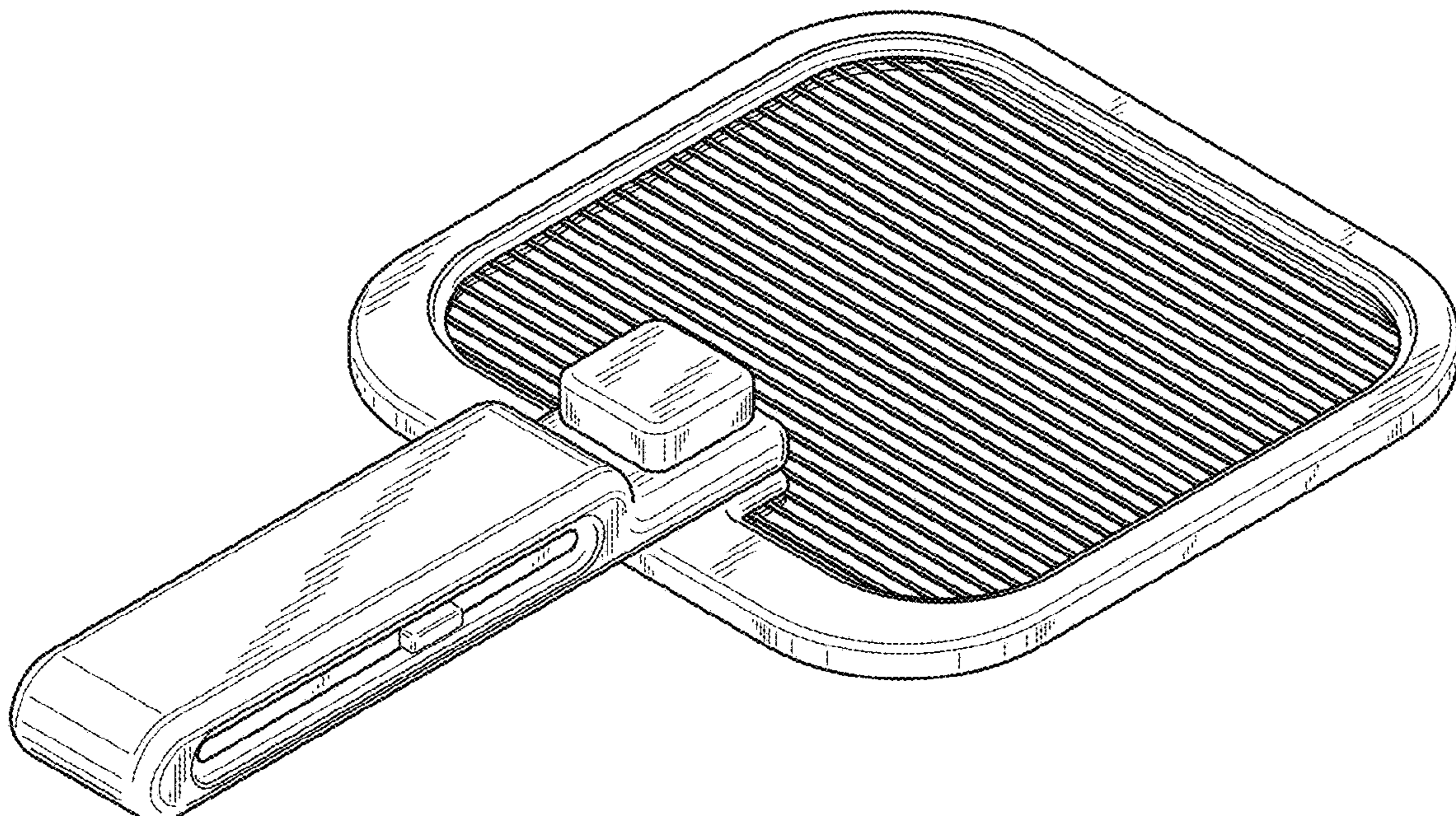
The ornamental design for a handheld bug zapper, as shown

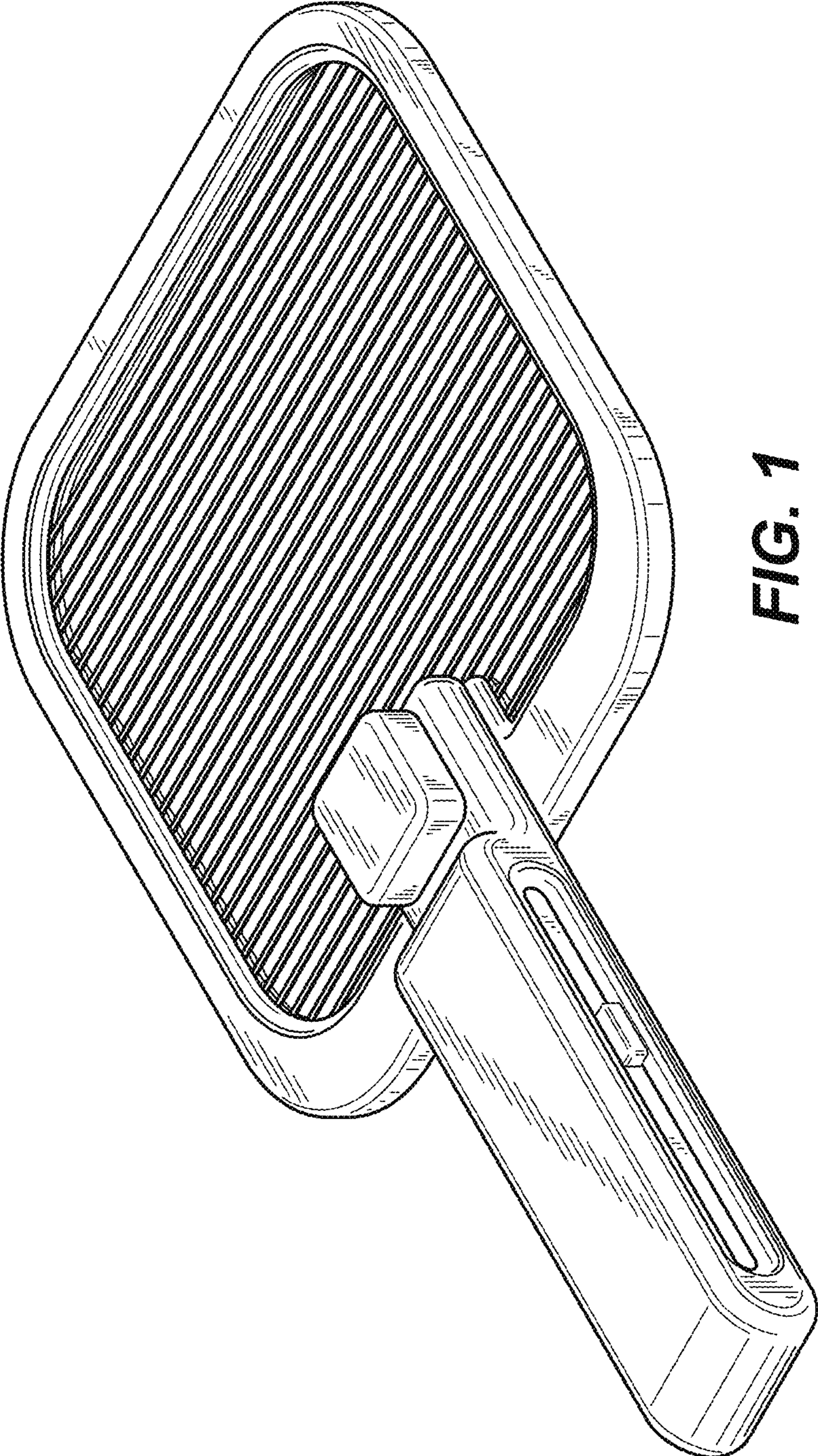

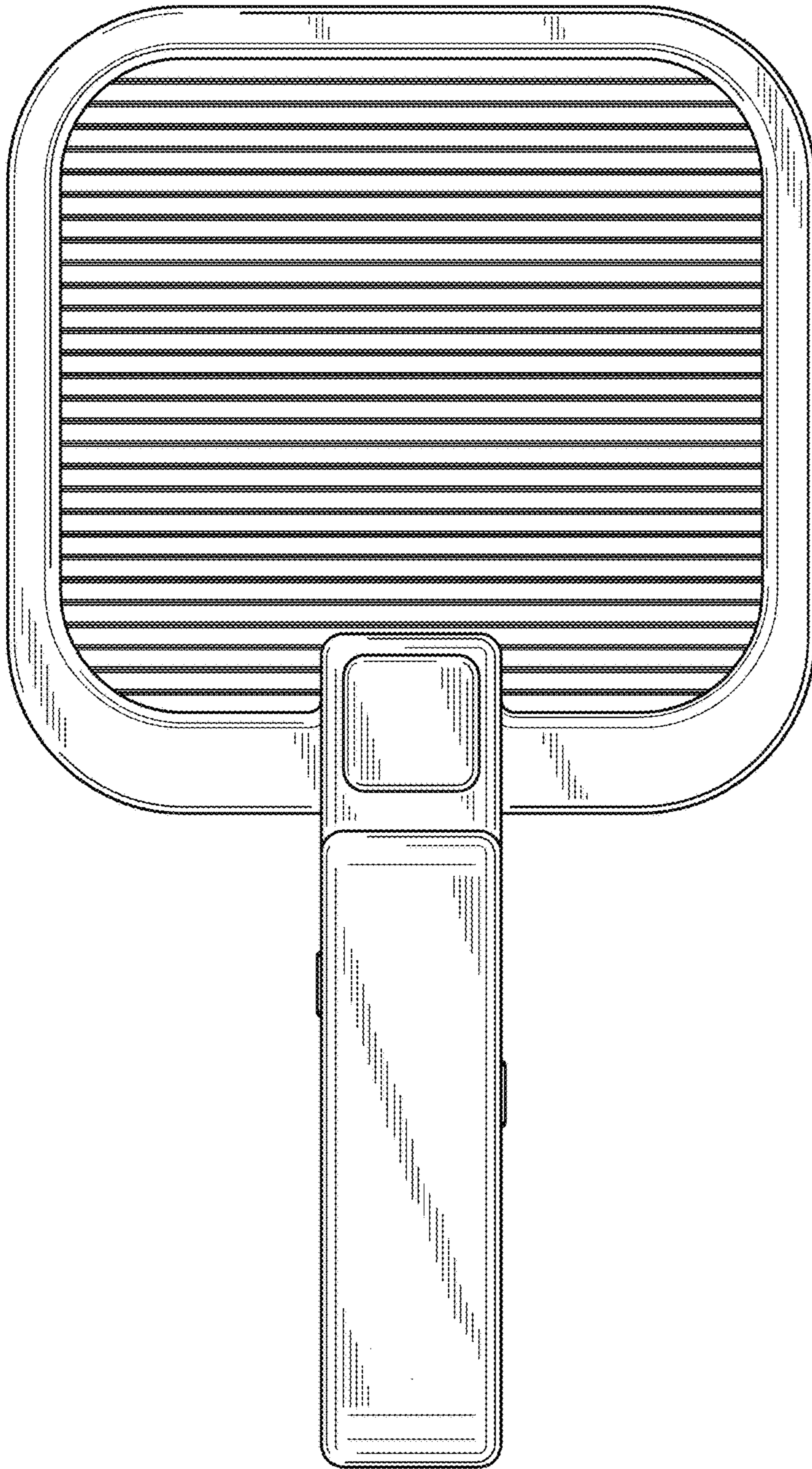

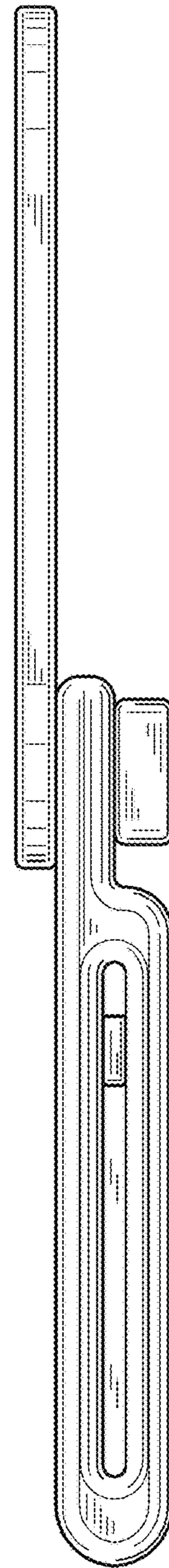

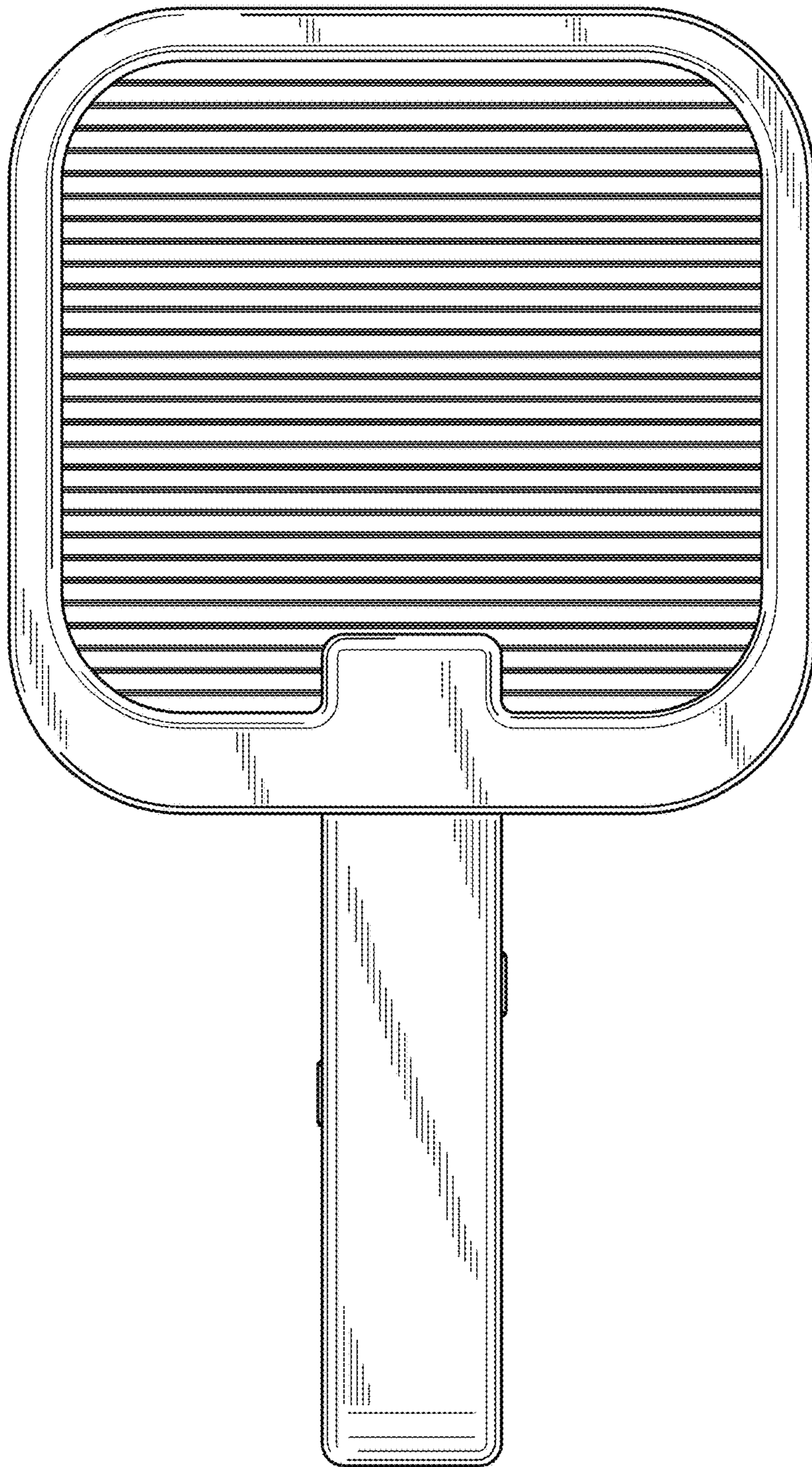

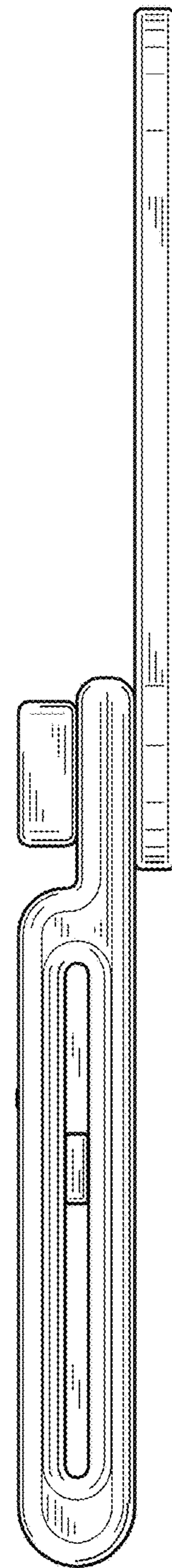

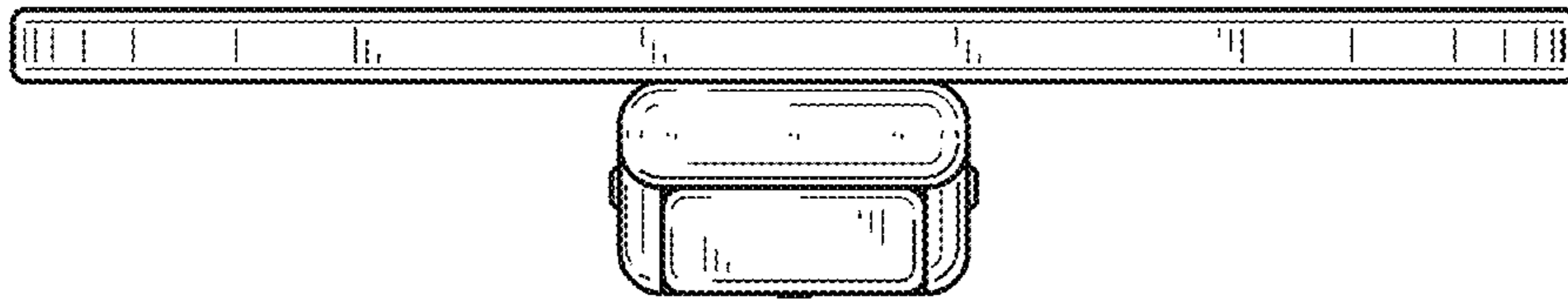

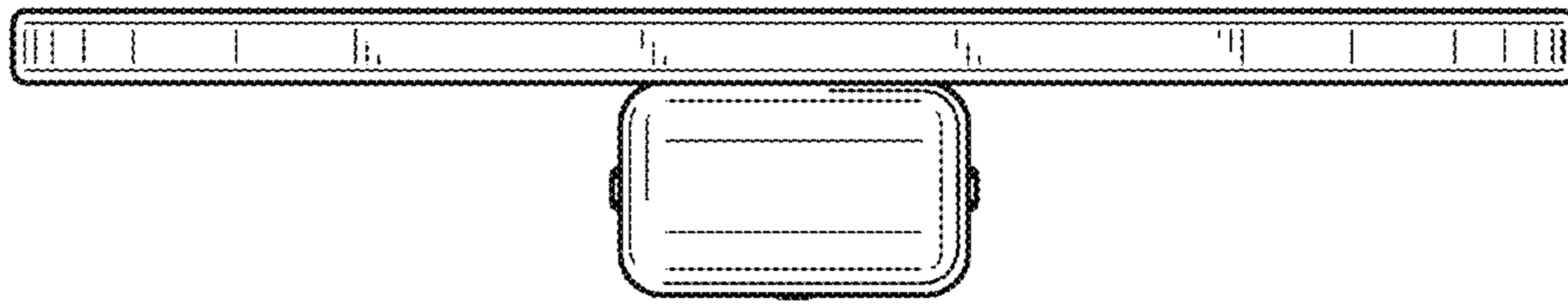
