**DESCRIPTION**

FIG. 12 is a left side elevation view of the cartridge of FIG. 8;

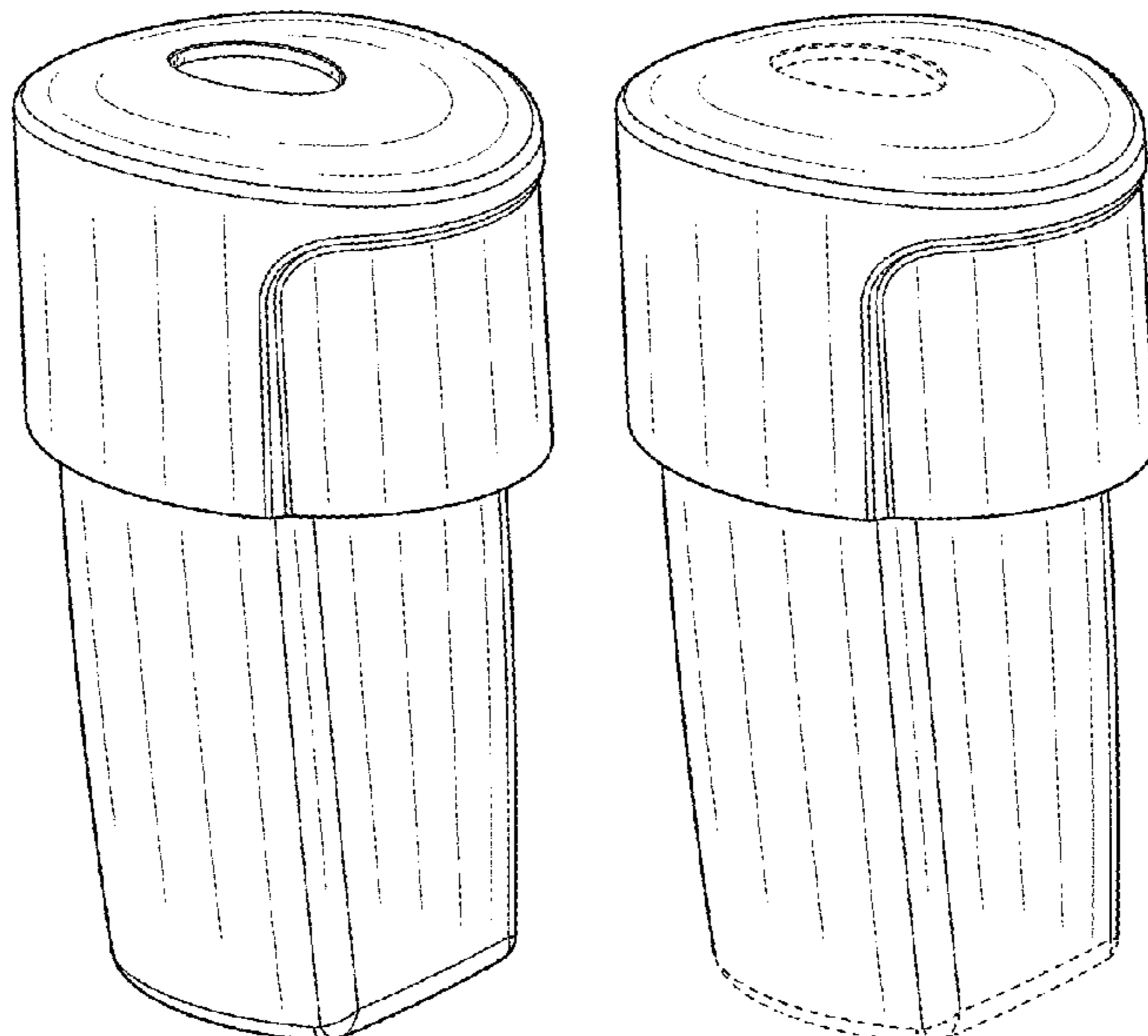
FIG. 13 is a top plan view of the cartridge of FIG. 8; and,

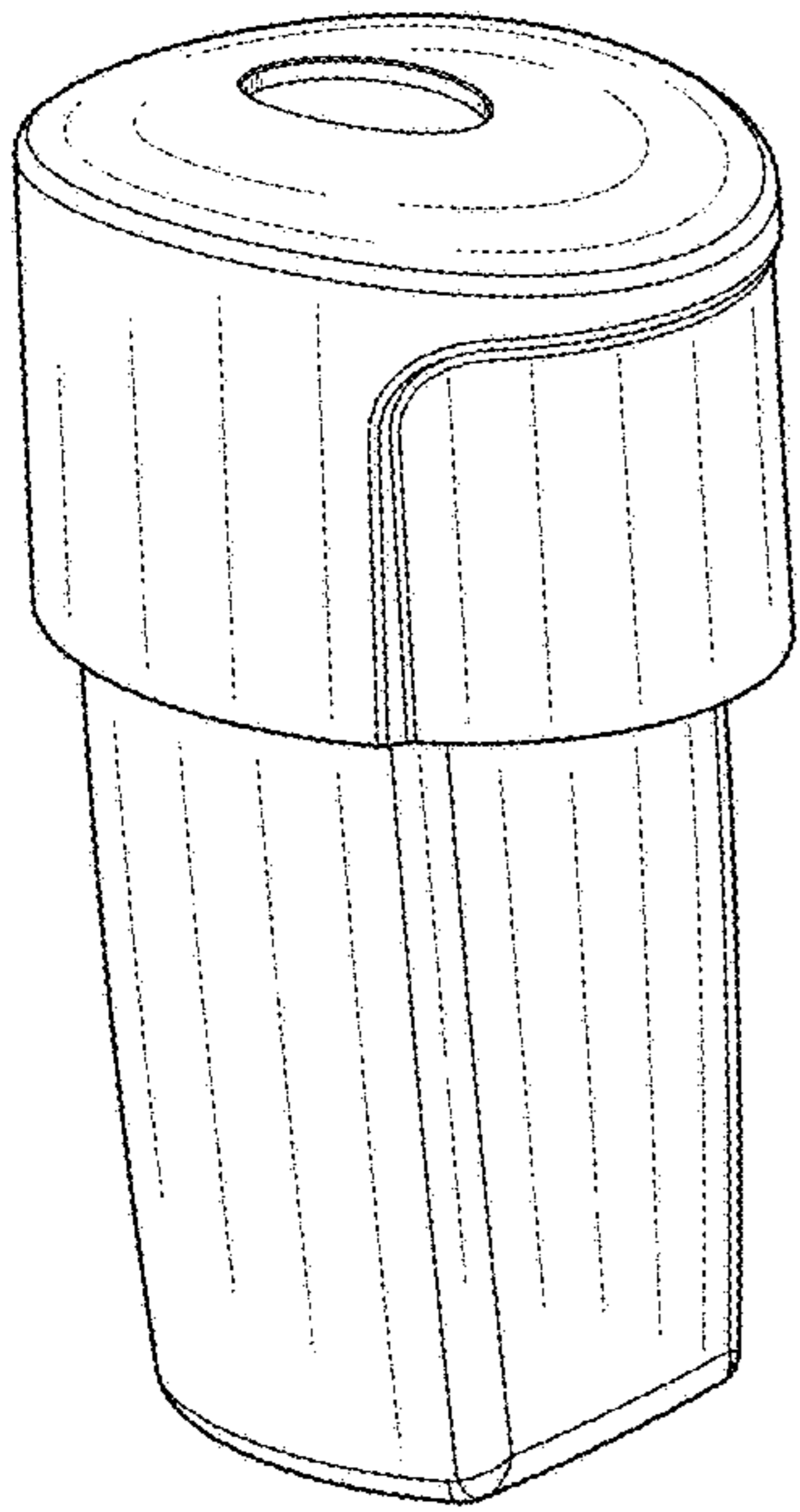

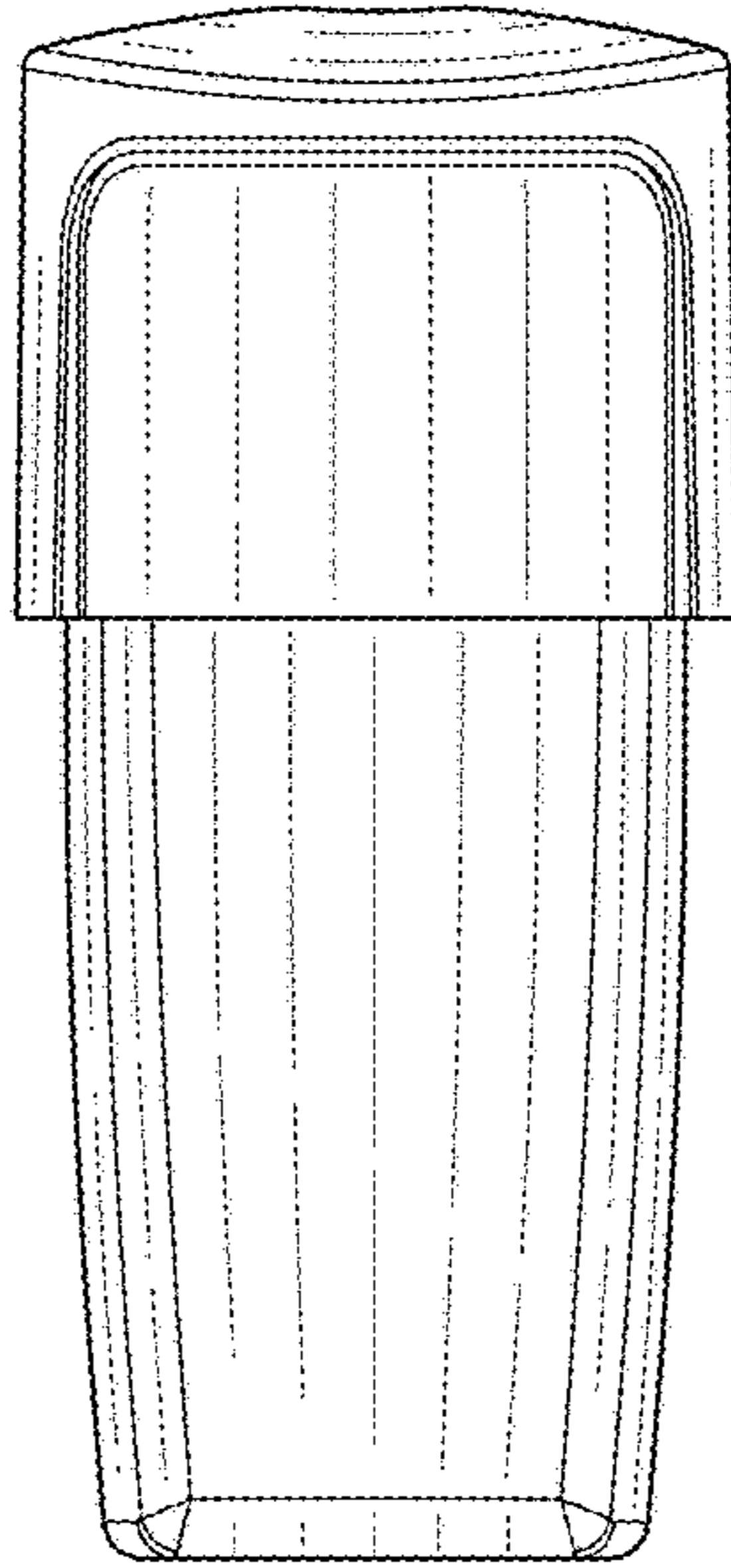

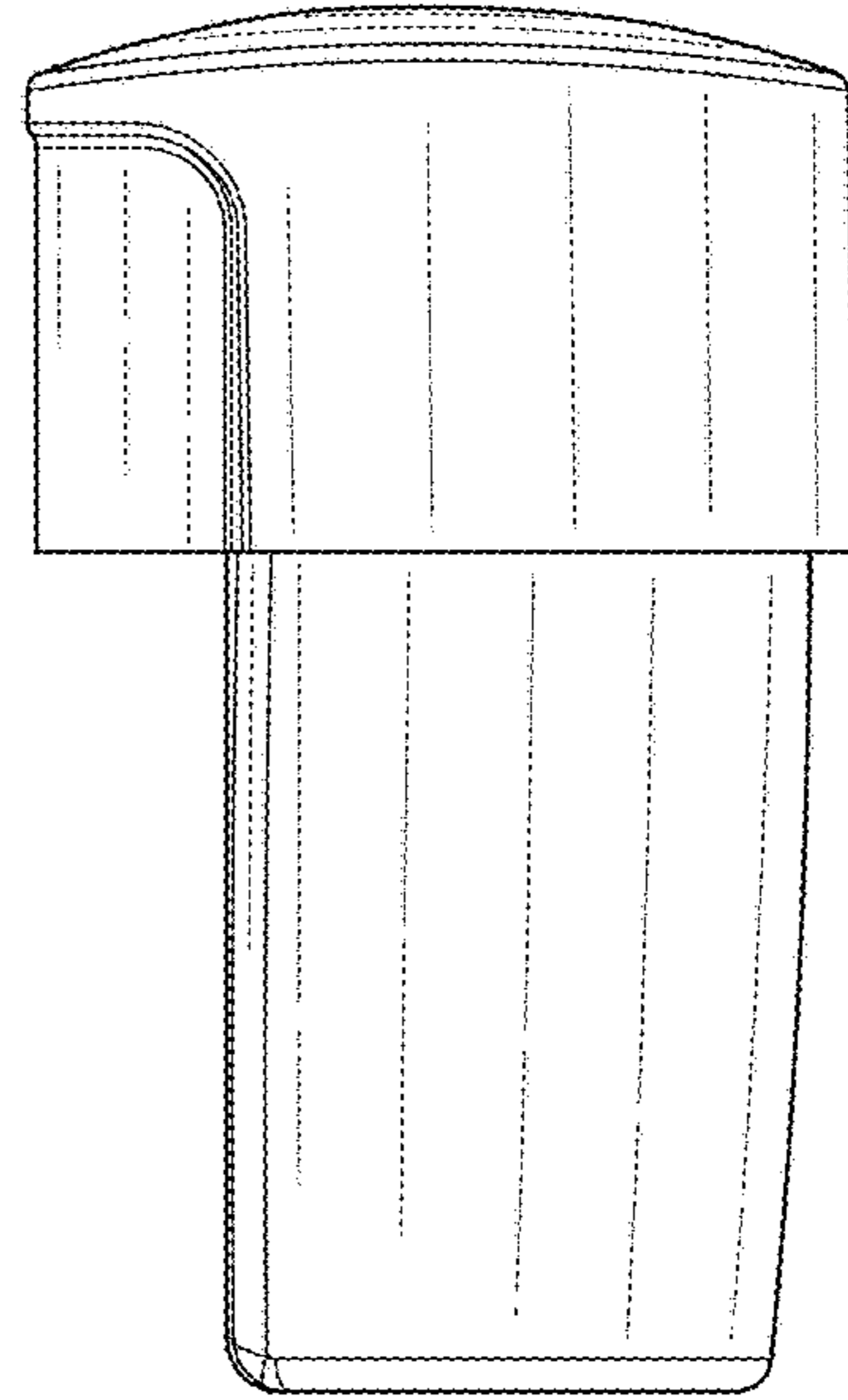

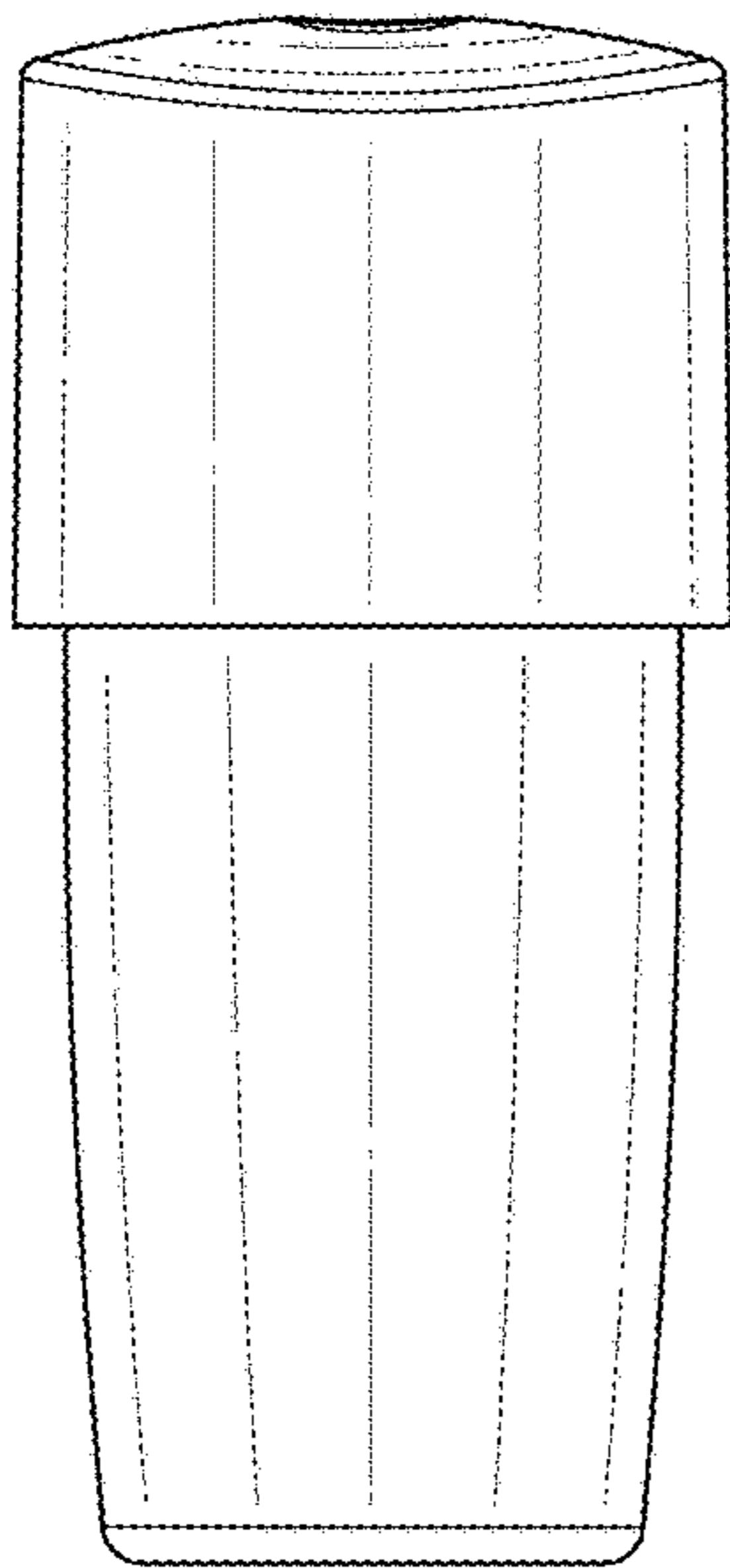

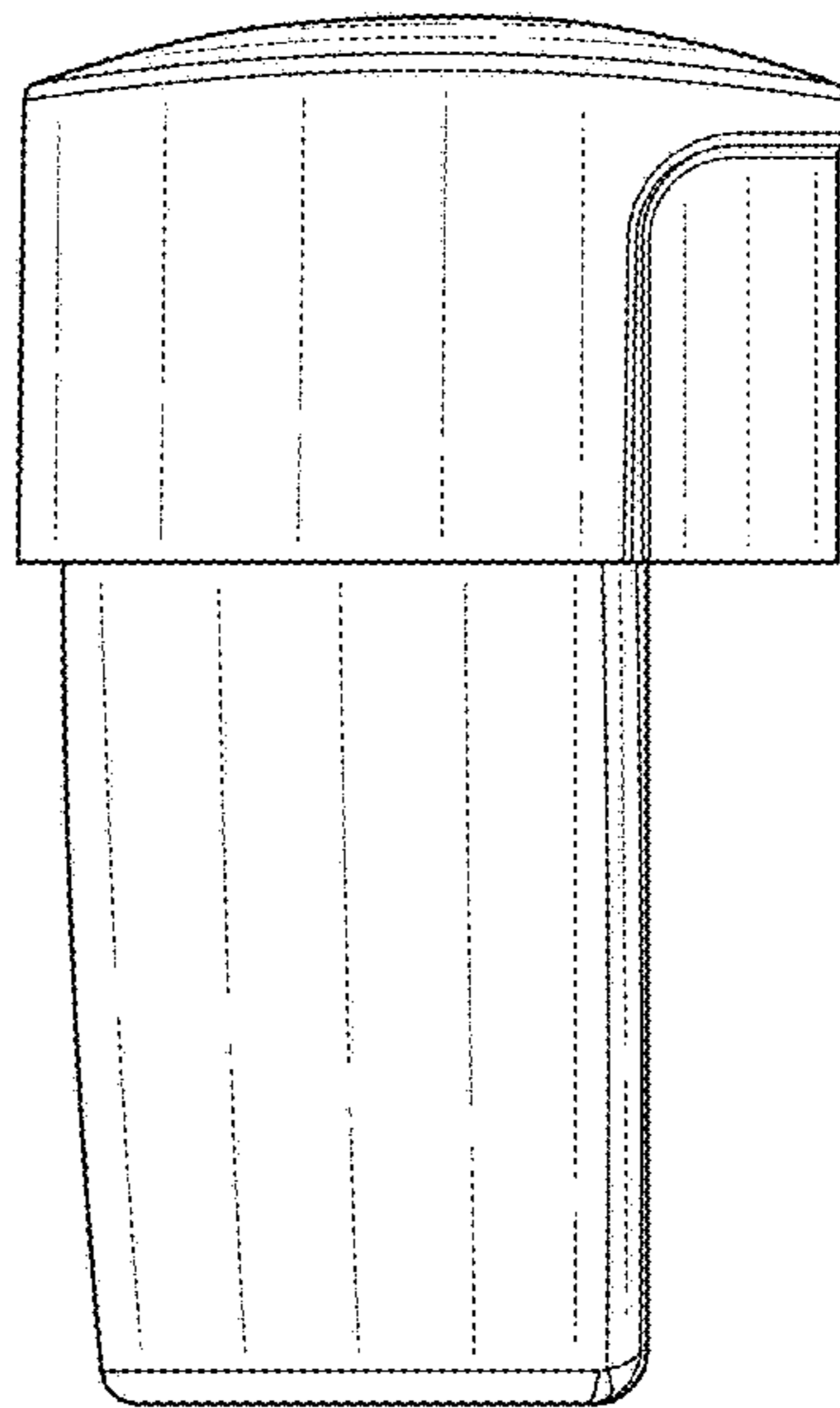

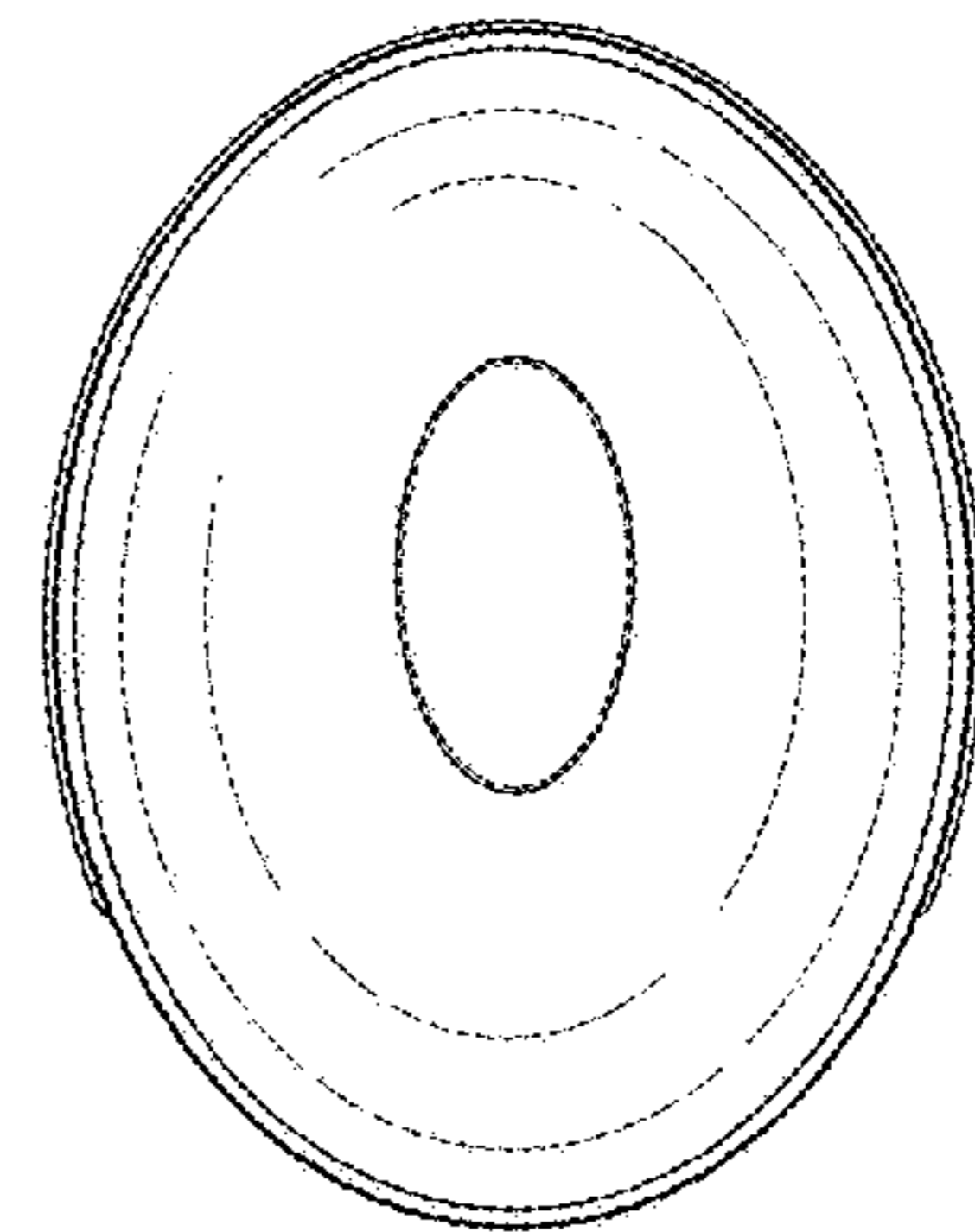

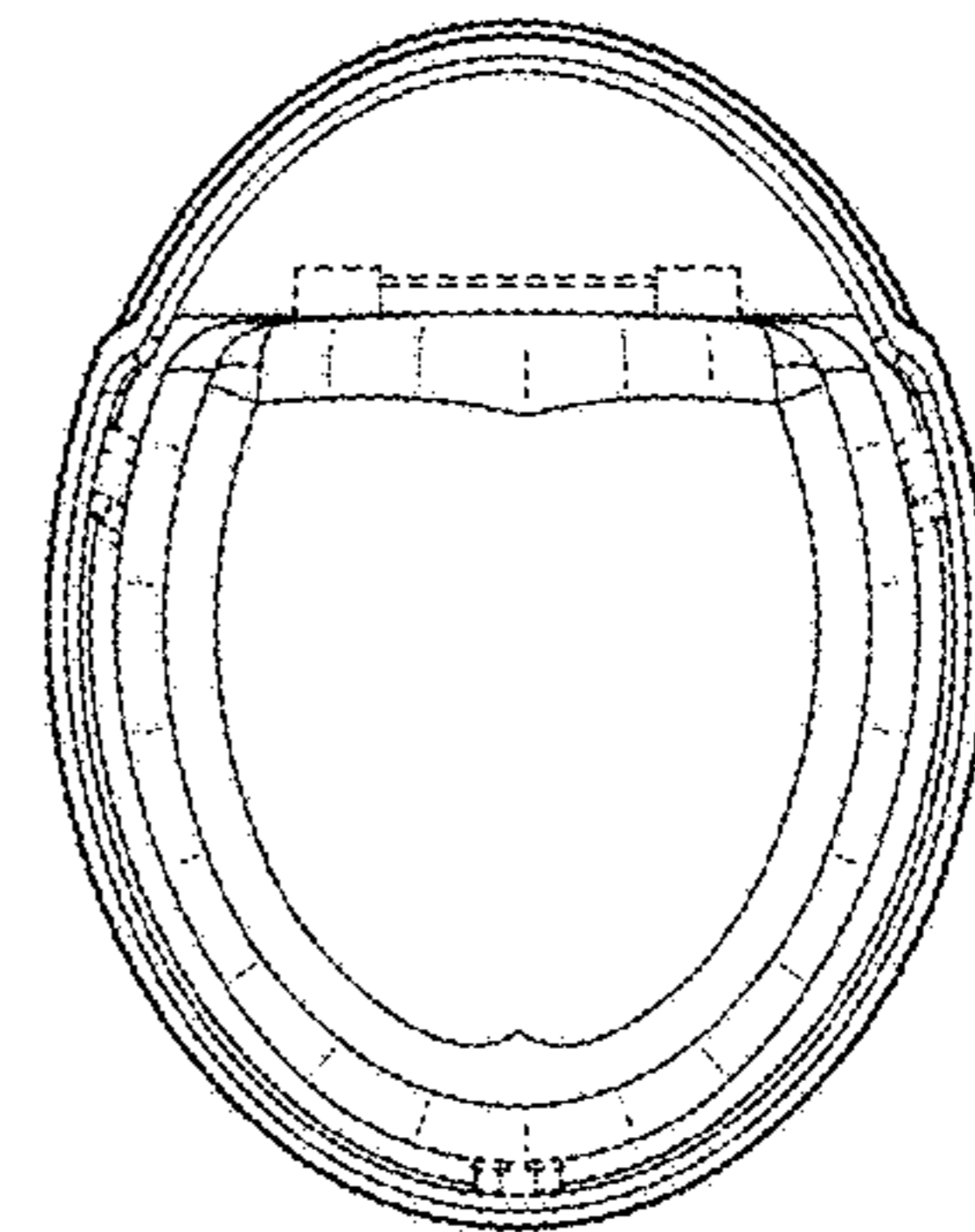

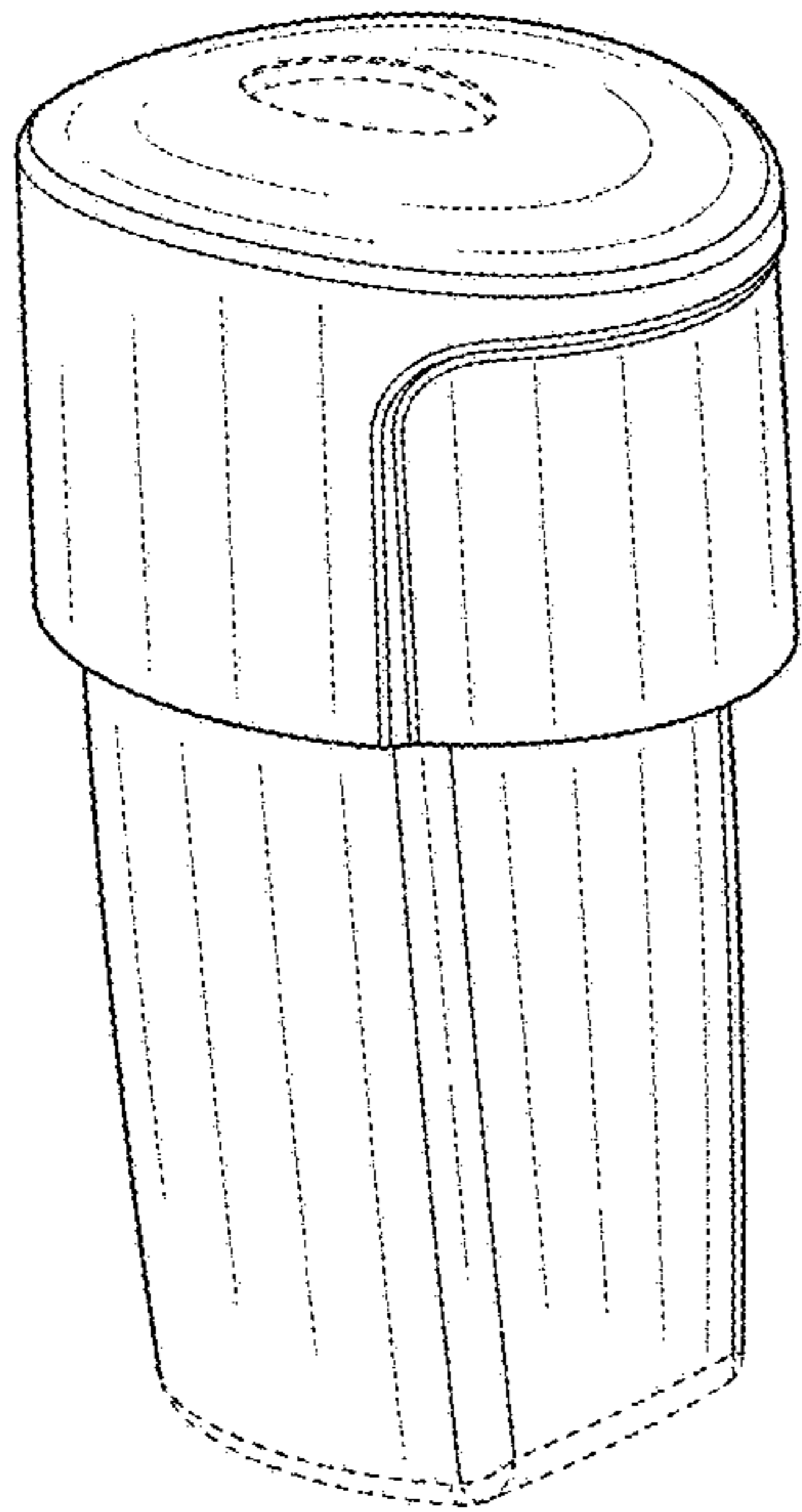

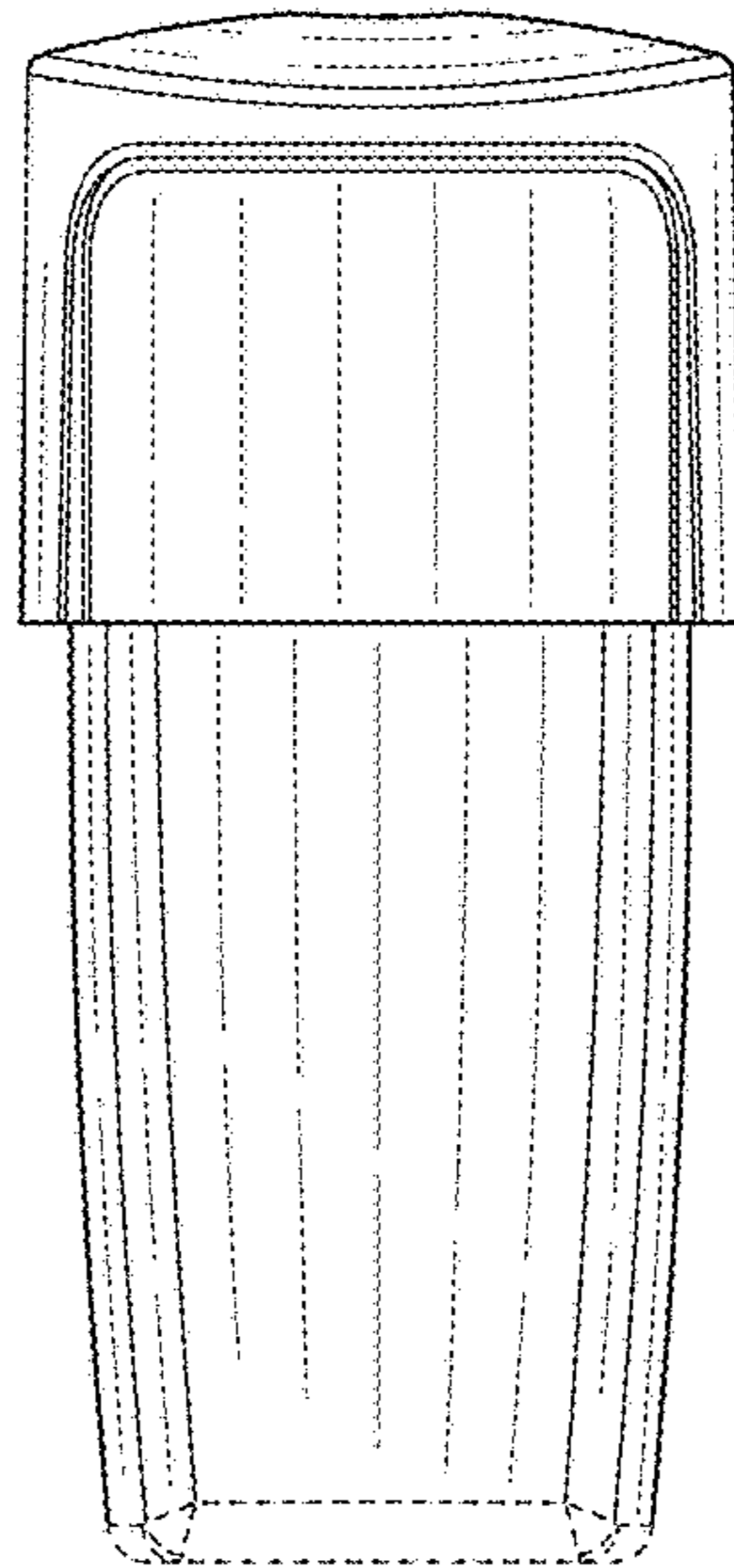

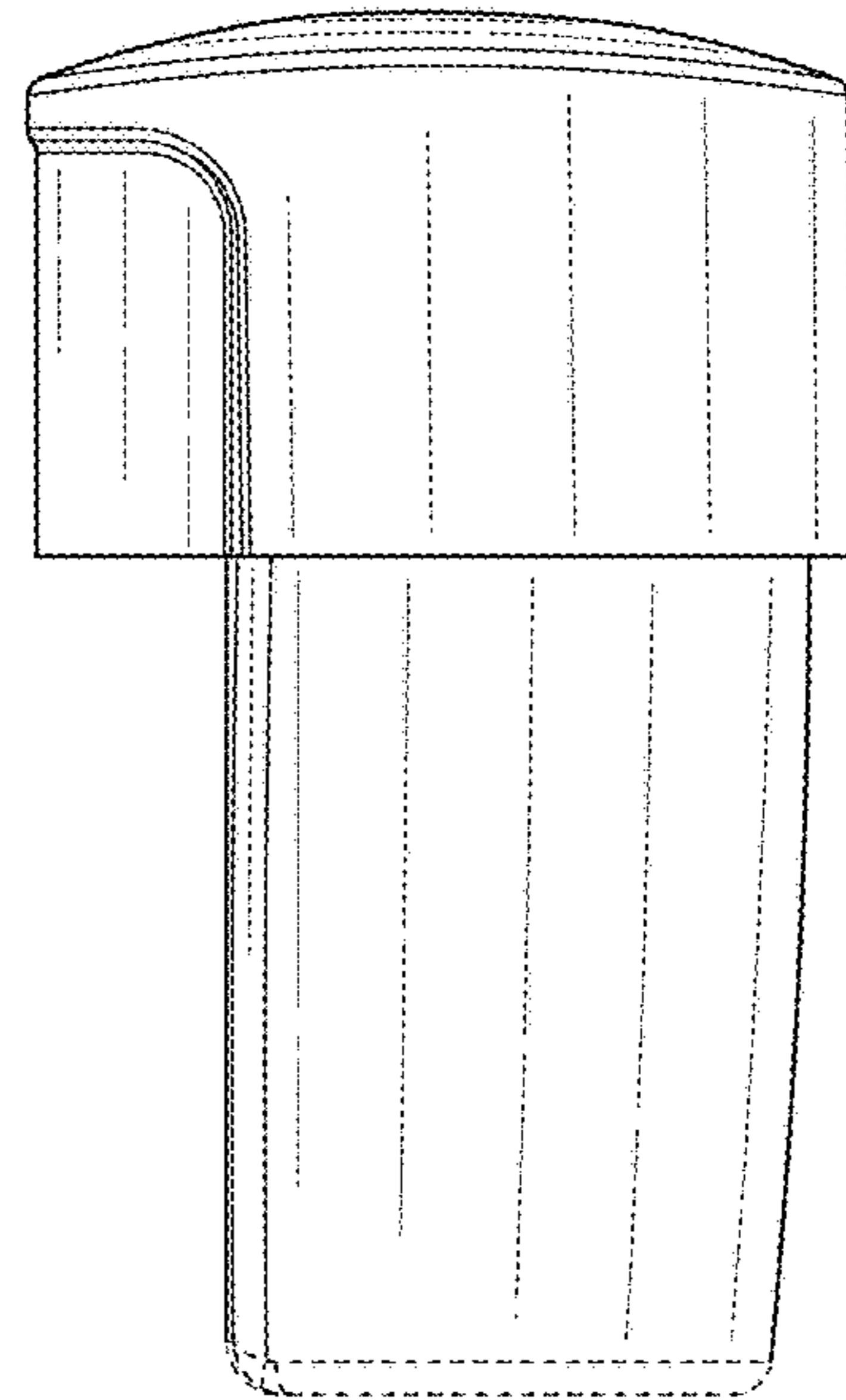

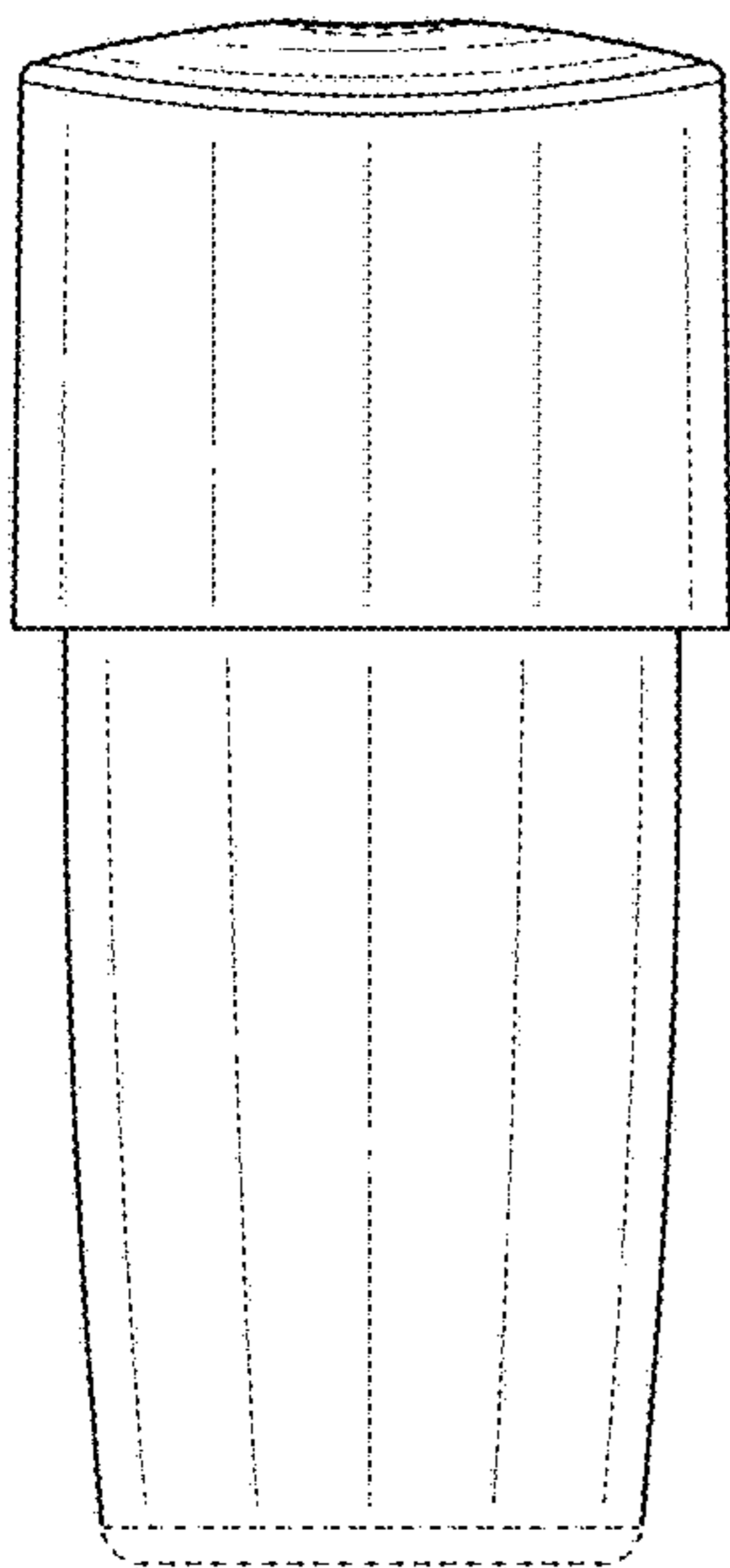

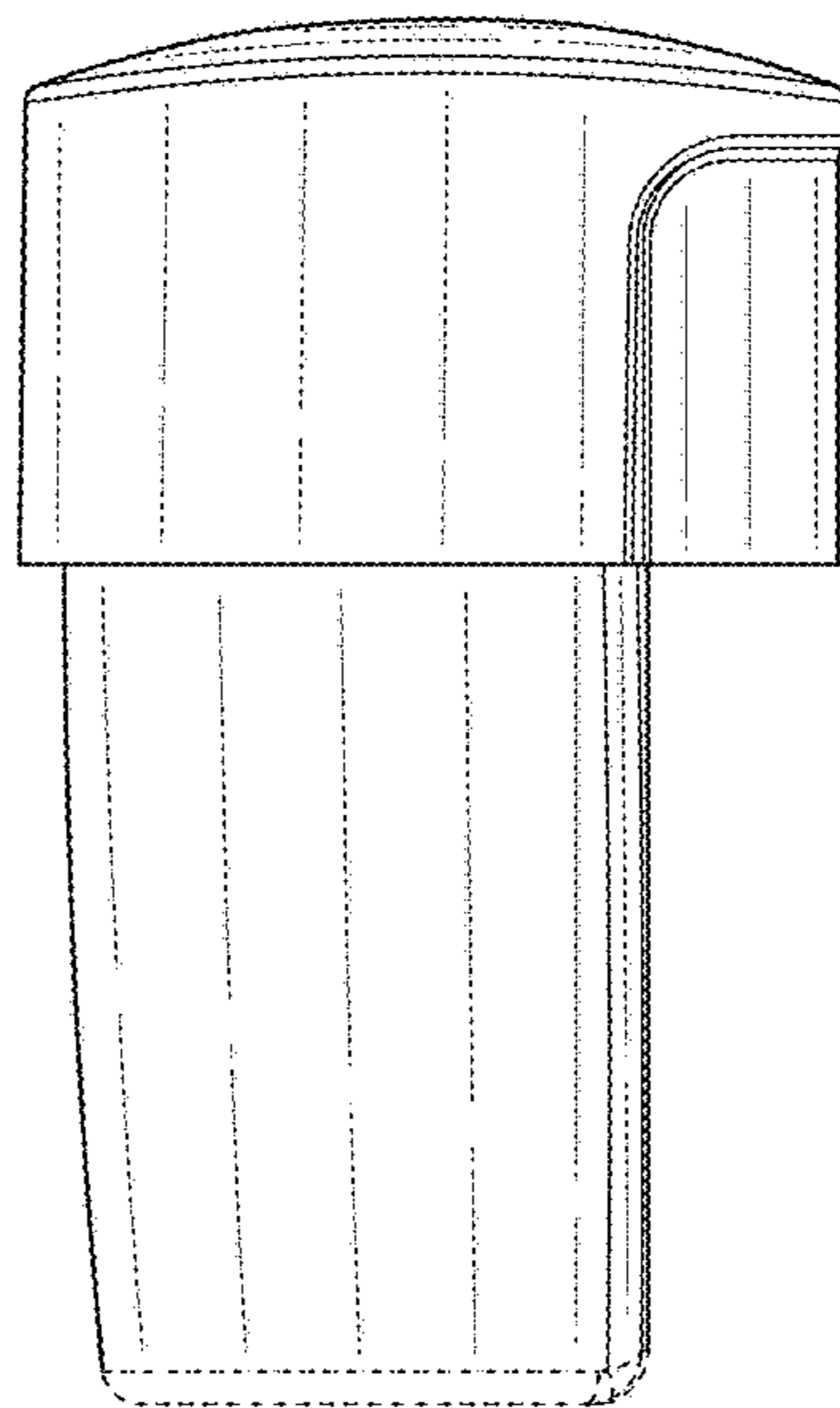

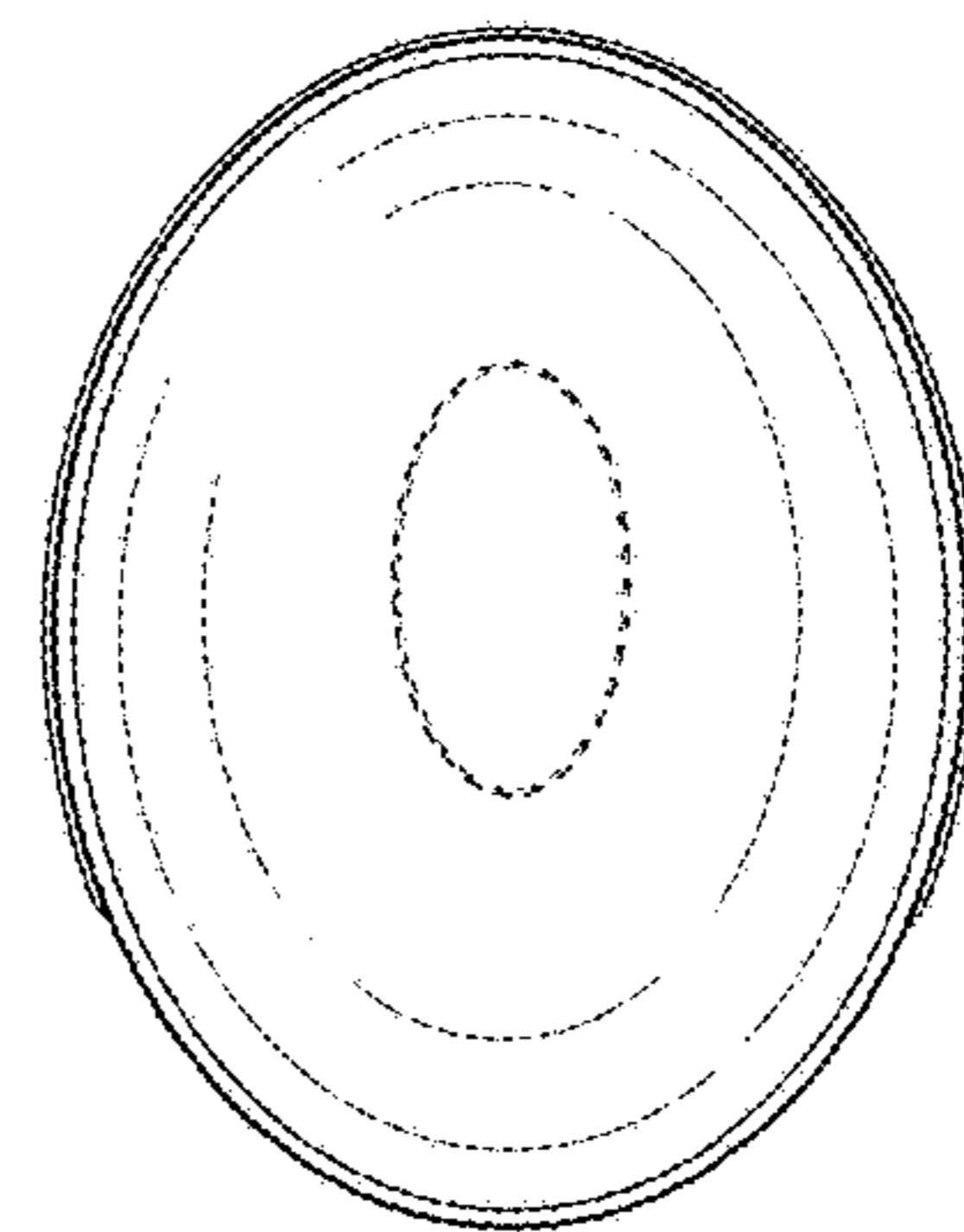

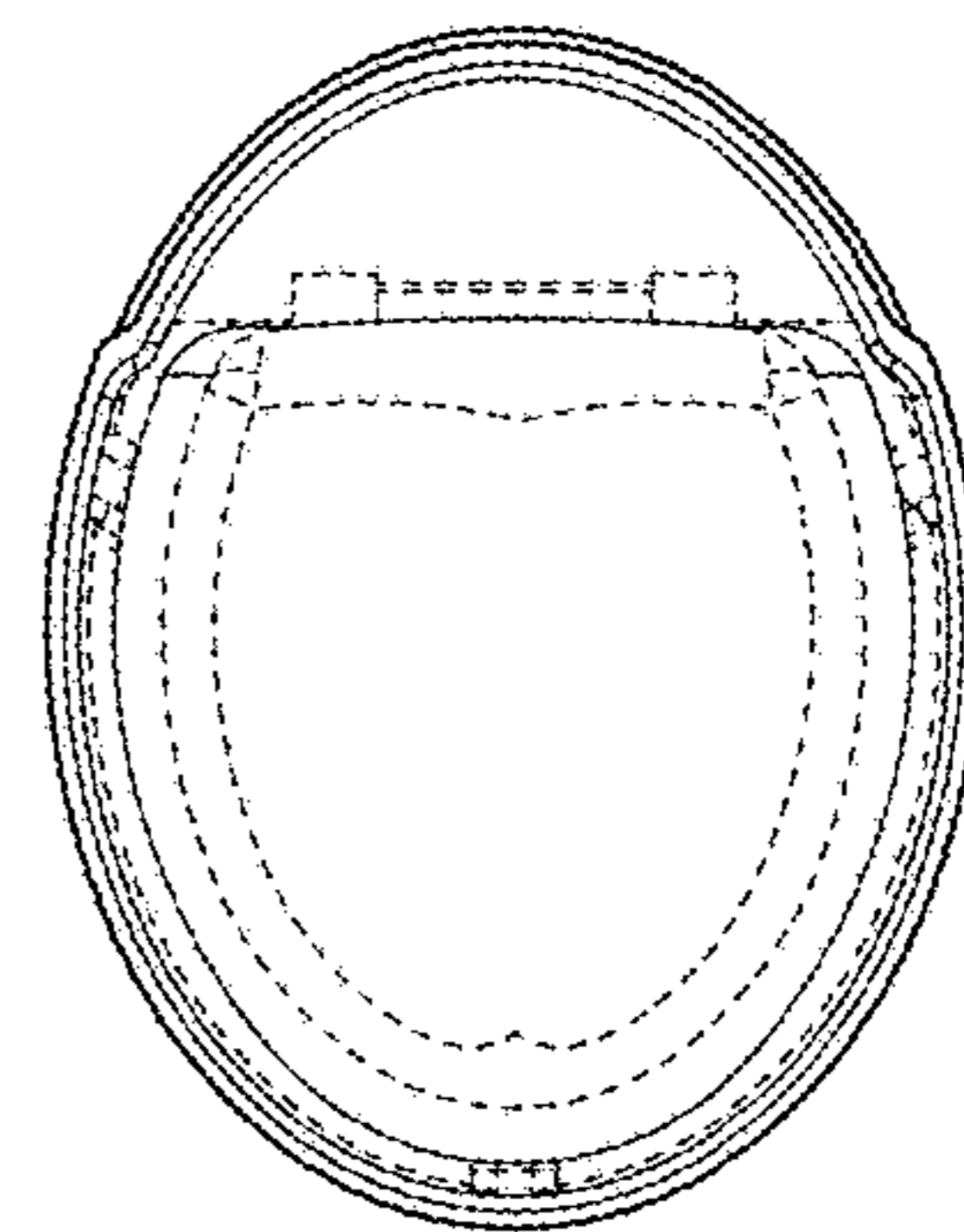
